(the "**Company**") announces that on 05 December 2025 it has purchased, in accordance with the authority granted by shareholders at the 2025 Annual General Meeting of the Company, a total of 1,710,234 of its ordinary shares of 0.25 each ("**Shares**") on the London Stock Exchange and Cboe (UK) as part of the buyback programme announced on 4 November 2025 (the "**Programme**") and as detailed below:
