The cosmetic pillar has a partnership with Croda plc where SkinBiotix<sup>®</sup> is being used as an active skin ingredient with the Croda trade name, Zenakine<sup>™</sup>. The AxisBiotix<sup>™</sup> pillar has a range of products targeting the symptoms of inflammatory skin conditions, being sold directly and via Amazon, and on the High Street in selected Superdrug Stores plc stores.

The Group is also acting as a consolidator and is making acquisitions in complementary areas such as skincare and cosmetic applications, that also bring new distribution and geographical platforms, and manufacturing capabilities through which it can funnel its in-house pillar products.
