These shares will be cancelled.

Therefore, the total number of voting rights in the Company is 60,995,500 which may be used by shareholders as the denominator for the calculations by which they will determine if they are required to notify their interest or a change to their interest in the Company under the FCA's Disclosure Guidance and Transparency Rules.
