## Aviva plc Total Voting Rights

As at close of business on 31 December 2025, Aviva plc had 3,057,731,705 issued ordinary shares of 32 17/19 pence each admitted to trading. Each ordinary share carries the right to one vote in relation to all circumstances at general meetings of Aviva plc. Aviva plc does not hold any ordinary shares in treasury.

Therefore, as at close of business on 31 December 2025, the total number of voting rights in Aviva plc was 3,057,731,705.

The above figure may be used by shareholders as the denominator for the calculations by which they will determine if they are required to notify their interest in, or a change to their interest in, Aviva plc under the FCA's Disclosure and Transparency Rules.
