

Taseko Announces PDMR Share Transaction

January 23, 2026, Vancouver, BC - Taseko Mines Limited (TSX: TKO; NYSE American: TGB; LSE: TKO) ("Taseko" or the "Company") announces that one of its Executives, Brian Bergot, was issued 78,469 common shares by the Company related to the vesting of Performance Share Units on January 16, 2026, and advised the Company that he subsequently sold a total of 55,000 common shares of the Company at an average price of C 9.83 per share (approximately £5.27/share) and exercised 120,000 share options and sold them at an average price of C 9.97.
