

Taseko Announces PDMR Share Transaction

January 23, 2026, Vancouver, BC - Taseko Mines Limited (TSX TKO; NYSE American: TGB; LSE: TKO) ("Taseko" or the "Company") announces that one of its Executives, Richard Tremblay, was issued 136,012 common shares by the Company related to the vesting of Performance Share Units on January 16, 2026, and advised the Company that he subsequently sold a total of 136,012 common shares of the Company at an average price of C 9.81 per share (approximately £5.27/share) and exercised 374,000 share options and sold them at an average price of C 9.96.
