Richmond Hill Resources (AIM:RHR) is pleased to announce a retail offer via the Winterflood Retail Access Platform (**WRAP**) to raise up to Â£100,000 (the "**WRAP Retail Offer**") through the issue of new ordinary shares of 0.1 pence each in the capital of the Company ("**Ordinary Shares**"). Under the WRAP Retail Offer up to 3,846,153 new Ordinary Shares (the **WRAP Retail Offer Shares**) will be made available at a price of 2.6 pence per share.

In addition to the WRAP Retail Offer and as announced on 28 January 2026, the Company placed 23,077,000 new Ordinary Shares (the "**Placing Shares**") to raise approximately Â£600,000 (before expenses) (the "**Placing**") at a price of 2.6 pence per Placing Share (the "**Placing Price**"). The Placing Price represents a premium of approximately 6 per cent. to the mid-market closing price of an Ordinary Share on 27 January 2026 (being the latest practicable date prior to this announcement). The issue price of the WRAP Retail Offer Shares is equal to the Placing Price.

A separate announcement has been made regarding the Placing and its terms and sets out the reasons for the Placing and use of proceeds. The proceeds of the WRAP Retail Offer will be utilised in the same way as the proceeds of the Placing.
