**Lion Finance Group PLC announces Transaction in own shares**

**Lion Finance Group PLC** (the "**Company**"- LSE: BGEO LN) announces that on 28 January 2026, Cavendish Capital Markets Limited ("**Cavendish**") purchased on behalf of the Company the number of ordinary shares of £0.01 each on the London Stock Exchange as set out in the table below (the "**Repurchased Shares**") pursuant to the share buyback and cancellation programme which was announced on 20 August 2025 and extended on 20 November 2025 (the "**Buyback Programme**").
