SHARE CONSOLIDATION EFFECTIVE AND TOTAL VOTING RIGHTS

Further to the announcement on 27 January 2026 that shareholder approval was granted at the General Meeting for a Special Dividend and associated Share Consolidation, Reckitt Benckiser Group plc (the "**Company**") is pleased to announce that the Company's Share Consolidation becomes effective today.

Admission of the Company's new ordinary shares to the ESCC category of the Official List of the Financial Conduct Authority and to trading on the London Stock Exchange's Main Market for listed securities, is due to take place at 8.00 a.m. today.

The ISIN for the new ordinary shares is GB00BSZBP530.

As a result of the Share Consolidation and in accordance with the requirements of the FCA's Disclosure Guidance and Transparency Rule 5.6.1A, the Company hereby notifies the market that the Company's issued share capital as at 8.00 a.m. on 2 February 2026 will consist of 674,005,752 ordinary shares of 10⁵/₁₀₀ pence each. The Company will hold 29,252,346 ordinary shares in treasury. Therefore, the total number of voting rights in the Company as at 2 February 2026 will be 644,753,406. 644,753,406 may be used by shareholders and others with notification obligations as their denominator for the calculations by which they will determine if they are required to notify their interest in, or a change to their interest in, the Company under the FCA's Disclosure Guidance and Transparency Rules.

Capitalised terms used but not otherwise defined in this announcement have the same meaning given to them in the Circular dated 7 January 2026.
