Essentra plc (the Company") announces that in accordance with DTR 5.6.1R of the FCA's Disclosure, Guidance and Transparency Rules, as at 31 January 2026 the Company's issued share capital consisted of 288,138,301 ordinary shares of 25p each ("Ordinary Shares"). Of these Ordinary Shares, 3,127,057 are held in Treasury.

Accordingly, as at 31 January 2026 there were 285,011,244 Ordinary Shares with voting rights.

The figure of 285,011,244 should be used by shareholders (and others with notification obligations) as the denominator for the calculations by which they will determine if they are required to notify their interest, or a change to their interest in Essentra plc under the FCA's Disclosure Guidance and Transparency Rules.
