LSEG announces it has purchased the following number of its ordinary shares of 6^{79/86} pence each from Citigroup Global Markets Limited ("Citi") on the London Stock Exchange as part of its share buyback programme, as announced on 04 November 2025.

LSEG intends to cancel all of the purchased shares.

Following the cancellation of the repurchased shares, LSEG has 507,012,183 ordinary shares of 6^{79/86} pence each in issue (excluding treasury shares) and holds 21,451,599 of its ordinary shares of 6^{79/86} pence each in treasury. Therefore, the total voting rights in the Company will be 507,012,183. This figure for the total number of voting rights may be used by shareholders (and others with notification obligations) as the denominator for the calculation by which they will determine if they are required to notify their interest in, or a change to their interest in, the Company under the FCA's Disclosure Guidance and Transparency Rules.
