**Hostelworld Group plc (the "Company")**

The Company announces that on 11 February 2026 it purchased a total of 20,000 of its Ordinary Shares of €0.01 each (the "Ordinary Shares") on the London Stock Exchange through the Company's broker Goodbody Stockbrokers UC ("Goodbody"), as detailed below. The repurchased shares will be cancelled.
