Digital 9 Infrastructure plc announces that the Investment Manager, InfraRed Capital Partners Limited ("InfraRed") has purchased 2,893,489 ordinary shares of no par value in the capital of the Company ("Ordinary Shares") at an average price of 4.90 pence per share on 20 April 2026. This purchase of Ordinary Shares was made by InfraRed Partners LLP, a company in the InfraRed Group.

This purchase was made in accordance with the terms of InfraRed's Investment Management Agreement whereby InfraRed is committed to use 10% of its annual management fee (net of applicable taxes) to acquire ordinary shares in the capital of D9 in the secondary market. The Investment Manager, excluding employees or partners, now holds a total of 4,452,358 Ordinary Shares in the Company, representing approximately 0.82% of the total issued share capital.
