Issue of Ordinary Shares

On 24 June 2026 Odyssean Investment Trust plc (the "Company") issued 50,000 new ordinary shares of 1p each at a price of 207.95 pence per share from its blocklisting, pursuant to the Company's premium management strategy.

These shares rank pari passu with the existing ordinary shares in issue and they were issued at a premium to the estimated net asset value per share at the time of the transaction.

Following this issue, the Company has a block listing for 4,260,921 ordinary shares.

As a result of this issuance, the total number of ordinary shares in issue is 140,430,791 and the total number of voting rights in the Company is 140,430,791. There are no shares held in treasury.
