**Explanation of Responses:**

1. On March 12, 2015, Carlos Caponera, acquired the issuer's Series A Senior Convertible Notes (the "Series A Notes") and a Warrant to purchase 9,035 shares of the issuer's Common Stock for an aggregate purchase price of \$10,000. Each share of Series A Notes is convertible at Mr. Caponera's option into 18,071 shares of the issuer's Common Stock. The conversion price of the Series A Notes is currently fixed at \$0.5534, but is subject to certain anti-dilution adjustments as set forth in a related Securities Purchase Agreement.
