

### BUSINESS STRUCTURE

During the year under review, Vantage International (Holdings) Limited and its subsidiaries are principally engaged in the following businesses in Hong Kong:

- the contract works business, through Able Engineering Holdings Limited (stock code: 1627) and its subsidiaries;
- the property investment and development business; and
- the provision of finance business.

### HIGHLIGHTS

- Turnover for the year ended 31 March 2019 increased by approximately 2.4% to approximately HK\$3,545 million from approximately HK\$3,463 million for the year ended 31 March 2018.
- Net profit for this year increased to approximately HK\$740 million, representing an increase of approximately 63% as compared with approximately HK\$453 million for the year ended 31 March 2018.
- Basic earnings per share for the year ended 31 March 2019 amounted to HK41.86 cents (2018: HK23.94 cents).
- Proposed final dividend per share for the year ended 31 March 2019 amounted to HK2 cents (2018: HK2 cents) per share.

- 截至二零一九年三月三十一日止年度之每股基本溢利為41.86港仙（二零一八年：23.94港仙）。






Revenue from Continuing Operations:

## CHAIRMAN'S STATEMENT 主席報告

Dear Shareholders,

On behalf of the board of directors of Vantage International (Holdings) Limited, I am delighted to report the annual results of the Group for the year ended 31 March 2019.

### RESULTS AND DIVIDEND

During the year under review, the Group was principally engaged in the contract works business, the property investment and development business and the provision of finance business in Hong Kong.

For the year ended 31 March 2019, the Group's profit attributable to owners of the parent amounted to HK\$705 million compared to HK\$409 million in last year, an increase of 72%. Excluding revaluation gains from its investment properties, the Group's underlying net profit of this year rose to HK\$647 million from HK\$269 million of the year ended 31 March 2018. The basic earnings per share for this year was HK41.86 cents compared to HK23.94 cents in last year. In addition, the equity attributable to owners of the parent as at 31 March 2019 amounted to HK\$4,206 million (approximately HK\$2.50 per share), representing an increase of 21% (31 March 2018: HK\$3,464 million (approximately HK\$2.06 per share)). The substantial increase in the underlying net profit for the year ended 31 March 2019 was largely due to the completion of all sales transactions of the Group's "Pokfulam Peak" project in this year.

On the other hand, the performance of contract works, property investment and provision of finance businesses remained stable in this year. Upon the initial adoption of HKFRS 15 on 1 April 2018, the Group recognised contract works profits of approximately HK\$92 million directly in equity.

The Board has recommended the payment of a final dividend of HK2 cents (2018: HK2 cents) per share for the year ended 31 March 2019. The proposed final dividend will be payable on or before Friday, 20 September 2019, subject to the approval of the Company's shareholders at the forthcoming 2019 annual general meeting of the Company.

致各位股東：

本人謹代表盈信控股有限公司之董事會，欣然宣佈本集團截至二零一九年三月三十一日止年度的全年業績。

### 業績及股息

於回顧年度內，本集團主要於香港經營合約工程業務、物業投資及發展業務及提供融資業務。

於截至二零一九年三月三十一日止年度，本集團母公司持有者應佔溢利由去年度之4.09億港元，上升72%至7.05億港元。經扣除投資物業之重估收益後，本集團之淨溢利由截至二零一八年三月三十一日止年度之2.69億港元，上升至本年度的6.47億港元。本年度之每股基本溢利為41.86港仙，而去年則為23.94港仙。此外，於二零一九年三月三十一日的母公司持有者應佔權益為42.06億港元（約每股股份佔2.50港元），較去年上升21%（於二零一八年三月三十一日：34.64億港元（約每股股份佔2.06港元））。截至二零一九年三月三十一日止年度之基礎溢利之顯著增長主要是由於本集團的「Pokfulam Peak」項目已於年內完成全部銷售交易所致。

另一方面，本年度合約工程、物業投資及提供融資業務則維持穩定表現。於二零一八年四月一日首次採用香港財務報告準則第15號時，本集團直接於權益確認約0.92億港元合約工程的溢利。

董事會已建議就截至二零一九年三月三十一日止年度派發末期股息，每股2港仙（二零一八年：2港仙）。擬派發之末期股息須於本公司即將舉行之二零一九年股東週年大會上獲得本公司股東批准後，於二零一九年九月二十日（星期五）或之前派付。



## CHAIRMAN'S STATEMENT 主席報告

### ACQUISITION OF JOINT VENTURE

In November 2018, a subsidiary of the Group's major subsidiary, Able Holdings (stock code: 1627), entered into transactions to acquire 50% equity interests in and 50% shareholder's loan to Gold Victory for a total consideration of HK\$60 million. Accordingly, Gold Victory and its subsidiaries, which mainly engaged in manufacturing, trading and installation of doors, door frames, furniture in Hong Kong and the PRC become joint ventures of the Group. Through this acquisition, the business of Able Group expanded into a new scope of works which broaden its income source while diversify its business risk.

### ACQUISITION OF PROPERTIES

In March 2019, the Group acquired No. 18 Shek O Headland, Hong Kong through the acquisition of York Star Holdings Limited for a consideration of HK\$338 million. Given the property's prime location in the luxury residential area of Shek O, this acquisition enhances the property portfolio of the Group.

To strengthen the land bank of the Group, we also entered into a provisional sales and purchase agreement with an independent third party in April 2019 to acquire No. 12 Wiltshire Road, Kowloon, Hong Kong for a consideration of HK\$140 million. This acquisition was completed subsequent to the year end on 21 May 2019.

### 收購合營企業

於二零一八年十一月，安保控股（本集團的一間主要附屬公司，股份代號：1627）旗下的一間附屬公司斥資收購Gold Victory的50%權益及50%股東貸款，總代價0.6億港元。據此，Gold Victory及其主要於香港及中國製造、買賣及安裝門戶、門框、傢俬之附屬公司成為本集團的合營企業。通過此項收購，安保集團的業務範圍擴張至新工程範疇，擴大其收入來源，並同時分散業務風險。

### 收購物業

於二零一九年三月，本集團完成以3.38億港元，通過收購York Star Holdings Limited而購入位於香港石澳山仔路18號的物業。鑑於該物業位於石澳豪華住宅區之黃金地段，此收購事項增強了本集團之物業組合。

為增強本集團之土地儲備，我們亦於二零一九年四月與一獨立第三方訂立協議，以1.40億港元收購位於香港九龍九龍塘渭州道12號的物業。是項收購已於年末後（二零一九年五月二十一日）完成。



## CHAIRMAN'S STATEMENT 主席報告

### OUTLOOK

In recent years, housing policy remains a prime focus of the HKSAR Government. As addressed in the 2018 Policy Address, the HKSAR Government will implement various measures to increase land and public housing supplies, such as the redevelopment of aged housing estates and allocate 70% (based on housing units) of newly developed land to public housing development. All these measures involve building construction works which are one of the key business of the Group. Accordingly, the Directors believe that the construction industry will remain active in the future. To stay competitive, the Group will put more effort in enhancing our work efficiency and work safety, supporting research and development projects in construction materials and other sectors, as well as actively investing in the use of technologies in daily operation.

For the property investment and development business, after a modest decline in property prices in Hong Kong during Q3 of 2018/19, residential prices in both the luxury and mass segments all rebounded in Q4 of 2018/19 and continue to increase in April 2019. However, current market sentiments are affected by the trade war between China and the US and recent social contradiction in Hong Kong. In this regard, it is expected the current market outlook remains heavily dependent on how the trade war and the social instability plays out. Should the trade war or social conflict persist and escalate, the intensifying downside risk will affect most of the industries. The Directors are confident that market fundamentals like wage levels, unemployment rate, interest, property supply and interest rate will remain stable in the short to medium term, while the long-term outlook of the property market are unclear. The Group will keep a close look on the market and be flexible to adjust its property sales strategy and to replenish its property investment and development projects. Disregard of the market conditions, as the Group only has one ready-for-sale property project on hand, it is expected that the revenue and profits that can be earned from the property development business will drop significantly in the year 2019/20.

### 前景

近年來，房屋政策一直是香港特區政府的首要關注點。正如二零一八年施政報告所述，香港政府將採取多項措施增加土地及房屋供應，例如重建舊屋邨及把七成新增土地（以房屋單位計算）用於開發公營房屋。所有這些措施均涉及屬本集團的主要業務之一的建築工程。因此，董事相信建築業將持續活躍。為保持競爭力，本集團將更大力提升工作效率及安全作業、支持有關建築物料及其他項目的研發及正積極投資於應用新科技於日常作業。

就物業投資及發展業務而言，香港房地產價格經過二零一八至一九年年度第三季的溫和調整後，豪宅及一般住宅價格在二零一八至一九年年度第四季度均出現反彈，及至二零一九年四月皆持續上升。然而，近期市場情緒正受到中國大陸與美國之間的貿易戰及近日香港社會矛盾的影響。在這方面，市場前景嚴重受制於貿易戰及社會矛盾的發展，若貿易戰或社會衝突持續升級，經濟下行風險將增加並影響各行各業。董事相信，工資水平、失業率、房地產供應和利率等市場基本面向中短期內將保持穩定，唯房地產市場的長遠前景暫時仍未明朗。本集團將密切關注市場，並靈活調整其物業銷售策略及補充其物業投資及發展項目。撇除市場因素外，由於本集團現時僅有一個待售物業項目，預計本集團在二零一九至二零年年度自物業發展業務所賺取的銷售收入及利潤將大幅下降。



## CHAIRMAN'S STATEMENT 主席報告

In response to increasing uncertainties and instabilities, the Group will continuously keep a close eye on the market and be prepared to react quickly to challenges and new investment and development opportunities. To manage investment risk, the Group may also co-operate with different independent partners in tendering projects and expand its business.

The following discussions should be read in conjunction with the audited consolidated financial statements of Vantage International (Holdings) Limited (the “Company”) for the year ended 31 March 2019.

### PERFORMANCE

During the year under review, Vantage International (Holdings) Limited (the “Company”) and its subsidiaries (collectively, the “Group”, including Able Engineering Holdings Limited (“Able Holdings”; stock code: 1627) and its subsidiaries (collectively, the “Able Group”)) was principally engaged in the contract works business, which mainly comprised of building construction and repair, maintenance, alteration and addition (“RMAA”) works, the property investment and development business and the provision of finance business in Hong Kong.

### 業績表現

於回顧年度內，盈信控股有限公司（「本公司」）及其附屬公司（統稱「本集團」，包括安保工程控股有限公司（「安保控股」；股份代號：1627）及其附屬公司（統稱「安保集團」））主要於香港經營合約工程業務（當中主要包括樓宇建築及維修、保養、改建及加建（「維修、保養、改建及加建」）工程）、物業投資及發展業務及提供融資業務。

For the year ended 31 March 2019, the Group's profit attributable to owners of the parent amounted to HK\$705 million compared to HK\$409 million in last year, an increase of 72%. Excluding revaluation gains from its investment properties, the Group's underlying net profit of this year rose to HK\$647 million from HK\$269 million of the year ended 31 March 2018. The basic earnings per share for this year was HK41.86 cents compared to HK23.94 cents in last year. In addition, the equity attributable to owners of the parent as at 31 March 2019 amounted to HK\$4,206 million (approximately HK\$2.50 per share), representing an increase of 21% (31 March 2018: HK\$3,464 million (approximately HK\$2.06 per share)). The substantial increase in the underlying net profit for the year ended 31 March 2019 was largely due to the completion of all sales transactions of the Group's "Pokfulam Peak" project in this year.

On the other hand, the performance of contract works, property investment and provision of finance businesses remained stable in this year. Upon the initial adoption of HKFRS 15 on 1 April 2018, the Group recognised contract works profits of approximately HK\$92 million directly in equity.

### DIVIDEND

No interim dividend has been paid or declared by the Company during this year (2018: nil). At the Company's annual general meeting ("AGM") held on 31 August 2018, shareholders approved the payment of a final dividend of HK2 cents per ordinary share for the year ended 31 March 2018 which amounted to a total of approximately HK\$33,659,000. The dividend was paid on 21 September 2018.

The Board recommends the payment of a final dividend of HK2 cents (2018: HK2 cents) per ordinary share for the year ended 31 March 2019 to the shareholders whose names appear on the register of members of the Company on 10 September 2019, Tuesday. The proposed payment of the final dividend is subject to the approval of the Company's shareholders at the forthcoming 2019 AGM of the Company and has not been recognised as a liability as at 31 March 2019.

Based on the 1,682,966,400 ordinary shares of the Company in issue as of the approval date of this annual report, the total final dividend amounted to approximately HK\$33,659,000.

另一方面，本年度合約工程、物業投資及提供融資業務則維持穩定表現。於二零一八年四月一日首次採用香港財務報告準則第15號時，本集團直接於權益確認約0.92億港元合約工程的溢利。

### 股息

本公司於本年度並無宣派或支付中期股息（二零一八年：無）。於二零一八年八月三十一日舉行之本公司股東週年大會（「股東週年大會」）上，股東批准為截至二零一八年三月三十一日止年度派發每股普通股2港仙末期股息，共約33,659,000港元。該股息已於二零一八年九月二十一日派付。

董事會建議就截至二零一九年三月三十一日止年度向於二零一九年九月十日（星期二）名列本公司股東名冊上的股東派發末期股息，每股普通股2港仙（二零一八年：2港仙）。擬派發之末期股息須於本公司即將舉行的二零一九年股東週年大會上獲得股東批准，方可作實，此末期股息因而並未在二零一九年三月三十一日確認為負債。

按本年度報告公告獲批准之日本公司之已發行股份1,682,966,400股普通股股份計算，末期股息總額約為33,659,000港元。

### BUSINESS REVIEW

#### Business Model and Strategies

The Group's businesses are focused in Hong Kong. It adopted a diversified business model which comprises "three pillars" namely, the contract works business, the property investment and development business and the provision of finance business. The contract works business and the property investment business provide a reliable income source to the Group, while the property development business is a profit driver, and the provision of finance business allows the Group to better utilize its short-term cash resources. The Group is dedicated to maximising value for shareholders over the long term by conducting our business in an efficient and environmentally sound manner, as well as building and maintaining a diversified and competitive land bank and achieving a growth through acquisition strategy.

#### Contract Works

##### Market review

In recent years, housing policy remains a prime focus of the Hong Kong Special Administrative Region (the "HKSAR" or "Hong Kong") Government. As addressed in the 2018 Policy Address, the HKSAR Government will implement various measures to increase land and public housing supplies, such as the redevelopment of aged housing estates and allocate 70% (based on housing units) of newly developed land to public housing development. All these measures involve building construction works which are one of the key business of the Group. The Directors believe that the construction industry will remain promising in the future.

##### The Group's performance

The Group currently carries on its contract works business through the Able Group. The contract works segment can be further divided into two businesses according to nature of contracts, being building construction and RMAA works. As of 31 March 2019, the Group's substantial contracts on hand were mainly related to building construction works from the public sector.

#### 業務回顧

##### 業務模式及策略

本集團的業務主要集中在香港。其採取多元化發展模式，當中包括「三大業務支柱」：即合約工程業務、物業投資及發展業務及提供融資業務。合約工程業務及物業投資業務為本集團提供可靠的收入來源；物業發展業務則為溢利增長提供動力；而提供融資業務可令本集團更有效運用短期資金。本集團致力於通過有效率和環保的方式開展業務、建立和維持土地儲備以及通過收購實現增長的策略，為股東創造最大的長遠價值。

#### 合約工程

##### 市場狀況

近年來，房屋政策一直是香港特別行政區（「香港」）政府的首要關注點。正如二零一八年施政報告所述，香港政府將採取多項措施增加土地及房屋供應，例如重建舊屋邨及把七成新增土地（以房屋單位計算）用於開發公營房屋。所有這些措施均涉及屬本集團的主要業務之一的建築工程。董事相信建築業將持續活躍。

##### 本集團表現

本集團現時透過安保集團進行合約工程業務。合約工程分部按工程類型可再細分為兩項業務，即樓宇建築以及維修、保養、改建及加建工程。於二零一九年三月三十一日，本集團手頭上的重大合約主要為與公營機構有關的樓宇建築工程。

For the year ended 31 March 2019, external revenue amounted to approximately HK\$2,385 million (2018: approximately HK\$3,112 million), representing a decrease of 23% from that of last year. The decrease in turnover was mainly resulted from the completion of substantial portion of certain large-scale building construction projects of the Able Group during the year. A large portion of revenue of these matured projects had already been recognised last year and they reached final stage of development in this year. Accordingly, these projects did not contribute much revenue to the Able Group in current year. On the other hand, works regarding those new construction projects awarded to the Able Group only commenced in the second half year of 2018/19 that they did not contribute much revenue for the year ended 31 March 2019.

The gross profit margin of this segment increased from 8.0% for the year ended 31 March 2018 to 9.9% for the year ended 31 March 2019. The increase was mainly resulted from the effect of the adoption of HKFRS 15 since 1 April 2018. In prior years, revenue and costs of contract works were recognised using the percentage of completion method and a relatively even gross profit margin was achieved for an individual contract over the life of the contract. Under HKFRS 15, contract works costs related to satisfied performance obligations in a contract would be recognised in profit or loss immediately, resulting in uneven gross profit margins in individual reporting periods over the life of each contract. Albeit the overall profit that can be recognised for a project will not be affected by HKFRS 15, it is expected the gross profit margins of the contract works business will fluctuate over different reporting periods, depending on the actual revenue certified and costs incurred for the construction works performed. As further explained in note 2.2 to the audited consolidated financial statements, the Group recognised contract works profits of approximately HK\$92 million directly in equity upon the initial adoption of HKFRS 15 on 1 April 2018.

Substantial building construction works contracts awarded to the Group during the year ended 31 March 2019 were set out below:

截至二零一九年三月三十一日止年度，外部收入約為23.85億港元（二零一八年：約31.12億港元），較上年度減少23%。營業額下跌主要由於安保集團於本年間完成若干項大型樓宇建造項目的大部分工程，該等已成熟項目的大部分收入已於去確認並於本年處於最後發展階段，故於本年間並未有為安保集團貢獻太多收入。另一方面，鑑於安保集團於本年間獲得的新建築項目於二零一八至一九年年度下半年才動工，該等項目因而並未對截至二零一九年三月三十一日止年度的收入有較大貢獻。

本分部的毛利率由截至二零一八年三月三十一日止年度的8.0%上升至截至二零一九年三月三十一日止年度9.9%。增加主要由於自二零一八年四月一日開始採納香港財務報告準則第15號所致。於以前年度，合約工程的收入及成本乃使用完工百分比的方法確認，而個別合約於合約期內不同期間的毛利率會較平均。於採納香港財務報告準則第15號後，有關已達成履約責任的合約工程成本將即時於損益中確認，並將導致各工程於合約期內不同期間的毛利率不均。儘管個別項目的整體利潤不會受香港財務報告準則第15號的影響，預期合約工程分部之毛利率將視乎已進行建造工程所產生之經核定實際收入及成本而於不同報告期間有所波動。此外，誠如經審核綜合財務報表附註2.2所述，於二零一八年四月一日首次採用香港財務報告準則第15號時，本集團直接於權益確認約0.92億港元合約工程的溢利。

### Property Investment and Development

#### Market review

The elevated US-Mainland trade conflicts and the interest rate hikes weakened market sentiment in the second half of 2018/19 that property price recorded a drop from August to December 2018. However, as supported by strong demand from home buyers and investors and slower than expected increase in interest rates, the property price and transaction volume rebounded in the last quarter of 2018/19.

### The Group's performance

#### Property investment

During the year ended 31 March 2019, the Group's gross rental income increased from approximately HK\$80 million for the year ended 31 March 2018 to approximately HK\$85 million. The increase of rental income was mainly contributed from temporary leasing of certain units of the newly acquired Man Shung Building (as defined in this annual report) during the year under the leases brought forward from the acquisition and before such leases expired.

我們預期，上述合約將於項目開展後兩至五年內完成。

### 物業投資及發展

#### 市場狀況

受美國與內地的貿易摩擦升溫及加息周期的影響，市場氣氛在二零一八至一九年年度下半年減弱，令物業價格於二零一八年八月至十二月期間錄得下降。然而，由於用家及投資者對住宅的強勁需求及利率加幅較預期輕微，物業價格及成交量於二零一八至一九年年度第四季錄得回升。

### 本集團表現

#### 物業投資

於截至二零一九年三月三十一日止年度，本集團之物業總租金收入由截至二零一八年三月三十一日止年度的約0.80億港元增加至約0.85億港元。租金收入增加主要因為於年內連同租約新購入萬順大廈(如本年度報告所定義)後，在相關租約完結前暫時出租物業的若干單位而收取的租金所致。

The Group's "Investment properties" were valued amounting to HK\$2,138 million in aggregate as of 31 March 2019 (31 March 2018: HK\$2,039 million) by an independent professional valuer. Based on the independent valuation performed, the Group recorded net gain on changes in fair value of investment properties of approximately HK\$93 million for the year ended 31 March 2019 (31 March 2018: approximately HK\$183 million). The increase in fair value in this year was mainly contributed from general market appreciation and increase in rental potential at Tin Ma Court, Wong Tai Sin.

As at 31 March 2019, approximately half of the aggregated value of the Group's investment properties portfolio referred to the investment properties at Tin Ma Court, Wong Tai Sin and Kam Ying Court, Man On Shan acquired in May 2016.

### Property development

As mentioned in the Company's 2017/18 annual report, the Group's revenue earned from property development business rose significantly in 2018/19. While only one property sales transaction of "Pokfulam Peak" project was recognised in last year, the Group completed the sales of remaining properties of the project in this year, leading to substantial increase in revenue and profits of the property development business from approximately HK\$252 million and HK\$121 million of the year ended 31 March 2018 to approximately HK\$1,055 million and HK\$497 million, respectively, in this year.

Regarding the Group's proposed redevelopment at No. 1 & No. 1A Wood Road, Wanchai, Hong Kong (the "Wood Road Property"), the Group successfully bid for the acquisition of the Wood Road Property at a public auction held on 29 June 2018 under the Land (Compulsory Sale for Redevelopment) Ordinance (Cap. 545) (the "Wood Road Acquisition"). The Wood Road Acquisition was completed in August 2018 and further details of the acquisition was set out in the Company's announcement dated 29 June 2018. As of 31 March 2019, all units of the Wood Road Property were vacant for redevelopment and the Group was planning the demolishing works of the building.

The site foundation works of the residential development at No. 28 Lugard Road, The Peak, Hong Kong (the "Lugard Project") was in progress during the year and as of 31 March 2019. Due to the geographical location of this project and road conditions of nearby areas, it is expected that the development of the Lugard Project will be completed after 2021.

於二零一九年三月三十一日，本集團之「投資物業」經一獨立專業估值師評估，總值達21.38億港元（於二零一八年三月三十一日：20.39億港元）。根據已進行之獨立評估，本集團於截至二零一九年三月三十一日止年度錄得約0.93億港元有關投資物業公平價值變動之收益淨額（於二零一八年三月三十一日：約1.83億港元）。本年度公平價值之上升主要源自整體物業市場普遍升值及位於黃大仙天馬苑的投資物業的租賃潛力增加所致。

於二零一九年三月三十一日，位於黃大仙天馬苑及馬鞍山錦英苑的投資物業（於二零一六年五月購入）之價值約佔本集團投資物業組合總值的一半。

### 物業發展

誠如本公司於二零一七至一八年年度報告所述，本集團來自物業發展業務的收入於二零一八至一九年年度大幅增加。與去年只錄得一項「Pokfulam Peak」項目的物業銷售交易相比，本集團已於本年內完成其餘所有該項目的銷售，令本集團來自物業發展業務的收入及利潤分別由截至二零一八年三月三十一日止年度之約2.52億港元及1.21億港元，大幅增加至本年度之約10.55億港元及4.97億港元。

關於本集團擬於香港灣仔活道1號及1A號（「活道物業」）進行的重建項目，本集團已於二零一八年六月二十九日按《土地（為重新發展而強制售賣）條例》（香港法例第545章）而舉行的公開拍賣中，成功收購活道物業（「該活道收購事項」）。該活道收購事項已於二零一八年八月完成，有關收購的進一步詳情載於本公司日期為二零一八年六月二十九日之公告。於二零一九年三月三十一日，活道物業的所有單位已為重建而交吉，而本集團正計劃相關樓宇拆卸工作。

於本年內及於二零一九年三月三十一日，位於香港山頂盧吉道28號的項目（「盧吉道項目」）正進行地基工程。由於該項目的地理位置及鄰近道路的情況，預期盧吉道項目的發展將於二零二一年後竣工。

As of 31 March 2019, the Group's "Properties held for sale" in the consolidated statement of financial position were referring to properties at "Belfran Peak". This high-end residential development project is located at No. 9 Belfran Road, Kowloon, Hong Kong. The project was granted the certificate of compliance and is ready for sale. "Belfran Peak" consists of a 20-storey residential building, which contains six duplex apartments, a triplex apartment, car parking spaces and recreational facilities.

Details of the Group's "Investment properties", "Properties held for development", "Properties under development" and "Properties held for sale" as at 31 March 2019 have been disclosed in pages 16 to 19 of this annual report.

### Provision of Finance

A wholly-owned subsidiary of the Group has been granted a licence under the "Money Lenders Ordinance" to carry on the provision of finance business in Hong Kong since September 2015. During this year, interest at rates ranging from approximately 2% to 30% per annum (2018: approximately 4% to 41% per annum) were charged to borrowers and interest income of approximately HK\$20 million was earned (2018: approximately HK\$18 million).

### Other Income and Gains, Net

Other income and gains (net) recorded a decrease from approximately HK\$191 million for the year ended 31 March 2018 to approximately HK\$180 million for the year ended 31 March 2019. The decrease was mainly attributable to the drop of net gain on changes in fair value of the Group's investment properties from approximately HK\$183 million for the year ended 31 March 2018 to approximately HK\$93 million in current year. The higher net fair value gains recorded in last year was mainly due to increase in rental potential of certain investment properties after change in floor layout while the increase in this year was mainly resulted from general market appreciation in Hong Kong. Besides, a property sales transaction was canceled this year that confiscated deposits and compensation income of approximately HK\$75 million was also recognised.

### Selling and Marketing Expenses

Expenses incurred for the year ended 31 March 2018 represented respective advertising and marketing costs incurred for the marketing of the "Pokfulam Peak" project while that of current year represented cost incurred for the launch of "Belfran Peak" project, including costs related to sales brochure, project website and advertising, etc..

於二零一九年三月三十一日，本集團之綜合財務狀況表中的「持有作出售之物業」為「Belfran Peak」物業。此高級住宅發展項目位於香港九龍巴芬道9號，項目已取得合約完成證明書（俗稱「滿意紙」）並可供銷售。「Belfran Peak」為一幢二十層的住宅大廈，當中包括六個複式單位、一個三層單位、泊車位及康樂設施。

本集團於二零一九年三月三十一日所持有之「投資物業」、「持有作發展之物業」、「發展中物業」及「持有作出售之物業」的詳情已載於本年度報告第16頁至第19頁。

### 提供融資

本集團的一間全資附屬公司自二零一五年九月起根據《放債人條例》獲發牌照，可於香港從事提供融資業務。於本年內，自借款方收取的利息介乎每年約2%至30%（二零一八年：每年約4%至41%），賺取約0.20億港元利息收入（二零一八年：約0.18億港元）。

### 其他收入及收益（淨額）

其他收入及收益（淨額）由截至二零一八年三月三十一日止年度約1.91億港元，下降至截至二零一九年三月三十一日止年度約1.80億港元。跌幅主要由本集團的投資物業公平值變動收益淨額由截至二零一八年三月三十一日止年度之約1.83億港元，下降至本年度約0.93億港元所致。上年度較高之公平值變動淨收益主要由於部份投資物業的租賃潛力因變更樓層佈局而增加而本年度的升幅則主要基於香港整體物業價格的上升。此外，由於一項物業銷售交易已於本年度被取消，年內因而確認了沒收按金及補償金的收入約0.75億港元。

### 銷售及推廣開支

於截至二零一八年三月三十一日止年度的銷售及推廣開支為「Pokfulam Peak」項目的廣告及推廣費用，而本年度的開支則為推出「Belfran Peak」項目的相關市場推廣費用，包括售樓書、項目網站及廣告等支出。

### Administrative Expenses

Administrative expenses increased from approximately HK\$114 million for the year ended 31 March 2018 to approximately HK\$141 million for the year ended 31 March 2019. The higher administrative expenses of current year was mainly due to the depreciation, maintenance and operating costs incurred for newly acquired properties such as the Man Shung Building, and the increase in director's and staff related costs, including salary, discretionary bonus and welfare expenses.

### Finance Costs

For the year ended 31 March 2019, the Group recognised approximately HK\$32 million finance costs as expenses (2018: approximately HK\$28 million) while the Group's total interest on bank loans before interest capitalisation to "Properties under development" was approximately HK\$37 million (2018: approximately HK\$30 million). The increase in overall finance costs was mainly caused by the increase in average bank loans and interest rates during this year.

### Share of Profits and Losses of Joint Ventures

To expand into new sector of the contract works businesses, the Group, through the Able Group, acquired 50% interest in Gold Victory (as defined in this annual report) through the JV Acquisition (as defined in this annual report) on 30 November 2018. During the four months from the completion of the JV Acquisition to 31 March 2019, net profits shared by the Group from Gold Victory amounted to approximately HK\$2 million.

### Income Tax Expense

Income tax expense increased by 74% from approximately HK\$56 million for the year ended 31 March 2018 to approximately HK\$97 million for this year. The increase was consistent with the increase in taxable profit for this year.

### Profit Attributable to Owners of the Parent

As a result of the foregoing, the Group's profit attributable to owners of the parent for this year recorded an increase from approximately HK\$409 million for the year ended 31 March 2018 to approximately HK\$705 million of current year.

### 行政開支

行政開支由截至二零一八年三月三十一日止年度約1.14億港元增加至截至二零一九年三月三十一日止年度約1.41億港元。本年度錄得較高的行政開支主要歸因於如萬順大廈等新購入物業的折舊、保養及營運費用，以及與董事及員工相關的開支（包括薪酬、酌情花紅及福利）上升而引致。

### 財務費用

於截至二零一九年三月三十一日止年度，本集團確認約0.32億港元的財務費用為支出（二零一八年：約0.28億港元），而本集團未計算資本化至「發展中物業」以前之銀行貸款利息約為0.37億港元（二零一八年：約0.30億港元）。整體財務費用的上升主要源於本年度內平均銀行貸款額增加及利率的上升。

### 應佔合營企業之溢利及虧損

為拓展合約工程業務至其他領域，本集團（經安保集團）於二零一八年十一月三十日，通過該合營企業收購事項（如本年度報告所定義）購入Gold Victory（如本年度報告所定義）的50%權益。自完成該合營企業收購事項起至二零一九年三月三十一日止之四個月期間，本集團應佔Gold Victory的淨利潤約2百萬港元。

### 所得稅支出

所得稅支出由截至二零一八年三月三十一日止年度的約0.56億港元，上升74%至本年度的約0.97億港元。升幅與本年度之應課稅溢利的增長一致。

### 母公司持有者應佔溢利

鑑於上述因素，本集團之母公司持有者應佔溢利由截至二零一八年三月三十一日止年度約4.09億港元，上升至本年度約7.05億港元。

### FINANCIAL REVIEW

#### Capital Structure, Liquidity and Financial Resources

The capital of the Company only comprises ordinary shares. The Group's banking facilities, comprising primarily bank loans, overdrafts and performance bond, amounted to approximately HK\$3,305 million as of 31 March 2019 (31 March 2018: approximately HK\$3,202 million), of which approximately HK\$1,455 million (31 March 2018: approximately HK\$1,642 million) was unutilised. The Group monitors capital structure using gearing ratio and net gearing ratio. Gearing ratio is measured as total bank borrowings divided by equity attributable to owners of the parent while net gearing ratio is measured as total bank borrowings less cash and cash equivalents, divided by equity attributable to owners of the parent. As at 31 March 2019, the Group's gearing and net gearing ratios were 37.4% and 0.4% (31 March 2018: 39.8% and -2.9%), respectively.

The Group's cash and cash equivalents recorded an increase by 4.8% from approximately HK\$1,481 million as at 31 March 2018 to approximately HK\$1,552 million as at 31 March 2019. In this year, the Group recognised significant net cash outflows in investing activities for the acquisition of the Man Shung Building, the Shek O Property (as defined in this annual report) and certain land lots at Kam Tin, Yuen Long for the Group's own use. On the other hand, operating net cash inflows from both contract works business and property investment and development business remained strong in this year.

Current ratio of the Group stood at 1.44 as at 31 March 2019, while that as at 31 March 2018 was 1.48. Current ratio is measured as total current assets divided by total current liabilities. The Group maintains sufficient working capital resources to execute its contract works, property investment and development plans and provision of finance business.

Looking forward, due to the commencement of a substantial hospital project awarded to the joint operation in which a subsidiary of the Group is a joint operator, it is expected significant amount of cash would be consumed by the contract works business in the coming twelve months. The Group will continuously take a prudent and cautious approach to cash application and capital commitments.

#### 財務回顧

##### 資本架構、流動資金及財務資源

本公司的資本僅由普通股組成。本集團的銀行信貸主要包括銀行貸款、透支及履約擔保，於二零一九年三月三十一日，額度共約33.05億港元（於二零一八年三月三十一日：約32.02億港元），其中約14.55億港元（於二零一八年三月三十一日：約16.42億港元）尚未動用。本集團根據槓桿比率及淨槓桿比率來監察資本架構。槓桿比率以銀行貸款總額除以母公司持有者應佔權益計算；而淨槓桿比率以銀行貸款總額減去現金及現金等值物，除以母公司持有者應佔權益計算。於二零一九年三月三十一日，本集團的槓桿及淨槓桿比率分別為37.4%及0.4%（於二零一八年三月三十一日：39.8%及-2.9%）。

本集團於二零一九年三月三十一日持有之現金及現金等值物約15.52億港元，較二零一八年三月三十一日之約14.81億港元增加4.8%。於本年度，本集團由於收購萬順大廈、該石澳物業（如本年度報告所定義）及位於元朗錦田的土地作自用，令投資業務錄得重大淨現金流出。另一方面，本集團於本年度自合約工程業務及物業投資及發展業務均繼續錄得強勁的經營業務淨現金流入。

本集團於二零一九年三月三十一日的流動比率為1.44，而於二零一八年三月三十一日則為1.48。流動比率以流動資產總值除以流動負債總值計算。本集團維持足夠的營運資金，以執行其承包之合約工程、物業投資及發展計劃及提供融資業務。

展望未來，由於本集團的一間附屬公司作為合營方之合營業務的重大醫院項目已展開，預計未來十二個月內，合約工程業務將耗用大量資金。本集團將繼續持審慎和謹慎的態度以運用資金及作資本承擔。

### Interest and Foreign Exchange Exposure

The Group's business operations are principally engaged in Hong Kong, and certain operation of a joint venture is engaged in the People's Republic of China (the "PRC"). Majority of the Group's business transactions are denominated in the local currencies. Hence, the Group is not exposed to significant foreign exchange risk.

At 31 March 2018 and 31 March 2019, the Group's bank borrowings were all denominated in Hong Kong dollars and on a floating rate basis. The Group's bank accounts were operated with principal bankers in Hong Kong. The interest rates of these bank accounts are determined by reference to the respective banks' offer rate. For the year ended 31 March 2018 and 31 March 2019, the Group did not engage in any interest rates and currency speculation activities.

### Non-current Prepayments and Other Assets

As at 31 March 2018, the Group recorded non-current prepayments and other assets of approximately HK\$115 million, which represented prepayments and deposits of approximately HK\$114 million paid for the acquisition of total 25/26 shares in the Man Shung Building and deposits of approximately HK\$1 million paid for the acquisition of certain land lots at Kam Tin, Yuen Long. Both acquisitions were completed in this year.

### Accounts Receivable

As at 31 March 2019, approximately 99% (31 March 2018: approximately 99%) of the Group's accounts receivable represented the receivables of contract works business of the Able Group, among which, accounts receivable only included contract trade receivables in accordance with HKFRS 15, while that as of 31 March 2018 also combined retentions receivable and unbilled revenue which rights to receipt have not yet become unconditional in relation to completed and on-going contract works projects. Contract trade receivables represent progress billing of work performed by the Able Group and which the amounts have been verified by the progress payment certificates issued by and received from customers. The level of contract trade receivables is principally affected by work progress and the amount of the progress payment certificate received from customers before the end of the reporting period. Approximately 93% of the contract trade receivables as at 31 March 2019 were subsequently settled by 31 May 2019 (31 March 2018: approximately 97% were subsequently settled by 31 May 2018).

### 利率及匯率波動風險

本集團主要於香港經營業務，而其一間合營企業的部份業務則於中華人民共和國（「中國」）進行。本集團大部分業務交易均以當地貨幣計值。因此，本集團並無面臨重大外匯風險。

於二零一八年三月三十一日及二零一九年三月三十一日，本集團的銀行借款均以港元計值，並按浮動利率計算利息。本集團的銀行賬戶在香港主要銀行開設，相關銀行賬戶的利率由有關銀行拆放利率而釐定。於截至二零一八年三月三十一日及二零一九年三月三十一日止之年度內，本集團並無從事任何利率及貨幣投機活動。

### 非流動預付款項及其他資產

於二零一八年三月三十一日，本集團錄有非流動預付款項及其他資產約1.15億港元，其中約1.14億港元為購入萬順大廈共25/26份額之預付款項及按金，而約1百萬港元為購入位於元朗錦田若干土地的按金。兩項收購皆於本年度內完成。

### 應收賬款

於二零一九年三月三十一日，本集團之應收賬款中約99%（於二零一八年三月三十一日：約99%）為安保集團的合約工程業務之應收賬款，相關應收賬款按香港財務報告準則第15號只包含工程收款；而於二零一八年三月三十一日，則亦包含了有關已完成及在建合約工程項目的尚未達至無條件收款權之應收保留款項及未開賬單的收入。工程應收款指安保集團進行的工程的進度款，金額經由客戶發出及已自其取得的分階段付款證明書核定。工程應收款之水平主要受於報告期末前之工程進度，以及自客戶取得的分階段付款證明書中的數額所影響。於二零一九年三月三十一日的工程應收款中，約93%已於二零一九年五月三十一日或以前收回（於二零一八年三月三十一日：約97%已於二零一八年五月三十一日或以前收回）。

### Prepayment, Other Receivables and Other Assets

Both the Group's balances at 31 March 2018 and 31 March 2019 contained refundable security deposits of HK\$45 million paid for the potential acquisition of RICHREAR INT'L (as defined in this annual report), prepaid insurance for contract works, bank interest receivable, deposits paid for building management services, wastage disposal, utilities, etc.. Increase in balance at current year was mainly due to approximately HK\$75 million sales proceeds of "Pokfulam Peak" escrowed at lawyer.

### Contract Assets

Balance at current year end represented retention of accounts receivable and unbilled revenue of HK\$162 million and HK\$58 million, respectively, which the Group's rights to receipt have not yet become unconditional. Both balances were previously classified under "Accounts receivable" before the adoption of HKFRS 15 on 1 April 2018. In general, half of the retention money will be released upon practical completion of a project and the remaining half of the retention money is released upon expiry of the defect liability period.

### Other Payables and Accruals

The Group's balances at 31 March 2019 mainly represented provision of contract works, staff costs payable, rental income received in advance and deposits received from tenants, etc.. Significant increase in balance in current year end was primarily caused by the increase in provision of contract works after the adoption of HKFRS 15. Besides, amount received in advance for the sale of properties as of 31 March 2018 had been recognised as income upon completion of respective sales transactions in this year.

### Charges on Assets

At 31 March 2019, the following assets of the Group were pledged in favour of certain banks to secure certain banking facilities granted by those banks to certain members of the Group:

- investment properties with an aggregate carrying amount of HK\$2,138,000,000 (31 March 2018: HK\$2,039,000,000);
- land and buildings with an aggregate carrying amount of HK\$95,059,000 (31 March 2018: HK\$85,354,000);

### 預付款項、其他應收款及其他資產

本集團於二零一八年三月三十一日及二零一九年三月三十一日的結餘皆包括就可能收購 RICHREAR INT'L (如本年度報告所定義) 而支付的0.45億港元可退還保證金、預付合約工程的保險費用、應收銀行利息、以及支付樓宇管理服務、處理廢置物及水電的按金等。本年餘額增加主要源於有關出售「Pokfulam Peak」物業而暫托於律師樓的0.75億港元銷售收入。

### 合約資產

年末餘額為應收帳款保留款項1.62億港元及未發出付款證書的收入0.58億港元，而本集團收取相關款項的權利尚未達至無條件。於二零一八年四月一日採用香港財務報告準則第15號前，相關項目皆包含在「應收帳款」中。一般而言，保留款項的一半會於工程實際竣工後發放，而餘下一半則會於保修期屆滿後發放。

### 其他應付款及預提費用

本集團於二零一九年三月三十一日的結餘主要為合約工程的撥備、應付員工費用、預收租金及收取租戶的按金等。本年年末的結餘大幅增加主要由於合約工程的撥備於採用香港財務報告準則第15號後上升所致。另一方面，於二零一八年三月三十一日的有關出售物業而預收的款項已於本年度內完成相關銷售交易時確認為收入。

### 資產抵押

於二零一九年三月三十一日，本集團之下列資產已抵押予若干銀行，以取得該等銀行授予本集團若干成員的若干銀行信貸：

Completion of the Shek O Acquisition took place on 15 March 2019.

The Shek O Property falls within the luxury residential area of Shek O Headland, with unobstructed sea view. It comprises a 2-storey waterfront house together with terrace, garden and a swimming pool erected upon a site with site area of approximately 15,400 sq. ft.. It has a saleable area of approximately 3,382 sq. ft. according to the Rating and Valuation Department.

The Shek O Acquisition constituted a discloseable transaction of the Company under Chapter 14 of the Rules (the “**Listing Rules**”) Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (The “**Stock Exchange**”). For further details of the Shek O Acquisition, please refer to the announcements of the Company dated 28 December 2018 and 15 March 2019.

### ACQUISITION OF 50% INTEREST IN GOLD VICTORY

On 30 November 2018, Grand Superb Limited (“**Grand Superb**”), an indirect wholly-owned subsidiary of Able Holdings) as the purchaser, Golden Stone Asia Inc. (“**Golden Stone**”, an independent third party) as the vendor and Mr. WONG Kin Wah (the “**Guarantor**”, an independent third party) as the guarantor entered into an equity transfer agreement (the “**Equity Transfer Agreement**”) pursuant to which Grand Superb agreed to purchase and Golden Stone agreed to sell 50% interest of the Gold Victory Resources Inc. (“**Gold Victory**”) at a consideration of HK\$60 million (the “**JV Acquisition**”). Completion of the JV Acquisition took place on the same day.

Gold Victory and its subsidiaries (collectively, the “**JV Group**”) are principally engaged in the manufacturing of doors, door frames, furniture and other related products in a leased factory in Dongguan City of the PRC and the installation and trading of doors, door frames, furniture and other related products in Hong Kong. The goodwill arising from the JV Acquisition amounted to approximately HK\$45 million. The Board believed that the JV Acquisition can achieve synergy and strategic advantage and broaden the income source while diversify the business risk of the Group.

The JV Acquisition constituted a discloseable transaction for each of the Company and Able Holdings under Chapter 14 of the Listing Rules. For further details of the JV Acquisition, please refer to the joint announcements of the Company and Able Holdings dated 30 November 2018 and 18 December 2018.

Pursuant to the Equity Transfer Agreement, Golden Stone irrevocably warrants and guarantees to Grand Superb that the actual profits of the JV Group for the period commencing from 1 December 2018 and ending on 31 March 2022 (the “**Profit Warranty Period**”) shall not be less than the guaranteed profits (the “**Guaranteed Profits**”) of HK\$50 million (the “**Profit Warranty**”). In the event the total Guaranteed Profits are not achieved or reached for the entire Profit Warranty Period based on auditor’s certification, Golden Stone shall pay Grand Superb 50% of the shortfall between the actual profits and the Guaranteed Profits, unless the shortfall is caused by the event of force majeure as defined in the Equity Transfer Agreement. The JV Group has achieved the estimated portion of the Guaranteed Profits of HK\$3 million for the period from 1 December 2018 to 31 March 2019 as illustrated in the joint announcement of the Company and Able Holdings dated 30 November 2018.

The Profit Warranty constitutes a derivative financial instrument of the Group. As at 31 March 2019, the fair value of the Profit Warranty was HK\$194,000, which was determined by Asset Appraisal Limited, an independent professional valuer, based on the probabilistic flow method.

### THE MAN SHUNG ACQUISITION

On 8 January 2018, Bright Wind Limited (“**Bright Wind**”, an indirect wholly-owned subsidiary of Able Holdings) entered into nine provisional sale and purchase agreements with various independent third parties for the acquisition of certain properties (representing 21/26 equal and undivided shares) located at Man Shung Industrial Building (the “**Man Shung Building**”), No. 7, Lai Yip Street, Kwun Tong, Kowloon, Hong Kong at an aggregate consideration of HK\$438.6 million (the “**First Round Man Shung Acquisition**”). In addition, Bright Wind also entered into three provisional sale and purchase agreements with various independent third parties for the acquisition of certain remaining properties (representing 4/26 equal and undivided shares) of the Man Shung Building at an aggregate consideration of HK\$180 million on 9 February 2018 (the “**Second Round Man Shung Acquisition**”); and entered into one provisional sale and purchase agreement with an independent third party for the acquisition of Portion B on 11th Floor of the Man Shung Building (representing 1/26 equal and undivided shares) at a consideration of HK\$30.3 million on 28 June 2018 (the “**Third Round Man Shung Acquisition**”, together with the First Round Man Shung Acquisition and the Second Round Man Shung Acquisition, the “**Man Shung Acquisition**”).

Completion of the First Round Man Shung Acquisition and the Second Round Man Shung Acquisition took place on 12 April 2018, while completion of the Third Round Man Shung Acquisition took place on 30 August 2018. After completion of the Man Shung Acquisition, the Group, through the Able Group, owns the entire Man Shung Building. The Man Shung Acquisition will provide a self-owned working space to the Able Group as office, project rooms, rooms for new BEAM and innovation and technology functions, technical workshop and training centre for its expansion. As the Man Shung Building was acquired on “as is” basis, certain units of the property have been leasing to third parties which contributed approximately HK\$7 million to the Group’s rental revenue of this year. Based on current negotiation with the tenants, the latest tenancy will expire/be terminated before December 2019.

The Man Shung Acquisition constituted a major transaction for each of the Company and Able Holdings under Chapter 14 of the Listing Rules. For further details of the Man Shung Acquisition, please refer to the joint announcements of the Company and Able Holdings dated 8 January 2018, 9 February 2018, 12 April 2018 and 28 June 2018, and the circulars of the Company and Able Holdings, both dated 28 March 2018.

### SUBSEQUENT ACQUISITION OF THE WILTSHIRE ROAD PROPERTY

On 11 April 2019, Luck Huge Limited (“**Luck Huge**”, an indirect wholly-owned subsidiary of the Company) entered into a provisional sale and purchase agreement with The Lutheran Church - Missouri Synod for the acquisition of No. 12 Wiltshire Road (the “**Wiltshire Road Property**”), Kowloon, Hong Kong at a consideration of HK\$140 million (the “**Wiltshire Road Acquisition**”). Completion of the Wiltshire Road Acquisition took place on 21 May 2019.

The Wiltshire Road Property is located at the traditional luxury residential area of Kowloon Tong. It comprises a 4-storey domestic property together with garden erected upon a site with site area of approximately 5,235 sq. ft.. It has a saleable area of approximately 7,470 sq. ft. according to Rating and Valuation Department. Given the property’s prime location in the traditional luxury residential area of Kowloon Tong, the Directors are of the view that there is good potential for capital appreciation as well as redevelopment. The Group intends to redevelop the Wiltshire Road Property for rental or long-term appreciation purpose to strengthen the property portfolio of the Group.

於二零一九年四月十一日，Luck Huge Limited (「**Luck Huge**」，本公司之一間間接全資附屬公司)與The Lutheran Church - Missouri Synod訂立臨時買賣協議，以代價1.40億港元收購(「**該渭州道收購事項**」)位於香港九龍九龍塘渭州道12號(「**該渭州道物業**」)。該渭州道收購事項已於二零一九年五月二十一日完成。

該渭州道物業包括一幢樓高4層之住宅物業，連同花園佔地約5,235平方呎。根據差餉物業估價署之數據，其可銷售面積約為7,470平方呎。鑑於該渭州道物業位於九龍塘傳統豪華住宅區之黃金地段，董事認為該物業之資本增值及重建潛力可觀。本集團擬重新開發該渭州道物業作租賃或長期升值用途，以增強本集團的物業組合。

### POSSIBLE RICHREAR ACQUISITION

As disclosed in the Company's announcement dated 8 January 2018, Profit Chain Investments Limited ("Profit Chain", a direct wholly-owned subsidiary of the Company) entered into a conditional share transfer agreement with an independent third party (the "Vendor") on 5 January 2018, pursuant to which, Profit Chain has conditionally agreed to acquire and the Vendor has conditionally agreed to sell the entire equity interest of Richrear International Limited ("RICHREAR INT'L") at a consideration of HK\$150 million (the "Richrear Acquisition").

RICHREAR INT'L is a limited company incorporated in the British Virgin Islands that its sole business is to hold the entire issued share capital of Richrear Plastic Material Limited ("RICHREAR HK", a limited liability company incorporated in Hong Kong) which has been engaged in the processing and trading of plastic materials, pigments and master batch and the holding of the SZ Properties (as defined below). At the same time, RICHREAR HK also owns the entire interests of 富亮塑膠原料(深圳)有限公司 ("RICHREAR SZ"), a company established in the PRC with limited liability and is principally engaged in the processing of plastic materials, pigments and master batch at the SZ Properties.

The SZ Properties refers to a piece of industrial land of approximately 10,000 square metres with six 3-6 storey high buildings and fixtures erected thereon, including an office building, three plants and two staff dormitories located in the Hong Qiao Tou Industrial Estate, Song Gang Sub-district, Baoan District, Shenzhen, the PRC (No. 608 Song Gang Section, China National Highway 107).

Up to the approval date of this annual report, refundable deposits of HK\$45 million in aggregate has been paid to the Vendor, albeit the Richrear Acquisition may or may not proceed. If proceed, it is expected that the Richrear Acquisition will constitute a discloseable transaction of the Company under Chapter 14 of the Listing Rules. Further announcement(s) in relation to the Richrear Acquisition will be made by the Company as and when appropriate in accordance with the Listing Rules.

誠如本公司於日期為二零一八年一月八日的公告所披露，Profit Chain Investments Limited (「Profit Chain」，本公司的一間直接全資附屬公司)於二零一八年一月五日與一獨立第三方(「賣方」)訂立有條件股份轉讓協議，據此，Profit Chain 有條件同意購買而賣方有條件同意出售 Richrear International Limited (「RICHREAR INT'L」)之全部股權，代價1.50億港元(「收購RICHREAR事項」)。

RICHREAR INT'L為一間於英屬維爾京群島註冊成立的有限公司，其唯一業務為持有富亮塑膠原料(顏料)有限公司(「富亮香港」，一間於香港註冊成立的有限公司)之全部已發行股本。富亮香港主要從事製造和銷售塑膠原料、色料及複合母料，其亦持有該等深圳物業(如下文所定義)。同時，富亮香港亦持有富亮塑膠原料(深圳)有限公司(「富亮深圳」)的全部權益。富亮深圳為一間於中國成立之有限公司，其主要業務為於該等深圳物業內進行加工塑膠原料、色料及複合母料。

該等深圳物業指位於中國深圳市寶安區松崗街道洪橋頭工業村的工業用地(107國道松崗段608號)，佔地約10,000平方米；及土地上建有的六幢三至六層高的建築物，包括一幢辦公樓、三幢廠房及兩幢員工宿舍。

截至批准本年度報告之日，共0.45億港元之可退還保證金已支付予賣方，惟收購RICHREAR事項不一定落實進行。如進行收購RICHREAR事項，預期該交易將根據上市規則第十四章構成本公司之一項須予披露交易。本公司將適時根據上市規則就收購RICHREAR事項刊發進一步公告。

### USE OF PROCEEDS FROM THE LISTING OF ABLE HOLDINGS

The Group disposed 25% interests of its contract works business through the separate listing (the “Listing”) of Able Holdings on the Main Board of The Stock Exchange on 20 February 2017. After deducting the underwriting commission and other expenses in relation to the Listing, Able Holdings successfully raised a total net cash proceeds of approximately HK\$524 million from the Listing and approximately HK\$181 million of the net proceeds were unused as at 31 March 2019 (31 March 2018: approximately HK\$386 million). The unused proceeds were deposited in licensed banks in Hong Kong.

According to the section “Future Plans and Proposed Use of Proceeds” as set out in the prospectus of Able Holdings dated 26 January 2017, the Able Group used the net proceeds during the year ended 31 March 2019 as follows:

### EMPLOYEES AND REMUNERATION POLICY

As of 31 March 2019, the Group employed 369 full-time employees (31 March 2018: 404) in Hong Kong. The Group remunerates its employees based on their performance and work experience and with reference to the prevailing market conditions. On top of the regular remuneration, discretionary bonus and share options may be granted to senior management and staff members by reference to the Group's performance, specific project's performance as well as the individual employee's performance. Staff benefits include mandatory provident fund, medical insurance, incentive travel, subsidies for education and training programmes, etc..

At the AGM of the Company held on 7 September 2011, the Company adopted a new share option scheme (the "2011 Scheme") in replacement of its share option scheme which was adopted on 5 August 2002. The purposes of the 2011 Scheme are to provide incentives for the Group's employees and executives, to recognise their contributions to the Group's growth and to provide more flexibility for the Group in formulating its remuneration policy. During the year ended 31 March 2019, the Company did not grant any share options under the 2011 Scheme to the Group's employees (including Directors) (2018: nil). As at 31 March 2019, the Company had 10,080,000 share options (31 March 2018: 10,200,000 share options) outstanding under the 2011 Scheme.

At the respective AGMs of Able Holdings and the Company held on 31 August 2018, the adoption of a share option scheme by Able Holdings (the "Subsidiary Option Scheme") was considered and approved. The purposes of the Subsidiary Option Scheme are to provide incentives for the directors and employees of the members of the Group to work towards enhancing the value of Able Holdings and its shares for the benefit of Able Holdings and its shareholders as a whole. The Subsidiary Option Scheme provides Able Holdings with a flexible means of either retaining, incentivising, rewarding, remunerating, compensating and/or providing benefits to participants of the scheme. From the date of adoption of the Subsidiary Option Scheme and up to 31 March 2019, Able Holdings did not grant any share options under the Subsidiary Option Scheme and no equity-settled share option expense was charged to the profit or loss.

### 僱員及薪酬政策

於二零一九年三月三十一日，本集團於香港聘用369名（於二零一八年三月三十一日：404名）全職僱員。本集團根據僱員之表現、工作經驗及參考現行市場狀況以釐定僱員薪酬。除一般薪酬外，本集團因應其業績、個別項目的業績及僱員之個人表現，或會向高級管理層及僱員授出酌情花紅及購股權。僱員福利包括強制性公積金、醫療保險、獎勵旅遊、教育津貼及培訓計劃等。

於本公司二零一一年九月七日舉行之股東週年大會上，本公司採納一項新購股權計劃（「二零一一年計劃」），以取代其於二零零二年八月五日所採納之購股權計劃。二零一一年計劃旨在獎勵本集團之僱員及行政人員，確認彼等對本集團發展之貢獻，並使本集團於制訂其薪酬政策時具有更大彈性。於截至二零一九年三月三十一日止年度，本公司並無根據二零一一年計劃授出購股權予本集團之僱員（包括董事）（二零一八年：無）。於二零一九年三月三十一日，本公司尚有10,080,000份（於二零一八年三月三十一日：10,200,000份）據二零一一年計劃授出而尚未被行使之購股權。

Corporate governance is the system by which the Company is directed and controlled. The board (the “**Board**”) of directors (the “**Directors**”) of the Company is fully aware of its importance to the shareholders and has developed a rigorous system of checks and balances which allows management to respond to the strategic directions approved by the Board. The Board believes that a well-balanced corporate governance system enables the Company to achieve business excellence and fulfill the Company’s mission.

This report describes the Company’s corporate governance practices and structures that were in place during the financial year ended 31 March 2019, with specific reference to the principles and guidelines of the “Corporate Governance Code and Corporate Governance Report” (the “**CG Code**”) as set out in Appendix 14 to the Rules (the “**Listing Rules**”) Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (The “**Stock Exchange**”). In developing and reviewing its corporate governance policies and practices, the Company has sought to adopt a balanced approach.

### COMPLIANCE WITH THE CG CODE

In the opinion of the Directors, the Company complied with the code provisions as set out in the CG Code throughout the year ended 31 March 2019.

### THE BOARD

The overall management of the Company’s business is vested in the Board, which assumes the responsibility for leadership and control of the Company, and the Directors are collectively responsible for promoting the success of the Company by directing and supervising its affairs and overseeing the achievement of strategic plans to enhance shareholders’ value. The Board has undertaken the corporate governance function as required under the CG Code. The Board is responsible for all major aspects of the Company’s affairs, which includes:

- formulating key policy matters, overall strategic plans and directions, and objectives of the Group;
- monitoring the performance of the management of the Group;
- appointing members and chairman to the Board and the Board Committees;
- implementing and monitoring an effective framework of risk management and internal controls;
- monitoring material transactions (including, in particular, those which may involve conflicts of interest);

### 董事會

本公司業務的整體管理歸屬於董事會，它承擔領導及監管本公司的責任，董事通過指導和監督公司事務及監察戰略的實現以提升股東價值，對促進公司的成功共同負責。董事會按企業管治守則之要求承擔企業管治功能。董事會負責本公司所有類型的主要決策，當中包括：

IP Kwok Him, GBM, GBS, JP (“**The Hon. IP**”) and Mr. FUNG Pui Cheung, Eugene (“**Mr. FUNG**”). Subsequent to the year end, Mr. MONG Chan (“**Mr. MONG**”) has also been appointed as an additional INED with effect from 2 May 2019. Brief biographical details of the Directors are set out in the section “**BIOGRAPHICAL DETAILS OF DIRECTORS AND SENIOR MANAGEMENT**” on pages 40 to 47 of this annual report. A list of Directors and their role and function is also available on the Company’s websites.

When needed and upon making request to the Board, the INEDs may obtain independent professional advice at the Company’s expense in carrying out their duties.

### The INEDs

During the year ended 31 March 2019, the Board at all times met the requirements of the Listing Rules relating to the appointment of at least three INEDs, with at least one INED possessing appropriate professional qualifications, or accounting or related financial management expertise. The Company has also met the requirement of at least one-third of members of the Board being INEDs.

The INEDs of the Company are persons of high caliber, with professional qualifications and experience in the fields of engineering, legislation and accounting and finance. With their experience gained from various sectors, they provide strong support towards the effective discharge of the duties and responsibilities of the Board.

Each of Prof. KO, The Hon. IP, Mr. FUNG and Mr. MONG, all being INEDs of the Company, has made an annual confirmation of independence pursuant to Rule 3.13 of the Listing Rules. The Company is of the view that each of Prof. KO, The Hons. IP, Mr. FUNG and Mr. MONG meets the independence guidelines set out in Rule 3.13 of the Listing Rules and is independent.

The INEDs are appointed for a fixed specific term. Each of Prof. KO, The Hon. IP and Mr. FUNG has served as an INED of the Company for more than 9 years that their further appointment (if any) should be subject to separate resolutions to be approved by shareholders.

### Meetings

Regular Board meetings are held at least four times a year at approximately quarterly intervals. Tentative dates of regular Board meetings for next year are scheduled approaching the end of each calendar year in order to facilitate the Directors to plan for attendance of the meetings. Meetings will also be convened, as and when required, to deal with ad hoc issues.

Any Director who is not able to present physically may participate in any Board meeting through electronic means of communication, such as conference telephone or other similar communication equipment, in accordance with the Bye-laws of the Company.

### 會議

董事會每年最少舉行四次定期會議，約每季一次。翌年董事會定期會議之日期將於每年近年底時擬定，以便董事就出席會議作出安排。董事會於有需要時會另行召開會議，以處理突發事項。

根據本公司之公司細則，任何無法親身出席之董事均可透過電子通訊設備，例如會議電話或其他類似通訊設備，參與任何董事會會議。

Notice convening each regular Board meeting is sent at least 14 days in advance, and reasonable notice is given for other Board meetings. The Company Secretary assists the Chairman of the Board to prepare the meeting notice and agenda. Each Director may include any item in the agenda. The agenda, accompanied by meeting papers with sufficient and reliable information, are sent to each Director not less than 3 days before the date of a Board meeting to enable the Directors to make informed decisions on the matters to be discussed, except where a Board meeting is convened on a very urgent basis to consider any urgent ad hoc matter.

Minutes of Board meetings are recorded in sufficient details regarding the matters considered by the Board at the meetings and decisions reached. Draft minutes of Board meetings are circulated to the Directors for comments and the signed minutes are kept by the Company Secretary and open for inspection to any Director on request.

Each Director is expected to give sufficient time and attention to the affairs of the Company. The individual attendance record of each Director at the general meetings of the Board and the Board Committees, and at the annual general meeting (“AGM”) during the year ended 31 March 2019 are set out below:

The Board is responsible for reviewing the Board composition, developing and formulating the relevant procedures for nomination and appointment of Directors, monitoring the appointment and succession of Directors and assessing the independence of INEDs. The appointment of INEDs adheres to the guidelines for assessing independence as set out in Rule 3.13 of the Listing Rules. The Board, through the Nomination Committee set up in December 2011, reviews from time to time its own structure, size and composition to ensure that it has a balance of appropriate expertise, skills and experience for the needs of the businesses of the Group.

The Company recognises and embraces the benefits of having a diverse Board to enhance the quality of its performance. In 2013, the Board adopted a board diversity policy (the “**Board Diversity Policy**”) upon the recommendation of the Nomination Committee which set out the approach to achieve diversity of Board members. In 2019, the Board also adopted a director nomination policy (the “**Director Nomination Policy**”) upon the recommendation of the Nomination Committee which set out the approach and procedures the Board adopts for the nomination and selection of Directors. A summary of each of the policies is set out in the subsection “Nomination Committee” under the section “BOARD COMMITTEES” in this report.

Mr. MONG was appointed as an INED by the Board with effect from 2 May 2019. In arriving at the decision to nominate Mr. MONG for appointment as an INED, the Nomination Committee had (i) considered the structure, size and skill mix of the Board; (ii) taken measures to identify potential candidates, especially those senior executives who possess the experience and competence commensurate with the position of a director; (iii) considered the independence of Mr. MONG with reference to Rule 3.13 of the Listing Rules; and (iv) the time commitment that Mr. MONG can spend on the INED’s role. Mr. MONG, as a professional accountant, is with extensive senior management experience on sizable institution. The Nomination Committee and the Board considered that Mr. MONG was a suitable candidate.

Except for Mr. MONG who will only enter into a letter of appointment with the Company after the 2019 AGM, the term of office of each of the Directors has been fixed for a specific term for not more than three years. The Directors are subject to retirement by rotation and re-election at the Company’s AGM in accordance with the Company’s Bye-laws.

董事會負責檢討董事會的組成、發展及制定提名及委任董事的相關程序、監督董事之委任及繼任和評估獨立非執行董事的獨立性。獨立非執行董事之委任乃遵守上市規則第3.13條所列有關評估獨立性的指引。通過於二零一一年十二月成立的提名委員會，董事會將不時檢討其自身的架構、規模及組成，以確保董事會具有適當及平衡的專業知識、技能和經驗以符合本集團業務的需求。

本公司明白並深信董事會成員多元化對提升其表現素質大有裨益。於二零一三年，董事會在提名委員會的建議下採納《董事會成員多元化政策》（「董事會成員多元化政策」），文件載列達致董事會成員多元化而採取的方針；於二零一九年，董事會亦在提名委員會的建議下採納《董事提名政策》（「董事提名政策」），文件載列董事會採納以提名及甄選董事的方法及程序。兩份政策的概要已載於本報告內「董事會轄下之委員會」一節項下「提名委員會」之分節中。

蒙先生自二零一九年五月二日起獲董事會委任為獨立非執行董事的。在考慮向董事會提名蒙先生為獨立非執行董事時，提名委員會已 (i) 考慮董事會的架構、人數及技能組合；(ii) 採取措施物色潛任人選，尤其是擁有董事所需之經驗和能力的高級行政人員；(iii) 按上市規則第3.13條所載考慮蒙先生的獨立性；及(iv) 蒙先生可為獨立非執行董事之職務所花之時間。蒙先生為專業會計師，具備豐富大型機構的高級管理層經驗。提名委員會及董事會皆認為蒙先生為合適的獨立非執行董事人選。

除蒙先生（彼將於二零一九年股東週年大會後才與本公司訂立委任函）外，每一名董事之任期訂明為不多於三年。董事須根據本公司之公司細則於本公司股東週年大會上輪值告退及可膺選連任。

Pursuant to clause 86 of the Company's Bye-laws, any Director(s) appointed during the year as an addition to the Board or to fill a casual vacancy on the Board should hold office only until the next coming general meeting of the Company and shall then be eligible for re-election at that meeting. Accordingly, Mr. MONG is subject to retirement and re-election at the next general meeting of the Company.

Pursuant to the Company's Bye-laws, at each AGM, one-third of the Directors for the time being (other than the newly appointed Directors) shall retire from office by rotation. A retiring Director shall be eligible for re-election. The election of each candidate is done through a separate resolution.

The Company has also complied with the requirement of the CG Code on considering the independence of an INED who has served more than 9 years for his further appointment. Prof. KO, The Hon. IP and Mr. FUNG, each has served on the Board for more than 9 years, was re-elected as INEDs at the 2018 AGM by passing separate resolutions at the 2018 AGM. The Board's view on their independent status was set out in the 2018 AGM circular dated 20 July 2018 and the subsection "The INEDs" under the section "THE BOARD" of this report.

Except for Mr. FUNG, who informed the Nomination Committee and the Board that he will not seek for re-election at the forthcoming 2019 AGM subsequent to the approval date of this report, all the above retiring Directors, are eligible and will offer themselves for re-election to serve for another term at the forthcoming AGM.

The Nomination Committee recommended the re-election of Dr. LEE, Prof. KO, The Hon. IP and Mr. MONG to the Board at the 2019 AGM. The Board endorsed the recommendations of the Nomination Committee on re-election. Details with respect to the candidates standing for election as Directors are set out in the AGM circular to shareholders.

The above nomination was made in accordance with the Directors Nomination Policy and the diversity aspects (including without limitation, gender, age, cultural/educational and professional background, skills, knowledge and experience) as set out under the Board Diversity Policy, and with due regard for the benefits to the business and strategy of the Company. The Nomination Committee and the Board, having reviewed the Board's composition, had taken into account the respective contributions of the Directors to the Board and their commitment to their roles. The retiring Directors (as member of the Nomination Committee and/or the Board, as applicable), who offered themselves for re-election at the AGM, abstained from voting on the recommendation on his own re-election throughout the nomination processes.

根據本公司之公司細則第86條，於年度內為增加現有董事的名額或填補董事會內某臨時空缺而獲委任的董事，只任職至下屆股東大會，並有資格於該大會上膺選連任。據此，蒙先生須於本公司下屆股東大會上退任並膺選連任。

根據本公司之公司細則，在每屆股東週年大會上，當時三分之一的董事（不包括新委任的董事）須輪值退任。退任的董事有資格膺選連任。每名候選人的選舉按獨立的決議案逐一表決。

於續任已擔任董事超過九年的獨立非執行董事時，本公司亦已遵守企業管治守則的要求來考慮其獨立性。高教授、葉議員及馮先生均擔任獨立非執行董事超過九年，彼等之重選已於二零一八年股東週年大會上分別以獨立決議案形式通過。董事會對彼等之獨立性的意見已載於日期為二零一八年七月二十日之二零一八年股東週年大會之通函及本報告「董事會」一節項下「獨立非執行董事」之分節。

除馮先生（彼於批准本報告之日後，知會提名委員會及董事會，決定不會於即將舉行的二零一九年股東週年大會上尋求膺選連任）外，所有上述退任董事均符合資格並願意於即將舉行的二零一九年股東週年大會上膺選連任。

提名委員會向董事會建議於二零一九年股東週年大會上重選李醫生、高教授、葉議員及蒙先生。而董事會通過了提名委員會有關重選的建議。各候選董事的資料載於寄予股東的股東週年大會通函內。

上述提名乃根據《董事提名政策》及《董事會多元化政策》所述之多元化方面（包括但不限於性別、年齡、文化／教育和專業背景、技能、知識和經驗）並經適當考慮本公司業務和戰略所需而進行。提名委員會和董事會檢討了董事會的組成，並考慮了各董事對董事會的貢獻及其對其職責的承擔。將於股東週年大會上膺選連任之各退任董事（作為提名委員會成員和／或董事會成員（如適用）），在整個提名過程中並無就與其連任相關的建議投票。

Each of Prof. KO and The Hon. IP has demonstrated his ability to provide an independent view to the Company's matters during his years of service. Notwithstanding their service as INEDs of the Company over 9 years, the Board and the Nomination Committee is of the view that Prof. KO and The Hon. IP are able to continue to fulfill their roles as required and are able to contribute to the diversity of the Board.

Further, the Board and the Nomination Committee have received and reviewed the written confirmations of independence of each INED in June 2019 and are satisfied that each of the INEDs, among others, those who have offered themselves for re-election at the 2019 AGM, namely, Prof. KO, The Hon. IP and Mr. MONG, meets the independence guidelines set out in Rule 3.13 of the Listing Rules and is independent in accordance with the terms of the guidelines having regard to (i) their annual confirmations on independence as required under the Listing Rules; (ii) the absence of involvement in the daily management of the Company; (iii) the absence of any relationships or circumstances which would interfere with the exercise of their independent judgment; and (iv) the absence of remuneration from the Company other than the directors' fees and the share options granted to them (if any). Accordingly, they are recommended by the Board and the Nomination Committee for re-election at the 2019 AGM.

With their breadth and diversity of experience and background as more particularly set out in the section "BIOGRAPHICAL DETAILS OF DIRECTORS AND SENIOR MANAGEMENT" to this annual report, the retiring Directors proposed for re-election at the forthcoming AGM are able to provide valuable and diverse views, as well as relevant insights to the Board and to contribute to the diversity of the Board.

### CHAIRMAN AND CHIEF EXECUTIVE OFFICER

The roles of Chairman and Chief Executive Officer ("CEO") of the Company are performed by Mr. NGAI and Mr. YAU, respectively. This segregation ensures a clear division of the Chairman's responsibilities for the management of the Board and the CEO's responsibilities for the day-to-day management of the Company's business. Mr. NGAI and Mr. YAU are brothers-in-law.

此外，董事會及提名委員會已於二零一九年六月接獲及審閱所有獨立非執行董事就彼等之獨立性發出的書面確認，並認為所有獨立非執行董事（包括將於二零一九年股東週年大會上膺選連任的高教授、葉議員及蒙先生）均符合載於上市規則第3.13條之獨立性指引，並根據該指引條文考慮彼等(i)根據上市規則要求遞交的年度獨立性確認書；(ii)並無參與本公司日常管理；(iii)無任何關係或情況影響而對其行使獨立判斷構成干預；及(iv)除董事袍金及授予他們的購股權(如有)外，本公司並無向彼等支付其他酬金，認為彼等均屬獨立人士。董事會及提名委員會因此推薦彼等於二零一九年股東週年大會上膺選連任。

憑藉各將於股東週年大會上膺選連任的退任董事載於本年度報告「董事及高級管理層履歷」一節中的廣泛而多元化的經驗及背景，彼等能夠為董事會提供寶貴而多元化的意見以及見解，從而為董事會成員多元化做出貢獻。

### 主席及行政總裁

本公司主席及行政總裁（「行政總裁」）的角色分別由魏先生及游先生擔任。主席及行政總裁分開委任之安排確保主席負責管理董事會而行政總裁負責本公司業務的日常管理的清晰區分。游先生為魏先生的妹夫。

The Chairman is responsible for providing leadership for the Board, and ensuring that all Directors are properly briefed on issues arising at Board meetings and that the Directors receive adequate, complete and reliable information in a timely manner. The Chairman has an additional or casting vote in the event of an equality of votes on any matter to be decided by the Board.

The CEO is appointed by the Board and is responsible for providing leadership for the management, implementing and reporting to the Board on the Group's strategy, overseeing the day-to-day operations of the Group and providing all such information to the Board as is necessary to enable the Board to monitor the performance of the management.

According to the then enacted code provision A.2.7 of the CG Code, the Chairman met with the NED and INEDs of the Company for once without the presence of the management and the other Executive Directors on 28 November 2018.

### BOARD COMMITTEES

The Board has set up three Board Committees, namely, the Audit Committee, the Remuneration Committee and the Nomination Committee, to oversee particular aspects of the Company's affairs.

#### Audit Committee

The Company's Audit Committee was established on 8 September 2000 with written terms of reference. The Audit Committee's terms of reference has been revised and adopted on 31 December 2018 and the document is available on the websites of the Company and The Stock Exchange.

As at 31 March 2019, the Audit Committee comprised three INEDs, namely Prof. KO, The Hon. IP and Mr. FUNG. Mr. FUNG is currently the chairman of the Audit Committee. Mr. FUNG is a certified public accountant and possesses the appropriate accounting qualifications and experiences in financial matters. Subsequent to the year end, Mr. MONG, a certified practicing accountant who also possesses the appropriate accounting qualifications and experiences in financial matters, was appointed as a member of the Audit Committee with effect on 2 May 2019.

於二零一八年十一月二十八日，根據於其時適用的企業管治守則的守則條文第A.2.7條，在本公司的管理層及其他執行董事不在場的情況下，主席與本公司的非執行董事及獨立非執行董事進行了一次會面。

### 董事會轄下之委員會

董事會已成立三個董事會之委員會，即審核委員會、薪酬委員會及提名委員會，以監督本公司不同範疇的事務。

#### 審核委員會

本公司之審核委員會於二零零零年九月八日成立，並定立書面職權範圍。審核委員會的職權範圍於二零一八年十二月三十一日經修訂後採納，文件已載於本公司網站及聯交所網站。

於二零一九年三月三十一日，審核委員會由三名獨立非執行董事組成，即高教授、葉議員及馮先生。馮先生現為審核委員會主席。馮先生為會計師，並具有合適的會計資格及財務事宜的經驗。年末後，蒙先生（執業會計師，並具有合適的會計資格及財務事宜的經驗）獲委任為審核委員會的成員，於二零一九年五月二日生效。

The main responsibilities of the Audit Committee are to review the consolidated financial statements and the auditor's report, and to monitor the integrity of the consolidated financial statements. It also assists the Board to oversee risk management and internal control systems and internal and external audit functions. The Audit Committee holds regular meetings at least twice a year and they also meet with the Company's external auditor at least twice a year to discuss the audit plan and to review the Company's reports and accounts. During the year ended 31 March 2019, the Audit Committee held five meetings and the primarily works performed by the Audit Committee were, among others:

- reviewed the unaudited accounts, interim report and interim results announcement of the Company and the Group;
- reviewed the audited accounts and final results announcement of the Company and the Group;
- reviewed the accounting policies and practices adopted by the Company and the Group;
- reviewed and recommended the appointment and reappointment of external auditor;
- approved the scope and plan of internal and external audit;
- reviewed proposed non-audit services according to "Policy on Provision of Non-audit Services by the Group's External Auditor and its Associates";
- reviewed the engagement, services (including non-audit services) provided and remuneration of the external auditor and its independence;
- reviewed the results and effectiveness of the internal and external audit function;
- reviewed and monitored the adequacy and effectiveness of the financial reporting function, risk management system and internal control system of the Group;
- reviewed the continuing connected transactions; and
- reviewed and revised the terms of reference of the Audit Committee.

It is confirmed that there is no disagreement between the Board and the Audit Committee's view on re-appointment of external auditor, and they both have agreed to recommend the re-appointment of Ernst & Young as the Company's external auditor for the ensuing year at the 2019 AGM of the Company.

### Remuneration Committee

The Company's Remuneration Committee was established on 16 December 2005 with written terms of reference and consists of a majority of INEDs. The purpose of the Remuneration Committee is to set policy on Executive Directors' and senior management's remuneration and for making recommendations to the Board on remuneration packages for Directors and senior management. The Remuneration Committee's terms of reference has been revised and adopted on 31 December 2018 and the document is available on the websites of the Company and The Stock Exchange.

As at 31 March 2019, the Remuneration Committee was made up of the three INEDs, namely Prof. KO, The Hon. IP and Mr. FUNG; one NED, namely Dr. LEE (being appointed on 1 September 2017); and one Executive Director, namely Mr. YAU. Prof. KO is the chairman of the Remuneration Committee. Subsequent to the year end, Mr. MONG, has been appointed as a member of the Remuneration Committee with effect on 2 May 2019.

The main responsibility of the Remuneration Committee is to make recommendations to the Board on the remuneration policy and structure for Directors and senior management and their remuneration packages with reference to the Group's corporate goals and strategies. The Remuneration Committee meets at least once a year. During the year ended 31 March 2019, the Remuneration Committee held four meetings and the major works performed by the Remuneration Committee were, among others:

- approved the contract/letter of appointments entered into between the Company and individual Director(s);
- reviewed and made recommendations to the Board on the policy and structure for remuneration of the Directors and senior management;
- reviewed and made recommendations to the Board on the remuneration package, including discretionary performance-based bonus, of individual Director and senior management; and
- reviewed the terms of reference of the Remuneration Committee.

The major duties of the Nomination Committee include reviewing the structure, size and diversity of the Board at least annually and making recommendations on any proposed changes to the Board; identifying individuals suitably and qualified to become Directors; and making recommendations to the Board on the selection of individuals nominated for directorships. The Nomination Committee meets at least once a year. During the year ended 31 March 2019, the Nomination Committee held four meetings. The major works performed by the Nomination Committee were, among others:

- reviewed the structure, size and composition (including the skills, knowledge and experience) of the Board and made recommendations to the Board on the appointment or re-appointment of Directors and succession planning for Directors;
- set up written “Director Nomination Policy”;
- identifying individuals suitably qualified to become members of the Board and putting forward nominations or recommendations to the Board for proposed appointments to the Board;
- assessed the independence of INEDs;
- reviewed time commitment of Directors for performance of their responsibilities;
- reviewed and monitored the training and continuous professional development of Directors;
- reviewed the “Board Diversity Policy” and monitor its implementation; and
- reviewed the terms of reference of the Nomination Committee.

### *Director Nomination Policy*

The Company recognises the importance of having a qualified and competent Board to achieve the Group’s corporate strategy as well as promote shareholders’ value and is committed to ensure that proper nomination and election processes are in place for the selection and nomination of Directors. In March 2019, upon the recommendation of the Nomination Committee, the Board formally adopted a “Director Nomination Policy” which set out the approach and procedures adopted for the nomination and selection of directors, including the appointment of additional Directors, replacement of Directors, and re-election of Directors.

### *董事提名政策*

本公司明白設立合資格及稱職的董事會對實踐本集團的企業策略以及提升股東價值的重要性，本公司會致力確保設有適當的董事提名及甄選程序。於二零一九年三月，經提名委員會的建議下，董事會正式採納一項《董事提名政策》，當中列載提名及甄選董事，包括委任額外董事、替補董事及重選董事的方法及程序。

Pursuant to the Director Nomination Policy, the Nomination Committee assists the Board on the selection and nomination and succession planning for Directors in making recommendations to the Board. The procedures and process in respect of the nomination of Directors are summarised below:

- for appointment of new and replacement Directors: the Nomination Committee shall assess the potential candidates based on the selection criteria as set out in the policy and other appropriate factors and shall make recommendation to the Board. The Board has the authority on determining suitable director candidate for appointment; and
- for re-election of Directors and nomination from shareholders: the Nomination Committee shall make recommendation to the Board/Shareholder on such retiring Director to stand for re-election at a general meeting.

The Nomination Committee shall, consider a variety of factors in making nominations, including but not limited to the following in assessing the suitability of the proposed candidate:

- reputation for integrity;
- the skills, knowledge, experience and professional expertise which are relevant to the operations of the Group;
- commitment in respect of sufficient time, interest and attention and participate in induction on appointment, continuous professional development and other Board associated activities;
- ability to exercise sound business judgement and possess experience in senior management;
- contribute to the Board's diversity with due regard to the diversity perspectives set out in the "Board Diversity Policy" of the Company; and
- compliance with the criteria of independence as set out under the Listing Rules for the consideration of appointment of an INED.

跟據董事提名政策，提名委員會為董事會就甄選及提名董事及董事的繼任計劃向董事會提供協助及建議。提名董事的程序及流程簡述如下：

- 於委任新任及替補董事時：提名委員會應根據甄選準則及其他適合因素評核準候選人，並向董事會提供建議。董事會擁有決定合適董事人選以作出委任的權力；及
- 於重選董事及股東提名時：提名委員會應考慮並（如認為適當）建議董事會／股東考慮該名（退任）人仕在股東大會上候選董事。

提名委員會於衡量候選人是否合適時考慮多項因素，包括但不限於下列各項：

### *Board Diversity Policy*

The “Board Diversity Policy” sets out the approach to achieve diversity of the Board. It is believed that a truly diverse board will include and make good use of differences in a number of factors, including but without limitation, gender, age, cultural, skills, background, experience, knowledge, expertise and other qualities of members of the Board. These differences will be taken into account in determining the optimum composition of the Board. All appointments of Directors will be based on merit and the Nomination Committee will review the Board composition by considering the benefits of all aspects of diversity. The “Board Diversity Policy” shall be reviewed by the Nomination Committee, as appropriate and at least annually, to ensure its effectiveness.

Considered the business needs of the Group, the Nomination Committee considers that the members of the Board have a diverse range of experience and professional expertise, despite most of the Directors have been serving the Company for more than 9 years. Accordingly, the Nomination Committee suggest the appointment of a new Director to the Board and new member to the Board Committees during the year ended 31 March 2019.

In considering the nomination of Mr. MONG as a new INED, the Board Diversity Policy was taken into account and the relevant provisions of the Director Nomination Policy was followed. As Mr. MONG has over 40 years of experience in financial and cost management, accounting, general management and information technology and will contribute to diversity of the Board, the Nomination Committee suggested the appointment of Mr. MONG. The Board accepted the suggestion and Mr. MONG was appointed as an INED and a member of each of the Board Committees with effect on 2 May 2019.

### *董事會成員多元化政策*

《董事會成員多元化政策》載列實現董事會成員多元化之方式。本公司認為，一個真正成員多元化之董事會將融入及善用董事會成員之不同特質，包括但不限於性別、年齡、文化、技能、背景、經驗、知識、專長及其他質素。該等差異將在釐定董事會之最佳組合時納入考量。所有董事的任命均以用人唯才為原則，而提名委員會將透過考慮多元化之所有益處檢討董事會之組成。《董事會成員多元化政策》須由提名委員會（於適當時而最少每年）進行檢討，以確保其有效。

就本集團的業務需要而言，提名委員會認為董事會成員擁有不同領域的經驗及專長，惟大部份董事已服務本公司逾九年。因此，提名委員會於截至二零一九年三月三十一日止年度建議為董事會任命一名新董事及為董事會之委員會任命一名新成員。

在考慮提名蒙先生為一名新獨立非執行董事時，董事會多元化政策已被考慮在內，並已遵循董事提名政策的有關條文。基於蒙先生在財務及成本管理、會計、一般管理及資訊科技方面擁有逾40年經驗，有助於董事會的多元化，提名委員會建議任命蒙先生。董事會接納建議，任命蒙先生為一名獨立非執行董事以及各董事會之委員會的成員，於二零一九年五月二日生效。

The Company continues its effort in providing updates on the changes in the relevant regulatory requirements applicable to the Group from time to time and recommending relevant seminars/conferences/forums to the Directors as and when appropriate.

The Directors acknowledge the need for continuous professional development and confirmed that they had complied with the code provision A.6.5 of the CG Code during the year. All Directors are required to provide the Company with the records of the training they received annually. According to the records maintained by the Company, all Directors pursued continuous professional development during the year ended 31 March 2019 and relevant details are set out below:

### SECURITIES TRANSACTIONS OF DIRECTORS AND EMPLOYEES

The Company has adopted the “Model Code for Securities Transactions by Directors of Listed Issuers” as set out in Appendix 10 of the Listing Rules (the “Model Code”) as the code of conduct regarding the Directors’ securities transactions.

Following specific enquiry made by the Company, all Directors have confirmed that they had complied with the required standard set out in the Model Code throughout the year ended 31 March 2019. Full details of the Directors’ interests in the shares of the Company and its associated corporation are set out on pages 84 to 87 in the “REPORT OF THE DIRECTORS” of this annual report.

The Company has also established written code on no less exacting terms than the Model Code for dealings in the securities of the Company and its associated corporations by employees who are likely to be in possession of unpublished inside information in relation to the Company or any of its associated corporations.

During the year under review, the Company sent notifications to the Directors and employees reminding them of the “black-out period(s)” as specified in the relevant codes during which they are not allowed to deal in the securities of the Company and its associated corporations at the relevant times. All Directors and employees are also bound by corporate policies of the Company to refrain from dealing in the Company’s and its associated corporations’ securities if they are in possession of any inside information of the Group or any of its associated corporations.

### 董事及僱員進行證券交易

### COMPANY SECRETARY

The Company Secretary is to support the Board by ensuring good information flow with the Board as well as the Board policy and procedures being followed. The Company Secretary is also responsible for advising the Board on governance matters and facilitates the professional development of the Directors. Ms. TSANG Hau Lam (“Ms. TSANG”), the Company Secretary, is a full-time employee of the Group and her brief biography is set out on page 49 of this annual report.

Ms. TSANG has confirmed that she has complied with all the qualifications and training requirements of company secretary under the Listing Rules. Ms. TSANG is also the financial controller of the Group.

### RISK MANAGEMENT AND INTERNAL CONTROL

The Board recognises its overall responsibility for maintaining a sound and effective system of risk management and internal control to safeguard the shareholders’ investment and the Company’s assets, ensure the maintenance of proper accounting records and the truth and fairness of the financial statements, ensure compliance with relevant legislation and regulations. The systems are designed to provide reasonable, but not absolute, assurance against material errors, losses and fraud, and manage rather than eliminate risks of failure in the Group’s operational systems and in the achievement of the Group’s business objectives.

The Board has entrusted the Audit Committee with the responsibility to review the risk management and internal control systems of the Group, covering all the departments and business units to monitor, assess and manage various risks in the Group’s business activities.

During the year, the Group’s internal auditor conducted systematic reviews of the Group’s internal control system by using a risk-based approach and review the effectiveness of the Group’s system of internal control against an internal audit plan approved by the Audit Committee. The Chief Executive Officer and any members of the Audit Committee may instruct the internal auditor to undertake internal audit activities of an urgent or sensitive nature. The internal auditor reports directly to the Audit Committee and has free access to review all aspects of the Group’s activities and controlling systems. Internal audit findings and control weaknesses will be summarized and reported to the Audit Committee at least annually. Other Directors are also informed of the findings of and weaknesses identified.

### 公司秘書

### 風險管理及內部監控

董事會已授權審核委員會負責檢討本集團之風險管理及內部監控系統，涵蓋所有部門及業務單位，以監察、評核及管理本集團業務活動的各種風險。

於本年度，本集團的內部審核人員根據審核委員會批准的內部審核計劃，採用以風險為基礎之審核方法，有系統地檢討本集團的內部監控系統的成效。行政總裁及審核委員會的任何成員亦可指示內部審核員進行緊急或具敏感性質的內部審核活動。內部審核員直接向審核委員會報告，並可自由查閱本集團各方面的活動及監控系統。內部審核之結果及發現之監控弱點總結，會向審核委員會作出不少於每年一次的報告，而其他董事亦會獲知有關結果及發現之監控弱點。

A whistle-blowing policy has been put in place for the Group's employees and associates of the Group's business to follow when anyone of them believes reasonably and in good faith that fraud, malpractices, violation of business ethics or improprieties that he/she come across. Further details about the policy are available on the website of the Company.

During the year under review, the Audit Committee, assisted by the management and the internal audit function, had reviewed and evaluated the effectiveness of the Group's risk management system and internal control system for the year ended 31 March 2019. The Audit Committee considered the risk management and internal control systems of the Group were effective and adequate. The Board also reviewed the Group's risk management and internal control systems through discussion with the Audit Committee on audit findings and internal control matters.

Both the Audit Committee and the Board were satisfied that the risk management and internal control systems of the Group of the reporting year were effective and adequate.

### AUDITOR'S REMUNERATION

Ernst & Young was re-appointed by the shareholders of the Company at the AGM held on 31 August 2018 as the Company's external auditor until the next AGM.

During the year, the Company also awarded non-audit services to Ernst & Young and its associates. Through the Audit Committee, the Board monitors the non-audit services performed from its external auditor and its associates to the Group to ensure that the independence and objectivity of the external auditor would not be impaired.

During the year ended 31 March 2019, the Audit Committee set up written "Policy on Provision of Non-audit Services by the Group's External Auditor and its Associates". Pursuant to the policy, all proposed non-audit services of the external auditor or its associates would be reviewed by the Audit Committee before the respective engagement. Accordingly, the Audit Committee reviewed the nature of non-audit services proposed to be performed by Ernst & Young and/or its associates and confirmed that it gave rise to no impairment of actual or perceived independence or objectivity of the audit work itself. The Audit Committee has recommended to the Board the re-appointment of Ernst & Young as independent external auditor of the Company for shareholders' approval at the forthcoming AGM.

於截至二零一九年三月三十一日止年度，審核委員會制定了書面《本集團外聘核數師及其聯繫人提供非審計服務的政策》。根據該政策，審核委員會將審批所有委聘外聘核數師或其聯繫人進行非審核服務的建議。據此，審核委員會檢視擬委聘安永會計師事務所及／或其聯繫人進行的非審計工作的性質，確認審計工作的獨立性或客觀性並無因而受到任何實際或預期的負面影響。審核委員會已向董事局提出續聘安永會計師事務所為獨立核數師的建議，以供股東於即將舉行的股東週年大會批准。

### COMMUNICATIONS WITH SHAREHOLDERS

The Company is endeavouring to maintain a high level of transparency in communication with shareholders and investors in general. The Company has formally adopted a "Shareholder" Communication Policy", which is available on the website of the Company, since 12 September 2012. The various channels via which the Company communicates with its shareholders include interim and annual reports, information on The Stock Exchange's and the Company's websites, and general meetings.

Shareholders are encouraged to attend the Company's general meetings where the Chairman, and other members of the Board are available to answer questions. Separate resolutions are proposed at the general meetings on each substantially separate issue, including the re-election of individual Directors.

### SHAREHOLDERS' RIGHTS

#### Right to convene special general meeting

In accordance with Article 58 of the Bye-laws of the Company, any shareholder holding not less than one-tenth of the paid-up capital of the Company carrying the right of voting at general meetings shall have the right, by written requisition served to the Board or the Company Secretary, to require a special general meeting to be convened by the Board for transaction of any business specified in such requisition. The requisition should state the general nature of the business to be dealt with, and may include the text of a resolution that may properly be moved and is intended to be moved at the meeting, and such meeting shall be held within two (2) months after the deposit of such requisition. If within twenty-one (21) days of such deposit the Board fails to proceed to convene such meeting, the requisitionists themselves may do so in accordance with the provisions of Section 74(3) of the Companies Act 1981 of Bermuda, as amended from time to time.

The board (the “Board”) of directors (the “Directors”) of the Company are pleased to present their report together with the audited consolidated financial statements of the Group for the year ended 31 March 2019.

### PRINCIPAL ACTIVITIES

The principal activities of the Company are investment holding and the provision of corporate management services. Details of the principal activities of the Group’s principal subsidiaries are set out in note 1 to the audited consolidated financial statements. There were no significant changes in the nature of the Group’s principal activities during the year.

### BUSINESS REVIEW

A review of the business of the Group during the year, an analysis of the Group’s financial performance during the year using financial key performance indicators, a discussion on the Group’s future business development and a description of the principal risks and uncertainties facing by the Group are provided in this report and the “MANAGEMENT DISCUSSION AND ANALYSIS” section of this annual report on pages 22 to 39. Also, the Group’s financial risk management objectives and policies are set out in note 43 to the audited consolidated financial statements.

A summary of the published results and the consolidated statements of financial position of the Group for the last five financial years, as extracted from the audited consolidated financial statements and restated/reclassified as appropriate, together with performance indicators of the relevant reporting periods, is set out in the “FIVE-YEAR FINANCIAL SUMMARY” section of this annual report on pages 6 to 10. This summary does not form part of the audited consolidated financial statements.

The Group is committed to be an environmentally-responsible corporation with the aim to conserve the environment while making reasonable returns. The Group has operated an environmental management system which complies with international standards and will continuously encourage our business partners, suppliers and sub-contractors to follow the same standards. Further information of the Group’s policies and performance about the environment would be included in the “Environmental, Social and Governance Report” of the Company to be published within three months from the date of this annual report. During the year ended 31 March 2019, there were no material breach of or non-compliance with applicable laws and regulations by the Group that have significant impact on the businesses and operations of the Group.

### RESULTS AND DIVIDENDS

The Group's profit for the year ended 31 March 2019 and the Group's financial position at that date are set out in the audited consolidated financial statements and the notes thereunder on pages 103 to 232 of this annual report.

No interim dividend was paid or declared by the Company during this year (2018: nil). At the Company's annual general meeting ("AGM") held on 31 August 2018, shareholders approved the payment of a final dividend of HK2 cents per ordinary share for the year ended 31 March 2018 which amounted to a total of approximately HK\$33,659,000. The dividend was paid on 21 September 2018.

The Board recommends the payment of a final dividend of HK2 cents (2018: HK2 cents) per ordinary share for the year ended 31 March 2019 to the shareholders whose names appear on the register of members of the Company on 10 September 2019, Tuesday. The proposed payment of the final dividend is subject to the approval of the Company's shareholders at the forthcoming 2019 AGM of the Company and has not been recognised as a liability as at 31 March 2019.

Based on the 1,682,966,400 ordinary shares of the Company in issue as of the approval date of this annual report, the total final dividend amounted to approximately HK\$33,659,000.

### AGM AND CLOSURE OF REGISTER OF MEMBERS

The 2019 AGM of the Company will be held in Hong Kong on 28 August 2019, Wednesday. Notice of the AGM will be issued and disseminated to the shareholders in due course.

To ascertain the entitlement to attend and vote at the 2019 AGM, the register of members of the Company will be closed from 23 August 2019, Friday to 28 August 2019, Wednesday (both days inclusive) during which period no transfer of shares will be registered. In order to qualify for attending and voting at the 2019 AGM, all share transfer documents accompanied by the relevant share certificates must be lodged with the Company's branch share registrar in Hong Kong, Tricor Tengis Limited at Level 54, Hopewell Centre, 183 Queen's Road East, Hong Kong, for registration not later than 4:30 pm on 22 August 2019, Thursday.

In order to qualify for the final dividend, all share transfer documents accompanied by the relevant share certificates must be lodged with the Company's branch share registrar in Hong Kong, Tricor Tengis Limited at Level 54, Hopewell Centre, 183 Queen's Road East, Hong Kong for registration not later than 4:30 pm on 6 September 2019, Friday. It is expected that the final dividend will be payable to those entitled shareholders on or before 20 September 2019, Friday.

### DIVIDEND POLICY

To enhance transparency of Company in the recommendation and declaration of dividend, the Board has approved and adopted a written dividend policy on 18 March 2019 (the "Dividend Policy"). Under the Dividend Policy, the Board shall endeavor to strike a balance between providing immediate return to the shareholders through the payment of dividends whilst retaining adequate reserves as the Group's working capital and for the Group's future growth.

Pursuant to the Dividend Policy, in deciding whether to propose or declare a dividend and in determining the dividend amount and means of payment, the Board shall take into account, among others:

- the actual and expected financial performance of the Group;
- the Group's liquidity position;
- the capital and debt level of the Group;
- retained earnings and distributable reserves of the Company and major subsidiaries of the Group; and
- the working capital requirements, capital expenditure requirements and future development plans of the Group.

### RISK MANAGEMENT

Under the Group's internal control and risk management framework, the Board has entrusted the Audit Committee with the responsibility to review the risk management and internal control systems of the Group. Other than the significant accounting judgements and estimates and the financial risk management policies of the Group set out in note 4 and note 43 to the audited consolidated financial statements, the Group is also exposed to other key risks factors and uncertainties, among others:

#### Business and Market Risk

Demand for services and products of the Group is cyclical in nature and directly correlates with the level of real estate development, construction activities, liquidity demands and general economic environment in Hong Kong. In respect of the Group's contract works business, it relies heavily on public sector projects which by their nature are only awarded by a limited number of customers who are normally the Hong Kong Special Administrative Region ("HKSAR") Government and/or various institutional bodies. There is no guarantee that our customers will provide the Group with new business or that we will secure new customers.

The Group's business and profitability may be materially and adversely affected by failure to tender for new contract works, any material reduction in spending by the HKSAR Government or various institutional bodies on public sector works and/or delay in awarding contracts of such works by the HKSAR Government. In respect of the Group's property investment and development business, growth and sustainable of the business may be materially and adversely affected by failure to replenish development projects, significant drop in property prices, shortage of land supply and other investment opportunities, changes in government policies or economic downturn.

### 風險管理

根據本集團的內部監控和風險管理框架，董事會已委託審核委員會負責審查本集團的風險管理及內部監控制度。除載於經審核綜合財務報表附註4及附註43的本集團的主要會計判斷及估計及財務風險管理政策外，本集團亦面臨其他關鍵風險因素及不確定性(當中包括)：

#### 業務和市場風險

本集團的服務和產品需求呈週期性，與香港的房地產開發、建設活動、資金流動性需求和總體經濟環境水平直接相關。就合約工程業務而言，本集團主要倚賴公營項目，其特性為只透過數目有限並一般為香港特別行政區(「香港特區」)政府及/或各機構組織的客戶取得項目。本集團無法保證客戶將給予我們新的業務，或我們將取得新客戶。

如果無法取得新合約工程、香港特區政府或其他機構組織大幅削減公營工程開支及/或香港特區政府延遲批出工程合同，均可能對本集團的業務及盈利能力造成重大不利影響。就本集團的物業投資及發展業務而言，增長和可持續發展或會因未能發展新項目、物業價值大幅下降、土地供應短缺及其他投資機會的不足、政府政策的轉變或經濟衰退而有重大負面影響。

### Compliance Risk

The Group is exposed to compliance risk in relation to various rules and regulations, including but not limited to rules and regulations in relation to construction, labour, occupational health and safety, environmental protection, money lending, contractor registration and listing. Noncompliance may lead to fine, suspension of works/trading in securities, suspension of tender, legal sanctions, material claims, loss in reputation and/or loss of business. The Group pays high attention to the enactment and amendment of laws and regulations which may cause legal or business risks to the Group's business and will arrange appropriate training and experience sharing activities for relevant employees. The Group also launched a safety promotion campaign "Safety • My Habit" since last year to promote safety awareness and invested in the provision of self-owned safety tools for sub-contractors' or suppliers' use in high risk operations like lifting.

### Construction Risk

In respect of the contract works business, the Group is exposed to construction risk in relation to price fluctuation, duration of works, quality of work, environmental protection and safety involved in the construction business, which may adversely affect the Group's profitability. The Group manages and mitigates these risks through risk transfer, improve communication between project teams with project estimation and procurement department and implementation of management system which meets international standards.

### Risk on Reliance of Key Management Personnel

The Group's success and growth depends on our ability to identify, hire, train and retain suitable, skilled and qualified employees, including management personnel with the requisite industry expertise. The Directors and members of senior management, in particular, the executive Directors, are important to the Group. If any of the executive Directors cease to be involved in the management of the Group and the Group is unable to find suitable replacements in a timely manner, there could be an adverse impact on our business, results of operation and profitability of the Group.

### 合規風險

本集團面臨各種法例與法規的合規風險：包括但不限於有關建築、勞工、職業健康與安全、環境保護、提供融資、承建商註冊及上市的法例與法規。不合規的行為可能引致罰款、暫停施工／股份交易、停止投標、法律制裁、重大索賠、有損之聲譽及／或損失業務等結果。本集團非常關注可能為本集團帶來法律或營運風險的法律與法規的制定和修改，並會為有需要之僱員安排合適的培訓及經驗分享。本集團亦已於去年起推出安全推廣活動「安全•我的習慣」，以提升安全意識，並投放資源為分判商或供應商的高風險作業（如吊運）提供自置安全用具。

### 施工風險

就合約工程業務而言，本集團面臨有關價格波動、工程時間、施工質量、環保及安全等與建築業務相關的施工風險，或會對本集團的盈利能力造成不利影響。本集團通過風險轉移、加強施工隊伍與項目評估及採購部門之間的溝通，以及實施符合國際標準的管理系統等措施來管理及減輕這些風險。

### 依賴主要管理人員的風險

本集團的成功與發展取決於我們物色、聘用、培訓及挽留適當、熟練及合資格僱員的能力，包括具備所需行業專業知識的管理人員。董事及高級管理層成員（尤其是執行董事）對本集團非常重要。若任何該等執行董事日後不再參與管理本集團，而本集團未能及時覓得適當替代人選，則可能對本集團的業務、經營業績及盈利能力造成不利影響。

### Business Partners Risk

The Group relies on third-party sub-contractors and service providers in certain parts of its business. The management realises that such operational dependency may pose a threat of vulnerability to unexpected poor or lapses in service including reputation damage, business disruption and monetary losses. In addition, some of the Group's businesses are conducted through joint ventures or joint operations in which the Group shares control with other business partners. The relevant risks include that these business partners may not continue their relationships with the Group, take actions against the Group's interests, do not work for the Group's interest, undergo a change of control or not fulfil their obligations under the joint ventures or joint operations. To address such uncertainties, the Group only engages/cooperates with reputable and experienced business partners and closely monitors their performance.

### Cyber and Information Security Risk

Frequency of cyber-attacks like sophisticated phishing campaigns and ransomware continued to increase in recent years. The potential threat of a cyber-attack is increasing. Cyber-attacks may lead to loss of information, leakage of confidential information, unavailability of systems and disruption of operation that significant costs may be incurred for data recovery and system restoration, and/or possible claims. The Group manages this risk by implement security measures such as firewall, anti-spam and anti-virus protection, and increase internal communication of cyber and information security threats to raise staff awareness.

## PROPERTY, PLANT AND EQUIPMENT

Details of movements in the Group's property, plant and equipment during the year are set out in note 14 to the audited consolidated financial statements. Further details of the Group's land and buildings are set out on page 17 of this annual report.

## INVESTMENT PROPERTIES

All of the Group's investment properties were revalued by an independent professional valuer as at 31 March 2019 using the fair value model. Details of movements in the Group's investment properties during the year are set out in note 16 to the audited consolidated financial statements. Further details of the Group's investment properties are set out on page 17 of this annual report.

### 業務夥伴風險

本集團依賴第三方分判商及服務供應商提供若大部分的業務。管理層清楚營運方面有所依賴或會令本集團在服務突然轉差或出現真空期時，容易受到不利影響，包括聲譽受損、業務中斷及金錢損失。此外，本集團部分業務乃與其他業務夥伴合作的合營企業或共同經營進行，相關風險包括該等業務夥伴或未能與本集團維持其合作關係、向本集團採取不利行動、不以本集團利益而行事、控制權變更或未能履行其於合營安排或共同經營的責任等。針對有關不明朗因素，本集團僅會聘請或與信譽良好及富經驗之業務夥伴合作，並會密切監察其表現。

### 網絡及信息安全風險

近年來，「網絡釣魚」及勒索軟件等複雜的網絡攻擊個案有上升趨勢，而網絡攻擊的潛在風險亦日增。網絡攻擊或會引致信息丟失、洩漏機密資料、系統失靈及業務中斷。復修數據及復原系統成本不菲，亦可能引致索賠。本集團通過實施防火牆、反垃圾郵件和防病毒保護等安全措施來管理這一風險，並增強內部有關網絡及信息安全威脅的溝通以提高員工意識。

### 物業、機器及設備

本集團之物業、機器及設備於本年度之變動詳情載於經審核綜合財務報表附註14。本集團之土地及樓宇之進一步詳情載於本年度報告第17頁。

### 投資物業

所有本集團之投資物業已由一名獨立專業估值師採用公允值模式重估其於二零一九年三月三十一日之價值。本集團之投資物業於本年度之變動詳情載於經審核綜合財務報表附註16。本集團之投資物業之進一步詳情載於本年度報告第17頁。

### DISTRIBUTABLE RESERVES

At 31 March 2019, the Company's reserves available for distribution, calculated in accordance with the Companies Act 1981 of Bermuda (as amended), amounted to HK\$650,131,000 (31 March 2018: HK\$380,234,000). In addition, the Company's "share premium" account, in the amount of HK\$253,274,000 at 31 March 2019 (31 March 2018: HK\$253,274,000), may be distributed in the form of fully paid bonus shares.

### DONATIONS

During the year, the Group made charitable and other donations of approximately HK\$223,000 (2018: HK\$2,633,000).

### MAJOR CUSTOMERS AND SUPPLIERS

The Group recognises the importance of maintaining good relationships with customers, suppliers and sub-contractors to achieve its long-term business growth and development. Accordingly, the Group has kept good communications and shared business updates with business partners when appropriate.

For the year ended 31 March 2019, the Group's five largest customers are all from the contract works segment. Contract works revenue earned from these customers accounted for approximately 99% (2018: 98%) of the total contract works revenue for the year and contract works revenue earned from the largest customer included therein accounted for approximately 80% (2018: 85%). Three (2018: four) out of the five largest customers are from the public sector. The Group has not entered into any long-term framework agreements with any of these major customers.

Costs paid to the Group's five largest suppliers/sub-contractors accounted for approximately 16% (2018: 14%) of the total sub-contracting charges and material costs incurred for the year. Amount paid to the largest supplier/sub-contractor included therein accounted for approximately 6% (2018: 4%).

None of the Directors, their close associates, or any shareholder (which to the knowledge of the Directors own more than 5% of the Company's issued share capital) has any interest in the Group's five largest customers and suppliers/sub-contractors.

At the AGM of the Company held on 7 September 2011, the shareholders of the Company approved the adoption of the 2011 Scheme and the termination of the share option scheme adopted by the Company on 5 August 2002. Unless otherwise terminated or amended, the 2011 Scheme will remain in force for ten years from the date of adoption.

From the adoption date of the 2011 Scheme to 31 March 2019, the Company granted 25,620,000 share options under the 2011 Scheme to the Group's employees (including the Directors). Particulars of the 2011 Scheme of the Company are disclosed in note 32 to the audited consolidated financial statements.

As at 31 March 2019, the Company had 10,080,000 share options (31 March 2018: 10,200,000 share options) outstanding under the 2011 Scheme. Each share option entitles the holder to subscribe for one ordinary share of the Company. The exercise in full of the outstanding share options would, under the present share capital structure of the Company, result in the issue of 10,080,000 additional ordinary shares of the Company, which represented approximately 0.60% of the Company's shares in issue as at that date, and result in additional "share capital" of approximately HK\$252,000 and "share premium" of approximately HK\$5,050,000 (before issue expenses).

### 2.1 BASIS OF PREPARATION

These financial statements have been prepared in accordance with Hong Kong Financial Reporting Standards (“HKFRSs”) (which include all Hong Kong Financial Reporting Standards, Hong Kong Accounting Standards (“HKASs”) and Interpretations) issued by the Hong Kong Institute of Certified Public Accountants (the “HKICPA”), accounting principles generally accepted in Hong Kong and the disclosure requirements of the Hong Kong Companies Ordinance. They have been prepared under the historical cost convention, except for investment properties and a derivative financial instrument, which have been measured at fair value.

These financial statements are presented in Hong Kong dollars (“HK\$”), which is the Company’s functional and presentation currency, and all values are rounded to the nearest thousand (HK\$’000) except when otherwise indicated.

#### Basis of consolidation

The consolidated financial statements include the financial statements of the Company and its subsidiaries for the year ended 31 March 2019. A subsidiary is an entity (including a structured entity), directly or indirectly, controlled by the Company. Control is achieved when the Group is exposed, or has rights, to variable returns from its involvement with the investee and has the ability to affect those returns through its power over the investee (i.e., existing rights that give the Group the current ability to direct the relevant activities of the investee).

When the Company has, directly or indirectly, less than a majority of the voting or similar rights of an investee, the Group considers all relevant facts and circumstances in assessing whether it has power over an investee, including:

- (a) the contractual arrangement with the other vote holders of the investee;
- (b) rights arising from other contractual arrangements; and
- (c) the Group's voting rights and potential voting rights.

The financial statements of the subsidiaries are prepared for the same reporting period as the Company, using consistent accounting policies. The results of subsidiaries are consolidated from the date on which the Group obtains control, and continue to be consolidated until the date that such control ceases.

Profit or loss and each component of other comprehensive income are attributed to the owners of the parent of the Group and to the non-controlling interests, even if this results in the non-controlling interests having a deficit balance. All intra-group assets and liabilities, equity, income, expenses and cash flows relating to transactions between members of the Group are eliminated in full on consolidation.

The Group reassesses whether or not it controls an investee if facts and circumstances indicate that there are changes to one or more of the three elements of control described above. A change in the ownership interest of a subsidiary, without a loss of control, is accounted for as an equity transaction.

#### HKFRS 9 *Financial Instruments*

HKFRS 9 *Financial Instruments* replaces HKAS 39 *Financial Instruments: Recognition and Measurement* for annual periods beginning on or after 1 January 2018, bringing together all three aspects of the accounting for financial instruments: classification and measurement, impairment and hedge accounting.

With the exception of hedge accounting, which the Group has applied prospectively, the Group has recognised the transition adjustments against the applicable opening balances in equity at 1 April 2018. Therefore, the comparative information was not restated and continues to be reported under HKAS 39.

#### (a) *Classification and measurement*

Upon the adoption of HKFRS 9, the Group's loans and receivables are reclassified as financial assets at amortised cost and the accounting for the Group's financial liabilities remains largely the same as it was under HKAS 39.

#### (b) *Impairment*

The Group has six types of financial assets that are subject to HKFRS 9's new expected credit loss ("ECL") model:

- Accounts receivable;
- Contract assets;
- Loans and interest receivables;
- Financial assets included in prepayments, other receivables and other assets;
- Amount due from a joint venture; and
- Cash and cash equivalents

The Group was required to revise its impairment methodology under HKFRS 9 for each of these classes of assets. The restatement of the loss allowance for these classes of assets on transition to HKFRS 9 as a result of applying the ECL model was not significant. Therefore, the carrying amounts for these classes of assets and the retained profits at 1 April 2018 have not been impacted by the initial application of HKFRS 9. Further details are disclosed in notes 17, 22, 23, 24, 25 and 43 to the financial statements.

就二零一八年一月一日或以後開始的年度期間，香港財務報告準則第9號「金融工具」取代香港會計準則第39號「金融工具：確認及計量」，匯集金融工具會計處理的三大方面：分類及計量、減值及對沖會計。

除本集團以未來適用法應用對沖會計外，本集團已經在二零一八年四月一日的權益確認各適用期初結餘的過渡調整。因此，概無重列比較資料，而是繼續根據香港會計準則第39號呈報。

#### (a) *分類及計量*

於採用香港財務報告準則第9號後，本集團的貸款和應收款項重新分類為以攤餘成本計量的金融資產；而本集團的金融負債之會計處理則與按香港會計準則第39號所規定的無重大分別。

#### (b) *減值*

##### (c) *Hedge accounting*

The requirements related to hedge accounting would better align the accounting treatments with risk management activities and enable entities to better reflect these activities in their financial statements. It relaxes the requirements for assessing hedge effectiveness which more risk management strategies may be eligible for hedge accounting. It also relaxes the rules on using non-derivative financial instruments as hedging instruments and allows greater flexibility on hedged items. Users of the financial statements will be provided with more relevant information about risk management and the effect of hedge accounting on the financial statements. The adoption of the hedge accounting requirements of HKFRS 9 has had no impact on the Group's financial statements as the Group does not have any hedge accounting.

#### HKFRS 15 *Revenue from Contracts with Customers*

HKFRS 15 and its amendments replace HKAS 11 *Construction Contracts*, HKAS 18 *Revenue* and related interpretations and it applies, with limited exceptions, to all revenue arising from contracts with customers. HKFRS 15 establishes a new five-step model to account for revenue arising from contracts with customers. Under HKFRS 15, revenue is recognised at an amount that reflects the consideration to which an entity expects to be entitled in exchange for transferring goods or services to a customer. The principles in HKFRS 15 provide a more structured approach for measuring and recognising revenue. The standard also introduces extensive qualitative and quantitative disclosure requirements, including disaggregation of total revenue, information about performance obligations, changes in contract assets and liabilities account balances between periods and key judgements and estimates. The disclosures are included in notes 4 and 6 to the financial statements. As a result of the application of HKFRS 15, the Group has changed the accounting policy with respect to revenue recognition in note 3 to the financial statements.

##### (c) 對沖會計

有關對沖會計的規定將令會計處理與風險管理活動更趨一致，令企業的財務報表更能反映其於該等活動的情況。有關規定放寬了對評估對沖有效性的要求，令更多的風險管理策略或可符合使用對沖會計；亦放寬了使用非衍生金融工具作對沖工具的要求；並提高可被對沖項目的彈性。財務報表使用者將可獲取更多有關風險管理的資訊，以及對沖會計對財務報表的影響。由於本集團並無任何對沖會計處理，因此，採用香港財務報告準則第9號的對沖會計規定對本集團的財務報表並無產生任何影響。

#### 香港財務報告準則第15號「與客戶之間的合約產生的收入」

香港財務報告準則第15號及其修訂取代香港會計準則第11號「建造合約」、香港會計準則第18號「收入」及相關詮釋，除有限的例外情況外，其適用於所有與客戶之間的合約產生的收入。香港財務報告準則第15號訂立就與客戶之間的合約產生的收入核算的新的五步法模型。根據香港財務報告準則第15號，收入應按反映實體預期有權就轉移商品或服務予客戶所換取之代價的金額來確認。香港財務報告準則第15號內的原則為計量及確認收入提供更具結構的方法。準則亦引進廣泛的描述性及定量披露要求，包括總收入的分析、有關履行義務的資料、合約資產和負債賬戶結餘於各期間的變動，以及重大判斷和估計。有關披露包括在財務報表附註4及6內。由於應用香港財務報告準則第15號，本集團已經更改財務報表附註3內有關收入確認的會計政策。

- (i) Recognition of contract costs  
Prior to the adoption of HKFRS 15, the Group mainly accounted for revenue from contract works using the percentage of completion method, measured by reference to the percentage of certified value of work performed to date to the total contract sum of the relevant contract. Profit was only recognised when the work was sufficiently advanced such that the costs to complete and the revenue could be reliably estimated. Contract costs were recognised according to the project's overall profit estimation using the percentage of completion method. Where contract costs incurred to date plus recognised profits less recognised losses exceeded progress billings, the surplus was treated as an amount due from customers for contract works. Where progress billings exceeded contract costs incurred to date plus recognised profits less recognised losses, the surplus was treated as accruals of contract works.

Upon the adoption of HKFRS 15, revenue from contract works will continue to be recognised over time when the Group creates or enhances an asset that the customer controls over time in accordance with the direct measurements of the value transferred by the Group to the customer with reference to the certified value of work performed to date. Costs that relate to satisfied performance obligations in a contract will be recognised to profit or loss immediately when work is performed, together with any provision of expected contract loss.

As a result of this change in accounting policy, the effect of the change has led to a decrease in gross amount due from customers for contract works amounting to HK\$17,306,000; a decrease in accruals of costs for contract works amounting to HK\$224,360,000; an increase in other payables and accruals amounting to HK\$96,524,000; an increase in tax payable amounting to HK\$18,237,000; an increase in retained profits amounting to HK\$69,220,000; and an increase in non-controlling interests amounting to HK\$23,073,000 as at 1 April 2018.

At as 31 March 2019, the effect of the change has led to a decrease in gross amount due from customers for contract works amounting to HK\$10,746,000; a decrease in accruals of costs for contract works amounting to HK\$394,727,000; an increase in other payables and accruals amounting to HK\$362,579,000; an increase in tax payable amounting to HK\$3,531,000; an increase in retained profits amounting to HK\$13,404,000; and an increase in non-controlling interests amounting to HK\$4,467,000.

Prior to the adoption of HKFRS 15, unbilled revenue resulting from construction contracts and retention receivables were classified as accounts receivable; and certain unbilled expenses recoverable from customers for the sale of properties were classified as other receivables. Upon adoption of HKFRS 15, these balances are reclassified to contract assets.

Therefore, upon adoption of HKFRS 15, the Group reclassified HK\$94,350,000 from receipts in advance in other payables and accruals to contract liabilities in other payables and accruals as at 1 April 2018 in relation to the consideration received from customers in advance as at 1 April 2018.

As at 31 March 2019, there was no receipts in advance in relation to the consideration received from customers in advance for the sale of properties.

In addition to the adjustments described above, other items of the primary financial statements such as tax payable and non-controlling interests were adjusted as necessary and retained profits were adjusted accordingly.

Amendments to HKFRS 3 clarify and provide additional guidance on the definition of a business. The amendments clarify that for an integrated set of activities and assets to be considered a business, it must include, at a minimum, an input and a substantive process that together significantly contribute to the ability to create output. A business can exist without including all of the inputs and processes needed to create outputs. The amendments remove the assessment of whether market participants are capable of acquiring the business and continue to produce outputs. Instead, the focus is on whether acquired inputs and acquired substantive processes together significantly contribute to the ability to create outputs. The amendments have also narrowed the definition of outputs to focus on goods or services provided to customers, investment income or other income from ordinary activities. Furthermore, the amendments provide guidance to assess whether an acquired process is substantive and introduce an optional fair value concentration test to permit a simplified assessment of whether an acquired set of activities and assets is not a business. The Group expects to adopt the amendments prospectively from 1 April 2020.

Amendments to HKFRS 10 and HKAS 28 (2011) address an inconsistency between the requirements in HKFRS 10 and in HKAS 28 (2011) in dealing with the sale or contribution of assets between an investor and its associate or joint venture. The amendments require a full recognition of a gain or loss when the sale or contribution of assets between an investor and its associate or joint venture constitutes a business. For a transaction involving assets that do not constitute a business, a gain or loss resulting from the transaction is recognised in the investor's profit or loss only to the extent of the unrelated investor's interest in that associate or joint venture. The amendments are to be applied prospectively. The previous mandatory effective date of amendments to HKFRS 10 and HKAS 28 (2011) was removed by the HKICPA in January 2016 and a new mandatory effective date will be determined after the completion of a broader review of accounting for associates and joint ventures. However, the amendments are available for adoption now.

香港財務報告準則第3號(修訂)對業務的定義進行了澄清並提供額外指引。該項修訂明確了如果要構成一項業務，一組整合的活動和資產必須至少包括一項投入和一項實質性過程，二者可以共同顯著促進創造產出的能力，業務可以不具備所有創造產出所需的投入和過程。該修訂刪除了對市場參與者是否有能力購買業務並能持續產生產出的評估，轉而重點關注所取得的投入和所取得的實質性過程是否共同顯著促進創造產出的能力。該修訂縮小了產出的定義範圍，重點關注於向顧客提供的商品或服務、投資收益或其他日常活動收入。此外，該修訂為實體評估所取得的過程是否為實質性過程提供了指引，並引入了可選的公平價值集中度測試，允許對所取得的一組活動和資產是否不構成業務進行簡化評估。本集團預期將會由二零二零年四月一日起按未來適用法採用修訂。

香港財務報告準則第10號及香港會計準則第28號(二零一一年)(修訂)旨在解決香港財務報告準則第10號與香港會計準則第28號(二零一一年)對關於投資者與其聯營企業或合營企業之間資產出售或投入的不同處理規定。該修訂規定，當投資者向聯營企業或合營企業出售或投入資產構成一項業務，則相關的收益或虧損應予全額確認；如果上述資產交易不構成一項業務，則交易產生的收益或虧損以其他不相關投資者在聯營企業或合營企業的利益為限在投資者的損益內進行確認。修訂須按未來適用法應用。香港會計師公會已經於二零一六年一月移除香港財務報告準則第10號及香港會計準則第28號(二零一一年)(修訂)先前的強制生效日期，新的強制生效日期將會於對聯營企業及合營企業的會計處理所作更廣泛的審視完成後釐定。然而，修訂現已可供採用。

HKFRS 16 replaces HKAS 17 *Leases*, HK(IFRIC)-Int 4 *Determining whether an Arrangement contains a Lease*, HK(SIC)-Int 15 *Operating Leases – Incentives* and HK(SIC)-Int 27 *Evaluating the Substance of Transactions Involving the Legal Form of a Lease*. The standard sets out the principles for the recognition, measurement, presentation and disclosure of leases and requires lessees to recognise assets and liabilities for most leases. The standard includes two elective recognition exemptions for lessees – leases of low-value assets and short-term leases. At the commencement date of a lease, a lessee will recognise a liability to make lease payments (i.e., the lease liability) and an asset representing the right to use the underlying asset during the lease term (i.e., the right-of-use asset). The right-of-use asset is subsequently measured at cost less accumulated depreciation and any impairment losses unless the right-of-use asset meets the definition of investment property in HKAS 40, or relates to a class of property, plant and equipment to which the revaluation model is applied. The lease liability is subsequently increased to reflect the interest on the lease liability and reduced for the lease payments. Lessees will be required to separately recognise the interest expense on the lease liability and the depreciation expense on the right-of-use asset. Lessees will also be required to remeasure the lease liability upon the occurrence of certain events, such as change in the lease term and change in future lease payments resulting from a change in an index or rate used to determine those payments. Lessees will generally recognise the amount of the remeasurement of the lease liability as an adjustment to the right-of-use asset. Lessor accounting under HKFRS 16 is substantially unchanged from the accounting under

HKAS 17. Lessors will continue to classify all leases using the same classification principle as in HKAS 17 and distinguish between operating leases and finance leases. HKFRS 16 requires lessees and lessors to make more extensive disclosures than under HKAS 17. Lessees can choose to apply the standard using either a full retrospective or a modified retrospective approach. The Group will adopt HKFRS 16 from 1 April 2019. The Group plans to adopt the transitional provisions in HKFRS 16 to recognise the cumulative effect of initial adoption as an adjustment to the opening balance of retained earnings at 1 April 2019 and will not restate the comparatives. In addition, the Group plans to apply the new requirements to contracts that were previously identified as leases applying HKAS 17 and measure the lease liability at the present value of the remaining lease payments, discounted using the Group's incremental borrowing rate at the date of initial application. The right-of-use asset will be measured at the amount of the lease liability, adjusted by the amount of any prepaid or accrued lease payments relating to the lease recognised in the statement of financial position immediately before the date of initial application. The Group plans to use the exemptions allowed by the standard on lease contracts whose lease terms end within 12 months as of the date of initial application. As at 31 March 2019, the Group has non-cancellable operating lease commitments of HK\$402,000 as disclosed in note 38(b) to the financial statements. A preliminary assessment indicates that these arrangements will meet the definition of a lease. Upon application of HKFRS 16, the Group will recognise a right-of-use asset and a corresponding liability in respect of these leases.

Amendments to HKAS 1 and HKAS 8 provide a new definition of material. The new definition states that information is material if omitting, misstating or obscuring it could reasonably be expected to influence decisions that the primary users of general purpose financial statements make on the basis of those financial statements. The amendments clarify that materiality will depend on the nature or magnitude of information. A misstatement of information is material if it could reasonably be expected to influence decisions made by the primary users. The Group expects to adopt the amendments prospectively from 1 April 2020. The amendments are not expected to have any significant impact on the Group's financial statements.

Amendments to HKAS 28 clarify that the scope exclusion of HKFRS 9 only includes interests in an associate or joint venture to which the equity method is applied and does not include long-term interests that in substance form part of the net investment in the associate or joint venture, to which the equity method has not been applied. Therefore, an entity applies HKFRS 9, rather than HKAS 28, including the impairment requirements under HKFRS 9, in accounting for such long-term interests. HKAS 28 is then applied to the net investment, which includes the long-term interests, only in the context of recognising losses of an associate or joint venture and impairment of the net investment in the associate or joint venture. The Group expects to adopt the amendments on 1 April 2019 and will assess its business model for such long-term interests based on the facts and circumstances that exist on 1 April 2019 using the transitional requirements in the amendments. The Group also intends to apply the relief from restating comparative information for prior periods upon adoption of the amendments.

香港會計準則第28號(修訂)澄清,香港財務報告準則第9號的範圍例外僅包括應用權益法的在聯營公司或合營企業中的權益,而不包括實質上構成聯營公司或合資企業淨投資的一部分的長期權益(其並無應用權益法)。因此,實體對該等長期權益的會計處理,應應用香港財務報告準則第9號,包括香港財務報告準則第9號下對減值的要求,而非香港會計準則第28號。然後,僅在確認聯營公司或合營企業的虧損以及聯營公司或合營企業淨投資的減值時,才應用香港會計準則第28號於淨投資,包括長期權益。本集團預期將會由二零一九年四月一日起採用修訂,並將根據修訂中的過渡規定,基於二零一九年四月一日存在的事實和情況,評估其有關長期權益的商業模式。本集團亦擬於採用修訂時應用無須重列以前期間比較資料的寬免。

HK(IFRIC)-Int 23 addresses the accounting for income taxes (current and deferred) when tax treatments involve uncertainty that affects the application of HKAS 12 (often referred to as “uncertain tax positions”). The interpretation does not apply to taxes or levies outside the scope of HKAS 12, nor does it specifically include requirements relating to interest and penalties associated with uncertain tax treatments. The interpretation specifically addresses (i) whether an entity considers uncertain tax treatments separately; (ii) the assumptions an entity makes about the examination of tax treatments by taxation authorities; (iii) how an entity determines taxable profits or tax losses, tax bases, unused tax losses, unused tax credits and tax rates; and (iv) how an entity considers changes in facts and circumstances. The interpretation is to be applied retrospectively, either fully retrospectively without the use of hindsight or retrospectively with the cumulative effect of application as an adjustment to the opening equity at the date of initial application, without the restatement of comparative information. The Group expects to adopt the interpretation from 1 April 2019. The interpretation is not expected to have any significant impact on the Group’s financial statements.

#### Investments in joint ventures

A joint venture is a type of joint arrangement whereby the parties that have joint control of the arrangement have rights to the net assets of the joint venture. Joint control is the contractually agreed sharing of control of an arrangement, which exists only when decisions about the relevant activities require the unanimous consent of the parties sharing control.

The Group's investments in joint ventures are stated in the consolidated statement of financial position at the Group's share of net assets under the equity method of accounting, less any impairment losses. Adjustments are made to bring into line any dissimilar accounting policies that may exist.

The Group's share of the post-acquisition results and other comprehensive income of joint ventures are included in the consolidated statement of profit or loss and other comprehensive income. In addition, when there has been a change recognised directly in the equity of the joint ventures, the Group recognises its share of any changes, when applicable, in the consolidated statement of changes in equity. Unrealised gains and losses resulting from transactions between the Group and its joint ventures are eliminated to the extent of the Group's investments in the joint ventures, except where unrealised losses provide evidence of an impairment of the assets transferred. Goodwill arising from the acquisition of joint ventures is included as part of the Group's investments in joint ventures.

If an investment in a joint venture becomes an investment in an associate, the retained interest is not remeasured. Instead, the investment continues to be accounted for under the equity method. In all other cases, upon loss of the joint control over the joint venture, the Group measures and recognises any retained investment at its fair value. Any difference between the carrying amount of the joint venture upon loss of joint control and the fair value of the retained investment and proceeds from disposal is recognised in profit or loss.

#### 於合營企業的投資

合營企業是一種合營安排，據此，對安排享有共同控制的各方對合營企業的淨資產享有權利。共同控制指在合約上同意分享安排的控制權，這只有在關於相關活動的決定需要分享控制權各方一致同意時存在。

本集團於合營企業的投資在綜合財務狀況表中，以根據會計的權益法核算的本集團所佔淨資產份額減去減值虧損後的餘額列賬。可能存在的不同的會計政策已經調整一致。

本集團應佔合營企業收購後業績和其他全面收益計入綜合損益及其他全面收益表中。此外，當直接在合營企業的權益中確認變動時，本集團會在綜合權益變動表內確認其應佔的任何變動（如適用）。本集團與其合營企業進行交易而出現的未實現損益會互相抵銷，金額以本集團於合營企業的投資為限，但如果未實現虧損證明所轉讓資產發生減值則除外。收購合營企業產生的商譽包括在本集團於合營企業的投資內。

如果於合營企業的投資變為於聯營公司的投資，則不會重新計量保留權益。取而代之，該項投資會繼續根據權益法核算。在所有其他情況下，本集團不再對合營企業有共同控制權時，本集團會按其公平價值計量及確認任何保留投資。合營企業於喪失共同控制權時的賬面金額與所保留投資的公平價值及出售所得款項兩者之間的任何差額會在損益中確認。

#### Interests in joint operations

A joint operation is a joint arrangement whereby the parties that have joint control of the arrangement have rights to the assets, and obligations for the liabilities, relating to the arrangement.

The Group recognises in relation to its interest in a joint operation:

- its assets, including its share of any assets held jointly;
- its liabilities, including its share of any liabilities incurred jointly;
- its revenue from the sale of its share of the output arising from the joint operation;
- its share of the revenue from the sale of the output by the joint operation; and
- its expenses, including its share of any expenses incurred jointly.

The assets, liabilities, revenues and expenses relating to the Group's interests in joint operations are accounted for in accordance with the HKFRSs applicable to the particular assets, liabilities, revenues and expenses.

#### 於共同經營的權益

共同經營指一種共同安排，當中，對安排擁有共同控制的各方擁有與安排相關的資產的權利和承擔與安排相關的負債的義務。

本集團就其於共同經營的權益確認：

- 其資產，包括其在任何共同持有的資產中所佔的份額；
- 其負債，包括其在任何共同發生的負債中所佔的份額；
- 其從銷售其在共同經營所產生的產出中所佔的份額而賺取的收入；
- 其在共同經營銷售產出所賺取的收入中所佔的份額；及
- 其開支，包括其在任何共同發生的開支中所佔的份額。

#### Business combinations and goodwill

Business combinations are accounted for using the acquisition method. The consideration transferred is measured at the acquisition date fair value which is the sum of the acquisition date fair values of assets transferred by the Group, liabilities assumed by the Group to the former owners of the acquiree and the equity interests issued by the Group in exchange for control of the acquiree. For each business combination, the Group elects whether to measure the non-controlling interests in the acquiree that are present ownership interests and entitle their holders to a proportionate share of net assets in the event of liquidation at fair value or at the proportionate share of the acquiree's identifiable net assets. All other components of non-controlling interests are measured at fair value. Acquisition-related costs are expensed as incurred.

When the Group acquires a business, it assesses the financial assets and liabilities assumed for appropriate classification and designation in accordance with the contractual terms, economic circumstances and pertinent conditions as at the acquisition date. This includes the separation of embedded derivatives in host contracts of the acquiree.

If the business combination is achieved in stages, the previously held equity interest is remeasured at its acquisition date fair value and any resulting gain or loss is recognised in profit or loss.

Any contingent consideration to be transferred by the acquirer is recognised at fair value at the acquisition date. Contingent consideration classified as an asset or liability is measured at fair value with changes in fair value recognised in profit or loss. Contingent consideration that is classified as equity is not remeasured and subsequent settlement is accounted for within equity.

#### 企業合併與商譽

企業合併採用購買法進行核算。企業合併所轉移的代價按收購日公平價值計量，其為本集團為換取被收購方控制權而轉讓給被收購方前持有者的資產、本集團所承擔的負債及本集團發行的股本權益於收購日的公平價值的總和。每次企業合併，有關為目前所有者權益及賦予其持有者在清盤時可按比例分得淨資產的於被收購方的非控制性權益，本集團可選擇以公平價值或被收購方可辨認淨資產的應佔比例計算。非控制性權益的所有其他組成部分均按公平價值計量。收購相關成本於發生時支銷。

當本集團收購一個企業，會在收購日根據合同條款、經濟狀況以及相關狀況來評估對金融資產和承擔的負債進行合適分類或指定，包括將被收購企業嵌入衍生工具從主合同中進行分離。

如企業合併分階段進行，之前持有的股權按其於收購日期的公平價值重新計量，產生的任何損益在損益中確認。

將由收購方轉讓的任何或有代價都應按照購買日的公平價值進行確認。分類為資產或負債的或有代價按公平價值計量，其公平價值變動在損益中確認。分類為權益的或有代價不重新計量，其之後的結算在權益中入賬。

Goodwill is initially measured at cost, being the excess of the aggregate of the consideration transferred, the amount recognised for non-controlling interests and any fair value of the Group's previously held equity interests in the acquiree over the identifiable net assets acquired and liabilities assumed. If the sum of this consideration and other items is lower than the fair value of the net assets acquired, the difference is, after reassessment, recognised in profit or loss as a gain on bargain purchase.

After initial recognition, goodwill is measured at cost less any accumulated impairment losses. Goodwill is tested for impairment annually or more frequently if events or changes in circumstances indicate that the carrying value may be impaired. The Group performs its annual impairment test of goodwill as at 31 March. For the purpose of impairment testing, goodwill acquired in a business combination is, from the acquisition date, allocated to each of the Group's cash-generating units, or groups of cash-generating units, that are expected to benefit from the synergies of the combination, irrespective of whether other assets or liabilities of the Group are assigned to those units or groups of units.

Impairment is determined by assessing the recoverable amount of the cash-generating unit (group of cash-generating units) to which the goodwill relates. Where the recoverable amount of the cash-generating unit (group of cash-generating units) is less than the carrying amount, an impairment loss is recognised. An impairment loss recognised for goodwill is not reversed in a subsequent period.

商譽初始按成本計量，即是所轉移的代價、確認的非控制性權益金額以及本集團原先持有的被收購方的股本權益的公平價值總和超過所收購可辨認淨資產和所承擔負債的部分。如果該代價和其他項目的總金額低於所收購淨資產的公平價值，其差額在再次評估後在損益確認為廉價購買收益。

初始確認之後，商譽以成本減去累計減值虧損來計量。商譽的賬面價值需每年進行評估是否發生減值，如果事件或情況的改變表明賬面價值可能出現減值，則需要進行更頻繁的複查。本集團在每年三月三十一日進行年度商譽減值測試。為了進行減值測試，企業合併取得的商譽自收購日起，分配給本集團的每一個預期能從企業合併協同獲益的現金產出單元或現金產出單元組，無論本集團的其他資產或負債是否被分配給上述單元或單元組。

Where goodwill has been allocated to a cash-generating unit (or group of cash-generating units) and part of the operation within that unit is disposed of, the goodwill associated with the operation disposed of is included in the carrying amount of the operation when determining the gain or loss on the disposal. Goodwill disposed of in these circumstances is measured based on the relative value of the operation disposed of and the portion of the cash-generating unit retained.

##### Fair value measurement

The Group measures its investment properties at fair value at the end of each reporting period. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The fair value measurement is based on the presumption that the transaction to sell the asset or transfer the liability takes place either in the principal market for the asset or liability, or in the absence of a principal market, in the most advantageous market for the asset or liability. The principal or the most advantageous market must be accessible by the Group. The fair value of an asset or a liability is measured using the assumptions that market participants would use when pricing the asset or liability, assuming that market participants act in their economic best interest.

A fair value measurement of a non-financial asset takes into account a market participant's ability to generate economic benefits by using the asset in its highest and best use or by selling it to another market participant that would use the asset in its highest and best use.

The Group uses valuation techniques that are appropriate in the circumstances and for which sufficient data are available to measure fair value, maximising the use of relevant observable inputs and minimising the use of unobservable inputs.

#### 企業合併與商譽 (續)

如果商譽分配至現金產出單元(現金產出單元組)，且該單元業務的一部分被處置，在確定處置損益時，與被處置業務相關的商譽將包括在該業務的賬面金額。在這種情況下處置的商譽以被處置的業務和被保留的現金產出單元的相對值為基礎計量。

#### 公平價值計量

本集團在每個報告期末按公平價值計量其投資物業。公平價值是指市場參與者在計量日的有序交易中，出售一項資產所能收到或者轉移一項負債所需支付的價格。公平價值計量乃基於出售資產或者轉移負債的交易在相關資產或負債的主要市場進行，或在不存在主要市場的情況下，則在相關資產或負債的最有利市場進行的假定。主要市場(或最有利市場)應當是本集團能夠進入的市場。資產或負債的公平價值乃基於市場參與者在對該資產或負債定價時(假設市場參與者以實現其經濟利益最大化的方式行事)所採用的假設計量。

非金融資產的公平價值計量會考慮市場參與者透過以最大限度使用該資產達致最佳用途，或透過將該資產出售給能夠以最大限度使用該資產達致最佳用途的其他市場參與者產生經濟利益的能力。

本集團採用在當前情況下適用並且有足夠可利用數據支持的估值技術去計量公平價值，儘量使用相關可觀察輸入值及儘量減少使用不可觀察輸入值。

All assets and liabilities for which fair value is measured or disclosed in the financial statements are categorised within the fair value hierarchy, described as follows, based on the lowest level input that is significant to the fair value measurement as a whole:

Level 1 – based on quoted prices (unadjusted) in active markets for identical assets or liabilities

Level 2 – based on valuation techniques for which the lowest level input that is significant to the fair value measurement is observable, either directly or indirectly

Level 3 – based on valuation techniques for which the lowest level input that is significant to the fair value measurement is unobservable

For assets and liabilities that are recognised in the financial statements on a recurring basis, the Group determines whether transfers have occurred between levels in the hierarchy by reassessing categorisation (based on the lowest level input that is significant to the fair value measurement as a whole) at the end of each reporting period.

在財務報表內計量或披露公平價值的所有資產及負債，均根據對公平價值計量整體而言具有重要意義的最低層次輸入值在下述公平價值層次內進行分類：

第二層次 – 基於對公平價值計量而言具有重要意義的最低層次輸入值乃直接或間接可觀察的估值技術

#### Impairment of non-financial assets

Where an indication of impairment exists, or when annual impairment testing for an asset is required (other than properties held for development, properties under development, properties held for sale, deferred tax assets, financial assets and investment properties), the asset's recoverable amount is estimated. An asset's recoverable amount is the higher of the asset's or cash-generating unit's value in use and its fair value less costs of disposal, and is determined for an individual asset, unless the asset does not generate cash inflows that are largely independent of those from other assets or groups of assets, in which case the recoverable amount is determined for the cash-generating unit to which the asset belongs.

An impairment loss is recognised only if the carrying amount of an asset exceeds its recoverable amount. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset. An impairment loss is charged to profit or loss in the period in which it arises, unless the asset is carried at a revalued amount, in which case the impairment loss is accounted for in accordance with the relevant accounting policy for that revalued asset.

An assessment is made at the end of each reporting period as to whether there is an indication that previously recognised impairment losses may no longer exist or may have decreased. If such an indication exists, the recoverable amount is estimated. A previously recognised impairment loss of an asset other than goodwill is reversed only if there has been a change in the estimates used to determine the recoverable amount of that asset, but not to an amount higher than the carrying amount that would have been determined (net of any depreciation/amortisation) had no impairment loss been recognised for the asset in prior years. A reversal of such an impairment loss is credited to profit or loss in the period in which it arises, unless the asset is carried at a revalued amount, in which case the reversal of the impairment loss is accounted for in accordance with the relevant policy for that revalued asset.

#### 非金融資產減值

如果存在減值跡象，或當資產須進行週年減值測試時（持有作發展之物業、發展中物業、持有作出售之物業、遞延稅項資產、金融資產及投資物業除外），會估計資產的可收回金額。資產的可收回金額以資產或現金產生單位的使用價值與其公平價值減出售成本兩者中的較高者計算，並以個別資產釐定，除非資產並不獨立於其他資產或資產組合產生現金流入，在此情況下，可收回金額乃以資產所屬現金產生單位釐定。

只有當資產賬面值超過其可收回金額時，方會確認減值虧損。估計使用價值時，會採用反映對貨幣時間價值和該資產特有風險的當時市場評價的稅前折現率對該估計未來現金流量進行折現為現值。減值虧損會在其出現期間在損益中扣除，除非資產按重估價值，在該情況下，減值虧損會根據重估資產的有關會計政策入賬。

於各報告期末均會評估是否有跡象顯示於過往確認的減值虧損可能不再存在或可能已減少。如出現有關跡象，則會估計可收回金額。只有在確定資產的可收回金額中所使用的估計發生改變時，才能轉回以前已確認的資產減值虧損（不包括商譽），然而，由於資產減值虧損的轉回而增加的資產賬面值，不應高於資產以前年度沒有確認減值虧損時的賬面值（扣除任何折舊／攤銷）。這種減值虧損的轉回在其出現期間貸記於損益中，除非該資產按重新估價金額計量，這種情況下，根據重新估價資產的相關會計政策對減值虧損的轉回進行會計處理。

##### Property, plant and equipment and depreciation

Property, plant and equipment are stated at cost less accumulated depreciation and any impairment losses. The cost of an item of property, plant and equipment comprises its purchase price and any directly attributable costs of bringing the asset to its working condition and location for its intended use.

Expenditure incurred after items of property, plant and equipment have been put into operation, such as repairs and maintenance, is normally charged to profit or loss in the period in which it is incurred. In situations where the recognition criteria are satisfied, the expenditure for a major inspection is capitalised in the carrying amount of the asset as a replacement. Where significant parts of property, plant and equipment are required to be replaced at intervals, the Group recognises such parts as individual assets with specific useful lives and depreciates them accordingly.

Changes in the values of revalued property, plant and equipment are dealt with as movements in the property revaluation reserve. If the total of this reserve is insufficient to cover a deficit, on an individual asset basis, the excess of the deficit is charged to profit or loss. Any subsequent revaluation surplus is credited to profit or loss to the extent of the deficit previously charged.

#### 物業、機器及設備及折舊

物業、機器及設備乃按原值減累計折舊及任何減值虧損列賬。物業、機器及設備項目之原值包括其購買價及任何將資產達致其現有運作狀況及地點作擬定用途之直接成本。

在物業、機器及設備項目投入運作後產生之支出，如維修與保養等，一般於支出期間的損益中扣除。如果符合確認準則，則主要檢查的支出會作為替換資本化於資產賬面值。如果物業、機器及設備的主要部分須定期替換，則本集團確認有關部分為獨立資產，其具有特定的使用年限及據此折舊。

重估物業、機器及設備的價值變動作為資產重估儲備變動處理。就單個資產而言，如果該儲備合計不足抵消赤字，則赤字超出的部分扣自損益。任何後續重估盈餘以之前扣除的赤字為限計入損益。

Depreciation is calculated on the straight-line basis to write off the cost of each item of property, plant and equipment to its residual value over its estimated useful life. The principal annual rates used for this purpose are as follows:

Buildings	Over the shorter of the remaining term of the land lease and 40 years
Leasehold improvements	Over the shorter of the lease term and 20%
Machinery and equipment	20% to 24%
Furniture, fixtures and office equipment	20% to 33%
Motor vehicles	24% to 30%

Where parts of an item of property, plant and equipment have different useful lives, the cost of that item is allocated on a reasonable basis among the parts and each part is depreciated separately. Residual values, useful lives and the depreciation method are reviewed, and adjusted if appropriate, at least at each financial year end.

An item of property, plant and equipment including any significant part initially recognised is derecognised upon disposal or when no future economic benefits are expected from its use or disposal. Any gain or loss on disposal or retirement recognised in profit or loss in the year the asset is derecognised is the difference between the net sales proceeds and the carrying amount of the relevant asset.

折舊乃以直線法按其估計可使用年期撇銷各項物業、機器及設備項目的成本至其殘值。就此而言所採用之主要年率如下：

當一項物業、機器及設備的各部份具有不同的可使用年期，該項目的成本依照合理的基準分配予各部份，而每部份會分開折舊。殘值、可使用年期及折舊方法會最少於各財政年度結算日檢討及調整(如合適)。

一項物業、機器及設備(包括初始確認的任何重大部分)在出售時或預期不會從其使用或出售獲得未來經濟利益時終止確認。任何出售或報廢損益會於資產終止確認年度按相當於有關資產的出售所得款項淨額與賬面值的差額在損益中確認。

#### Investment properties

Investment properties are interests in land and buildings (including the leasehold interest under an operating lease for a property which would otherwise meet the definition of an investment property) held to earn rental income and/or for capital appreciation, rather than for use in the production or supply of goods or services or for administrative purposes; or for sale in the ordinary course of business. Such properties are measured initially at cost, including transaction costs. Subsequent to initial recognition, investment properties are stated at fair value, which reflects market conditions at the end of the reporting period.

Gains or losses arising from changes in the fair values of investment properties are included in profit or loss in the year in which they arise.

Any gains or losses on the retirement or disposal of an investment property are recognised in profit or loss in the year of the retirement or disposal.

#### Properties held for development

Properties held for development are stated at cost less impairment losses. These properties are reclassified as properties under development or investment properties, as appropriate, when development commences.

Properties held for development are classified as non-current assets as the construction period of the relevant property development project is expected to complete beyond the normal operating cycle.

#### 投資物業

投資物業為於持有作賺取租金收入及／或資本增值，而非作生產或供應貨品或服務或作行政用途，亦非作通常業務運作過程中出售的土地及樓宇權益（包括物業經營租賃的租賃權益，而有關物業如非根據經營租賃租出，則符合投資物業的定義）。該等物業初始按成本（包括交易費用）計量。於初始確認後，投資物業按反映報告期末市場狀況的公平價值列值。

投資物業公平價值變動所產生的損益包括在出現年度的損益中。

報廢或出售投資物業的任何損益於報廢或出售年度的損益中確認。

#### 持有作發展之物業

持有作發展之物業以成本減去減值虧損列值。該等物業於發展開始時恰當地重新分類為發展中物業或投資物業。

由於有關物業發展項目的建築期預期超過正常經營周期方完成，因此，持有作發展之物業分類為非流動資產。

#### Properties under development

Properties under development for sale are included under current assets and are stated at the lower of cost and net realisable value. Cost comprises acquisition costs, construction costs, interest and other direct attributable costs.

Properties under development are classified as current assets as the construction period of the relevant property development project is expected to complete within the normal operating cycle. On completion, the properties are transferred to properties held for sale.

Net realisable value is determined by reference to the estimated selling price less estimated total cost of the development and the estimated costs necessary to make the sale of the properties.

#### Properties held for sale

Properties held for sale are stated at the lower of cost and net realisable value. Net realisable value represents the estimated selling price in the ordinary course of business less the estimated costs necessary to make the sale of the properties.

#### Leases

Leases that transfer substantially all the rewards and risks of ownership of assets to the Group, other than legal title, are accounted for as finance leases. At the inception of a finance lease, the cost of the leased asset is capitalised at the present value of the minimum lease payments and recorded together with the obligation, excluding the interest element, to reflect the purchase and financing. Assets held under capitalised finance leases, including prepaid land lease payments under finance leases, are included in property, plant and equipment, and depreciated over the shorter of the lease terms and the estimated useful lives of the assets. The finance costs of such leases are charged to profit or loss so as to provide a constant periodic rate of charge over the lease terms.

#### 發展中物業

擬出售的發展中物業將會計入流動資產項下，並按成本與可變現淨值（兩者以較低者為準）列賬。成本包括收購成本、建築成本、利息及其他的直接成本。

由於有關物業發展項目的建築期預期於正常經營周期內完成，因此，發展中物業分類為流動資產。完成時，有關物業會轉撥至持有作出售之物業。

可變現淨值乃參考估計售價減估計發展成本總額及估計用以銷售物業的必要成本後釐定。

#### 持有作出售之物業

持有作出售之物業按成本與可變現淨值兩者中的較低者列值。可變現淨值相當於在通常業務運作過程中的估計售價減估計用以銷售物業的必要成本。

#### 租賃

凡將資產所有權之絕大部份回報及風險（法定所有權除外）轉移至本集團之租約，均視作融資租賃。融資租賃開始時，租賃資產之成本即按最低應付租金之現值資本化，並連同負債（不計利息部份）一併記錄，以反映購置及融資。根據已資本化之融資租賃持有之資產（包括融資租賃的預付土地租賃付款額）會列入物業、機器及設備，並按該等資產之租賃期和估計可用年期兩者中較短者內進行折舊。該等租約之融資成本自損益中扣除，以得出一個於租約期間內之固定週期支銷率。

#### Leases (continued)

Leases where substantially all the rewards and risks of ownership of assets remain with the lessor are accounted for as operating leases. Where the Group is the lessor, assets leased by the Group under operating leases are included in non-current assets, and rentals receivable under the operating leases are credited to profit or loss on the straight-line basis over the lease terms. Where the Group is the lessee, rentals payable under the operating leases net of any incentives received from the lessor are charged to profit or loss on the straight-line basis over the lease terms.

#### Investments and other financial assets (policies under HKFRS 9 applicable from 1 April 2018)

##### *Initial recognition and measurement*

Financial assets are classified, at initial recognition, as subsequently measured at amortised cost and fair value through profit or loss.

The classification of financial assets at initial recognition depends on the financial asset's contractual cash flow characteristics and the Group's business model for managing them. With the exception of accounts receivable that do not contain a significant financing component or for which the Group has applied the practical expedient of not adjusting the effect of a significant financing component, the Group initially measures a financial asset at its fair value, plus in the case of a financial asset not at fair value through profit or loss, transaction costs. Accounts receivable that do not contain a significant financing component or for which the Group has applied the practical expedient are measured at the transaction price determined under HKFRS 15 in accordance with the policies set out for "Revenue recognition (applicable from 1 April 2018)" below.

In order for a financial asset to be classified and measured at amortised cost, it needs to give rise to cash flows that are solely payments of principal and interest on the principal amount outstanding.

#### 租賃 (續)

凡資產所有權之絕大部份回報及風險仍由出租人承擔之租約，均視為經營租賃。倘本集團為出租人，本集團根據經營租賃出租之資產列入非流動資產內，而經營租賃之應收租金，乃按租賃期以直線法列入損益內；倘本集團為承租人，經營租賃之應付租金扣除出租人提供的任何優惠在租賃期內乃按直線法計入損益內。

#### 投資及其他金融資產 (根據香港財務報告準則第9號由二零一八年四月一日起適用的政策)

##### *初始確認和計量*

在初始確認時，金融資產分類為後續以攤餘成本計量以及以公平價值計量且其變動計入損益。

金融資產於初始確認時的分類取決於金融資產的合約現金流量特徵以及本集團管理金融資產的業務模式。除未包含重大融資成分或本集團已應用便於實務操作的方法不就重大融資成分的影響作出調整的應收賬款外，本集團初始以其公平價值計量金融資產，如果不是以公平價值計量且其變動計入損益的金融資產，則還應加上交易費用。未包含重大融資成分或本集團已應用便於實務操作的方法的應收賬款以根據香港財務報告準則第15號根據下文「收入確認 (由二零一八年四月一日起適用)」所載政策釐定的交易價格計量。

金融資產如要分類為以攤餘成本計量，其產生的現金流量須僅為對本金和未償付本金金額為基礎的利息支付。

#### *Initial recognition and measurement (continued)*

The Group's business model for managing financial assets refers to how it manages its financial assets in order to generate cash flows. The business model determines whether cash flows will result from collecting contractual cash flows, selling the financial assets, or both.

All regular way purchases and sales of financial assets are recognised on the trade date, that is, the date that the Group commits to purchase or sell the asset. Regular way purchases or sales are purchases or sales of financial assets that require delivery of assets within the period generally established by regulation or convention in the marketplace.

#### *Subsequent measurement*

The subsequent measurement of financial assets depends on their classification as follows:

#### *Financial assets at amortised cost (debt instruments)*

The Group measures financial assets at amortised cost if both of the following conditions are met:

- The financial asset is held within a business model with the objective to hold financial assets in order to collect contractual cash flows.
- The contractual terms of the financial asset give rise on specified dates to cash flows that are solely payments of principal and interest on the principal amount outstanding.

Financial assets at amortised cost are subsequently measured using the effective interest method and are subject to impairment. Gains and losses are recognised in profit or loss when the asset is derecognised, modified or impaired.

#### *初始確認和計量(續)*

本集團管理金融資產的業務模式，是指如何管理金融資產以產生現金流量。業務模式決定現金流量的來源是收取合約現金流量、出售金融資產還是兩者兼有。

所有常規購買和出售金融資產於交易日(即本集團承諾購買或銷售該資產之日)確認。常規購買或出售金融資產指購買或出售需要在一般由法規或市場慣例確定的期間內移交資產。

#### *後續計量*

金融資產的後續計量視乎其分類如下：

#### *以攤餘成本計量的金融資產(債務工具)*

本集團將同時符合下列條件的金融資產，分類為以攤餘成本計量的金融資產：

- 管理該金融資產的業務模式是以收取合約現金流量為目標。
- 該金融資產的合約條款規定，在特定日期產生的現金流量，僅為對本金和以未償付本金金額為基礎的利息的支付。

以攤餘成本計量的金融資產後續使用實際利率法計量，並可予減值。收益及虧損在資產終止確認、修改或減值時在損益內確認。

#### *Financial assets at fair value through profit or loss*

Financial assets at fair value through profit or loss include financial assets held for trading, financial assets designated upon initial recognition at fair value through profit or loss, or financial assets mandatorily required to be measured at fair value. Financial assets are classified as held for trading if they are acquired for the purpose of selling or repurchasing in the near term. Derivatives, including separated embedded derivatives, are also classified as held for trading unless they are designated as effective hedging instruments. Financial assets with cash flows that are not solely payments of principal and interest are classified and measured at fair value through profit or loss, irrespective of the business model. Notwithstanding the criteria for debt instruments to be classified at amortised cost or at fair value through other comprehensive income, as described above, debt instruments may be designated at fair value through profit or loss on initial recognition if doing so eliminates, or significantly reduces, an accounting mismatch.

Financial assets at fair value through profit or loss are carried in the statement of financial position at fair value with net changes in fair value recognised in profit or loss.

This category includes derivative instruments which the Group had not irrevocably elected to classify at fair value through other comprehensive income.

A derivative embedded in a hybrid contract, with a financial liability or non-financial host, is separated from the host and accounted for as a separate derivative if the economic characteristics and risks are not closely related to the host; a separate instrument with the same terms as the embedded derivative would meet the definition of a derivative; and the hybrid contract is not measured at fair value through profit or loss. Embedded derivatives are measured at fair value with changes in fair value recognised in profit or loss. Reassessment only occurs if there is either a change in the terms of the contract that significantly modifies the cash flows that would otherwise be required or a reclassification of a financial asset out of the fair value through profit or loss category.

以公平價值計量且其變動計入損益的金融資產包括交易性金融資產、於初始確認時指定為以公平價值計量且其變動計入損益的金融資產，或強制須以公平價值計量的金融資產。如果取得相關金融資產的目的，是為了近期出售或回購，則金融資產會分類為交易性。衍生工具(包括單獨的嵌入衍生工具)亦分類為交易性，但被指定為有效套期工具的衍生工具除外。現金流量並非僅為對本金和利息的支付的金融資產分類為以公平價值計量且其變動計入損益，而不論業務模式。儘管有上文所述債務工具分類為以攤餘成本計量或按公平價值計入其他全面收益的準則，在初始確認時，如果能夠消除或顯著減少會計錯配，可以將債務工具指定為以公平價值計量且其變動計入損益的金融資產。

以公平價值計量且其變動計入損益的金融資產在財務狀況表以公平價值計量，而其公平價值變動淨額在損益內確認。

該類別包括本集團並無不可撤銷地選擇分類為按公平價值計入其他全面收益的衍生工具。

當嵌入到混合合約(包含金融負債或非金融主合約)中的衍生工具的經濟特徵和風險與主合約不緊密相關；與嵌入衍生工具具有相同條款的單獨工具符合衍生工具的定義；且該混合合約不是以公平價值計量且其變動計入損益時，嵌入衍生工具與主合約分拆並作為單獨衍生工具處理。嵌入衍生工具以公平價值計量，且其公平價值變動計入損益。只有在合約條款出現變動，且重大改變所需的現金流量或將以公平價值計量且其變動計入損益的金融資產重新分類時，方進行重新評估。

A derivative embedded within a hybrid contract containing a financial asset host is not accounted for separately. The financial asset host together with the embedded derivative is required to be classified in its entirety as a financial asset at fair value through profit or loss.

##### *Initial recognition and measurement*

Financial assets are classified, at initial recognition, as loans and receivables as appropriate. When financial assets are recognised initially, they are measured at fair value plus transaction costs that are attributable to the acquisition of the financial assets.

All regular way purchases and sales of financial assets are recognised on the trade date, that is, the date that the Group commits to purchase or sell the asset. Regular way purchases or sales are purchases or sales of financial assets that require delivery of assets within the period generally established by regulation or convention in the marketplace.

The Group's financial assets include accounts receivable, loans and interest receivables, deposits and other receivables, contract assets and an amount due from a joint venture and cash and cash equivalents.

金融資產在初始確認時恰當地分類為貸款和應收款。初始確認金融資產時，按公平價值計量，並加上歸屬於取得該金融資產的交易費用。

##### Loans and receivables

Loans and receivables are non-derivative financial assets with fixed or determinable payments that are not quoted in an active market. After initial measurement, such assets are subsequently measured at amortised cost using the effective interest rate method less any allowance for impairment. Amortised cost is calculated by taking into account any discount or premium on acquisition and includes fees or costs that are an integral part of the effective interest rate. The effective interest rate amortisation is included in other income and gains in profit or loss. The loss arising from impairment is recognised in profit or loss in finance costs for loans and in other expenses for receivables.

#### Derecognition of financial assets (policies under HKFRS 9 applicable from 1 April 2018 and policies under HKAS 39 applicable before 1 April 2018)

A financial asset (or, where applicable, a part of a financial asset or part of a group of similar financial assets) is primarily derecognised (i.e., removed from the Group's consolidated statement of financial position) when:

- the rights to receive cash flows from the asset have expired; or

When the Group has transferred its rights to receive cash flows from an asset or has entered into a pass-through arrangement, it evaluates if, and to what extent, it has retained the risk and rewards of ownership of the asset. When it has neither transferred nor retained substantially all the risks and rewards of the asset nor transferred control of the asset, the Group continues to recognise the transferred asset to the extent of the Group's continuing involvement. In that case, the Group also recognises an associated liability. The transferred asset and the associated liability are measured on a basis that reflects the rights and obligations that the Group has retained.

Continuing involvement that takes the form of a guarantee over the transferred asset is measured at the lower of the original carrying amount of the asset and the maximum amount of consideration that the Group could be required to repay.

#### **Impairment of financial assets (policies under HKFRS 9 applicable from 1 April 2018)**

The Group recognises an allowance for ECLs for all debt instruments not held at fair value through profit or loss. ECLs are based on the difference between the contractual cash flows due in accordance with the contract and all the cash flows that the Group expects to receive, discounted at an approximation of the original effective interest rate. The expected cash flows will include cash flows from the sale of collateral held or other credit enhancements that are integral to the contractual terms.

#### *General approach*

ECLs are recognised in two stages. For credit exposures for which there has not been a significant increase in credit risk since initial recognition, ECLs are provided for credit losses that result from default events that are possible within the next 12 months (a 12-month ECL). For those credit exposures for which there has been a significant increase in credit risk since initial recognition, a loss allowance is required for credit losses expected over the remaining life of the exposure, irrespective of the timing of the default (a lifetime ECL).

At each reporting date, the Group assesses whether the credit risk on a financial instrument has increased significantly since initial recognition. When making the assessment, the Group compares the risk of a default occurring on the financial instrument as at the reporting date with the risk of a default occurring on the financial instrument as at the date of initial recognition and considers reasonable and supportable information that is available without undue cost or effort, including historical and forward-looking information.

The Group considers a financial asset in default when contractual payments are 90 days past due. However, in certain cases, the Group may also consider a financial asset to be in default when internal or external information indicates that the Group is unlikely to receive the outstanding contractual amounts in full before taking into account any credit enhancements held by the Group. A financial asset is written off when there is no reasonable expectation of recovering the contractual cash flows.

預期信用損失分兩個階段進行確認。對於自初始確認後並未顯著增加的信貸風險，就可能於未來12個月內出現的違約事件計提預期信用損失(12個月內預期信用損失)。對於自初始確認後已顯著增加的信貸風險，須就預期在剩餘存續期內發生的信用損失風險計提虧損撥備，不論違約事件於何時發生(整個存續期內預期信用損失)。

##### *Simplified approach*

For accounts receivable and contract assets that do not contain a significant financing component or when the Group applies the practical expedient of not adjusting the effect of a significant financing component, the Group applies the simplified approach in calculating ECLs. Under the simplified approach, the Group does not track changes in credit risk, but instead recognises a loss allowance based on lifetime ECLs at each reporting date. The Group has established a provision matrix that is based on its historical credit loss experience, adjusted for forward-looking factors specific to the debtors and the economic environment.

For accounts receivable and contract assets that contain a significant financing component and lease receivables, the Group chooses as its accounting policy to adopt the simplified approach in calculating ECLs with policies as described above.

#### Impairment of financial assets (policies under HKAS 39 applicable before 1 April 2018)

The Group assesses at the end of each reporting period whether there is objective evidence that a financial asset or a group of financial assets is impaired. An impairment exists if one or more events that occurred after the initial recognition of the asset have an impact on the estimated future cash flows of the financial asset or the group of financial assets that can be reliably estimated. Evidence of impairment may include indications that a debtor or a group of debtors is experiencing significant financial difficulty, default or delinquency in interest or principal payments, the probability that they will enter bankruptcy or other financial reorganisation and observable data indicating that there is a measurable decrease in the estimated future cash flows, such as changes in arrears or economic conditions that correlate with defaults.

對於不包含重大融資成分的應收賬款及合約資產，或當本集團應用便於實務操作的方法而不就重大融資成分的影響作出調整，本集團應用簡化方法計量預期信用損失。根據簡化方法，本集團不會追蹤信貸風險的變化，而是於每個報告日期根據整個存續期預期信用損失確認虧損撥備。本集團已根據其歷史信用損失經驗設立撥備矩陣，並根據債務人及經濟環境的特定前瞻性因素作出調整。

對於包含重大融資成分的應收賬款及合約資產以及應收租賃款，本集團所選擇的會計政策為如上文所述採用簡化方法計算預期信用損失。

本集團在每個報告期末均會進行評價，以判斷是否存在任何客觀證據表明某項金融資產或某組金融資產發生減值。如果資產初始確認後發生的一個或多個事項對金融資產或金融資產組的預計未來現金流量的影響能可靠地估計，則存在減值。減值證據可包括債務人或一組債務人發生重大財務困難，拖欠利息或本金的支付，他們很可能破產或進行其他財務重組，以及有可觀察數據表示預計未來現金流量出現可量度的減少，例如與拖欠相聯繫的欠款或經濟狀況的改變。

##### *Financial assets carried at amortised cost*

For financial assets carried at amortised cost, the Group first assesses whether impairment exists individually for financial assets that are individually significant, or collectively for financial assets that are not individually significant. If the Group determines that no objective evidence of impairment exists for an individually assessed financial asset, whether significant or not, it includes the asset in a group of financial assets with similar credit risk characteristics and collectively assesses them for impairment. Assets that are individually assessed for impairment and for which an impairment loss is, or continues to be, recognised are not included in a collective assessment of impairment.

The amount of any impairment loss identified is measured as the difference between the asset's carrying amount and the present value of estimated future cash flows (excluding future credit losses that have not yet been incurred). The present value of the estimated future cash flows is discounted at the financial asset's original effective interest rate (i.e., the effective interest rate computed at initial recognition).

The carrying amount of the asset is reduced through the use of an allowance account and the loss is recognised in profit or loss. Interest income continues to be accrued on the reduced carrying amount using the rate of interest used to discount the future cash flows for the purpose of measuring the impairment loss. Loans and receivables together with any associated allowance are written off when there is no realistic prospect of future recovery and all collateral has been realised or has been transferred to the Group.

If, in a subsequent period, the amount of the estimated impairment loss increases or decreases because of an event occurring after the impairment was recognised, the previously recognised impairment loss is increased or reduced by adjusting the allowance account. If a write-off is later recovered, the recovery is credited to other expenses in profit or loss.

有關以攤餘成本列值的金融資產，本集團首先要評估是否有重大的個別金融資產單獨發生減值或個別不重大的金融資產整體發生減值。如果本集團確定沒有客觀證據表明評估的個別金融資產，無論重大與否，發生減值，則該資產計入具有相似信用風險特徵的金融資產組，並對整個小組進行減值評估。已進行減值評估並確認或繼續確認減值損失的個別資產，不計入整體減值評估中。

所辨認的任何減值虧損的金額按資產的賬面值及對預期未來現金流量進行折現後的現值(不包括未發生的未來信貸虧損)兩者之間的差額計量。對預期未來現金流量進行折現後的現值以金融資產最初的實際利率(即初始確認時計算的實際利率)計算。

資產賬面值透過使用撥備賬抵減資產賬面值。減值虧損在損益中確認。利息收入繼續按減少後的賬面值累計，利率為量度減值虧損時用以將未來現金流量折現的利率。當並無實際希望可於未來收回，而所有抵押品已經變賣或轉讓給本集團時，貸款及應收款項及任何相關撥備會一併撇銷。

在後續期間，如果估計減值虧損金額增加或減少，且其與確認減值之後發生的事件有關，則先前確認的減值虧損會透過調整撥備抵賬戶而增加或減少。如果撇銷金額其後收回，則收回金額會貸記於損益的其他開支中。

##### *Initial recognition and measurement*

Financial liabilities are classified, at initial recognition, as loans and borrowings or as payables, as appropriate.

All financial liabilities are recognised initially at fair value and, in the case of loans and borrowings and payables, net of directly attributable transaction costs.

The Group's financial liabilities include accounts payable, other payables, amounts due to joint ventures and interest-bearing bank loans.

##### *Subsequent measurement*

The subsequent measurement of financial liabilities depends on their classification as follows:

##### *Loans and borrowings*

After initial recognition, interest-bearing bank loans are subsequently measured at amortised cost, using the effective interest rate method unless the effect of discounting would be immaterial, in which case they are stated at cost. Gains and losses are recognised in profit or loss when the liabilities are derecognised as well as through the effective interest rate amortisation process.

Amortised cost is calculated by taking into account any discount or premium on acquisition and fees or costs that are an integral part of the effective interest rate. The effective interest rate amortisation is included in finance costs in profit or loss.

*Financial guarantee contracts (policies under HKFRS 9 applicable from 1 April 2018)*

Financial guarantee contracts issued by the Group are those contracts that require a payment to be made to reimburse the holder for a loss it incurs because the specified debtor fails to make a payment when due in accordance with the terms of a debt instrument. A financial guarantee contract is recognised initially as a liability at its fair value, adjusted for transaction costs that are directly attributable to the issuance of the guarantee. Subsequent to initial recognition, the Group measures the financial guarantee contracts at the higher of: (i) the ECL allowance determined in accordance with the policy as set out in “Impairment of financial assets (policies under HKFRS 9 applicable from 1 April 2018)”; and (ii) the amount initially recognised less, when appropriate, the cumulative amount of income recognised.

*Financial guarantee contracts (policies under HKAS 39 applicable before 1 April 2018)*

A financial guarantee contract is recognised initially as a liability at its fair value, adjusted for transaction costs that are directly attributable to the issuance of the guarantee. Subsequent to initial recognition, the Group measures the financial guarantee contract at the higher of: (i) the amount of the best estimate of the expenditure required to settle the present obligation at the end of the reporting period; and (ii) the amount initially recognised less, when appropriate, cumulative amortisation.

A financial liability is derecognised when the obligation under the liability is discharged or cancelled, or expires.

When an existing financial liability is replaced by another from the same lender on substantially different terms, or the terms of an existing liability are substantially modified, such an exchange or modification is treated as a derecognition of the original liability and a recognition of a new liability, and the difference between the respective carrying amounts is recognised in profit or loss.

**Offsetting of financial instruments (policies under HKFRS 9 applicable from 1 April 2018 and HKAS 39 applicable before 1 April 2018)**

Financial assets and financial liabilities are offset and the net amount is reported in the statement of financial position if there is a currently enforceable legal right to offset the recognised amounts and there is an intention to settle on a net basis, or to realise the assets and settle the liabilities simultaneously.

#### Cash and cash equivalents

For the purpose of the consolidated statement of cash flows, cash and cash equivalents comprise cash on hand and demand deposits, and short term highly liquid investments that are readily convertible into known amounts of cash, are subject to an insignificant risk of changes in value, and have a short maturity of generally within three months when acquired, less bank overdrafts which are repayable on demand and form an integral part of the Group's cash management.

For the purpose of the consolidated statement of financial position, cash and cash equivalents comprise cash on hand and at banks, including term deposits, and assets similar in nature to cash, which are not restricted as to use.

#### 現金及現金等值物

就綜合現金流量表而言，現金及現金等值物指手頭現金及活期存款及短期高度流通而可以隨時兌換成已知數額之現金，而該筆現金須承受價值改變之風險較低，並為較短期之投資項目（一般為於購入後三個月內到期），減去須即期償還之銀行透支，而成為本集團現金管理之主要部份。

就綜合財務狀況表而言，現金及現金等值物包括手頭現金及銀行現金，包括用途不受限制的定期存款及與現金性質類似的資產。

#### Provisions

A provision is recognised when a present obligation (legal or constructive) has arisen as a result of a past event and it is probable that a future outflow of resources will be required to settle the obligation, provided that a reliable estimate can be made of the amount of the obligation.

The Group recognises provision for onerous contracts when the unavoidable costs of meeting the performance obligations under the construction contracts exceed the economic benefits expected to be received under it. The amount of provision for onerous contracts is estimated based on contract costs to completion and contract claims. The estimation basis is reviewed on an ongoing basis and revised where appropriate.

When the effect of discounting is material, the amount recognised for a provision is the present value at the end of the reporting period of the future expenditures expected to be required to settle the obligation. The increase in the discounted present value amount arising from the passage of time is included in finance costs in profit or loss.

#### Income tax

Income tax comprises current and deferred tax. Income tax relating to items recognised outside profit or loss is recognised outside profit or loss, either in other comprehensive income or directly in equity.

Current tax assets and liabilities are measured at the amount expected to be recovered from or paid to the taxation authorities, based on tax rates (and tax laws) that have been enacted or substantively enacted by the end of the reporting period, taking into consideration interpretations and practices prevailing in the countries in which the Group operates.

Deferred tax is provided, using the liability method, on all temporary differences at the end of the reporting period between the tax bases of assets and liabilities and their carrying amounts for financial reporting purposes.

#### 所得稅

Unrecognised deferred tax assets are reassessed at the end of each reporting period and are recognised to the extent that it has become probable that sufficient taxable profit will be available to allow all or part of the deferred tax asset to be recovered.

Deferred tax assets and liabilities are measured at the tax rates that are expected to apply to the period when the asset is realised or the liability is settled, based on tax rates (and tax laws) that have been enacted or substantively enacted by the end of the reporting period.

Deferred tax assets and deferred tax liabilities are offset if and only if the Group has a legally enforceable right to set off current tax assets and current tax liabilities and the deferred tax assets and deferred tax liabilities relate to income taxes levied by the same taxation authority on either the same taxable entity or different taxable entities which intend either to settle current tax liabilities and assets on a net basis, or to realise the assets and settle the liabilities simultaneously, in each future period in which significant amounts of deferred tax liabilities or assets are expected to be settled or recovered.

#### Government grants

Government grants are recognised at their fair value where there is reasonable assurance that the grant will be received and all attaching conditions will be complied with. When the grant relates to an expense item, it is recognised as income on a systematic basis over the periods that the costs, which it is intended to compensate, are expensed.

##### *Revenue from contracts with customers*

Revenue from contracts with customers is recognised when control of goods or services is transferred to the customers at an amount that reflects the consideration to which the Group expects to be entitled in exchange for those goods or services.

When the consideration in a contract includes a variable amount, the amount of consideration is estimated to which the Group will be entitled in exchange for transferring the goods or services to the customer. The variable consideration is estimated at contract inception and constrained until it is highly probable that a significant revenue reversal in the amount of cumulative revenue recognised will not occur when the associated uncertainty with the variable consideration is subsequently resolved.

When the contract contains a financing component which provides the customer a significant benefit of financing the transfer of goods or services to the customer for more than one year, revenue is measured at the present value of the amount receivable, discounted using the discount rate that would be reflected in a separate financing transaction between the Group and the customer at contract inception. When the contract contains a financing component which provides the Group a significant financial benefit for more than one year, revenue recognised under the contract includes the interest expense accreted on the contract liability under the effective interest method. For a contract where the period between the payment by the customer and the transfer of the promised goods or services is one year or less, the transaction price is not adjusted for the effects of a significant financing component, using the practical expedient in HKFRS 15.

##### (a) Construction services

Revenue from the provision of construction services is recognised over time, using an output method to measure progress towards complete satisfaction of the service, because the Group's performance creates or enhances an asset that the customer controls over time as the asset is created or enhanced. The output method recognises revenue in accordance with the direct measurements of the value of the services transferred by the Group to the customer with reference to the certified value of work performed to date.

##### (b) Sale of properties

Revenue from the sale of properties is recognised at the point in time when the purchasers obtain the physical possession or the legal title of the completed property and the Group has present right to payment and the collection of the consideration is probable.

##### *Interest income*

Interest income is recognised on an accrual basis using the effective interest method by applying the rate that exactly discounts the estimated future cash receipts over the expected life of the financial instrument or a shorter period, when appropriate, to the net carrying amount of the financial asset.

##### *Revenue from other sources*

Rental income is recognised on a time proportion basis over the lease terms.

##### Contract assets (applicable from 1 April 2018)

A contract asset is the right to consideration in exchange for goods or services transferred to the customer. If the Group performs by transferring goods or services to a customer before the customer pays consideration or before payment is due, a contract asset is recognised for the earned consideration that is conditional.

##### Contract liabilities (applicable from 1 April 2018)

A contract liability is the obligation to transfer goods or services to a customer for which the Group has received a consideration (or an amount of consideration that is due) from the customer. If a customer pays the consideration before the Group transfers goods or services to the customer, a contract liability is recognised when the payment is made or the payment is due (whichever is earlier). Contract liabilities are recognised as revenue when the Group performs under the contract.

##### Contract costs (applicable from 1 April 2018)

Other than the costs which are capitalised as inventories, property, plant and equipment and intangible assets, costs incurred to fulfil a contract with a customer are capitalised as an asset if all of the following criteria are met:

- (a) The costs relate directly to a contract or to an anticipated contract that the entity can specifically identify.
- (b) The costs generate or enhance resources of the entity that will be used in satisfying (or in continuing to satisfy) performance obligations in the future.
- (c) The costs are expected to be recovered.

The capitalised contract costs are amortised and charged to profit or loss on a systematic basis that is consistent with the pattern of the revenue to which the asset related is recognised. Other contract costs are expensed as incurred.

合約資產是指因向客戶轉讓商品或服務而獲得代價的權利。如果本集團在客戶支付代價或付款到期前已通過向客戶轉讓商品或服務而履約，則應當將該有條件收取的代價確認為合約資產。

#### 合約負債(由二零一八年四月一日起適用)

Contract revenue comprises the agreed contract amount and appropriate amounts from variation orders, claims and incentive payments. Contract costs incurred comprise direct materials, the costs of subcontracting, direct labour and an appropriate proportion of variable and fixed construction overheads.

Revenue from fixed price contracts is recognised on the percentage of completion method, measured by reference to the percentage of certified value of work performed to date to the total contract sum of the relevant contract.

Provision is made for foreseeable losses as soon as they are anticipated by management. Where contract costs incurred to date plus recognised profits less recognised losses exceed progress billings, the surplus is treated as an amount due from customers for contract works.

#### Share-based payments

The Company operates share option schemes for the purpose of providing incentives and rewards to eligible participants who contribute to the success of the Group's operations. Employees (including directors) of the Group receive remuneration in the form of share-based payments, whereby employees render services as consideration for equity instruments ("equity-settled transactions").

The cost of equity-settled transactions with employees is measured by reference to the fair value at the date at which they are granted.

The cost of equity-settled transactions is recognised in employee benefit expense, together with a corresponding increase in equity, over the period in which the performance and/or service conditions are fulfilled. The cumulative expense recognised for equity-settled transactions at the end of each reporting period until the vesting date reflects the extent to which the vesting period has expired and the Group's best estimate of the number of equity instruments that will ultimately vest. The charge or credit to profit or loss for a period represents the movement in the cumulative expense recognised as at the beginning and end of that period.

倘管理層預計到於可見未來出現虧損，即會提取撥備。迄今所產生之合約成本另加已確認溢利減去已確認虧損若超逾進度賬單款項，則超出部分被視為應收客戶之合約工程款項。

#### 以股份為基礎的付款

本公司設有購股權計劃，其目的在於向為本集團的成功營運作出貢獻的合資格參與人給予激勵及回報。本集團僱員（包括董事）按以股份為基礎的付款方式收取報酬，僱員則提供服務作為收取權益性工具的代價（「以權益結算的交易」）。

與僱員進行以權益結算的交易的成本，參照於授出日的公平價值計量。

在滿足表現及／或服務條件的期間，應確認以權益結算的交易費用為僱員福利開支並同時相應增加權益。在歸屬日前，於每個報告期末確認的以權益結算的交易的累計開支，反映歸屬期已到期部份及本集團對最終將會歸屬的權益性工具數目的最佳估計。在某一期間內在損益中扣除或計入的金額，為於該期間期初及期終確認的累計開支之變動。

Service and non-market performance conditions are not taken into account when determining the grant date fair value of awards, but the likelihood of the conditions being met is assessed as part of the Group's best estimate of the number of equity instruments that will ultimately vest. Market performance conditions are reflected within the grant date fair value. Any other conditions attached to an award, but without an associated service requirement, are considered to be non-vesting conditions. Non-vesting conditions are reflected in the fair value of an award and lead to an immediate expensing of an award unless there are also service and/or performance conditions.

For awards that do not ultimately vest because non-market performance and/or service conditions have not been met, no expense is recognised. Where awards include a market or non-vesting condition, the transactions are treated as vesting irrespective of whether the market or non-vesting condition is satisfied, provided that all other performance and/or service conditions are satisfied.

Where the terms of an equity-settled award are modified, as a minimum an expense is recognised as if the terms had not been modified, if the original terms of the award are met. In addition, an expense is recognised for any modification that increases the total fair value of the share-based payments, or is otherwise beneficial to the employee as measured at the date of modification.

Where an equity-settled award is cancelled, it is treated as if it had vested on the date of cancellation, and any expense not yet recognised for the award is recognised immediately. This includes any award where non-vesting conditions within the control of either the Group or the employee are not met. However, if a new award is substituted for the cancelled award, and is designated as a replacement award on the date that it is granted, the cancelled and new awards are treated as if they were a modification of the original award, as described in the previous paragraph.

在確定獎勵授予日的公平價值時，並不計及服務條件及非市場表現條件，但會作為本集團對最終將會歸屬的權益性工具的數目的最佳估計的一部分評估符合有關條件的可能性。市場表現條件在授予日公平價值中反映。獎勵所附帶的任何其他條件(但不帶有相聯服務要求)視為非歸屬條件。非歸屬條件在獎勵的公平價值中反映，除非同時存在服務及/或表現條件，否則獎勵會即時確認為費用。

對於因未有符合非市場表現及/或服務條件而最終未能歸屬的獎勵，不確認費用。如果獎勵包括市場條件或非歸屬條件，則無論是否滿足市場條件或非歸屬條件，只要其他所有表現及/或服務條件得以滿足，有關交易均視作已歸屬。

如以權益結算的獎勵的條款有所修改，所確認開支最少須達到假設條款並無任何修改下的金額，如果獎勵的原條款獲履行。此外，如任何修改導致以股份為基礎的付款的總公平價值有所增加，或為僱員帶來其他利益(於修改日計量)，則應就該等修改確認開支。

如以權益結算的獎勵被註銷，應被視為猶如已於註銷日歸屬，任何尚未確認的獎勵開支應即時確認。這包括在本集團或僱員控制範圍以內的不歸屬條件未能獲履行的任何獎勵。然而，如以新獎勵代替所註銷的獎勵，並於授出日指定為代替獎勵，則所註銷的獎勵與新獎勵會如前段所述被視為原先獎勵的修訂。

The dilutive effect of outstanding options is reflected as additional share dilution in the computation of earnings per share.

#### Other employee benefits

##### *Paid leave carried forward*

The Group provides paid annual leave to its employees under their employment contracts on a calendar year basis. Under certain circumstances, such leave which remains untaken as at the end of the reporting period is permitted to be carried forward and utilised by the respective employees in the following year. An accrual is made at the end of the reporting period for the expected future cost of such paid leave earned during the year by the employees and carried forward.

##### *Pension schemes*

The Group operates a defined contribution Mandatory Provident Fund retirement benefit scheme (the “MPF Scheme”) under the Mandatory Provident Fund Schemes Ordinance for those employees who are eligible to participate in the MPF Scheme. Contributions are made based on a percentage of the employees’ basic salaries and are charged to profit or loss as they become payable in accordance with the rules of the MPF Scheme. The assets of the MPF Scheme are held separately from those of the Group in an independently administered fund. The Group’s employer contributions vest fully with the employees when contributed into the MPF Scheme.

The Group also operates a Mandatory Provident Fund Exempted Occupational Retirement Schemes Ordinance (“ORSO”) retirement benefit scheme for those employees who are eligible to participate in the ORSO scheme. This scheme operates in a way similar to the MPF Scheme, except that when an employee leaves the scheme prior to his/her interest in the Group’s employee contributions vesting fully, the ongoing contributions payable by the Group are reduced by the relevant amount of forfeited employer’s contributions.

#### 其他僱員福利

##### *結轉有薪假期*

本集團根據聘用合約按公曆年的基準向其僱員提供有薪年假。在若干情況下，於報告期末，該等尚未使用的假期可結轉，而有關僱員可在下一年度使用。於報告期末，本集團就該等在年度內產生及結轉的有薪假期涉及的預期未來費用撥作預提費用。

##### *退休福利計劃*

本集團已按照強制性公積金計劃條例為所有合資格參與強積金計劃之僱員設有定額供款強制性公積金退休福利計劃（「強積金計劃」）。供款乃按照僱員底薪百分比計算，當需要按照強積金計劃條款規定供款時，即在損益中扣除有關供款。強積金計劃資產乃由獨立管理基金持有並與本集團資產分開管理。當向強積金計劃供款時，本集團之僱主強制供款將全數歸於僱員所得。

本集團亦為合資格參與強制性公積金豁免職業退休計劃條例（「職業退休計劃條例」）計劃之僱員設有職業退休計劃條例計劃。該計劃以類似強積金計劃之方式經營，惟當僱員於符合資格全數享有本集團僱員供款前離職，則本集團須持續支付之供款可扣除被沒收僱主供款之有關款額。

#### Borrowing costs

Borrowing costs directly attributable to the acquisition, construction or production of qualifying assets, i.e., assets that necessarily take a substantial period of time to get ready for their intended use or sale, are capitalised as part of the cost of those assets. The capitalisation of such borrowing costs ceases when the assets are substantially ready for their intended use or sale. Investment income earned on the temporary investment of specific borrowings pending their expenditure on qualifying assets is deducted from the borrowing costs capitalised. All other borrowing costs are expensed in the period in which they are incurred. Borrowing costs consist of interest and other costs that an entity incurs in connection with the borrowing of funds.

#### Dividends

Final dividends are recognised as a liability when they are approved by the shareholders in a general meeting.

Interim dividends are simultaneously proposed and declared, because the Company's memorandum and articles of association grant the directors the authority to declare interim dividends. Consequently, interim dividends are recognised immediately as a liability when they are proposed and declared.

Proposed final dividends are disclosed in the note 12 to the financial statements.

#### 借貸成本

直接與收購、建築或製造合資格資產(即資產必須經過一段相當時間以撥備作擬定用途或銷售)有關的借貸成本，將資本化為該等資產成本的一部份。倘資產已大致可作擬定用途或銷售，則停止資本化該借貸成本。待用於合資格資產的借貸於暫時性投資時所產生之投資收入，則於已資本化的借貸成本中扣除。所有其他借貸成本在發生當期確認為費用。借貸成本包括實體就借用資金而發生的利息及其他成本。

#### 股息

末期股息在股東大會上被股東批准後，確認為負債。

因為本公司的組織章程大綱和細則賦予董事宣告發放中期股息的權力，故可以同時建議並宣告發放中期股息。因此，中期股息在建議和宣告發放後即刻確認為負債。

#### Foreign currencies

These financial statements are presented in Hong Kong dollars, which is the Company's functional currency. Each entity in the Group determines its own functional currency and items included in the financial statements of each entity are measured using that functional currency. Foreign currency transactions recorded by the entities in the Group are initially recorded using their respective functional currency rates prevailing at the dates of the transactions. Monetary assets and liabilities denominated in foreign currencies are translated at the functional currency rates of exchange ruling at the end of the reporting period. Differences arising on settlement or translation of monetary items are recognised in profit or loss.

Differences arising on settlement or translation of monetary items are recognised in profit or loss with the exception of monetary items that are designated as part of the hedge of the Group's net investment of a foreign operation. These are recognised in other comprehensive income until the net investment is disposed of, at which time the cumulative amount is reclassified to profit or loss. Tax charges and credits attributable to exchange differences on those monetary items are also recorded in other comprehensive income.

Non-monetary items that are measured in terms of historical cost in a foreign currency are translated using the exchange rates at the dates of the initial transactions. Non-monetary items measured at fair value in a foreign currency are translated using the exchange rates at the date when the fair value was measured. The gain or loss arising on translation of a non-monetary item measured at fair value is treated in line with the recognition of the gain or loss on change in fair value of the item (i.e. translation difference on the item whose fair value gain or loss is recognised in other comprehensive income or profit or loss is also recognised in other comprehensive income or profit or loss, respectively).

#### 外幣

財務報表以本公司的功能貨幣港元列報。本集團各實體決定其本身的功能貨幣，各實體的財務報表的項目乃使用該功能貨幣計量。本集團實體記錄的外幣交易初始按交易日它們各自的功能貨幣之匯率記賬。以外幣為單位的貨幣性資產與負債會按報告期末的功能貨幣之匯率換算。結算或折算貨幣項目所產生的差額在損益中確認。

結算或折算貨幣項目所產生的差額在損益中確認，惟對於用作本集團境外經營淨投資的套期一部分的貨幣性項目除外。該等差額在其他全面收益內確認，直至淨投資被處置，這時累積金額會重新分類進損益。歸屬於那些貨幣性項目的匯兌差額的稅項支出和稅項抵減亦於其他全面收益中記賬。

以外幣歷史成本計量的非貨幣項目，按初始交易日的匯率換算。按外幣公平價值計量的非貨幣項目，按照計量公平價值之日的匯率換算。折算以公平價值計量的非貨幣項目所產生的損益的處理方法與有關項目公平價值變動的損益一致（即公平價值損益分別在其他全面收益或損益中確認的折算差額亦分別在其他全面收益或損益中確認）。

#### Foreign currencies (continued)

In determining the exchange rate on initial recognition of the related asset, expense or income on the derecognition of a non-monetary asset or non-monetary liability relating to an advance consideration, the date of initial transaction is the date on which the Group initially recognises the non-monetary asset or non-monetary liability arising from the advance consideration. If there are multiple payments or receipts in advance, the Group determines the transaction date for each payment or receipt of the advance consideration.

The functional currencies of certain overseas joint ventures are currencies other than the Hong Kong dollar. As at the end of the reporting period, the assets and liabilities of these entities are translated into Hong Kong dollars at the exchange rates prevailing at the end of the reporting period and their statements of profit or loss are translated into Hong Kong dollars at the weighted average exchange rates for the year. The resulting exchange differences are recognised in other comprehensive income and accumulated in other reserve. On disposal of a foreign operation, the component of other comprehensive income relating to that particular foreign operation is recognised in profit or loss.

Any goodwill arising on the acquisition of a foreign operation and any fair value adjustments to the carrying amounts of assets and liabilities arising on acquisition are treated as assets and liabilities of the foreign operation and translated at the closing rate.

The preparation of the Group's financial statements requires management to make judgements, estimates and assumptions that affect the reported amounts of revenues, expenses, assets and liabilities, and their accompanying disclosures, and the disclosure of contingent liabilities. Uncertainty about these assumptions and estimates could result in outcomes that could require a material adjustment to the carrying amounts of the assets or liabilities affected in the future.

#### 外幣 (續)

預付代價相關的非貨幣性資產或非貨幣性負債終止確認所產生的相關資產、費用或收入，在確定其初始確認所使用的匯率時，其初始交易日為本集團因預付代價而初始確認非貨幣性資產或非貨幣性負債的日期。如果支付或收取多筆預付款，則本集團對支付或收取的每一筆預付代價確定交易日。

某些海外合營企業的功能貨幣是港元之外的貨幣。於報告期末，這些公司的資產和負債按照報告期末的匯率折算成港元，而它們的損益表按照本年加權平均匯率折算成港元。由此產生的匯兌差額在其他全面收益內確認，並在其他儲備內累積。出售境外經營時，在其他全面收益中與上述特定境外經營相關的組成部分在損益中確認。

因收購境外經營而產生的任何商譽及對因收購產生的資產及負債賬面金額的任何公平價值調整，均被視為該境外經營的資產及負債，並以結算匯率換算。

編製本集團的財務報表要求管理層作出會影響收入、開支、資產和負債的報告金額及其隨附披露以及或然負債披露的判斷、估計和假設。有關該等假設和估計的不確定性可能導致可能須於未來對受影響資產或負債的賬面值作出重大調整的結果。

#### Judgements

In the process of applying the Group's accounting policies, management has made the following judgements, apart from those involving estimations, which have the most significant effect on the amounts recognised in the financial statements:

#### *Classification between investment properties and owner-occupied properties*

The Group determines whether a property qualifies as an investment property, and has developed criteria in making that judgement. Investment property is a property held to earn rentals or for capital appreciation or both. Therefore, the Group considers whether a property generates cash flows largely independently of the other assets held by the Group. Some properties comprise a portion that is held to earn rentals or for capital appreciation and another portion that is held for use in the production or supply of goods or services or for administrative purposes. If these portions could be sold separately or leased out separately under a finance lease, the Group accounts for these portions separately. If the portions could not be sold separately, the property is an investment property only if an insignificant portion is held for use in the production or supply of goods or services or for administrative purposes. Judgement is made on an individual property basis to determine whether ancillary services are so significant that a property does not qualify as an investment property.

#### **Estimation uncertainty**

The key assumptions concerning the future and other key sources of estimation uncertainty at the end of the reporting period, that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year, are described below.

於應用本集團之會計政策的過程中，管理層作出以下對於財務報表中所確認的金額構成最重大影響之判斷(除涉及估計者外)：

#### *投資物業和自用物業的劃分*

本集團決定物業是否符合投資物業的條件，並制定出此類判斷的標準。投資物業指為賺取租金或資本升值或同時為這兩個目的而持有的物業。憑此，本集團考慮一項物業產生的現金流是否大部分獨立於本集團持有的其他資產。有些物業的一部分是為賺取租金或資本升值而持有，而另一部分是為用於生產或提供商品或服務或行政用途而持有。如果這些部分可以分開出售(或按融資租賃分開出租)，則本集團對這些部分分開進行會計處理。如果這些部分不能分開出售，則只有在為用於生產或提供商品或服務或行政用途而持有的部分不重大的情況下，該物業才是投資物業。判斷是對各單項物業作出，以確定配套服務是否如此重要而使物業不符合投資物業。

#### **估計數字的不確定性**

下面描述可能引致資產負債之賬面值於下個財政年度須予以重大調整的重大風險，且有關未來的主要假設，以及於報告期末存在之估計不確定性的其他主要來源。

##### *Accounting for contract works*

The Group's revenue from contract works are recognised over time using the output method and is measured in accordance with the progress towards complete satisfaction of the performance obligations. Budgeted contract costs are prepared by the management on the basis of contract concluded with and/or quotations provided by the major sub-contractors, suppliers or vendors involved from time to time, the experience of the management and current market condition. The profitability of each project is dependent on the estimation of the total outcome of the contract, as well as the work done to date. The Group reviews and revises the estimates of contract costs to completion, variation orders and contract claims prepared for each contract work as the contract progresses. Significant judgement is required in estimating contract costs to completion, variation works and contract claims which may have an impact to the total outcome of the contract and recognition of profit. Actual outcomes of total contract costs may be higher or lower than estimated at the end of the reporting period, which would affect the profit recognised in future years as an adjustment to the amounts recorded to date.

##### *Recoverability of accounts receivable and contract assets*

The policy for impairment of accounts receivable and contract assets of the Group is based on the evaluation of collectability and ageing analysis of accounts receivable and contract assets as well as other quantitative and qualitative information and on management's judgement and assessment of the forward-looking information. Significant judgement and estimates are required in assessing the ultimate realisation of these assets, based on the current creditworthiness, the past collection history and subsequent settlements of each customer. If the financial conditions of customers of the Group were to deteriorate, resulting in an impairment of their ability to make payments, additional provisions may be required. Further details are disclosed in notes 22, 23 and 43 to the financial statements.

#### 估計數字的不確定性 (續)

##### *合約工程的會計處理*

本集團來自合約工程的收入使用產出法在一段時間內確認，其根據邁向完全履行履約義務的進度計量。預算合約成本由管理層根據不時與所涉及的主要分判商、供應商或賣方所簽訂的合約及／或由彼等所提供的報價、管理層的經驗以及當前市場情況而編製。每個項目的溢利視乎對合約總體結果的估計以及迄今已完成工作而定。隨著合約的進行，本集團會審視及修訂為每項合約工程所編製的完工合約成本、改建或附加工程以及合約索償額的估計。估計完工合約成本、改建或附加工程以及合約索償額需要作出重大判斷，其可能會對合約的總體結果及溢利的確認產生影響。總合約成本的實際結果可能會高於或低於報告期末的估計，而對迄今為止記錄的金額作出調整，會影響到於未來年度確認的溢利。

##### *應收賬款及合約資產的可收回性*

本集團應收賬款及合約資產的減值政策為基於對應收賬款及合約資產的可收回性及賬齡分析所作的評估以及其他定量及定性信息以及管理層對前瞻性信息的判斷及評估。根據各客戶當前所知信譽、過去的收款歷史以及後續付款情況評估該等資產最終能否變現需要作出重大判斷及估計。倘若本集團客戶的財務狀況惡化，導致其付款能力下降，則可能需要計提額外撥備。有關進一步詳情，在財務報表附註22、23及43內披露。

##### *Estimation of fair value of investment properties*

As disclosed in note 16 to the financial statements, investment properties are revalued at the end of the reporting period on market value, existing use basis by independent professionally qualified valuer. Such valuations were based on certain assumptions and estimates, which are subject to uncertainty and might materially differ from the actual outcomes. In making the judgement for valuation of investment properties, the Group considered the discounted cash flow projections based on reliable estimates of future cash flows, supported by the terms of any existing lease and other contracts and (when possible) by external evidence such as current market rents for similar properties in the same location and condition, and using discount rates that reflect current market assessments of the uncertainty in the amount and timing of the cash flows.

### 5. SEGMENT INFORMATION

For management purposes, the Group is organised into business units based on their products and services and has three reportable operating segments as follows:

- (a) the contract works segment engages in contract works as a main contractor or sub-contractor, primarily in respect of building construction and repair, maintenance, alteration and addition (“RMAA”) works;
- (b) the property investment and development segment engages in investment in retail and commercial premises for their rental income potential and the development of properties for rental or for sale purpose; and
- (c) the provision of finance segment engages in money lending business.

##### *投資物業公平價值的估計*

如財務報表附註16所披露，投資物業於報告期末由獨立專業合格估值師按市場價值及現有用途基準重估。有關估值乃根據若干未確定之假設及估計而進行，該等假設及估計可能與實際結果有很大出入。就投資物業進行估價時會作出判斷，而本集團已考慮到根據對未來現金流量的可靠估計所作的折現的現金流量預測，輔以任何現有的租賃和其他合同的條款，以及(如果可能)處於同一位置和狀況下的類似房地產的當前市場租金等外部證據，採用反映當前市場對現金流量的金額和時間的不確定性的估計的折現率。

### 5. 分部資料

出於管理目的，本集團根據產品和服務的性質來劃分業務單元，本集團有以下三個可匯報經營分部：

- (a) 合約工程分部乃擔任總承建商或分判商，主要承接樓宇建築以及維修、保養、改建及加建(「維修、保養、改建及加建」)工程；
- (b) 物業投資及發展分部乃投資於具有租金收入潛力的零售及商用物業，以及從事物業發展以供出租或銷售；及
- (c) 提供融資分部，其從事放債業務。

Management monitors the results of the Group's operating segments separately for the purpose of making decisions about resources allocation and performance assessment. Segment performance is evaluated based on reportable segment profit, which is a measure of adjusted profit before tax. The adjusted profit before tax is measured consistently with the Group's profit before tax except that bank interest income, finance costs, share of profits and losses of joint ventures as well as head office and corporate expenses are excluded from such measurement.

Intersegment sales and transfers are transacted with reference to the selling prices used for sales made to third parties at the then prevailing market prices.

### 5. 分部資料 (續)

管理層監察本集團各經營分部之業績以決定如何分配資源及評核表現。分部之表現可按匯報分部之溢利(即經調整除稅前溢利)評核。經調整除稅前溢利之計算與本集團之除稅前溢利一致,惟計算經調整除稅前溢利時不包括銀行利息收入、財務費用、應佔合營企業溢利及虧損,亦不包括總辦事處及企業費用。

分部間的銷售和轉讓,參照向第三方銷售所採用的售價,按照當時現行的市場價格進行交易。

The Group's principal financial instruments include interest-bearing bank loans, accounts receivable, other receivables, loans and interest receivables, accounts payable, other payables and bank balances and time deposits. Details of these financial instruments are disclosed in the respective notes to the financial statements.

The Group's ordinary activities expose it to various financial risks, including interest rate risk, credit risk and liquidity risk. The risks associated with financial instruments and the policies on how to mitigate these risks are described below. Management monitors closely the Group's exposures to financial risks to ensure appropriate measures are implemented in a timely and effective manner.

#### Interest rate risk

The Group's exposure to the risk of changes in market interest rates relates primarily to the Group's debt obligations with floating interest rates.

At 31 March 2019, it was estimated that an increase/decrease of 25 basis points in interest rates, with all other variables held constant, would decrease/increase the Group's profit after tax and retained profits by HK\$3,279,000 (2018: HK\$2,881,000), arising as a result of higher/lower interest expense on the Group's floating-rate borrowings. There would be no impact on other components of the Group's equity.

The sensitivity analysis above has been determined assuming that the change in interest rates had occurred at the end of the reporting period. For the purposes of the analysis, it is assumed that the amount of variable-rate borrowings outstanding at the end of the reporting period was outstanding throughout the whole year. The 25 basis point increase or decrease represents management assessment of a reasonably possible change in interest rates over the period until the reporting date of the next financial year. The analysis was performed on the same basis for the year ended 31 March 2018.

#### Credit risk

The Group's credit risk is primarily attributable to accounts receivables, contract assets, loans and interest receivables, financial assets included in prepayments, other receivables and other assets and cash and bank balances. The Group's maximum credit risk exposure at the end of each reporting period in the event of other parties failing to perform their obligations is represented by the carrying amounts of financial assets as stated in the consolidated statements of financial position.

Management monitors the creditworthiness and payment patterns of each debtor closely and on an ongoing basis.

The Group's accounts receivable and contract assets from contract works represent interim payments or retentions certified by the customers under terms as stipulated in the contracts and the Group does not hold any collateral over these accounts receivable and contract assets. As the Group's customers in respect of contract works primarily consist of government departments and developers or owners with strong financial backgrounds, management considers that the risk of irrecoverable receivables from contract works is not significant.

In respect of rentals receivable, to limit the credit risk exposure, deposits or guarantee are required from each tenant upon inception of the leases and monthly rentals are received in advance. Payments from each tenant are monitored and collectability is reviewed closely.

In respect of loans and interest receivables, individual credit evaluations are performed on all borrowers requiring credit over a certain amount. These evaluations focus on the borrowers' past history of making payments when due and current ability to pay, and take into account information specific to the borrowers. Certain of these loans and interest receivables are secured by the properties owned by respective borrowers.

管理層緊密並持續監察各債務人的信貸可靠性及還款模式。

本集團應收之合約工程賬款及合約資產為根據合約內訂定條款支付的中期付款或客戶核實的保留款。就這些應收賬款及合約資產，本集團並未持有任何抵押品。本集團的合約工程客戶主要包括政府部門及具有強大財務背景的發展商或業主，故管理層認為，不能收回應收之合約工程款的風險不大。

有關應收租金，為減低面對的信貸風險，各租戶均須於租賃開始時繳交按金或出具擔保，而月租亦於期初收取。本集團會監察各租戶的付款情況，亦會密切檢討是否可以收回。

有關應收貸款及利息，會對所有要求超過某信貸額的借款人進行個別信用評估。有關評估專注於借款人以前在到期時付款的記錄以及其目前的付款能力，並且考慮到借款人特定的資料。部分應收貸款及利息以各有關借款人所擁有的物業作為抵押。

At 31 March 2019, the Group had certain concentrations of credit risk as 30% (31 March 2018: 68%) and 84% (31 March 2018: 81%) of the total accounts receivable, contract assets and loans and interest receivables were due from the Group's largest external customer and the Group's five largest external customers, respectively.

The Group has applied the simplified approach to provide for impairment for ECLs prescribed by HKFRS 9, which permits the use of the lifetime expected loss provision for impairment of all accounts receivable and contract assets. To measure the ECLs, accounts receivable and contract assets have been grouped based on shared credit risk characteristics and the days past due. With the incorporation of forward-looking information in the ECLs, management considered that the ECL rate for the Group's accounts receivable and contract assets is minimal and therefore no provision for impairment of accounts receivable and contract assets was necessary as at 31 March 2019 and 1 April 2018.

For loans and interest receivables, the Group applied the general approach to provide for impairment for ECLs prescribed by HKFRS 9. As at 31 March 2019, loans and interest receivables that were overdue amounted to HK\$91,137,000 (31 March 2018: nil) and all the balances were categorised within Stage 1 or Stage 2 for the measurement of ECLs.

An impairment analysis is performed throughout the reporting period, which are estimated by applying the probability of default approach with reference to the risks of default of the borrowers. As certain loans and interest receivables are covered by the pledge of properties of the borrowers, management considered that the ECL rate for the Group's loans and interest receivables is minimal and therefore no provision for impairment of loans and interest receivables was made as at 31 March 2019 and 1 April 2018.

The Group's policy is to monitor regularly the current and expected liquidity requirements to ensure that it maintains sufficient reserves of cash and adequate committed lines of funding from major financial institutions to meet its liquidity requirements in the short and long term. In addition, banking facilities have been put in place for contingency purposes.

The following table details the remaining contractual maturities at the end of the reporting period of the Group's financial liabilities, which are based on contractual undiscounted cash flows (including interest payments computed using contractual rates, or if floating, based on rates current at the end of the reporting period) and the earliest date that the Group could be required to repay:

#### Capital management

The primary objective of the Group's capital management policy is to ensure that the Group will be able to continue as a going concern while maximising the return to stakeholders through the optimisation of the debt and equity balance.

The directors of the Company review the capital structure on a periodical basis. As part of this review, the directors of the Company consider the cost of capital and the risks associated with each class of capital and will balance the Group's overall capital structure through new share issues as well as the raising of new debts and repayment of existing debts.

The Group monitors capital using a net gearing ratio, which is net debt divided by the equity attributable to owners of the parent. Net debt includes total interest-bearing bank loans less cash and cash equivalents as shown in the consolidated statement of financial position. The following table is an analysis of the Group's capital structure as at 31 March:
