According to the details of the distribution reinvestment scheme in respect of the interim distribution for the six months ended 30 September 2020 as described in the ricular to Unitholders dated 27 November 2020 (the "Circular"), no fraction of a New Unit will be issued. Therefore, if you elect to receive the maximum number of New Units in lieu of a cash distribution, or if your entitlement is not enough to receive a New Unit, a residual distribution entitlement may arise, representing the difference between the maximum distribution available for election of New Units in respect of your unitholding and the total cash equivalent of the New Units based on the Issue Price to be issued to you. Any residual distribution entitlement will be carried forward in Hong Kong dollars (without interest) and added to the next distribution, if applicable, to which a distribution reinvestment scheme is made available to determine such number of new units you may elect to receive on that
