CHAIRMAN'S STATEMENT

主席報告

Dear Shareholders,

On behalf of the board (the "Board") of directors (the "Directors") of GET Holdings Limited (the "Company", together with its subsidiaries, referred to as the "Group"), I would like to present the annual results of the Group for the year ended 31 December 2020 (the "Year") together with its strategies and prospects.

FINANCIAL RESULTS

The Group recorded a loss of approximately HK\$32,410,000 for the Year (2019: loss of approximately HK\$61,680,000).

The Group's consolidated loss attributable to the owners of the Company amounted to approximately HK\$39,286,000 for the Year (2019: loss of approximately HK\$67,200,000).

DIVIDEND

The Directors do not recommend the payment of a dividend for the Year (2019: Nil).

REVIEW OF OPERATIONS

The volatility of the global macro-economic environment, uncertainties posed by the geopolitical pressure, and the COVID-19 pandemic had left 2020 an unprecedentedly challenging year for all. Due to the pandemic, global business activities are dampened. Governments imposed strict national lockdowns which adversely affected the global sales and trading activities. Despite the impact of COVID-19 and macro-economic uncertainties, we emphasise to ensure resilience and maintain our competitive edge with a view to achieving sustainable growth to the shareholders of the Company ("Shareholders"). The Group is principally engaged in the Software Business, the Corporate Management Solutions and I.T. Contract Services Business, the B2C Online Sales Platform and B2B Product Trading Business, and the Securities Investment Business (all as defined below).

During the Year, the Software Business remained as one of the main revenue streams and pillar businesses of the Group. Revenue generated from the Software Business amounted to approximately HK\$82,252,000, representing approximately 35.5% of the Group's total turnover for the Year. Amidst headwinds in the global market environment, the Group insisted in adhering to its corporate strategy, and maximising its strengths in technology and innovation capabilities through the Software Business. We had constantly reviewed and upgraded various software products during the Year in order to keep up with the fast-changing information technology ("I.T.") industry and to provide a seamless experience to the software products users.

本人謹代表智易控股有限公司（「本公司」，連同其附屬公司統稱「本集團」）董事（「董事」）會（「董事會」）提呈本集團截至二零二零年十二月三十一日止年度（「本年度」）的年度業績連同本集團的策略及展望。

財務業績

本集團於本年度錄得虧損約32,410,000港元（二零一九年：虧損約61,680,000港元）。

本集團於本年度的本公司擁有人應佔綜合虧損約為39,286,000港元（二零一九年：虧損約67,200,000港元）。

股息

董事不建議就本年度派付任何股息（二零一九年：無）。

業務回顧

全球宏觀經濟環境波動、地緣政治壓力帶來的不確定性及COVID-19疫情，令各行各業於二零二零年經歷前所未有的挑戰。由於疫情，全球商業活動減弱。各國政府實施嚴格的全國封鎖措施，嚴重影響全球銷售及貿易活動。面對COVID-19及宏觀經濟不確定性的影響，我們著力保持韌性及維持我們的競爭優勢，以期為本公司股東（「股東」）實現可持續的增長。本集團主要從事軟件業務、企業管理解決方案及資訊科技合約服務業務、B2C網上銷售平台及B2B產品貿易業務以及證券投資業務（定義見下文）。

於本年度，軟件業務仍然是本集團的主要收入來源及支柱業務之一。軟件業務產生的收入約為82,252,000港元，佔本集團本年度總收入的約35.5%。面對全球市場環境不景氣，本集團堅守其企業策略，在軟件業務上充分發揮其科技及創新能力。本年度內，我們持續檢討並升級多款軟件產品，以緊貼瞬息萬變的資訊科技（「資訊科技」）行業發展，為我們的軟件產品用戶提供無縫體驗。

CHAIRMAN'S STATEMENT

主席報告

We diversified our landscape through the Corporate Management Solutions and I.T. Contract Services Business and the B2C Online Sales Platform and B2B Product Trading Business. Over the Year, we offer quality I.T. products and solutions at home and aboard with an aim of enhancing the connectivity and compatibility with our customers. During the Year, the revenue from the B2C Online Sales Platform and B2B Product Trading Business accounted for approximately 52.4% of the Group's total turnover for the Year, and the revenue from the Corporate Management Solutions and I.T. Contract Services Business accounted for approximately 12.1% of the Group's total turnover for the Year.

As at 31 December 2020, the Group had cash and cash equivalents and pledged bank deposits of approximately HK\$118,804,000 and net current assets of approximately HK\$120,182,000. Based on the solid financial position, the Group will remain cautious in looking for and evaluating business opportunities with growth potential. It will strategically invest its capital with the aim of generating long-term and stable revenue and achieving further business diversification, thereby delivering the best returns to the Shareholders.

PROSPECTS

Looking forward, despite the unprecedented challenge from the pandemic and the complicated socio-economic environment, the Group is cautiously optimistic about the future market conditions. In coming year, the Group will continue to endeavour at its best to capture stable business growth and return, and to ultimately bring sustainable return to the Shareholders. The Group will continue to effectively utilise its resources to expand its core businesses and to keep exploring new business opportunities with good potential. At the same time, the Group will strive to maintain an appropriate balance between risk and return.

APPRECIATION

Finally, on behalf of the Board, I would like to take this opportunity to express my gratitude to all our business partners, the Shareholders and customers for their continuing trust and support in the past year. I would also like to extend my sincere thanks to all staff of the Group and members of the Board for their dedication and devotion during 2020, alongside their desire for the Group to realise progress.

我們透過經營企業管理解決方案及資訊科技合約服務業務、B2C網上銷售平台及B2B產品貿易業務，實現業務範圍多元化。本年度內，我們在國內外提供優質的資訊科技產品及解決方案，致力提升與客戶的連接性及兼容性。於本年度，來自B2C網上銷售平台及B2B產品貿易業務的收入佔本集團本年度總收入的約52.4%以及來自企業管理解決方案及資訊科技合約服務業務的收入佔本集團本年度總收入的約12.1%。

於二零二零年十二月三十一日，本集團擁有現金及現金等價物以及已抵押銀行存款約118,804,000港元，以及流動資產淨值約120,182,000港元。基於穩健的財務狀況，本集團仍將在物色及評估具增長潛力的商機方面保持謹慎。本集團將策略性地投資其資金，以創造持久穩定的收入來源，進一步實現業務多元化，從而為股東帶來最佳的回報。

前景

展望未來，儘管面對疫情帶來的前所未有的挑戰及複雜的社會經濟環境，本集團對後市仍持審慎樂觀的態度。來年，本集團將繼續不懈努力，爭取實現穩定的業務增長及回報，為股東創造可持續的回報。本集團將繼續有效利用資源，拓展其核心業務並繼續發掘具潛力的新商機。同時，本集團將努力在風險與回報之間保持適當的平衡。

BUSINESS REVIEW

Software Business

During the Year, the business of research, development and distribution of personal computer (“PC”) performance software, anti-virus software, mobile phone applications and toolbar advertisements (“Software Business”) of the Group recorded a revenue of approximately HK\$82,252,000 (2019: approximately HK\$73,994,000), representing an increase of approximately 11.2% as compared to that of 2019. The segment profit of the Software Business amounted to approximately HK\$23,347,000 (2019: loss of approximately HK\$46,264,000). Such change from a loss to a profit was primarily attributable to the absence of an impairment loss on goodwill in relation to the cash-generating unit (“CGU”) of the Software Business in 2020 (2019: approximately HK\$65,000,000). As at 31 December 2020, with reference to the assessment by an independent valuer, the recoverable amount of the CGU of the Boom Max Group is valued to approximately HK\$127,455,000. As the recoverable amount of the CGU of the Boom Max Group exceeded its carrying value by approximately HK\$3,658,000, no impairment was required for the Year.

During the Year, the Group has continued to strengthen its foothold in the software industry through Boom Max International Limited and its subsidiaries (collectively, the “Boom Max Group”), the operating unit of the Group carrying on the Software Business, which is one of the main revenue streams of the Group.

As innovation capabilities and customer satisfaction are the heart of the business, we underline the relentless effort of the Boom Max Group in investing in research and development (“R&D”) which comprises experts devoting their focus to network security, building software products and marketing channels, in order to strengthen the Group’s products line against computer malwares and ransomwares.

Over the Year, the Boom Max Group upgraded new versions of some of our software products, including IObit Malware Fighter, IObit Uninstaller, Driver Booster, IObit Software Updater. In the fourth quarter of 2020, the Boom Max Group launched an upgraded version of our flagship product, Advanced SystemCare, to version 14 (i.e. Advanced SystemCare 14). A new version of Advanced SystemCare Ultimate, namely Advanced SystemCare Ultimate 14, which spots its all-in-one solution to further maximise computer optimisation and combat potential cybersecurity threats, was also released. In upcoming quarter, with a view to keeping abreast with the latest technology trend and enhance user experience, the Boom Max Group expects to release fine-tuned updates of the latest versions of some of its software products, including Advanced SystemCare 14, Advanced SystemCare Ultimate 14, Smart Defrag 6, IObit Uninstaller 10, etc on the market.

業務回顧

軟件業務

於本年度，本集團研發及分銷個人電腦（「個人電腦」）性能軟件、防毒軟件、流動電話應用程式及工具欄廣告業務（「軟件業務」）錄得收入約82,252,000港元（二零一九年：約73,994,000港元），較二零一九年增加約11.2%。軟件業務分部溢利約23,347,000港元（二零一九年：虧損約46,264,000港元）。由虧轉盈乃主要由於二零二零年並無與軟件業務現金產出單元（「現金產出單元」）有關之商譽減值虧損（二零一九年：約65,000,000港元）。於二零二零年十二月三十一日，經參考獨立估值師作出的評估後，Boom Max集團現金產出單元的可收回金額約為127,455,000港元。由於Boom Max集團現金產出單元的可收回金額超過其賬面值約3,658,000港元，故本年度無需作出減值。

於本年度，本集團繼續透過Boom Max International Limited及其附屬公司（統稱「Boom Max集團」），本集團從事軟件業務（本集團主要收入來源之一）的營運單位）加強其於軟件行業的市場地位。

創新能力及客戶滿意度是該業務的核心，我們持續加大Boom Max集團在研究與開發（「研發」）方面的投入力度，其中包括專家持續專注於網絡安全、軟件產品及營銷渠道的建設，以加強本集團抵禦電腦惡意軟件及勒索軟件的產品線。

過去一年，Boom Max集團推出包括IObit Malware Fighter、IObit Uninstaller、Driver Booster、IObit Software Updater在內的多個軟件產品的新升級版本。二零二零年第四季度，Boom Max集團推出其旗艦產品Advanced SystemCare的升級版本至第14版（即Advanced SystemCare 14）。為進一步最大程度地優化電腦及打擊潛在的網絡安全威脅，亦已發佈Advanced SystemCare Ultimate的新版本（即Advanced SystemCare Ultimate 14），其專注於一體化解決方案。為緊貼最新科技趨勢及提升用戶體驗，Boom Max集團預計在下一季度於市場上發佈Advanced SystemCare 14、Advanced SystemCare Ultimate 14、Smart Defrag 6、IObit Uninstaller 10等若干款軟件產品最新版本的微調升級。

MANAGEMENT DISCUSSION AND ANALYSIS

管理層討論及分析

During the Year, the Boom Max Group continued to build and reinforce its sales and distribution channels including the implementation of digital marketing campaigns. Apart from strengthening its customer base in traditional markets, the Group will continue to explore business opportunities and expand distribution channels in the emerging markets such as countries in the Asia-Pacific region. In addition, our software products are available at www.iobit.com, or other software downloading directory websites and affiliate websites. New versions of our software products are available for downloading on the website in different languages, such as English, Spanish, French, Chinese and Dutch. As at 31 December 2020, according to the internal sales data of the Boom Max Group, its products had more than 61 million (2019: more than 56 million) new users in total, including new non-paying and active paying users (i.e. users who had subscribed product at least once during the Year).

Headwinds of the global macro-economy and the outbreak of the COVID-19 pandemic have affected the Software Business to varying degrees. In spite of the disruption to the economic activities worldwide, the COVID-19 pandemic has resulted in profound changes to our ordinary life and work. During the Year, the computer software industry including the Software Business generally benefited from a rise in use of the PC due to a change of customer behaviour of the industry. On the other hand, more customers may tend to free subscription instead of purchasing our software products in view of the uncertainties in the post-pandemic era and the sluggish economy ahead. Therefore, it is hard to quantify the future impacts of the pandemic on this segment. In the meantime, the Boom Max Group has been facing challenges from fierce competition in the I.T. industry, geopolitical pressure and the potential sluggish economic growth resulting from the outbreak of the COVID-19 pandemic. The Board will continue to closely monitor the performance of this segment and the potential impact from the pandemic. Looking ahead, the Boom Max Group will continue to focus on exploring new technological application realm and enhancing its software products. It will also strengthen and expand its distribution and sales channels by cooperating closely with local dealers and affiliates.

於本年度，Boom Max集團繼續建立及加強其銷售及分銷渠道（包括開展數字營銷活動）。除鞏固其於傳統市場的客戶基礎外，本集團將繼續探索亞太地區國家等新興市場的商業機遇並擴大分銷渠道。此外，我們的軟件產品可從www.iobit.com或其他軟件下載目錄網站及聯盟網站下載。網站以英文、西班牙語、法語、中文及荷蘭語等不同語言提供軟件產品的最新版本供下載。於二零二零年十二月三十一日，根據Boom Max集團的內部銷售數據，其產品新用戶總數超過61,000,000名（二零一九年：超過56,000,000名），包括新的非付費用戶及活躍付費用戶（指於本年度最少訂購一次產品的用戶）。

全球宏觀經濟承壓及COVID-19疫情爆發，對軟件業務造成不同程度的影響。儘管COVID-19疫情令全球經濟活動受阻，但同時亦已對我們的日常生活及工作帶來巨大轉變。本年度，電腦軟件行業（包括我們的軟件業務）普遍受惠於行業內客戶行為轉變帶來的個人電腦使用量增加。惟另一方面，鑒於疫情後時代具不確定性及未來經濟低迷，更多客戶可能傾向於免費訂閱而非購買我們的軟件產品，因此難以量化未來疫情對此分部造成的影響。與此同時，Boom Max集團亦面對資訊科技行業競爭激烈、地緣政治壓力及COVID-19疫情可能導致經濟增長放緩的挑戰。董事會將繼續密切監察此分部的表現及疫情的潛在影響。展望未來，Boom Max集團將繼續致力探索新的技術應用領域及提升其軟件產品，同時透過與當地經銷商及聯營公司緊密合作，加強及拓展其分銷和銷售渠道。

MANAGEMENT DISCUSSION AND ANALYSIS

Corporate Management Solutions and I.T. Contract Services Business

During the Year, the Group provided corporate management solutions, I.T. contract services, network infrastructure solutions, network professional services and I.T. project implementation services (“Corporate Management Solutions and I.T. Contract Services Business”) to corporate clients mainly in Hong Kong.

During the Year, revenue from this business segment was approximately HK\$27,892,000 (2019: approximately HK\$46,347,000), representing a decrease of approximately 39.8% as compared with that of 2019. This business segment recorded a loss of approximately HK\$17,907,000 for the Year (2019: loss of approximately HK\$6,794,000), including an impairment loss on goodwill of approximately HK\$11,300,000 for the Year (2019: approximately HK\$254,000). The loss was primarily attributable to the outbreak of the COVID-19 pandemic and the keen competition in the I.T. market. The impairment loss on goodwill (“Impairment Loss on Goodwill”) of approximately HK\$11,300,000 in relation to Wafer Systems (Hong Kong) Limited (“Wafer HK”), an indirect wholly-owned subsidiary of the Company and the CGU of the Corporate Management Solutions and I.T. Contract Services Business, was recognised during the Year. Details of the Impairment Loss on Goodwill are set out in the sub-section headed “Update on Material Asset Impairment” in the section headed “Management Discussion and Analysis” in this report and note 22 to the consolidated financial statements contained in this report.

During the Year, the COVID-19 pandemic caused disruptions to the Hong Kong economy and operational environment of this business segment, pressuring on the sales activities of this segment. Compounded by the severe competition in the I.T. industry in Hong Kong, the market condition of this business segment is expected to remain challenging in coming year. The Group will endeavour to expand customer base and enhance efficiency in order to improve the financial performance of this segment. In the meantime, the Group’s management will continue to pay close attention to the prospect of this business segment and may consider the possibility of, including but not limited to, scale-down or disposal of part of this business segment in the coming future.

企業管理解決方案及資訊科技合約服務業務

於本年度，本集團向主要位於香港的企業客戶提供企業管理解決方案、資訊科技合約服務、網絡基建解決方案、網絡專業服務及資訊科技項目推行服務（「企業管理解決方案及資訊科技合約服務業務」）。

於本年度，來自此業務分部的收入約為27,892,000港元（二零一九年：約46,347,000港元），較二零一九年減少約39.8%。此業務分部於本年度亦錄得虧損約17,907,000港元（二零一九年：虧損約6,794,000港元）（包括本年度商譽減值虧損約11,300,000港元（二零一九年：約254,000港元））。虧損乃主要由於COVID-19疫情爆發及資訊科技市場競爭激烈。於本年度就本公司之間接全資附屬公司威發系統（香港）有限公司（「威發香港」）及企業管理解決方案及資訊科技合約服務業務之現金產出單元確認商譽減值虧損（「商譽減值虧損」）約11,300,000港元。商譽減值虧損詳情載於本報告「管理層討論及分析」一節中「有關重大資產減值的更新資料」分節及本報告綜合財務報表附註22。

於本年度，COVID-19疫情影響香港經濟及此業務分部的營商環境，對此分部的銷售活動造成壓力。加上香港資訊科技行業競爭激烈，預計來年此業務分部的市況仍具挑戰。本集團將努力擴大客戶基礎並提高效率，以改善此分部的財務表現。與此同時，本集團的管理層將繼續密切關注此業務分部的前景並可能考慮於未來（包括但不限於）縮減或出售此業務分部的一部分的可能性。

On 31 December 2020, in view of the severe competition in the I.T. industry in Hong Kong, the unfavourable operational environment of this business segment and the financial performance of e-Perfect IT Limited, the Group disposed of all its shares in e-Perfect IT Limited, the then wholly-owned subsidiary operating the Corporate Management Solutions and I.T. Contract Services Business, to a director of e-Perfect IT Limited (“e-Perfect Disposal”). As disclosed in note 39(a) to the consolidated financial statements contained in this report, the e-Perfect Disposal did not constitute a notifiable transaction of the Company under Chapter 19 of the GEM Listing Rules. The e-Perfect Disposal fell under the definition of “connected transaction” under Chapter 20 of the GEM Listing Rules but was de minimis in nature and therefore was exempt from the reporting, annual review, announcement and independent Shareholders’ approval requirements under Chapter 20 of the GEM Listing Rules. The e-Perfect Disposal did not result in any significant impact on the operation of this business segment.

B2C Online Sales Platform and B2B Product Trading Business

During the Year, revenue derived from this business segment was approximately HK\$121,260,000 (2019: approximately HK\$249,498,000), representing a decrease of approximately 51.4% as compared with that of 2019. The segment loss of this business for the Year was approximately HK\$5,015,000 (2019: profit of approximately HK\$4,107,000).

During the Year, the business-to-customer online sales platform (“B2C Online Sales Platform”) and business-to-business product trading (“B2B Product Trading”) Business segment was challenged by the global economic condition caused by geopolitical tensions and the outbreak of the COVID-19 pandemic, leading to an increasing pressure on logistics, disruptions to global business activities and sluggish market demand.

The Group is committed to enhancing the lifestyle of its customers through developing online and offline sales channel to offer quality products to its customers around the world. During the Year, the Group engaged in the operation of a B2C Online Sales Platform, and the B2B Product Trading, focusing on offering quality electronic lifestyle products to domestic and international customers through its indirect wholly-owned subsidiaries, GET Development Limited and Sure Team (H.K.) Limited. According to the internal sales data of the B2C Online Sales Platform and B2B Product Trading Business, during the Year, over 81% (2019: over 86%) of the revenue of the B2C Online Sales Platform and B2B Product Trading Business was attributable to the sale of electronic lifestyle products which primarily include electronic devices.

於二零二零年十二月三十一日，考慮到香港資訊科技行業競爭激烈、此業務分部的不利經營環境及普暉科技有限公司的財務表現，本集團已向普暉科技有限公司之董事出售其於經營企業管理解決方案及資訊科技合約服務業務的前全資附屬公司普暉科技有限公司之全部股份（「普暉出售事項」）。誠如本報告所載之綜合財務報表附註39(a)所披露，普暉出售事項並無構成GEM上市規則第19章項下本公司之須予公佈交易。普暉出售事項符合GEM上市規則第20章項下之「關連交易」之定義，惟屬最低豁免性質，因此獲豁免遵守GEM上市規則第20章之申報、年度審閱、公告及獨立股東批准規定。普暉出售事項並無對此業務分部的經營造成任何重大影響。

B2C網上銷售平台及B2B產品貿易業務

於本年度，來自此業務分部的收入約為121,260,000港元（二零一九年：約249,498,000港元），較二零一九年減少約51.4%。本年度此業務的分部虧損約為5,015,000港元（二零一九年：溢利約4,107,000港元）。

於本年度，受地緣政治局勢緊張及COVID-19疫情爆發影響，導致物流壓力增加、全球業務活動受阻及市場需求疲弱，企業對客戶網上銷售平台（「B2C網上銷售平台」）及企業對企業產品貿易（「B2B產品貿易」）業務分部面對全球經濟狀況不利的挑戰。

本集團致力通過發展線上及線下銷售渠道，為全球客戶提供優質產品，提升客戶的生活品質。於本年度，本集團從事B2C網上銷售平台營運及B2B產品貿易，專注於透過其間接全資附屬公司智易發展有限公司及定添（香港）有限公司，向國內外客戶提供優質電子生活產品。根據B2C網上銷售平台及B2B產品貿易業務的內部銷售數據，本年度B2C網上銷售平台及B2B產品貿易業務逾81%（二零一九年：逾86%）的收入來自以電子設備為主的電子生活產品銷售。

With an aim of diversifying business portfolio, expanding geographical footprint and increasing market penetration, the Group introduced quality products from various regions of the globe to other parts of the world through the operation of the B2B Product Trading business. In operating the B2B Product Trading business, the Group has strived to carefully control the cost and increase the variety of products when business opportunities arise.

In respect of the operation of the B2C Online Sales Platform, the Group targets to source quality products from various regions around the world and sell them to global customers, who can then enjoy a convenient and secured cross-border online shopping experience. The Group has registered seller accounts on several business-to-customer foreign trade e-commerce platforms to offer a spectrum of quality products to customers around the world.

Headwinds of the volatile market environment and the wider impact from the COVID-19 pandemic will be expected to continue to pose challenges to this business segment. Looking ahead, the Board will continue to carefully review and pay close attention to the performance of this business segment in exercising prudent cost control and credit risks control and maintaining an appropriate balance of risks and opportunities.

Securities Investment Business

During the Year, the Group recorded a segment loss for the securities investment business ("Securities Investment Business") of approximately HK\$12,775,000 (2019: profit of approximately HK\$8,381,000). The segment loss was primarily attributable to the net fair value loss on financial assets at fair value through profit or loss ("FVTPL Financial Assets") of approximately HK\$8,729,000 for the Year (2019: fair value gain of approximately HK\$8,462,000) and the loss on disposal of the FVTPL Financial Assets of approximately HK\$3,942,000 for the Year (2019: Nil).

Escalating trade disputes between the United States and China, global geopolitical tensions and the COVID-19 pandemic had brought instabilities to the Hong Kong financial market over the Year. The Group will continue to explore potential investment opportunities and closely monitor the financial market of Hong Kong as well as the performance of the Securities Investment Business.

As at 31 December 2020, fair value of the FVTPL Financial Assets and financial assets at fair value through other comprehensive income ("FVTOCI Financial Assets") of the Group were approximately HK\$12,310,000 (31 December 2019: approximately HK\$32,536,000) and approximately HK\$1,135,000 (31 December 2019: approximately HK\$1,040,000) respectively, consisting of four (2019: four) investment items, three of which are shares listed on the Stock Exchange and one is shares of an unlisted company.

為多元化業務組合、擴大地域覆蓋範圍及提高市場滲透率，本集團透過經營B2B產品貿易業務將全球各地的優質產品轉口貿易至全球其他地區。在經營B2B產品貿易業務過程中，本集團努力謹慎控制成本並在出現商機時增加產品種類。

在經營B2C網上銷售平台方面，本集團從全球各地採購優質產品並轉售予全球客戶，使客戶可享受便捷及有保障的跨境網上購物體驗。本集團已在多個企業對消費者外貿電子商務平台註冊賣家賬戶，為全球客戶提供種類豐富的優質產品。

預計市場環境波動及COVID-19疫情的廣泛影響將繼續對此業務分部構成挑戰。未來，董事會將繼續審慎審視並密切關注此業務分部的表現，審慎控制成本及信貸風險及在風險與機遇之間維持適當的平衡。

證券投資業務

於本年度，本集團錄得證券投資業務（「證券投資業務」）之分部虧損約12,775,000港元（二零一九年：溢利約8,381,000港元）。分部虧損主要由於本年度透過損益以公平價值列賬的金融資產（「透過損益以公平價值列賬的金融資產」）的公平價值虧損淨額約8,729,000港元（二零一九年：公平價值收益約8,462,000港元）及本年度出售透過損益以公平價值列賬的金融資產的虧損約3,942,000港元（二零一九年：無）。

中美貿易爭端升級、全球地緣政治局勢緊張及COVID-19疫情，為香港金融市場帶來不穩定因素。本集團將繼續探尋潛在投資機會，並密切監察香港金融市場情況及證券投資業務的表現。

於二零二零年十二月三十一日，本集團透過損益以公平價值列賬的金融資產及透過其他全面收益以公平價值列賬的金融資產（「透過其他全面收益以公平價值列賬的金融資產」）的公平價值分別約為12,310,000港元（二零一九年十二月三十一日：約32,536,000港元）及約為1,135,000港元（二零一九年十二月三十一日：約1,040,000港元），其由四個（二零一九年：四個）投資項目組成，其中三個項目為於聯交所上市的股份，一個項目為非上市公司股份。

Convoy Global (stock code: 1019) and its subsidiaries (collectively referred to as the "Convoy Group") principally engage in independent financial advisory business, money lending business, asset management business and securities dealing business. Based on the annual report of Convoy Global for the year ended 31 December 2019 published on 18 February 2021, the Convoy Group's revenue for the year ended 31 December 2019 was approximately HK\$957.7 million (2018: approximately HK\$802.7 million), representing an increase of approximately 19.3% relative to the year before. The Convoy Group recorded a loss before tax of approximately HK\$537.8 million for the year ended 31 December 2019 (2018: loss of approximately HK\$616.5 million), representing a decrease of approximately 12.8% relative to the year before. As disclosed in the same report of Convoy Global, the Convoy Group was building new business and reorienting itself for a broader set of opportunities, with a robust risk management approach and a strong balance sheet with the talent to deploy it. The Convoy Group has successfully rebuilt its brand and was investing across its businesses and bringing the world-class technology and expertise to serve new and existing customers, to build a one-stop omni-channel financial service platform. The management of Convoy Global was confident that the Convoy Group was in a solid position to accelerate the Convoy Group's ambitions in the financial services sector and poised for strong growth in years to come. At the request of Convoy Global, trading in its shares on the Stock Exchange was suspended since 7 December 2017. As disclosed in the announcements of Convoy Global dated 5 June 2020, 31 July 2020, 28 August 2020, 30 October 2020 and 11 March 2021, the Listing Committee of the Stock Exchange decided to cancel the listing of Convoy Global under Rule 6.01A of the Listing Rules. Convoy Global submitted a written submission to the Listing Review Committee for the purpose of the review of the delisting decision. As disclosed in the announcements of Convoy Global dated 11 March 2021, on 10 March 2021, Convoy Global was informed that the review hearing for the delisting decision will be heard on 30 March 2021. As disclosed in the announcements of Convoy Global dated 29 July 2020, 17 August 2020, 24 August 2020, 28 August 2020, 28 September 2020 and 25 February 2021, there was a possible conditional voluntary share exchange offer by National Arts Entertainment and Culture Group Limited ("National Arts") (stock code: 8228), a company whose shares are listed on GEM, to acquire shares in Convoy Global. On 15 March 2021, Convoy announced that the board of National Arts has come to a decision to discontinued the conditional voluntary share exchange offer.
2. 康宏環球(股份代號:1019)及其附屬公司(統稱為「康宏集團」)主要從事獨立理財顧問業務、借貸業務、資產管理業務及證券買賣業務。根據康宏環球於二零二一年二月十八日就截至二零一九年十二月三十一日止年度所刊發之年報,康宏集團於截至二零一九年十二月三十一日止年度之收入為約957,700,000港元(二零一八年:約802,700,000港元),較上一年增加約19.3%。康宏集團就截至二零一九年十二月三十一日止年度錄得除稅前虧損約537,800,000港元(二零一八年:虧損約616,500,000港元),較上一年減少約12.8%。誠如康宏環球之上述年報所披露,憑藉穩健的風險管理方針及強大的資產負債表,以及人才配置,康宏集團現正建立新業務並調整方向,以迎接更多機遇。康宏集團已成功重塑品牌,在各業務上進行投資,並引入世界一流的技術及專業知識以向新舊客戶提供服務,打造一站式全方位金融服務平台。康宏環球之管理層有信心康宏集團地位穩固,加快康宏集團在金融服務行業的鴻圖偉略,並為未來幾年的強勁增長做好準備。應康宏環球的要求,其股份自二零一七年十二月七日起在聯交所暫停交易。誠如康宏環球日期為二零二零年六月五日、二零二零年七月三十一日、二零二零年八月二十八日、二零二零年十月三十日及二零二一年三月十一日之公告所披露,聯交所上市委員會根據上市規則第6.01A條決定取消康宏環球的上市地位。康宏環球已向上市覆核委員會提出覆核除牌決定之書面請求。誠如康宏環球日期為二零二一年三月十一日之公告所披露,於二零二一年三月十日,康宏環球獲告知,除牌決定覆核聆訊將於二零二一年三月三十日舉行。誠如康宏環球日期為二零二零年七月二十九日、二零二零年八月十七日、二零二零年八月二十四日、二零二零年八月二十八日、二零二零年九月二十八日及二零二一年二月二十五日之公告所披露,國藝娛樂文化集團有限公司(「國藝」)(其股份於GEM上市,股份代號:8228)可能作出有條件自願換股要約以收購康宏環球的股份。康宏於二零二一年三月十五日公佈,國藝董事會已決定終止有條件自願換股要約。

3. First Credit (stock code: 8215) and its subsidiaries (collectively referred to as the "First Credit Group") focus on money lending business. Based on the annual report of First Credit for the year ended 31 December 2019 published on 26 March 2020, the First Credit Group's revenue for the year ended 31 December 2019 was approximately HK\$88.88 million, representing a decrease of approximately 4.18% over the revenue of approximately HK\$92.76 million recorded for the year ended 31 December 2018. The loss attributable to owners of the company was approximately HK\$132.89 million for the year ended 31 December 2019 when compared to a profit attributable to owners of the company of approximately HK\$25.93 million for the year ended 31 December 2018. As disclosed in the third quarterly report of First Credit dated 6 November 2020, the revenue of the First Credit Group decreased significantly to approximately HK\$25.95 million for the nine months ended 30 September 2020 from approximately HK\$67.79 million for the nine months ended 30 September 2019. For the nine months ended 30 September 2020, the First Credit Group recorded a significant increase in consolidated loss contributable to owners of the company of approximately HK\$213.35 million as compared to the consolidated loss contributable to owners of the company of approximately HK\$49.90 million for the nine months ended 30 September 2019. Trading in the shares of First Credit has been suspended since 24 November 2017 pursuant to Section 8(1) of the Securities and Futures (Stock Market Listing) Rules (Chapter 571V of the Laws of Hong Kong). As disclosed in the announcement of First Credit dated 24 June 2019, the Stock Exchange has withheld exercising its right to delist First Credit although trading in its shares remained suspended on 31 July 2019. Trading in the shares of First Credit will continue to be suspended until further notice. As disclosed in the announcement of First Credit dated 24 June 2019, First Credit has been using its best endeavour and taking necessary steps to procure for a resumption of trading of the shares. As disclosed in the announcement of First Credit dated 1 February 2021, First Credit had made further submission to the Securities and Futures Commission ("SFC") on 31 December 2020 and had continued its effort in communicating with and addressing the concern of SFC with a view to achieving a resumption of trading of its shares as soon as possible. As disclosed in the same announcement, First Credit will continue to closely monitor its cash position and explore potential investment opportunities including but not limited to investments in bonds, debt instruments, listed equity securities or project-based investments, subject to the prevailing market condition and the financial position of the First Credit Group.
3. 第一信用(股份代號:8215)及其附屬公司(統稱為「第一信用集團」)專注於放債業務。根據第一信用於二零二零年三月二十六日刊發之截至二零一九年十二月三十一日止年度之年度報告,第一信用集團於截至二零一九年十二月三十一日止年度錄得收益約88,880,000港元,較截至二零一八年十二月三十一日止年度所錄得收益約92,760,000港元減少約4.18%。截至二零一九年十二月三十一日止年度,該公司擁有人應佔虧損約為132,890,000港元,而截至二零一八年十二月三十一日止年度該公司擁有人應佔溢利約為25,930,000港元。誠如第一信用於二零二零年十一月六日刊發之第三季度報告所披露,截至二零二零年九月三十日止九個月,第一信用集團之收益由截至二零一九年九月三十日止九個月的約67,790,000港元大幅減少至約25,950,000港元。截至二零二零年九月三十日止九個月,相較截至二零一九年九月三十日止九個月該公司擁有人應佔綜合虧損約49,900,000港元,第一信用集團錄得該公司擁有人應佔綜合虧損大幅增加約213,350,000港元。第一信用之股份已自二零一七年十一月二十四日起根據香港法例第571V章《證券及期貨(在證券市場上市)規則》第8(1)條暫停買賣。誠如第一信用日期為二零一九年六月二十四日的公告所披露,儘管股份於二零一九年七月三十一日仍然暫停買賣,但聯交所保留行使其將第一信用除牌的權利。第一信用之股份將繼續暫停交易,直至另行通知為止。誠如第一信用日期為二零一九年六月二十四日之公告所披露,第一信用一直盡最大努力並採取必要措施以促使恢復股份買賣。誠如第一信用日期為二零二一年二月一日之公告所披露,第一信用已於二零二零年十二月三十一日向證券及期貨事務監察委員會(「證監會」)提交進一步陳述,並繼續努力與證監會溝通及回應其質詢,以求盡快恢復股份買賣。誠如同一份公告所披露,第一信用將繼續緊密監察其現金狀況,並視乎現行市況及第一信用集團財務狀況,探索潛在投資機會,包括但不限於投資債券、債務工具、上市股本證券或以項目為基礎的投資。

The principal businesses of Tailam (stock code: 6193) and its subsidiaries (collectively referred to as the "Tailam Group") are manufacturing and selling prestressed high-strength concrete piles and commercial concrete in the People's Republic of China ("PRC"). On 25 March 2019, a subscription agreement ("Subscription Agreement") was entered into by Perfect Growth Limited ("Perfect Growth"), a wholly-owned subsidiary of the Company, Tailam and a guarantor ("Tailam Guarantor"), being an individual who is the majority shareholder of Tailam, pursuant to which Perfect Growth agreed to subscribe for, and Tailam agreed to allot and issue, 1,400,000 ordinary shares of HK\$0.01 par value each in the issued share capital of Tailam at the subscription price of HK\$19,500,000 in cash, subject to the terms and conditions of the Subscription Agreement. Dealing in the shares of Tailam commenced at 9:00 a.m. on 18 December 2019 on the Main Board of the Stock Exchange. Immediately following completion of the capitalisation issue and the share offer of Tailam, Perfect Growth was interested in 21,000,000 ordinary shares, representing approximately 5.25% of the issued share capital of Tailam. As disclosed in the prospectus of Tailam dated 5 December 2019, Perfect Growth had irrevocably undertaken to Tailam and the Tailam Guarantor that subject to compliance with the requirements of applicable Hong Kong laws, regulations and provisions of the Rules Governing the Listing of Securities on the Stock Exchange, Perfect Growth would not, among others, dispose of the shares of Tailam of which it is shown in the prospectus of Tailam to be beneficial owner during the period ended on the date which is 180 days from the date of listing of shares of Tailam (i.e. 15 June 2020). For further details of the Company's investment in Tailam, please refer to the Company's announcement dated 25 March 2019 and the prospectus of Tailam dated 5 December 2019. As disclosed in the annual report of Tailam for the year ended 31 December 2019 dated 31 March 2020, the revenue of the Tailam Group increased by approximately RMB86.9 million, or approximately 19.1%, from approximately RMB454.2 million for the year ended 31 December 2018 to approximately RMB541.1 million for the year ended 31 December 2019. Profit of the Tailam Group decreased by approximately RMB8.7 million, or approximately 25.7%, from approximately RMB34.0 million for the year ended 31 December 2018 to approximately RMB25.3 million for the year ended 31 December 2019. As disclosed in the interim report of Tailam dated 25 August 2020, the revenue of the Tailam Group decreased by approximately RMB94.3 million from approximately RMB271.3 million for the six months ended 30 June 2019 to approximately RMB177.0 million for the six months ended 30 June 2020. The Tailam Group recorded a profit of approximately RMB6.7 million for the six months ended 30 June 2020, representing a decrease of approximately RMB9.8 million as compared to that for the corresponding period in 2019. The Tailam Group will adhere to prudent financial management in project selection and cost control. Tailam Group will try its best to look for new business opportunities to offset the negative impacts of the COVID-19 outbreak. The Tailam Group will continue to explore various opportunities in construction industry to create greater value for shareholders of the Company.
4. 泰林 (股份代號：6193) 及其附屬公司 (統稱為「泰林集團」) 主要業務為於中華人民共和國 (「中國」) 製造及銷售預應力高強度混凝土管樁及商品混凝土。於二零一九年三月二十五日，本公司之全資附屬公司肇堅有限公司 (「肇堅」)、泰林及一名擔保人 (「泰林擔保人」，一名個人，為泰林的主要股東) 訂立一份認購協議 (「認購協議」)，據此，於認購協議條款及條件的規限下，肇堅同意認購及泰林同意配發及發行泰林已發行股本中每股面值0.01港元的1,400,000股普通股，認購價為現金19,500,000港元。泰林股份於二零一九年十二月十八日上午九時正起於聯交所主板開始買賣。緊隨泰林資本化發行及股份發售完成後，肇堅擁有21,000,000股普通股權益，相當於泰林已發行股本約5.25%。誠如泰林日期為二零一九年十二月五日之招股章程所披露，肇堅已不可撤回地向泰林及泰林擔保人承諾，在遵守適用香港法例、規例及聯交所證券上市規則條文的規限下，肇堅將不會 (其中包括) 於截至泰林股份上市日期起計滿180天 (即二零二零年六月十五日) 當日止期間出售根據泰林之招股章程所示其身為實益擁有人的泰林股份。有關本公司於泰林投資的進一步詳情，請參閱本公司日期為二零一九年三月二十五日之公告及泰林日期為二零一九年十二月五日之招股章程。誠如泰林於二零二零年三月三十一日刊發之截至二零一九年十二月三十一日止年度之年報所披露，泰林集團的收益由截至二零一八年十二月三十一日止年度的約人民幣454,200,000元增加約人民幣86,900,000元或約19.1%至截至二零一九年十二月三十一日止年度的約人民幣541,100,000元。泰林集團的溢利由截至二零一八年十二月三十一日止年度的約人民幣34,000,000元減少約人民幣8,700,000元或約25.7%至截至二零一九年十二月三十一日止年度的約人民幣25,300,000元。誠如泰林日期為二零二零年八月二十五日的中期報告所披露，泰林集團的收益由截至二零一九年六月三十日止六個月的約人民幣271,300,000元減少約人民幣94,300,000元至截至二零二零年六月三十日止六個月的約人民幣177,000,000元。泰林集團於截至二零二零年六月三十日止六個月錄得溢利約人民幣6,700,000元，較二零一九年同期減少約人民幣9,800,000元。泰林集團將於項目篩選及成本控制方面堅守謹慎的財務管理。泰林集團將盡力尋求新業務機遇，以抵銷COVID-19爆發帶來的負面影響。泰林集團將繼續於建築行業開拓不同機會，為本公司的股東創造更大價值。

5. Jun Yang Energy, which was incorporated in the Cayman Islands, is an unlisted company. Jun Yang Energy and its subsidiaries (collectively referred to as the “Jun Yang Energy Group”) principally engage in solar energy business with a focus on development, construction, operation and maintenance of power stations in the PRC. Based on the unaudited consolidated management accounts of the Jun Yang Energy Group for the year ended 31 December 2019, the revenue of the Jun Yang Energy Group for the year ended 31 December 2019 amounted to approximately HK\$67,331,000 (2018: approximately HK\$75,990,000). Loss of the Jun Yang Energy Group for the year ended 31 December 2019 was approximately HK\$5,326,000 (2018: approximately HK\$59,853,000). On 31 May 2018, the National Development and Reform Commission and the Ministry of Finance and National Energy Administration jointly released the “Notice on matters relevant to photovoltaic power generation in 2018”, stating that construction of general solar power stations had been suspended in 2018 and standardised management applied to development of distributed solar power generation projects, and for new-on-grid solar power operations, the levels of subsidy had been lowered. The management of Jun Yang Energy will continue to keep a close watch on policy direction and change in development situations, adjust its capital strategy accordingly and make timely disclosure to its shareholders. Pursuant to a shareholder loan agreement entered into by the Group as shareholder of Jun Yang Energy in February 2017, a loan in the principal amount of US\$3,500,000 (equivalent to approximately HK\$27,230,000) was provided to Jun Yang Energy. Taking into account the declining financial performance and working capital position of the Jun Yang Energy Group and the low recoverability of the loan due from the Jun Yang Energy Group, the Group recorded an expected credit loss allowance of approximately HK\$27,230,000 on the loan due from the Jun Yang Energy Group for the year ended 31 December 2018. Details of the shareholder loan agreement and the provision of the expected credit loss allowance are set out in the Company’s announcement dated 24 February 2017 and the annual report of the Company for the year ended 31 December 2019 respectively.
5. 君陽能源為一間於開曼群島註冊成立的非上市公司。君陽能源及其附屬公司（統稱「君陽能源集團」）主要於中國從事太陽能業務（專注於發電站之開發、建設、營運及維護）。根據君陽能源集團於截至二零一九年十二月三十一日止年度之未經審核綜合管理賬目，君陽能源集團於截至二零一九年十二月三十一日止年度之收益為約67,331,000港元（二零一八年：約75,990,000港元）。君陽能源集團於截至二零一九年十二月三十一日止年度之虧損為約5,326,000港元（二零一八年：約59,853,000港元）。於二零一八年五月三十一日，國家發展和改革委員會、財政部及國家能源局聯合印發《關於二零一八年光伏發電有關事項的通知》，宣佈暫停安排二零一八年普通太陽能電站建設，規範管理分佈式太陽能發電項目發展，同時下降新投運的光伏電站補貼標準。君陽能源管理層將繼續密切留意政策動向及事態發展，視事況調整資金策略並及時向其股東披露。根據本集團（作為君陽能源的股東）於二零一七年二月訂立的股東貸款協議，向君陽能源提供一筆本金金額為3,500,000美元（相當於約27,230,000港元）的貸款。經考慮君陽能源集團的財務表現下滑及營運資金狀況，以及應收君陽能源集團貸款的可收回程度低，本集團於截至二零一八年十二月三十一日止年度錄得應收君陽能源集團貸款的預期信貸虧損撥備約27,230,000港元。該股東貸款協議及計提預期信貸虧損撥備之詳情分別載於本公司日期為二零一七年二月二十四日之公告及本公司截至二零一九年十二月三十一日止年度之年報。

FINANCIAL REVIEW

Revenue

During the Year, revenue of the Group's operations was approximately HK\$231,404,000, representing a decrease of approximately 37.4% as compared to the revenue of approximately HK\$369,839,000 for 2019. The revenue of the Group for the Year was mainly contributed by the revenue of (i) the Software Business of approximately HK\$82,252,000; (ii) the Corporate Management Solutions and I.T. Contract Services Business of approximately HK\$27,892,000; and (iii) the B2C Online Sales Platform and B2B Product Trading Business of approximately HK\$121,260,000.

Gross Profit

Gross profit of the Group for the Year decreased by approximately 2.07% to approximately HK\$71,509,000 for the Year from approximately HK\$73,017,000 for 2019.

Finance Costs

The finance costs of the Group were approximately HK\$98,000 for the Year, representing a decrease of approximately 4.9% from approximately HK\$103,000 for 2019.

Loss for the Year

The Group recorded a net loss of approximately HK\$32,410,000 for the Year (2019: net loss of approximately HK\$61,680,000). The net loss for the Year was mainly the combined effects of (i) segment profit of the Software Business of approximately HK\$23,347,000 (2019: loss of approximately HK\$46,264,000); (ii) segment loss of the Securities Investment Business of approximately HK\$12,775,000 (2019: profit of approximately HK\$8,381,000); (iii) segment loss of the Corporate Management Solutions and I.T. Contract Services Business of approximately HK\$17,907,000 (2019: loss of approximately HK\$6,794,000), including the Impairment Loss on Goodwill of approximately HK\$11,300,000 (2019: approximately HK\$254,000); (iv) segment loss of the B2C Online Sales Platform and B2B Product Trading Business of approximately HK\$5,015,000 (2019: profit of approximately HK\$4,107,000); and (v) other corporate expenses of approximately HK\$12,894,000 incurred during the Year (2019: approximately HK\$14,996,000).

The net loss attributable to owners of the Company was approximately HK\$39,286,000 for the Year as compared with the net loss attributable to owners of the Company of approximately HK\$67,200,000 for 2019.

收入

毛利

於本年度，本集團的毛利由二零一九年約73,017,000港元減少約2.07%至本年度約71,509,000港元。

融資成本

本集團於本年度融資成本約為98,000港元，較二零一九年約103,000港元減少約4.9%。

本年度虧損

於本年度，本集團錄得虧損淨額約32,410,000港元（二零一九年：虧損淨額約61,680,000港元）。於本年度錄得虧損淨額主要歸因於(i)軟件業務錄得分部溢利約23,347,000港元（二零一九年：虧損約46,264,000港元）；(ii)證券投資業務錄得分部虧損約12,775,000港元（二零一九年：溢利約8,381,000港元）；(iii)企業管理解決方案及資訊科技合約服務業務錄得分部虧損約17,907,000港元（二零一九年：虧損約6,794,000港元），包括商譽減值虧損約11,300,000港元（2019年：約254,000港元）；(iv)B2C網上銷售平台及B2B產品貿易業務錄得分部虧損約5,015,000港元（二零一九年：溢利約4,107,000港元）；及(v)本年度產生的其他企業開支約12,894,000港元（二零一九年：約14,996,000港元）的綜合影響。

於本年度，本公司擁有人應佔虧損淨額約為39,286,000港元，而二零一九年的本公司擁有人應佔虧損淨額則約為67,200,000港元。

Liquidity, Financial Resources and Capital Structure

As at 31 December 2020, the Group had cash and cash equivalents and pledged bank deposit of approximately HK\$118,804,000 (31 December 2019: approximately HK\$81,350,000), which were principally denominated in United States dollars, Hong Kong dollars and Renminbi (2019: United States dollars and Hong Kong dollars). During the Year, the Group generally financed its operations with internal resources and there was no significant change in its capital structure.

Gearing Ratio

As at 31 December 2020, the Group had total assets amounting to approximately HK\$326,665,000 (31 December 2019: approximately HK\$370,896,000) and total liabilities of approximately HK\$57,821,000 (31 December 2019: approximately HK\$64,320,000). The gearing ratio of the Group, calculated as total liabilities over total assets, was approximately 17.7% as at 31 December 2020 (31 December 2019: approximately 17.3%).

Final Dividend

The Board does not recommend any payment of dividend for the Year (2019: Nil).

Charges on the Group's Assets

As at 31 December 2020, the Group pledged bank deposits of approximately US\$81,000 (equivalent to approximately HK\$630,000) (31 December 2019: approximately US\$81,000 (equivalent to approximately HK\$627,000) for securing banking facilities of HK\$500,000 (31 December 2019: HK\$500,000) granted to the Group. The bank deposits were denominated in United States dollars with a term of six months at fixed interest rate of 0.05% per annum.

As at 31 December 2020, the Group had undrawn banking facilities of approximately HK\$242,000 (31 December 2019: approximately HK\$857,000).

As at 31 December 2020 and 31 December 2019, the Group did not hold any margin trading account.

流動資金、財務資源及資本架構

於二零二零年十二月三十一日，本集團的現金及現金等價物以及已抵押銀行存款約為118,804,000港元（二零一九年十二月三十一日：約81,350,000港元），主要以美元、港元及人民幣（二零一九年：美元及港元）列值。於本年度，本集團一般應用內部資源為營運基金。本集團之資本架構概無重大變動。

資產負債比率

於二零二零年十二月三十一日，本集團的資產總值約為326,665,000港元（二零一九年十二月三十一日：約370,896,000港元），而負債總額則約為57,821,000港元（二零一九年十二月三十一日：約64,320,000港元）。本集團於二零二零年十二月三十一日的資產負債比率（即負債總額除以資產總值）約為17.7%（二零一九年十二月三十一日：約17.3%）。

RISK FACTORS

Foreign Exchange Exposure

During the Year, business activities of the Group were mainly denominated in United States dollars, Hong Kong dollars and Renminbi. The United States dollar is the main currency for transactions made by the Group. Since the Hong Kong dollar remains pegged to the United States dollar within a defined range, the Group is not exposed to any significant foreign exchange risk against the United States dollar. The Group has not entered into any foreign exchange contract as hedging measures. The Directors did not consider the Group as being exposed to any significant foreign currency exchange risk. Notwithstanding the above, the Group continues to manage its foreign currency risk against other currencies by closely monitoring movement of exchange rates and may use hedging derivatives, such as foreign currency forward contracts, as and when appropriate.

Financial Risk

The total assets of the Group of approximately HK\$326,665,000 as at 31 December 2020 mainly included the FVTOCI Financial Assets of approximately HK\$1,135,000, the FVTPL Financial Assets of approximately HK\$12,310,000, goodwill of approximately HK\$69,525,000 and intangible assets of approximately HK\$90,762,000. The Group's FVTOCI Financial Assets and the FVTPL Financial Assets are measured at fair value at the end of each reporting period. Therefore, the Group is exposed to equity security price risk due to fluctuation of the fair value of the FVTOCI Financial Assets and the FVTPL Financial Assets. The Directors regularly review exposure of the Group's FVTOCI Financial Assets and the FVTPL Financial Assets to equity security price risk. Moreover, the Directors closely monitor the financial performance and operation of cash generating units containing goodwill and intangible assets, and conduct impairment review on goodwill and intangible assets annually and more frequently should there be any unforeseeable events or changes in circumstances pointing to potential impairment.

Operation Risk

The Group is exposed to the corresponding operation risks each of its business divisions faces. To manage those risks, the management of each business division is responsible for monitoring the operation of their respective divisions and assessing related operation risks. They are responsible for implementing the Group's risk management policies and procedures and shall report any irregularities in connection with operation of projects to the Directors and seek direction.

外匯風險

於本年度，本集團的業務活動主要以美元、港元及人民幣列值。美元為本集團的主要交易貨幣。由於港元仍在既定範圍內與美元掛鈎，故在兌換美元上本集團並無承受任何重大外匯風險，本集團無訂立任何外匯合約作為對沖措施。董事認為，本集團並無承受任何重大外匯風險。儘管存在上述情況，本集團仍繼續透過密切監察外幣匯率走勢管理兌換其他貨幣的外幣風險，並可能於適當情況下利用對沖衍生工具（如外幣遠期合約）管理其外幣風險。

財務風險

本集團於二零二零年十二月三十一日的資產總值約326,665,000港元，主要包括透過其他全面收益以公平價值列賬的金融資產約1,135,000港元、透過損益以公平價值列賬的金融資產約12,310,000港元、商譽約69,525,000港元及無形資產約90,762,000港元。本集團的透過其他全面收益以公平價值列賬的金融資產及透過損益以公平價值列賬的金融資產按於各報告期末的公平價值計量。因此，本集團由於透過其他全面收益以公平價值列賬的金融資產及透過損益以公平價值列賬的金融資產的公平價值波動而承受股本證券價格風險。董事定期檢討本集團透過其他全面收益以公平價值列賬的金融資產及透過損益以公平價值列賬的金融資產的股本證券價格風險。此外，董事密切監察各包含商譽及無形資產的現金產出單元之財務表現及營運，且每年對商譽及無形資產進行減值檢討，及倘任何突發事件或環境變化導致潛在減值時更頻密進行。

營運風險

本集團面臨與本集團各業務分部有關的營運風險。為管理營運風險，各業務分部的管理層負責監控彼等各自業務分部的業務經營及評估營運風險。彼等負責落實本集團的風險管理政策及程序，並應向董事報告有關項目營運的任何不合規情況並尋求指示。

Credit Risk

The Group is exposed to credit risk which is mainly attributable to its trade and other receivables. During the Year, the Group's credit risk mainly arose from the operating activities of the B2C Online Sales Platform and B2B Product Trading Business and the Corporate Management Solutions and I.T. Contract Services Business. Please refer to note 6(c) to the consolidated financial statements contained in this report for details of the credit risk of the Group for the Year. The trade and other receivables of the Group were approximately HK\$29,891,000 as at 31 December 2020. During the Year, due to the worsening economic environment caused by the COVID-19 pandemic and socio-political instability, the chance of default in payment may inevitably be higher than expected. To minimise credit risk, the Directors continue to closely monitor the overall level of credit exposure, whereas the management is responsible for determining credit approvals and monitoring the implementation of collection procedure to ensure follow-up actions are taken to recover overdue debts. In addition, the Group reviews the recoverable amount of each individual trade debt at the end of a reporting period to ensure adequate impairment losses are made for irrecoverable amounts.

LITIGATIONS

As at 31 December 2020, the Group was involved in the following civil legal proceedings, namely, the Perfect Growth Litigation, the AP Acquisition Litigation and the AP Management Litigation (all as defined below).

信貸風險

訴訟

於二零二零年十二月三十一日，本集團涉及以下民事法律訴訟，即肇堅訴訟、愛拼收購訴訟及愛拼管理人員訴訟（定義均見下文）。

(1) Perfect Growth Litigation

On 3 July 2018, Perfect Growth, a wholly-owned subsidiary of the Company, received an amended writ of summons (“Amended Writ”) with an amended statement of claim (“Amended Statement of Claim”) issued in the Court of First Instance of the High Court of Hong Kong by Convoy Global (“1st Plaintiff”), Convoy Collateral Limited (“2nd Plaintiff”) and CSL Securities Limited (“3rd Plaintiff”) (1st Plaintiff, 2nd Plaintiff and 3rd Plaintiff collectively referred to as the “Plaintiffs”) against, among other defendants, Perfect Growth as the 34th defendant (“Perfect Growth Litigation”). Perfect Growth was joined as one of the defendants by way of the Amended Writ.

Pursuant to the Amended Statement of Claim attached to the Amended Writ, Perfect Growth was named as one of the Alleged Independent Placees (being placees of the placing of shares of the 1st Plaintiff carried out in around October 2015 (“October 2015 Placing”)) and was allotted with some shares of the 1st Plaintiff pursuant to the October 2015 Placing.

In the Perfect Growth Litigation, the reliefs claimed by the Plaintiffs against Perfect Growth are as follows:

- (1) the 1st Plaintiff seeks a declaration and an order as against, among others, Perfect Growth, that the allotment of the 1st Plaintiff’s shares to, among others, Perfect Growth pursuant to the October 2015 Placing is null and void, or has been rescinded and be set aside;
- (2) the 1st Plaintiff seeks an account of profits and an order for payment of any sums found to be due, equitable compensation to be assessed and/or damages to be assessed for dishonest assistance, unlawful means conspiracy and/or lawful means conspiracy as against, among others, Perfect Growth, in relation to, among other matters, the October 2015 Placing and the allotment of the 1st Plaintiff’s shares pursuant to the same; and
- (3) the Plaintiffs seek as against, among others, Perfect Growth (a) general or special damages; (b) interests; (c) costs; (d) further and/or other reliefs.

(1) 肇堅訴訟

於二零一八年七月三日，本公司之全資附屬公司肇堅接獲由康宏環球（「第一原告人」）、康宏財務有限公司（「第二原告人」）及康證有限公司（「第三原告人」）（第一原告人、第二原告人及第三原告人統稱為「該等原告人」）入稟香港高等法院原訟法庭向包括肇堅（為第34名被告人）在內的被告人發出之經修訂傳訊令狀（「經修訂令狀」）連同經修訂申索陳述書（「經修訂申索陳述書」）（「肇堅訴訟」）。肇堅因經修訂令狀而被加入成為其中一名被告人。

根據經修訂令狀隨附之經修訂申索陳述書，肇堅被列為聲稱獨立承配人之一（即第一原告人於二零一五年十月前後進行之股份配售（「二零一五年十月配售」）之承配人），並曾根據二零一五年十月配售獲配發第一原告人之若干不當配發股份。

該等原告人於肇堅訴訟針對肇堅而申索的濟助如下：

- (1) 第一原告人尋求針對（其中包括）肇堅宣佈及頒令，使第一原告人根據二零一五年十月配售獲配發第一原告人之向（其中包括）肇堅配發之不當配發股份應告無效及不再具有效力，或予以撤回及撤銷；
- (2) 第一原告人尋求，就（其中包括）二零一五年十月配售及第一原告人據此配發不當配發股份而針對（其中包括）肇堅作出頒令，要求交出利潤及支付被發現到期的款項、因不誠實協助、非法及／或合法手段串謀而將予評定之衡平補償及／或將予評定之損害賠償；及
- (3) 該等原告人尋求，針對（其中包括）肇堅申索(a)一般或特定損害賠償；(b)利息；(c)訟費；(d)進一步及／或其他濟助。

On 22 November 2018, Perfect Growth filed its defence to the Amended Statement of Claim.

On 3 December 2019, the Plaintiffs filed its reply to Perfect Growth's defence. The Plaintiffs have not, however, filed its reply to each of the other defendants' defence, and as such the pleadings of the Perfect Growth Litigation have not been closed yet.

Details of the Perfect Growth Litigation are set out in the Company's announcement dated 5 July 2018.

(2)(a) AP Acquisition Litigation

References are made to the announcements of the Company dated 13 June 2016, 23 June 2016 and 1 July 2016 in relation to, among other matters, the acquisition of 51% equity interest in AP Group Investment Holdings Limited ("AP Group Investment", together with its subsidiaries, referred to as the "AP Group") ("Acquisition") and the announcements of the Company dated 12 June 2018, 26 June 2018 and 16 July 2018 in relation to the adjustment to consideration for the Acquisition.

On 13 June 2016, Lucky Famous Limited ("Lucky Famous"), a wholly owned subsidiary of the Company, entered into a sale and purchase agreement ("SP Agreement") with Fragrant River Entertainment Culture (Holdings) Limited ("Vendor") and Universe International Holdings Limited (now known as Universe Entertainment and Culture Group Company Limited) ("Guarantor"), pursuant to which the Group conditionally agreed to acquire, and the Vendor conditionally agreed to sell 51% equity interest of AP Group Investment, at the consideration of HK\$20,400,000, subject to downward adjustments as described below, which shall be settled by way of allotment and issue of 40,800,000 new ordinary shares of the Company, credited as fully paid, at the issue price of HK\$0.50 per share to the Vendor (or its nominee), on the date of completion. The AP Group was principally engaged in the provision of self-improvement and self-enhancement training programmes in Hong Kong. Completion of the Acquisition took place on 1 July 2016.

於二零一九年十二月三日，該等原告人對肇堅之抗辯提出答辯。然而，該等原告人並無對其他被告人各自的抗辯進行答辯，因此肇堅訴訟之狀書尚未結束。

肇堅訴訟之詳情載於本公司日期為二零一八年七月五日之公告。

(2)(a) 愛拼收購訴訟

茲提述本公司日期為二零一六年六月十三日、二零一六年六月二十三日及二零一六年七月一日的公告，內容有關（其中包括）收購愛拼集團控股有限公司（「愛拼集團控股」，連同其附屬公司統稱「愛拼集團」）51%股權（「收購事項」）及本公司日期為二零一八年六月十二日、二零一八年六月二十六日及二零一八年七月十六日之公告，內容有關就收購事項調整代價。

於二零一六年六月十三日，本公司全資附屬公司 Lucky Famous Limited（「Lucky Famous」）與香江娛樂文化（控股）有限公司（「賣方」）及寰宇國際控股有限公司（現稱為寰宇娛樂文化集團有限公司）（「擔保人」）訂立一份買賣協議（「買賣協議」），據此，本集團有條件同意收購而賣方有條件同意出售愛拼集團控股的51%股權，代價為20,400,000港元（可按下文所述進行下調），將通過於完成日期按每股0.50港元之發行價，向賣方（或其代名人）配發及發行40,800,000股入賬列作繳足之本公司新普通股之方式支付。愛拼集團主要於香港從事提供有關自我提升及自我增值培訓計劃。收購事項於二零一六年七月一日完成。

In accordance with the terms and conditions of the SP Agreement, in the event that the audited consolidated profit after tax of AP Group Investment attributable to its owners from 1 January 2016 to 31 December 2017 (“FY 2016 & 2017”) (which will only include income or gain generated by activities in the ordinary and usual course of business of the AP Group) (“FY 2016 & 2017 Net Profit”) is less than HK\$16,000,000, the Vendor shall, and the Guarantor shall procure the Vendor to, pay to Lucky Famous (or to its order) an adjustment amount (“Adjustment Amount”) in cash within 14 days after the audited consolidated financial statements of AP Group Investment for FY 2016 & 2017 (“FY 2016 & 2017 Audited Accounts”) are available. The Adjustment Amount shall be determined in accordance with the formula set out below:

$$A = \text{HK\$}20,400,000 - (\text{NP}/2) \times 5 \times 51\%$$

Where:

“A” means the amount of the Adjustment Amount in HK\$; and

“NP” means the FY 2016 & 2017 Net Profit. Where the FY 2016 & 2017 Net Profit is a negative figure, “NP” shall be deemed to be zero.

The FY 2016 & 2017 Net Profit shall be based on the FY 2016 & 2017 Audited Accounts which shall be prepared in accordance with the Hong Kong Financial Reporting Standards and audited, adjusted for any non-recurring items.

Based on the FY 2016 & 2017 Audited Accounts, the AP Group recorded a net loss of HK\$189,799. In accordance with the SP Agreement, the FY 2016 & 2017 Net Profit of the AP Group shall be deemed to be zero. Accordingly, the Group has requested the Vendor and the Guarantor to pay the Adjustment Amount of HK\$20,400,000 on or before 26 June 2018 according to the terms and conditions of the SP Agreement (“AP Receivable”). On 22 June 2018, the Group received a letter from the legal adviser acting for the Vendor and the Guarantor that they will defend the purported claim of the Group for the payment of the Adjustment Amount alleged by the Group.

Up to 26 June 2018, i.e. the last date on which the Vendor and the Guarantor shall pay the Adjustment Amount after the FY 2016 & 2017 Audited Accounts were made available to them, the Group had not received any payment of the Adjustment Amount from any of the Vendor and the Guarantor.

根據買賣協議的條款及條件，倘於二零一六年一月一日至二零一七年十二月三十一日（「二零一六財年及二零一七財年」）愛拼集團控股擁有人應佔其經審核綜合除稅後溢利（將僅包括於愛拼集團正常及日常業務過程中的活動所產生的收入或收益）（「二零一六財年及二零一七財年純利」）低於16,000,000港元，賣方將且擔保人將促使賣方在愛拼集團控股於二零一六財年及二零一七財年經審核綜合財務報表（「二零一六財年及二零一七財年經審核賬目」）刊發後十四日內以現金向Lucky Famous（或根據其指令）支付調整金額（「調整金額」）。調整金額將根據下列公式釐定：

$$A = 20,400,000 \text{ 港元} - (\text{NP}/2) \times 5 \times 51\%$$

「A」指調整金額（港元）；及

「NP」指二零一六財年及二零一七財年純利。倘二零一六財年及二零一七財年純利為負值，則「NP」將視作零。

二零一六財年及二零一七財年純利應根據二零一六財年及二零一七財年經審核賬目釐定，而該等賬目應根據香港財務報告準則編製及審核，並就任何非經常性項目調整。

基於二零一六財年及二零一七財年經審核賬目，愛拼集團錄得淨虧損189,799港元。根據買賣協議，愛拼集團於二零一六財年及二零一七財年純利應視作零。因此，本集團已要求賣方及擔保人於二零一八年六月二十六日或之前按照買賣協議的條款及條件支付調整金額20,400,000港元（「愛拼應收款項」）。於二零一八年六月二十二日，本集團接獲代表賣方及擔保人的法律顧問函件，表示彼等將就本集團指稱支付調整金額的宣稱索賠作出抗辯。

截至二零一八年六月二十六日（即賣方及擔保人於二零一六財年及二零一七財年經審核賬目發出後支付調整金額的最後日期），本集團並未收到任何賣方及擔保人支付的調整金額。

The Board considered that the Vendor and the Guarantor have potentially breached their contractual obligations by failing to repay the Group the Adjustment Amount in accordance with the terms and conditions of the SP Agreement. In order to safeguard the legitimate rights and interests of the Group, after seeking legal advice, the Group has commenced legal proceeding (“AP Acquisition Litigation”) against the Vendor as the 1st defendant and the Guarantor as the 2nd defendant. A writ of summons with an indorsement of claim were filed by Lucky Famous as plaintiff at the Court of First Instance of the High Court of Hong Kong on 16 July 2018. Based on the writ, the Group claimed against the Vendor and the Guarantor for (a) the Adjustment Amount of HK\$20,400,000; (b) interests; (c) costs; and (d) further and/or other reliefs.

An amended writ of summons with an indorsement of claim were filed at the Court of First Instance of the High Court of Hong Kong on 26 September 2019. Based on the amended writ, the Group claimed against the Vendor and the Guarantor for (a) the Adjustment Amount of HK\$20,400,000; (b) interests; (c) costs; and (d) further and/or other relief, and also against Mr. Chan Sze Long (“Chan”) and Ms. Lim Wah Elsa (“Lim”) for (e) damages in the sum of HK\$20,400,000; (f) interests; (g) costs; and (h) further and/or other relief (collectively, the “Legal Action”). The Board considered that Chan and Lim, who are the former directors of AP Group Investment until their respective resignations on 18 July 2018, have potentially breached their duties and obligations in contract and tort by failing to, amongst other things, prepare audited consolidated financial statements of AP Group Investment for the year ended 31 December 2015, provide the auditors of AP Group Investment with the written information that they requested to support their audit, and keep and/or preserve adequate accounting records in respect of the transactions entered into by AP Group Investment, its financial position and its financial performance.

Details of the AP Acquisition Litigation are set out to the Company’s announcements dated 12 June 2018, 26 June 2018 and 16 July 2018.

於二零一九年九月二十六日，本集團於香港高等法院原訴法庭遞交一份經修訂傳訊令狀及一份申索背書。根據經修訂令狀，本集團就(a)調整金額20,400,000港元；(b)利息；(c)訟費；及(d)進一步及／或其他濟助向賣方及擔保人提出索償，亦就(e)損害賠償合共20,400,000港元；(f)利息；(g)訟費；及(h)進一步及／或其他濟助向陳思朗先生（「陳」）及林樺女士（「林」）提出索償（統稱「法律訴訟」）。董事會認為，陳及林（各自於二零一八年七月十八日辭任前擔任愛拼集團控股前任董事）可能因以下事項而違反合約中彼等之職責及責任及違反侵權法，其中包括未編製愛拼集團控股截至二零一五年十二月三十一日止年度之經審核綜合財務報表、未向愛拼集團控股核數師提供彼等要求以支持彼等審核之書面資料以及未保存及／或存置有關愛拼集團控股所訂立交易、其財務狀況及其財務表現的充足會計記錄。

有關愛拼收購訴訟的詳情載於本公司日期為二零一八年六月十二日、二零一八年六月二十六日及二零一八年七月十六日之公告內。

(2)(b) AP Management Litigation

On 26 July 2018, the Company as the 1st plaintiff and AP Group Investment as the 2nd plaintiff, issued a writ of summons in the High Court of Hong Kong against Chan as the 1st defendant and Lim as the 2nd defendant (collectively referred to as the “Defendants”) for the matters as detailed below (“AP Management Litigation”). Chan and Lim are former directors of AP Group Investment until their respective resignations on 18 July 2018. Chan and/or his controlled company, and the controlled company of Lim, are also former directors of the other members of the AP Group at all material times.

The Company is a majority shareholder holding 51% interest in AP Group Investment through its wholly-owned subsidiary, Lucky Famous. As a result of the 51% shareholding in AP Group Investment, all members of the AP Group are subsidiaries of the Company and their financial results have been consolidated into the Group’s consolidated financial statements prior to the deconsolidation of the AP Group becoming effective on 1 April 2018. The AP Group was principally engaged in the provision of self-improvement and self-enhancement training programs in Hong Kong at all material times.

At all material times and during the tenure of office of the Defendants as directors of AP Group Investment, in reliance of the experience and expertise of the Defendants in running the AP Group, it was agreed by the parties that the Defendants were wholly responsible for the efficient and proper management and operation of the AP Group, including but not limited to, the efficient daily operations of the AP Group, keeping proper books and records of the AP Group at all times for inspection by the Group, and the provision of weekly cash and bank balance reports, annual budget and monthly financial reports of AP Group Investment, including that of all the other members of the AP Group to the Company, within 15 days after each month’s end. After the resignations of the Defendants as directors of AP Group Investment on 18 July 2018 and up to the date of this report, the Defendants failed to deliver up all the accounting books and financial records of, and all businesses records in connection with, the running of the AP Group, including but not limited to records in relation to the students’ records, instructors’ records and information on potential litigations, for the period of seven years immediately prior to the date of their resignations as director of AP Group Investment on 18 July 2018 (“Full Business Records”) to the Group.

(2)(b) 愛拼管理人員訴訟

於二零一八年七月二十六日，本公司（作為第一原告人）與愛拼集團控股（作為第二原告人）入稟香港高等法院，向第一被告人陳（即第一被告人）及第二被告人林（即第二被告人）（統稱「被告人」）就以下詳述之事項發出傳訊令狀（「愛拼管理人員訴訟」）。陳及林為愛拼集團控股的前任董事，直至彼等各自於二零一八年七月十八日辭任。陳及／或其受控公司以及林之受控公司，在所有關鍵時間亦為愛拼集團其他成員公司之前任董事。

本公司為透過其全資附屬公司Lucky Famous持有愛拼集團控股51%股權之主要股東。由於持有愛拼集團控股51%股權，愛拼集團控股之所有成員公司為本公司之附屬公司，其財務業績已於愛拼集團取消綜合入賬於二零一八年四月一日生效前於本集團之綜合財務報表綜合入賬。愛拼集團在所有關鍵時間主要從事在香港提供自我增值及自我提升培訓計劃。

在所有關鍵時間及被告人作為愛拼集團控股董事的任期內，依據被告人營運愛拼集團的經驗及專業知識，訂約方同意由被告人全權負責愛拼集團有效及妥善之管理及營運，包括但不限於愛拼集團之有效日常營運，無論何時均保存愛拼集團適當之賬簿及記錄以供本集團查閱，提供每週現金及銀行結餘報告、年度預算及於各月結日後15天內向本公司提供愛拼集團控股（包括愛拼集團所有成員公司）之月度財務報告。於二零一八年七月十八日被告人辭任愛拼集團控股董事後及直至本報告日期，被告人未能向本集團提供緊接二零一八年七月十八日被告人辭任愛拼集團控股董事前七年期間所有與愛拼集團營運有關之會計賬簿、財務記錄及所有業務記錄，包括但不限於有關學生記錄、講師記錄及潛在訴訟資料之記錄（「完整商業記錄」）。

In order to safeguard the legitimate rights and interests of the Group, after seeking legal advice, the Group has commenced legal proceeding against the Defendants. The Group claimed against the Defendants for the reliefs, including but not limited to, delivering up of the Full Business Records, accounting for the assets of the AP Group that were in the power, possession or control of the Defendants and damages to be assessed.

Details of the AP Management Litigation are set out in the Company's announcement dated 27 July 2018.

(2)(c) Settlement of the AP Acquisition Litigation and the AP Management Litigation

On 1 February 2021, Lucky Famous, the Vendor, the Guarantor, Chan, Lim, Very Easy Limited ("Very Easy"), a company wholly owned by Chan, and City Link Consultancy Limited ("City Link"), a company wholly owned by Lim, without admission of any liability in relation to the Legal Action, had amicably resolved and entered into a settlement agreement ("Settlement Agreement") in relation to the final and full settlement of the Disputes (as defined below). In accordance with the Settlement Agreement, the parties agreed that (i) the disputes in the Legal Action; and (ii) any other claims and complaint that the parties to the Settlement Agreement may have against each other arising out of or in connection with the sale and purchase agreement in respect of the sale and purchase of 510 shares of AP Group Investment entered into by and among the Vendor, Very Easy, City Link, Chan and Lim in 2015 and the SP Agreement (collectively, the "Disputes") shall be settled in full.

為保障本集團的合法權益，經尋求法律意見後本集團已向被告人展開法律訴訟。本集團向被告人提出濟助索償，包括但不限於遞交完整商業記錄、屬被告人權力、管有或控制之愛拼集團的資產核算以及待評估之損害賠償。

有關愛拼管理人員訴訟的詳情載於本公司日期為二零一八年七月二十七日之公告內。

(2)(c) 愛拼收購訴訟及愛拼管理人員訴訟之和解

於二零二一年二月一日，Lucky Famous、賣方、擔保人、陳、林、Very Easy Limited (「Very Easy」) (一間由陳全資擁有的公司) 及City Link Consultancy Limited (「City Link」) (一間由林全資擁有的公司) 在並無接納任何有關法律訴訟責任的情況下已友好議決並就最終及全面解決爭議 (定義見下文) 訂立和解協議 (「和解協議」)。根據和解協議，各訂約方已同意(i)法律訴訟中的爭議；及(ii)和解協議各訂約方可能因或就賣方、Very Easy、City Link、陳及林於二零一五年就買賣愛拼集團控股510股股份而訂立的買賣協議及該買賣協議而對彼此提出的任何其他申索及申訴 (統稱「爭議」) 應獲全數解決。

In accordance with the terms of the Settlement Agreement, (i) the Vendor and the Guarantor shall pay to the Group a sum of HK\$1,500,000 at the time of signing of the Settlement Agreement in full and final settlement of the Disputes; (ii) Chan shall pay to the Group a sum of HK\$2,700,000 in full and final settlement of the Disputes, by paying (a) a sum of HK\$1,300,000 at the time of signing of the Settlement Agreement; (b) a sum of HK\$23,500 per month for 59 months starting from 1 March 2021 up to 1 January 2026; and (c) a final sum of HK\$13,500 on or before 1 February 2026; (iii) Lim shall pay to the Group a sum of HK\$1,800,000 in full and final settlement of the Disputes, by paying (a) a sum of HK\$200,000 at the time of signing of the Settlement Agreement; (b) a sum of HK\$26,500 per month for 59 months starting from 1 March 2021 up to 1 January 2026; and (c) a final sum of HK\$36,500 on or before 1 February 2026; and (iv) within 7 days of the date of the Settlement Agreement, Lucky Famous or its legal representatives shall file at the Court of First Instance of the High Court of Hong Kong a consent summons for discontinuing the Legal Action with no order as to costs. The Group shall be entitled as of right to take immediate legal action, including commencing bankruptcy proceedings without further notice if Chan and/or Lim fail(s) to make full and timely payment of any of the instalment(s) under (ii) and (iii) above.

Details of the Settlement Agreement are set out in the announcement of the Company dated 1 February 2021.

On 16 February 2021, the High Court of Hong Kong granted an order by consent that, amongst others, Lucky Famous do have leave to discontinue the Legal Action against the Vendor, the Guarantor, Chan and Lim.

Without prejudice to any right against the Vendor and the Guarantor under the SP Agreement, the AP Receivable was HK\$20,400,000 as at 31 December 2020. Based on the valuation performed by an independent professional valuer using the probability-weighted method, the Group had recognised an expected credit loss allowance on the AP Receivable of approximately HK\$1,246,000 and approximately HK\$12,200,000 for the years ended 31 December 2019 and 2018, respectively. By reference to the status of the AP Acquisition Litigation, additional lifetime expected credit loss allowance on the AP Receivable of approximately HK\$3,954,000 was further provided for the Year.

根據和解協議的條款，(i)賣方及擔保人須於簽署和解協議時向本集團悉數支付1,500,000港元以全面及最終解決爭議；(ii)陳須向本集團悉數支付2,700,000港元，通過(a)於簽署和解協議時支付1,300,000港元；(b)自二零二一年三月一日起至二零二六年一月一日止59個月每月支付23,500港元；及(c)於二零二六年二月一日或之前支付最後一筆款項13,500港元，以全面及最終解決爭議；(iii)林須向本集團悉數支付1,800,000港元，通過(a)於簽署和解協議時支付200,000港元；(b)自二零二一年三月一日起至二零二六年一月一日止59個月每月支付26,500港元；及(c)於二零二六年二月一日或之前支付最後一筆款項36,500港元，以全面及最終解決爭議；及(iv)和解協議日期後7日內，Lucky Famous或其法定代表須向香港高等法院原訟法庭遞交一份終止法律訴訟之同意傳票，當中不就訟費頒發命令。倘陳及／或林未能根據上述第(ii)及第(iii)項及時全額支付任何分期付款，則本集團有權立即採取法律行動（包括展開破產程序）而毋須另行通知。

有關和解協議的詳情載於本公司日期為二零二一年二月一日之公告內。

香港高等法院於二零二一年二月十六日頒佈一項命令（其中包括），Lucky Famous獲准終止對賣方、擔保人、陳及林之法律訴訟。

在不影響賣方及擔保人於買賣協議項下任何權利的前提下，愛拼應收款項於二零二零年十二月三十一日為20,400,000港元。根據一名獨立專業估值師採用概率加權法進行的估值，於截至二零一九年及二零一八年十二月三十一日止年度，本集團已就愛拼應收款項分別確認預期信貸虧損撥備約1,246,000港元及約12,200,000港元。經參考愛拼收購訴訟的現狀後，於本年度進一步計提愛拼應收款項之額外整個存續期的預期信貸虧損撥備約3,954,000港元。

TREASURY POLICY

The Group adopts a conservative treasury policy. Treasury activities are centralised and the Group normally invests in portfolios comprising diverse products. It has guidelines in place to monitor and control investment risk exposure and to manage capital. The Board closely reviews the Group's liquidity position to ensure the Group has a liquidity structure, with assets, liabilities and other commitments, adequate for meeting its funding requirements at all times.

UPDATE ON MATERIAL ASSET IMPAIRMENT

For the six months ended 30 June 2020, the Board noted that the financial performance of Wafer HK, one of the CGUs of the Corporate Management Solutions and I.T. Contract Service Business, did not pick up as expected and has further declined. In view of the decrease in revenue of Wafer HK of approximately HK\$9,827,000 for the six months ended 30 June 2020 as compared to that of approximately HK\$21,328,000 for the corresponding period in 2019, the Board considered that this was an indicator of potential impairment on the carrying amount of the goodwill of Wafer HK. Accordingly, the Company appointed Ascent Partners Valuation Service Limited as independent valuer in assisting in the valuation of the CGU in relation to Wafer HK as at 30 June 2020.

During the six months ended 30 June 2020, the Group recorded the Impairment Loss on Goodwill of approximately HK\$11,300,000 in relation to Wafer HK. For the six months ended 31 December 2020, no further impairment loss on goodwill in relation to Wafer HK was recognised by the Group. The Impairment Loss on Goodwill, which was non-cash in nature, did not affect the Group's working capital condition for the Year.

本集團就庫務政策採取穩健方針。庫務活動較為集中且本集團傾向投資多元化產品組合。本集團訂有監察及管控投資風險及資本管理之指引。董事會密切檢討本集團的流動資金狀況，以確保本集團之資產、負債及其他承擔之流動資金架構在所有時間均能應付其資金需求。

有關重大資產減值的更新資料

截至二零二零年六月三十日止六個月，董事會注意到威發香港（企業管理解決方案及資訊科技合約服務業務的其中一個現金產出單位）的財務表現並無如預期般復甦並進一步下跌。鑒於截至二零二零年六月三十日止六個月威發香港的收益較二零一九年同期約21,328,000港元減少約9,827,000港元，董事會認為這可能是威發香港之商譽賬面值出現潛在減值之跡象。因此，本公司已委任艾升評估諮詢有限公司作為獨立估值師，以協助就二零二零年六月三十日之威發香港現金產出單位進行估值。

截至二零二零年六月三十日止六個月，本集團就威發香港錄得商譽減值虧損約11,300,000港元。截至二零二零年十二月三十一日止六個月，本集團並無就威發香港確認進一步商譽減值虧損。商譽減值虧損為非現金性質，並不影響本集團於本年度之營運資金狀況。

Impairment on goodwill

In accordance with Hong Kong Accounting Standard 36, an impairment loss shall be recognised for the CGU if the recoverable amount of the CGU is less than the carrying amount of the CGU. The Company appointed Ascent Partners Valuation Service Limited as independent professional valuer in assisting in the valuation of the CGU in relation to Wafer HK as at 30 June 2020. Wafer HK was one of the operating units of the Group carrying on the Corporate Management Solutions and I.T. Contract Service Business.

Calculation of impairment loss

As at 30 June 2020, the carrying amount of Wafer HK's CGU before impairment was approximately HK\$22,904,000 (31 December 2019: approximately HK\$22,929,000) which comprised (i) goodwill of approximately HK\$20,659,000 (31 December 2019: approximately HK\$20,913,000); and (ii) net operating assets of approximately HK\$2,245,000 (31 December 2019: approximately HK\$2,016,000) of Wafer HK.

With reference to the assessment by Ascent Partners Valuation Service Limited, the recoverable amount of Wafer HK as at 30 June 2020 on a fair value less costs of disposal ("FVLCD") basis was higher than that on a value in use ("VIU") basis. The recoverable amount of Wafer HK's CGU has been determined based on FVLCD (31 December 2019: FVLCD) in accordance with Hong Kong Accounting Standard 36. As at 30 June 2020, the recoverable amount of Wafer HK attributable to the Group was approximately HK\$11,635,000 (31 December 2019: approximately HK\$22,675,000) which was lower than its carrying amount attributable to the Group by approximately HK\$11,269,000, as a result of the uncertain market conditions such as the outbreak of the COVID-19 pandemic and fierce competition in the market. The carrying amount of the CGU has been reduced to its recoverable amount and the Group recognised the Impairment Loss on Goodwill in respect of Wafer HK of approximately HK\$11,300,000 (31 December 2019: HK\$254,000) for the six months ended 30 June 2020.

商譽減值

根據香港會計準則第36號，倘現金產出單位之可收回金額少於現金產出單位之賬面值，則須就現金產出單位確認減值虧損。本公司已委任艾升評估諮詢有限公司作為獨立專業估值師，以協助就威發香港現金產出單位於二零二零年六月三十日之估值。威發香港為本集團執行企業管理解決方案及資訊科技合約服務業務的經營單位之一。

計算減值虧損

於二零二零年六月三十日，威發香港現金產出單位扣除減值前之賬面值約為22,904,000港元（二零一九年十二月三十一日：約22,929,000港元），當中包括威發香港之(i)商譽約20,659,000港元（二零一九年十二月三十一日：約20,913,000港元）；及(ii)營運資產淨值約2,245,000港元（二零一九年十二月三十一日：約2,016,000港元）。

經參考艾升評估諮詢有限公司作出的評估後，按公平價值減銷售成本（「公平價值減銷售成本」）基準計算的於二零二零年六月三十日之威發香港的可收回金額高於按使用價值（「使用價值」）基準計算者。威發香港現金產出單位的可收回金額乃根據香港會計準則第36號按公平價值減銷售成本（二零一九年十二月三十一日：公平價值減銷售成本）釐定。於二零二零年六月三十日，本集團應佔威發香港的可收回金額約為11,635,000港元（二零一九年十二月三十一日：約22,675,000港元），較本集團應佔其賬面值低約11,269,000港元，乃由於市況不穩定（例如COVID-19疫情）及市場競爭激烈所致。於截至二零二零年六月三十日止六個月，現金產出單位的賬面值已減至其可收回金額及本集團已確認威發香港之商譽減值虧損約11,300,000港元（二零一九年十二月三十一日：254,000港元）。

Key basis and assumptions

In determining the FVLCD of Wafer HK, the independent professional valuer has adopted market approach. The FVLCD of the CGU was appraised through guideline public company method under market approach. Since there were public companies operating similar business, their market value captures current market expectations of the corresponding industry thus were good indicators.

Price-to-Sales and Enterprise Value (EV)-to-Sales multiples were considered in this valuation. The Price-to-Sales ratio establishes a relationship between the value of a corporation's stock and its annual revenue. Since Wafer HK had recorded loss, Price-to-Earnings multiple was not applicable. EV-to-Sales is an expansion of the Price-to-Sales multiple which considers debt and cash that a company owns.

There were no significant changes in the basis adopted in the preparation of this valuation as compared with the valuation as at 31 December 2019, except for the selection of comparable companies. Comparable companies were searched in Hong Kong listed companies that principally provide corporate I.T. and system integration services. To more accurately reflect the situation of Wafer HK, these companies with net loss/minimal profit in the latest fiscal year were selected. Several companies with business scopes and operations similar to those of Wafer HK were adopted as comparable companies. The comparable companies were selected mainly with reference to the following selection criteria:

- (i) the comparable companies selected are principally engaged in Corporate Management Solutions and I.T. Contract Services Business in Hong Kong;
- (ii) the companies have sufficient listing and operating history;
- (iii) the financial information of the companies is available to the public; and
- (iv) the share price of the comparable companies is available on the Stock Exchange.

Compared with the valuation on Wafer HK as at 31 December 2019, one comparable company has been replaced due to the change in its major revenue segment.

主要基準及假設

在釐定威發香港的公平價值減銷售成本時，獨立專業估值師已採用市場法。現金產出單位的公平價值減銷售成本乃按市場法項下的公開公司標準法進行評估。由於存在經營業務相似的上市公司，彼等市值反映相應行業的當前市場預期，因而屬良好的指標。

是次估值考慮市銷率倍數及企業價值與營收比率倍數。市銷率反映一間公司的股票價值與其年度收入的關係。由於威發香港錄得虧損，市盈率倍數並不適用。企業價值與營收比率為市銷率倍數的擴展，當中考慮一間公司擁有的債務及現金。

除選擇可比公司外，與二零一九年十二月三十一日的估值相比，編製是次估值所採用的基準並無重大變動。我們於主要提供企業資訊科技及系統集成服務的香港上市公司間搜尋可比公司。為更精準地反映威發香港的情況，我們選取了最新財政年度錄得淨虧損／最少利潤的公司。業務範圍及營運與威發香港類似的數間公司已被採納為可比公司。可比公司乃主要參考以下挑選標準進行挑選：

- (i) 被選出的可比公司主要於香港從事企業管理解決方案及資訊科技合約服務業務；
- (ii) 該等公司擁有足夠的上市及經營歷史；
- (iii) 該等公司的財務資料可供公眾查閱；及
- (iv) 可比公司的股價可於聯交所上查閱。

與二零一九年十二月三十一日威發香港的估值相比，一間可比公司因其主要收入分部變更已被替換。

The average of the valuation multiples of the comparable companies is then applied to the Trailing Twelve Months (TTM) sales of Wafer HK as at the valuation date (i.e. 30 June 2020 and 31 December 2019) to derive the value of its 100% equity interest value and enterprise value respectively. The equity interest value was then derived from enterprise value by adjusting the operating debt, non-operating assets and liabilities, and cash and cash equivalents of Wafer HK. As Wafer HK is a private company, a discount for lack of marketability (DLOM) is applied. A DLOM of 15.80% was adopted as reference to "2018 Stout Restricted Stock Study Companion Guide" published by Stout Risius Ross, LLC.. In addition, as reference to "Value of Corporate Control: Some International Evidence" by Paul Hanouna, Atulya Sarin, and Alan C. Shapiro, a control premium of 25.00% was adopted to account for the control interest on Wafer HK.

The calculation of the FVLCD of Wafer HK based on the valuation multiples is tabulated as follows:

By taking the average of the above calculated values based on the Price-to-Sales and EV-to-Sales multiples, the FVLCD of Wafer HK was calculated as HK\$11,635,000, which was lower than its carrying amount attributable to the Group by approximately HK\$11,269,000, and the Group recognised the Impairment Loss on Goodwill in respect of Wafer HK of approximately HK\$11,300,000 for the six months ended 30 June 2020.

As at 31 December 2020, the FVLCD of Wafer HK was higher than the carrying amount of its CGU by approximately HK\$1,109,000. Therefore, no further impairment loss was recorded for the six months ended 31 December 2020. Details of the impairment test for the CGU containing goodwill are disclosed in note 22 to the consolidated financial statements contained in this report.

The Group did not have any material acquisition or disposal during the Year.

Employees and remuneration policies

As at 31 December 2020, the Group had 35 employees (31 December 2019: 62 employees). During the Year, the total staff costs of the Group (including Directors’ emoluments and provident funds) were approximately HK\$28,848,000 (2019: approximately HK\$27,471,000). The Group’s remuneration policy emphasises equality, motivation and performance of the employees in order to strengthen its competitiveness in the market and comply with statutory requirements of Hong Kong. Remuneration packages are generally reviewed annually. Apart from salary payments, other staff benefits include provident fund contributions, medical insurance coverage and performance-related bonuses. The Group also has a share option scheme in place to reward and motivate employees. Details of the share option scheme of the Company are set out in the section headed “Other Information—Share Option Scheme” in this report.

Contingent liabilities

As at 31 December 2020, the Group did not have any significant contingent liabilities (31 December 2019: Nil).

The Company is committed to maintaining corporate governance of high standard and quality procedures. The Company has put in place governance practices with emphasis on the integrity to the Shareholders and quality of disclosure, transparency and accountability to the Shareholders for the sake of maximising returns to the Shareholders. The Directors acknowledge in the Corporate Governance Report their responsibility for preparing the financial statements.

Throughout the Year, the Board has reviewed the Group's corporate governance practices and is satisfied that the Company has complied with the Code Provisions under the Corporate Governance Code set out in Appendix 15 to the GEM Listing Rules (the "CG Code").

BOARD OF DIRECTORS

Composition

During the Year and as at 31 December 2020, the Board comprised five members, two executive Directors, namely Mr. Wong Jing Shong (Chairman of the Board) and Mr. Zhang Long (former chief executive officer of the Company ("Chief Executive Officer")) and three independent non-executive Directors, namely Mr. Chan Yung, Mr. Cheng Hong Kei and Professor Chui Tsan Kit. Independent non-executive Directors are invited to serve on the audit committee (the "Audit Committee"), the remuneration committee (the "Remuneration Committee") and the nomination committee (the "Nomination Committee") of the Board. On 8 February 2021, Mr. Zhang Long resigned as an executive Director and the Chief Executive Officer. Mr. Lau Siu Cheong was appointed as an executive Director and the Chief Executive Officer with effect from 8 February 2021.

The composition of the Board reflects the balance of skills and experience appropriate for the requirements of the Group's business and for the exercise of independent decisions. The Company has three independent non-executive Directors representing more than half of the Board. They are professionals in different areas and provide independent opinions based on their expertise.

Mr. Wong Jing Shong, the Chairman of the Board and an executive Director, is a director of CONCORD and a number of subsidiaries of CONCORD (as defined below), namely, EPRO HK (as defined below), EPRO Systems (China) Limited, EPRO Technology Limited and EPRO Limited, and the chief executive officer of EPRO HK. He is also interested in 49% interests in CONCORD. Mr. Zhang Long, the former executive Director and the former Chief Executive Officer, is also a director of the above-mentioned subsidiaries of CONCORD. Further details in relation to the directorship of Mr. Wong Jing Shong and Mr. Zhang Long in the said companies are disclosed in the section headed "Biographical Details of Directors and Senior Management" and in the sub-section headed "Competing Interest" in the section headed "Report of the Directors" in this report. Save as disclosed above, there is no relationship among members of the Board (including financial, business, family or other material/relevant relationship). The biographies of the Directors are set out in the section headed "Biographical Details of Directors and Senior Management" in this report.

董事會的組成反映切合本集團業務所需及作出獨立決定的技巧和經驗之平衡。本公司共有三名獨立非執行董事，多於董事會人數的一半。彼等為不同領域的專業人士，依據其各自的專業知識提供獨立意見。

BOARD PRACTICES AND CONDUCT OF MEETINGS

Formal notice of at least 14 days will be given in respect of a regular meeting. For special Board meeting, reasonable notice will be given. The Directors participated, either in person or through other electronic means of communication, in the Board meetings.

The Directors meet regularly at least 4 times a year and participate in person or through other means of communication. All notices of Board meetings were given to all Directors, who were given an opportunity to include matters in the agenda for discussion. All Directors are kept informed on a timely basis of major changes that may affect the Group's businesses, including relevant rules and regulations. The Directors can also seek independent professional advice in performing their duties at the Company's expense, if necessary. Minutes of each Board meeting are kept by the company secretary of the Company (the "Company Secretary") and are open for inspection at any reasonable time on request by any Director.

Directors' insurance

The Company has arranged appropriate insurance cover in respect of the legal action against the Directors.

Responsibilities, accountabilities and contributions of the Board and management

The Board should assume responsibility for leadership and control of the Company and is collectively responsible for promoting the success of the Company by directing and supervising its affairs. All Directors should make decisions objectively in the interests of the Company.

The Board reserves for its decision on all major matters relating to policy, strategies and budgets, internal control and risk management, material transactions (in particular those that may involve conflict of interests), financial information, appointment of Directors and other significant operational matters of the Company. Responsibilities relating to implementing decisions of the Board, directing and coordinating the daily operation and management of the Company are delegated to the management.

Independent Non-executive Directors

During the Year, the Board complied at all times with the requirements of the GEM Listing Rules that at least three independent non-executive Directors sit in the Board (more than one-third of the Board members) and at least one of them has appropriate professional qualifications or accounting or related financial management expertise.

The Company has received written annual confirmation from each of the existing independent non-executive Directors in respect of his independence in accordance with the independence guidelines set out in the GEM Listing Rules. As at the date of this report, the Company in its best knowledge considers all independent non-executive Directors are independent.

Appointment and re-election of Directors

The Company has established formal, considered and transparent procedures for the appointment of new Directors.

The procedures and process of appointment, re-election and removal of Directors are laid down in the Company's Bye-laws. According to the Company's Bye-laws, any Director appointed by the Board to fill a casual vacancy should be subject to re-election by the Shareholders at the first general meeting after appointment, and any Director appointed by the Board as an addition to the Board shall be subject to re-election by the Shareholders at the next following annual general meeting after appointment. Other relevant provision in the Bye-law states that one-third of the Directors for the time being, or, if their number is not a multiple of three, then the number nearest to but not less than one-third, shall retire from office by rotation at every annual general meeting. A retiring Director shall be eligible for re-election. The Directors to retire by rotation shall include (so far as necessary to ascertain the number of Directors to retire by rotation) any Director who wishes to retire and not to offer himself for re-election. Any further Directors so to retire shall be those of the other Directors subject to retirement by rotation who have been longest in office since their last re-election or appointment. All Directors should retire by rotation at least once every three years.

Under the Code Provision A.4.1 of the CG Code, non-executive Directors should be appointed for a specific term and subject to re-election. The independent non-executive Directors were appointed for a specific term: Professor Chui Tsan Kit was re-appointed for a term of 3 years commencing on 23 April 2020 whereas, Mr. Chan Yung and Mr. Cheng Hong Kei were appointed for a term of 3 years both commencing on 24 November 2020. All of them are subject to retirement by rotation once every three years.

董事委任及重選

本公司已制定正式、經審慎考慮及具透明度的新董事委任程序。

本公司的公司細則載有董事委任、重選及罷免程序及過程。根據本公司的公司細則，任何獲董事會委任以填補臨時空缺的董事須於彼獲委任後首屆股東大會接受股東重選，而任何獲董事會委任以增加現有董事會人數的董事須於彼獲委任後下屆股東週年大會接受股東重選。其他相關公司細則訂明於每屆股東週年大會上當時三分一的董事（或倘董事人數並非三的倍數，則為最接近但不少於三分之一）須輪值退任。退任董事符合資格膺選連任。輪值退任之董事應包括（確定輪席退任董事的數目為必需）願意退任且不再膺選連任的任何董事。此外退任的任何其他董事應為自上次連任或委任起計任期最長而須輪值退任的其他董事。所有董事應至少每三年輪值退任一次。

根據企業管治守則守則條文第A.4.1條，非執行董事應有指定任期，並須予以重選。獨立非執行董事有指定任期：徐燦傑教授重獲委任的任期由二零二零年四月二十三日起計為期三年，而陳勇先生及鄭康棋先生的任期為由二零二零年十一月二十四日起計為期三年。彼等均應每三年輪值退任一次。

At the forthcoming annual general meeting of the Company, Mr. Wong Jing Shong, Mr. Lau Siu Cheong and Mr. Chan Yung shall retire and each of them, being eligible, will offer himself for re-election pursuant to the Company's Bye-laws as stated in the foregoing paragraph. The Board and the Nomination Committee recommended their re-appointment. The Company's circular, to be sent to the Shareholders, contains detailed information of the Directors who will offer themselves for re-election at the forthcoming annual general meeting of the Company as required by the GEM Listing Rules.

Continuous professional development of Directors

Directors keep abreast of responsibilities as a Director and of the conduct, business activities and development of the Company. Every newly appointed Director will receive formal, comprehensive and tailored induction on the first occasion of his appointment to ensure appropriate understanding of the business and operations of the Company and full awareness of the Director's responsibilities and obligations under the GEM Listing Rules and relevant statutory requirements.

Besides, the Directors should participate in appropriate continuous professional development to develop and refresh their knowledge and skills to ensure that their contribution to the Board remains informed and relevant. Internally facilitated briefings for the Directors will be arranged and reading materials on relevant topics will be issued to the Directors where appropriate. All Directors are encouraged to attend relevant training courses at the Company's expenses.

According to the records maintained by the Company, the current and former Directors received the following training with an emphasis on the roles, functions and duties of a Director of a listed company in compliance with the CG Code on continuous professional development during the Year.

The Directors acknowledge their responsibility for the preparation of the annual report and financial statements of the Company for the Year to ensure that these financial statements give a true and fair presentation in accordance with Hong Kong Companies Ordinance (Chapter 622 of the Laws of Hong Kong) ("Companies Ordinance") and the applicable accounting standards. The Directors are not aware of any material uncertainties relating to events or conditions that may cast significant doubt on the Company's ability to continue as a going concern.

Accounting policies

The Directors consider that in preparing the financial statements, the Group applies appropriate accounting policies that are consistently adopted and makes judgments and estimates that are reasonable and prudent in accordance with the applicable accounting standards.

Accounting records

The Directors are responsible for ensuring that the Group keeps accounting records which disclose the financial positions of the Group upon which financial statements of the Group could be prepared in accordance with the Group's accounting policies.

Safeguarding assets

The Directors are responsible for taking all reasonable and necessary steps to safeguard the assets of the Group and to prevent and detect fraud and other irregularities within the Group.

AUDITOR'S REMUNERATION

During the Year, auditor's remuneration for audit services was approximately HK\$1,000,000 (2019: approximately HK\$1,380,000) and non-audit services (including but not limited to professional advice on financial activities and taxation) was approximately HK\$486,000 (2019: approximately HK\$526,000).

RISK MANAGEMENT AND INTERNAL CONTROL

Goals and Objectives

The Board is responsible for formulating the Group's risk management and internal control systems and reviewing their effectiveness on an ongoing basis. Such systems are designed to manage rather than eliminate the risk of failure to achieve business objectives, and can only provide reasonable and not absolute assurance against material misstatement or loss.

Main features of the risk management and internal control systems

The Group's risk governance structure and the main responsibilities of each level of the structure are summarised below:

Board

- evaluates and determines the nature and extent of the risks it is willing to take in achieving the Group's strategic objectives, and ensures the implementation of an effective risk management and internal control systems; and
- oversees the management in the design, implementation and monitoring of the risk management and internal control systems.

Management

- designs, implements and monitors the risk management and internal control systems;
- identifies and assesses the risks which threaten the achievement of the strategic objectives;
- reviews the risk areas and risk level;
- advises on matters raised by employees and the Company;
- coordinates and promotes risk management by ensuring that risk and activities processes are operated efficiently and effectively and in compliance with the GEM Listing Rules; and
- reports periodically to the Board.

Process Used to Identify, Evaluate and Manage Significant Risks

The Group's risk assessment processes are summarised as follows:

Risk Identification

- Identifies the risks through discussion with the management and directors of subsidiaries of the Company. Risk identification and management questionnaire are used to document the risks identified by the management and directors of subsidiaries of the Company.

Risk Assessment

- Determines the existing controls and analyses risks in terms of consequence and likelihood in the context of those controls. The analysis considers the range of potential consequences and how likely those consequences are to occur. Consequences and likelihood are combined to produce an estimated level of risk.

Risk Response

- Categorises the risks into low risk, medium risk and high risk;
- Determines the strategy to handle the risk; and
- Develops the risk register and internal control audit plan and determines the frequency of review and control testing on key controls.

Risk Monitoring and Reporting

- on-going communication of monitoring results to the Board which enables it to assess control of the Group and the effectiveness of risk management during the Year, including:
 - risk questionnaires completed by the management, risk register and internal control audit plan; and
 - fact finding report with recommendations on the review and testing of internal controls on certain operating cycles and areas.

Internal Audit Function

The Group's internal audit function is performed by the management of the Company, including analysing and appraising the adequacy and effectiveness of the Group's risk management and internal control systems. For the enhancement of the quality of the internal audit, the Company has engaged an external consultant to execute a significant scope of internal audit function to:

- perform the risk assessment based on management evaluation on identified area and report the findings and recommendations to the management; and
- conduct various agreed-upon-procedures reviews on material controls and perform testing of internal controls on certain operating cycles and areas in accordance with the Company's internal control audit plan.

During the Year, the Board, as assisted by the Audit Committee, reviewed the Company's risk management and internal control systems for the Year, which cover all material controls, including financial, operational and compliance controls, the adequacy of resources, staff qualifications and experience, training programmes and budget of the Group's accounting, internal audit and financial reporting functions, and assessed the effectiveness of the risk management and internal control systems of the Group by reviewing the work and findings of the internal audit function. Such review is conducted annually. Both the Audit Committee and the Board considered that the systems were effective and adequate for the Year.

DIVIDEND POLICY

Under the dividend policy adopted by the Company with effect from 1 January 2019, dividends may be declared and paid to the Shareholders by way of cash or by other means that the Board considers appropriate. It is the policy of the Board, in recommending dividends, to allow the Shareholders to participate in the Company's profits, and at the same time, to ensure the Company to retain adequate reserves for future growth. The Company's decision to declare or to pay any dividends in the future, and the amount of such dividends will depend upon, among other things, the current and future operations, financial condition, liquidity position and capital requirements of the Group, as well as dividends received from the Company's subsidiaries and associates, which in turn will depend on the ability of those subsidiaries and associates to pay a dividend. In addition, any final dividends for a financial year will be subject to the approval of the Shareholders. The declaration and payment of dividends by the Company is also subject to any restrictions under the laws of Bermuda, the laws of Hong Kong, the Company's Bye-laws and any applicable laws, rules and regulations. The Board will continue to review the dividend policy from time to time and the Board may exercise its sole and absolute discretion to update, amend and/or modify the dividend policy at any time as it deems fit and necessary.

內部審核職能

本集團的內部審核職能由本公司管理層履行，包括分析及評估本集團風險管理及內部監控系統是否充足且具成效。為提高內部審核質量，本公司已委聘外部顧問實施大範圍的內部審核職能以：

- 根據管理層對已識別範圍進行風險評估並向管理層匯報發現及推薦建議；及
- 對重大監控進行各項協定程序檢討，並根據本公司的內部監控審核計劃對若干營運週期及範圍進行內部監控測試。

於本年度，在審核委員會的協助下，董事會已檢討本公司於本年度的風險管理及內部監控系統，其涵蓋所有重大監控（包括財務、營運及合規監控）、資源充足性、員工資格及經驗、培訓計劃及本集團的會計預算、內部審核及財務報告職能，並審閱內部審核職能的工作及發現，藉此評估本集團的風險管理及內部監控系統的成效。有關檢討乃每年進行。審核委員會及董事會均認為，於本年度，該等系統乃有效且充足。

股息政策

根據本公司自二零一九年一月一日起採納的股息政策，股息可以現金方式或董事會認為適當的其他方式宣派及派付予股東。董事會於推薦派付股息方面的政策乃為允許股東分享本公司溢利，並同時確保本公司留存充足儲備作未來發展。本公司宣派或派付任何未來股息的決定及有關股息的數額將取決於（其中包括）本集團的現時及未來營運業務、財務狀況、流動資金狀況及資本需求，以及收取自本公司附屬公司及聯營公司的股息（這將取決於該等附屬公司及聯營公司派付股息的能力）。此外，財政年度的任何末期股息將須遵守股東批准規定。本公司的股息宣派及派付亦須受百慕達法例、香港法律、本公司的公司細則及任何適用法律、規則及法規項下的任何限制規限。董事會將繼續不時審閱股息政策，且董事會可行使其全權絕對酌情權於其認為適當且必須的任何時間更新、修訂及／或修改股息政策。

INFORMATION DISCLOSURE POLICY

The Company has adopted its information disclosure policy and related procedures with regard to the “Guidelines on Disclosure of Inside Information” issued by the Securities and Futures Commission. The policy stipulates the responsibilities of the Group, key disclosure requirements under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong) (“SFO”) and Rules 17.10, 17.11 and 17.11A of the GEM Listing Rules, control measures and reporting procedures of handling confidential information and monitoring information disclosure. The Group adopts an upward reporting approach within the Group for identifying and escalating any potential inside information to the Board. The policy is reviewed annually and all reasonable measures have to be taken from time to time to ensure proper safeguards to prevent any breach of disclosure requirements and to maintain strict confidentiality of information.

BOARD COMMITTEES/FUNCTIONS

The Board has established three committees, namely, the Remuneration Committee, the Audit Committee and the Nomination Committee, for overseeing particular aspects of the Company’s affairs. All Board committees of the Company are established with defined written terms of reference. The terms of reference of the Board committees are posted on the Company’s website and the Stock Exchange’s website. Copies of minutes of all meetings and resolutions of the committees, which are kept by the Company Secretary, are circulated to all Board members and the committees are required to report back to the Board on their decision and recommendations where appropriate.

For any person that is nominated by a shareholder for election as a director at the general meeting of the Company, the Nomination Committee and/or the Board shall evaluate such candidate based on the criteria as set out above to determine whether such candidate is qualified for directorship and where appropriate, the Nomination Committee and/or the Board shall make recommendation to shareholders in respect of the proposed election of director at the general meeting.

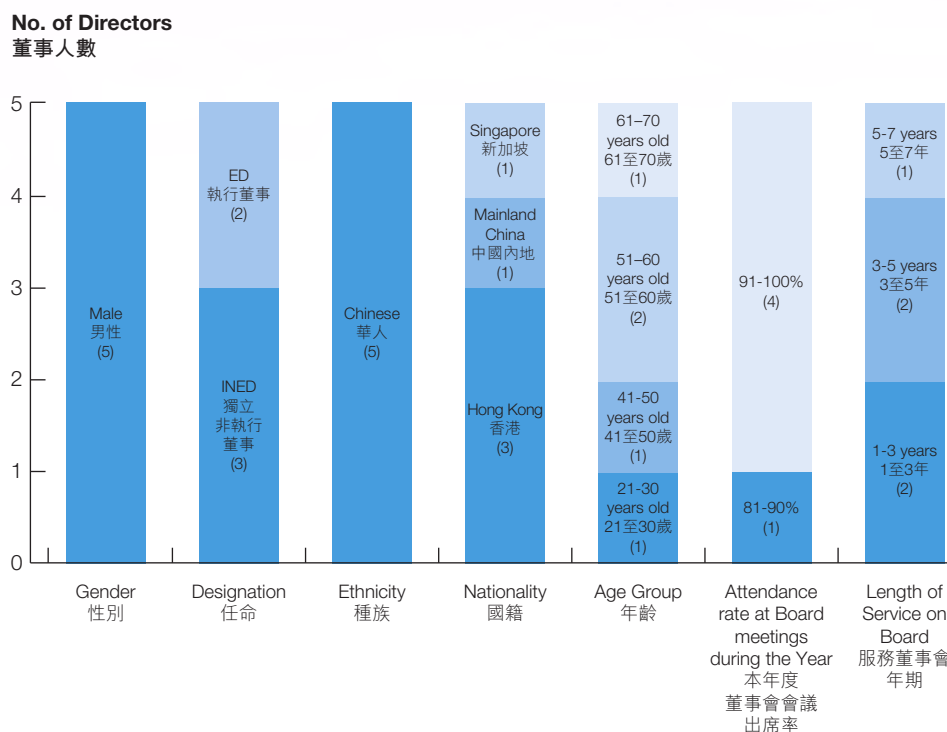

SHAREHOLDERS' RIGHTS

To safeguard the Shareholders' interests and rights, a separate resolution is proposed for each substantially separate issue at the Shareholders' meetings, including the election of individual Directors. According to the GEM Listing Rules, all resolutions put forward at the Shareholders' meetings will be voted on by poll and poll results will be posted on the websites of the Stock Exchange and the Company after each Shareholders' meeting.

Set out below are the procedures for members to make proposals at general meeting other than a proposal of a person for election as the Directors.

Procedures for members to make proposals at general meeting other than a proposal of a person for election as Director

The following procedures are subject to the Company's Bye-laws, the Bermuda Companies Act 1981 and applicable legislation and regulations.

1. The Company holds an annual general meeting every year, and may hold a general meeting known as a special general meeting whenever necessary.
2. Member(s) of the Company holding (i) not less than one-twentieth of the total voting rights of all members having the right to vote at the general meeting; or (ii) not less than 100 members, can submit a written request stating the resolution intended to be moved at the annual general meeting; or a statement of not more than 1,000 words with respect to the matter referred to in any proposed resolution or the business to be dealt with at a particular general meeting.
3. The written request/statements must be signed by the member(s) concerned and deposited at the Company's registered office at Clarendon House, 2 Church Street, Hamilton HM11, Bermuda and its head office and principal place of business in Hong Kong (subject to change from time to time), for the attention of the Company Secretary, not less than six weeks before the annual general meeting in the case of a requisition requiring notice of a resolution and not less than one week before the general meeting in the case of any other requisition.

If the written request is in order, the Company Secretary will ask the Board (i) to include the resolution in the agenda for the annual general meeting; or (ii) to circulate the statement for the general meeting, provided that the member(s) concerned have deposited a sum of money reasonably determined by the Board sufficient to meet the Company's expenses in serving the notice of the resolution and/or circulating the statement submitted by the member(s) concerned in accordance with the statutory requirements to all the registered members. On the contrary, if the requisition is invalid or the member(s) concerned have failed to deposit sufficient money to meet the Company's expenses for the said purposes, the member(s) concerned will be advised of this outcome and accordingly, the proposed resolution will not be included in the agenda for the annual general meeting; or the statement will not be circulated for the general meeting.

The following are the procedures for the Shareholders to propose a person for election as a Director.

Procedures for Shareholders to propose a person for election as a Director

The following procedures are subject to the Company's Bye-laws, the Bermuda Companies Act 1981 and applicable legislation and regulations.

If a member, who is duly qualified to attend and vote at the general meeting convened to deal with appointment/election of Director(s), wishes to propose a person (other than the member himself/herself) for election as a Director at that meeting, he/she can deposit a written notice at the Company's head office and principal place of business in Hong Kong (subject to change from time to time), for the attention of the Company Secretary.

In order for the Company to inform all members of that proposal, the written notice must state the full name of the person to be proposed for election as a Director, his/her biographical details as required by Rule 17.50(2) of the GEM Listing Rules, and be signed by the member concerned and that person indicating his/her willingness to be elected.

The period for lodgment of such a written notice will commence on the day after the despatch of the notice of the general meeting and end no later than seven (7) days prior to the date of such general meeting. If the notice is received less than fifteen (15) business days prior to that general meeting, the Company will need to consider adjournment of the general meeting in order to (i) assess the suitability of the proposed candidate; and (ii) publish an announcement or circulate a supplementary circular in relation to the proposal to the members at least fourteen (14) clear days and not less than ten (10) business days prior to the general meeting.

Detailed procedures for the Shareholders to propose a person for election as a Director are available on the Company's website at www.geth.com.hk.

Procedures for Shareholders to convene a special general meeting

The following procedures are subject to the Company's Bye-laws, the Bermuda Companies Act 1981 and applicable legislation and regulations.

Shareholders holding at the date of deposit of the requisition not less than one-tenth of the paid up capital of the Company carrying the right of voting at general meetings of the Company shall at all times have the right, by written requisition sent to the Company's registered office at Clarendon House, 2 Church Street, Hamilton HM11, Bermuda and its head office and principal place of business in Hong Kong (subject to change from time to time), for the attention of the Company Secretary, to require a special general meeting to be called by the Board for the transaction of any business specified in such requisition; and such meeting shall be held within two (2) months after the deposit of such requisition. If the Board does not within twenty-one (21) days from the date of the deposit of the requisition proceed duly to convene a meeting, the requisitionists, or any of them representing more than one half of the total voting rights of all of them, may themselves convene a meeting, but any meeting so convened shall not be held after the expiration of three months from the said date.

Procedures for sending enquiries to the Board

For putting forward any enquiries to the Board, the Shareholders may send written enquiries to the Board of Directors/Company Secretary at the Company's principal place of business in Hong Kong. For the avoidance of doubt, the Shareholder(s) must deposit and send the original duly signed written requisition, notice or statement, or enquiry (as the case may be) to the Company's principal place of business in Hong Kong and provide their full name, contact details and identification in order to give effect thereto. The Shareholders' information may be disclosed as required by law.

The Group recognises the importance of maintaining environmental sustainability in its daily operations and acts in all material respects in compliance with the laws and regulations relating to environmental protection and pollutant control, such as the Water Pollution Control Ordinance (Chapter 358 of the Laws of Hong Kong), the Air Pollution Control Ordinance (Chapter 311 of the Laws of Hong Kong) and the Waste Disposal Ordinance (Chapter 354 of the Laws of Hong Kong). The Group is a service-oriented enterprise mainly with office operations, therefore its daily business does not generate material direct emission, industrial pollutants, sewage and hazardous waste. Nevertheless, the Group pays high attention to environmental protection in order to become a green corporation.

The Group is committed to environment protection and sustainable development through promoting and adopting green practices in its business activities. Initiatives within the Group include, but not limited to, waste reduction by double-sided printing and separating recyclable paper, green procurement by avoiding single-use disposable items and using office equipment with Energy Label issued by the Electrical and Mechanical Services Department, and energy reduction by switching off idle electronic appliances. The Group will continuously review its green practices to integrate environmental, health and safety management and compliance considerations into its operational processes. To maintain its market competitiveness within the industry, the Group aims at delivering services of constantly high standards of quality to its customers. During the Year, there was no material and significant dispute between the Group and its suppliers and/or customers.

According to the credit rating of different customers, the Group allows a credit period of up to 90 days to customers. In extending and/or granting credit terms to customers, the Group will carefully assess creditworthiness and financial standing of each individual customer. Management will also closely monitor all outstanding debts and review their collectability periodically.

COMPLIANCE WITH RELEVANT LAWS AND REGULATIONS

Data privacy has become a critical issue for online sales business in the world. In relation to the Software Business and the B2C Online Sales Platform and B2B Product Trading Business, the Group has paid close attention to confidentiality of personal data and privacy of its customers. Under the daily operation of the Software Business and the B2C Online Sales Platform and B2B Product Trading Business, it is inevitable to deal with enormous amount of customers’ and potential customers’ information during the process of online transactions. It is of significant importance for the Group to handle their data with care so as to comply with the laws and regulations relating to data privacy. Employees are required to fully abide by the provisions stipulated when handling customers’ data and they are prohibited from any unauthorised copying, dissemination or disclosure of confidential information, including customers’ identity and transaction records.

During the Year, the Company was not aware of any material non-compliance with any relevant laws and regulations that had a significant impact on the Group.

EVENT AFTER THE REPORTING PERIOD

The outbreak of the COVID-19 pandemic is impacting global economic markets. The Directors continue to monitor the situation closely and have considered the impact of COVID-19 on the Group's business and financial performance. CONCORD is a subsidiary of Hang Tai Yue Group Holdings Limited (恆泰裕集團控股有限公司) (“Hang Tai Yue Group”) (stock code: 8081), a company listed on GEM of the Stock Exchange. Mr. Wong has been further employed as (i) the chief executive officer of the CONCORD Group; and (ii) an executive director of EPRO HK for a term of three years since May 2019. He has also been appointed as a director of CONCORD. As at 31 December 2020, CONCORD was owned as to 49% by Mr. Wong and as to 51% by Hang Tai Yue Group. The CONCORD Group is principally engaged in the provision of professional I.T. contract and maintenance services.

Mr. Zhang Long, a former executive Director and Chief Executive Officer, who resigned on 8 February 2021, has also been a director of each of EPRO HK, EPRO Systems (China) Limited, EPRO Technology Limited and EPRO Limited since 2017.

The CONCORD Subsidiaries may compete with the Corporate Management Solutions and I.T. Contract Services Business undertaken by the Group in Hong Kong and overseas.

SHARE OPTION SCHEME

A share option scheme ("Share Option Scheme") was approved by the Shareholders in the annual general meeting of the Company on 13 June 2017 and adopted on 15 June 2017.

The Share Option Scheme is to enable the Company to grant options to the eligible participants as incentives or rewards for their contribution to the Group and/or to enable the Group to recruit and retain high-calibre employees and attract human resources that are valuable to the Group and any entities in which any member of the Group holds equity interest.

The Directors may subject to the provisions of the Share Option Scheme and the GEM Listing Rules, invite any person belonging to any of the following classes of eligible participants, to take up share options to subscribe for Shares: (a) any eligible employee (whether full time or part time, including any executive Director but excluding any non-executive Director) of the Company, any of its subsidiaries or any entity in which any member of the Group holds any equity interest ("invested entity"); (b) any non-executive Director (including independent non-executive Directors) of the Company, any of its subsidiaries or any invested entity; and (c) any adviser (professional or otherwise) or consultant to any area of business or business development of any member of the Group or any invested entity.

The Share Option Scheme shall continue in force for a period of 10 years commencing on its adoption date. The Share Option Scheme will remain in force until 15 June 2027 and after such date no further options shall be offered but the provisions of the Share Option Scheme shall remain in full force and effect to the extent necessary to give effect to the exercise of any options granted before its expiry or termination but not yet exercised.

We have determined the "Impairment assessment of goodwill" to be the key audit matter and how our audit addressed this key audit matter is set out below:

As at 31 December 2020, the Group had goodwill with carrying value of approximately HK\$69,525,000, arising from the acquisition of Boom Max International Limited and its subsidiaries ("Boom Max Group") and Wafer Systems (Hong Kong) Limited ("Wafer HK"). Management has allocated goodwill to individual cash-generating units ("CGUs"). Goodwill is required to be tested for impairment on an annual basis.

於二零二零年十二月三十一日，貴集團因收購Boom Max International Limited及其附屬公司（「Boom Max 集團」）及威發系統（香港）有限公司（「威發香港」）產生之商譽賬面值約為69,525,000港元。管理層已將商譽分配至個別現金產出單元（「現金產出單元」）。商譽須每年進行減值測試。

The recoverable amounts of the CGUs were determined based on either fair value less cost of disposal or value in use models which require significant estimates concerning future cash flows, and associated discount rates and growth rates assumptions, which are based on management's expectations of future business performance and prospects. In respect of the goodwill arising from Wafer HK, impairment losses of approximately HK\$11,300,000 was made during the year to reduce the CGU's carrying amount to its recoverable amount.

1. GENERAL INFORMATION

GET Holdings Limited (the “Company”) was incorporated as an exempted company with limited liability in the Cayman Islands on 30 July 2001 and continued in Bermuda on 9 January 2014. The registered office of the Company is located at Clarendon House, 2 Church Street, Hamilton HM 11, Bermuda. The principal place of business in Hong Kong is located at Room 1204-05, 12/F., Centre Point, 181-185 Gloucester Road, Wanchai, Hong Kong.

The Company’s shares are listed on the GEM of The Stock Exchange of Hong Kong Limited (the “Stock Exchange”). The principal activity of the Company is investment holding. The principal activities of its subsidiaries (together with the Company collectively referred to as the “Group”) are set out in note 24 to the consolidated financial statements.

The consolidated financial statements are presented in thousands of units of Hong Kong dollars (HK\$’000) unless otherwise stated. Hong Kong dollars (“HK\$”) is the Company’s functional and the Group’s presentation currency.

2. BASIS OF PREPARATION

These consolidated financial statements have been prepared in accordance with all applicable Hong Kong Financial Reporting Standards (“HKFRSs”) issued by the Hong Kong Institute of Certified Public Accountants (the “HKICPA”). HKFRSs comprise Hong Kong Financial Reporting Standards (“HKFRS”); Hong Kong Accounting Standards (“HKAS”); and Interpretations. These consolidated financial statements also comply with the applicable disclosure provisions of the Rules Governing the Listing of Securities on the Stock Exchange and with the disclosure requirements of the Hong Kong Companies Ordinance (Cap. 622). Significant accounting policies adopted by the Group are disclosed below.

The HKICPA has issued certain new and revised HKFRSs that are first effective or available for early adoption for the current accounting period of the Group. Note 3 provides information on any changes in accounting policies resulting from initial application of these developments to the extent that they are relevant to the Group for the current and prior accounting periods reflected in these consolidated financial statements.

1. 一般資料

本公司股份於香港聯合交易所有限公司（「聯交所」）GEM上市。本公司的主要業務為投資控股，其附屬公司（連同本公司統稱「本集團」）的主要業務載於綜合財務報表附註24。

除非另有說明，否則綜合財務報表以千港元（「千港元」）的單位列報。港元（「港元」）為本公司的功能貨幣及本集團的列報貨幣。

2. 編製基準

該等綜合財務報表已根據香港會計師公會（「香港會計師公會」）頒佈的所有適用香港財務報告準則（「香港財務報告準則」）編製。香港財務報告準則包括香港財務報告準則（「香港財務報告準則」）；香港會計準則（「香港會計準則」）；及詮釋。該等綜合財務報表亦符合聯交所證券上市規則的適用披露條文及香港公司條例（第622章）的披露規定。本集團採納的主要會計政策於下文披露。

4. SIGNIFICANT ACCOUNTING POLICIES

These consolidated financial statements have been prepared under the historical cost convention, unless mentioned otherwise in the accounting policies below (e.g. certain financial instruments that are measured at fair value).

The preparation of financial statements in conformity with HKFRS requires the use of certain critical accounting estimates. It also requires management to exercise its judgement in the process of applying the Group's accounting policies. The areas involving a higher degree of judgement or complexity, or areas where assumptions and estimates are significant to the consolidated financial statements are disclosed in note 5.

The significant accounting policies applied in the preparation of these consolidated financial statements are set out below.

(a) Consolidation

The consolidated financial statements include the financial statements of the Company and its subsidiaries made up to 31 December. Subsidiaries are entities over which the Group has control. The Group controls an entity when it is exposed, or has rights, to variable returns from its involvement with the entity and has the ability to affect those returns through its power over the entity. The Group has power over an entity when the Group has existing rights that give it the current ability to direct the relevant activities, i.e. activities that significantly affect the entity's returns.

When assessing control, the Group considers its potential voting rights as well as potential voting rights held by other parties. A potential voting right is considered only if the holder has the practical ability to exercise that right.

4. 主要會計政策

除非下述會計政策另有提述(如若干金融工具按公平價值計量),否則此等綜合財務報表乃根據歷史成本基準編製。

財務報表乃遵照香港財務報告準則編製,當中須要求使用若干主要會計估計。其亦要求管理層於應用本集團會計政策過程中作出判斷。涉及高度的判斷或複雜性或對綜合財務報表而言屬重大假設及估計的範疇,乃於附註5披露。

編製該等綜合財務報表時應用的主要會計政策載列如下。

(a) 綜合賬目

綜合財務報表包括本公司及其附屬公司截至十二月三十一日止的財務報表。附屬公司指受本集團控制的實體。倘本集團因參與實體業務而面對回報有所不同的風險或有權享有回報,並有能力透過其權力影響實體的該等回報,則本集團為控制該實體。當本集團現有權利令其目前有能力主導相關活動(即對實體回報構成重大影響的活動),則本集團對該實體擁有權力。

在評估是否擁有控制權時,本集團會考慮潛在表決權以及其他各方所持潛在表決權。潛在表決權僅於持有人擁有實質能力可行使該項權利時方予考慮。

(a) Consolidation (continued)

Subsidiaries are consolidated from the date on which control is transferred to the Group. They are de-consolidated from the date the control ceases.

The gain or loss on the disposal of a subsidiary that results in a loss of control represents the difference between (i) the fair value of the consideration of the sale plus the fair value of any investment retained in that subsidiary and (ii) the Company's share of the net assets of that subsidiary plus any remaining goodwill and any accumulated exchange reserve relating to that subsidiary.

Intragroup transactions, balances and unrealised profits are eliminated. Unrealised losses are also eliminated unless the transaction provides evidence of an impairment of the asset transferred. Accounting policies of subsidiaries have been changed where necessary to ensure consistency with the policies adopted by the Group.

Non-controlling interests represent the equity in subsidiaries not attributable, directly or indirectly, to the Company. Non-controlling interests are presented in the consolidated statement of financial position and consolidated statement of changes in equity within equity. Non-controlling interests are presented in the consolidated statement of profit or loss and consolidated statement of profit or loss and other comprehensive income as an allocation of profit or loss and total comprehensive income for the year between the non-controlling shareholders and owners of the Company.

Profit or loss and each component of other comprehensive income are attributed to the owners of the Company and to the non-controlling shareholders even if this results in the non-controlling interests having a deficit balance.

Changes in the Company's ownership interest in a subsidiary that do not result in a loss of control are accounted for as equity transactions (i.e. transactions with owners in their capacity as owners). The carrying amounts of the controlling and non-controlling interests are adjusted to reflect the changes in their relative interests in the subsidiary. Any difference between the amount by which the non-controlling interests are adjusted and the fair value of the consideration paid or received is recognised directly in equity and attributed to the owners of the Company.

In the Company's statement of financial position, an investment in a subsidiary is stated at cost less impairment loss, unless the investment is classified as held for sale (or included in a disposal group that is classified as held for sale).

附屬公司在控制權轉移至本集團當日起綜合入賬。附屬公司在控制權終止當日起停止綜合入賬。

因出售一間附屬公司而導致失去控制權的盈虧指(i)出售代價公平價值加上於該附屬公司任何保留投資公平價值與(ii)本公司應佔該附屬公司資產淨值加上與該附屬公司有關的任何餘下商譽及任何累計匯兌儲備兩者間的差額。

集團內公司之間的交易、結餘及未變現溢利均予對銷。未變現虧損亦會對銷，除非該交易有證據顯示所轉讓資產出現減值則作別論。附屬公司的會計政策已按需要變更，以確保與本集團所採納的政策貫徹一致。

非控股權益指並非由本公司直接或間接應佔的附屬公司權益。非控股權益於綜合財務狀況表及綜合權益變動表的權益內呈列。非控股權益於綜合損益表以及綜合損益及其他全面收益表呈列為本年度損益及全面收益總額在非控股股東與擁本公司有人之間的分配。

各項損益及其他全面收益項目歸屬於本公司擁有人及非控股股東，即使導致非控股權益結餘出現虧絀。

本公司並無導致失去附屬公司控制權的擁有人權益變動入賬列作權益交易，即與以擁有人身份進行的擁有人交易。控股及非控股權益的賬面值經調整，以反映其於該附屬公司相關權益的變動。非控股權益的調整數額與已付或已收代價公平價值兩者間的差額乃直接於權益確認，並歸本公司擁有人所有。

(b) Business combination and goodwill

The acquisition method is used to account for the acquisition of a subsidiary in a business combination. The consideration transferred in a business combination is measured at the acquisition-date fair value of the assets given, equity instruments issued, liabilities incurred and any contingent consideration. Acquisition-related costs are recognised as expenses in the periods in which the costs are incurred and the services are received. Identifiable assets and liabilities of the subsidiary in the acquisition are measured at their acquisition-date fair values.

The excess of the sum of the consideration transferred over the Group's share of the net fair value of the subsidiary's identifiable assets and liabilities is recorded as goodwill. Any excess of the Group's share of the net fair value of the identifiable assets and liabilities over the sum of the consideration transferred is recognised in consolidated profit or loss as a gain on bargain purchase which is attributed to the Group.

In a business combination achieved in stages, the previously held equity interest in the subsidiary is remeasured at its acquisition-date fair value and the resulting gain or loss is recognised in consolidated profit or loss. The fair value is added to the sum of the consideration transferred in a business combination to calculate the goodwill.

The non-controlling interests in the subsidiary are initially measured at the non-controlling shareholders' proportionate share of the net fair value of the subsidiary's identifiable assets and liabilities at the acquisition date.

After initial recognition, goodwill is measured at cost less accumulated impairment losses. For the purpose of impairment testing, goodwill acquired in a business combination is allocated to each of the cash-generating units ("CGUs") or groups of CGUs that is expected to benefit from the synergies of the combination. Each unit or group of units to which the goodwill is allocated represents the lowest level within the Group at which the goodwill is monitored for internal management purposes. Goodwill is monitored at the operating segment level. Goodwill impairment reviews are undertaken annually, or more frequently if events or changes in circumstances indicate a potential impairment. The carrying value of the CGU containing the goodwill is compared to the recoverable amount, which is the higher of value in use and the fair value less costs of disposal. Any impairment is recognised immediately as an expense and is not subsequently reversed.

(b) 業務合併及商譽

業務合併中收購附屬公司採用收購法入賬。於業務合併時所轉讓代價按所給予資產、所發行股本工具、所產生負債及任何或然代價的收購日期公平價值計量。收購相關成本於產生成本及接受服務期間確認為開支。收購中附屬公司的可辨認資產及負債按收購日期公平價值計量。

所轉讓代價超出本集團應佔附屬公司的可辨認資產及負債公平淨值的差額列賬為商譽。本集團應佔可辨認資產及負債公平淨值超出所轉讓代價總額的任何差額於綜合損益確認為撥歸本集團議價收購收益。

倘業務合併分階段完成，先前持有附屬公司股權按收購日期公平價值重新計量，而所產生收益或虧損於綜合損益確認。計算商譽時在於業務合併時所轉讓代價中加入公平價值。

於附屬公司的非控股權益初步按非控股股東應佔該附屬公司可辨認資產及負債於收購日期的公平淨值比例計量。

於初步確認後，商譽一般按成本減累計減值虧損計量。就減值測試而言，因業務合併而購入的商譽乃分配至預期從合併協同效應中獲利的各現金產出單元（「現金產出單元」）或現金產出單元組別。各獲分配商譽的單位或單位組別指就內部管理而言本集團監察商譽的最低層面。商譽乃於營運分部層面進行監察。商譽每年進行減值檢討，或當有事件出現或情況改變顯示可能出現減值時作更頻密檢討。包含商譽的現金產出單元賬面值與其可收回價值比較，可收回金額為使用價值與公平價值減出售成本兩者中的較高者。任何減值即時確認為開支，且其後不會撥回。

(c) Associates

Associates are entities over which the Group has significant influence. Significant influence is the power to participate in the financial and operating policy decisions of an entity but is not control or joint control over those policies. The existence and effect of potential voting rights that are currently exercisable or convertible, including potential voting rights held by other entities, are considered when assessing whether the Group has significant influence. In assessing whether a potential voting right contributes to significant influence, the holder's intention and financial ability to exercise or convert that right is not considered.

Investment in an associate is accounted for in the consolidated financial statements by the equity method and is initially recognised at cost. Identifiable assets and liabilities of the associate in an acquisition are measured at their fair values at the acquisition date. The excess of the cost of the investment over the Group's share of the net fair value of the associate's identifiable assets and liabilities is recorded as goodwill. The goodwill is included in the carrying amount of the investment and is tested for impairment together with the investment at the end of each reporting period when there is objective evidence that the investment is impaired. Any excess of the Group's share of the net fair value of the identifiable assets and liabilities over the cost of acquisition is recognised in consolidated profit or loss.

The Group's share of an associate's post-acquisition profits or losses and other comprehensive income is recognised in consolidated statement of profit or loss and other comprehensive income. When the Group's share of losses in an associate equals or exceeds its interest in the associate (which includes any long-term interests that, in substance, form part of the Group's net investment in the associate), the Group does not recognise further losses, unless it has incurred obligations or made payments on behalf of the associate. If the associate subsequently reports profits, the Group resumes recognising its share of those profits only after its share of the profits equals the share of losses not recognised.

於聯營公司的投資乃採用權益法於綜合財務報表列賬，並按成本作出初步確認。所收購聯營公司的可識別資產及負債乃按其於收購當日的公平價值計算。倘投資成本超出本集團應佔聯營公司的可識別資產及負債的公平淨值，則差額將以商譽列賬，而該商譽將列入投資的賬面值，並在有客觀證據顯示投資出現減值時連同於各報告期末的投資一併進行減值測試。倘本集團應佔可識別資產及負債的公平淨值高於收購成本，則有關差額將於綜合損益表內確認。

本集團應佔聯營公司收購後損益及其他全面收益於綜合損益及其他全面收益表內確認。倘本集團應佔聯營公司虧損等於或多於其於該聯營公司的權益（包括實際組成本集團於該聯營公司投資淨值其中部分的任何長期權益），則本集團不會進一步確認虧損，除非其已產生負債或代聯營公司付款。倘聯營公司其後報收溢利，則本集團僅於其應佔溢利等於其應佔未確認的虧損後恢復確認其應佔的該等溢利。

The gain or loss on the disposal of an associate that results in a loss of significant influence represents the difference between (i) the fair value of the consideration of the sale plus the fair value of any investment retained in that associate and (ii) the Group's entire carrying amount of that associate (including goodwill) and any related accumulated exchange reserve. If an investment in an associate becomes an investment in a joint venture, the Group continues to apply the equity method and does not remeasure the retained interest.

Unrealised profits on transactions between the Group and its associates are eliminated to the extent of the Group's interests in the associates. Unrealised losses are also eliminated unless the transaction provides evidence of an impairment of the asset transferred. Accounting policies of associates have been changed where necessary to ensure consistency with the policies adopted by the Group.

(d) Foreign currency translation

(i) Functional and presentation currency

Items included in the financial statements of each of the Group's entities are measured using the currency of the primary economic environment in which the entity operates (the "functional currency"). The consolidated financial statements are presented in Hong Kong dollars, which is the Company's functional and presentation currency.

(ii) Transactions and balances in each entity's financial statements

Transactions in foreign currencies are translated into the functional currency on initial recognition using the exchange rates prevailing on the transaction dates. Monetary assets and liabilities in foreign currencies are translated at the exchange rates at the end of each reporting period. Gains and losses resulting from this translation policy are recognised in profit or loss.

Non-monetary items that are measured at fair value in foreign currencies are translated using the exchange rates at the dates when the fair values are determined.

外幣交易於初步確認時採用於交易日期適用的匯率換算為功能貨幣。以外幣呈列的貨幣資產及負債按各報告期末的匯率換算。因此匯兌政策產生的盈虧均於損益確認。

(iii) *Translation on consolidation*

The results and financial position of all the Group entities that have a functional currency different from the Company's presentation currency are translated into the Company's presentation currency as follows:

- Assets and liabilities for each statement of financial position presented are translated at the closing rate at the date of that statement of financial position;
- Income and expenses are translated at average exchange rates for the period (unless this average is not a reasonable approximation of the cumulative effect of the rates prevailing on the transaction dates, in which case income and expenses are translated at the exchange rates on the transaction dates); and
- All resulting exchange differences are recognised in other comprehensive income and accumulated in the exchange reserve.

On consolidation, exchange differences arising from the translation of monetary items that form part of the net investment in foreign entities are recognised in other comprehensive income and accumulated in the exchange reserve. When a foreign operation is sold, such exchange differences are reclassified to consolidated profit or loss as part of the gain or loss on disposal.

Goodwill and fair value adjustments arising on the acquisition of a foreign entity are treated as assets and liabilities of the foreign entity and translated at the closing rate.

Property, plant and equipment are stated in the consolidated statement of financial position at cost, less subsequent accumulated depreciation and subsequent accumulated impairment losses, if any.

Subsequent costs are included in the asset's carrying amount or recognised as a separate asset, as appropriate, only when it is probable that future economic benefits associated with the item will flow to the Group and the cost of the item can be measured reliably. All other repairs and maintenance are recognised in profit or loss during the period in which they are incurred.

Depreciation of property, plant and equipment is calculated at rates sufficient to write off their cost less their residual values over the estimated useful lives on a straight-line basis. The principal annual rates are as follows:

(f) Intangible assets (other than goodwill)

Expenditure on research activities is recognised as an expense in the period in which it is incurred. Expenditure on development activities is capitalised as intangible assets if the product or process is technically and commercially feasible and the Group has sufficient resources and the intention to complete development. The expenditure capitalised includes the costs of materials, direct labour, and an appropriate proportion of overheads and borrowing costs, where applicable. Capitalised development costs are stated at cost less accumulated amortisation and impairment losses. Other development expenditure is recognised as an expense in the period in which it is incurred.

Customer relationship and computer software are that intangible assets with finite useful lives and are acquired through business combination. The intangible assets acquired in a business combination are stated at cost, being the fair value at the date of completion of the business combination, less accumulated amortisation and accumulated impairment losses.

Amortisation of intangible assets with finite useful lives is charged to profit or loss on a straight-line basis over the assets' estimated useful lives. The following intangible assets with finite useful lives are amortised from the date they are available for use and their estimated useful lives are as follows:

(g) Leases

At inception of a contract, the Group assesses whether the contract is, or contains, a lease. A contract is, or contains, a lease if the contract conveys the right to control the use of an identified asset for a period of time in exchange for consideration. Control is conveyed where the customer has both the right to direct the use of the identified asset and to obtain substantially all of the economic benefits from that use.

The Group as a lessee

Where the contract contains lease component(s) and non-lease component(s), the Group has elected not to separate non-lease components and accounts for each lease component and any associated non-lease components as a single lease component for all leases.

At the lease commencement date, the Group recognises a right-of-use asset and a lease liability, except for short-term leases that have a lease term of 12 months or less and leases of low-value assets which, for the Group are primarily office equipment and office premises. When the Group enters into a lease in respect of a low-value asset, the Group decides whether to capitalise the lease on a lease-by-lease basis. The lease payments associated with those leases which are not capitalised are recognised as an expense on a systematic basis over the lease term.

Where the lease is capitalised, the lease liability is initially recognised at the present value of the lease payments payable over the lease term, discounted using the interest rate implicit in the lease or, if that rate cannot be readily determined, using a relevant incremental borrowing rate. After initial recognition, the lease liability is measured at amortised cost and interest expense is calculated using the effective interest method. Variable lease payments that do not depend on an index or rate are not included in the measurement of the lease liability and hence are charged to profit or loss in the accounting period in which they are incurred.

本集團作為承租人

當合約包含租賃組成部分及非租賃組成部分時，本集團選擇不分拆非租賃組成部分，並就所有租賃將各租賃組成部分及任何相關非租賃組成部分入賬列作單一租賃組成部分。

於租賃開始日期，就本集團而言租賃主要為辦公室設備及辦公室物業，本集團確認使用權資產及租賃負債（租賃期為12個月或更短的短期租賃以及低價值資產租賃除外）。當本集團就低價值資產訂立租賃時，本集團按每項租賃情況決定是否將租賃資本化。與該等不作資本化租賃相關的租賃付款於租賃期內按系統基準確認為開支。

當租賃撥充資本時，租賃負債初步於租期內按應付租賃付款現值確認，並使用租賃隱含之利率貼現，或倘利率無法即時釐定，則使用相關增量借貸利率。於初步確認後，租賃負債按攤銷成本計量，而利息開支使用實際利率法計算。並無依賴指數或利率之可變租賃付款並不會計入租賃負債計量，並於產生之會計期間於損益扣除。

The right-of-use asset recognised when a lease is capitalised is initially measured at cost, which comprises the initial amount of the lease liability plus any lease payments made at or before the commencement date, and any initial direct costs incurred. Where applicable, the cost of the right-of-use assets also includes an estimate of costs to dismantle and remove the underlying asset or to restore the underlying asset or the site on which it is located, discounted to their present value, less any lease incentives received. The right-of-use asset is subsequently stated at cost less accumulated depreciation and impairment losses.

Right-of-use assets in which the Group is reasonably certain to obtain ownership of the underlying leased assets at the end of the lease term are depreciated from commencement date to the end of the useful life. Otherwise, right-of-use assets are depreciated on a straight-line basis over the shorter of its estimated useful life and the lease term.

Refundable rental deposits paid are accounted under HKFRS 9 and initially measured at fair value. Adjustments to fair value at initial recognition are considered as additional lease payments and included in the cost of right-of-use assets.

The lease liability is remeasured when there is a change in future lease payments arising from a change in an index or rate, or there is a change in the Group's estimate of the amount expected to be payable under a residual value guarantee, or there is a change arising from the reassessment of whether the Group will be reasonably certain to exercise a purchase, extension or termination option. When the lease liability is remeasured in this way, a corresponding adjustment is made to the carrying amount of the right-of-use asset, or is recorded in profit or loss if the carrying amount of the right-of-use asset has been reduced to zero.

The lease liability is also remeasured when there is a change in the scope of a lease or the consideration for a lease that is not originally provided for in the lease contract that is not accounted for as a separate lease. In this case the lease liability is remeasured based on the revised lease payments and lease term using a revised discount rate at the effective date of the modification.

已付可退還租賃按金根據香港財務報告準則第9號入賬並在初始時按公平價值計量。初始確認時的公平價值調整視作額外租賃付款並計入使用權資產成本。

當未來租賃付款額因指數或比率的變化而發生改變，或本集團剩餘價值擔保下預計應付的金額估計發生變化，或當重新評估本集團是否將合理確定行使購買、延長或終止選擇權而產生變動，則會重新計量租賃負債。當租賃負債以此方式重新計量，對使用權資產的賬面金額作出相應調整，或倘若使用權資產的賬面金額已經減至零，則記入損益。

(h) Inventories

Inventories represent finished goods which are stated at the lower of cost and net realisable value. Cost is determined using the first-in, first-out basis. Net realisable value is the estimated selling price in the ordinary course of business, less the estimated costs of completion and the estimated costs necessary to make the sale.

(i) Contract assets and contract liabilities

Contract asset is recognised when the Group recognises revenue before being unconditionally entitled to the consideration under the payment terms set out in the contract. Contract assets are assessed for expected credit losses (“ECL”) in accordance with the policy set out in note 4(v) and are reclassified to receivables when the right to the consideration has become unconditional.

A contract liability is recognised when the customer pays consideration before the Group recognises the related revenue. A contract liability would also be recognised if the Group has an unconditional right to receive consideration before the Group recognises the related revenue. In such cases, a corresponding receivable would also be recognised.

For a single contract with the customer, either a net contract asset or a net contract liability is presented. For multiple contracts, contract assets and contract liabilities of unrelated contracts are not presented on a net basis.

When the contract includes a significant financing component, the contract balance includes interest accrued under the effective interest method.

存貨指按成本及可變現淨值兩者中的較低者入賬的製成品。成本按先進先出基準計算。可變現淨值乃按一般業務過程中的估計售價減估計完工成本及進行銷售所需估計成本計算。

(i) 合約資產及合約負債

在本集團有權無條件獲取合約所載付款條款代價前確認收益時確認合約資產。合約資產按附註4(v)所載政策就預期信貸虧損（「預期信貸虧損」）而獲評估，並在代價權利成為無條件後獲重新分類至應收款項。

本集團確認相關收益前，合約負債在客戶支付代價時確認。如本集團有無條件權利在本集團確認相關收益前收取代價，則合約負債亦會獲確認。在相關情況下，相應應收款項亦會獲確認。

就與客戶的單一合約而言，淨合約資產或淨合約負債得以呈列。就多份合約而言，不相關合約的合約資產及合約負債不按淨額基準呈列。

合約計及重大融資成分時，合約結餘計入按實際利率法累計的利息。

(i) Contract for services

Revenue from contracts with customers in the Group's corporate management solutions ("CMS services") and I.T. contract services business recognised over time when the Group's performance does not create an asset with an alternative use to the Group and the Group has an enforceable right to payment for performance completed to date.

When the outcome of a CMS services contract can be reasonably measured, revenue from the contract is recognised progressively over time using the cost-to-cost method, i.e. based on the proportion of the actual costs incurred relative to the estimated total costs. The directors consider that this input method is an appropriate measure of the progress towards complete satisfaction of these performance obligations under HKFRS 15.

The Group becomes entitled to invoice customers for rendering of CMS services based on achieving a series of performance-related milestones. When a particular milestone is reached the customer is sent an invoice for the related milestone payment. The Group will previously have recognised a contract asset for any work performed. Any amount previously recognised as a contract asset is reclassified to trade receivables at the point at which it is invoiced to the customer. If the milestone payment exceeds the revenue recognised to date under the cost-to-cost method then the Group recognises a contract liability for the difference. There is not considered to be a significant financing component in contracts with customers as the period between the recognition of revenue under the cost-to-cost method and the milestone payment is always less than one year.

The likelihood of the Group earning contractual bonuses for early completion or suffering contractual penalties for late completion are taken into account in making these estimates, such that revenue is only recognised to the extent that it is highly probable that a significant reversal in the amount of cumulative revenue recognised will not occur.

When the outcome of the contract cannot be reasonably measured, revenue is recognised only to the extent of contract costs incurred that are expected to be recovered.

If at any time the costs to complete the contract are estimated to exceed the remaining amount of the consideration under the contract, then a provision is recognised.

(i) 服務合約

當本集團的履約行為並未創造一項可被本集團用於替代用途之資產，且本集團具有就迄今為止已完成之履約部分獲得客戶付款之可執行權利時，本集團與客戶所訂立企業管理解決方案（「企業管理解決方案服務」）及資訊科技合約服務業務的合約，會逐漸確認合約的收入。

當可以合理地計量企業管理解決方案服務合約的結果時，使用成本比例法，即基於實際發生的成本佔估計總成本的比例，逐漸確認合約的收入。董事認為，此輸入法是就香港財務報告準則第15號並完全履行該等履約責任進展的適當方法。

在達成一系列與表現相關的重要階段後，本集團有權就提供企業管理解決方案服務向客戶開具發票。當達到特定階段時，向客戶發出相關階段的付款發票。本集團先前將就任何已履行工作確認合約資產。先前已確認為合約資產的任何金額在向客戶開具發票時重新分類至貿易應收賬款。倘若階段付款超過截至當時根據成本比例法已確認的收入，則本集團會就差額確認合約負債。與客戶之間的合同中並無重大融資成分，因為根據成本比例法確認收入與階段付款之間的期間通常少於一年。

(k) Recognition and derecognition of financial instruments

Financial assets and financial liabilities are recognised in the consolidated statement of financial position when the Group becomes a party to the contractual provisions of the instruments.

Financial assets and financial liabilities are initially measured at fair value. Transaction costs that are directly attributable to the acquisition or issue of financial assets and financial liabilities (other than financial assets at FVTPL) are added to or deducted from the fair value of the financial assets or financial liabilities, as appropriate, on initial recognition. Transaction costs directly attributable to the acquisition of financial assets or financial liabilities at FVTPL are recognised immediately in profit or loss.

The Group derecognises a financial asset only when the contractual rights to the cash flows from the asset expire, or when it transfers the financial asset and substantially all the risks and rewards of ownership of the asset to another entity. If the Group neither transfers nor retains substantially all the risks and rewards of ownership and continues to control the transferred asset, the Group recognises its retained interest in the asset and an associated liability for amounts it may have to pay. If the Group retains substantially all the risks and rewards of ownership of a transferred financial asset, the Group continues to recognise the financial asset and also recognises a collateralised borrowing for the proceeds received.

The Group derecognises financial liabilities when, and only when, the Group's obligations are discharged, cancelled or have expired. The difference between the carrying amount of the financial liability derecognised and the consideration paid and payable, including any non-cash assets transferred or liabilities assumed, is recognised in profit or loss.

Financial assets and liabilities are offset and the net amount reported in the balance sheet when there is a legally enforceable right to offset the recognised amounts and there is an intention to settle on a net basis or realise the asset and settle the liability simultaneously. The legally enforceable right must not be contingent on future events and must be enforceable in the normal course of business and in the event of default, insolvency or bankruptcy of the company or the counterparty.

當有法定可執行權力可抵銷已確認金額，並有意圖按淨額基準結算或同時變現資產和結算負債時，金融資產與負債可互相抵銷，並在資產負債表報告其淨額。法定可執行權利必須不得依賴未來事件而定，而在一般業務過程中以及倘公司或對方一旦出現違約、無償債能力或破產時，這也必須具有約束力。

(i) Financial assets

All regular way purchases or sales of financial assets are recognised and derecognised on a trade date basis. Regular way purchases or sales are purchases or sales of financial assets that require delivery of assets within the time frame established by regulation or convention in the marketplace. All recognised financial assets are measured subsequently in their entirety at either amortised cost or fair value, depending on the classification of the financial assets.

Debt investments

Debt investments held by the Group are classified under amortised cost, if the investment is held for the collection of contractual cash flows which represent solely payments of principal and interest. Interest income from the investment is calculated using the effective interest method.

Equity investments

An investment in equity securities is classified as FVTPL unless the equity investment is not held for trading purposes and on initial recognition of the investment the Group makes an election to designate the investment at FVTOCI (non-recycling) such that subsequent changes in fair value are recognised in other comprehensive income. Such elections are made on an instrument-by-instrument basis, but may only be made if the investment meets the definition of equity from the issuer's perspective. Where such an election is made, the amount accumulated in other comprehensive income remains in the investment revaluation reserve (non-recycling) until the investment is disposed of. At the time of disposal, the amount accumulated in the investment revaluation reserve (non-recycling) is transferred to accumulated losses. It is not recycled through profit or loss. Dividends from an investment in equity securities, irrespective of whether classified as at FVTPL or FVTOCI, are recognised in profit or loss as other income.

(m) Trade and other receivables

A receivable is recognised when the Group has an unconditional right to receive consideration. A right to receive consideration is unconditional if only the passage of time is required before payment of that consideration is due. If revenue has been recognised before the Group has an unconditional right to receive consideration, the amount is presented as a contract asset.

Receivables are stated at amortised cost using the effective interest method less allowance for credit losses.

(n) Cash and cash equivalents

Cash and cash equivalents comprise cash at bank and on hand, demand deposits with banks and other financial institutions, and short-term, highly liquid investments that are readily convertible into known amounts of cash and which are subject to an insignificant risk of changes in value, having been within three months of maturity at acquisition. Bank overdrafts that are repayable on demand and form an integral part of the Group's cash management are also included as a component of cash and cash equivalents for the purpose of the consolidated cash flow statement. Cash and cash equivalents are assessed for ECL.

(o) Financial liabilities and equity instruments

Financial liabilities and equity instruments are classified according to the substance of the contractual arrangements entered into and the definitions of a financial liability and an equity instrument under HKFRSs. An equity instrument is any contract that evidences a residual interest in the assets of the Group after deducting all of its liabilities. The accounting policies adopted for specific financial liabilities and equity instruments are set out below.

(i) Trade and other payables

Trade and other payables are recognised initially at their fair value and subsequently measured at amortised cost using the effective interest method unless the effect of discounting would be immaterial, in which case they are stated at cost.

(ii) Equity instruments

An equity instrument is any contract that evidence a residual interest in the assets of an entity after deducting all of its liabilities. Equity instruments issued by the Company are recorded at the proceeds received, net of direct issue costs.

(p) Revenue recognition and other income

Revenue is recognised when control over a product or service is transferred to the customer, at the amount of promised consideration to which the Group is expected to be entitled, excluding those amounts collected on behalf of third parties. Revenue excludes value added tax or other sales taxes and is after deduction of any trade discounts.

Depending on the terms of the contract and the laws that apply to the contract, control of services may be transferred over time or at a point in time. Control of the services is transferred over time if the Group's performance:

- provides all of the benefits received and consumed simultaneously by the customer;
- creates and enhances an asset that the customer control as the Group performs; or
- does not create an asset with an alternative use to the Group and the Group has an enforceable right to payment for performance completed to date.

Revenue is recognised over the period of the contract by reference to the progress towards complete satisfaction of the performance obligation.

當產品或服務的控制權按本集團預期有權獲取的承諾代價數額(不包括代表第三方收取的金額)轉移至客戶時,收入予以確認。收入不包括增值稅或其他銷售稅,並經扣除任何貿易折扣。

視乎合約條款及適用於合約的法律,服務控制權可經過一段時間或於某一時間點轉移。倘本集團在履約過程中滿足下列條件,服務的控制權將經過一段時間轉移:

(i) Service income

- Revenue from CMS services is recognised based on the stage of completion of the contract in accordance with the policy set out in note 4(j) above. Payment for CMS services is not due from the customer until the services are complete and therefore a contract asset is recognised over the period in which the CMS services are performed representing the entity's right to consideration for the services performed to date.
- Services fee income from I.T. contract services including I.T. maintenance services and system integration services are recognised as a performance obligation satisfied over time when the related services are rendered. Services are fixed-price contracts that customer pays the fixed amount based on a payment schedule. If the services rendered by the Group exceed the payment, a contract asset is recognised. If the payments exceed the services rendered, a contract liability is recognised.

(ii) Sale of goods

- Revenue from the sale of computer and mobile phone software is recognised when the customer obtains control of the software when a contract is agreed, the software is delivered and the customer has the right to use it.
- Revenue from the sales of hardware and software products is recognised when control of the goods has been transferred which generally coincides with the time when the goods are delivered and the title has passed to the customers. A receivable is recognised by the Group when the goods are delivered to the customer as this represents the point in time at which the right to consideration becomes unconditional, as only the passage of time is required before payment is due.

(iii) Toolbar and advertisement income

Toolbar revenue is derived principally from online toolbar private label arrangements with toolbar service providers. The Group allows toolbar service providers to launch their toolbar installation application when the Group's software is installed by users. Toolbar revenue is determined based on the number of qualified installations and as a share of search based income when users use the search engine incorporated in the toolbar to search for goods and services and purchase goods and services advertised in the search result.

Income from advertisement is derived principally from online advertising arrangements. The Group enters into advertising arrangements with advertisers to allow them to put advertisements on particular areas of the Group's electronic platforms, or embedded hyperlinks to advertisements in the Group's electronic platforms. For the hyperlinks embedded in the Group's websites, the advertisers pay the Group based on number of clicks on the hyperlinks.

The Group recognises revenue as a performance obligation at a point in time when the revenue can be measured reliably and the collectability is reasonably assured.

(iv) Interest income

Interest income on loans are recognised as it accrues using the effective interest method. For financial assets measured at amortised cost or financial assets at FVTOCI (recycling) that are not credit-impaired, the effective interest rate is applied to the gross carrying amount of the asset. For credit impaired financial assets, the effective interest rate is applied to the amortised cost (i.e. gross carrying amount net of loss allowance) of the asset.

廣告收入主要來自網上廣告。本集團與廣告商訂立廣告安排，讓彼等於本集團的電子平台特定區域登載廣告，或於本集團電子平台的廣告中嵌入超連結。就嵌入本集團網站的超連結而言，廣告商根據超連結的點擊率向本集團付款。

收入能夠可靠計量及合理確定可收回時，本集團於履約責任之時間點確認收入。

(iv) 利息收入

(v) *Bank interest income*

Bank interest income is recognised as it accrues using the effective interest method.

(vi) *Dividend income*

Dividend income is recognised when the shareholders' rights to receive payment are established.

(q) Employee benefits

(i) *Employee leave entitlements*

Employee entitlements to annual leave and long service leave are recognised when they accrue to employees. A provision is made for the estimated liability for annual leave and long service leave as a result of services rendered by employees up to the end of the reporting period.

Employee entitlements to sick leave and maternity leave are not recognised until the time of leave.

(ii) *Pension obligations*

The Group contributes to defined contribution retirement schemes which are available to all employees. Contributions to the schemes by the Group and employees are calculated as a percentage of employees' basic salaries. The retirement benefit scheme cost charged to profit or loss represents contributions payable by the Group to the funds.

Subsidiaries incorporated in the People's Republic of China ("PRC") participate in the retirement schemes operated by the local authorities for the Group's employees in the PRC. Contributions to these schemes are charged to profit or loss when incurred.

Termination benefits are recognised at the earlier of the dates when the Group can no longer withdraw the offer of those benefits, and when the Group recognises restructuring costs and involves the payment of termination benefits.

(r) Government grants

A government grant is recognised when there is reasonable assurance that the Group will comply with the conditions attaching to it and that the grant will be received.

Government grants that become receivable as compensation for expenses or losses already incurred or for the purpose of giving immediate financial support to the Group with no future related costs are recognised in profit or loss in the period in which they become receivable.

(s) Taxation

Income tax represents the sum of the current tax and deferred tax.

The tax currently payable is based on taxable profit for the year. Taxable profit differs from profit recognised in profit or loss because of items of income or expense that are taxable or deductible in other years and items that are never taxable or deductible. The Group's liability for current tax is calculated using tax rates that have been enacted or substantively enacted by the end of the reporting period.

Deferred tax is recognised on differences between the carrying amounts of assets and liabilities in the consolidated financial statements and the corresponding tax bases used in the computation of taxable profit. Deferred tax liabilities are generally recognised for all taxable temporary differences and deferred tax assets are recognised to the extent that it is probable that taxable profits will be available against which deductible temporary differences, unused tax losses or unused tax credits can be utilised. Such assets and liabilities are not recognised if the temporary difference arises from goodwill or from the initial recognition (other than in a business combination) of other assets and liabilities in a transaction that affects neither the taxable profit nor the accounting profit.

Deferred tax liabilities are recognised for taxable temporary differences arising on investments in subsidiaries and associates, except where the Group is able to control the reversal of the temporary difference and it is probable that the temporary difference will not reverse in the foreseeable future.

The carrying amount of deferred tax assets is reviewed at the end of each reporting period and reduced to the extent that it is no longer probable that sufficient taxable profits will be available to allow all or part of the asset to be recovered.

Deferred tax is calculated at the tax rates that are expected to apply in the period when the liability is settled or the asset is realised, based on tax rates that have been enacted or substantively enacted by the end of the reporting period. Deferred tax is recognised in profit or loss, except when it relates to items recognised in other comprehensive income or directly in equity, in which case the deferred tax is also recognised in other comprehensive income or directly in equity.

The measurement of deferred tax assets and liabilities reflects the tax consequences that would follow from the manner in which the Group expects, at the end of the reporting period, to recover or settle the carrying amount of its assets and liabilities.

For the purposes of measuring deferred tax for leasing transactions in which the Group recognises the right-of-use assets and the related lease liabilities, the Group first determines whether the tax deductions are attributable to the right-of-use assets or the lease liabilities.

For leasing transactions in which the tax deductions are attributable to the lease liabilities, the Group applies HKAS 12 requirements to right-of-use assets and lease liabilities separately. Temporary differences relating to right-of-use assets and lease liabilities are not recognised at initial recognition and over the lease terms due to application of the initial recognition exemption.

Deferred tax assets and liabilities are offset when there is a legally enforceable right to set off current tax assets against current tax liabilities and when they relate to income taxes levied by the same taxation authority and the Group intends to settle its current tax assets and liabilities on a net basis.

遞延稅項資產及負債於有可合法執行權利將當期稅項資產抵銷當期稅項負債，及當其與相同稅務機關徵收的所得稅有關之時，且本集團擬按淨額基準清償其當期稅項資產及負債的情況下予以抵銷。

(u) Impairment of non-financial assets

The carrying amounts of non-financial assets are reviewed at each reporting date for indications of impairment and where an asset is impaired, it is written down as an expense through the consolidated statement of profit or loss to its estimated recoverable amount. The recoverable amount is determined for an individual asset, unless the asset does not generate cash inflows that are largely independent of those from other assets or groups of assets. If this is the case, recoverable amount is determined for the cash-generating unit to which the asset belongs. Recoverable amount is the higher of value in use and the fair value less costs of disposal of the individual asset or the cash-generating unit.

Value in use is the present value of the estimated future cash flows of the asset/cash-generating unit. Present values are computed using pre-tax discount rates that reflect the time value of money and the risks specific to the asset/cash-generating unit whose impairment is being measured.

Impairment losses for cash-generating units are allocated first against the goodwill of the unit and then pro rata amongst the other assets of the cash-generating unit. Subsequent increases in the recoverable amount caused by changes in estimates are credited to profit or loss to the extent that they reverse the impairment.

The Group recognises a loss allowance for ECL on investments in debt instruments that are measured at amortised cost, trade receivables and contract assets. The amount of ECL is updated at each reporting date to reflect changes in credit risk since initial recognition of the respective financial instrument.

The Group always recognises lifetime ECL for trade receivables and contract assets. The ECL on these financial assets are estimated using a provision matrix based on the Group's historical credit loss experience, adjusted for factors that are specific to the debtors, general economic conditions and an assessment of both the current as well as the forecast direction of conditions at the reporting date, including time value of money where appropriate.

For all other financial instruments, the Group recognises lifetime ECL when there has been a significant increase in credit risk since initial recognition. However, if the credit risk on the financial instrument has not increased significantly since initial recognition, the Group measures the loss allowance for that financial instrument at an amount equal to 12-month ECL.

Lifetime ECL represents the expected credit losses that will result from all possible default events over the expected life of a financial instrument. In contrast, 12-month ECL represents the portion of lifetime ECL that is expected to result from default events on a financial instrument that are possible within 12 months after the reporting date.

Significant increase in credit risk

In assessing whether the credit risk on a financial instrument has increased significantly since initial recognition, the Group compares the risk of a default occurring on the financial instrument at the reporting date with the risk of a default occurring on the financial instrument at the date of initial recognition. In making this assessment, the Group considers both quantitative and qualitative information that is reasonable and supportable, including historical experience and forward-looking information that is available without undue cost or effort. Forward-looking information considered includes the future prospects of the industries in which the Group's debtors operate, obtained from economic expert reports, financial analysts, governmental bodies, relevant think-tanks and other similar organisations, as well as consideration of various external sources of actual and forecast economic information that relate to the Group's core operations.

In particular, the following information is taken into account when assessing whether credit risk has increased significantly since initial recognition:

- an actual or expected significant deterioration in the financial instrument's external (if available) or internal credit rating;
- significant deterioration in external market indicators of credit risk for a particular financial instrument;
- existing or forecast adverse changes in business, financial or economic conditions that are expected to cause a significant decrease in the debtor's ability to meet its debt obligations;

- an actual or expected significant deterioration in the operating results of the debtor;
- significant increases in credit risk on other financial instruments of the same debtor;
- an actual or expected significant adverse change in the regulatory, economic, or technological environment of the debtor that results in a significant decrease in the debtor's ability to meet its debt obligations.

Irrespective of the outcome of the above assessment, the Group presumes that the credit risk on a financial asset has increased significantly since initial recognition when contractual payments are more than 30 days past due, unless the Group has reasonable and supportable information that demonstrates otherwise.

Despite the foregoing, the Group assumes that the credit risk on a financial instrument has not increased significantly since initial recognition if the financial instrument is determined to have low credit risk at the reporting date. A financial instrument is determined to have low credit risk if:

- The financial instrument has a low risk of default,
- The debtor has a strong capacity to meet its contractual cash flow obligations in the near term, and
- Adverse changes in economic and business conditions in the longer term may, but will not necessarily, reduce the ability of the borrower to fulfil its contractual cash flow obligations.

The Group considers a financial asset to have low credit risk when the asset has external credit rating of “investment grade” in accordance with the globally understood definition or if an external rating is not available, the asset has an internal rating of “performing”. Performing means that the counterparty has a strong financial position and there is no past due amounts.

The Group regularly monitors the effectiveness of the criteria used to identify whether there has been a significant increase in credit risk and revises them as appropriate to ensure that the criteria are capable of identifying significant increase in credit risk before the amount becomes past due.

Definition of default

The Group considers the following as constituting an event of default for internal credit risk management purposes as historical experience indicates that receivables that meet either of the following criteria are generally not recoverable.

- when there is a breach of financial covenants by the counterparty; or
- information developed internally or obtained from external sources indicates that the debtor is unlikely to pay its creditors, including the Group, in full (without taking into account any collaterals held by the Group).

Irrespective of the above analysis, the Group considers that default has occurred when a financial asset is more than 90 days past due unless the Group has reasonable and supportable information to demonstrate that a more lagging default criterion is more appropriate.

本集團認為，若根據眾所周知的定義，金融資產的外部信貸評級為「投資級」，或倘未獲得外部評級，金融資產的內部評級為「正常」，則該金融資產具有較低信貸風險。正常指對方的財務狀況穩健，且並無逾期款項。

本集團定期監察識別信貸風險是否顯著上升所用標準的有效性，並酌情修訂以確保該標準能夠在款項逾期前識別信貸風險的顯著上升。

違約的定義

本集團認為以下情況就內部信貸風險管理目的而言構成違約事件，因為過往經驗表明符合以下任何一項條件的應收款項一般無法收回。

- 交易對方違反財務契諾；或
- 內部產生或自外部來源獲取的資料表明，債務人不太可能向債權人（包括本集團）全額還款（不考慮本集團持有的任何抵押品）。

不論上述分析結果如何，本集團認為，當金融資產逾期超過90天時即發生違約，惟本集團有合理且可支持的資料證明更為滯後的違約標準更為適當除外。

Credit-impaired financial assets

A financial asset is credit-impaired when one or more events that have a detrimental impact on the estimated future cash flows of that financial asset have occurred. Evidence that a financial asset is credit-impaired includes observable data about the following events:

- significant financial difficulty of the issuer or the counterparty;
- a breach of contract, such as a default or past due event;
- the lender(s) of the counterparty, for economic or contractual reasons relating to the counterparty's financial difficulty, having granted to the counterparty a concession(s) that the lender(s) would not otherwise consider;
- it is becoming probable that the counterparty will enter bankruptcy or other financial reorganisation; or
- the disappearance of an active market for that financial asset because of financial difficulties.

Write-off policy

The Group writes off a financial asset when there is information indicating that the debtor is in severe financial difficulty and there is no realistic prospect of recovery, including when the debtor has been placed under liquidation or has entered into bankruptcy proceedings, or in the case of trade receivables, when the amounts are over two years past due, whichever occurs sooner. Financial assets written off may still be subject to enforcement activities under the Group's recovery procedures, taking into account legal advice where appropriate. Any recoveries made are recognised in profit or loss.

撇銷政策

當有資料顯示債務人陷入嚴重財政困難，且並無實際收回的可能之時（包括債務人已清算或進入破產程序）時，或就貿易應收賬款而言，當款項逾期超過兩年時（以較早發生者為準），本集團會撇銷金融資產。已撇銷的金融資產仍可根據本集團的收回程序實施強制執行，在適當情況下考慮法律意見。任何收回款項會於損益中確認。

Measurement and recognition of ECL

The measurement of ECL is a function of the probability of default, loss given default (i.e. the magnitude of the loss if there is a default) and the exposure at default. The assessment of the probability of default and loss given default is based on historical data adjusted by forward-looking information as described above. As for the exposure at default, for financial assets, this is represented by the assets' gross carrying amount at the reporting date.

For financial assets, the ECL is estimated as the difference between all contractual cash flows that are due to the Group in accordance with the contract and all the cash flows that the Group expects to receive, discounted at the original effective interest rate.

If the Group has measured the loss allowance for a financial instrument at an amount equal to lifetime ECL in the previous reporting period, but determines at the current reporting date that the conditions for lifetime ECL are no longer met, the Group measures the loss allowance at an amount equal to 12-month ECL at the current reporting date, except for assets for which simplified approach was used.

The Group recognises an impairment gain or loss in profit or loss for all financial instruments with a corresponding adjustment to their carrying amount through a loss allowance account.

預期信貸虧損的計量為違約概率、違約損失率 (即違約時的損失程度) 及違約風險暴露的函數。評估違約概率及違約損失率的依據是過往數據，並按上述前瞻性資料進行調整。而金融資產的違約風險暴露，則由資產於報告日期的賬面總值代表。

Provisions are recognised for liabilities of uncertain timing or amount when the Group has a present legal or constructive obligation arising as a result of a past event, it is probable that an outflow of economic benefits will be required to settle the obligation and a reliable estimate can be made. Where the time value of money is material, provisions are stated at the present value of the expenditures expected to settle the obligation.

Where it is not probable that an outflow of economic benefits will be required, or the amount cannot be estimated reliably, the obligation is disclosed as a contingent liability, unless the probability of outflow is remote. Possible obligations, whose existence will only be confirmed by the occurrence or non-occurrence of one or more future events are also disclosed as contingent liabilities unless the probability of outflow is remote.

(x) Events after the reporting period

Events after the reporting period that provide additional information about the Group's position at the end of the reporting period or those that indicate the going concern assumption is not appropriate are adjusting events and are reflected in the consolidated financial statements. Events after the reporting period that are not adjusting events are disclosed in the notes to the consolidated financial statements when material.

5. CRITICAL JUDGEMENTS AND KEY ESTIMATES

Estimates and judgements are continually evaluated and are based on historical experience and other factors, including expectations of future events that are believed to be reasonable under the circumstances.

The Group makes estimates and assumptions concerning the future. The resulting accounting estimates will, by definition, seldom equal the related actual results. The estimates and assumptions that have a significant risk of causing a material adjustment to the carrying amount of assets and liabilities within the next financial year are discussed below.

(a) Impairment of goodwill

Determining whether goodwill is impaired requires an estimation of the value in use ("VIU") and fair value less costs of disposal ("FVLCD") of the CGU to which goodwill has been allocated. The VIU calculation requires the directors to estimate the future cash flows expected to arise from the CGU and a suitable discount rate in order to calculate present value. Calculation of fair value using a market approach requires valuation technique which uses prices and other relevant information generated by market transactions involving identical and comparable groups of assets and liabilities or business, a control premium and marketability discount. The carrying amount of goodwill at the end of the reporting period was approximately HK\$69,525,000 (2019: HK\$80,825,000) after an impairment loss of approximately HK\$11,300,000 (2019: HK\$65,254,000) was recognised during the year. Details of the impairment test for CGU containing goodwill are set out in note 22.

5. 關鍵判斷及主要估計

估計及判斷乃根據過往經驗及其他因素進行持續評估，包括在有關情況下對未來事件相信為合理的預測。

本集團對未來作出估計及假設。按定義得出的會計估計絕少會與相關實際結果相同。下文討論估計及假設存在導致資產與負債賬面值於下一個財政年度須作出重大調整的重大風險。

(a) 商譽減值

釐定商譽是否出現減值須估計獲分配商譽的現金產出單元的使用價值（「使用價值」）及公平價值減出售成本（「公平價值減銷售成本」）。計算使用價值時，董事須估計預期自現金產出單元產生的未來現金流量及適當的貼現率以計算現值。使用價值計算方法需要本集團估計預期現金產出單元將產生的未來現金流量及適當貼現率以計算現值。按市場法計算公平價值需要的估值方法使用價格及其他涉及相同及可資比較資產及負債組別或業務的市場交易產生的其他相關資料、控制權溢價及市場流通性貼現率。於本年度內確認減值虧損約11,300,000港元（二零一九年：65,254,000港元）後，商譽於報告期末的賬面值約為69,525,000港元（二零一九年：80,825,000港元）。現金產出單元（包括商譽）的減值測試詳情載於附註22。

(b) Recoverability of intangible assets

During the year, the management has evaluated the impairment of intangible assets by way of higher of VIU calculation by reference to the discounted cash flows derived from financial budgets approved by the management of the Group or FVLCD with reference to the latest market transactions. If the higher of the VIU or FVLCD is less than the corresponding carrying amounts, an impairment loss may be required.

(i) *Development costs on Computer and Mobile Phone Software*

During the year, the Group reconsidered the recoverability of its internally-generated intangible asset arising from the Group's Computer and Mobile Phone Software development. The projects continue to progress in a very satisfactory manner, and customer reaction has reconfirmed the Group's previous estimates of anticipated revenues from the projects. However, increased competitor activities have caused the Group to reconsider its assumptions regarding future market shares and anticipated margins on these products. Detailed sensitivity analysis has been carried out and the Group is confident that the carrying amount of the asset will be recovered in full, even if returns are reduced. This situation will be closely monitored, and adjustments made in future periods, if future market activity indicates that such adjustments are appropriate.

The carrying amount of development costs on Computer and Mobile Phone Software at 31 December 2020 was approximately HK\$90,762,000 (2019: HK\$81,993,000). No impairment loss (2019: HK\$Nil) was recognised during the year. Details of the impairment review refer to note 23 to the consolidated financial statements.

(i) 電腦及流動電話軟件開發成本

於本年度，本集團重新考慮其電腦及流動電話軟件開發所產生的內部產生無形資產的可收回程度。該項目進展仍然非常理想，客戶已再次肯定本集團先前對該項目預期收益的估計。然而，競爭對手活動加劇導致本集團重新考慮有關產品的未來市場佔有率及預期利潤的假設。本集團已進行詳盡敏感度分析，並深信即使回報可能有所減少，但資產賬面值將可全數收回。本集團將密切審視形勢，當未來市場活動顯示需要作出適當調整時，本集團將於往後期間作出調整。

電腦及流動電話軟件開發成本於二零二零年十二月三十一日的賬面值約為90,762,000港元(二零一九年：81,993,000港元)。於本年度概無確認任何減值虧損(二零一九年：零港元)。有關減值審核的詳情，請參閱綜合財務報表附註23。

(ii) *Customer relationship and computer software*

The management determines whether customer relationship and computer software are impaired requires an estimation of the VIU of the CGU to which the assets are allocated. The VIU calculation requires the management to estimate the future cash flows expected to arise from the CGU and a suitable discount rate to calculate the present value. The carrying amount of customer relationship and computer software at 31 December 2020 were approximately HK\$Nil (2019: HK\$976,000) and HK\$Nil (2019: HK\$Nil) respectively after impairment loss of approximately HK\$425,000 (2019: HK\$Nil) was recognised during the year. Details of the impairment review are provided in note 23 to the consolidated financial statements.

(c) Estimated useful lives of intangible assets

The estimated useful lives of intangible assets reflect management's estimation on the Group's intention to derive future economic benefits from the intangible assets. The management performs annual reviews of whether the assumptions made of useful lives continue to be valid. When useful lives of intangible assets are different from those previously estimated, the amortisation charges for future periods will be adjusted accordingly.

The carrying amount of intangible assets as at 31 December 2020 was approximately HK\$90,762,000 (2019: HK\$82,969,000).

(d) Impairment of property, plant and equipment and right-of-use assets

Property, plant and equipment and right-of-use assets are stated at costs less accumulated depreciation and impairment, if any. In determining whether an asset is impaired, the Group has to exercise judgment and make estimation, particularly in assessing: (i) whether an event has occurred or any indicators that may affect the asset value; (ii) whether the carrying value of an asset can be supported by the recoverable amount, in the case of value in use, the net present value of future cash flows which are estimated based upon the continued use of the asset; and (iii) the appropriate key assumptions to be applied in estimating the recoverable amounts including cash flow projections and an appropriate discount rate. When it is not possible to estimate the recoverable amount of an individual asset (including right-of-use assets), the Group estimates the recoverable amount of the cash-generating unit to which the assets belongs. Changing the assumptions and estimates, including the discount rates or the growth rate in the cash flow projections, could materially affect the net present value used in the impairment test.

The carrying amount of property, plant and equipment and right-of-use assets as at 31 December 2020 were approximately HK\$1,168,000 (2019: HK\$1,591,000) and HK\$1,684,000 (2019: HK\$1,883,000) respectively.

The Group uses its judgement to select and consider information from a variety of sources and make assumptions that are mainly based on market conditions existing at the end of each reporting period. Changes in these estimates and assumptions could have a material effect on the fair value of the financial assets at FVTOCI and financial assets at FVTPL.

The carrying amount of financial assets at FVTOCI and financial assets at FVTPL that are not traded in an active market and securities that are traded in the Stock Exchange but imposed special conditions on shareholders at the end of the reporting period were approximately HK\$1,135,000 (2019: HK\$1,040,000) and approximately HK\$4,731,000 (2019: HK\$32,536,000) respectively.

(f) Impairment of trade receivables and contract assets

The management of the Group estimates the amount of impairment loss for ECL on trade receivables and contract assets based on the credit risk of trade receivables and contract assets. The amount of the impairment loss based on ECL model is measured as the difference between all contractual cash flows that are due to the Group in accordance with the contract and all the cash flows that the Group expects to receive, discounted at the effective interest rate determined at initial recognition. Where the future cash flows are less than expected, or being revised downward due to changes in facts and circumstances, a material impairment loss may arise.

As at 31 December 2020, the carrying amount of trade receivables and contract assets is approximately HK\$21,627,000 (net of allowance for doubtful debts of approximately HK\$4,757,000) (2019: HK\$65,563,000 (net of allowance for doubtful debts of approximately HK\$1,184,000)).

(f) 貿易應收賬款及合約資產之減值

本集團管理層按貿易應收賬款及合約資產的信貨風險估計貿易應收賬款及合約資產的預期信貸虧損的減值虧損金額。根據預期信貸虧損模式計算的減值虧損金額按照根據合約應付本集團的所有合約現金流量與本集團預期收到的所有現金流量之間的差額計算，並按於初始確認時釐定的實際利率貼現。倘未來現金流量低於預期，或因事實及情況變化而下調，則可產生重大減值虧損。

(g) Income taxes

The Group is subject to income taxes in various jurisdictions. Significant estimates are required in determining the worldwide provision for income taxes. There are many transactions and calculations for which the ultimate tax determination is uncertain during the ordinary course of business. The Group recognised liabilities for anticipated tax issues based on estimates of whether additional taxes will be due. Where the final tax outcome of these matters is different from the amounts that were initially recorded, such differences will impact the income tax and deferred tax provisions in the period in which such determination is made.

During the year, approximately HK\$3,870,000 (2019: HK\$3,894,000) of income tax was charged to profit or loss based on the estimated profit.

(h) Revenue and profit recognition

As explained in policy note 4(j), revenue from CMS services are recognised over time. Such revenue and profit recognition on uncompleted projects is dependent on estimating the total outcome of the contract, as well as the work done to date. Based on the Group's recent experience and the nature of the CMS activities undertaken by the Group, the Group has made estimates of the point at which it considered the work was sufficiently advanced such that the outcome of the contract can be reasonably measured. Until this point is reached the related contract assets disclosed in note 29 do not include profit which the Group might eventually realise from the work done to date. In addition, actual outcomes in terms of total cost or revenue may be higher or lower than estimated at the end of the reporting period, which would affect the revenue and profit recognised in future years as an adjustment to the amounts recorded to date.

During the year, approximately HK\$4,250,000 (2019: HK\$3,828,000) of revenue from CMS services was recognised.

(g) 所得稅

本集團須繳納多個司法權區的所得稅。於釐定全球各地的所得稅撥備時須作出重大估計。於日常業務過程中，有許多交易及計算均難以釐定最終稅項。本集團按照額外稅項是否到期的估計，就預期稅務事宜確認負債。倘此等事宜的最終稅項有別於初步記錄的金額，則有關差額對釐定有關期間的所得稅及遞延稅項撥備構成影響。

於本年度，約3,870,000港元（二零一九年：3,894,000港元）所得稅已基於估計溢利自損益扣除。

(h) 收益及溢利確認

誠如政策附註4(j)闡釋，企業管理解決方案服務收益可於一段時間內確認。有關未完成項目確認的收益及溢利取決於合約估計總成果以及目前的工作進度。根據本集團近期的經驗及本集團所承接企業管理解決方案活動的性質，本集團於其認為工作進度足以合理地計量合約成果時作出估計。在達到這一點之前，附註29中披露的相關合約資產不包括本集團最終可能從迄今已完成工作中獲得的利潤。此外，以總成本或收入計算，實際結果可能較報告期間末所估計者為高或低，從而影響未來年度確認的收入及溢利（作為對目前所記錄金額的調整）。

(i) Business model assessment

Classification and measurement of financial assets depends on the results of the solely payments of principal and interest and the business model test. The Group determines the business model at a level that reflects how groups of financial assets are managed together to achieve a particular business objective. This assessment includes judgement reflecting all relevant evidence including how the performance of the assets is evaluated and their performance measured, the risks that affect the performance of the assets and how these are managed and how the managers of the assets are compensated. The Group monitors financial assets measured at amortised cost or financial assets at FVTOCI that are derecognised prior to their maturity to understand the reason for their disposal and whether the reasons are consistent with the objective of the business for which the asset was held. Monitoring is part of the Group's continuous assessment of whether the business model for which the remaining financial assets are held continues to be appropriate and if it is not appropriate whether there has been a change in business model and so a prospective change to the classification of those assets. No such changes were required during the periods presented.

6. FINANCIAL RISK MANAGEMENT

The Group's activities expose it to a variety of financial risks: foreign currency risk, price risk, credit risk, liquidity risk and interest rate risk. The Group's overall risk management programme focuses on the unpredictability of financial markets and seeks to minimise potential adverse effects on the Group's financial performance.

(a) Foreign currency risk

The Group has minimal exposure to foreign currency risk as most of its business transactions, assets and liabilities are principally denominated in the functional currencies of the Group entities and United States dollars ("US\$"). The Group currently does not have a foreign currency hedging policy in respect of foreign currency transactions, assets and liabilities. The Group monitors its foreign currency exposure closely and will consider hedging significant foreign currency exposure should the need arise.

The effect of the strengthened or weakened of Hong Kong dollars against US\$ on the loss after tax is not significant.

(i) 業務模式評估

金融資產的分類和計量取決於純粹本金及利息之償付及業務模式測試的結果。本集團按反映金融資產組合如何一併管理以實現特定業務目標的層面釐定業務模式。該評估涉及反映所有相關證據的判斷，包括如何評估並計量資產表現，影響資產表現的風險及如何對其進行管理，以及資產管理人獲得何等報酬。本集團監控按攤銷成本計量或透過其他全面收益以公平價值列賬的金融資產於到期日前終止確認的情況，以理解出售原因，以及其原因是否符合持有資產的業務目標。監控是本集團持續評估持有餘下金融資產的業務模式是否仍然適用的一部分，以及如果不再適用，是否需要更改其業務模式且相應改變其資產的分類。於呈列期間毋須作出有關更改。

6. 財務風險管理

本集團業務使其面對各種財務風險：外幣風險、價格風險、信貸風險、流動資金風險及利率風險。本集團的整體風險管理計劃專注於金融市場不可預測的特性，務求將對本集團財務表現帶來的潛在不利影響減至最低。

(a) 外幣風險

本集團大部分業務交易、資產及負債主要以本集團實體的功能貨幣及美元（「美元」）為單位，故本集團承受輕微外幣風險。本集團目前並無就外幣交易、資產及負債設有外幣對沖政策。本集團將密切監察其外幣風險，並於有需要時考慮對沖重大外幣風險。

港元兌美元升值或貶值對除稅後虧損的影響並不重大。

(b) Price risk

The Group's financial assets at FVTOCI and financial assets at FVTPL are measured at fair value. Therefore, the Group is exposed to equity security price risk due to the fluctuation of share prices of financial assets at FVTOCI and financial assets at FVTPL. The directors review the exposure to the equity security price risk on the financial assets at FVTOCI and financial assets at FVTPL regularly.

If the share prices of the financial assets at FVTOCI and financial assets at FVTPL increase/decrease by 10% (2019: 10%), the other comprehensive income and loss after tax for the year would have been approximately HK\$114,000 higher/lower (2019: HK\$104,000 lower/higher) and approximately HK\$1,028,000 (2019: HK\$2,717,000) lower/higher respectively, arising as a result of the fair value gain/loss of the financial assets at FVTOCI and financial assets at FVTPL respectively.

At 31 December 2020, the Group had concentration of equity security price risk on one (2019: one) of its listed equity securities investments which is classified as financial assets at FVTOCI accounted for 100% (2019: 100%) of its financial assets at FVTOCI and one (2019: one) of its listed investments which is classified as financial assets at FVTPL accounted for 62% (2019: 88%) of its financial assets at FVTPL as at 31 December 2020.

(b) 價格風險

本集團透過其他全面收益以公平價值列賬的金融資產及透過損益以公平價值列賬的金融資產均按公平價值計量。因此，本集團承受股本證券價格風險，原因為透過其他全面收益以公平價值列賬的金融資產及透過損益以公平價值列賬的金融資產的股價波動。董事定期審閱透過其他全面收益以公平價值列賬的金融資產及透過損益以公平價值列賬的金融資產所帶來的股本證券價格風險。

倘透過其他全面收益以公平價值列賬的金融資產及透過損益以公平價值列賬的金融資產的股價上升/下跌10% (二零一九年：10%)，則本年度其他全面收益及除稅後虧損將分別因透過其他全面收益以公平價值列賬的金融資產及透過損益以公平價值列賬的金融資產的公平價值收益/虧損而分別增加/減少約114,000港元 (二零一九年：減少/增加104,000港元) 以及減少/增加約1,028,000港元 (二零一九年：2,717,000港元)。

(c) Credit risk

Credit risk is the risk that a counterparty will not meet its obligations under a financial instrument or customer contract, leading to a financial loss. The Group is exposed to credit risk from its operating activities (primarily trade and other receivables) and from its financing activities, including deposits with banks and financial institutions and other financial instruments. The Group's credit risk is primarily attributable to trade and other receivables, contract assets, pledged bank deposits, cash and cash equivalents and financial assets at amortised cost. Management has a credit policy in place and the exposures to these credit risks are monitored on an ongoing basis.

The credit risk on bank deposits is limited because the counterparties are banks with high credit ratings.

The credit risk on amounts due from brokers is limited because the counterparties are well-established securities broker firms in Hong Kong.

Trade receivables and contract assets

Customer credit risk is managed by each business unit subject to the Group's established policy, procedures and control relating to customer credit risk management. Individual credit evaluations are performed on all customers and service providers, requiring credit over a certain amount. These evaluations focus on the customers' and service providers' past history of making payments when due and current ability to pay, and take into account information specific to the customer and service provider as well as pertaining to the economic environment in which the customer and service provider operate. Trade receivables are due within 90 days from date of billings negotiated on a case-by-case basis. Normally the Group does not obtain collateral from customers. The directors are of the opinion that no further provision for uncollectible receivables is required in the consolidated financial statements. Normally, the Group does not obtain collateral or guarantee from customers and service providers.

(c) 信貸風險

信貸風險指對方無法履行金融工具或客戶合約項下責任而引致金融損失的風險。本集團面臨來自其經營活動（主要為貿易及其他應收款項）及其融資活動（包括銀行及金融機構存款及其他金融工具）的信貸風險。本集團的信貸風險主要來自貿易及其他應收款項、合約資產、已抵押銀行存款、現金及現金等價物以及按攤銷成本計量的金融資產。管理層訂有信貸政策，會持續監控所承受的信貸風險。

銀行存款的信貸風險有限，乃由於對方為擁有高信用評級的銀行。

應收經紀款項的信貸風險有限，乃由於對方為香港業務發展成熟的證券經紀公司。

貿易應收款項及合約資產

At 31 December 2020, the Group had certain concentration of credit risk as 30% (2019: 28%) of the trade receivables was due from the Group's largest debtor.

The Group measures loss allowances for trade receivables and contract assets at an amount equal to lifetime ECL which is calculated using a provision matrix on individual segment. As the Group's historical credit loss experience does not indicate significantly different loss patterns for different customer and services provider segments, the loss allowance based on past due status is not further distinguished between the Group's different customer and service provider bases. The ECL on trade receivables and contracts assets are estimated using a simplified method. The Group has assessed that the ECL for trade receivables and contract assets based on individually significant customer and service provider or ageing of customers and service providers collectively that are not individually significant. According to different segments of the Group which include the following:

- Provision of corporate management solutions and I.T. contract services ("Corporate Management Solutions and I.T. Contract Services Business")

Expected loss rates are based on actual loss experience over the past two years. These rates are adjusted to reflect differences between economic conditions during the period over which the historical data has been collected, current conditions and the Group's view of economic conditions over the expected lives of the receivables.

No loss allowance was provided for contract assets as at 31 December 2020 as no contracts assets recognised in the consolidated financial statements upon disposal of e-Perfect IT. As at 31 December 2019, expected loss rate for contract assets was assessed to be 0.3% and the loss allowance provision for contract assets was amounted to approximately HK\$5,000.

Loss allowances for contract assets are always measured at an amount equal to lifetime ECL. ECL on these financial assets are estimated using a provision matrix based on the Group's historical credit loss experience, adjusted for factors that are specific to the customers and an assessment of both the current and forecast general economic conditions at the reporting date.

Other financial assets at amortised cost

Other financial assets at amortised cost include loan receivable from Jun Yang Energy Holdings Limited ("Jun Yang Energy"), other receivable from Fragrant River Entertainment Culture (Holdings) Limited ("Fragrant River"), amounts due from non-controlling interests of a subsidiary and other miscellaneous receivables.

For loan receivable from Jun Yang Energy of HK\$27,230,000 (note 27(f)) and other receivable from Fragrant River of HK\$20,400,000 (note 27(d)), the management performed assessment on the recoverability of the outstanding balance periodically.

The Group had assessed lifetime ECL on the loan receivable from Jun Yang Energy following the significant deterioration in the operating results of Jun Yang Energy during the year ended 31 December 2018 which lead to a significant increase in credit risk. Lifetime expected credit loss allowance for the loan receivable from Jun Yang Energy of HK\$27,230,000 was recognised in full during the year ended 31 December 2018 as the management assessed the ECL to be 100%. The management has reassessed the lifetime ECL of loan from Jun Yang Energy, no reversal on the allowance for the years ended 31 December 2020 and 2019.

繼君陽能源於截至二零一八年十二月三十一日止年度的經營業績顯著惡化，導致信貸風險大幅增加後，本集團已評估應收君陽能源貸款的整個存續期預期信貸虧損。由於管理層評估得出的預期信貸虧損為100%，因此於截至二零一八年十二月三十一日止年度已就應收君陽能源貸款全數確認整個存續期的預期信貸虧損撥備為27,230,000港元。管理層已重新評估君陽能源貸款整個存續期的預期信貸虧損，於截至二零二零年及二零一九年十二月三十一日止兩個年度概無撥回撥備。

For other receivable from Fragrant River, the Group had assessed lifetime ECL following the default in payment from Fragrant River during the year ended 31 December 2018 which lead to a significant increase in credit risk. The lifetime ECL as at 31 December 2019 and 2018 were assessed based on the valuation performed by an independent professional valuer using probability-weighted method. Lifetime expected credit loss allowance of approximately HK\$1,246,000 and HK\$12,200,000 were recognised during the years ended 31 December 2019 and 2018 respectively in accordance with the valuation report. The lifetime ECL mainly caused by the increase of estimated legal fee to be incurred in the AP Acquisition Litigation (as defined in note 43(a)) for the year ended 31 December 2019 and the significant increase of credit risk for the year ended 31 December 2018.

The management reassessed the lifetime ECL as at 31 December 2020 by reference with the status of the AP Acquisition Litigation (as defined in note 43(a)), additional lifetime expected credit loss allowance of approximately HK\$3,954,000 was recognised for the year ended 31 December 2020.

For amounts due from non-controlling interests of a subsidiary, the management makes periodic collective assessments as well as individual assessment on the recoverability of the receivables. The Group has assessed that the ECL for these receivables are not material under the 12-month expected credit losses method. Thus no loss allowance provision was recognised during the years ended 31 December 2020 and 2019.

Impairment test for cash-generating units containing goodwill

In accordance with Hong Kong Accounting Standard 36 Impairment of Assets, a CGU to which goodwill has been allocated shall be tested for impairment annually, and whenever there is an indication that the CGU may be impaired, by comparing the carrying amount of the CGU, including goodwill, with the recoverable amount of the CGU.

In addition to goodwill, property, plant and equipment, right-of-use assets and intangible assets that generate cash flows together with the related goodwill are also included in the respective CGU for the purpose of impairment assessment.

The recoverable amounts of the CGU are the higher of the VIU and the FVLCD.

(a) CGU of Boom Max Group

The Group determined the recoverable amounts of the Boom Max Group's CGUs on the basis of their VIU (2019: VIU) using discounted cash flow method. The key assumptions for the discounted cash flow method are consistent with last year which are those regarding the discount rates, growth rates and budgeted gross margin and revenue during the year. The Group estimates discount rates using pre-tax rates that reflect current market assessments of the time value of money and the risks specific to the CGUs. The growth rates are based on long-term average economic growth rate of the geographical area in which the businesses of the CGUs operate. Budgeted gross margin and revenue are based on past performance and expectations on market development.

For the purpose of impairment testing, the Group prepared cash flow forecasts derived from the most recent financial budgets approved by the directors for the next five years with the residual period using the growth rates as stated below. These rates do not exceed the average long-term growth rates for the relevant markets.

The Group engaged Ascent Partners Valuation Service Limited ("Ascent Partners"), an independent professional valuer, to determine the recoverable amount of the CGU of the Software Business as at 31 December 2020 and 31 December 2019.

本集團採用貼現現金流量法按其使用價值（二零一九年：使用價值）釐定Boom Max集團現金產出單元的可收回金額。貼現現金流量法的主要假設與去年一致，乃與年內的貼現率、增長率以及預算毛利率及收入有關。本集團採用除稅前比率估計貼現率，該除稅前比率反映現金產出單元的貨幣時值及特定風險的現時市場評估。增長率乃根據現金產出單元業務經營所在地區的長期平均經濟增長率計算。預算毛利率及收入乃基於過去表現及市場發展預期計算。

就減值測試而言，本集團編製的現金流量預測乃按最近由董事批准的未來五年財務預算以及餘下期間採用的下述增長率計算。該等比率並未超逾有關市場的平均長期增長率。

本集團已委聘獨立專業估值師艾升評估諮詢有限公司（「艾升」）釐定軟件業務的現金產出單元於二零二零年十二月三十一日及二零一九年十二月三十一日的可收回金額。

As at 31 December 2020, with reference to the assessment by Ascent Partners, the recoverable amount of the CGU of Boom Max Group is valued to approximately HK\$127,455,000. As the recoverable amount of the CGU of Boom Max Group exceeded its carrying value, no impairment was required.

At 31 December 2019, with reference to the assessment by Ascent Partners, the recoverable amount of the CGU of Boom Max Group attributable to the Group was valued to approximately HK\$117,845,000, which was lower than the carrying amount of this CGU attributable to the Group by approximately HK\$65,000,000 due to various factors including the slower-than-expected development pace in the Asian market, the volatility of the global economy, the keen market competition in the I.T. market, the decline in the demand for PCs and the growing popularity of free software products. The CGU had been reduced to its recoverable amount and the Group recognised an impairment loss on goodwill of approximately HK\$65,000,000 at 31 December 2019 which was included in other gains and losses.

(b) CGU of e-Perfect IT

During the year ended 31 December 2020, the Group disposed of its entire interest in e-Perfect IT to a director of e-Perfect IT at a consideration of HK\$1. The transaction was completed on 31 December 2020. The carrying amount of goodwill in respect of CGU of e-Perfect IT was derecognised accordingly. Please refer to note 39(a) to the consolidated financial statements for details.

As at 31 December 2018, the carrying amount of e-Perfect IT's CGU was fully impaired. The recoverable amount of e-Perfect IT's CGU was determined based on FVLCD. The Group engaged Ascent Partners, an independent professional valuer, to determine the recoverable amount of e-Perfect IT's CGU as at 31 December 2018 by adopting asset-based approach as cash flows from operations were expected to be minimal. The decline in the performance of this CGU was primarily attributable to the decrease in the number of sizeable project contracts compared with 2017 and keen competition in the I.T. market. In view of the deteriorating financial performance of CGU of e-Perfect IT, the Group considered not to invest further resources to e-Perfect IT.

(c) CGU of Wafer HK

The Group determined the recoverable amount of Wafer HK's CGU based on FVLCD (2019: FVLCD). In determining the FVLCD of the CGU, management has adopted market approach (level 3 fair value measurements), which has adopted price to sales multiple and enterprise value to sales multiple in the valuation. Several companies with business scopes and operations similar to those of Wafer HK were adopted as comparable companies. The comparable companies were selected mainly with reference to the following selection criteria:

- (i) the comparable companies selected are principally engaged in Corporate Management Solutions and I.T. Contract Services Business in Hong Kong;
- (ii) the companies have sufficient listing and operating histories;
- (iii) the financial information of the companies is available to the public; and
- (iv) the share price of the comparable companies is available in the Stock Exchange.

During the year, the directors noted that the financial performance of Wafer HK did not pick up as expected and had further declined. In view of the decrease in revenue of Wafer HK for the six months ended 30 June 2020 to approximately HK\$9,827,000 as compared to that of approximately HK\$21,328,000 for the corresponding period in 2019, the directors considered that this was an indicator of potential impairment on the carrying amount of the goodwill of Wafer HK. Accordingly, the Company appointed Ascent Partners in assisting on the valuation of the CGU in relation to Wafer HK as at 30 June 2020 ("June 2020 Valuation"). The recoverable amount of the CGU of Wafer HK as at 30 June 2020 attributable to the Group was approximately HK\$11,635,000 which is lower than the carrying amount of this CGU attributable to the Group by approximately HK\$11,269,000. The CGU of Wafer HK has been reduced to its recoverable amount and an impairment loss of approximately HK\$11,300,000 was recognised on goodwill. The impairment loss was included in other gains and losses. Details of the impairment testing of the CGU of Wafer HK as at 30 June 2020 are set out in the Company's interim report dated 12 August 2020.

As at 31 December 2020, the management reappointed Ascent Partners in assisting to re-assess the recoverable amount of CGU of Wafer HK with the same major assumptions and/or basis as adopted in June 2020 Valuation. The recoverable amount of this CGU attributable to the Group is valued to approximately HK\$12,466,000 which is higher than the carrying amount of this CGU. The directors considered that no further impairment loss is required.

At 31 December 2019, with reference to the assessment by Ascent Partners, the recoverable amount of the CGU of Wafer HK attributable to the Group was approximately HK\$22,675,000, which was lower than the carrying amount of this CGU attributable to the Group by approximately HK\$254,000, as a result of the uncertain market conditions and fierce competition in the market. The carrying amount of the CGU had been reduced to its recoverable amount and the Group recognised an impairment loss of approximately HK\$254,000 on goodwill during the year ended 31 December 2019.

於二零一九年十二月三十一日，經參考艾升作出的評估後，本集團應佔威發香港現金產出單元的可收回金額約為22,675,000港元，較本集團應佔該現金產出單元賬面值低約254,000港元，乃由於市況不穩定及市場競爭激烈。於截至二零一九年十二月三十一日止年度，現金產出單元的賬面值已減至其可收回金額，而本集團已確認商譽減值虧損約254,000港元。

- (a) The capitalised development costs for the years ended 31 December 2020 and 2019 represented the expenditure incurred for developing computer and mobile phone software.

The average remaining amortisation period of the computer and mobile phone software is four years (2019: four years).

The Group carried out reviews of the recoverable amount of its development costs on computer and mobile phone software as at 31 December 2020 and 2019, having regard to the market conditions of the Group's products. These assets were used in the Group's Software Business segment. The management is of the view that the carrying amount of intangible assets as at 31 December 2020 could be supported by the future economic benefits. No impairment loss was provided.

- (b) Computer software (the "Software") and the customer relationship (the "Customer Relationship") were acquired through business combination. The Software are used for the development of tailor-made programs to the Group's customers and the Customer Relationship represents certain contractual relationship with its existing customers at the date of acquisition of e-Perfect IT in 2014. These assets are used in the Group's Corporate Management Solutions and I.T. Contract Services Business segment.

The recoverable amounts of the Software and the Customer Relationship are allocated to CGU of Corporate Management Solutions and I.T. Contract Services Business of e-Perfect IT (note 22).

As the economic benefits arising from these intangible assets are totally integrated with the Corporate Management Solutions and I.T. Contract Services Business, these carrying amounts have been taken into consideration for the impairment assessment of goodwill allocated to this segment (note 22).

During the year ended 31 December 2020, the management carried out impairment review on the recoverable amount of e-Perfect IT's CGU and determined an impairment loss of approximately HK\$425,000 (2019: HK\$Nil) was recognised in the profit or loss.

On 31 December 2020, the carrying value of Software and Customer Relationship was derecognised upon the completion of the disposal of e-Perfect IT (note 39(a)).

The Group's primarily objectives when managing capital are to safeguard the Group's ability to continue as a going concern, so that it can continue to provide returns for the shareholders, by pricing products and services commensurately with the level of risk and by securing access to finance at a reasonable cost.

The Group actively and regularly reviews and manages its capital structure to maintain a balance between higher shareholder returns that might be possible with higher levels of borrowings and the advantages and security afforded by a sound capital position, and makes judgement as to the capital structure in light of changes in economic conditions.

The Group and the Company monitor its capital structure on the basis of a debt-to-equity ratio. For this purpose, adjusted net debts is defined as total debts (which includes trade and other payables and amount due to a subsidiary, which is applicable). Equity comprises share capital and reserves.

During 2020, the Group's strategy was to maintain a debt-to-equity ratio at not more than 45% (2019: 45%). In order to maintain or adjust the ratio, the Group may adjust the amount of dividends paid to shareholders, issue new shares, return capital to shareholders, raise new debt financing or sell assets to reduce debts.

38. DEFINED CONTRIBUTION RETIREMENT PLANS

The Group operates a Mandatory Provident Fund Scheme (the “MPF Scheme”) under the Mandatory Provident Fund Schemes Ordinance (Chapter 485 of the Laws of Hong Kong) for employees employed under the jurisdiction of the Hong Kong Employment Ordinance. The MPF Scheme is a defined contribution retirement scheme administered by independent trustees. Under the MPF Scheme, the employer and its employees are each required to make contributions to the scheme at 5% of the employees’ relevant income, subject to a cap of monthly relevant income of HK\$30,000. Contributions to the scheme vest immediately.

The employees of the Group’s subsidiary established in the PRC are members of a central pension scheme operated by the local municipal government. This subsidiary is required to contribute certain percentage of the employees’ basic salaries and wages to the central pension scheme to fund the retirement benefits. The local municipal government undertakes to assume the retirement benefits obligations of all existing and future retired employees of this subsidiary. The only obligation of this subsidiary with respect to the central pension scheme is to meet the required contributions under the scheme.

On 13 June 2016, Lucky Famous, a wholly-owned subsidiary of the Company, entered into a sale and purchase agreement ("SP Agreement") with Fragrant River ("Vendor") and Universe ("Guarantor"), pursuant to which the Group conditionally agreed to acquire, and the Vendor conditionally agreed to sell 51% equity interest of AP Group Investment, at the consideration of HK\$20,400,000, subject to downward adjustments as described below, which shall be settled by way of allotment and issued of 40,800,000 new ordinary shares of the Company, credited as fully paid, at the issue price of HK\$0.50 per share to the Vendor (or its nominee), on the date of completion. The AP Group was principally engaged in the provision of self-improvement and self-enhancement training programmes in Hong Kong. Completion of the Acquisition took place on 1 July 2016.

In accordance with the terms and conditions of the SP Agreement, in the event that the audited consolidated profit after tax of AP Group Investment attributable to its owners from 1 January 2016 to 31 December 2017 (“FY 2016 & 2017”) (which will only include income or gain generated by activities in the ordinary and usual course of business of the AP Group) (“FY 2016 & 2017 Net Profit”) is less than HK\$16,000,000, the Vendor shall, and the Guarantor shall procure the Vendor to, pay to the Lucky Famous (or to its order) an adjustment amount (“Adjustment Amount”) in cash within 14 days after the audited consolidated financial statements of AP Group Investment for FY2016 & 2017 (“FY2016 & 2017 Audited Accounts”) are available. The Adjustment Amount shall be determined in accordance with the formula set out below:

$$A = \text{HK\$}20,400,000 - (\text{NP}/2) \times 5 \times 51\%$$

In accordance with the SP Agreement, the FY2016 & 2017 Net Profit of the AP Group shall be deemed to be zero. Accordingly, the Group had requested the Vendor and the Guarantor to pay the Adjustment Amount of HK\$20,400,000 on or before 26 June 2018 according to the terms and conditions of the SP Agreement. On 22 June 2018, the Group received a letter from the legal adviser acting for the Vendor and the Guarantor that they will defend the purported claim of the Group for the payment of the Adjustment Amount alleged by the Group.

The board (the "Board") considered that the Vendor and the Guarantor have potentially breached their contractual obligations by failing to repay the Group the Adjustment Amount in accordance with the terms and conditions of the SP Agreement. In order to safeguard the legitimate rights and interests of the Group, after seeking legal advice, the Group has commenced legal proceeding ("AP Acquisition Litigation") against the Vendor as the 1st defendant and the Guarantor as the 2nd defendant. A writ of summons with an indorsement of claim were filed by Lucky Famous as plaintiff at the Court of First Instance of the High Court of Hong Kong on 16 July 2018. Based on the writ, the Group claimed against the Vendor and the Guarantor for (a) the Adjustment Amount of HK\$20,400,000; (b) interests; (c) costs; and (d) further and/or other reliefs.

An amended writ of summons with an indorsement of claim were filed at the Court of First Instance of the High Court of Hong Kong on 26 September 2019. Based on the amended writ, the Group claimed against the Vendor and the Guarantor for (a) the Adjustment Amount of HK\$20,400,000; (b) interests; (c) costs; and (d) further and/or other relief, and also against Mr. Chan Sze Long ("Chan") and Ms. Lim Wah Elsa ("Lim") for (e) damages in the sum of HK\$20,400,000; (f) interests; (g) costs; and (h) further and/or other relief (collectively, the "Legal Action"). The Board considered that Chan and Lim, who are the former directors of AP Group Investment until their respective resignations on 18 July 2018, have potentially breached their duties and obligations in contract and tort by failing to, amongst other things, prepare audited consolidated financial statements of AP Group Investment for the year ended 31 December 2015, provide the auditors of AP Group Investment with the written information that they requested to support their audit, and keep and/or preserve adequate accounting records in respect of the transactions entered into by AP Group Investment, its financial position and its financial performance.

董事會 (「董事會」) 認為, 根據買賣協議的條款及條件, 賣方及擔保人因未能向本集團償還調整金額而可能違反彼等合約責任。為保障本集團的合法權益, 於尋求法律意見後, 本集團已向賣方 (作為第一被告人) 及擔保人 (作為第二被告人) 開展法律訴訟 (「愛拼收購訴訟」)。於二零一八年七月十六日, Lucky Famous (作為原告人) 於香港高等法院原訴法庭發出一份傳訊令狀及一份申索背書。根據令狀, 本集團就(a)調整金額20,400,000港元; (b)利息; (c)訟費; 及 (d)進一步及/或其他濟助向賣方及擔保人提出索償。

於二零一九年九月二十六日, 本集團於香港高等法院原訴法庭遞交一份經修訂傳訊令狀及一份申索背書。根據經修訂令狀, 本集團就(a)調整金額20,400,000港元; (b)利息; (c)訟費; 及(d)進一步及/或其他濟助向賣方及擔保人提出索償, 亦就(e)損害合共20,400,000港元; (f)利息; (g)訟費; 及(h)進一步及/或其他濟助向陳思朗先生 (「陳」) 及林樺女士 (「林」) 提出索償 (統稱「法律訴訟」)。董事會認為, 陳及林 (各自於二零一八年七月十八日辭任前擔任愛拼集團控股前任董事) 可能因以下事項而違反合約中彼等之職責及責任及違反侵權法, 其中包括未編製愛拼集團控股截至二零一五年十二月三十一日止年度之經審核綜合財務報表、未向愛拼集團控股核數師提供彼等要求以支持彼等審核之書面資料以及未保存及/或存置有關愛拼集團控股所訂立交易、其財務狀況及其財務表現的充足會計記錄。

(a) AP Acquisition Litigation (continued)

On 1 February 2021, Lucky Famous, the Vendor, the Guarantor, Chan, Lim, Very Easy Limited (“Very Easy”), a company wholly owned by Chan, and City Link Consultancy Limited (“City Link”), a company wholly owned by Lim, without admission of any liability in relation to the Legal Action, had amicably resolved and entered into a settlement agreement (“Settlement Agreement”) in relation to the final and full settlement of the Disputes (as defined below). In accordance with the Settlement Agreement, the parties agreed that (i) the disputes in the Legal Action; and (ii) any other claims and complaint that the parties to the Settlement Agreement may have against each other arising out of or in connection with SP Agreement in respect of the sale and purchase of 510 shares of AP Group Investment entered into by and among the Vendor, Very Easy, City Link, Chan and Lim in 2015 and the SP Agreement (collectively, the “Disputes”) shall be settled in full.

In accordance with the terms of the Settlement Agreement, (i) the Vendor and the Guarantor shall pay to the Group a sum of HK\$1,500,000 at the time of signing of the Settlement Agreement in full and final settlement of the Disputes; (ii) Chan shall pay to the Group a sum of HK\$2,700,000 in full and final settlement of the Disputes, by paying (a) a sum of HK\$1,300,000 at the time of signing of the Settlement Agreement; (b) a sum of HK\$23,500 per month for 59 months starting from 1 March 2021 up to 1 January 2026; and (c) a final sum of HK\$13,500 on or before 1 February 2026; (iii) Lim shall pay to the Group a sum of HK\$1,800,000 in full and final settlement of the Disputes, by paying (a) a sum of HK\$200,000 at the time of signing of the Settlement Agreement; (b) a sum of HK\$26,500 per month for 59 months starting from 1 March 2021 up to 1 January 2026; and (c) a final sum of HK\$36,500 on or before 1 February 2026; and (iv) within 7 days of the date of the Settlement Agreement, Lucky Famous or its legal representatives shall file at the Court of First Instance of the High Court of Hong Kong a consent summons for discontinuing the Legal Action with no order as to costs. The Group shall be entitled as of right to take immediate legal action, including commencing bankruptcy proceedings without further notice if Chan and/or Lim fail(s) to make full and timely payment of any of the instalment(s) under (ii) and (iii) above.

On 16 February 2021, the High Court of Hong Kong granted an order by consent that, amongst others, Lucky Famous would have leave to discontinue the Legal Action against the Vendor, the Guarantor, Chan and Lim.

Details of the AP Acquisition Litigation are set out in the Company’s announcements dated 12 June 2018, 26 June 2018, 16 July 2018, 1 February 2021 and 2 February 2021.

根據和解協議的條款，(i)賣方及擔保人須於簽署和解協議時向本集團悉數支付1,500,000港元以全面及最終解決爭議；(ii)陳須向本集團悉數支付2,700,000港元，具體為(a)於簽署和解協議時支付1,300,000港元；(b)自二零二一年三月一日起至二零二六年一月一日止59個月每月支付23,500港元；及(c)於二零二六年二月一日或之前支付最後一筆款項13,500港元，以全面及最終解決爭議；(iii)林須向本集團悉數支付1,800,000港元，具體為(a)於簽署和解協議時支付200,000港元；(b)自二零二一年三月一日起至二零二六年一月一日止59個月每月支付26,500港元；及(c)於二零二六年二月一日或之前支付最後一筆款項36,500港元，以全面及最終解決爭議；及(iv)和解協議日期後7日內，Lucky Famous或其法定代表須向香港高等法院原訟法庭遞交一份終止法律訴訟之同意傳票，當中並無訟費令。倘陳及/或林未能根據上述第(ii)及第(iii)項及時全額支付任何分期付款，則本集團有權立即採取法律行動 (包括展開破產程序) 而毋須另行通知。

(b) AP Management Litigation

On 26 July 2018, the Company as the 1st plaintiff and AP Group Investment as the 2nd plaintiff, issued a writ of summons in the High Court of Hong Kong against Chan as the 1st defendant and Lim as the 2nd defendant (collectively refer to as the “Defendants”) for the matters as detailed below (“AP Management Litigation”). Chan and Lim are former directors of AP Group Investment until their respective resignations on 18 July 2018. Chan and/or his controlled company, and the controlled company of Lim, are also former directors of the other members of the AP Group at all material times.

The Company is a majority shareholder holding 51% interest in AP Group Investment through its wholly-owned subsidiary, Lucky Famous. As a result of the 51% shareholding in AP Group Investment, all members of the AP Group are subsidiaries of the Company and their financial results have been consolidated into the Group’s consolidated financial statements prior to the deconsolidation of the AP Group becoming effective on 1 April 2018. The AP Group was principally engaged in the provision of self-improvement and self-enhancement training programs in Hong Kong at all material times.

At all material times and during the tenure of office of the Defendants as directors of AP Group Investment, in reliance of the experience and expertise of the Defendants in running the AP Group, it was agreed by the parties that the Defendants were wholly responsible for the efficient and proper management and operation of the AP Group, including but not limited to, the efficient daily operations of the AP Group, keeping proper books and records of the AP Group at all times for inspection by the Group and the provision of weekly cash and bank balance reports, annual budget and monthly financial reports of AP Group Investment, including that of all the subsidiaries of the other members of the AP Group to the Company within 15 days after each month’s end. After the resignations of the Defendants as directors of AP Group Investment on 18 July 2018 and up to the date of this report, the Defendants failed to deliver up all the accounting books and financial records of, and all businesses records in connection with, the running of the AP Group, including but not limited to records in relation to the students’ records, instructors’ records and information on potential litigations, for the period of seven years immediately prior to the date of their resignations as director of AP Group Investment on 18 July 2018 (“Full Business Records”) to the Group.

(b) 愛拼管理人員訴訟

在所有關鍵時間及被告人作為愛拼集團控股董事的任期內，依據被告人營運愛拼集團的經驗及專業知識，訂約方同意由被告人全權負責愛拼集團有效及妥善之管理及營運，包括但不限於愛拼集團之有效日常營運，無論何時均保存愛拼集團適當之賬簿及記錄以供本集團查閱，提供每週現金及銀行結餘報告、年度預算及於各月結日後15天內向本公司提供愛拼集團控股（包括愛拼集團其他成員公司的所有附屬公司）之月度財務報告。於二零一八年七月十八日被告人辭任愛拼集團控股董事後直至本報告日期，被告人未能向本集團提供緊接二零一八年七月十八日被告人辭任愛拼集團控股董事前七年期間所有與愛拼集團營運有關之會計賬簿、財務記錄及所有業務記錄，包括但不限於有關學生記錄、講師記錄及潛在訴訟資料之記錄（「完整商業記錄」）。

In order to safeguard the legitimate rights and interests of the Group, after seeking legal advice, the Group has commenced legal proceeding against the Defendants. The Group claimed against the Defendants for the reliefs, including but not limited to, delivering up of the Full Business Records, accounting for the assets of the AP Group for the period from 1 April 2018 to 18 July 2018 that were in the power, possession or control of the Defendants and damages to be assessed.

On 1 February 2021, Lucky Famous, the Vendor, the Guarantor, Chan, Lim, Very Easy, a company wholly owned by Chan and City Link, a company wholly owned by Lim, without admission of any liability in relation to the Legal Action, had amicably resolved and entered into a Settlement Agreement in relation to the final and full settlement of the Disputes. Details of the Settlement Agreement refer to note 43(a) to the consolidated financial statements.

Details of the AP Management Litigation are set out in the Company's announcement dated 27 July 2018, 1 February 2021 and 2 February 2021.

(c) Perfect Growth Litigation

On 3 July 2018, Perfect Growth, a wholly-owned subsidiary of the Company, received an amended writ of summons ("Amended Writ") with an amended statement of claim ("Amended Statement of Claim") issued in the Court of First Instance of the High Court of Hong Kong by Convoy Global Holdings Limited ("1st Plaintiff"), Convoy Collateral Limited ("2nd Plaintiff") and CSL Securities Limited ("3rd Plaintiff") (1st Plaintiff, 2nd Plaintiff and 3rd Plaintiff collectively referred to as the "Plaintiffs") against, among other defendants, Perfect Growth as the 34th defendant ("Perfect Growth Litigation"). Perfect Growth was joined as one of the defendants by way of the Amended Writ.

Pursuant to the Amended Statement of Claim attached to the Amended Writ, Perfect Growth was named as one of the Alleged Independent Placees (being placees of the placing of shares of the 1st Plaintiff carried out in around October 2015 ("October 2015 Placing")) and was allotted with some shares of the 1st Plaintiff pursuant to the October 2015 Placing.

於二零一八年七月三日，本公司之全資附屬公司肇堅接獲由康宏環球控股有限公司（「第一原告人」）、康宏財務有限公司（「第二原告人」）及康證有限公司（「第三原告人」）（第一原告人、第二原告人及第三原告人統稱為「該等原告人」）入稟香港高等法院原訟法庭向包括肇堅（為第34名被告人）在內的被告人發出之經修訂傳訊令狀（「經修訂令狀」）連同經修訂申索陳述書（「經修訂申索陳述書」）（「肇堅訴訟」）。肇堅因經修訂令狀而被加入成為其中一名被告人。

根據經修訂令狀隨附之經修訂申索陳述書，肇堅被列為聲稱獨立承配人之一（即第一原告人於二零一五年十月前後進行之股份配售（「二零一五年十月配售」）之承配人），並曾根據二零一五年十月配售獲配發第一原告人之若干股份。

In the Perfect Growth Litigation, the reliefs claimed by the Plaintiffs against Perfect Growth are as follows:

- (i) the 1st Plaintiff seeks a declaration and an order as against, among others, Perfect Growth, that the allotment of the 1st Plaintiff's shares to, among others, Perfect Growth pursuant to the October 2015 Placing is null and void, or has been rescinded and be set aside;
- (ii) the 1st Plaintiff seeks an account of profits and an order for payment of any sums found to be due, equitable compensation to be assessed and/or damages to be assessed for dishonest assistance, unlawful means conspiracy and/or lawful means conspiracy as against, among others, Perfect Growth, in relation to, among other matters, the October 2015 Placing and the allotment of the 1st Plaintiff's shares pursuant to the same; and
- (iii) the Plaintiffs seek as against, among others, Perfect Growth (a) general or special damages; (b) interests; (c) costs; (d) further and/or other reliefs.

On 22 November 2018, Perfect Growth filed its defence to the Amended Statement of Claim.

On 3 December 2019, the Plaintiffs filed its reply to Perfect Growth's defence. The Plaintiffs have not, however, filed its reply to each of the other defendants' defence and as such the pleadings of the Perfect Growth Litigation have not been closed yet.

As at 31 December 2020, the carrying values of the shares of the 1st Plaintiff held by the Group were approximately HK\$1,135,000 (2019: HK\$1,040,000) and HK\$800 (2019: HK\$800) included in financial assets at FVTOCI and financial assets at FVTPL respectively.

Details of the Perfect Growth Litigation are set out in the Company's announcement dated 5 July 2018.
