Chapter IV Management Discussion and Analysis **第四章** 管理層討論與分析

4.1 INDUSTRY OVERVIEW

On 24 January 2022, the Ministry of Housing and Urban-Rural Development issued the "14th Five-Year Plan for Promoting the Development of Urban and Rural Development in the Yangtze River Economic Belt", proposing to coordinate the relationship between urban floods and waterlogging, improve the balance system of water storage and drainage, and enhance the capacity of urban flood control and drainage, build a water-saving city and implement regional reclaimed water recycling projects according to local conditions, which provides a good policy guide for the water supply and drainage industry to achieve large-scale utilization of reclaimed water.

On 9 February 2022, the National Development and Reform Commission, the Ministry of Ecology and Environment, the Ministry of Housing and Urban-Rural Development, and the National Health Commission issued the "Guiding Opinions on Accelerating the Construction of Urban Environmental Infrastructure" (the "Opinions"). The Opinions clearly stated the goal that: by 2025, the supply capacity and level of urban environmental infrastructure will be significantly improved, to accelerate the making up for the shortcomings of key areas and key sectors, and to construct of integrated sewage, garbage, solid waste, hazardous waste, medical waste treatment and disposal facilities and an environmental infrastructure system with monitoring and supervision capabilities. The objectives of sewage treatment and resource utilisation by 2025 are to attain new sewage treatment capacity of 20 million cubic meters per day, 80,000 kilometers of new and renovated sewage collection pipelines, new, renovated and expanded reclaimed water production capacity of not less than 15 million cubic meters per day, and the county sewage treatment rate of more than 95%, a utilization rate of wastewater in water-deficient cities at and above prefecture level of more than 25%, and the harmless disposal rate of urban sludge of 90%. By 2030, a modern environmental infrastructure system with complete systems, which is highly efficient, practical, intelligent, green, safe and reliable will be basically established. The Opinions are conducive to promoting the full coverage of urban sewage pipe networks and the "integration of plants and networks" for domestic sewage collection and treatment facilities, which provides a powerful policy guide for the sewage treatment industry in the fields of upgrading and renovation, environmental governance and other areas.

4.1 行業概覽

2022年1月24日,住房和城鄉建設部發佈印發了《「十四五」推動長江經濟帶發展城鄉建設行動方案》,提出協調城市洪澇關係,完善蓄排平衡體系,增強城市防洪排澇能力,建設節水型城市,因地制宜實施區域再生水循環利用工程,為供排水行業實現再生水規模化利用提供了良好的政策嚮導。

2022年2月9日,國家發展改革委、生態環境部、 住房城鄉建設部、國家衛生健康委發佈了《關於加 快推進城鎮環境基礎設施建設的指導意見》(「《意 見》|),《意見》明確指出目標:到2025年,城鎮 環境基礎設施供給能力和水平顯著提升,加快補 齊重點地區、重點領域短板弱項,構建集污水、 垃圾、固體廢物、危險廢物、醫療廢物處理處置 設施和監測監管能力於一體的環境基礎設施體 系。2025年污水處理及資源化利用的目標為:新 增污水處理能力2,000萬立方米/日,新增和改造 污水收集管網8萬公里,新建、改建和擴建再生水 生產能力不少於1.500萬立方米/日,縣城污水處 理率達到95%以上,地級及以上缺水城市污水資 源化利用率超過25%,城市污泥無害化處置率達 到90%。到2030年,基本建立系統完備、高效實 用、智能綠色、安全可靠的現代化環境基礎設施 體系。《意見》有利於推進城鎮污水管網全覆蓋, 推動生活污水收集處理設施「廠網一體化」,這為 污水處理行業在提標改造、環境治理等領域提供 了有力的政策嚮導。

4.2 DEVELOPMENT STRATEGY AND OUTLOOK

In the second half of 2022, the Company will continue to implement the new development concept of "innovation, coordination, greenness, openness and sharing" and seize the opportunity to continue to expand our water supply and drainage business, intelligent water services and related upstream and downstream industrial chains to increase our operating revenue in various aspects, and to effectively reduce production costs through refined management, so as to increase revenue and reduce expenses and ensure sustainable and stable development of the enterprise.

4.2 發展策略及展望

2022年下半年,本公司將持續深入貫撤實施「創新、協調、綠色、開放、共享」的新發展理念,把握機遇,繼續佈局供排水業務、智慧水務及相關上下遊產業鏈,多方位增加營業收入,並通過精細化管理,有效降低生產成本,達到增收節支的目的,確保企業持續穩健發展。

4.3 BUSINESS REVIEW

The Group is an integrated municipal water service provider in Sichuan Province, the PRC, and principally engages in tap water supply and wastewater treatment. We adopt project models of build-own-operate ("BOO"), transferown-operate ("TOO") and build-operate-transfer ("BOT") in the course of business, where we enter into concession agreements with local governments for periods up to 30 years. The Company mainly carries on business in Luzhou City, Weiyuan area in Neijiang City, Leshan City, part of Liangshan Prefecture and Qingbaijiang area in Chengdu City, the PRC, etc.

As at the end of the Reporting Period, we operated 12 tap water plants and 9 city wastewater treatment plants, and one industrial park wastewater treatment plant and six entrusted operation wastewater treatment plants. In addition, we operated several wastewater treatment facilities in urban and rural areas, and our total treatment capacity is approximately 1.277 million tons per day.

4.3 業務回顧

本集團為中國四川省綜合市政水務服務供應商,業務主要包括自來水供應和污水處理。我們在業務中採用建設一擁有一經營(「BOO」)、轉讓一擁有一經營(「TOO」)及建設一經營一轉讓(「BOT」)項目模式,並與地方政府訂立最長期限為30年的特許經營協議。本公司的業務在中國瀘州市、內江市威遠地區、樂山市、涼山州部分地區、成都市青白江地區等區域開展。

於報告期末,我們經營12座自來水廠和9座城市生活污水處理廠,以及1座工業園區污水處理廠及6座委託運營污水處理廠,我們還經營若干個鄉鎮及農村污水處理設施,日總處理能力約為127.7萬噸。

4.3.1 Tap Water Projects

As at the end of the Reporting Period, the Group had 12 tap water plants with a daily water supply capacity of approximately 774,000 tons (excluding emergency back-up water plants). The average utilization rate of tap water plants is 64.6%.

During the Reporting Period, our total water sales volume were approximately 76.5 million tons, representing an increase of 3.8% from approximately 73.7 million tons for the six months ended 30 June 2021. The increase was mainly due to the increase of water consumption in urban areas with the development of urban construction.

4.3.2 Wastewater Treatment Projects

As at the end of the Reporting Period, the Group owned 9 operating city wastewater treatment plants, with a daily treatment capacity of approximately 397,000 tons in aggregate and the average load rate of wastewater treatment plants stood at 94.80%; one industrial park wastewater treatment plant with a daily treatment capacity of approximately 20,000 tons in aggregate; and six entrusted operation wastewater treatment plants with a daily treatment capacity of approximately 32,000 tons in aggregate; a total of 197 wastewater treatment facilities in the townships and rural areas with a daily treatment capacity of approximately 54,000 tons. The daily wastewater treatment capacity remained the same as compared to 31 December 2021.

During the Reporting Period, our total wastewater treatment volume amounted to approximately 74.0 million tons, representing an increase of 12.5% as compared with approximately 65.8 million tons for the six months ended 30 June 2021. Our total volume of wastewater treatment with charges for the Reporting Period amounted to approximately 79.9 million tons (including entrusted operation and emergency projects), this represents an increase of 18.5% from approximately 67.4 million tons for the six months ended 30 June 2021.

4.3.1 自來水項目

於報告期末,本集團擁有12座日供水能力 共約77.4萬噸的自來水廠(不含應急備用水 廠),自來水廠平均利用率為64.6%。

報告期間,我們的售水總量為約76.5百萬噸,較截至2021年6月30日止六個月約73.7 百萬噸上升3.8%。增長原因主要是隨著城市建設發展,城區用水人口增多。

4.3.2 污水處理項目

於報告期末,本集團擁有9座營運中的城市生活污水處理廠,日處理能力約為39.7萬噸,污水處理廠的平均負荷率為94.8%;1座工業園區污水處理廠,日處理能力約2萬噸;及6座委託運營污水處理廠,日處理能力約3.2萬噸;鄉鎮農村污水處理設施共197個,日處理能力約5.4萬噸。污水處理日處理能力與2021年12月31日相比持平。

報告期間,我們的污水處理總量約為74.0百萬噸,較截至2021年6月30日止六個月的約65.8百萬噸的實際處理總量上升12.5%。我們於報告期間的污水收費處理總量約為79.9百萬噸(含受託運營收費水量及應急處理項目收費水量),較截至2021年6月30日止六個月的約67.4百萬噸上升18.5%。

4.4 FINANCIAL REVIEW

4.4.1 Analysis of Key Items in the Income Statement

4.4.1.1 Operating Revenue

During the Reporting Period, operating revenue of the Group amounted to RMB698.1 million, representing an increase of 4.1% from RMB670.5 million for the same period of 2021. The increase was mainly due to the increase in sales volume of tap water and wastewater treatment volume.

4.4.1.1.1 Tap water supply

Sales of tap water

During the Reporting Period, revenue of the Group generated from sales of tap water amounted to RMB182.0 million, representing an increase of 4.4% from RMB174.4 million for the same period of 2021. The increase was mainly due to the increase in sales volume of tap water. Revenue generated from sales of tap water accounted for 26.0% and 26.1% of our total revenue for the six months ended 30 June 2021 and 2022, respectively.

4.4 財務回顧

4.4.1 利潤表主要項目分析

4.4.1.1 營業收入

於報告期內,本集團實現營業收入為 人民幣698.1百萬元,較2021年同期 的人民幣670.5百萬元增加4.1%。增 加原因主要是自來水銷售量和污水處 理量增加。

4.4.1.1.1 自來水供應

自來水銷售

於報告期內,本集團銷售自來水產生的收入為人民幣182.0百萬元,較2021年同期的人民幣174.4百萬元增加4.4%。增加原因主要是自來水銷售量增加。銷售自來水產生的收入分別佔截至2021年及2022年6月30日止六個月總收入的26.0%及26.1%。

Engineering installation

Revenue of the Group generated from installation services amounted to RMB232.3 million, representing a decrease of 7.2% from RMB250.2 million for the same period of 2021. The decrease was mainly due to a decrease in the number of completed projects and meter installations during the Reporting Period as compared to the same period of last year. Revenue generated from installation services accounted for 37.3% and 33.3% of our total revenue for the six months ended 30 June 2021 and 2022, respectively.

44.1.1.2 Wastewater treatment

During the Reporting Period, the revenue of the Group generated from operating services of wastewater treatment amounted to RMB263.9 million, representing an increase of 23.2% from RMB214.2 million for the same period of 2021. The increase was mainly due to an increase in the treatment volume of wastewater. Revenue generated from wastewater treatment operation accounted for 32.0% and 37.9% of our total revenue for the six months ended 30 June 2021 and 2022, respectively.

工程安裝

本集團安裝服務產生的收入為人民幣232.3百萬元,較2021年同期的人民幣250.2百萬元減少7.2%。減少主要原因是報告期內完工項目及戶表安裝較上年同期有所減少。安裝服務產生的收入分別佔截至2021年及2022年6月30日止六個月總收入的37.3%及33.3%。

4.4.1.1.2 污水處理

於報告期內,本集團污水處理營運服務產生的收入為人民幣263.9百萬元,較2021年同期的人民幣214.2百萬元增加23.2%。增加原因主要是污水處理量增加。污水處理營運所得收入分別佔截至2021年及2022年6月30日止六個月總收入的32.0%及37.9%。

4.4.1.2 Operating cost

During the Reporting Period, the Group's operating cost amounted to RMB439.9 million, increased by 15.0% from RMB382.6 million for the same period of 2021. The increase was mainly due to the increase in sales volume of tap water and wastewater treatment volume and an increase in depreciation expenses for new wastewater treatment plants.

4.4.1.2.1 Tap water supply

Sales of tap water

During the Reporting Period, the Group's operating cost of tap water sales amounted to RMB181.7 million, representing an increase of 21.6% from RMB149.4 million for the same period of 2021. The increase was mainly due to the increase in tap water sales and an increase in depreciation expenses for new wastewater treatment plants. Operating cost associated with tap water sales accounted for 39.0% and 41.3% of our total operating cost for the six months ended 30 June 2021 and 2022, respectively.

Engineering installation

During the Reporting Period, the Group's operating cost associated with installation services amounted to RMB96.3 million, representing an increase of 2.8% from RMB93.7 million for the same period of 2021. The increase was mainly due to the upgrade of the Group's water pipeline materials to higher quality stainless steel pipes in order to enhance the quality of water supply. Operating cost associated with installation services accounted for 24.5% and 21.9% of the total operating cost for the six months ended 30 June 2021 and 2022, respectively.

4.4.1.2 營業成本

於報告期內,本集團營業成本為人民幣439.9百萬元,較2021年同期的人民幣382.6百萬元增加15.0%。增加原因主要是自來水銷售量和污水處理量增加及新建水廠折舊費用增加。

4.4.1.2.1 自來水供應

自來水銷售

於報告期內,本集團與自來水銷售相關的營業成本為人民幣181.7百萬元,較2021年同期的人民幣149.4百萬元增加21.6%。增加原因主要是自來水銷售量和新建水廠折舊費用增加。與自來水銷售相關的營業成本分別佔截至2021年及2022年6月30日止六個月總營業成本的39.0%及41.3%。

工程安裝

於報告期內,本集團與安裝服務相關的營業成本為人民幣96.3百萬元,較2021年同期的人民幣93.7百萬元增加2.8%。增加原因主要是為提升供水的質,本集團將供水管道材料升。與安裝服務相關的營業成本分別佔截至2021年及2022年6月30日止六個月總營業成本的24.5%及21.9%。

4.4.1.2.2 Wastewater Treatment

During the Reporting Period, the Group's operating cost from wastewater treatment operating services amounted to RMB146.1 million, representing an increase of 13.2% from RMB129.1 million for the same period of 2021. The increase was mainly due to the increase in wastewater treatment volume. Operating cost from wastewater treatment operating services accounted for 33.7% and 33.2% of the total operating cost for the six months ended 30 June 2021 and 2022, respectively.

4.4.1.3 Gross profit and gross profit margin

As a result of the above, the Group's gross profit amounted to RMB258.2 million during the Reporting Period, representing a decrease of 10.3% from RMB287.8 million for the same period of 2021. Gross profit margin decreased from 42.9% for the same period of 2021 to 37.0% for the Reporting Period which was mainly due to the decreases in gross profit margin from sales of tap water and household meter installation.

4.4.1.2.2 污水處理

於報告期內,本集團污水處理營運服務的營業成本為人民幣146.1百萬元,較2021年同期的人民幣129.1百萬元增加13.2%。增加原因主要是污水處理量增加。污水處理營運服務的營業成本分別佔截至2021年及2022年6月30日止六個月總營業成本的33.7%及33.2%。

4.4.1.3 毛利和毛利率

由於以上原因,報告期內本集團毛利 為人民幣258.2百萬元,較2021年同 期的人民幣287.8百萬元減少10.3%。 毛利率由2021年同期的42.9%減少 至報告期間的37.0%,減少原因主要 是自來水銷售及戶表安裝的毛利率下 降。

4.4.1.3.1 Tap water supply

Sales of tap water

During the Reporting Period, the gross profit of the Group for sales of tap water under tap water supply operations amounted to RMB0.3 million, representing a decrease of 98.7% from RMB25.0 million for the same period of 2021. Its corresponding gross profit margin decreased from 14.3% for the six months ended 30 June 2021 to 0.2% for the Reporting Period. The decrease was mainly due to that the scale effect of the newly constructed water treatment plant has not yet to materialise.

Engineering installation

During the Reporting Period, the gross profit of the Group for installation services amounted to RMB136.0 million, representing a decrease of 13.1% from RMB156.5 million for the same period of 2021. Its corresponding gross profit margin decreased from 62.6% for the same period of 2021 to 58.5% for the Reporting Period. The decrease was mainly due to the upgrade of the Group's water supply pipes to higher quality stainless steel pipes in order to enhance the quality of water supply and the impact of the adjustment of the policy on household meter charges.

4.4.1.3.1 自來水供應

自來水銷售

於報告期內,本集團自來水供應營運下的自來水銷售的毛利為人民幣0.3百萬元,較2021年同期的人民幣25.0百萬元減少98.7%。相應的毛利率由截至2021年6月30日止六個月的14.3%減少至報告期間的0.2%,減少原因主要是新投建水廠規模效應尚未顯現。

工程安裝

於報告期內,本集團安裝服務的毛利為人民幣136.0百萬元,較2021年同期的人民幣156.5百萬元減少13.1%。其相應的毛利率由2021年同期的62.6%減少至報告期間的58.5%。減少原因主要是為提升供水品質,本質更高的不鏽鋼管材及受戶表收費政策調整影響。

44132 Wastewater treatment

During the Reporting Period, the gross profit of the Group for wastewater treatment operating services amounted to RMB117.8 million, increased by 38.4% from RMB85.1 million for the same period of 2021. The corresponding gross profit margin increased from 39.7% for the six months ended 30 June 2021 to 44.6% for the Reporting Period. The increase was mainly due to the increase in the sewage treatment volume and the economies of scale being fully utilised.

44.1.4 Other revenue

During the Reporting Period, the Group's other revenue amounted to RMB45.8 million, representing an increase of 269.4% from RMB12.4 million for the same period of 2021. The increase was mainly due to the receipt of RMB30.9 million subsidy for increased sludge treatment for the period from September 2018 to August 2021 during the Reporting Period.

4.4.1.5 Cost of sales

During the Reporting Period, the Group's cost of sales amounted to RMB12.5 million, representing an increase of 16.8% from RMB10.7 million for the same period of 2021. The increase was mainly due to the increase in staff wages and selling expenses.

4.4.1.6 Management Expenses

During the Reporting Period, the Group's management expenses amounted to RMB45.6 million, which was essentially the same as compared to RMB45.6 million for the same period of 2021.

4.4.1.3.2 污水處理

於報告期內,本集團污水處理營運服務的毛利為人民幣117.8百萬元,較2021年同期的人民幣85.1百萬元增加38.4%。其相應的毛利率由截至2021年6月30日止六個月的39.7%增加至報告期間的44.6%。增加原因主要是污水處理量增加,規模經濟效益得以充分發揮。

4.4.1.4 其他收益

於報告期內,本集團其他收益為人民幣45.8百萬元,較2021年同期的人民幣12.4百萬元增加269.4%。增加原因主要是於報告期內收到2018年9月至2021年8月增量污泥補助款人民幣30.9百萬元。

4.4.1.5 銷售費用

於報告期內,本集團銷售費用為人民幣12.5百萬元,較2021年同期的人民幣10.7百萬元增加16.8%。增加原因主要是人工成本及銷售費用增加。

4.4.1.6 管理費用

於報告期內,本集團管理費用為人民 幣45.6百萬元,與2021年同期的人民 幣45.6百萬元持平。

4.4.1.7 Finance costs

During the Reporting Period, the Group's finance costs amounted to RMB67.1 million, representing an increase of 17.1% from RMB57.3 million for the same period of 2021. The increase was mainly due to the increase in finance costs as the interest previously capitalized was expensed following the fixed assets recognized from water works project.

4.4.1.8 Income tax expense

During the Reporting Period, the Group's income tax expenses amounted to RMB22.8 million, representing a decrease of 1.7% from RMB23.2 million for the same period of 2021. The decrease was mainly due to the impact of deferred income tax. As of 30 June 2021 and 2022, the effective tax rates of the Group were 14.7% and 15.8%, respectively.

44.1.9 Net Profit and Net Profit Margin

Based on the above reasons, the Group's net profit amounted to RMB133.1 million for the Reporting Period, representing an increase of 6.7% from RMB124.8 million for the same period in 2021. Net profit margin increased from 18.6% for the six months ended 30 June 2021 to 19.1% for the Reporting Period.

4.4.2 Analysis of Key Items in the Balance Sheets

4.4.2.1 Accounts receivable

Accounts receivable of the Group were RMB486.1 million and RMB548.8 million as of 31 December 2021 and as at the end of the Reporting Period, respectively. The increase was mainly due to an increase in accounts receivable as a result of the impact of COVID-19 and financial payments.

4.4.1.7 財務費用

於報告期內,本集團財務費用為人民幣67.1百萬元,較2021年同期的人民幣57.3百萬元增加17.1%。增加原因主要是水廠項目轉固後,原資本化的利息予以費用化,致財務費用增加。

4.4.1.8 所得稅費用

於報告期內,本集團所得税費用為人 民幣22.8百萬元,較2021年同期的人 民幣23.2百萬元減少1.7%。減少原因 主要是受遞延所得税影響。截至2021 年及2022年6月30日止,本集團的實 際税率分別為14.7%及15.8%。

4.4.1.9 淨利潤和淨利潤率

由於以上原因,報告期內本集團淨利潤為人民幣133.1百萬元,較2021年同期的人民幣124.8百萬元增加6.7%。淨利潤率由截至2021年6月30日止六個月的18.6%增加至報告期間的19.1%。

4.4.2.3 Other receivables

As of 31 December 2021 and as at the end of the Reporting Period, the Group's other receivables were RMB148.1 million and RMB150.0 million, respectively. The increase was mainly due to an increase in security deposits.

4.4.2.4 Fixed assets

As of 31 December 2021 and as at the end of the Reporting Period, the Group's fixed assets were RMB3,324.8 million and RMB3,251.3 million, respectively. The decrease was mainly due to depreciation charges.

4.4.2.5 Construction in progress

As of 31 December 2021 and as at the end of the Reporting Period, the balance of construction in progress of the Group were RMB318.0 million and RMB421.2 million, respectively. The increase was mainly due to the construction of new sewage treatment facilities and tap water pipelines network.

4.4.2.6 Intangible assets

As of 31 December 2021 and as at the end of the Reporting Period, the Group's intangible assets were RMB1,387.9 million and RMB1,406.5 million, respectively. The increase was mainly due to the acquisition of land use rights for the expansion of the Group's wastewater treatment business.

4.4.2.7 Long-term deferred expenses

As of 31 December 2021 and as at the end of the Reporting Period, the Group's long-term deferred expenses were RMB238.1 million and RMB225.5 million, respectively. The decrease was mainly due to amortisation.

4.4.2.10 Contract liabilities

As of 31 December 2021 and as at the end of the Reporting Period, the Group's contract liabilities were RMB194.0 million and RMB248.5 million, respectively. The increase was mainly due to an increase in receivables from household meter installations.

4.4.2.11 Other payables

As of 31 December 2021 and as at the end of the Reporting Period, the Group's other payables were RMB179.4 million and RMB271.8 million, respectively. The increase was mainly due to an increase in dividends payable and payables to government.

4.4.2.12 Non-current liabilities due within one vear

As of 31 December 2021 and as at the end of the Reporting Period, the Group's non-current liabilities due within one year were RMB927.4 million and RMB422.8 million, respectively. The decrease in liabilities was due to the fact that in April this year, the Company exercised the issuer's option to adjust the coupon rate of the 19 Lu Water 01 Bonds from 5.99% to 3.7% and the investors exercised the resale option for a total amount of RMB395.5 million. As a result of the above, the principle of the 19 Lu Water 01 Bonds will be repaid in one lump sum after two years and therefore it will no longer be accounted for as a non-current liability due within one year. As the 19 Lu Water 02 Bonds will have been matured for 3 years in August this year and therefore no resale was triggered during the Reporting Period, and we still treat it as non-current liability due within one year.

4.4.2.13 Long-term borrowings

As of 31 December 2021 and as at the end of the Reporting Period, the Group's long-term borrowings were RMB1,390.7 million and RMB1,826.7 million, respectively. The increase was mainly due to the replacement of the maturing 2019 Public Issuance of Bonds (Phase I).

4.4.2.10 合同負債

4.4.2.15 Deferred income

As of 31 December 2021 and as at the end of the Reporting Period, the Group's deferred income were RMB268.6 million and RMB256.9 million, respectively. The decrease was mainly due to monthly amortisation of government grants.

4.4.3 Liquidity and Financial Resources

The Group manages its capital to ensure that entities of the Group will be able to continue as a going concern and optimize the debt and equity balance to maximize the return to the Shareholders. The Group's overall strategy remains unchanged during the Reporting Period. The capital structure of the Group consists of net debts (which includes borrowings, net cash and cash equivalents) and total equity (comprising of paid-in capital/share capital, capital reserve, statutory surplus reserve, retained profits and non-controlling interests). The Group is not subject to any externally imposed capital requirements.

As at the end of the Reporting Period, the cash and bank balances of the Group amounted to approximately RMB890.9 million (at the end of 2021: RMB871.7 million).

4.4.2.14 長期應付款

4.4.3 流動資金及財務資源

於報告期末,本集團之現金及銀行結餘約 為人民幣890.9百萬元(2021年末:人民幣 871.7百萬元)。

As at the end of the Reporting Period, the total borrowings of the Group amounted to approximately RMB2,006.8 million (at the end of 2021: RMB1,629.9 million), including bank and other borrowings. Approximately 87.53% of the bank borrowings and other borrowings bore interest at floating rates.

As at the end of the Reporting Period, the net debts to equity ratio of the Group (being calculated by total equity divided by debts (including long-term and short-term loans and bonds payable) less bank balances and cash) was 244.1% (at the end of 2021: 351.0%).

The gearing ratio of the Group (calculated by net debts divided by total assets) increased from approximately 25.3% as at the end of 2021 to approximately 40.2% as at the end of the Reporting Period. The increase was mainly due to the increase in borrowings.

During the Reporting Period, employee salaries and benefits expenses amounted to RMB80.0 million (for the six months ended 30 June 2021: RMB71.4 million). The remunerations and benefits for employees include basic and floating wages, bonuses and staff benefits. The Group endeavours to keep the level of employees' remuneration in line with industry practices and prevailing market conditions, and such remuneration will be determined based on their performance. The Group also provides external and internal training programs for the employees.

4.6 INITIAL PUBLIC OFFERING AND USE OF PROCEEDS FROM THE INITIAL PUBLIC OFFERING

The Company was listed on the Hong Kong Stock Exchange on 31 March 2017, and 214,940,000 H shares of the Company with a value of RMB1.00 each had been issued at the price of HK\$2.30 per share with net proceeds received from the issuance of approximately HK\$400.8 million. As at the end of the Reporting Period, HK\$400.8 million of the proceeds from the IPO had been fully used by the Group in the manner disclosed in the prospectus.

4.7 MAJOR ACQUISITIONS AND DISPOSALS

During the Reporting Period, the Group had no material acquisitions and disposals in respect of subsidiaries, associates and joint ventures.

4.8 PLEDGED ASSETS OF THE GROUP

As at the end of the Reporting Period, the Group had bank borrowings secured by the operating concessions for all water supply projects of the Company in Jiangyang District, the charging right for certain wastewater treatment projects, several buildings and tap water plants of Weiyuan Qingxi Water, and the charging right for wastewater treatment projects of Fanxing Environmental in townships and rural areas in Jiangyang District, Luzhou City.

Save as disclosed above, as at the end of the Reporting Period, the Group had not pledged any other assets.

4.9 FOREIGN EXCHANGE RISKS

During the Reporting Period, the Group carried out business in the PRC and received revenue and paid its costs/ expenses in RMB. As at the end of the Reporting Period, the Group had unutilized monetary funds in Hong Kong dollar, and confirmed that there was no foreign exchange gains during the Reporting Period (and recognised a net foreign exchange gain of approximately RMB52,682.27 in the Reporting Period). The Group does not currently hedge its exposure to foreign currencies.

4.6 首次公開發售及首次公開發售所 得款項用途

4.9 外匯風險

於報告期間,本集團在中國進行業務、收取收入並以人民幣支付成本/開支。於報告期末,本集團有尚未使用的以港元計價的貨幣資金,並確認報告期間未產生外匯收益(並在報告期間確認了外匯收益淨額約為人民幣52,682.27元)。本集團現時並無對沖其外幣敞口。

4.10 CONTINGENT LIABILITIES

During the Reporting Period, in the course of performance of the Cooperation Agreement for Wastewater Treatment Equipment Supply and Installation in the Townships and Rural Areas in Luzhou City entered into between Fanxing Environmental and Sichuan Changjiang Crane Co., Ltd.(四 川長江起重機有限責任公司) ("Changjiang Crane"), dispute related to contract price arose between both parties due to the quality of equipment supplied by Changjiang Crane not meeting contract stipulation. As Changiang Crane has entered into bankrupcy proceedings, the bankruptcy administrator of Changjiang Crane has filed a lawsuit on behalf of Changqi Company in March 2021, seeking payment of RMB42.82 million and liquidated damages of RMB17.15 million, as well as litigation costs from Fanxing Environmental. The case has not yet been concluded as the date of this report.

4.10 或有負債

報告期內,繁星環保與四川長江起重機有限責任公司(「**長起公司**」)就簽訂的《瀘州市鄉鎮和農村污水處理設備供貨及安裝工程合作協議》在履行過程中,因長起公司供應的設備質量不符合合同約定,故雙方就合同價款問題產生爭議。因長起公司已進入破產程序,長起公司破產管理人代長起公司於2021年3月提起訴訟,要求繁星環保支付所欠貨款人民幣42.82百萬元、違約金人民幣17.15百萬元及案件訴訟費,截至本報告日期,該案尚未審結。

4.11 MATERIAL INVESTMENT HELD

As at the end of the Reporting Period, the equity investments held by the Group amounted to approximately RMB55.2 million (at the end of 2021: approximately RMB55.3 million), which mainly represents the Group's equity investment of 12.72% equity interest of Sichuan Xiangjiaba Irrigation Construction and Development Co., Ltd.* (四川省向家壩灌區建設開發有限責任公司) and other unlisted companies in the PRC.

Information on Sichuan Xiangjiaba Irrigation Construction and Development Co., Ltd. is set out in Note 6 to the consolidated financial statements of this report.

In response to the COVID-19 pandemic, the Chinese government took mandatory quarantine measures, and the region where the Company is located was identified as a low-risk region. The Company fully implemented the government's various decisions and arrangements to ensure the safe water supply and wastewater discharge meeting the standards. The Board believes that the COVID-19 pandemic has had basically no impact on the unaudited condensed consolidated financial statements of the Group for the six months ended 30 June 2022.

Non-employee representative Directors of the second session of the Board were reelected and appointed at the extraordinary meeting of the Company convened on 4 March 2022 and the employee representative Director and Supervisors were appointed at the employee representative meeting of the Company held on the same day. For details, please refer to the announcements of the Company dated 26 January 2022 and 4 March 2022.

During the Reporting Period, except for code provision B.2.2 of the Corporate Governance code, the Company has been complied with all code provisions under the Corporate Governance Code. The Board will review the corporate governance practices and operations of the Company from time to time for the purpose of reviewing the relevant requirements under the Listing Rules.

The independent non-executive Directors have reviewed the information provided by Controlling Shareholder regarding compliance with the Non-competition Agreement and determined that Controlling Shareholder had fully complied with and was not in breach of the Non-competition Agreement during the Reporting Period.

Save from the above disclosure, the Company had not been involved in any material legal proceedings nor arbitration, and the Directors are not aware of any legal proceedings or claims of material importance pending or threatened against the Company as at the end of the Reporting Period.

1. BASIC INFORMATION OF THE COMPANY

Beijiao Water Supply Company and Urban Pipe Network Branchand together with its subsidiaries, the "Group") is a wholly state-owned company established by the former Beijiao Water Supply Company and Urban Pipe Network Branch with the approval for reform by the document Lu Shi Fu Han [2002] No. 79 issued by the Luzhou Municipal People's Government. The registered capital of the Company was RMB66.28 million, which was invested by the Luzhou Planning and Construction Bureau as the authorised state-owned asset investor, which was verified by the capital verification report (Chuan Yu Kuai Zheng (2002) no. 080) issued by Sichuan Yulong Certified Public Accountants. It was incorporated with the Administration for Industry and Commerce of Luzhou on 31 July 2002. The unified social credit code of the Company is 91510500204702995Y.

There is no change in the Company's history, registered address and headquarters address, nature of business, principal activities and the controlling shareholder compared to the 2021 annual report prepared by the Group for the year ended December 31, 2021.

2. SCOPE OF CONSOLIDATED FINANCIAL STATEMENTS

The financial statements of the Group for the period covered 18 subsidiaries, including Luzhou Xinglu Wastewater Treatment Co., Ltd., Luzhou Xinghe Water Governance Co., Ltd. and Luzhou Xinglu Water (Group) Hejiang Water Co., Ltd.. For details please refer to 7. change in scope of consolidation and 8. Interests in other entities under this note.

3. BASIS OF PREPARATION OF FINANCIAL STATEMENTS

1. Basis of preparation

The financial statements of the Group are prepared based on going-concern and actual transactions and events according to the Accounting Standards for Business Enterprises and relevant regulations (collectively "Accounting Standard for Business Enterprises"), and the disclosure requirements pursuant to China Securities Regulatory Commission's Compilation Rules for Information Disclosure by Companies Offering Securities to the Public No. 15 - General Provisions on Financial Reports (Revised), and the relevant disclosure required by the "Companies Ordinance" of Hong Kong and the "Listing Rules" of The Stock Exchange of Hong Kong Limited, and prepared based on 4. Major Accounting Policies and Accounting Estimates in this note.

2. Going-concern

The Group is able to continue as a going concern for at least the next 12 months from the end of the Reporting Period, and there is no material matters affecting its operation as a going concern.

4. MAJOR ACCOUNTING POLICIES AND ACCOUNTING ESTIMATES

The accounting policies and accounting estimates developed by the Group according to relevant provisions of accounting standards in combination of characteristics of actual production and operation include business cycle, recognition and measurement of bad debt provision for receivables, fixed assets classification and depreciation methods, amortization of intangible assets, recognition and measurement of incomes, etc.

2. Contingent liabilities arising from pending litigations and arbitration

(1) Litigation Matters in Contract Disputes of Fanxing Environmental

On 19 July 2017, in the course of performance of the Cooperation Agreement for Wastewater Treatment Equipment Supply and Installation in the Townships and Rural Areas in Luzhou City signed between Fanxing Environmental, a subsidiary of the Company and Sichuan Changjiang Engineering Crane Co., Ltd. (四 川長江工程起重機有限責任公司) ("Changqi Company"). The equipment provided by Changgi Company failed to complete the commissioning on time and to meet the production target, and the two parties had repeatedly communicated but failed to reach agreement. On 28 October 2020, China SINOMACH Heavy Industry Corporation, the controlling shareholder of Changqi Company filed a bankruptcy petition with the Luzhou Municipal Intermediate People's Court to liquidate the company due to its inability to pay off its debts as they fall due. On 19 November 2020, the Luzhou Intermediate People's Court ruled that the bankruptcy of Sichuan Changjiang Engineering Crane Co., Ltd. was accepted for liquidation. As Changqi Company has entered into bankruptcy and liquidation, its obligations under the above equipment supply and installation agreement, warranty obligations, after-sales services, financial assessment matters, etc. could no longer be performed and accordingly Fanxing Environmental did not continue to pay the final payment under the agreement.

In March 2021, Changgi Company and its bankruptcy administrator (the "plaintiff") sued Fanxing Environmental on behalf of Changqi Company in the Luzhou Intermediate People's Court with the following claims:

"1. To rule the defendant to pay the plaintiff the sum of RMB42,821,100; 2. to rule the defendant to pay the plaintiff liquidated damages of RMB17,152,580.2; 3. To rule the defendant to bear the costs of the proceedings.

The case has not yet been concluded and the Company's preliminary judgement, in conjunction with the advice of its lawyers, is that the plaintiff has not yet completed its financial assessment of the equipment for which it is suing and cannot determine the final price of the equipment, and therefore is not yet in a position to pay. At the same time, as the equipment provided by the plaintiff did not complete the commissioning on time, it failed to meet the standard and reach production, and has not yet completed the acceptance, the prerequisites for the payment of equipment are not yet available. On the contrary, the equipment provided by the plaintiff had to be repaired and modified in order to achieve the contractual objective of reaching the target and production, and the relevant costs should also be borne by the plaintiff. Therefore, the Company is of the opinion that there is no breach of contract by Fanxing Environmental and it is highly unlikely that the Company will pay liquidated damages.
