## Chairman's Statement 主席報告

Dear Shareholders.

On behalf of the board (the "Board") of directors ("Directors") of NOVA Group Holdings Limited (the "Company"), I am pleased to present the report and the audited consolidated financial statements of the Company and its subsidiaries (collectively, the "Group") for the year ended 30 June 2022 (the "Reporting Year") to all shareholders of the Company.

The Group recorded revenue for the Reporting Year of approximately HK\$112.16 million (2021: approximately HK\$228.07 million), representing a decrease of approximately 50.82% as compared with that for the year ended 30 June 2021 (the "**Prior Year**" or "**2021**"). Loss for the Reporting Year was approximately HK\$122.87 million (2021: approximately HK\$5.45 million), representing an increase of approximately 21.54 times as compared with that for the Prior Year. Total comprehensive expenses for the Reporting Year was approximately HK\$137.00 million (2021: total comprehensive income of approximately HK\$46.54 million).

The coronavirus disease 2019 pandemic is still an ongoing issue and has brought economic and social disruption to the People's Republic of China. The pandemic prevention measures and social distancing policy by the government, especially the city-wide lockdown in Shanghai, have negatively affected the Group's business.

Given the uncertain economic outlook, the Group has suspended the development of the exhibition business, therefore no revenue was generated during the Reporting Year. For the cultural and entertainment business, the Group focused on improving the operational efficiency for customers' need rather than developing new businesses. We believe that as long as we can stay strong with the customers together during this economic downturn, our businesses will get better when the pandemic is kept under control.

Looking forward, the Group will continue to be prudent in managing revenue streams, to save resources as its basic principle and take stringent cost control measures to minimise the possible risk exposure. 各位股東:

本人欣然代表諾發集團控股有限公司(「本公司」)董事(「董事」)會(「董事會」)向本公司全體股東呈列本公司及其附屬公司(統稱「本集團」)截至二零二二年六月三十日止年度(「報告年度」)之報告及經審核綜合財務報表。

本集團錄得於報告年度的收益約為 112,160,000港元(二零二一年:約 228,070,000港元),較截至二零二一年六月 三十日止年度(「去年」或「二零二一年」)減少約50.82%。於報告年度的虧損約 122,870,000港元(二零二一年:約5,450,000港元),與去年相比增加約21.54倍。於報告年度的全面開支總額約137,000,000港元(二零二一年:全面收入總額約46,540,000港元)。

2019冠狀病毒病疫情仍然持續,並為中華人民共和國帶來了經濟及社會混亂。政府的防疫措施及社交距離政策,尤其是上海封城,均對本集團的業務造成負面影響。

鑑於經濟前景不明朗,本集團已暫停發展展覽會業務,因此於報告年度並無產生收益。就文化及娛樂業務而言,本集團專注於提升營運效率以滿足客戶需求,而非開發新業務。我們相信,只要我們能在經濟低迷時期與客戶一同堅守,當疫情受控時,我們的業務將會改善。

展望未來,本集團將繼續審慎管理收益來源,以節約資源為基本原則,並採取嚴格成本控制措施,盡量降低可能承受的風險。

### Management Discussion and Analysis 管理層討論及分析

#### **BUSINESS REVIEW**

Nova Group Holdings Limited (the "Company") and its subsidiaries (collectively, the "Group") is principally engaged in the organisation and sponsorship of exhibitions and events, the operation of cultural and entertainment comprehensive services platform and provision of loan and financing services.

Revenue and segment results of the Group for the year ended 30 June 2022 (the "Reporting Year") and for the year ended 30 June 2021 (the "Prior Year" or "2021") are set out as follows:

#### 業務回顧

諾發集團控股有限公司(「本公司」)及其附屬公司(統稱「本集團」)主要從事籌辦及贊助展覽會及活動、經營文化及娛樂綜合服務平台以及提供貸款及融資服務。

本集團於截至二零二二年六月三十日止年度 (「**報告年度**」)及截至二零二一年六月三十日 止年度(「**去年**」或「二零二一年」)的收益及 分部業績載列如下:

#### **Exhibitions and Events Business**

The exhibition industry continued to suffer from the coronavirus disease 2019 ("COVID-19") pandemic. The Group is on its knees under stringent quarantine control. Under such a prevailing environment, the Group has not launched any exhibition during the Reporting Year and has decided to suspend the exhibition and events business.

No revenue from the exhibitions and events business was recorded for the Reporting Year (2021: approximately HK\$0.12 million). It represented 0% (2021: approximately 0.05%) of the total revenue.

#### 展覽會及活動業務

展覽會行業繼續受2019冠狀病毒病(「COVID-19」)疫情影響。本集團正受到嚴格檢疫管制。在該大環境下,本集團於報告年度並無舉辦任何展覽會,並決定暫停展覽會及活動業務。

展覽會及活動業務於報告年度均無錄得收益 (二零二一年:約120,000港元),佔總收益 的0%(二零二一年:約0.05%)。

#### **BUSINESS REVIEW** (Continued)

#### **Cultural and Entertainment Business**

The overall cultural and entertainment business performance was weak since the outbreak of COVID-19 pandemic. Epidemic prevention measures and social distancing policy introduced by the People's Republic of China ("PRC") government have a significant impact on the industry. The Group has decided to suspend the brand marketing on "PHEBE", "MT" and "U.CLUB" and focus on "DrOscar" only. We might not continue to develop new brands for brand management. We understand from the market that the development of brand management is not a trend nowadays.

Although the business in 諾笛聯盟平台 (transliterated as "NOD Union Platform" or "NOD Union") is weak these years, it is still a core competitive edge of the Group. We believe that it is important to go through the economic difficulties with our NOD Union members together. When the COVID-19 pandemic issue is under control, we will restart the promotion of NOD Union again.

As for the trading business (mainly trading of wine and liquors), we had over a hundred customers, which most of the revenue came from our existing or previous NOD Union members and customers in brand management. The Group discussed and negotiated the cost with distributors during the contract period, and we determine the selling price ourselves in a range of the suggested selling price offered by the distributors. A manageable level of inventory is maintained to lower the inventory risk and the burden of the credit period. The Group will continue to explore new wine distributors to enable us to grow in the industry.

Affected by many factors such as the economic devastation brought by the outbreak of the COVID-19 pandemic, many of our customers experienced significant reductions in revenue, and most of the restaurants and entertainment stores were temporarily closed for a period longer than initially expected. Most of the NOD Union members were forced to cease operation due to the pandemic prevention measures.

Revenue from cultural and entertainment business has decreased by approximately HK\$118.50 million, or approximately 67.59%, from approximately HK\$175.33 million for the Prior Year to approximately HK\$56.83 million for the Reporting Year and the prospect of income is uncertain in the following few years. It represented approximately 50.67% (2021: approximately 76.88%) of the total revenue.

#### 業務回顧(續)

#### 文化及娛樂業務

自COVID-19疫情爆發以來,整體文化及娛樂業務表現疲弱。中華人民共和國(「中國」)政府實施的防疫措施及社交距離政策對行業構成重大打擊。本集團已決定暫停「PHEBE」、「MT」及「U.CLUB」品牌推廣,並僅專注於「DrOscar」。我們可能不會繼續開發新品牌以進行品牌管理。我們從市場上了解到,開發品牌管理並非現今趨勢。

雖然近年諾笛聯盟平台業務疲弱,惟仍然是本集團的核心競爭優勢。我們相信與諾笛聯盟平台成員一同渡過經濟困境乃屬至關重要。當COVID-19疫情問題受控後,我們將再次重啟諾笛聯盟平台的推廣。

就貿易業務(主要是洋酒及酒類貿易)而言, 我們擁有超過一百名客戶,而大部分收 自我們現有或過往的諾笛聯盟平台會員以 品牌管理的客戶。本集團於合約期內與分銷 商討論及磋商成本,我們在分銷商提供的建 議售價範圍內自行釐定售價。維持質明的 存貨水平,以降低存貨風險及信貸期負 在集團將繼續探索新的洋酒分銷商,使我們 能夠在行業中成長。

受COVID-19疫情爆發帶來的經濟受創等諸 多因素影響,我們的大部份客戶的收益遭受 大幅削減,且大部分餐廳及娛樂場所暫時關 閉的時間較初步預期要長。由於防疫措施, 大部分諾笛聯盟平台會員被迫停止營運。

文化及娛樂業務的收益由去年約175,330,000港元減少約118,500,000港元或約67.59%至報告年度約56,830,000港元,有關收入於未來數年的前景並不明朗。其佔總收益約50.67%(二零二一年:約76.88%)。

#### i. Brand management and related services

Providing brand management and related services under the brand names of "PHEBE", "MT", "U.CLUB" and "DrOscar".

#### ii. Promotion and consulting services

Providing product promotion services, systematic entertainment solution and advisory services, including entertainment management consulting, event planning, online marketing; and other ad hoc consultancy services.

#### iii. Trading of goods

Trading of wine and liquor, e-cigarettes and daily supplies to entertainment stores and NOD Union members, which selling wine and liquors represent approximately 99.35% of the trading business.

#### **Financing Business**

Due to the COVID-19 outbreak and the ensuing city-wide lockdown in Shanghai, business operations and cashflows of customers have been negatively affected. In response to the Shanghai government's call to alleviate the operating pressure, and to provide support for the resumption of production and business of, the enterprise, with a view to navigating through challenges amid the COVID-19 pandemic with collective effort, the Group has granted a waiver of three-month interests to those customers located in Shanghai, which is shown as loss on modification of factoring loans of approximately HK\$4.63 million in other gains and losses. As a result of the uncertain environment in cultural and entertainment business, the Group did not sign any new finance lease agreements to control the risk.

The Group has credit policy and loan approval process to minimise credit risks. The interest rate range has been adjusted during the Reporting Year due to the market changes. Compared with the other two segments, the result from our financing business is encouraging, the Group will continue to explore new customer bases.

Revenue from financing business has increased by approximately HK\$2.71 million, or approximately 5.15%, from approximately HK\$52.62 million for the Prior Year to approximately HK\$55.33 million for the Reporting Year. It represented approximately 49.33% (2021: approximately 23.07%) of the total revenue.

The financing business is currently divided into the following components:

#### 融資業務

由於COVID-19的爆發及隨之而來的上海封城,客戶的業務營運及現金流均受到負面影響。為響應上海政府的號召,減輕企業的經營壓力,為企業恢復生產及業務提供支援,以期在COVID-19疫情中群策群力,渡過期內域於上海的客戶授出三個月的利息豁免,並於其他收益及虧損中顯示為修訂保理貸款的虧損約4,630,000港元。由於文化及娛樂業務環境並不明朗,本集團並無簽訂任何新的融資租賃協議以控制風險。

本集團設有信貸政策及貸款審批程序以盡量 減低信貸風險。於報告年度,利率範圍已因 市場變動而作出調整。與其他兩個分部相 較,融資業務的業績令人鼓舞,本集團將繼 續開拓新的客戶群。

融資業務的收益由去年約52,620,000港元增加約2,710,000港元或約5.15%至報告年度約55,330,000港元。其佔總收益約49.33%(二零二一年:約23.07%)。

#### i. Credit factoring

Credit factoring allows customers to free up cash tied up in unpaid invoices. The finance period given to customers ranges from 6 months to 3 years and the finance services allow customers to release up to 80% of the invoice value.

#### ii. Finance leasing

The Group focused on expanding its small and medium-sized leasing from sale and leaseback business and centering on the cultural and entertainment customers. The financing period given to customers ranges from 1.25 to 3 years.

#### iii. Money lending

Providing pledged and non-pledged money lending to individuals to maximise customer value. The financing period given to customers ranges from 6 to 12 months.

#### FINANCIAL REVIEW

During the Reporting Year, the Group has recorded approximately HK\$112.16 million in revenue, representing a decrease of approximately 50.82% as compared with that in the Prior Year of approximately HK\$228.07 million. Operating loss for the Reporting Year was approximately HK\$116.82 million as compared with an operating profit of approximately HK\$56.75 million for the Prior Year. Net loss for the Reporting Year was approximately HK\$122.87 million, representing an increase of approximately 21.54 times as compared with the net loss in the Prior Year of approximately HK\$5.45 million. The increase in net loss was mainly attributable to the impairment loss on goodwill and impairment losses under expected credit loss ("ECL") model, net of reversal.

#### i. 信貸保理

信貸保理使客戶可釋出被未付發票鎖定的現金。 給予客戶的融資期介乎6個月至3年,而融資服 務使客戶可釋出多達80%的發票價值。

#### ii. 融資租賃

本集團專注於拓展中小型售後回租租賃業務,並 以文化和娛樂客戶為主。給予客戶的融資期限介 乎1.25至3年。

#### iii. 放債

向個人提供有質押及無質押放債以將客戶價值最大化。給予客戶的融資期限介乎6至12個月。

#### 財務回顧

於報告年度,本集團錄得收益約112,160,000港元,較去年約228,070,000港元減少約50.82%。報告年度之經營虧損約為116,820,000港元,去年則錄得經營溢利約56,750,000港元。報告年度之淨虧損約為122,870,000港元,較去年淨虧損約5,450,000港元增加約21.54倍。淨虧損增加主要由於商譽減值虧損及預期信貸虧損(「預期信貸虧損」)模式項下之減值虧損(扣除撥回)。

#### Revenue

The revenue has decreased by approximately HK\$115.91 million, or approximately 50.82%, from approximately HK\$228.07 million for the Prior Year to approximately HK\$112.16 million for the Reporting Year. The reduction was mainly attributable to the decrease in the revenue of cultural and entertainment segment of approximately HK\$118.50 million and no revenue from exhibitions and events segment was recorded due to the outbreak of COVID-19 pandemic.

#### 收益

收益由去年約228,070,000港元減少約115,910,000港元或約50.82%至報告年度約112,160,000港元。收益減少主要由於COVID-19疫情爆發導致文化及娛樂分部收益減少約118,500,000港元,而展覽會及活動分部並無錄得收益。

#### Other Gains and Losses

The net other losses has increased by approximately HK\$0.34 million, or approximately 4.55%, from net other losses of approximately HK\$7.47 million for the Prior Year to net other losses of approximately HK\$7.81 million for the Reporting Year.

The Group's loss on financial assets at FVTPL has decreased significantly to approximately HK\$0.80 million, or approximately 95.55% for the Reporting Year (2021: loss of approximately HK\$17.98 million), primarily due to an unrealised loss from an investment in a Hong Kong listed equity security of approximately HK\$13.00 million was recorded for the Prior Year, as trading of its shares has been suspended by the Stock Exchange since 5 May 2021. The fair value was assessed by the directors of the Company (the "Directors") with reference to the professional valuation carried out by Peak Vision Appraisals Limited ("Peak Vision"), an independent qualified professional valuer.

During the Reporting Year, the Group recognised loss on modification of factoring loans of approximately HK\$4.63 million due to the waiver of three-month interests to customers affected by the city-wide lockdown in Shanghai.

#### **Impairment Loss on Goodwill**

During the Reporting Year, the Group recognised impairment loss on goodwill of approximately HK\$111.42 million, of which approximately HK\$81.67 million was for Cheer Sino Group cash-generating unit ("**CGU(s)**") and approximately HK\$29.75 million was for Fortune Selection Group CGU, due to the risk of uncertain developments in the economic condition.

Many of our customers experienced significant reductions in revenue due to the economic devastation brought by the outbreak of COVID-19 pandemic. Most of the restaurants and entertainment stores were temporarily closed for a period longer than initially expected. The prospect of relevant income is uncertain in the following few years. The impairment loss on goodwill arose as a result of the less than satisfactory past and expected performance of the Cheer Sino Group CGU and Fortune Selection Group CGU. Further details of the impairment loss on goodwill are set out in Note 20 of the consolidated financial statements.

#### 其他收益及虧損

其他虧損淨額由去年其他虧損淨額約7,470,000港元增加約340,000港元或約4.55%至報告年度其他虧損淨額約7,810,000港元。

本集團按公平值計入損益之金融資產之虧損於報告年度大幅減少至約800,000港元或約95.55%(二零二一年:虧損約17,980,000港元),主要由於自二零二一年五月五日起被聯交所暫停股份買賣以來,去年錄得於香港上市股權證券之投資之未變現虧損約13,000,000港元。公平值由本公司董事(「董事」)參考由獨立合資格專業估值師湯鋒評估有限公司(「**澋鋒**」)所進行之專業估值後評估得出。

於報告年度,由於受上海封城影響而向客戶豁免三個月利息,本集團確認修訂保理貸款的虧損約4,630,000港元。

#### 商譽減值虧損

於報告年度,由於經濟狀況發展的不確定性 風險,本集團確認商譽之減值虧損約 111,420,000港元,其中約81,670,000港元屬 於華志集團現金產生單位(「**現金產生單位**」) 及約29,750,000港元屬於Fortune Selection 集團現金產生單位。

由於COVID-19疫情爆發導致經濟受創,我們的大部分客戶的收益遭受大幅削減。大部分餐廳及娛樂場所暫時關閉的時間較初步預期要長。有關收入於未來數年的前境並不明朗。華志集團現金產生單位及Fortune Selection集團現金產生單位過往及預期表現未如理想,導致產生商譽減值虧損。商譽減值虧損之進一步詳情載於綜合財務報表附註20。

## Impairment Losses under ECL Model, Net of Reversal

During the Reporting Year, the Group recognised impairment losses under ECL model, net of reversal of approximately HK\$45.63 million. The impairment assessment under ECL model is performed individually or based on a provision matrix. The credit risk has increased significantly as there is a higher risk that a prolonged pandemic could let to increased credit default rates. The ECLs are estimated based on the probability of default and loss given default and are adjusted for forward-looking information that is reasonable and supportable available without undue costs or effort. Further details of the impairment losses under ECL model, net of reversal are set out in Notes 23–27 of the consolidated financial statements.

#### **Selling and Administrative Expenses**

The Group's selling expenses has decreased by approximately HK\$5.66 million, or approximately 38.87%, from approximately HK\$14.56 million for the Prior Year to approximately HK\$8.90 million for the Reporting Year. The Group's administrative expenses has decreased by approximately HK\$18.80 million, or approximately 43.02%, from approximately HK\$43.70 million for the Prior Year to approximately HK\$24.90 million for the Reporting Year. Such decrease was primarily due to the cost control measures taken by the Group.

#### **Operating Loss and Operating Loss Margin**

As a result of the foregoing, the Group's operating loss for the Reporting Year was approximately HK\$116.82 million, as compared with an operating profit of approximately HK\$56.75 million for the Prior Year. The Group had an operating loss margin of approximately 104.15% for the Reporting Year, as compared with an operating profit margin of approximately 24.88% for the Prior Year. The change of operating profit into operating loss was mainly due to the decrease in revenue, increase in impairment loss on goodwill and impairment losses under ECL model, net of reversal led by the outbreak of COVID-19 pandemic.

於報告年度,本集團確認預期信貸虧損模式項下之減值虧損(扣除撥回)約45,630,000港元。本集團按個別或撥備矩陣進行預期信貸虧損模式下之減值評估。由於疫情持續致信貸違約率增加的風險較高,故此信貸與險已大幅增加。預期信貸虧損乃根據違約概率及違約損失率進行估計,並就毋須付出過多成本或努力即可獲得的合理及可靠前瞻性資料作出調整。預期信貸虧損模式項下之財務報表附註23至27。

#### 銷售及行政開支

本集團的銷售開支由去年約14,560,000港元減少約5,660,000港元或約38.87%至報告年度約8,900,000港元。本集團之行政開支從去年約43,700,000港元減少約18,800,000港元或約43.02%至報告年度約24,900,000港元。有關減少主要由於本集團採取成本控制措施。

#### 經營虧損及經營虧損率

由於以上所述,本集團於報告年度之經營虧損約為116,820,000港元,而去年則錄得經營溢利約56,750,000港元。本集團之經營虧損率於報告年度約為104.15%,而去年則錄得經營溢利率約24.88%。從經營溢利轉為經營虧損主要由於COVID-19疫情爆發,導致收益減少,商譽減值虧損及預期信貸虧損模式項下之減值虧損(扣除撥回)增加。

#### **Finance Costs**

The Group's finance costs has decreased by approximately HK\$16.23 million, or approximately 77.07%, from approximately HK\$21.06 million for the Prior Year to approximately HK\$4.83 million for the Reporting Year. Such decrease was mainly due to the redemption of corporate bonds during the Reporting Year and less interest expenses was needed.

# Loss for the Year Attributable to the Owners of the Company

The Group's loss for the year attributable to the owners of the Company has increased by approximately HK\$122.05 million, or approximately 148.84 times, from approximately HK\$0.82 million for the Prior Year to approximately HK\$122.87 million for the Reporting Year.

#### SIGNIFICANT INVESTMENTS

Save as disclosed in this report, the Group did not hold any significant investments during the Reporting Year.

# LIQUIDITY, FINANCIAL RESOURCES AND CAPITAL RESOURCES

As at 30 June 2022, the Group's total current assets and current liabilities were approximately HK\$559.47 million (2021: approximately HK\$569.59 million) and approximately HK\$56.51 million (2021: approximately HK\$95.78 million), respectively, while the current ratio was about 9.90 times (2021: about 5.95 times).

As at 30 June 2022, the Group maintained cash and cash equivalents of approximately HK\$71.76 million (2021: approximately HK\$69.06 million). The cash and cash equivalents of the Group as at 30 June 2022 was mainly denominated in Hong Kong dollars ("HK\$") and Renminbi ("RMB").

Equity securities listed in Hong Kong classified as financial assets at FVTPL with carrying amount of approximately HK\$269,000 are placed in margin accounts of a regulated securities broker. No margin facility was utilised as at 30 June 2022.

#### **Contingent Liabilities**

As at 30 June 2022 and 2021, the Group did not have any material contingent liabilities.

#### **FUTURE PLANS AND PROSPECTS**

The outbreak of the COVID-19 pandemic has forced the Group to review and recalibrate its development strategies and planning based on assessments of the actual and potential impacts of the pandemic. The overdue percentage of trade receivables has increased and most of the factoring and finance lease customers settled their respective payment during the grace period or even later. The credit risk has increased and higher than our expectation.

As the COVID-19 pandemic is still an ongoing issue, the Company believes that the Group's business environment will continue to be challenging under the stress of pandemic prevention and control in the short to medium term, we will continue to monitor the risk factors and re-assess the client's recoverability when needed. As more people joined the COVID-19 vaccination programme, the Company expects the revenue will be improved after the COVID-19 pandemic is under control in the long term.

Looking ahead into the coming year, the Group continues to closely monitor the development of the COVID-19 pandemic and will take all possible and reasonable measures to mitigate the effect on the Group's operation.

The Group manages or operates its business in Hong Kong and the PRC and is exposed to foreign exchange risk arising from various currency exposures, primarily with respect to United States dollars and RMB. The Group has no significant direct exposure to foreign currencies as most of the commercial transactions, assets and liabilities are denominated in a currency same as the functional currency of each entity of the Group and has not employed any financial instruments for hedging purpose.

# **EMPLOYEES AND REMUNERATION POLICY**

As at 30 June 2022, the Group had a total of 96 full-time employees in Hong Kong and the PRC (2021: 97 full-time employees). The remuneration payable to its employees included salaries, discretionary bonus and commissions. Remuneration packages were generally structured according to market situations and individual performance. Apart from the mandatory provident fund and statutory retirement benefits, the Group also provided medical benefits and trainings to its employees. The Company has also adopted a share option scheme as incentive to eligible employees.

Furthermore, the remuneration committee of the Board will review and give recommendations to the Board as to the remuneration packages of the Directors and senior management of the Group with reference to salaries paid by comparable companies, time commitment and responsibilities of the Directors and senior management of the Group.

The total remuneration paid to employees, including the Directors, for the Reporting Year was approximately HK\$18,395,000 (2021: approximately HK\$28,287,000). Remuneration is determined by reference to market terms and the performance, qualification and experience of each individual employee.

There may be other risks and uncertainties which are currently not known to the Group or immaterial but then it turns out to be material in the future.

#### **Operation Risk**

During the Reporting Year, the outbreak of the coronavirus disease 2019 ("COVID-19") pandemic has affected many businesses. Based on the current situation and unpredictable circumstances, the Directors consider the contingency measures implemented by the government will have short-term adverse impact on the Group's operations and it could be materially different from the aforesaid expectation depending on how the situation evolves.

The Group's business and profitability growth during the Reporting Year was affected by the increase in competition in the industry and the volatility and uncertainty of the macroeconomic conditions in Hong Kong and the People's Republic of China (the "**PRC**"). The Group is expected to continue to be affected by the above factors.

#### **Financial Risk**

The details of financial risk management objectives and practices of the Group are set out in Note 5 to the consolidated financial statements of the Group. There may be other risks and uncertainties in addition to those mentioned above which are not known to the Group or which may not be material now but could turn out to be material in the future.

#### PRC Economic, Political and Legal Risk

The Group's business operations are mainly conducted in the PRC and therefore significantly affected by the economic, political and legal developments in the PRC. The PRC government may implement various measures to encourage economic growth, some of the measures may have a negative effect on the Group.

The Group has a team to monitor the development in the PRC to enable the Group to make necessary adjustments to its business strategies. Any material changes that could impact the Group significantly will be reported to the Board for actions.

#### **Environmental Policies and Performance**

The Group is committed to building an environmentally-friendly corporation that pays close attention to conserving natural resources. The Group strives to minimise its impact on the environment by reducing electricity consumption and encouraging recycling of office supplies and double-sided printing. For further details, please refer to the Environmental, Social and Governance Report set out on pages 61 to 103 of this annual report.

The Company may seek to re-comply with code provision A.2.1 (now rearranged as C.2.1) by identifying and appointing a suitable and qualified candidate to the position of the CEO in due course by considering the business needs and developments of the Group.

Except for the above deviations from the CG Code, the Board is of the view that the Company has complied with the CG Code for the Reporting Year.

At the same time, in order to fulfill the requirement of code provision A.2.1 (now rearranged as C.2.1) of the CG Code, the Company is looking for a suitable and qualified candidate to the position of the CEO in due course by considering the business needs and developments of the Group.

### Appointment, Re-election and Removal of Directors

Mr. Deng Zhonglin, as an executive Director, entered into a service agreement dated 14 October 2016 (supplemented by a supplemental service contract dated 14 October 2019) with the Company, pursuant to which Mr. Deng holds office for an initial term of three years commencing on 14 October 2016 and renewable automatically on expiry for successive terms of three years, subject to retirement by rotation and reelection at the annual general meeting of the Company in accordance with the articles of association of the Company (the "Articles of Association").

Mr. Wong Yuk Lun Alan, as an executive Director, entered into a service agreement with the Company with an initial term of three years commencing on 15 July 2020, which may be continued subject to terms and conditions to be mutually agreed by both parties.

The non-executive Director and all independent non-executive Directors have been appointed for an initial term of one year, renewable automatically for successive term of one year each commencing from the next day after the expiry of the then current term appointment. All remuneration paid to executive Directors are covered by respective service contracts and all remuneration paid to the non-executive Director and independent non-executive Directors are covered by respective letters of appointment.

### RISK MANAGEMENT AND INTERNAL CONTROLS

The Board is responsible for establishing and maintaining a sound system of risk management and internal control within the Group and reviewing their effectiveness. However, such system was designed to manage various risks (including ESG risks) of the Group within certain acceptable risk level, rather than to completely eliminate the risk of failure to achieve the business objectives of the Group and can only provide reasonable but not absolute assurance against material misstatement or loss.

The Board delegates their responsibility to the Audit Committee to review the practices of management with respect to risk management and internal control, including the design, implementation and supervision of the risk management and internal control systems, on an annual basis.

During the Reporting Year, the Board through the Audit Committee, conducted an annual review of both the design and implementation effectiveness of the risk management and internal control systems of the Group, covering all material controls, with a view to ensuring that the resources, staff qualifications and experience, training programmes and budget of the Group's accounting, internal audit and financial reporting functions, as well as those relating to the Company's ESG performance and reporting are adequate. In this respect, the Audit Committee communicates any material issues to the Board.

The Board has engaged an external professional service firm to carry out the internal audit function of the Group. Review of the Group's internal controls covered major financial, operational and compliance controls, as well as risk management functions of different systems has been performed on a systematic rotational basis on the risk assessments of the operations and controls. During the risk assessment process, the firm interviewed the relevant personnel and identified the business objectives and significant risks of the Group. A risk management review and internal audit report prepared by the firm which sets out the risks, issues and recommended action plan was presented to the Board for review and endorsement. The Board considered that significant risks of the Group were managed within the acceptable level and the management will continue to monitor the residual risks and report to the Board on ongoing basis. The Board have reviewed the risk management and internal control system and procedures and they consider them effective and adequate.

With respect to the procedures and internal controls for the handling and dissemination of inside information, the Company is aware of the relevant obligations under the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong) and the Listing Rules. In order to enhance the Group's system of handling inside information, and to ensure the truthfulness, accuracy, completeness and timeliness of its public disclosures, the Group also adopts and implements an inside information policy and procedures, which include the access of information being restricted to a limited number of employees on a need-to-know basis, to ensure that proper safeguards exist to prevent possible mishandling of inside information within the Group.

Arrangements are in place to facilitate the employees of the Company to raise, in confidence, concerns about possible improprieties in financial reporting, internal control or other matters of the Company.

### **ANTI-CORRUPTION**

The Group has zero tolerance for bribery and corruption. The Group's ethical standards and requirements are clearly set out in the employee handbook, which requires all business activities to be operated with high level of integrity. Regardless of seniority and employment nature, all employees are required to fully comply with the following anti-bribery and anti-corruption legislation:

- The Anti-Unfair Competition Law of the PRC
- The Criminal Law of the PRC

Employees are prohibited from committing theft, fraud or dishonesty in connection with the Group properties, or committing a criminal offence outside the Group, which brings adverse publicity to the Group and/or affects the Group's reputation. The policy on declaration and handling of conflict of interest requires employees in key positions to submit an annual declaration of interests in work situations.

#### WHISTLEBLOWING SYSTEM

The Group's whistleblowing policy states that whistleblowers can make confidential reports to the Board directly upon any suspicious activities, either in person or email to the chairman of the Audit Committee. All reports and the identities of whistle-blowers would be treated in the strictest confidence. In the event an employee is found to have committed any act of misconduct, the Group reserves the rights to take disciplinary actions including termination of employment. The Group has not aided, abetted, assisted or colluded with an individual who has committed, or conspired to commit any unlawful activities. No non-compliance with relevant laws and regulations that have a significant impact on the Group relating to corruption, bribery, fraud and money laundering had been identified during the Reporting Year. There was no concluded legal case regarding corrupt practices brought against the Group or its employees during the Reporting Year.

Such meeting shall be held within two months after the deposit of such requisition. If within 21 days of such deposit the Directors fail to proceed to convene such meeting, the requisitionist(s) himself (themselves) may do so in the same manner, and all reasonable expenses incurred by the requisitionist(s) as a result of the failure of the Directors shall be reimbursed to the requisitionist(s) by the Company.



Through excellent management and compliant operation, we hope to promote the economic development of society, serve the real economy and facilitate sustainable development while providing quality services to customers. To this end, during our daily operation, we attach high importance to business ethics and strictly comply with relevant laws and regulations such as the Hong Kong Companies Ordinance, the Company Law of the PRC《中華人民共和國公司法》and the Anti-Unfair Competition Law of the PRC《中華人民共和國公司法》

The Group adopts a zero-tolerance approach and all forms of bribery and corruption are strictly prohibited by the Group. Employees should not offer, solicit or accept anything of material value to or from their colleagues, customers, suppliers or other business partner of the Group. They should perform their duties with integrity, such that no bribery, fraud or money laundering will be carried out for their personal gains at the expense of the Group's interests. Anti-corruption guideline has been detailed in staff handbook, which is distributed to all employees at the commencement of their employment, so that they can familiarize themselves with the guidelines.

During daily operations of money lending business, we perform relevant due diligence on all customers. We verify the customer's identity by reference to documents or information provided by reliable and independent sources. Personal documents, including ID/passport, driving license etc., will be obtained before entering into any business relationships with our customers. All the information and records are well maintained to meet the record-keeping requirements.

In addition, the Group has established a reliable whistle-blowing channel for employees and those who deal with the Group to report any suspected misconduct to their respective department head or human resources department verbally or in writing. The whistle-blower's identity will always remain anonymous and be protected throughout the investigation. Upon receipt of the report, we will conduct investigation immediately, and if the allegation is found to be true, we will take disciplinary actions against the person concerned, and if necessary, take legal actions to report to the relevant regulatory or law enforcement authorities.

During the Reporting Year, we were not aware of any illegal cases of bribery, extortion, fraud or money laundering threatened against the Group or its employees. In addition, the Group arranged an anti-corruption session during the orientation training for the new employees. The Group will closely monitor the regulatory development and will arrange relevant anti-corruption trainings for our employees and directors, where necessary.

Suppliers play an integral role in the business of the Group. The Group firmly believes that comprehensive supply chain management is paramount to maintain the quality of the products and services of the Group, and to promote sustainable development. To protect our vital interests, the Group always selects legitimate suppliers with outstanding quality, relevant qualifications and excellent service capabilities on the basis of transparency and fairness. The performance of suppliers in discharging their environmental and social responsibilities is also one of the evaluation criteria for our suppliers. In the process of selecting suppliers, factors such as candidates' sustainable development and management strategies, labour standards, moral standards and environmental management systems are included in the scoring system for close examination. The Group also encourages suppliers to actively assume their corporate social responsibilities by observing the regulatory requirements and business ethics in respect of business operation, marketing campaigns, social occasions and environmental obligations.

To ensure the services and products quality provided by suppliers, we evaluate our existing suppliers on a regular basis and remove those found to be in serious non-compliance or whose quality fails to meet the requirements, thereby reducing the risks associated with the supply chain. New suppliers will also be introduced according to our selection criteria to maintain the Group's sustainable development and achieve our ultimate goal of a win-win situation.

During the Reporting Year, the Group has engaged 52 suppliers located in the PRC. We will continue to invest in our collaboration with suppliers and expand our network of providers, in a bid to provide the best experience to our users.

During the Reporting Year, the Group strictly complied with laws and regulations in regard to product responsibility in the PRC that have a significant impact on our business, including, but not limited to, Trademark Law of the PRC, Copyright Law of the PRC and Rules of Protection on Information Network Dissemination Rights of the PRC.

The Group values greatly on the safety and health issue of our product provided. During the Reporting Year, the Group has not recalled any products sold or shipped subject for safety and health reasons. If customers are not satisfied with the quality of the services and products delivered, the frontline staff have to conduct preliminary assessment, and will pass the products to the Sales Department for further checking, if necessary.

We have established procedures in relation to monitoring and protection of intellectual property rights. The Group requires its subsidiaries to purchase legitimate software and multimedia resources to ensure the use of licensed multimedia and software resources. If any piracy, theft, falsification, illegal possession, counterfeiting or other forms of infringement of intellectual property are found upon investigation, the Group will immediately rectify such behaviour and take disciplinary actions, and serious cases will be handed over to relevant authorities for their handling in accordance with the law; if such behaviour constitutes an offence, those who committed such offence shall be held responsible in accordance with the law.

The Group has pledged that the use of false promotional messages is prohibited. When disseminating public information such as advertisements and recruitment materials, we strictly comply with the requirements under the laws and regulations such as the Advertising Law of the PRC 《中華人民共和國廣告法》by filing them with approving authorities for their review and approval.

In addition, the Group ensures that the information of customers and business are highly secured. To further clarify the requirements on privacy protection by the Group, as required by the laws and regulations such as the Personal Data (Privacy) Ordinance of Hong Kong, the Civil Code of the PRC 《中華人民共和國民法典》 and Personal Information Protection Law of the PRC 《中華人民共和國個人信息保護法》, we ensure that the confidentiality of material non-public information such as business secrets and customer information are strictly maintained.

The Group has formulated relevant regulations with detailed provisions on the scope of confidential issues and confidentiality level categorisation, the requirements for confidential issues and the handling and accountability for unauthorised disclosure and leakage. The Group has signed non-disclosure agreements with all employees and cooperating suppliers to ensure that they are aware of and undertakes to comply with the Group's confidentiality requirements. We take reasonable steps to protect the personal data and records from unauthorised access, handling, deletion or use. Within the "Staff Handbook", all employees are required to protect the sensitive information and clients' personal information obtained when performing the job duties. Information should not be disclosed to any third parties unless and to the extent that it is necessary to make such disclosure. In the event of any leakage of the private information of our customers or the Group, the Group will promptly take remedial measures and disciplinary actions against the persons held responsible depending on the severity of the incident.

When the Group receives complaints from customers, our Business Department is responsible for handling the complaints, and that all complaints received will be recorded in writing and submitted to senior staff for reviews and follow-up recommendations. All documents and reports will be properly kept and we aim to resolve all complaints, including those involving malpractices or alleged negligence. A follow-up response will also be communicated to the relevant customer when the complaint is duly handled and resolved.

During the Reporting Year, no material complaints were received and no material legal proceedings regarding infringement of intellectual property, advertising, labelling and privacy issues were brought against the Group.

#### **Lawful Labour**

The Group prohibits the use of child labour or forced labour. In accordance with the Employment Ordinance of Hong Kong, the Labour Contract Law of the PRC《中華人民共和國勞動合 同法》, the Law of the PRC on the Protection of Minors and the Regulations on the Implementation of the Employment Contract《中華人民共和國未成年人保護法和勞動合同實施 條例》、the Law of the PRC on the Protection of Minors《中華 人民共和國未成年人保護法》and the Provisions on the Prohibition against the Use of Child Labour《禁止使用童工 規定》, we have clearly stipulated in the labour contracts that the Group and its employees have equal legal status and that no party shall impose its/his/her will on the other party. The Group strictly implements relevant procedures in the recruitment process and screens out all job applicants under the age of 16, and their identification certificates are carefully examined in the interviews. In case of any violation of relevant regulations, the Group will immediately terminate the employment contract to prevent child labour. The Group formulates the working hours of employees according to relevant laws and regulations, and does not encourage and emphasise overtime work.

During the Reporting Year, the Group had not experienced any kind of child labour or forced labour related complaints.

#### **Health and Safety**

As a responsible employer, the Group believes employees' health and safety are the guarantee of steady operation for an enterprise. The Group continues to improve the health and safety related system construction and daily management to protect employees' physical and mental health. The Group strictly complies with the Occupational Safety and Health Ordinance of Hong Kong, the Regulation on Work-Related Injury Insurance《工傷保險條例》, the Fire Safety (Commercial Premises) Ordinance of Hong Kong and the Production Safety Law of the PRC《中華人民共和國安全 生產法》, the Law on Prevention and Control of Occupational Diseases of the PRC《中華人民共和國職業病防治法》, and the Administrative Measures for Occupational Health Inspection《職業性健康檢查管理辦法》and other relevant laws and regulations, committed to creating a sanitary, safe and comfortable office environment for employees.

We have formulated a series of emergency preparation and response procedures at the Group's exhibitions and entertainment venues to further improve occupational health management and reduce safety risks, regularly organised safety drills, and equipped business premises with sufficient labour protection supplies and firefighting equipment (such as fire extinguishers and fire hoses), so as to comprehensively reduce occupational safety risks.

In order to maintain a hygienic office environment, we regularly hire professional cleaning companies to disinfect telephones, keyboards, computers and other office supplies; clean glass windows, walls, carpets as well as debugs. We also carry out regular inspections of the hygienic conditions of the items in our office environment and promptly clean or replace those that do not meet hygienic standards.

In the midst of the COVID-19, the Group has implemented all practicable preventive and protective measures to minimise occupational risk, including but not limited to encouraging the employees to wear surgical mask and remain social distancing, when necessary, and provision of sanitizers. The Group will pay close attention to the latest development and regularly reviews the measures implemented to ensure the measures are effective.

During the Reporting Year, the Group recorded zero case of work injury and no relevant lost days (2021: 0 case; 2020: 0 case). No work-related fatalities were recorded by the Group in the past three years including the Reporting Year. As the Group places its employees' safety as top priority, it will continue to strive for a safe and healthy work environment for its employees.

諾發集團依法建立完善的薪酬與福利保障體 系,奉行平等公正的用人原則,只會以求職 者的道德品行、工作能力、發展潛力以及與 本公司文化的契合度作為任用人才的考量, 並按其教育背景、工作經驗、職業抱負等因 素提供公平且具競爭力的薪酬及福利。員工 薪酬包括基本工資、崗位績效工資及綜合補 貼,亦結合其業務表現及個人績效提供獎 金,以有效激勵員工。本集團透過對員工的 工作能力及過往的工作表現進行評估,以及 參考市場及行業標準,定期調整員工的薪酬 及福利,並以此為晉升的依據之一。同時, 本集團根據員工的工作表現及崗位提供崗位 績效工資,以提高員工努力工作的動力,並 制定薪酬結構表,釐定各職級的薪金範圍, 為員工提供明確的指引。本集團保證一切薪 酬評定、職位及工作等級調動等程序公平、 公開及诱明,確保所有求職者及員工均獲得 平等機會。

#### **Employee Care** (Continued)

Not only reasonable remuneration, the Group also emphasises on welfare policy to encourage cohesion of our staff and passion of work. Subject to the Employment Ordinance of Hong Kong and the Labour Contract Law of the PRC《中華人民共和國勞動合同法》, we provide a wide range of benefits to employees, including labour insurance, Mandatory Provident Fund, medical and life insurance. telecommunication subsidy, lunch allowance, overtime subsidy, travel allowance, heatstroke prevention subsidy and labour protection allowance. In addition, we implement standardised management on employees' holidays and rest periods, and formulate policies to restrict employees' working hours with reference to laws, regulations and guidelines such as the Employment Ordinance of Hong Kong and the Provisions of the State Council on Employees' Working Hours 《國務院關於職工工作時間的規定》, to ensure that employees have sufficient rest. In addition to statutory holidays and fixed paid annual leave, the Group's employees are provided with paid leave including annual leave, sick leave, maternity leave, marriage leave, bereavement leave and examination leave to further protect the legitimate rights of employees.

To ensure that our employees work in a pleasant and comfortable environment, we attach great importance to our employees' voices, and have established a number of channels, such as feedback boxes for collecting employees' comments, in order to enhance communication with them, understand their thoughts and suggestions, and continue to perfect our employee management system. The Group also encourages employees to respect, coordinate and support one another during work and create a fair and diverse working environment free from discrimination so as to manifest our corporate values and fulfil social responsibilities.

Furthermore, we arrange various kinds of recreational activities, dinners and parties for our employees from time to time. On major traditional holidays, such as the Dragon Boat Festival and the Mid-Autumn Festival, the Company buys rice dumplings and mooncakes for employees as benefits, which not only unites our team, but also encourages employees to achieve a balance between life and work.

為使員工在工作期間有一個愉快舒適的工作 氛圍,我們重視聆聽員工的心聲,設置多種 渠道,如意見箱等收集員工的意見,增進與 員工的溝通,了解他們的看法和建議,不在 完善員工管理制度。本集團亦倡導員工在 作期間應互相尊重、互相協作、互相支持 傳 團結共事,共同創造公平、多元化和無歧視 的工作環境,共同彰顯企業價值、履行社會 責任。

此外,我們不定期為員工組織各類康樂活動及聚餐派對等,每逢重大傳統節日如端午節和中秋節,本公司會給員工購買粽子和月餅以作為員工福利,增強團隊凝聚力之外,亦鼓勵員工實現生活工作相平衡。

#### **Environmental Protection**

The Group understands the importance of environmental protection, strictly controls generation and emission of air pollutants, waste discharges and others in adherence to the Air Pollution Control Ordinance of Hong Kong, the Environmental Protection Law of the PRC《中華人民共和國環 境保護法》、the Law of the PRC on the Prevention and Control of Pollution《中華人民共和國污染防治法》、the Law of the PRC on the Prevention and Control of Water Pollution《中華 人民共和國水污染防治法》, the Law of the PRC on the Prevention and Control of Environmental Noise Pollution《中 華人民共和國環境噪聲污染防治法》, the Law of the PRC on the Prevention and Control of Environment Pollution Caused by Solid Wastes《中華人民共和國固體廢物污染防治法》and the Law of the PRC on Conserving Energy《中華人民共和國 節 約 能 源 法 》 and other related laws and regulations, to ensure that the Group does not violate any laws or regulations related to environment in the course of our operation and management.

As a responsible corporate citizen, we consistently carry out the environmental sustainability development strategy across our operations, perfect our environment management system and promote green development. We continuously gather and monitor data and information relating to major environmental issues which are material to the Group. As the Group is principally engaged in the exhibition management business, management services and other business activities which are all conducted in office, our daily operations do not have any material effect on the environment, except for greenhouse gas emissions indirectly generated from the use of externally purchased electricity.

During the Reporting Year, the Group was not aware of any violation of environmental protection laws and regulations.

#### 綠色運營

#### 環境保護

本集團深明環境保護的重要性,嚴格遵守香港《空氣污染管制條例》以及《中華人民共和國環境保護法》、《中華人民共和國污染防治法》、《中華人民共和國環境噪聲污染防治法》、《中華人民共和國固體廢物污染防治法》及《中華人民共和國節約能源法》等法律法規,嚴格控制空氣污染物、廢棄物等的產生與排放,保證本集團的運營及管理不觸犯相關的環境法律法規。

作為一個負責任的企業公民,我們在運營過程中貫徹環境可持續發展方針,完善環境管理體系,推動綠色發展,持續收集並監控與本集團相關的重大環境議題之相關數據及對。由於本集團主要從事的展覽會管理服務及其他業務活動均於辦公室內,儘管我們的日常營運並未對環境造成重大影響,惟外購電力在使用過程中間接產生溫室氣體排放。

於報告年度內,本集團未有知悉任何違反環境保護法律法規的個案。

#### **ENVIRONMENTAL OPERATIONS** (Continued)

#### **Energy Saving and Reducing Emission**

In order to reduce carbon emissions in business operations and jointly cope with climate change, the Group actively advocates the green policy of sustainable development and strives to save energy, water, paper and other resources within its capacity. We proactively raised our staff's environmental awareness and implemented relevant measures in energy saving and reducing emission in daily operation so as to establish a low-carbon office. During the Reporting Year, the greenhouse gas emission intensity increased 2% when compared to the previous reporting year, which did not achieve the target set in previous reporting year. This is mainly because four more business unit's greenhouse gas emission has been disclosed for comprehensives, meanwhile the number of employee level remains similar, which might lead to a slight increase in greenhouse gas emission intensity. To uphold the principles of sustainable development, the Group is committed to reducing or maintaining both the greenhouse gas emission intensity between 90% to 120% of the level of baseline year ended 30 June 2022 in the next reporting year via adopting the following measures.

Electricity is the principal energy consumed in our daily operation within the offices and galleries. The Group regularly monitors the electricity consumption of the offices in Hong Kong and Mainland China, instals LED lights with higher energy efficiency in the offices to replace traditional fluorescent tubes, and encourages employees to minimise the use of lights when natural light is abundant; signings are displayed at prominent locations in offices to raise employees' awareness of energy conservation; central airconditioning is subject to reasonable adjustments in different seasons; electrical appliances are subject to regular energy consumption inspections; energy saving and environmental protection are considered in the procurement of new electrical appliances. During the Reporting Year, the electricity consumption intensity increased 3% when compared to the previous reporting year, which did not achieve the target set in previous reporting year. As aforementioned, this is mainly because four more business unit's electricity consumption has been disclosed, meanwhile the number of employee level remains similar, which might lead to a slight increase in electricity consumption intensity. To uphold the principles of sustainable development, the Group is committed to reducing or maintaining the electricity consumption intensity between 90% to 120% of the level of baseline year ended 30 June 2022 in the next reporting year by implementing the said mitigating measures.

#### 綠色運營(續)

#### 節能減排

電力為我們日常辦公室運營及展覽廳所使用 的主要能源消耗。本集團定期監察位於香港 及中國內地辦公室的電力消耗,在辦公室安 裝能源效益較高的LED燈以代替傳統的光 管,並鼓勵員工在自然光線充沛的情況下盡 量減少使用電燈;辦公室的顯眼位置貼有標 識,提高員工的節能意識;中央空調會在不 同季節作出合理調節;電器定期進行能耗檢 查;在採購新電器時會考慮節能環保。於報 告年度,電力消耗密度較上一報告年度增加 3%,並未達到上一報告年度設立的目標。誠 如上文所述,此乃主要由於本集團已披露額 外四個業務單位的電力消耗,同時員工級別 數目保持相似,可能導致電力消耗密度輕微 增加。為秉持可持續發展原則,本集團致力 通過採取上述減緩措施,在下一報告年度將 電力消耗密度降低或維持在截至二零二二年 六月三十日止基準年度水平的90%至120% 之間。

#### **Effective Use of Resources**

The Group understands the precious nature of the earth's resources and actively advocates paperless office in the office to reduce unnecessary office paper consumption. The Group encourages employees to prioritise the communication and dissemination of information through e-mail and other electronic platforms. The Group encourages double-sided printing and use of waste paper for printing internal documents whenever possible.

The Group adheres to its commitment to sustainable management and has taken various measures in the office to encourage recycling to reduce waste generation. The Group encourages employees to reuse office stationery such as used envelopes and document folders whenever possible. In terms of hazardous waste, as the business of the Group does not involve any industrial production activities, the Group did not generate any significant hazardous waste during the Reporting Year.

The major non-hazardous waste is produced from the paper consumption for administrative work. During the Reporting Year, the paper consumption intensity increased 11% when compared to the previous reporting year, which did not achieve the target set in previous reporting year. This is mainly because of the statistics of the paper consumption for the Reporting Year has been disclosed together with Hong Kong head office and PRC offices for comprehensiveness, while previous reporting year disclosed the paper consumption in the Hong Kong head office only. Therefore, the increasing paper consumption level would be resulted.

In order to minimise the usage of paper, we cultivate a paperless working environment among our employees. To avoid unnecessary wastage and promote effective use of paper, our employees are encouraged to use electronic copies instead of hard copies. If printing is necessary, we encourage the use of double-sided printing. For any paper that has been used for single-sided printing, they should be reused when there is no confidential information on the printed side of the paper. To uphold the principles of sustainable development, the Group is committed to reducing or maintaining the non-hazardous waste intensity generated between 90% to 120% of the level of baseline year ended 30 June 2022 in the next reporting year.

#### 善用資源

本集團深明地球資源的珍貴,並積極在辦公室內倡導無紙化辦公,減少不必要的辦公室用紙。本集團鼓勵員工優先以電子郵件和其他電子平台等途徑溝通和發佈信息。本集團鼓勵雙面列印及盡量使用廢紙列印內部文件。

本集團堅守可持續化管理的承諾,在辦公室 內採取多項措施,鼓勵循環再用,以減低廢 物的產生。本集團鼓勵員工盡可能重用舊信 封和文件夾等辦公室文具。在有害廢物方 面,由於本集團的業務並不涉及任何工業生 產活動,故本公司並未於報告年度內產生任 何重大的有害廢物。

主要的無害廢棄物來自行政工作用紙。於報告年度,用紙密度較上一報告年度增加11%,並未達到上一報告年度設立的目標。此乃主要由於本集團已連同香港總部辦公室及中國辦公室,一併全面披露報告年度的用紙量統計,而上一報告年度僅披露香港總部辦公室的用紙量,故導致用紙量水平增加。

為盡可能減少紙張的使用,我們向僱員提倡無紙化的辦公環境。為避免不必要的浪費及提高紙張的使用效率,我們鼓勵僱員使用電子副本以代替影印本。倘必須打印時,我們使用雙面打印。就已用於單面打印的抵張而言,倘該紙張的打印面上並無機發層,則應予以再利用。為秉持可持續審務原則,本集團致力在下一報告年度將無害所則,本集團致力在下一報告年度將無害所數密度降低或維持在截至二零二二年六月三十日止基準年度水平的90%至120%之間。

#### **Effective Use of Resources** (Continued)

The operation of the Group involves a small amount of water for office activities. During the Reporting Year, the water consumption intensity decreased 55% when compared to the previous reporting year, which achieved the target set in previous reporting year. The significant drop in water consumption intensity is mainly contributed by COVID-19 situation. Due to the pandemic, the business of the Group reduced and work from home arrangement has been made for the employee, which leads to greatly reduce in water consumption during the Reporting Period.

Although the Group did not encounter any issue in sourcing water that is fit for purpose, we strive to reduce water consumption and improve the efficiency of water use in our operations. The Group has put up "Saving Water Resource" posters in washrooms and food bars in the office to raise employees' awareness of water conservation. In addition, the Group also regularly inspects and repairs the water supply system, including water taps, water pipelines and water storage tanks. Once the water supply equipment is found to have dripping or leaking, professional parties will be arranged to repair the water supply equipment immediately to reduce waste caused by leakage of the water supply system. To uphold the principles of sustainable development, the Group is committed to reducing or maintaining the water consumption intensity between 90% to 120% of the level of baseline year ended 30 June 2022 in the next reporting year.

#### **CLIMATE CHANGE**

Climate change is among the most pressing global challenges of our time. Against the backdrop of global climate actions, the Group has implemented measures to conserve energy and reduce greenhouse gas emissions. In addition, the Group is conscious that the frequency of extreme weather is increasing, which could impact its business operations.

Going forward, the Group will continue to review the impact of climate change on its operations and implement mitigation controls for significant risks to enhance its resilience and adaptability to climate change.

The Group has considered the potential climate-related risks and opportunities in respect of the recommendations of the Task Force on Climate-related Financial Disclosures, in which potential physical risk and transition risk from climate change may pose adverse financial impacts on the Group's businesses. Acute physical risk can arise from extreme weather conditions such as flooding and storms and chronic physical risk can arise from sustained high temperature, while transition risk may result from the change in environmental-related regulations or change in customer preferences, and the potential climate-related risks are summarised as below:

#### 氣候變化

### 1. GENERAL INFORMATION

The Company was incorporated as an exempted company with limited liability in the Cayman Islands under the Companies Law of Cayman Islands and is listed on The Stock Exchange of Hong Kong Limited (the "Stock Exchange"). The registered office of the Company is Cricket Square, Hutchins Drive, P.O. Box 2681, Grand Cayman, KY1-1111, Cayman Islands and the principal place of business of the Company in Hong Kong is Room 2102, 21/F., Tower One, Lippo Centre, 89 Queensway, Hong Kong.

The Company is an investment holding company. The principal activities of its subsidiaries are set out in Note 21 to the consolidated financial statements.

The consolidated financial statements are presented in Hong Kong dollars ("HK\$"), which is also the functional currency of the Company. In addition, the functional currencies of certain group entities that operate outside Hong Kong are determined based on the currency of the primary economic environment in which the group entities operate. All values are rounded to the nearest thousand, unless otherwise stated.

The consolidated financial statements have been prepared on the historical cost basis except for certain financial instruments that are measured at fair values at the end of each reporting period, as explained in the accounting policies set out below.

Historical cost is generally based on the fair value of the consideration given in exchange for goods and services.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date, regardless of whether that price is directly observable or estimated using another valuation technique. In estimating the fair value of an asset or a liability, the Group takes into account the characteristics of the asset or liability if market participants would take those characteristics into account when pricing the asset or liability at the measurement date. Fair value for measurement and/or disclosure purposes in these consolidated financial statements is determined on such a basis, except for share-based payment transactions that are within the scope of HKFRS 2 Sharebased Payment ("HKFRS 2"), leasing transactions that are accounted for in accordance with HKFRS 16 Leases ("HKFRS 16"), and measurements that have some similarities to fair value but are not fair value, such as net realisable value in HKAS 2 Inventories or value-inuse in HKAS 36 Impairment of Assets.

A fair value measurement of a non-financial asset takes into account a market participant's ability to generate economic benefits by using the asset in its highest and best use or by selling it to another market participant that would use the asset in its highest and best use.

For financial instruments which are transacted at fair value and a valuation technique that unobservable inputs is to be used to measure fair value in subsequent periods, the valuation technique is calibrated so that at initial recognition the results of the valuation technique equals the transaction price.

In addition, for financial reporting purposes, fair value measurements are categorised into Level 1, 2 or 3 based on the degree to which the inputs to the fair value measurements are observable and the significance of the inputs to the fair value measurement in its entirety, which are described as follows:

- Level 1 inputs are quoted prices (unadjusted) in active markets for identical assets or liabilities that the entity can access at the measurement date;
- Level 2 inputs are inputs, other than quoted prices included within Level 1, that are observable for the asset or liability, either directly or indirectly; and
- Level 3 inputs are unobservable inputs for the asset or liability.

#### Basis of consolidation

The consolidated financial statements incorporate the financial statements of the Company and entities controlled by the Company and its subsidiaries. Control is achieved when the Company:

- has power over the investee:
- is exposed, or has rights, to variable returns from its involvement with the investee; and
- has the ability to use its power to affect its returns.

The Group reassesses whether or not it controls an investee if facts and circumstances indicate that there are changes to one or more of the three elements of control listed above.

Consolidation of a subsidiary begins when the Group obtains control over the subsidiary and ceases when the Group loses control of the subsidiary. Specifically, income and expenses of a subsidiary acquired or disposed of during the year are included in the consolidated statement of profit or loss and other comprehensive income from the date the Group gains control until the date when the Group ceases to control the subsidiary.

Profit or loss and each component of other comprehensive income are attributed to the owners of the Company and to the non-controlling interests. Total comprehensive income of subsidiaries is attributed to the owners of the Company and to the non-controlling interests even if this results in the non-controlling interests having a deficit balance.

When necessary, adjustments are made to the financial statements of subsidiaries to bring their accounting policies into line with the Group's accounting policies.

All intragroup assets and liabilities, equity, income, expenses and cash flows relating to transactions between members of the Group are eliminated in full on consolidation.

Non-controlling interests in subsidiaries are presented separately from the Group's equity therein, which represent present ownership interests entitling their holders to a proportionate share of net assets of the relevant subsidiaries upon liquidation.

# Changes in the Group's ownership interests in existing subsidiaries

Changes in the Group's interests in subsidiaries that do not result in the Group losing control over the subsidiaries are accounted for as equity transactions. The carrying amounts of the Group's relevant components of equity and the non-controlling interests are adjusted to reflect the changes in their relative interests in the subsidiaries, including re-attribution of relevant reserves between the Group and the non-controlling interests according to the Group's and the non-controlling interests' proportionate interests.

Any difference between the amount by which the noncontrolling interests are adjusted, and the fair value of the consideration paid or received is recognised directly in equity and attributed to owners of the Company.

When the Group loses control of a subsidiary, the assets and liabilities of that subsidiary and non-controlling interests (if any) are derecognised. A gain or loss is recognised in profit or loss and is calculated as the difference between (i) the aggregate of the fair value of the consideration received and the fair value of any retained interest and (ii) the carrying amount of the assets (including goodwill), and liabilities of the subsidiary attributable to the owners of the Company. All amounts previously recognised in other comprehensive income in relation to that subsidiary are accounted for as if the Group had directly disposed of the related assets or liabilities of the subsidiary (i.e. reclassified to profit or loss or transferred to another category of equity as specified/permitted by applicable HKFRSs). The fair value of any investment retained in the former subsidiary at the date when control is lost is regarded as the fair value on initial recognition for subsequent accounting under HKFRS 9 Financial Instruments ("**HKFRS 9**") or, when applicable, the cost on initial recognition of an investment in an associate or a joint venture.

# Business combinations or asset acquisitions

#### **Optional concentration test**

The Group can elect to apply an optional concentration test, on a transaction-by-transaction basis, that permits a simplified assessment of whether an acquired set of activities and assets is not a business. The concentration test is met if substantially all of the fair value of the gross assets acquired is concentrated in a single identifiable asset or group of similar identifiable assets.

The gross assets under assessment exclude cash and cash equivalents, deferred tax assets, and goodwill resulting from the effects of deferred tax liabilities. If the concentration test is met, the set of activities and assets is determined not to be a business and no further assessment is needed.

### **Asset acquisitions**

When the Group acquires a group of assets and liabilities that do not constitute a business, the Group identifies and recognises the individual identifiable assets acquired and liabilities assumed by allocating the purchase price first to financial assets/financial liabilities at the respective fair values, the remaining balance of the purchase price is then allocated to the other identifiable assets and liabilities on the basis of their relative fair values at the date of purchase. Such a transaction does not give rise to goodwill or bargain purchase gain.

Acquisitions of businesses are accounted for using the acquisition method. The consideration transferred in a business combination is measured at fair value, which is calculated as the sum of the acquisition-date fair values of the assets transferred by the Group, liabilities incurred by the Group to the former owners of the acquiree and the equity interests issued by the Group in exchange for control of the acquiree. Acquisition-related costs are generally recognised in profit or loss as incurred.

At the acquisition date, the identifiable assets acquired and the liabilities assumed are recognised at their fair value, except that:

- deferred tax assets or liabilities, and assets or liabilities related to employee benefit arrangements are recognised and measured in accordance with HKAS 12 Income Taxes ("HKAS 12") and HKAS 19 Employee Benefits respectively;
- liabilities or equity instruments related to sharebased payment arrangements of the acquiree or share-based payment arrangements of the Group entered into to replace share-based payment arrangements of the acquiree are measured in accordance with HKFRS 2 at the acquisition date;
- assets (or disposal groups) that are classified as held for sale in accordance with HKFRS 5 Noncurrent Assets Held for Sale and Discontinued Operations are measured in accordance with that standard; and

If, after reassessment, the net amount of the identifiable assets acquired and liabilities assumed exceeds the sum of the consideration transferred, the amount of any non-controlling interests in the acquiree and the fair value of the acquirer's previously held interest in the acquiree (if any), the excess is recognised immediately in profit or loss as a bargain purchase gain.

Non-controlling interests that are present ownership interests and entitle their holders to a proportionate share of the relevant subsidiary's net assets in the event of liquidation are initially measured either at fair value or at the non-controlling interests' proportionate share of the recognised amounts of the acquiree's identifiable net assets. The choice of measurement basis is made on a transaction-by-transaction basis. Other types of non-controlling interests are measured at fair value.

When the consideration transferred by the Group in a business combination includes a contingent consideration arrangement, the contingent consideration is measured at its acquisition-date fair value and included as part of the consideration transferred in a business combination. Changes in the fair value of the contingent consideration that qualify as measurement period adjustments are adjusted retrospectively. When a business combination is achieved in stages, the Group's previously held equity interest in the acquiree is remeasured to fair value at the acquisition date (i.e. the date when the Group obtains control), and the resulting gain or loss, if any, is recognised in profit or loss or other comprehensive income, as appropriate. Amounts arising from interests in the acquiree prior to the acquisition date that have previously been recognised in other comprehensive income and measured under HKFRS 9 would be accounted for on the same basis as would be required if the Group had disposed directly of the previously held equity interest.

If the initial accounting for a business combination is incomplete by the end of the reporting period in which the combination occurs, the Group reports provisional amounts for the items for which the accounting is incomplete. Those provisional amounts are adjusted retrospectively during the measurement period (see above), and additional assets or liabilities are recognised, to reflect new information obtained about facts and circumstances that existed at the acquisition date that, if known, would have affected the amounts recognised at that date.

#### Goodwill

Goodwill arising on an acquisition of a business is carried at cost as established at the date of acquisition of the business (see the accounting policy above) less accumulated impairment losses, if any.

For the purposes of impairment testing, goodwill is allocated to each of the Group's CGUs (or groups of CGUs) that is expected to benefit from the synergies of the combination, which represent the lowest level at which the goodwill is monitored for internal management purposes and not larger than an operating segment.

A CGU (or group of CGUs) to which goodwill has been allocated is tested for impairment annually or more frequently when there is indication that the unit may be impaired. For goodwill arising on an acquisition in a reporting period, the CGU (or group of CGUs) to which goodwill has been allocated is tested for impairment before the end of that reporting period. If the recoverable amount of the CGU is less than its carrying amount, the impairment loss is allocated first to reduce the carrying amount of any goodwill allocated to the unit and then to the other assets of the unit on a prorata basis based on the carrying amount of each asset in the unit (or group of CGUs).

On disposal of the relevant CGU or any of the CGU within the group of CGUs, the attributable amount of goodwill is included in the determination of the amount of profit or loss on disposal. When the Group disposes of an operation within the CGU (or a CGU within a group of CGUs), the amount of goodwill disposed of is measured on the basis of the relative values of the operation (or the CGU) disposed of and the portion of the CGU (or the group of CGUs) retained.

Property, plant and equipment are tangible assets that are held for use in production or supply of goods or services, or for administrative purpose are stated in the consolidated statements of financial position at cost less subsequent accumulated depreciation and subsequent accumulated impairment losses, if any.

Depreciation is recognised so as to write off the cost of assets less their residual values over their estimated useful lives, using the straight-line method, at the following rates per annum:

Computer equipment 10%–33%
Furniture, fixtures and equipment 20%–50%
Motor vehicles 20%

The residual values, estimated useful lives and depreciation method are reviewed, and adjusted if appropriate, at the end of each reporting period.

An item of property, plant and equipment is derecognised upon disposal or when no future economic benefits are expected to arise from the continued use of the asset. Any gain or loss arising on the disposal or retirement of an item of property, plant and equipment is determined as the difference between the sales proceeds and the carrying amount of the asset and is recognised in profit or loss.

### **Intangible assets**

#### Intangible assets acquired separately

Intangible assets with finite useful lives that are acquired separately are carried at cost less accumulated amortisation and accumulated impairment losses. Amortisation for intangible assets with finite useful lives is recognised on a straight-line basis over their estimated useful lives. The estimated useful life and amortisation method are reviewed at the end of each reporting period, with the effect of any changes in estimate being accounted for on a prospective basis.

Amortisation of intangible assets with finite useful lives is charged to profit or loss on a straight-line basis over their estimated useful lives.

Both the period and method of amortisation are reviewed annually.

### **Derecognition of intangible assets**

An intangible asset is derecognised on disposal, or when no future economic benefits are expected from use or disposal. Gains and losses arising from derecognition of an intangible asset, measured as the difference between the net disposal proceeds and the carrying amount of the asset, is recognised in profit or loss when the asset is derecognised.

Such contract will not be reassessed unless the terms and conditions of the contract are subsequently changed.

Allocation of consideration to components of a contract For a contract that contains a lease component and one or more additional lease or non-lease components, the Group allocates the consideration in the contract to each lease component on the basis of the relative stand-alone price of the lease component and the aggregate stand-alone price of the non-lease components.

As a practical expedient, leases with similar characteristics are accounted on a portfolio basis when the Group reasonably expects that the effects on the financial statements would not differ materially from individual leases within the portfolio.

At the end of each reporting period, the Group reviews the carrying amounts of its property, plant and equipment, right-of-use assets and intangible assets with finite useful lives to determine whether there is any indication that these assets have suffered an impairment loss. If any such indication exists, the recoverable amount of the relevant asset is estimated in order to determine the extent of the impairment loss (if any).

The recoverable amount of property, plant and equipment, right-of-use assets and intangible assets are estimated individually. When it is not possible to estimate the recoverable amount individually, the Group estimates the recoverable amount of the CGU to which the asset belongs. In addition, the Group assesses whether there is indication that corporate assets may be impaired. If such indication exists, corporate assets are also allocated to individual CGUs, when a reasonable and consistent basis of allocation can be identified, or otherwise they are allocated to the smallest group of CGUs for which a reasonable and consistent allocation basis can be identified.

Recoverable amount is the higher of fair value less costs of disposal and value-in-use. In assessing value-in-use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset (or a CGU) for which the estimates of future cash flows have not been adjusted.

All regular way purchases or sales of financial assets are recognised and derecognised on a trade date basis. Financial assets and financial liabilities are initially measured at fair value except for trade receivables arising from contracts with customers which are initially measured in accordance with HKFRS 15 Revenue from Contracts with Customers. Transaction costs that are directly attributable to the acquisition or issue of financial assets and financial liabilities (other than financial assets and financial liabilities at FVTPL) are added to or deducted from the fair value of the financial assets or financial liabilities, as appropriate, on initial recognition. The effective interest method is a method of calculating the amortised cost of a financial asset or financial liability and of allocating interest income and interest expense over the relevant period. The effective interest rate is the rate that exactly discounts estimated future cash receipts and payments (including all fees and points paid or received that form an integral part of the effective interest rate, transaction costs and other premiums or discounts) through the expected life of the financial asset or financial liability, or, where appropriate, a shorter period to the net carrying amount on initial recognition.

Interest income which are derived from the Group's ordinary course of business are presented as revenue.

### Impairment of financial assets

The Group performs impairment assessment under ECL model on financial assets (including trade receivables, deposits and other receivables, factoring receivables, lease receivables, loan receivables and cash and cash equivalents) which are subject to impairment under HKFRS 9. The amount of ECL is updated at each reporting date to reflect changes in credit risk since initial recognition.

Lifetime ECL represents the ECL that will result from all possible default events over the expected life of the relevant instrument. In contrast, 12-month ECL ("12m ECL") represents the portion of lifetime ECL that is expected to result from default events that are possible within 12 months after the reporting date. Assessments are done based on the Group's historical credit loss experiences, adjusted for factors that are specific to the debtors, general economic conditions and an assessment of both the current conditions at the reporting date as well as the forecast of future conditions.

The Group always recognises lifetime ECL for trade receivables under simplified approach. The ECL on these receivables are assessed individually for debtors with significant balances.

For all other financial instruments, including factoring receivables, loan receivables, lease receivables, other receivable, deposits and cash and cash equivalents, the Group measures the loss allowance equal to 12m ECL, unless when there has been a significant increase in credit risk since initial recognition, in which case the Group recognises lifetime ECL. The assessment of whether lifetime ECL should be recognised is based on significant increases in the likelihood or risk of a default occurring since initial recognition.

(i) Significant increase in credit risk

In assessing whether the credit risk has increased significantly since initial recognition, the Group compares the risk of a default occurring on the financial instrument as at the reporting date with the risk of a default occurring on the financial instrument as at the date of initial recognition. In making this assessment, the Group considers both quantitative and qualitative information that is reasonable and supportable, including historical experience and forward-looking information that is available without undue cost or effort.

In particular, the following information is taken into account when assessing whether credit risk has increased significantly:

- an actual or expected significant deterioration in the financial instrument's external (if available) or internal credit rating;
- significant deterioration in external market indicators of credit risk, e.g. a significant increase in the credit spread, the credit default swap prices for the debtor;

Irrespective of the outcome of the above assessment, the Group presumes that the credit risk has increased significantly since initial recognition when contractual payments are more than 180 days past due, unless the Group has reasonable and supportable information that demonstrates otherwise.

The Group regularly monitors the effectiveness of the criteria used to identify whether there has been a significant increase in credit risk and revises them as appropriate to ensure that the criteria are capable of identifying significant increase in credit risk before the amount becomes past due.

#### (ii) Definition of default

For internal credit risk management, the Group considers an event of default occurs when information developed internally or obtained from external sources indicates that the debtor is unlikely to pay its creditors, including the Group, in full (without taking into account any collaterals held by the Group).

Irrespective of the above, the Group considers that default has occurred when a financial asset is more than 240 days past due unless the Group has reasonable and supportable information to demonstrate that a more lagging default criterion is more appropriate.

A financial asset is credit-impaired when one or more events that have a detrimental impact on the estimated future cash flows of that financial asset have occurred. Evidence that a financial asset is credit-impaired includes observable data about the following events:

- (a) significant financial difficulty of the issuer or the borrower;
- (b) a breach of contract, such as a default or past due event;
- (c) the lender(s) of the borrower, for economic or contractual reasons relating to the borrower's financial difficulty, having granted to the borrower a concession(s) that the lender(s) would not otherwise consider:
- (d) it is becoming probable that the borrower will enter bankruptcy or other financial reorganisation; or

The Group writes off a financial asset when there is information indicating that the counterparty is in severe financial difficulty and there is no realistic prospect of recovery, for example, when the counterparty has been placed under liquidation or has entered into bankruptcy proceedings, or in the case of trade receivables, when the amounts are over two years past due, whichever occurs sooner. Financial assets written off may still be subject to enforcement activities under the Group's recovery procedures, taking into account legal advice where appropriate. A write-off constitutes a derecognition event. Any subsequent recoveries are recognised in profit or loss.

(v) Measurement and recognition of ECL

The measurement of ECL is a function of the probability of default, loss given default (i.e. the magnitude of the loss if there is a default) and the exposure at default. The assessment of the probability of default and loss given default is based on historical data adjusted by forward-looking information. Estimation of ECL reflects an unbiased and probability-weighted amount that is determined with the respective risks of default occurring as the weights.

The Group uses a practical expedient in estimating ECL on trade receivables using a provision matrix taking into consideration historical credit loss experience, adjusted for forward looking information that is available without undue cost or effort.

Generally, the ECL is the difference between all contractual cash flows that are due to the Group in accordance with the contract and all the cash flows that the Group expects to receive, discounted at the effective interest rate determined at initial recognition.

Interest income is calculated based on the gross carrying amount of the financial asset unless the financial asset is credit-impaired, in which case interest income is calculated based on amortised cost of the financial asset.

The Group recognises an impairment gain or loss in profit or loss for all financial instruments by adjusting their carrying amount, with the exception of trade receivables, lease receivables, factoring receivables and loan receivables where the corresponding adjustment is recognised through an impairment allowance account.

### Derecognition of financial assets

The Group derecognises a financial asset only when the contractual rights to the cash flows from the asset expire, or when it transfers the financial asset and substantially all the risks and rewards of ownership of the asset to another entity. On derecognition of a financial asset measured at amortised cost, the difference between the asset's carrying amount and the sum of the consideration received and receivable is recognised in profit or loss.

#### Modification of financial assets

Where the original contractual terms of a financial asset have been modified for credit reasons and the instrument has not been derecognised (an instrument is derecognised when a modification results in a change in cash flows that the Group would consider substantial), the resulting modification loss is recognised in profit or loss with a corresponding decrease in the gross carrying value of the asset.

Expected credit loss for modified financial assets that have not been derecognised and are not considered to be credit-impaired will be recognised on a 12-month basis, or a lifetime basis, if there is a significant increase in credit risk. These assets are assessed to determine whether there has been a significant increase in credit risk subsequent to the modification. In addition to the recognition of modification gains and losses, the revised carrying value of modified financial assets will impact the calculation of expected credit losses, with any increase or decrease in expected credit loss recognised.

### Equity instrument

An equity instrument is any contract that evidences a residual interest in the assets of an entity after deducting all of its liabilities. Equity instruments issued by a group entity are recognised at the proceeds received, net of direct issue costs.

For financial liabilities that are designated as at FVTPL, the amount of change in the fair value of the financial liability that is attributable to changes in the credit risk of that liability is recognised in other comprehensive income, unless the recognition of the effects of changes in the liability's credit risk in other comprehensive income would create or enlarge an accounting mismatch in profit or loss. Changes in fair value attributable to a financial liability's credit risk that are recognised in other comprehensive income are not subsequently reclassified to profit or loss, instead, they are transferred to retained earnings upon derecognition of the financial liability.

#### Convertible notes

The component parts of compound instruments (convertible notes) issued by the Company are classified separately as financial liabilities and equity in accordance with the substance of the contractual arrangements and the definitions of a financial liability and an equity instrument. A conversion option that will be settled by the exchange of a fixed amount of cash or another financial asset for a fixed number of the Company's own equity instruments is an equity instrument.

At the date of issue, the fair value of the liability component is estimated using the prevailing market interest rate for similar non-convertible instruments. This amount is subsequently recorded as a liability on an amortised cost basis using the effective interest method until extinguished upon conversion or at the instrument's maturity date.

# Derecognition of financial liabilities

The Group derecognises financial liabilities when, and only when, the Group's obligations are discharged, cancelled or have expired. The difference between the carrying amount of the financial liability derecognised and the consideration paid and payable is recognised in profit or loss.

The Group accounts for an exchange with a lender of a financial liability with substantially different terms as an extinguishment of the original financial liability and the recognition of a new financial liability. A substantial modification of the terms of an existing financial liability or a part of it (whether or not attributable to the financial difficulty of the Group) is accounted for as an extinguishment of the original financial liability and the recognition of a new financial liability.

The Group considers that the terms are substantially different if the discounted present value of the cash flows under the new terms, including any fees paid net of any fees received and discounted using the original effective interest rate, is at least 10 per cent different from the discounted present value of the remaining cash flows of the original financial liability. Accordingly, such exchange of debt instruments or modification of terms is accounted for as an extinguishment, any costs or fees incurred are recognised as part of the gain or loss on the extinguishment. The exchange or modification is considered as non-substantial modification when such difference is less than 10 per cent.

#### Non-substantial modifications of financial liabilities

For non-substantial modifications of financial liabilities that do not result in derecognition, the carrying amount of the relevant financial liabilities will be calculated at the present value of the modified contractual cash flows discounted at the financial liabilities' original effective interest rate. Transaction costs or fees incurred are adjusted to the carrying amount of the modified financial liabilities and are amortised over the remaining term. Any adjustment to the carrying amount of the financial liability is recognised in profit or loss at the date of modification.

### **Derivative financial instruments**

Derivatives are initially recognised at fair value at the date when the derivative contracts are entered into and are subsequently remeasured to their fair value at the end of the reporting period. The resulting gain or loss is recognised in profit or loss.

### Embedded derivatives

Derivatives embedded in hybrid contracts that contain financial asset hosts within the scope of HKFRS 9 are not separated. The entire hybrid contract is classified and subsequently measured in its entirety as either amortised cost or fair value as appropriate.

Derivatives embedded in non-derivative host contracts that are not financial assets within the scope of HKFRS 9 are treated as separate derivatives when they meet the definition of a derivative, their risks and characteristics are not closely related to those of the host contracts and the host contracts are not measured at FVTPL.

Generally, multiple embedded derivatives in a single instrument that are separated from the host contracts are treated as a single compound embedded derivative unless those derivatives relate to different risk exposures and are readily separable and independent of each other.

# **Inventories**

Inventories are stated at the lower of cost and net realisable value. Cost of inventories are determined on first-in, first-out method.

Net realisable value represents the estimated selling price for inventories less all estimated costs of completion and costs necessary to make the sale.

# **Cash and cash equivalents**

Cash and cash equivalents comprise of cash on hand, cash at bank and other financial institutions which are readily convertible into known amounts of cash, are subject to an insignificant risk of changes in value, and have a short maturity of generally within three months when acquired.

The Group recognises revenue when (or as) a performance obligation is satisfied, i.e. when "control" of the goods or services underlying the particular performance obligation is transferred to the customer.

A performance obligation represents a good or service (or a bundle of goods or services) that is distinct or a series of distinct goods or services that are substantially the same.

Except for granting of a licence that is distinct from other promised goods or services, control is transferred over time and revenue is recognised over time by reference to the progress towards complete satisfaction of the relevant performance obligation if one of following criteria is met:

- the customer simultaneously receives and consumes the benefits provided by the Group's performance as the Group performs;
- the Group's performance creates and enhances an asset that the customer controls as the Group performs; or
- the Group's performance does not create an asset with an alternative use to the Group and the Group has an enforceable right to payment for performance completed to date.

Otherwise, revenue is recognised at a point in time when the customer obtains control of the distinct good or service.

For granting of a licence that is distinct from other promised goods or services, the nature of the Group's promise in granting a licence is a promise to provide a right to access the Group's intellectual property if all of the following criteria are met:

- the contract requires, or the customer reasonably expects, that the Group will undertake activities that significantly affect the intellectual property to which the customer has rights;
- the rights granted by the licence directly expose the customer to any positive or negative effects of the Group's activities; and
- those activities do not result in the transfer of a good or a service to the customer as those activities occur.

If the criteria above are met, the Group accounts for the promise to grant a licence as a performance obligation satisfied over time. Otherwise, the Group considers the grant of licence as providing the customers the right to use the Group's intellectual property and the performance obligation is satisfied at a point in time at which the licence is granted.

A contract asset represents the Group's right to consideration in exchange for goods or services that the Group has transferred to a customer that is not yet unconditional. It is assessed for impairment in accordance with HKFRS 9. In contrast, a receivable represents the Group's unconditional right to consideration, i.e. only the passage of time is required before payment of that consideration is due.

A contract liability represents the Group's obligation to transfer goods or services to a customer for which the Group has received consideration (or an amount of consideration is due) from the customer.

A contract asset and a contract liability relating to the same contract are accounted for and presented on a net basis.

# Contracts with multiple performance obligations (including allocation of transaction price)

For contracts that contain more than one performance obligations, the Group allocates the transaction price to each performance obligation on a relative stand-alone selling price basis.

The stand-alone selling price of the distinct good or service underlying each performance obligation is determined at contract inception. It represents the price at which the Group would sell a promised good or service separately to a customer. If a stand-alone selling price is not directly observable, the Group estimates it using appropriate techniques such that the transaction price ultimately allocated to any performance obligation reflects the amount of consideration to which the Group expects to be entitled in exchange for transferring the promised goods or services to the customer.

# Over time revenue recognition: measurement of progress towards complete satisfaction of a performance obligation

#### Output method

The progress towards complete satisfaction of a performance obligation is measured based on output method, which is to recognise revenue on the basis of direct measurements of the value of the goods or services transferred to the customer to data relative to the remaining goods or services promised under the contract, that best depict the Group's performance in transferring control of goods or services.

As a practical expedient, if the Group has a right to consideration in an amount that corresponds directly with the value of the Group's performance completed to date, the Group recognises revenue in the amount to which the Group has the right to invoice.

#### Principal versus agent

When another party is involved in providing goods or services to a customer, the Group determines whether the nature of its promise is a performance obligation to provide the specified goods or services itself (i.e. the Group is a principal) or to arrange for those goods or services to be provided by the other party (i.e. the Group is an agent).

The Group is a principal if it controls the specified goods or services before that goods or services is transferred to a customer.

The Group is an agent if its performance obligation is to arrange for the provision of the specified goods or services by another party. In this case, the Group does not control the specified goods or services provided by another party before that goods or services is transferred to the customer. When the Group acts as an agent, it recognises revenue in the amount of any fee or commission to which it expects to be entitled in exchange for the specified goods or services to be provided by the other party.

For trading of wine and daily supplies that is incidental to the cultural and entertainment segment in the People's Republic of China (the "PRC"), the Group determines if it acted as the principal by considering its primarily obligation in a transaction, e.g. inventory risk or latitude in establishing prices and selecting suppliers.

 Selecting suppliers — the Group performs supplier due diligence before contracting with the wine distributors and promoting the wine products to the customers. The Group selects the suppliers based on the unit price and number of purchase units.

- Establishing prices the Group could determine the selling price of the wine and liquors by itself within a range of the suggested selling price. The credit period offered by the suppliers is usually 15 days and the credit period the Group offer to the customers is 6 months. As such, the Group need to bear the credit risk.
- Inventory risk the Group stored inventories in the warehouse before the wine has been transferred to customer. Before such transfer, the Group need to bear the cost of damaged products and has the ability and is free to direct the use of and obtain substantially all of the benefits from the purchased wine before it is transferred to the customers.

Management of the Group considers that the Group is acting as a principal in the Trading Business because it obtains control of the wine and liquor and daily supplies before they are transferred to customers. Therefore, trading revenue was recognised in the gross amount of consideration.

## **Taxation**

Income tax expense represents the sum of the tax currently payable and deferred tax.

#### **Current tax**

The tax currently payable is based on taxable profit for the year. Taxable profit differs from "profit/loss before tax" because of income or expense that are taxable or deductible in other years and items that are never taxable or deductible. The Group's liability for current tax is calculated using tax rates that have been enacted or substantively enacted by the end of the reporting period.

Deferred tax is recognised on temporary differences between the carrying amounts of assets and liabilities in the consolidated financial statements and the corresponding tax bases used in the computation of taxable profit. Deferred tax liabilities are generally recognised for all taxable temporary differences. Deferred tax assets are generally recognised for all deductible temporary differences to the extent that it is probable that taxable profits will be available against which those deductible temporary differences can be utilised. Such deferred tax assets and liabilities are not recognised if the temporary difference arises from the initial recognition (other than in a business combination) of assets and liabilities in a transaction that affects neither the taxable profit nor the accounting profit. In addition, deferred tax liabilities are not recognised if the temporary difference arises from the initial recognition of goodwill.

Deferred tax liabilities are recognised for taxable temporary differences associated with investments in subsidiaries and associates, and interests in joint ventures, except where the Group is able to control the reversal of the temporary difference and it is probable that the temporary difference will not reverse in the foreseeable future. Deferred tax assets arising from deductible temporary differences associated with such investments and interests are only recognised to the extent that it is probable that there will be sufficient taxable profits against which to utilise the benefits of the temporary differences and they are expected to reverse in the foreseeable future.

The carrying amount of deferred tax assets is reviewed at the end of each reporting period and reduced to the extent that it is no longer probable that sufficient taxable profits will be available to allow all or part of the asset to be recovered.

Deferred tax assets and liabilities are measured at the tax rates that are expected to apply in the period in which the liability is settled or the asset realised, based on tax rates (and tax laws) that have been enacted or substantively enacted by the end of the reporting period.

### **Deferred tax** (Continued)

The measurement of deferred tax liabilities and assets reflects the tax consequences that would follow from the manner in which the Group expects, at the end of the reporting period, to recover or settle the carrying amount of its assets and liabilities.

For the purpose of measuring deferred tax for leasing transactions in which the Group recognises the right-of-use assets and the related lease liabilities, the Group first determines whether the tax deductions are attributable to the right-of-use assets or the lease liabilities.

For leasing transactions in which the tax deductions are attributable to the lease liabilities, the Group applies HKAS 12 requirements to the leasing transaction as a whole. Temporary differences relating to right-of-use assets and lease liabilities are assessed on a net basis. Excess of depreciation on right-of-use assets over the lease payments for the principal portion of lease liabilities resulting in net deductible temporary differences.

Deferred tax assets and liabilities are offset when there is a legally enforceable right to set off current tax assets against current tax liabilities and when they relate to income taxes levied to the same taxable entity by the same taxation authority.

#### Current and deferred tax for the year

Current and deferred tax are recognised in profit or loss, except when they relate to items that are recognised in other comprehensive income or directly in equity, in which case, the current and deferred tax are also recognised in other comprehensive income or directly in equity respectively. Where current tax or deferred tax arises from the initial accounting for a business combination, the tax effect is included in the accounting for the business combination.

# **Employee benefits**

### **Retirement benefits cost**

The Group participates in defined contribution retirement schemes for its employees in Hong Kong, the PRC and overseas. The Group operates a Mandatory Provident Fund Scheme (the "MPF Scheme") under the Mandatory Provident Fund Schemes Ordinance (Chapter 485 of the Laws of Hong Kong) for employees employed under the jurisdiction of the Employment Ordinance (Chapter 57 of the Laws of Hong Kong). The MPF Scheme is a defined contribution retirement plan administered by independent trustees. Under the MPF Scheme, the employer and its employees are each required to make contributions to the MPF Scheme at 5% of the employees' relevant income, subject to a cap of monthly relevant income of HK\$30,000. Contributions to the MPF Scheme vest immediately.

Pursuant to the relevant labour rules and regulations in the PRC, employees of the Group in the PRC participated in the central pension scheme (the "Central Pension Scheme"), which is a defined contribution plan administered by the PRC government, whereby the Group is required to make contributions to the Central Pension Scheme based on certain percentages of the employees' salaries. The local government authorities are responsible for the entire pension obligations payable to the retired employees. Contributions made to the Central Pension Scheme vest immediately.

During the years ended 30 June 2022 and 2021, there was no contributions forfeited by the Group on behalf of its employees who leave the plan prior to vesting fully in such contribution, nor had there been any utilisation of such forfeited contributions to reduce future contributions. As at 30 June 2022 and 2021, no forfeited contribution under the retirement benefits schemes of the Group is available to reduce the contribution payable in future years.

For grants of share options that are conditional upon satisfying specified vesting conditions, the fair value of services received is determined by reference to the fair value of share options granted at the grant date and is expensed on a straight-line basis over the vesting period, with a corresponding increase in equity (share option reserve).

At the end of the reporting period, the Group revised its estimates of the number of equity instruments that are expected to ultimately vest. The impact of the revision of the original estimates, if any, is recognised in profit or loss such that the cumulative expense reflects the revised estimate, with a corresponding adjustment to share option reserve transferred to retained profits.

For share options that vest immediately at the date of grant, the fair value of the share options granted is expensed immediately to profit or loss.

When share options are exercised, the amount previously recognised in the share option reserve will be transferred to share capital and share premium. When the share options are forfeited after the vesting date or are still not exercised at the expiry date, the amount previously recognised in share option reserve will be transferred to retained earnings.

#### **Borrowing costs**

All borrowing costs are recognised in profit or loss in the period in which they are incurred.

## **Government grants**

Government grants are not recognised until there is reasonable assurance that the Group will comply with the conditions attaching to them and that the grants will be received.

Government grants are recognised in profit or loss on a systematic basic over the periods in which the Group recognised as expense the related costs for which the grants are intended to compensate. Government grants that are receivable as compensation for expenses or losses already incurred or for the purpose of giving immediate financial support to the Group with no future related costs are recognised in profit or loss in the period in which they become receivable.

#### **Provisions**

Provisions are recognised when the Group has a present obligation (legal or constructive) as a result of a past event, it is probable that the Group will be required to settle the obligation, and a reliable estimate can be made of the amount of the obligation.

The amount recognised as a provision is the best estimate of the consideration required to settle the present obligation at the end of the reporting period, taking into account the risks and uncertainties surrounding the obligation. When a provision is measured using the cash flows estimated to settle the present obligation, its carrying amount is the present value of those cash flows (when the effect of the time value of money is material).

# **Contingent liabilities and contingent assets**

A contingent liability is a possible obligation that arises from past events and whose existence will only be confirmed by the occurrence or non-occurrence of one or more uncertain future events not wholly within the control of the Group. It can also be a present obligation arising from past events that is not recognised because it is not probable that outflow of economic resources will be required or the amount of obligation cannot be measured reliably. A contingent liability is not recognised but is disclosed. When a change in the probability of an outflow occurs so that outflow is probable, they will then be recognised as a provision.

A contingent asset is a possible asset that arises from past events and whose existence will be confirmed only by the occurrence or non-occurrence of one or more uncertain future events not wholly within the control of the Group. A contingent asset is not recognised but is disclosed when an inflow of economic benefits is probable. When inflow is virtually certain, an asset is recognised.

## **Foreign currencies**

In preparing the financial statements of each individual group entity, transactions in currencies other than the entity's functional currency (foreign currencies) are recognised at the rates of exchange prevailing at the dates of the transactions. At the end of the reporting period, monetary items denominated in foreign currencies are retranslated at the rates prevailing at that date. Non-monetary items carried at fair value that are denominated in foreign currencies are retranslated at the rates prevailing at the date when the fair value was determined. Non-monetary items that are measured in terms of historical cost in a foreign currency are not retranslated.

Exchange differences arising on the settlement of monetary items, and on the retranslation of monetary items, are recognised in profit or loss in the period in which they arise, except for exchange differences on monetary items receivable from or payable to a foreign operation for which settlement is neither planned nor likely to occur (therefore forming part of the net investment in the foreign operation), which are recognised initially in other comprehensive income and reclassified from equity to profit or loss on disposal or partial disposal of the Group's interests in associates.

For the purposes of presenting consolidated financial statements, the assets and liabilities of the Group's foreign operations are translated into the presentation currency of the Group (i.e. Hong Kong dollars) using exchange rates prevailing at the end of each reporting period. Income and expense items are translated at the average exchange rates for the period, unless exchange rates fluctuate significantly during that period, in which case the exchange rates at the dates of the transactions are used. Exchange differences arising, if any, are recognised in other comprehensive income and accumulated in equity under the heading of exchange reserve (attributed to non-controlling interests as appropriate).

On the disposal of a foreign operation (i.e. a disposal of the Group's entire interest in a foreign operation, or a disposal involving loss of control over a subsidiary that includes a foreign operation, or a partial disposal of an interest in a joint arrangement or an associate that includes a foreign operation of which the retained interest becomes a financial asset), all of the exchange differences accumulated in equity in respect of that operation attributable to the owners of the Company are reclassified to profit or loss.

Goodwill and fair value adjustments to identifiable assets acquired and liabilities assumed through acquisition of a foreign operation are treated as assets and liabilities of the foreign operation and translated at the rate of exchange prevailing at the end of each reporting period. Exchange differences arising are recognised in other comprehensive income.

In the application of the Group's accounting policies, which are described in Note 3, the directors of the Company are required to make judgements, estimates and assumptions about the carrying amounts of assets and liabilities that are not readily apparent from other sources. The estimates and associated assumptions are based on historical experience and other factors that are considered to be relevant. Actual results may differ from these estimates

The estimates and underlying assumptions are reviewed on an on-going basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods.

# Critical judgements in applying accounting policies

The following are the critical judgements, apart from those involving estimations, that the directors of the Company have made in the process of applying the Group's accounting policies and that have most significant effect on the amounts recognised in the consolidated financial statements.

# Determining whether the Group is acting as a principal or as an agent in trading of goods

Management of the Group considered that the Group is acting as a principal in this business because it obtains control of the products sold before they are transferred to customers. If control is unclear, when the Group is primarily obligated in a transaction, is subject to inventory risk, has latitude in establishing prices and selecting suppliers, or has several but not all of these indicators, gross amount of the sales and cost of sales are recorded. In determining whether the Group is acting as a principal or as an agent, management is required to exercise significant judgements and to consider all relevant facts and circumstances of the business.

## **Key sources of estimation uncertainty**

The following are the key assumptions concerning the future, and other key sources of estimation uncertainty at the end of the reporting period that may have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year.

#### Income taxes

The Group is subject to income taxes in various tax authorities. Significant judgement is required in determining the provision for income taxes and the timing of payment of the related tax. There are certain transactions and calculations for which the ultimate tax determination is uncertain during the ordinary course of business. The Group recognises liabilities for anticipated tax based on estimates of whether additional taxes will be due. Where the final tax outcome of these matters is different from the amounts that were initially recorded, such differences will impact the income tax provision in the period in which such determination is made.

#### **Depreciation and amortisation**

Property, plant and equipment, right-of-use assets and intangible assets (see Notes 16, 17 and 18 to the consolidated financial statements respectively) are depreciated and amortised on a straight-line basis over their estimated useful lives. The Group annually reviews the useful life of an asset and its residual value, if any. The useful life is based on the Group's historical experience with similar assets and taking into account anticipated technology changes. The depreciation and amortisation expenses for future periods are adjusted if there are significant changes from previous estimates.

At the end of the reporting period, the Group reviews the carrying amounts of its intangible assets to determine whether there is any indication that those assets have suffered an impairment loss. If any such indication exists, the recoverable amount of the asset is estimated in order to determine the extent of the impairment loss, if any. If the recoverable amount of an intangible asset is estimated to be less than its carrying amount, the carrying amount of the asset is reduced to its recoverable amount. An impairment loss is recognised as an expense immediately. As at 30 June 2022, the carrying amount of intangible assets was approximately HK\$1,035,000 (2021: approximately HK\$2,210,000) after taking into account that no the impairment loss is recognised (2021: HK\$Nil).

### **Deferred tax assets**

At 30 June 2022, deferred tax assets of approximately HK\$11,149,000 (2021: approximately HK\$\$809,000) in relation to the timing differences on revenue recognition and impairment allowances for credit loss has been recognised in the Group's consolidated statement of financial position. No deferred tax asset has been recognised on the tax losses of approximately HK\$9,114,000 (2021: approximately HK\$8,141,000) due to the unpredictability of future profit streams. The realisability of the deferred tax asset mainly depends on whether sufficient future profits or taxable temporary differences will be available in the future. In cases where the actual future taxable profits generated are less or more than expected, or change in facts and circumstances which result in revision of future taxation profits estimation, a material reversal or further recognition of deferred tax assets may arise, which would be recognised in profit or loss for the period in which such a reversal or further recognition takes place.

#### Allowance for inventories

At the end of the reporting period, the Group reviews its inventories and considers to make allowance for obsolete and slow-moving inventory items identified that are no longer marketable or suitable for sell. Management estimates the net realisable value for such items based primarily on the latest invoice prices and current market conditions.

### **Provision of ECL**

The measurement of impairment losses under HKFRS 9 across all categories of financial assets requires significant judgement and estimation, in particular, the assessment of a significant increase in credit risk and credit-impaired financial assets as well as the estimation of the amount and timing of future cash flows and collateral values when determining impairment losses. These estimates are driven by a number of factors, changes in which can result in different levels of allowances. At each reporting date, the Group assesses whether there has been a significant increase in credit risk for exposures since initial recognition by comparing the risk of default occurring over the expected life between the reporting date and the date of initial recognition. The Group considers reasonable and supportable information that is relevant and available without undue cost or effort for this purpose. This includes quantitative and qualitative information and also, forward-looking analysis. Details of the key assumptions and inputs used are set out in Note 5 to the consolidated financial statements.

# Fair value measurements of other financial instruments

Some of the Group's financial assets are measured at fair value for financial reporting purposes. In estimating the fair value of an asset or a liability, the Group uses market-observable data to the extent it is available. Where Level 1 inputs are not available, the Group engages an independent professional valuer to perform the valuation. The Group uses valuation techniques that include inputs that are not based on observable market data to estimate the fair value of certain types of financial instruments. Note 5(c) provides detailed information about the valuation techniques, inputs and key assumptions used in the determination of the fair value.

# (b) Financial risk management objectives and policies

The Group's major financial instruments include trade receivables, factoring receivables, lease receivables, loan receivables, deposits, other receivables, cash and cash equivalents, financial assets at FVTPL, trade payables, accruals and other payables, corporate bonds and lease liabilities. The details of these financial instruments are disclosed in the respective notes. The risks associated with these financial instruments and the policies on how to mitigate these risks are set out below. The management manages and monitors these exposures to ensure appropriate measures are implemented on a timely and effective manner.

The main risks arising from the Group's financial instruments are credit risk, liquidity risk, interest rate risk, currency risk and price risk. The directors of the Company review and agree policies for managing each of these risks and they are summarised below.

### Credit risk and impairment assessment

The Group's maximum exposure to credit risk which will cause a financial loss to the Group due to failure to discharge an obligation by the counterparties equal to the carrying amount of the respective recognised financial assets as stated in the consolidated statement of financial position.

In respect of trade receivables, in order to minimise the credit risk, Group has delegated a team responsible for determination of credit limits and credit approvals. Before accepting any new customer, the Group will assess the potential customer's credit quality and defines credit limits by individual customer. Receivables due from customers are due within the settlement period commonly adopted by the relevant market convention, which is usually within 90 days except for trading of goods which settlement is made in accordance with the terms specified in the contracts governing the relevant transactions. Normally, the Group does not hold any collateral or other credit enhancement over its trade receivables balances. Other monitoring procedures are in place to ensure the follow-up action is taken to recover overdue debts. In addition, the Group performs impairment assessment under ECL model at the end of each reporting period to ensure that adequate impairment losses are made. In this regard, the directors of the Company consider that the Group's credit risk is significantly reduced.

In respect of factoring receivables, lease receivables and loan receivables from customers. the objective of the Group's measure to manage credit risk is to control the potential exposure to the recoverability problem. The Group manages and analyses the credit risk of each of their new and existing customers before payment terms and conditions are concluded by assessing the credit quality of the customer, taking into account its financial position, past settlement experience and other factors. Factoring receivables, lease receivables and loan receivables balances are monitored on an on-going basis, management reviews the recoverable amount at each reporting date to ensure that adequate impairment losses are made for irrecoverable amounts. Interest income are usually billed on monthly or quarterly basis. The factoring receivables and lease receivables are also guaranteed by directors of the customers as additional security for shortfalls on collect outs due to dispute or breach of contract for which the guarantor is liable. Other monitoring procedures are in place to ensure that follow-up action is taken to recover overdue debts. In addition, the Group performs impairment assessment under ECL model at the end of each reporting period to ensure that adequate impairment losses are made. In this regard, the directors of the Company consider that the Group's credit risk is significantly reduced.

The credit risk on liquid funds is limited because the counterparties are banks and other financial institutions which are reputable in the opinion of management.

The Group's policy requires the review of individual outstanding amounts regularly depending on individual circumstance or market condition.

The management is responsible in developing and maintaining the processes for measuring ECL, the impairment requirements under HKFRS 9. The Group applies simplified approach to measure ECL on trade receivables and general approach to measure ECL on factoring receivables, lease receivables, loan receivables and other financial assets classified at amortised cost. Under the simplified approach, the Group measures the loss allowance at an amount equal to lifetime ECL. Under the general approach, financial assets migrate through the following three stages based on the change in credit risk since initial recognition: Stage 1: 12m ECL, Stage 2: Lifetime ECL — not credit-impaired and Stage 3: Lifetime ECL — credit-impaired.

For such financial assets classified as Stage 1 and 2, the management assesses loss allowances using the risk parameter modelling approach that incorporates key parameters, including probability of default ("PD"), loss given default ("LGD") and exposure at default ("EAD"). For credit-impaired financial assets classified as Stage 3, the management assesses the credit loss allowances by estimating the future cash flows expected to arise from the financial assets.

The Group adopts judgement, assumptions and estimation techniques in order to measure ECL according to the requirements of accounting standards such as:

#### (i) Criteria for judging significant increase in credit risk

The Group assesses whether or not the credit risk of the relevant financial instruments has increased significantly since the initial recognition at each reporting date. While determining whether the credit risk has significantly increased since initial recognition or not, the Group takes into account the reasonable and substantiated information that is accessible without exerting unnecessary cost or effort, including qualitative and quantitative analysis based on the historical data of the Group, credit rating grade, and forward-looking information. Based on the single financial instrument or the combination of financial instruments with similar characteristics of credit risk, the Group compares the risk of default of financial instruments on the reporting date with that on the initial recognition date in order to figure out the changes of default risk in the expected lifetime of financial instruments.

- Qualitative criteria: Significant adverse change in debtor's operation or financial status.

For factoring receivables and lease receivables, the number of days past due and loan-to-collateral value were used to estimate significant increase in credit risk. Other financial assets at amortised cost use number of days past due as determinant of credit risk.

  - Internal rating of the debtor indicating default or near-default;

The LGD is the percentage of loss of risk exposure at the time of default, calculated over the next 12 months or over the entire remaining lifetime;

#### Interest rate risk

The Group is exposed to fair value interest rate risk in relation to fixed coupon rate corporate bonds and lease liabilities. The Group is also exposed to cash flow interest rate risk relating to the Group's variable-rate bank balances.

The Group's exposure to interest rates on bank balances is considered insignificant and the interest rate on corporate bonds is shown in the liquidity risk section of this note. The Group's cash flow interest rate risk is mainly concentrated on the fluctuation of the prevailing market interest rate in Hong Kong and the PRC. During the year ended 30 June 2022, with reference to the professional valuation performed by the Peak Vision, the management of the Group has determined that an impairment loss of approximately HK\$111,418,000 (2021: approximately HK\$35.947.000) arose in relation to goodwill allocated to certain groups of CGUs. There were no material changes in the methodology and sources of market data applied in the valuation between 2022 and 2021. After reviewing the performance of Fortune Selection CGU and Cheer Sino CGU in 2022, the management of the Group revised the carrying amounts of Fortune Selection CGU and Cheer Sino CGU downwards based on cash flow forecasts. The cash flow forecasts, growth rates and discount rate as at 30 June 2022 have been reassessed taking into consideration higher degree of estimation uncertainties due to how the COVID-19 pandemic may progress and evolve.

The Eligible Persons shall accept the offer at the date not later than 21 days from the offer date or otherwise be deemed to have declined it. An option may be exercised in accordance with the terms of the Share Option Scheme at any time during a period to be determined and notified by the Board of Directors to each grantee, which period may commence on a day after the date upon which the offer for the grant of options is made but shall end in any event not later than 10 years from the date of grant of the option subject to the provisions for early termination thereof. Unless otherwise determined by the Board of Directors and stated in the offer of the grant of options to a grantee, there is no minimum period required under the Share Option Scheme for the holding of an option before it can be exercised.
