

## CHARACTERISTICS OF GEM OF THE STOCK EXCHANGE OF HONG KONG LIMITED (THE "STOCK EXCHANGE")

GEM has been positioned as a market designed to accommodate small and mid-sized companies to which a higher investment risk may be attached than other companies listed on the Stock Exchange. Prospective investors should be aware of the potential risks of investing in such companies and should make the decision to invest only after due and careful consideration.

#### MANAGEMENT DISCUSSION AND ANALYSIS

### 管理層討論及分析

### BUSINESS REVIEW AND FUTURE OUTLOOK Business Review

### Retail chain business in lighting and designer label furniture

Retail chain business in lighting and designer label furniture is the core business of the Company and its subsidiaries (collectively referred to as the "Group"). Being one of the most established retail chain groups of lighting products in Hong Kong, E Lighting possesses rich experience in the sale of quality lighting and designer label furniture products from all over the world. During the six months ended 30 September 2022 (the "Reporting Period"), the Group timely adjusted its product strategies and actively carried out promotion activities.

During the Reporting Period, revenue of the retail chain business in lighting and designer label furniture was approximately HK\$42,636,000, accounted for approximately 99% of the Group's revenue.

#### Tableware, giftware and other business

Tableware, giftware and other business is mainly for wholesale of tableware, giftware and other trading, which has expanded the Group's business portfolio, and broadened its source of income and generated additional cash flows. During the Reporting Period, revenue of the tableware, giftware and other business was approximately HK\$17,000, accounted for approximately 1% of the Group's revenue.

#### **Future Outlook**

The Directors foresee that the Hong Kong retail market remains challenging, retail market would continue to be affected by the development of local epidemic in the near term. The decline in global infection rates and mass vaccination programs around the world have shed some light on the situation. The Directors expect a recovery when social distancing rules are relaxed. The Directors believe that the Electronic Consumption Voucher Scheme organized by the Government will be a catalyst for local consumption in the last quarter in 2022. The Group will closely monitor the trend of the business environment, timely adjust its product strategies and actively carry out promotion activities, maintain pragmatic approach for its business and take every chance to identify any suitable opportunity in the market for the Group.

### 業務回顧及未來展望

燈飾及設計師品牌家具的零售連鎖業務

燈飾及設計師品牌家具的零售連鎖業務為本公司及其附屬公司(統稱為「本集團」)的核心業務。壹照明作為全港最具規模的燈飾零售連鎖集團之一,於銷售來自世界各地的優質品牌燈飾及設計師家具方面擁有豐富經驗。於截至二零二二年九月三十日止六個月(「報告期」)內,本集團適時調整產品策略及積極進行推廣活動。

於報告期內,來自經營燈飾及設計師品牌家具的零售連鎖業務的營業額約42,636,000港元, 佔本集團營業額約99%。

#### 餐具禮品及其他業務

餐具禮品及其他業務主要為批發餐具禮品及其 他貿易,令本集團業務組合得以擴大,並產生 多元收入及額外現金流。於報告期內,來自經 營餐具禮品及其他業務的營業額約17,000港元, 佔本集團營業額約1%。

#### 未來展望

The Group will continue to concentrate on the consolidation of its retail network, optimisation of product mix and intensification of cost control, and will also continue to seize opportunities to stabilise growth through cautious strategic planning. In the meantime, the Group is actively developing smart home and related products and closely looking for new opportunities for those businesses.

Looking forward, housing is one of the biggest concerns and needs for Hong Kong citizens and housing is closely related to demand of lighting and household products. Therefore, the Group is afforded with new opportunities in its various lines of business. The Group will adopt more cautious strategies, which will be executed with prudence and closely control its expenditure in order to maintain its competitiveness. The Group will strive to maintain a streamlined business operation, while catering for consumers' specific needs and being responsive to market changes. Leveraging the support of the capital market, its own strengths, and the global trends of saving energy, protecting the environment and pursuing a higher quality of life, the Group is cautiously confident of its development in the future. The Group will strive to maintain steady growth and to maximise returns for the investors.

#### FINANCIAL REVIEW

#### Revenue

During the Reporting Period, the Group's revenue was approximately HK\$42,653,000, representing a decrease of approximately 5.4% from approximately HK\$45,083,000 as compared with that of the corresponding period in last year, which was mainly due to the continuous impact of the local epidemic in the retail market.

During the Reporting Period, revenue of the retail chain business in lighting and designer label furniture was approximately HK\$42,636,000, representing a decrease of approximately 5.0% from approximately HK\$44,862,000 as compared with that of the corresponding period in last year.

During the Reporting Period, revenue of the tableware, giftware and other business was approximately HK\$17,000, representing a decrease of approximately 92.3% from approximately HK\$221,000 as compared with that of the corresponding period in last year.

本集團除了繼續專注於其零售網絡整合、產品 組合優化及加強成本控制外,亦透過審慎的策 略規劃,繼續把握機會穩定增長。與此同時, 本集團正積極發展智能家居及與相關產品,並 正密切尋找相關業務的機遇。

#### 財務回顧

#### 營業額

於報告期內,本集團的營業額約42,653,000港元,較去年同期約45,083,000港元減少約5.4%,主要由於本地疫情的持續發展對零售市場的影響。

於報告期內,來自經營燈飾及設計師品牌家具的零售連鎖業務的營業額約42,636,000港元,較去年同期約44,862,000港元減少約5.0%。

於報告期內,來自經營餐具禮品及其他業務的營業額約17,000港元,較去年同期約221,000港元減少約92.3%。

#### **Gross Profit and Gross Profit Margin**

During the Reporting Period, the Group's gross profit was approximately HK\$23,448,000, representing a decrease of approximately 5.8% from approximately HK\$24,902,000 as compared with that of the corresponding period in last year. The decrease was primarily due to decrease in sales. During the Reporting Period, the Group's overall gross profit margin was approximately 55.0%.

#### **Selling and Distribution Expenses**

During the Reporting Period, the Group's selling and distribution expenses was approximately HK\$14,061,000, representing a decrease of approximately 2.7% from approximately HK\$14,458,000 as compared with that of the corresponding period in last year. Selling and distribution expenses primarily consists of rentals for retail outlets and related expenses, depreciation on right-of-use assets, staff costs (including salaries and sales commission to salespersons) and electronic payment charges.

#### **Administrative and Other Expenses**

During the Reporting Period, the Group's administrative and other expenses was approximately HK\$7,762,000, representing an increase of approximately 15.9% from approximately HK\$6,695,000 as compared with that of the corresponding period in last year. Administrative and other expenses primarily consists of rentals for warehousing facilities, depreciation of right-of-use assets of office premises and warehousing facilities, staff costs (including salaries to administrative staff and emoluments to Directors) and professional expenses. The increase was primarily due to increase in depreciation of right-of-use assets and staff cost.

#### **Profit for the Period**

The Group recorded a profit of approximately HK\$2,246,000 during the Reporting Period (six months ended 30 September 2021: profit of approximately HK\$2,932,000).

#### DIVIDEND

The Board does not recommend the payment of any dividend for the six months ended 30 September 2022 (six months ended 30 September 2021: Nil).

#### 毛利及毛利率

於報告期內,本集團的毛利約23,448,000港元,較去年同期約24,902,000港元減少約5.8%。增加主要由於銷售減少所致。於報告期內,本集團的整體毛利率約55.0%。

#### 銷售及分銷開支

於報告期內,本集團的銷售及分銷開支約 14,061,000港元,較去年同期約14,458,000港 元減少約2.7%。銷售及分銷開支主要包括零售 店舖的租金及相關開支、使用權資產折舊、員 工成本(包括薪金及售貨員佣金)及電子付款費 用。

#### 行政及其他開支

於報告期內,本集團的行政及其他開支約7,762,000港元·較去年同期約6,695,000港元增加約15.9%。行政及其他開支主要包括倉庫設施租金,辦公室物業及倉庫設施使用權資產折舊,員工成本(包括行政人員的薪金及董事薪酬)及專業費用。增加主要由於使用權資產折舊及員工成本增加所致。

#### 期內溢利

於報告期內,本集團錄得溢利約2,246,000港元 (截至二零二一年九月三十日止六個月:溢利約 2,932,000港元)。

#### 股息

董事會不建議就截至二零二二年九月三十日止 六個月派付任何股息(截至二零二一年九月三十 日止六個月:無)。

## NOTES TO THE CONDENSED CONSOLIDATED FINANCIAL STATEMENTS

#### 1. CORPORATE INFORMATION

The Company was incorporated in the Cayman Islands as an exempted company with limited liability on 29 November 2013 under the Companies Law. Cap. 22 (Law 3 of 1961, as consolidated and revised) of the Cayman Islands. The address of the Company's registered office is 4th Floor, Harbour Place, 103 South Church Street, George Town, P.O. Box 10240, Grand Cayman KY1-1002, Cayman Islands and its principal place of business in Hong Kong is 10/F, Tiffan Tower, 199 Wanchai Road, Wanchai, Hong Kong. The Company's issued shares have been listed on GEM of The Stock Exchange of Hong Kong Limited ("Stock Exchange") since 29 September 2014.

The Company's principal activity is investment holding while the Group is principally engaged in retail chain business in lighting, designer label furniture and household products in Hong Kong and wholesale of tableware and giftware worldwide.

#### 2. BASIS OF PREPARATION

The unaudited condensed consolidated financial statements of the Group for the Reporting Period have been prepared in accordance with Hong Kong Accounting Standard 34 "Interim Financial Reporting" and all applicable Hong Kong Financial Reporting Standards, Hong Kong Accounting Standards ("HKASs") and Interpretations (hereinafter collectively referred to as the "HKFRSs") and the applicable disclosure requirements of the Hong Kong Companies Ordinance and GEM Listing Rules.

The unaudited condensed consolidated financial statements have been prepared under the historical cost convention. The accounting policies and methods of computation used in the preparation of the unaudited condensed consolidated financial statements are consistent with those used in the annual financial statements of the Group for the year ended 31 March 2022 as set out in the Annual Report 2021/22 of the Company, which have been prepared in accordance with HKFRSs. The unaudited condensed consolidated financial statements should be read in conjunction with the annual financial statements of the Group for the year ended 31 March 2022

In the current period, the HKICPA has issued a number of new and revised HKFRSs and interpretations that are first effective for the current accounting period of the Group. The Group has adopted all these new and revised HKFRSs and interpretations that are relevant to its operation. The adoption of these new and revised HKFRSs had no significant effects on the results of the Group for the current and prior periods.

#### 1. 公司資料

本公司的主要業務為投資控股,而本集團 則主要於香港經營燈飾及設計師品牌家具 及家居產品的零售連鎖業務及批發餐具及 禮品至世界各地。

#### 2. 編製基準

本集團於報告期的未經審核簡明綜合財務報表乃按香港會計準則第34號「中期財務報告」及適用的香港財務報告準則、香港會計準則(「香港會計準則」)及詮釋(統稱為「香港財務報告準則」)及GEM上市規則及香港公司條例之適用披露要求編製。

未經審核簡明綜合財務報表已按歷史成本法編製。編製未經審核簡明綜合財務報表所用會計政策及計算方法與本公司2021/22年報所載本集團截至二零二二年三月三十一日止年度的全年財務報表所開報表應與本集團截至二零二二年三月三十一日止年度的全年財務報表(根據香港財務報告準則編製)一併閱覽。

於本期間,香港會計師公會已頒佈多項於本集團目前會計期間首次生效的新訂及經修訂香港財務報告準則及詮釋。本集團已採納所有與其營運相關的此等新訂及經修訂香港財務報告準則及詮釋。應用此等新訂及經修訂香港財務報告準則對本集團目前及以往期間的業績並無造成重大影響。

#### 2. BASIS OF PREPARATION (continued)

The Group has not early adopted the new and revised HKFRSs that have been issued, but are not yet effective for the current period. The Group's current intention is to apply these changes on the date they become effective. The Group is in the process of assessing, where applicable, the potential impact of these new and revised HKFRSs that will be effective in future periods but is not yet in a position to state whether these new and revised HKFRSs would have a material impact on the Group's results of operation.

The preparation of the unaudited condensed consolidated financial statements in conformity with the HKFRSs requires the use of certain critical accounting estimates. It also requires the management to exercise their judgments in the process of applying the Group's accounting policies.

The unaudited condensed consolidated financial statements are presented in Hong Kong dollars ("HK\$"), which is the same as the functional currency of the Company.

The unaudited condensed consolidated financial statements have been reviewed by the Company's audit committee.

#### 3. SEGMENT INFORMATION

Operating segments are reported in a manner consistent with the internal reporting, in accordance with the Group's internal organisation and reporting structure, provided to the chief operating decision-maker to make strategic decisions.

The Group has two reportable segments. The segments are managed separately as each business offers different products and requires different business strategies. The following summary describes the operations in each of the Group's reportable segments:

Lighting and furniture business

 retail of lighting products and household furniture in Hong Kong

Tableware, giftware and other business

 retail and wholesale of tableware and giftware and other trading worldwide
