### Personal Information Collection Statement

- Reasons for the collection of your personal data**

To elect the Partial Cash Alternative for your Share(s), you must provide the personal data requested. Any failure to supply the requested data may result in the processing of your election being rejected or delayed. It may also prevent or delay the distribution of the eSun Consideration Shares to which you may be entitled to under the Partial Cash Alternative.
- Purposes**

The personal data which you provide in this Election Form may be used, held and/or stored (by whatever means) for the following purposes:

  - processing of your election and verification of compliance with the terms and procedures set out in this Election Form and the Scheme Document;
  - establishing your entitlements under the Partial Cash Alternative;
