

#### 主席報告

本人欣然宣佈二零二二年之全年業績。

#### 財務業績

本集團截至二零二二年十二月三十一日止年度之收入為38,379,000港元(二零二一年:38,166,000港元),較去年增加213,000港元或0.56%。本年度虧損為43,701,000港元(二零二一年:年度虧損為1,563,052,000港元),較二零二一年減少1,519,351,000港元。截至二零二二年十二月三十一日止年度虧損減少之主要事項如下:

- 1. 於本年度應收貸款及利息之減值虧損為 22,691,000港元,相比去年度減值虧損為 74,370,000港元。這兩年度減值虧損之主 要原因是本集團於二零一八年以投資為目標,認購一間香港獨立上市集團發行之高級 票據違約所致:及
- 2. 沒有出售一間附屬公司之虧損約 1,467,958,000港元,此出售於二零二一年 十月完成。

每股虧損為3.52港仙(二零二一年:每股虧損為125.98港仙),而於二零二二年十二月三十一日,每股資產淨值為1.25港元(二零二一年:1.29港元)。

本公司之董事會(「董事會」)不建議宣派截至二零 二二年十二月三十一日止年度之股息(二零二一年 中期股息(代替末期股息):無)。

#### **CHAIRMAN'S STATEMENT**

I am pleased to present to you the annual results for 2022.

#### **Financial Results**

The revenue of the Group for the year ended 31st December, 2022 was HK\$38,379,000 (2021: HK\$38,166,000), an increase of HK\$213,000 or 0.56% compared to the year before. The loss for the year amounted to HK\$43,701,000 (2021: loss for the year of HK\$1,563,052,000), representing a decrease of HK\$1,519,351,000 from 2021. The primarily items for the decrease in loss for the year ended 31st December, 2022 are as follows:

- an impairment losses on loan and interest receivables of HK\$22,691,000 in current year as compared with an impairment losses of HK\$74,370,000 in last year. These impairment losses in both years are mainly caused by the default of a senior note issued by an independent listed group in Hong Kong, of which the Group has subscribed for investment purpose in 2018; and
- 2. the absence of a loss on disposal of a subsidiary of approximately HK\$1,467,958,000 which was completed in October 2021.

Loss per share amounted to HK3.52 cents (2021: loss per share of HK125.98 cents), while the net asset value per share was HK\$1.25 as at 31st December, 2022 (2021: HK\$1.29).

The board of directors of the Company ("Board") does not recommend the payment of a dividend for the year ended 31st December, 2022 (2021 interim dividend (in lieu of a final dividend): Nil).

# 釐定出席本公司即將舉行之股東週年大會(「二零二三年股東週年大會」)並於會上投票的資格

二零二三年股東週年大會預定於二零二三年五月二十三日(星期二)舉行。為釐定股東出席二零二三年股東週年大會並於會上投票的資格,本公司將由二零二三年五月十八日(星期四)至二零二三年五月二十三日(星期二)(包括首尾兩天)暫停辦理本公司股份過戶登記,在此期間本公司股份之轉讓手續將不予辦理。股東為符合資格出席二零二三年及東週年大會並於會上投票,須於二零二三年五月十七日(星期三)下午四時三十分前將所有過戶文件連同有關股票送交本公司之股份過戶登記處卓佳登捷時有限公司(地址為香港夏慤道16號遠東金融中心17樓)辦理股份過戶登記手續。

#### 管理層討論及分析

#### 業務回顧

本集團主要經營範圍包括:於香港經營物業投資、物業租賃及物業管理業務。

截至二零二二年十二月三十一日止年度,本集 團位於港晶中心的商用物業錄得平均租用率約 87%,但租金收入表現未如理想。

於二零二二年年初開始在香港的第五波新型冠狀病毒疫情期間,由於政府對指定零售場所實施強制關閉或限制,港晶中心的零售業務受到嚴重影響。因此,本集團於期內視乎行業向部份租戶給予租金寬免,導致港晶中心之租金收入減少。於二零二二年年底,放寬社交距離措施後,上述提及之寬免已很少,而租金收入已逐漸增加。

截至二零二二年止年度,本集團位於憶京中心的辦公室及一些分層住宅錄得租用率分別為90%和89%。

# For determining the entitlement to attend and vote at the forthcoming annual general meeting of the Company ("2023 AGM")

The 2023 AGM is scheduled to be held on Tuesday, 23rd May, 2023. For determining the entitlement to attend and vote at the 2023 AGM, the register of members of the Company will be closed from Thursday, 18th May, 2023 to Tuesday, 23rd May, 2023 (both days inclusive), during which period no transfer of shares of the Company will be registered. In order for a shareholder to be eligible to attend and vote at the 2023 AGM, all transfer forms accompanied by the relevant share certificates must be lodged with the Company's share registrar, Tricor Tengis Limited of 17th Floor, Far East Finance Centre, 16 Harcourt Road, Hong Kong for registration not later than 4:30 p.m. on Wednesday, 17th May, 2023.

#### Management Discussion and Analysis

#### **Business Review**

The Group's core businesses comprise property investment, property leasing and estate management in Hong Kong.

For the year ended 31st December, 2022, the Group's commercial properties situated at Harbour Crystal Centre recorded an average occupancy level of approximately 87%, but the performance of rental income was not so good as expected.

During the fifth wave of COVID-19 in Hong Kong starting in early 2022, retail business in Harbour Crystal Centre was seriously affected due to the mandatory closure or restrictions of designated retail premises adopted by the Government. As a result, the Group has granted rent concession to some tenants depending on the trades during the period resulting a decrease in rental income from Harbour Crystal Centre. Following the relaxation of social distancing measures in late 2022, the said concession granted was minimal and the rental income was getting increased.

The Group's office spaces in Billion Centre and some strata residential apartments recorded 90% and 89% occupancy rate respectively for the year ended 2022.

#### 財務回顧

#### 本集團之資產及抵押

本集團之總資產由去年度之1,791,326,000港元下降至本年度之1,741,114,000港元。本集團之資產淨值由去年度之1,605,421,000港元下降至本年度之1,554,105,000港元。於二零二二年十二月三十一日,本集團於本港之投資物業並無(二零二一年:無)已抵押於銀行作為資金融通之抵押。本集團雖然無銀行借貸,但如有需要會向銀行提出申請事宜,銀行亦同意提供資金融通予本集團。

#### 本集團之財務狀況、流動資金及融資

本集團之總負債由二零二一年十二月三十一日之185,905,000港元上升至二零二二年十二月三十一日止之187,009,000港元。於二零二二年十二月三十一日,本集團之現金及銀行存款為147,668,000港元(二零二一年:119,853,000港元),主要以港元計值。總負債與總資產比例約10.74%(二零二一年:10.38%)。於二零二二年十二月三十一日,本集團並無(二零二一年:無)銀行貸款及總權益為1,554,105,000港元(二零二一年:1,605,421,000港元)。

於二零二二年十二月三十一日,本集團之流動資 產為288,057,000港元(二零二一年:269,058,000 港元),超出其流動負債262,088,000港元(二零 二一年:246,861,000港元)。

於二零二二年十二月三十一日止年度,本集團並 無重大匯率波動風險及相關對沖,亦無任何或然 負債。

#### **Financial Review**

#### **Group Assets and Charges**

The total assets of the Group have decreased from HK\$1,791,326,000 last year to HK\$1,741,114,000 in this year. The net assets of the Group have decreased from HK\$1,605,421,000 to HK\$1,554,105,000. At 31st December, 2022, no investment properties of the Group in Hong Kong (2021: HK\$ Nil) were pledged as security for banking facilities. The Group has no bank loan, but will undergo a discussion with the bank for the renewal of banking facilities and the bank has agreed to provide banking facilities if necessary.

#### **Group Financial Position, Liquidity and Financial Resources**

The total liabilities of the Group have increased from HK\$185,905,000 as at 31st December, 2021 to HK\$187,009,000 as at 31st December, 2022. The Group had cash and bank balances of HK\$147,668,000 as at 31st December, 2022 (2021: HK\$119,853,000) which were mainly denominated in Hong Kong dollars. The ratio of total liabilities to total assets was approximately 10.74% (2021: 10.38%). As at 31st December, 2022, the Group had no bank loans (2021: Nil) and the total equity was HK\$1,554,105,000 (2021: HK\$1,605,421,000).

As at 31st December, 2022, the current assets of the Group, amounting to HK\$288,057,000 (2021: HK\$269,058,000), exceeded its current liabilities by HK\$262,088,000 (2021: HK\$246,861,000).

For the year ended 31st December, 2022, the Group had no material exposure to fluctuations in exchange rates and no related hedges and there were no contingent liabilities.

#### 財務/經營之關鍵績效指標

#### 關鍵績效指標(「關鍵績效指標」)

在二零二二年,本集團已制定以下經營關鍵績效 指標,以維持高競爭力:

(1) 在自營投資物業上,我們的目標是保持總租 金收入與去年相同。

回顧全年表現,上述關鍵績效指標均能達到。本 集團會按市場環境變化不斷更新經營之關鍵績效 指標及出售/租賃之戰略。

#### 未來可能發展

#### 二零二三年目標如下:

- (1) 我們會通過收購具吸引力估值之優質物業及 出售表現落後之物業來持續改善我們的投資 組合,以平衡短期回報及長期資本增值的需 求。
- (2) 我們將審視現行之管理制度及成本結構,從 而提升效益及盡可能降低成本。
- (3) 我們會負責任地考慮增加項目的貸款從而提 升股本回報。

#### **Events after the Reporting Period**

#### **Financial/Operational Key Performance Indicators**

#### **Key Performance Indicators ("KPIs")**

For the year of 2022, the Group set the following operational KPIs to maintain high competitiveness:

(1) For the investment properties managed by the Group, our aim is to maintain the same as last year in the total rental income.

Having reviewed the annual performance, these KPIs had been achieved. The Group will keep updating its operational KPIs and sale/leasing strategy to adapt the market changes.

#### **Future Likely Development**

Objectives for 2023 are as follows:

- (1) We will continue to improve our investment portfolio through acquisition of quality properties at attractive valuations and disposals of under-performing properties in order to balance the demands of short-term returns and long-term capital appreciation.
- (2) We will review our management system and cost structure so as to improve efficiency and reduce expenses where possible.
- (3) We will consider gearing up our projects in a responsible manner in order to increase our return on equity.

#### 應對新型冠狀病毒疫情

本集團致力為員工提供安全舒適之工作環境。鑒 於2019新型冠狀病毒爆發,本集團已採取一系列 預防措施,以保障員工的健康及安全。

本集團密切監察新型冠狀病毒的發展趨勢,並為 任何可能爆發的疫情做好充分準備,政策如下:

- 每接種一劑疫苗提供一天疫苗假期
- 保持口罩、快速抗原測試包、洗手液及個人 衛生用品的庫存,並注重清潔及衛生
- 一 會議盡可能在場外舉行或通過電話會議或視頻會議舉行
- 取消所有非必要外遊
- 為員工提供彈性工作計劃,包括於疫情嚴峻 期間落實的彈性上班時間及在家工作安排
- 限制進入辦公室、體溫檢查,工作時須佩戴口罩
- 要求員工每週進行兩次快速抗原測試,必要 時亦需進行測試
- 外遊後自我隔離、有病徵或與新型冠狀病毒 確診者曾有接觸的員工需要接受核酸檢測

#### **COVID-19 Response**

The Group endeavours to provide a safe and pleasant working environment for the employees. In light of the outbreak of the COVID-19, the Group has carried out a number of preventive measures to safeguard the health and safety of the employees.

The Group has been closely monitoring the trend of COVID-19 and is well prepared for any possible outbreak with the following policies:

- Provide one-day vaccination leave for each dose of vaccination
- Maintain inventory of face masks, RAT kits, hand sanitiser and hygiene supplies and focus on cleaning and sanitation
- Meetings were held off-site or by conference calls or video conference as far as possible
- Cancellation of all non-essential travels
- Flexible working plans for employees, including flexi-hours and work from home arrangement during the critical period
- Restrictions on office access, temperature screening and require masks on during work
- Employees are required to do RAT twice a week and when necessary
- Self-isolation following travel, employees having symptoms, or interaction with a confirmed case of COVID-19 are required to undergo PCR test

#### 業務展望

隨著香港取消所有對新型冠病毒疫情相關的限制,我們預計本集團位於港晶中心(部分)的零售商舖之客流量將迅速恢復。由於該物業毗鄰過境列車總站,與中國大陸重新全面通關將會顯著增加港晶中心之商業活動。

我們相信香港的零售業已經觸底並將會迅速復 甦。本集團透過著力整合零售業務之元素於商用 物業上,將會從零售業的復甦中取得優勢。作為 這重點策略的一部分,我們計劃分拆位於香港和 中國大陸的非核心資產之住宅和辦公室物業。

持續的利率上升是對我們的業務發展造成負面風險的一個因素,這可能阻礙商業活動和對資本價值造成潛在影響。然而,我們認為在中國大陸經濟復甦的支持下,香港長遠的經濟前景依然健康,以及全面通關和取消對新型冠病毒疫情之限制措施下,所帶來的經濟反彈是可觀的。我們將繼續尋找極具吸引力的房地產發展機會,以增加我們的投資組合來符合我們對零售業務的重視。

#### **Business Outlook**

With all COVID-19-related restrictions cancelled in Hong Kong, we expect a rapid recovery in customer traffic in the Group's retail space in Harbour Crystal Centre (portion). The re-opening of borders with mainland China will also be a significant boost for business activity in Harbour Crystal Centre because of the property's proximity to the terminus for cross-border trains.

We believe the Hong Kong retail sector has already bottomed and will recover quickly. The Group will take advantage of this recovery for the retail segment by focusing our property portfolio on commercial properties with retail elements. As part of this focused strategy, we plan to diversify away from our non-core assets in residential and office properties in Hong Kong and mainland China.

A factor for negative risk to our business going forward is the impact of rising interest rates, which has the potential effect of dampening business activity as well as capital values. However, we believe the long-term prospects for the Hong Kong economy – backed by the recovering mainland Chinese economy – remain healthy, and that the economic rebound from border openings and removal of COVID-19 restrictions will be substantial. We will continue to search for attractive real estate opportunities to add to our portfolio in line with our focus on the retail segment.

本公司致力於切合實際之範圍內維持高水平之企業管治,以強調高透明度、問責性及獨立性為原則。本公司董事會(「董事會」)相信優良之企業管治對本公司之成功及提升股東價值至為重要。

#### 企業管治守則

根據香港聯合交易所有限公司證券上市規則(「上市規則」)附錄十四所載之企業管治守則(「企業管治守則」),董事會已審閱本公司之企業管治常規,並已採納多項經改進之程序,詳情載於本報告內。除下文解釋之若干已闡明原因之偏離行為外,於截至二零二二年十二月三十一日止年度,本公司已應用企業管治守則之原則及遵守適用之守則條文。董事會將至少每年檢討現行之常規一次,並在其認為需要時作出適當更改。

#### **CORPORATE GOVERNANCE REPORT**

The Company is committed to maintaining a high standard of corporate governance within a sensible framework with an emphasis on the principles of transparency, accountability and independence. The board of directors of the Company ("Board") believes that good corporate governance is essential to the success of the Company and to the enhancement of shareholders' value.

#### Corporate Governance Code

In the light of the Corporate Governance Code ("CG Code") contained in Appendix 14 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited ("Listing Rules"), the Board has reviewed the corporate governance practices of the Company with the adoption of the various enhanced procedures which are detailed in this report. The Company has applied the principles of, and complied with, the applicable code provisions of the CG Code during the year ended 31st December, 2022, except for certain deviations as specified with considered reasons for such deviations as explained below. The Board will review the current practices at least annually, and make appropriate changes if considered necessary.

The Board currently comprises seven directors ("Directors") in total, with four Executive Directors and three Independent Non-Executive Directors ("INEDs"). The composition of the Board during the year and up to the date of this report is set out as follows:

#### 董事會程序

於年內,獨立非執行董事為本公司及其附屬公司 (統稱「本集團」)提供廣泛之專業知識及經驗。彼 等積極參與董事會及委員會會議,對本集團之策 略、表現及管理程序之事宜提供獨立判斷,並顧 及本公司全體股東(「股東」)之利益。

於整年內及截至本報告日期止,本公司有三名獨立非執行董事,佔董事會人數不少於三分之一。 根據上市規則第3.10條之規定,至少一名獨立非執行董事具備適當之專業資格或會計或相關財務 管理專業知識。董事會已接獲每名獨立非執行董 事有關其獨立性之年度確認書,並認為所有獨立 非執行董事均具備上市規則第3.13條所載之指引 下之獨立性。

#### **Board Process**

During the year, the INEDs provided the Company and its subsidiaries (collectively "Group") with a wide range of expertise and experience. Their active participation in the Board and committee meetings brought independent judgement on issues relating to the Group's strategy, performance and management process, taking into account the interests of all shareholders of the Company ("Shareholders").

Throughout the year and up to the date of this report, the Company has had three INEDs representing not less than one-third of the Board. At least one of the INEDs has the appropriate professional qualifications or accounting or related financial management expertise under Rule 3.10 of the Listing Rules. The Board has received from each INED an annual confirmation of his/her independence and considers that all the INEDs are independent under the guidelines set out in Rule 3.13 of the Listing Rules.

The Board meets regularly to discuss the overall strategy as well as the operation and financial performance of the Group, and to review and approve the Group's annual and interim results and other ad hoc matters which need to be dealt with. During the year, four Board meetings were held and the individual attendance records of each Director at the meetings of the Board, Remuneration Committee, Audit Committee and general meeting during the year ended 31st December, 2022 are set out below:

經董事會決定或考慮之事宜主要包括本集團整體策略、全年營運預算、全年及中期業績、董事委任或重新委任之批准(按提名委員會之建議)、重大合約及交易、企業管治,以及其他重大政策及財務等事宜。董事會已將日常職責委派予行政管理人員,並由執行委員會(其具有特定書面職權範圍)指示/監督。董事會及本公司管理層之職能已分別確立並以書面列載,並不時由董事會作出檢討及更新,以確保其職能與現行規則及規例一致。

董事會定期會議的舉行日期於每年預先編定,以 便更多董事出席會議。召開董事會會議一般會給 予全體董事至少十四天之通知,以便彼等皆有機 會提出商討事項列入會議議程內。本公司之会議 程,以及確保已遵守所有適用規則及規例。議程 及隨附之董事會文件一般在擬舉行董事定期會 議(及就可行情況下,亦適用於其他董事會會議 就已初稿於提交下一次董事會會議部 發之初稿於提交下一次董事會會議部 發之初稿於提交下一次董事會會議記錄均由 全體董事傳閱並提出意見。所有會議記錄均由 司秘書保存,並供任何董事於發出合理通知時, 於任何合理時間內查閱。

根據董事會現行慣例,倘主要股東或董事在董事會將予考慮之事項中存有董事會認為屬重大之利益衝突,則有關事項會於正式召開之董事會會議上處理。本公司之組織章程細則(「組織章程細則」))亦規定,除當中所述之例外情況外,董事須就批准該名董事或其任何緊密聯繫人擁有重大利益之任何合約或安排之會議上就任何董事會決議案放棄投票,彼亦不會被計算於該等會議之法定人數內。

The Board has reserved for its decision or consideration matters covering mainly the Group's overall strategy, annual operating budget, annual and interim results, approval of Directors' appointment or re-appointment (based on the recommendations made by the Nomination Committee), material contracts and transactions, corporate governance as well as other significant policy and financial matters. The Board has delegated the day-to-day responsibility to the executive management under the instruction/ supervision of the Executive Committee which has its specific written terms of reference. The respective functions of the Board and management of the Company have been formalised and set out in writing and will be reviewed and updated by the Board from time to time to ensure that they are consistent with the existing rules and regulations.

Regular Board meetings each year are scheduled in advance to facilitate maximum attendance of Directors. At least 14 days' notice of a Board meeting is normally given to all Directors who are given an opportunity to include matters for discussion in the agenda. The company secretary of the Company ("Company Secretary") assists the Chairman of the Board in preparing the agenda for meetings and ensures that all applicable rules and regulations are complied with. The agenda and the accompanying Board papers are normally sent to all Directors at least 3 days before the intended date of a regular Board meeting (and so far as practicable for such other Board meetings). Draft minutes of each Board meeting are circulated to all Directors for their comment before being tabled at the following Board meeting for approval. All minutes are kept by the Company Secretary and are open for inspection at any reasonable time on reasonable notice by any Director.

According to the current Board practice, if a substantial Shareholder or a Director has a conflict of interest in a matter to be considered by the Board which the Board has determined to be material, the matter will be dealt with by the Board at a duly convened Board meeting. The articles of association of the Company ("Articles of Association") also stipulate that save for the exceptions as provided therein, a Director shall abstain from voting on any Board resolution and not be counted in the quorum at meetings for approving any contract or arrangement in which such Director or any of his/her close associates has a material interest.

The Board and each Director also have separate and independent access to the Company's senior management. Directors will be continuously updated on the major developments of the Listing Rules and other applicable regulatory requirements to ensure compliance and upkeeping of good corporate governance practices. In addition, as part of the mechanism to encourage independent views and input from Directors, a written procedure has been established since August 2017 and reviewed annually to enable the Directors, in discharge of their duties, to seek external independent professional advice in appropriate circumstances at a reasonable cost to be borne by the Company.

#### **Directors' Continuous Professional Development**

For continuous professional development, in addition to Directors' attendance at meetings and review of papers and circulars sent by the management of the Company, Directors participated in the activities including the following:

#### 多元化

本公司已於二零一七年八月採納董事會成員多元 化政策,載列有關董事會成員多元化之目標及原 則,以在可行情況下達致本公司在董事會成員多 元化方面取得平衡之策略目標。董事會所有委任 將以用人唯才為原則,及按可計量目標考慮人 選,並衡量本公司之業務及需要。

甄選人選將按一系列多元化標準為基準,包括但不限於性別、年齡、文化及教育背景、知識、專業經驗及技能。最終決定將按人選的長處及可為董事會提供的貢獻而定。

董事會女性代表的比例是公司評估多元化政策實施的可計量目標。董事會目前七名董事中有一名女性董事,董事會的性別多元化達到14.3%。董事會的目標是至少保持目前的女性代表水平,隨時間及在確定合適的候選人後,最終目標是增加女性成員的比例。

七名董事來自多元化及互補的背景,包括物業發展/管理、企業融資、投資及管理、法律、會計及財務管理以及媒體及公共關係。他們為我們的業務帶來的寶貴經驗和專業知識對本集團的長遠發展至關重要。

年內,董事會對董事會成員多元化政策的實施及 成效進行年度檢討,並對董事會成員多元化政策 得到妥善實施及有效感到滿意。

#### **Diversity**

The Company has adopted the Board Diversity Policy in August 2017 which sets out the objectives and principles regarding board diversity for the purpose of achieving the Company's strategic objectives of balanced diversity at the Board as far as practicable. Board appointments will be based on merit and candidates will be considered against measurable objectives, taking into account the Company's business and needs.

Selection of candidates will be based on a range of diversity criteria, including but not limited to gender, age, cultural and educational background, knowledge, professional experience and skills. The ultimate decision will be based on merit and the contribution that the selected candidates may bring to the Board.

The proportion of female Board representation is a measurable objective of the Company in assessing the implementation of the diversity policy. The Board currently has one female Directors out of seven Directors, achieving the gender diversity of the Board at 14.3%. The Board targets to maintain at least the current level of female representation, with the ultimate goal of increasing the proportion of female members over time as and when suitable candidates are identified.

The seven Directors are from diverse and complementary backgrounds, including property development/management, corporate finance, investment and management, legal, accounting and finance management and media and public relations. The valuable experience and expertise they bring to our business are critical for the long-term growth of the Group.

During the year, the Board conducted an annual review of the implementation and effectiveness of the Board Diversity Policy and is satisfied that the Board Diversity Policy has been properly implemented and is effective.

為努力保持性別多元化,在招聘和選拔高級管理人員和普通員工時也採用了類似的考慮因素。截至二零二二年十二月三十一日,員工(包括高級管理層)已實現62%男性: 38%女性性別比例,這是性別多元化的可計量目標。有關本集團之員工組成的進一步資料,請參閱另行刊列於香港聯合交易所有限公司(「聯交所」)及本公司網站「二零二二年環境、社會及管治報告」內。

#### 主席及行政總裁之角色

企業管治守則之守則條文C.2.1規定,主席及行政總裁「行政總裁」)之角色應有所區分,並不應由一人同時兼任。董事會主席李成偉先生主要負責領導董事會,確保(i)所有重大政策事宜乃經董事會以即時及建設性方式討論:(ii)所有董事能妥善地獲得董事會會議上討論問題之通報:及(iii)所有董事能收到準確、適時及清晰之資料。行政總裁一職由本公司行政總裁李樹賢先生擔任,彼負責本集團之日常業務管理。此等職位之職責已清晰區分且以書面形式載明,並於二零一七年八月經董事會批准及其後於二零一九年一月更新。

In striving to maintain gender diversity, similar considerations are used when recruiting and selecting senior management and general staff. As of 31st December, 2022, a 62% male: 38% female gender ratio, being a measurable objective for gender diversity, has been achieved in the workforce (including senior management). Further information about the composition of the Group's workforce can be found in the Environmental, Social and Governance Report 2022 separately released on the websites of The Stock Exchange of Hong Kong Limited ("Stock Exchange") and the Company.

#### Roles of Chairman and Chief Executive

Code provision C.2.1 of the CG Code stipulates that the roles of chairman and chief executive ("CE") should be separate and should not be performed by the same individual. Mr. Patrick Lee Seng Wei, being the Chairman of the Board, is primarily responsible for the leadership of the Board, ensuring that (i) all significant policy issues are discussed by the Board in a timely and constructive manner; (ii) all Directors are properly briefed on issues arising at Board meetings; and (iii) the Directors receive accurate, timely and clear information. The functions of the CE are performed by Mr. Lee Shu Yin, the Chief Executive of the Company, who is responsible for the day-to-day management of the Group's business. Their responsibilities are clearly segregated and have been set out in writing and approved by the Board in August 2017, and subsequently updated in January 2019.

提名委員會之職權範圍包括訂明遴選及推薦本公司董事候選人程序及準則之提名方法。

每名新獲委任之董事將於首次委任時獲公司秘書 發給一套入職資料。該套入職資料乃根據公司秘 例、上市規則以及證券及期貨條例董事須遵守之 職責及持續責任之全面、正式及按每名董事情況 專門編製之指引。此外,該套入職資料亦包括簡 述本公司運作及業務之資料,本公司最新公佈之 財務報告及董事會採納之企業管治常規文件。董 事將持續獲更新上市規則及其他適用之監管規定 之任何重大發展,以確保彼等遵守及維持良好之 企業管治常規。

本公司之所有獨立非執行董事均由二零二一年一月一日起獲為期兩年的指定任期。本公司之所有獨立非執行董事之委任條款,須受組織章程細則之有關條文或任何其他適用法例所規限,董事須離任或退任,但可膺選連任。獨立非執行董事之委任已從二零二三年一月一日起至更新。

在考慮委任或重新委任董事時,除上文「董事會」 下「多元化」之段落所載的多元化標準外,董事會 在提名委員會的協助及推薦下,亦會考慮多種因 素,包括但不限於董事會的架構、人數和組成、 候選人的資格,以及他們在需要時投入足夠時間 履行董事職責的能力,並為本公司之策略、政策 和表現的發展作出積極貢獻。

根據組織章程細則,於本公司每屆股東週年大會 (「股東週年大會」)上,三分之一當時在任之董事 (或倘人數並非三之倍數,則最接近但不少於三 分之一之數目)須輪值退任。此外,任何填補臨時 空缺而獲董事會委任之董事僅可任職至本公司下 屆股東大會為止,而獲委任為董事會新增之成員 可任職至下屆股東週年大會為止,在該兩種情況 下,該等董事應可於相關會議上膺選連任。每名 董事須至少每三年輪值退任一次。

#### Appointment and Re-Election of Directors

The terms of reference of the Nomination Committee include the nomination procedure specifying the process and criteria for the selection and recommendation of candidates for directorship of the Company.

Every newly appointed Director will receive an induction package from the Company Secretary on the first occasion of his/her appointment. This induction package is a comprehensive, formal and tailored induction on the responsibilities and on-going obligations to be observed by a director pursuant to the Companies Ordinance, the Listing Rules and the Securities and Futures Ordinance. In addition, this induction package includes materials briefly describing the operations and business of the Company, the latest published financial reports of the Company and the documentation for the corporate governance practices adopted by the Board. Directors will be continuously updated on any major developments of the Listing Rules and other applicable regulatory requirements to ensure compliance and upkeeping of good corporate governance practices.

All INEDs of the Company were appointed for a specific term of two years commencing from 1st January, 2021. All terms of appointments of INEDs of the Company are subject to the relevant provisions of the Articles of Association or any other applicable laws whereby the Directors shall vacate or retire from their office but are eligible for re-election. The appointment of all INEDs has been renewed from 1st January, 2023.

In considering the appointment or re-appointment of Directors, in addition to the diversity criteria set out in the paragraphs headed "Diversity" under "The Board" above, the Board, with the assistance and recommendation from the Nomination Committee, will also take into account a number of factors, including but not limited to the structure, size and composition of the Board, the candidates' qualifications and their ability to devote sufficient time as and when required to discharge their responsibilities as a director and to make positive contribution to the development of the Company's strategy, policies and performance.

According to the Articles of Association, at each annual general meeting of the Company ("AGM"), one-third of the Directors for the time being (or, if their number is not a multiple of three, the number nearest to but not less than one-third) shall retire from office by rotation. Further, any Director appointed by the Board to fill a casual vacancy shall hold office only until the next following general meeting of the Company whilst those appointed as an addition to the Board shall hold office until the next following AGM and in both cases, those Directors shall then be eligible for re-election at the relevant meeting. Every Director shall be subject to retirement by rotation at least once every three years.

董事會負責履行企業管治責任,並已於二零一七 年八月就其企業管治職能採納書面職權範圍。

董事會在企業管治職能方面之責任包括:

- (i) 制定及檢討本公司之企業管治政策及常規;

- (iii) 檢討及監察本公司在遵守法律及監管規定方面之政策及常規:

於二零二二年及截至本報告日期止,董事會已根 據其職權範圍履行企業管治責任。

#### Corporate Governance Function

The Board is responsible for performing corporate governance duties and has adopted the written terms of reference on its corporate governance functions in August 2017.

The duties of the Board in respect of the corporate governance functions include:

- (i) developing and reviewing the Company's policies and practices on corporate governance;
- (ii) reviewing and monitoring the training and continuous professional development of Directors and senior management;
- (iii) reviewing and monitoring the Company's policies and practices on compliance with legal and regulatory requirements;
- developing, reviewing and monitoring the code of conduct and compliance manual (if any) applicable to employees and Directors; and
- (v) reviewing the Company's compliance with the CG Code and disclosure in the Corporate Governance Report.

In 2022 and up to the date of this report, the Board has performed the corporate governance duties in accordance with its terms of reference.

董事會已成立多個委員會,包括提名委員會、薪酬委員會、審核委員會及執行委員會,各委員會均以書面具體列明其職權範圍。委員會之所有會議記錄及決議案均由公司秘書保存,並提供副本予全體董事會成員傳閱,而各委員會須向董事會滙報其決定及建議(倘適用)。董事會會議之程序及安排(於本報告「董事會」一節內提述)按可行情況下亦已獲採納於委員會會議。

#### 提名委員會

提名委員會已於二零一二年三月成立,並由一名獨立非執行董事擔任主席,且全部成員為獨立非執行董事。目前,提名委員會由三名成員組成,包括李澤雄先生(提名委員會主席)、蔡健民先生及楊麗琛女士。提名委員會獲提供充裕資源以履行其職務,並可按本公司之政策在有需要時尋求獨立專業意見。提名委員會之主要角色及職能已包含於其職權範圍內,該職權範圍已於聯交所及本公司網站內登載。

提名委員會已於其職權範圍內制訂並載列提名政策(「提名政策」)。提名政策旨在確保董事會按照本公司業務而具備適當所需技能、經驗及多樣的觀點與角度,以及董事可以投入足夠的時間並為公司作出與其角色和董事會職責相稱的貢獻。董事會應包括平衡執行董事和獨立非執行董事的組成,使董事會具有更強的獨立元素,可有效作出獨立判斷。

#### **Board Committees**

The Board has established various committees, including a Nomination Committee, a Remuneration Committee, an Audit Committee and an Executive Committee, each of which has its specific written terms of reference. Copies of minutes of all meetings and resolutions of the committees, which are kept by the Company Secretary, are circulated to all Board members and the committees are required to report back to the Board on their decisions and recommendations where appropriate. The procedures and arrangements for a Board meeting, as mentioned in the section headed "The Board" of this report, have been adopted for the committee meetings so far as practicable.

#### **Nomination Committee**

The Nomination Committee has been established since March 2012 and is chaired by an INED and comprises all INEDs. Currently, the Nomination Committee consists of three members, including Mr. Li Chak Hung (Chairman of the Nomination Committee), Mr. Choi Kin Man and Ms. Lisa Yang Lai Sum. The Nomination Committee is provided with sufficient resources to discharge its duties and has access to independent professional advice according to the Company's policy if considered necessary. The major roles and functions of the Nomination Committee are included in its terms of reference, which are available on the websites of the Stock Exchange and the Company.

The Nomination Committee has formulated and set out the nomination policy ("Nomination Policy") in its terms of reference. The objectives of the Nomination Policy are to ensure that the Board has a balance of skills, experience and diversity of perspectives appropriate to the requirements of the Company's business, and that the Directors can devote sufficient time and make contributions to the Company that are commensurate with their role and board responsibilities. A balanced composition of executive directors and INEDs shall be included in the Board so that there is a strong independent element in the Board, which can effectively exercise independent judgment.

為確保董事會組成的變動不會帶來不適當的干擾,本公司應設有正式、經審的慎考慮並具透明度的董事甄選、委任及重新委任的程序,並設定有秩序董事繼任的計劃(如認為有需要),包括定期檢討此計劃。委任新董事(作為新增董事或填補所出現的臨時空缺)或任何重新委任之董事乃經提名委員會推薦候選人後由董事會作出決定。

用於考慮候選人是否符合資格的標準,應視乎候選人是否能投入足夠時間及精神以處理本公司事務,並促進董事會成員多元化(包括性別多元化),使董事會能有效履行其職責。通過採納此類標準,有助本公司發展董事會候選人渠道,以達到性別多元化。更多甄選標準及程序的詳情載於提名委員會職權範圍,該職權範圍已於聯交所及本公司網站內登載。

根據其職權範圍,提名委員會將於有需要時召開會議,亦可透過傳閱文件方式處理事宜。於二零二二年,提名委員會並無召開會議,提名委員會 乃透過傳閱文件方式處理事宜。於二零二二年及 截至本報告日期止,提名委員會已履行之工作概 述如下:

- (i) 檢討及建議董事會批准就重選退任董事提呈 於二零二二年股東週年大會及二零二三年股 東週年大會之決議案;
- (ii) 檢討董事會的架構、人數、組成及多元化, 以及評核各獨立非執行董事的獨立性;
- (iii) 檢討及建議董事會批准經修訂的董事會成員 多元化政策及提名委員會的職權範圍(根據 自二零二二年一月一日起生效的企業管治守 則修訂);及
- (iv) 檢討及建議董事會批准獨立非執行董事之任期自二零二三年一月一日起。

To ensure changes to the Board composition can be managed without undue disruption, a formal, considered and transparent procedure is in place for selection, appointment and re-appointment of Directors, as well as plans in place for orderly succession (if considered necessary), including periodical review of such plans. The appointment of a new Director (to be an additional Director or fill a casual vacancy as and when it arises) or any re-appointment of Directors is a matter for decision by the Board upon the recommendation of the proposed candidate by the Nomination Committee.

The criteria to be applied in considering whether a candidate is qualified shall be his or her ability to devote sufficient time and attention to the affairs of the Company and contribute to the diversity of the Board (including gender diversity) as well as the effective carrying out of the responsibilities of the Board. By adopting such criteria, it facilitates the Company to develop a pipeline of candidates to the Board to achieve gender diversity. Further details of the selection criteria and the procedure are set out in the terms of reference of the Nomination Committee which are available on the websites of the Stock Exchange and the Company.

The Nomination Committee will meet as and when necessary in accordance with its terms of reference and may also deal with matters by way of circulation. In 2022, no Nomination Committee meeting was held while the Nomination Committee dealt with matters by way of circulation. In 2022 and up to the date of this report, the Nomination Committee performed the works as summarised below:

- reviewed and recommended for the Board's approval the proposed resolutions for re-election of the retiring Directors at 2022 AGM and 2023 AGM;
- (ii) reviewed the structure, size, composition and diversity of the Board and assessed the independence of each INED;

The terms of reference of the Remuneration Committee are in compliance with the code provision E.1.2 of the CG Code, but with a deviation from the code provision that the Remuneration Committee shall make recommendations to the Board on the remuneration packages of the Executive Directors only and not senior management (as opposed to executive directors and senior management under the code provision). The reasons for the above deviation are summarised as below:

- the Board believes that the Remuneration Committee is not properly in a position to evaluate the performance of senior management and that this evaluation process is more effectively carried out by the Executive Directors;
- (ii) the Executive Directors must be in a position to supervise and control senior management and thus must be able to control their compensation; and
- (iii) there is no reason for Executive Directors to pay senior management more than industry standards and thus Shareholders will benefit by reducing costs in the fixing of such compensation packages.

The Remuneration Committee shall meet at least once a year in accordance with its terms of reference. One Remuneration Committee meeting was held in 2022 and the attendance of each member is set out in the section headed "The Board" of this report.

The Directors acknowledge their responsibility for preparing, with the support from the Accounts Department, the consolidated financial statements of the Group. In preparing the consolidated financial statements for the year ended 31st December, 2022, the accounting principles generally accepted in Hong Kong have been adopted and the requirements of the Hong Kong Financial Reporting Standards (which also include Hong Kong Accounting Standards and Interpretations) issued by the Hong Kong Institute of Certified Public Accountants and the disclosure requirements of the Hong Kong Companies Ordinance were complied with. The Directors believe that they have selected suitable accounting policies and applied them consistently, and made judgements and estimates that are prudent and reasonable and have ensured that the consolidated financial statements are prepared on a going concern basis.

The reporting responsibilities of the Company's external auditor, Deloitte Touche Tohmatsu, are set out in the Independent Auditor's Report on pages 51 to 56.

#### **Risk Management and Internal Control**

The Board has the responsibility to review annually the effectiveness of the Group's risk management and internal control systems covering all material controls, including financial, operational and compliance controls. In 2022, the Board, through the Audit Committee, had reviewed the adequacy of resources, qualifications and experience of staff of the Company's accounting, internal audit and financial reporting functions, as well as those relating to ESG performance and reporting, and their training programmes and budget.

The Group's risk management and internal control systems are designed to provide reasonable, but not absolute, assurance against material misstatement or loss; to manage rather than completely eliminate the risk of system failure; and to assist in the achievement of the Group's agreed objectives and goals. They have a key role in the management of risks that are significant to the fulfilment of business objectives. In addition, they should provide a basis for the maintenance of proper accounting records and assist in the compliance with relevant laws and regulations.

#### **Policy on Disclosure of Inside Information**

The Board has adopted the Policy on the Disclosure of Inside Information ("Policy") effective on 1st January, 2013, with respect to the procedures and internal controls for the handling and dissemination of inside information. The Policy sets out guidelines and procedures to the Directors and relevant officers of the Group to ensure inside information of the Group is to be disseminated to the public on an equal basis and in timely manner. Directors and relevant officers in possession of potential inside information and/or inside information are required to take reasonable measures to ensure that proper safeguards are in place to preserve strict confidentiality of inside information and to ensure that its recipients recognise their obligations to maintain the information confidential. The Policy shall be updated and revised as and when necessary in light of changes in circumstances and changes in the Listing Rules, Part XIVA of the Securities and Futures Ordinance and relevant statutory and regulatory requirements from time to time.

#### Shareholders Engagement

The Board recognises the importance of good communication with Shareholders. Information in relation to the Group is disseminated to Shareholders in a timely manner through a number of formal channels, which include interim and annual reports, announcements and circulars. Such published documents together with the latest corporate information and news are also made available on the website of the Company.

The Company's AGM is a valuable forum for the Board to communicate directly with Shareholders. The Chairman actively participates at the AGM to answer any questions from Shareholders. The chairmen of the Audit Committee, Remuneration Committee and Nomination Committee or in their absence, another member of the respective committees or failing that their respective duly appointed delegate, are also available to answer questions at the AGM. The chairman of any independent board committee formed as necessary or pursuant to the Listing Rules (or if no such chairman is appointed, at least a member of the independent board committee) will also be available to answer questions at any general meeting of Shareholders to approve a connected transaction or any other transaction that is subject to independent Shareholders' approval.

During the year, the 2022 AGM was held on 19th May, 2022. The attendance records of the Directors at the 2022 AGM are set out in the section headed "The Board" of this report.

Separate resolutions are proposed at the general meetings for each substantial issue, including the re-election of retiring Directors.

The notice to Shareholders is to be sent in the case of AGM at least 21 days before the meeting and to be sent at least 14 days in case of all other general meetings. An explanation of the detailed procedures of conducting a poll is provided to the Shareholders at the commencement of the meeting. The chairman of the meeting answers questions from Shareholders regarding voting by way of a poll. The poll results are published in the manner prescribed under the requirements of the Listing Rules.

Shareholder(s) representing at least 5% of the total voting rights of all Shareholders having a right to vote at general meetings as at the date of deposit of the requisition can request the Directors to convene an extraordinary general meeting ("EGM") by sending a written request to the registered office of the Company ("Registered Office"). Such requisition must state the general nature of the business to be dealt with at the EGM and must be authenticated by the person or persons making it. Besides, Shareholders may make a proposal ("Proposal") at a Shareholders' meeting by submitting it in written form to the Board at the Registered Office (the address which can be found at the "Corporate Information" section of this annual report) in accordance with the Companies Ordinance and the Articles of Association where applicable. The Proposal shall be in the form of a proposed resolution, which shall clearly and concisely set out the Proposal for discussion and be relevant to the Company's business scope.

The Board updated a Shareholders' Communication Policy in August 2017. A Shareholder may serve an enquiry to the Board at the Registered Office for the attention of the Board in written form, which shall state the nature of the enquiry and the reason for making the enquiry. In addition, Shareholders can contact Tricor Tengis Limited, the share registrar of the Company, for any questions about their shareholdings.

During the year, the Board conducted a review of the implementation and effectiveness of the Shareholders Communication Policy. Having considered the multiple channels of communication and engagement in place as detailed above and in the Shareholders Communication Policy, the Board is satisfied that the Shareholders Communication Policy has been properly implemented and is effective.

#### Dividend Policy

The Board has adopted the Dividend Policy effective on 1st January, 2019. The Company's Dividend Policy aims at providing reasonable and sustainable returns to its Shareholders whilst maintaining a position of financial stability which allows the Company to take advantage of any investment and expansion opportunities that may arise from time to time.

The Board may declare or propose dividends on an annual basis and/or may declare interim dividends or special dividends. Proposal or declaration of dividends by the Board is subject to consideration of the Company's and the Group's operating results, accumulated and future earnings, gearing, liquidity position, capital commitment requirements and future expansion plans as well as general economic conditions and external factors that may have impact on the financial performance and position of the Company and the Group. In addition, as the Company is a holding company, the Board will also consider the dividends received from its subsidiaries and associates as the ability to pay dividends by the Company is dependent on the dividends received from those subsidiaries and associates.

The Board will regularly review the dividend policy and will amend and/or modify the dividend policy if necessary.

#### Amendment of Articles of Association

For the year ended 31st December, 2022, the Company made certain amendments to the Articles of Association of the Company, which has been approved in the 2022 AGM and adopted as the new articles of association of the Company. Please refer to the circular of the Company dated 21st April, 2022 and the announcement of the poll results of the 2022 AGM dated 19th May, 2022 for further details.

Save as disclosed above, the Company has not made any changes to the Articles of Association during the year under review. An up-to-date version of the Articles of Association is available on the websites of the Stock Exchange and the Company.

The board of directors of the Company ("Board") presents its annual report and the audited consolidated financial statements of the Company and its subsidiaries (collectively "Group") for the year ended 31st December, 2022.

#### **Principal Activities**

The Company acts as an investment holding company. The principal activities and details of its principal subsidiaries as at 31st December, 2022 are set out in note 33 to the consolidated financial statements.

The Group's revenue for the year was derived mainly from activities carried out in Hong Kong. The breakdown by principal activities of the Group's revenue and the contribution to profit before taxation for the year ended 31st December, 2022 is set out in note 5 to the consolidated financial statements.

#### **Business Review**

Detailed review of the Group's business is set out in the Chairman's Statement ("CS") on page 5. Particulars of important events affecting the Group that have occurred since the end of the financial year are provided in note 34 "Events after the Reporting Period" to the consolidated financial statements. Future development of the Company's business is set out in the CS on page 7. An analysis of the Group's performance during the year using financial key performance indicators is provided in the CS on page 7.

#### **Principal Risks and Uncertainties**

The Group adopts a comprehensive risk management framework. Risk management policies and procedures are regularly reviewed and updated to react to changes in market conditions and the Group's business strategy. The audit committee of the Company ("Audit Committee") reviews risk-related policies and scrutinises that management has performed its duty to have effective risk management and internal control systems necessary for monitoring and controlling major risks arising from the Group's business activities, changing external risks and the regulatory environment, and reports to the Board on the above.

#### 財務風險

財務風險包括市場風險、信貸風險及流動性風險。市場風險涉及投資價值因市場因素變動而改變,其可細分為利率風險、外幣風險及其他價格風險等。信貸風險乃客戶或交易對方不遵守承諾支付款項而引致損失的風險。流動性風險則涉及指定抵押品或資產未能迅速在市場上買賣以防止損失或賺取所需溢利的風險。財務風險管理之詳細論述於綜合財務報表附註30(b)「財務風險管理目標及政策」內概述。

#### 營運風險

營運風險涉及因內部程序、人為、制度之不足或 失當或外在事件導致之可能損失。本集團透過建 立健全內部監控、清晰界定職權範圍、恰當之職 務分工與有效內部匯報制度及應變計劃,減少及 控制營運風險。本集團的企業文化乃各級業務及 營運管理層均在日常工作中,對所屬業務單位的 營運風險充分了解及負責。獨立監控及檢討由本 集團內部審計功能執行,並定期向董事會主席及 審核委員會匯報。

#### 不確定性

於回顧年度,本集團的業務及盈利能力的增長受物業市場之不確定性因素影響。物業供求、政府對房地產市場價格的干預、房價指數及港元利率變動等因素可能引致本集團之業務、財務狀況及業績出現重大調整。

#### Financial Risk

Financial risk includes market risk, credit risk and liquidity risk. Market risk concerns that the value of an investment will change due to movements in market factors and which can be further divided into interest rate risk, foreign currency risk and other price risk. Credit risk is the risk of losses arising from clients or counterparties failing to make payments as contracted. Liquidity risk concerns that a given security or asset cannot be traded readily in the market to prevent a loss or make the required profit. Further discussion on financial risk management is outlined in note 30(b) "Financial risk management objectives and policies" to the consolidated financial statements.

#### **Operational Risk**

Operational risk is concerned with possible losses caused by inadequate or failed internal processes, people, systems or external events. Operational risk is mitigated and controlled through establishing robust internal controls, setting out clear lines of responsibility, proper segregation of duties and effective internal reporting and contingency planning. It is our corporate culture that the business and operating line management are fully aware of, and responsible for, managing the operational risks of their business units on a day-to-day basis. Independent monitoring and reviews are conducted by the Internal Audit Function of the Group which reports regularly to the Chairman of the Board and the Audit Committee.

#### **Uncertainties**

The Group's business and profitability growth in the year under review are affected by the uncertainty of the property market. The supply and demand of the properties, government interventions over the property market price, house price indexes and interest rates change in Hong Kong may induce a material adjustment on the Group's business, financial position and results.

- (a) on 27th February, 2023, Dan Form (China) Limited ("Dan Form", a direct wholly-owned subsidiary of the Company) as vendor, and Advance Growth Investments Limited ("Advance Growth", a direct wholly-owned subsidiary of TACI) as purchaser, entered into a sale and purchase agreement, pursuant to which, (i) Dan Form agreed to sell and Advance Growth agreed to acquire the entire issued share capital of Spring Victory Holdings Limited ("Spring Victory", a direct wholly-owned subsidiary of Dan Form); and (ii) Dan Form agreed to assign to Advance Growth the sale loan which Spring Victory may hereafter become indebted to Dan Form, at a consideration of HK\$80,000,000 ("Disposal I"); and
- (b) on 27th February, 2023, Simply Global Enterprises Limited ("Simply Global", a direct wholly-owned subsidiary of the Company) as vendor, and AP Development Limited ("AP Development", an indirect wholly-owned subsidiary of AGL) as purchaser, entered into a sale and purchase agreement, pursuant to which, (i) Simply Global agreed to sell and AP Development agreed to acquire the entire issued share capital of Hero Bless Investments Limited ("Hero Bless", a direct wholly-owned subsidiary of Simply Global) and Wisdom Giant Holdings Limited ("Wisdom Giant", a direct wholly-owned subsidiary of Simply Global); and (ii) Simply Global agreed to assign to AP Development the sale loans which Hero Bless and Wisdom Giant are indebted and may hereafter become indebted to Simply Global, at a consideration of HK\$250,000,000 ("Disposal II", together with Disposal I, the "Disposals").

As each of TACI and AGL is a substantial shareholder of the Company, Advance Growth, being a direct wholly-owned subsidiary of TACI, and AP Development, being an indirect wholly-owned subsidiary of AGL, are connected persons of the Company under Chapter 14A of the Listing Rules. Accordingly, the Disposals constituted connected transactions for the Company.

As (i) more than one of the relevant percentage ratios (as defined in the Listing Rules) in respect of Disposal I exceed 5% but are below 25%; (ii) one of the relevant percentage ratios (as defined in the Listing Rules) in respect of Disposal II, both on a stand-alone basis and when aggregated with Disposal I, exceeds 25% but is below 75%, the Disposals are subject to the reporting, announcement, circular and independent shareholders' approval requirements under Chapter 14A of the Listing Rules.

Details of the Directors' emoluments and employees' and senior management's emoluments in the Group for the year ended 31st December, 2022 are set out in notes 11 and 12 to the consolidated financial statements. 誠如綜合財務報表附註16所披露, 貴集團之投資物業指位於香港及中華人民共和國之商舖、住宅、工廈及停車場,於二零二二年十二月三十一日計值為1,297,022,000港元。於截至二零二二年十二月三十一日止年度, 貴集團虧損來自投資物業之公允價值變動為27,457,000港元已於綜合損益表內確認。

As disclosed in note 16 to the consolidated financial statements, the Group's investment properties which represent commercial, residential and carparks located in Hong Kong and the People's Republic of China carried at HK\$1,297,022,000 as at 31st December, 2022. During the year ended 31st December, 2022, a loss from change in fair value of the Group's investment properties of HK\$27,457,000 was recognised in the consolidated statement of profit or loss.

## 1. 概括資料

#### 1. General Information

Asiasec Properties Limited ("Company") is a public limited company incorporated in Hong Kong and its shares are listed on The Stock Exchange of Hong Kong Limited ("Stock Exchange"). Its parent is Autobest Holdings Limited (incorporated in the British Virgin Islands) and its ultimate holding company is Allied Group Limited ("AGL") (incorporated in Hong Kong and listed on the Stock Exchange). The address of the registered office which is also principal place of business of the Company is disclosed in the "Corporate Information" section to the annual report.

The principal activities of the Company and its subsidiaries (collectively referred to as the "Group") are property investment (including by way of equity investment as details set out in note 19), property leasing and estate management. The consolidated financial statements are presented in Hong Kong dollars ("HK\$"), which is also the functional currency of the Company.

# 3. Basis of Preparation of Consolidated Financial Statements and Significant Accounting Policies

The consolidated financial statements have been prepared in accordance with HKFRSs issued by the HKICPA and the Hong Kong Companies Ordinance. For the purpose of preparation of the consolidated financial statements, information is considered material if such information is reasonably expected to influence decisions made by primary users. In addition, the consolidated financial statements include applicable disclosures required by the Rules Governing the Listing of Securities on Stock Exchange ("Listing Rules").

The management has, at the time of approving the consolidated financial statements, a reasonable expectation that the Group has adequate resources to continue in operational existence for the foreseeable future. Thus they continue to adopt the going concern basis of accounting in preparing the consolidated financial statements.

The consolidated financial statements have been prepared on the historical cost basis except for certain properties and financial instruments that are measured at fair values at the end of each reporting period, as explained in the accounting policies set out below.

Historical cost is generally based on the fair value of consideration given in exchange for goods and services.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date, regardless of whether that price is directly observable or estimated using another valuation technique. In estimating the fair value of an asset or a liability, the Group takes into account the characteristics of the asset or liability if market participants would take those characteristics into account when pricing the asset or liability at the measurement date. Fair value for measurement and/or disclosure purposes in these consolidated financial statements is determined on such a basis, except for share-based payment transactions that are within the scope of HKFRS 2 "Share-based Payment", leasing transactions that are accounted for in accordance with HKFRS 16 "Leases" ("HKFRS 16"), and measurements that have some similarities to fair value but are not fair value, such as net realisable value in HKAS 2 "Inventories" or value in use in HKAS 36 "Impairment of Assets" ("HKAS 36").

A fair value measurement of a non-financial asset takes into account a market participant's ability to generate economic benefits by using the asset in its highest and best use or by selling it to another market participant that would use the asset in its highest and best use.

For financial instruments and investment properties which are transacted at fair value and a valuation technique that unobservable inputs is to be used to measure fair value in subsequent periods, the valuation technique is calibrated so that at initial recognition the results of the valuation technique equals the transaction price.

In addition, for financial reporting purposes, fair value measurements are categorised into Level 1, 2 or 3 based on the degree to which the inputs to the fair value measurements are observable and the significance of the inputs to the fair value measurement in its entirety, which are described as follows:

- Level 1 inputs are quoted prices (unadjusted) in active markets for identical assets or liabilities that the entity can access at the measurement date;
- Level 2 inputs are inputs, other than quoted prices included within Level 1, that are observable for the asset or liability, either directly or indirectly; and
- Level 3 inputs are unobservable inputs for the asset or liability.

The significant accounting policies are set out below.

#### **Basis of consolidation**

The consolidated financial statements incorporate the financial statements of the Company and entities controlled by the Company and its subsidiaries. Control is achieved when the Company:

- has power over the investee;
- is exposed, or has rights, to variable returns from its involvement with the investee; and
- has the ability to use its power to affect its returns.

## **Basis of consolidation (continued)**

The Group reassesses whether or not it controls an investee if facts and circumstances indicate that there are changes to one or more of the three elements of control listed above.

Consolidation of a subsidiary begins when the Group obtains control over the subsidiary and ceases when the Group loses control of the subsidiary. Specifically, income and expenses of a subsidiary acquired or disposed of during the year are included in the consolidated statement of profit or loss from the date the Group gains control until the date when the Group ceases to control the subsidiary.

When necessary, adjustments are made to the financial statements of subsidiaries to bring their accounting policies in line with the Group's accounting policies.

All intragroup assets and liabilities, equity, income, expenses and cash flows relating to transactions between members of the Group are eliminated in full on consolidation.

#### **Interests in associates**

An associate is an entity over which the Group has significant influence. Significant influence is the power to participate in the financial and operating policy decisions of the investee but is not control or joint control over those policies.

The results and assets and liabilities of associates are incorporated in these consolidated financial statements using the equity method of accounting. The financial statements of associates used for equity accounting purposes are prepared using uniform accounting policies as those of the Group for like transactions and events in similar circumstances. Under the equity method, an investment in an associate is initially recognised in the consolidated statement of financial position at cost and adjusted thereafter to recognise the Group's share of the profit or loss and other comprehensive income of the associate. Changes in net assets of the associate other than profit or loss and other comprehensive income are not accounted for unless such changes resulted in changes in ownership interest held by the Group. When the Group's share of losses of an associate exceeds the Group's interest in that associate (which includes any longterm interests that, in substance, form part of the Group's net investment in the associate), the Group discontinues recognising its share of further losses. Additional losses are recognised only to the extent that the Group has incurred legal or constructive obligations or made payments on behalf of the associate.

On acquisition of the investment in an associate, any excess of the cost of the investment over the Group's share of the net fair value of the identifiable assets and liabilities of the investee is recognised as goodwill, which is included within the carrying amount of the investment. Any excess of the Group's share of the net fair value of the identifiable assets and liabilities over the cost of the investment, after reassessment, is recognised immediately in profit or loss in the period in which the investment is acquired.

The Group assesses whether there is an objective evidence that the interest in an associate may be impaired. When any objective evidence exists, the entire carrying amount of the investment (including goodwill) is tested for impairment in accordance with HKAS 36 as a single asset by comparing its recoverable amount (higher of value in use and fair value less costs of disposal) with its carrying amount. Any impairment loss recognised is not allocated to any asset, including goodwill that forms part of the carrying amount of the investment. Any reversal of that impairment loss is recognised in accordance with HKAS 36 to the extent that the recoverable amount of the investment subsequently increases.

When the Group retains an interest in the former associate and the retained interest is a financial asset within the scope of HKFRS 9, the Group measures the retained interest at fair value at that date and the fair value is regarded as its fair value on initial recognition. The difference between the carrying amount of the associate and the fair value of any retained interest and any proceeds from disposing of the relevant interest in the associate is included in the determination of the gain or loss on disposal of the associate. In addition, the Group accounts for all amounts previously recognised in other comprehensive income in relation to that associate on the same basis as would be required if that associate had directly disposed of the related assets or liabilities. Therefore, if a gain or loss previously recognised in other comprehensive income by that associate would be reclassified to profit or loss on the disposal of the related assets or liabilities, the Group reclassifies the gain or loss from equity to profit or loss (as a reclassification adjustment) upon disposal/partial disposal of the relevant associate.

When a group entity transacts with an associate of the Group, profits and losses resulting from the transactions with the associate are recognised in the consolidated financial statements only to the extent of interests in the associate that are not related to the Group.

#### **Revenue from contracts with customers**

The Group recognises revenue when (or as) a performance obligation is satisfied, i.e. when "control" of the goods or services underlying the particular performance obligation is transferred to the customer.

A performance obligation represents a good or service (or a bundle of goods or services) that is distinct or a series of distinct goods or services that are substantially the same.

Control is transferred over time and revenue is recognised over time by reference to the progress towards complete satisfaction of the relevant performance obligation if one of the following criteria is met:

- the customer simultaneously receives and consumes the benefits provided by the Group's performance as the Group performs;
- the Group's performance creates or enhances an asset that the customer controls as the Group performs; or

As a practical expedient, if the Group has a right to consideration in an amount that corresponds directly with the value of the Group's performance completed to date, the Group recognises revenue in the amount to which the Group has the right to invoice.

#### Definition of a lease

A contract is, or contains, a lease if the contract conveys the right to control the use of an identified asset for a period of time in exchange for consideration.

For contracts entered into or modified on or after the date of initial application or arising from business combinations, the Group assesses whether a contract is or contains a lease based on the definition under HKFRS 16 at inception, modification date or acquisition date, as appropriate. Such contract will not be reassessed unless the terms and conditions of the contract are subsequently changed.

# The Group as a lessor

Classification and measurement of leases

Leases for which the Group is a lessor are classified as finance or operating leases. Whenever the terms of the lease transfer substantially all the risks and rewards incidental to ownership of an underlying asset to the lessee, the contract is classified as a finance lease. All other leases are classified as operating leases.

Rental income from operating leases is recognised in profit or loss on a straight-line basis over the term of the relevant lease. Initial direct costs incurred in negotiating and arranging an operating lease are added to the carrying amount of the leased asset, and such costs are recognised as an expense on a straight-line basis over the lease term except for investment properties measured under fair value model.

Rental income which are derived from the Group's ordinary course of business are presented as revenue.

The Group accounts for a modification to an operating lease as a new lease from the effective date of the modification, considering any prepaid or accrued lease payments relating to the original lease as part of the lease payments for the new lease.

Refundable rental deposits received are accounted for under HKFRS 9 "Financial Instruments" ("HKFRS 9") and initially measured at fair value. Adjustments to fair value at initial recognition are considered as additional lease payments from lessees.

Property, plant and equipment are tangible assets that are held for use in the production or supply of goods or services, or for administrative purpose. Property, plant and equipment are stated in the consolidated statement of financial position at cost less subsequent accumulated depreciation and subsequent accumulated impairment losses, if any.

When the Group makes payments for ownership interests of properties which includes both leasehold land and building elements, the entire consideration is allocated between the leasehold land and the building elements in proportion to the relative fair values at initial recognition. When the consideration cannot be allocated reliably between non-lease building element and undivided interest in the underlying leasehold land, the entire properties are classified as property, plant and equipment.

On the subsequent sale or retirement of the property, the relevant property revaluation reserve will be transferred directly to retained profits.

Depreciation is recognised so as to write off the cost of assets less their residual values over their estimated useful lives, using the straight-line method. The estimated useful lives, residual values and depreciation method are reviewed at the end of each reporting period, with the effect of any changes in estimate accounted for on a prospective basis.

An item of property, plant and equipment is derecognised upon disposal or when no future economic benefits are expected to arise from the continued use of the asset. Any gain or loss arising on the disposal or retirement of an item of property, plant and equipment is determined as the difference between the sales proceeds and the carrying amount of the asset and is recognised in profit or loss.

#### **Investment properties**

Investment properties are properties held to earn rentals and/or for capital appreciation.

Investment properties are initially measured at cost, including any directly attributable expenditure. Subsequent to initial recognition, investment properties are measured at fair value, adjusted to exclude any prepaid or accrued operating lease income.

Gains or losses arising from changes in the fair value of investment properties are included in profit or loss for the period in which they arise.

An investment property is derecognised upon disposal or when the investment property is permanently withdrawn from use and no future economic benefits are expected from its disposal. Any gain or loss arising on derecognition of the property (calculated as the difference between the net disposal proceeds and the carrying amount of the asset) is included in profit or loss in the period in which the property is derecognised.

# **Club memberships**

Club memberships with indefinite useful lives that are acquired separately are carried at cost less any subsequent accumulated impairment losses.

#### Impairment on property, plant and equipment

At the end of the reporting period, the Group reviews the carrying amounts of its property, plant and equipment to determine whether there is any indication that these assets have suffered an impairment loss. If any such indication exists, the recoverable amount of the relevant asset is estimated in order to determine the extent of the impairment loss (if any).

The recoverable amount of property, plant and equipment are estimated individually. When it is not possible to estimate the recoverable amount individually, the Group estimates the recoverable amount of the cashgenerating unit to which the asset belongs.

In testing a cash-generating unit for impairment, corporate assets are allocated to the relevant cash-generating unit when a reasonable and consistent basis of allocation can be established, or otherwise they are allocated to the smallest group of cash generating units for which a reasonable and consistent allocation basis can be established. The recoverable amount is determined for the cash-generating unit or group of cash-generating units to which the corporate asset belongs, and is compared with the carrying amount of the relevant cash-generating unit or group of cash-generating units.

In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset (or a cash-generating unit) for which the estimates of future cash flows have not been adjusted.

If the recoverable amount of an asset (or a cash-generating unit) is estimated to be less than its carrying amount, the carrying amount of the asset (or a cash-generating unit) is reduced to its recoverable amount. For corporate assets or portion of corporate assets which cannot be allocated on a reasonable and consistent basis to a cash-generating unit, the Group compares the carrying amount of a group of cash-generating units, including the carrying amounts of the corporate assets or portion of corporate assets allocated to that group of cash-generating units, with the recoverable amount of the group of cash-generating units. In allocating the impairment loss, the impairment loss is allocated first to reduce the carrying amount of any goodwill (if applicable) and then to the other assets on a pro-rata basis based on the carrying amount of each asset in the unit or the group of cash-generating units. Financial assets and financial liabilities are initially measured at fair value except for trade receivables arising from contracts with customers which are initially measured in accordance with HKFRS 15. Transaction costs that are directly attributable to the acquisition or issue of financial assets and financial liabilities (other than financial assets or financial liabilities at fair value through profit or loss ("FVTPL")) are added to or deducted from the fair value of the financial assets or financial liabilities, as appropriate, on initial recognition. Transaction costs directly attributable to the acquisition of financial assets or financial liabilities at FVTPL are recognised immediately in profit or loss.

The effective interest method is a method of calculating the amortised cost of a financial asset or financial liability and of allocating interest income and interest expense over the relevant period. The effective interest rate is the rate that exactly discounts estimated future cash receipts and payments (including all fees and points paid or received that form an integral part of the effective interest rate, transaction costs and other premiums or discounts) through the expected life of the financial asset or financial liability, or, where appropriate, a shorter period, to the net carrying amount on initial recognition.

Dividend income which are derived from the Group's ordinary course of business are presented as revenue.

Despite the aforegoing, the Group assumes that the credit risk on a debt instrument has not increased significantly since initial recognition if the debt instrument is determined to have low credit risk at the reporting date. A debt instrument is determined to have low credit risk if (i) it has a low risk of default, (ii) the borrower has a strong capacity to meet its contractual cash flow obligations in the near term and (iii) adverse changes in economic and business conditions in the longer term may, but will not necessarily, reduce the ability of the borrower to fulfil its contractual cash flow obligations. The Group considers a debt instrument to have low credit risk when it has an internal or external credit rating of "investment grade" as per globally understood definitions.

The Group regularly monitors the effectiveness of the criteria used to identify whether there has been a significant increase in credit risk and revises them as appropriate to ensure that the criteria are capable of identifying significant increase in credit risk before the amount becomes past due.

(ii) Definition of default

For internal credit risk management, the Group considers an event of default occurs when information developed internally or obtained from external sources indicates that the debtor is unlikely to pay its creditors, including the Group, in full (without taking into account any collaterals held by the Group).

Irrespective of the above, the Group considers that default has occurred when a financial asset is more than 90 days past due unless the Group has reasonable and supportable information to demonstrate that a more lagging default criterion is more appropriate.

(iii) Credit-impaired financial assets

A financial asset is credit-impaired when one or more events that have a detrimental impact on the estimated future cash flows of that financial asset have occurred. Evidence that a financial asset is credit-impaired includes observable data about the following events:

- (a) significant financial difficulty of the issuer or the borrower;
- (b) a breach of contract, such as a default or past due event;
- (c) the lender(s) of the borrower, for economic or contractual reasons relating to the borrower's financial difficulty, having granted to the borrower a concession(s) that the lender(s) would not otherwise consider; or
- (d) it is becoming probable that the borrower will enter bankruptcy or other financial reorganisation.

#### (iv) Write-off policy

The Group writes off a financial asset when there is information indicating that the counterparty is in severe financial difficulty and there is no realistic prospect of recovery, for example, when the counterparty has been placed under liquidation or has entered into bankruptcy proceedings, or in the case of trade receivables, when the amounts are over two years past due, whichever occurs sooner. Financial assets written off may still be subject to enforcement activities under the Group's recovery procedures, taking into account legal advice where appropriate. A write-off constitutes a derecognition event. Any subsequent recoveries are recognised in profit or loss.

#### (v) Measurement and recognition of ECL

The measurement of ECL is a function of the probability of default, loss given default (i.e. the magnitude of the loss if there is a default) and the exposure at default. The assessment of the probability of default and loss given default is based on historical data and forward-looking information. Estimation of ECL reflects an unbiased and probability-weighted amount that is determined with the respective risks of default occurring as the weights.

Generally, the ECL is the difference between all contractual cash flows that are due to the Group in accordance with the contract and the cash flows that the Group expects to receive, discounted at the effective interest rate determined at initial recognition.

Interest income is calculated based on the gross carrying amount of the financial asset unless the financial asset is credit-impaired, in which case interest income is calculated based on amortised cost of the financial asset.

The Group recognises an impairment gain or loss in profit or loss for all financial instruments by adjusting their carrying amount, with the exception of trade receivables where the corresponding adjustment is recognised through a loss allowance account.

Derecognition/modification of financial assets

The Group derecognises a financial asset only when the contractual rights to the cash flows from the asset expire, or when it transfers the financial asset and substantially all the risks and rewards of ownership of the asset to another entity.

For non-substantial modifications of financial assets that do not result in derecognition, the carrying amount of the relevant financial assets will be calculated at the present value of the modified contractual cash flows discounted at the financial assets' original effective interest rate. # **Foreign currencies**

In preparing the financial statements of each individual group entity, transactions in currencies other than the functional currency of that entity are recognised at the rates of exchanges prevailing on the dates of the transactions. At the end of the reporting period, monetary items denominated in foreign currencies are retranslated at the rates prevailing at that date. Non-monetary items carried at fair value that are denominated in foreign currencies are retranslated at the rates prevailing on the date when the fair value was determined. Non-monetary items that are measured in terms of historical cost in a foreign currency are not retranslated.

Exchange differences arising on the settlement of monetary items, and on the translation of monetary items, are recognised in profit or loss in the period in which they arise.

For the purposes of presenting the consolidated financial statements, the assets and liabilities of the Group's operations are translated into the presentation currency of the Group (i.e. HK\$) using exchange rates prevailing at the end of each reporting period. Income and expenses items are translated at the average exchange rates for the period, unless exchange rates fluctuate significantly during that period, in which case the exchange rates at the date of transactions are used. Exchange differences arising, if any, are recognised in other comprehensive income and accumulated in equity under the heading of exchange reserve.

On the disposal of a foreign operation (that is, a disposal of the Group's entire interest in a foreign operation, or a disposal involving loss of control over a subsidiary that includes a foreign operation, or a partial disposal of an interest in a joint arrangement or an associate that includes a foreign operation of which the retained interest becomes a financial asset), all of the exchange differences accumulated in equity in respect of that operation attributable to the owners of the Company are reclassified to profit or loss.

Government grants are not recognised until there is reasonable assurance that the Group will comply with the conditions attaching to them and that the grants will be received.

Government grants are recognised in profit or loss on a systematic basis over the periods in which the Group recognises as expenses the related costs for which the grants are intended to compensate. Specifically, government grants whose primary condition is that the Group should purchase, construct or otherwise acquire non-current assets are recognised as deferred income in the consolidated statement of financial position and transferred to profit or loss on a systematic and rational basis over the useful lives of the related assets.

Government grants related to income that are receivable as compensation for expenses or losses already incurred or for the purpose of giving immediate financial support to the Group with no future related costs are recognised in profit or loss in the period in which they become receivable. Such grants are presented under "other income".

Cash and cash equivalents presented on the consolidated statement of financial position include cash, which comprises of cash on hand and demand deposits.

#### **Taxation**

Income tax expense represents the sum of the tax currently payable and deferred tax.

The tax currently payable is based on taxable profit for the year. Taxable profit differs from loss before taxation because of income or expense that are taxable or deductible in other years and items that are never taxable or deductible. The Group's liability for current tax is calculated using tax rates that have been enacted or substantively enacted by the end of the reporting period.

Deferred tax is recognised on temporary differences between the carrying amounts of assets and liabilities in the consolidated financial statements and the corresponding tax bases used in the computation of taxable profit. Deferred tax liabilities are generally recognised for all taxable temporary differences. Deferred tax assets are generally recognised for all deductible temporary differences to the extent that it is probable that taxable profits will be available against which those deductible temporary differences can be utilised. Such deferred tax assets and liabilities are not recognised if the temporary difference arises from the initial recognition (other than in a business combination) of assets and liabilities in a transaction that affects neither the taxable profit nor the accounting profit.

Deferred tax liabilities are recognised for taxable temporary differences associated with investments in subsidiaries and associates, except where the Group is able to control the reversal of the temporary difference and it is probable that the temporary difference will not reverse in the foreseeable future. Deferred tax assets arising from deductible temporary differences associated with such investments and interests are only recognised to the extent that it is probable that there will be sufficient taxable profits against which to utilise the benefits of the temporary differences and they are expected to reverse in the foreseeable future.

The carrying amount of deferred tax assets is reviewed at the end of the reporting period and reduced to the extent that it is no longer probable that sufficient taxable profits will be available to allow all or part of the asset to be recovered.

Deferred tax assets and liabilities are measured at the tax rates that are expected to apply in the period in which the liability is settled or the asset is realised, based on tax rate (and tax laws) that have been enacted or substantively enacted by the end of the reporting period.

The measurement of deferred tax liabilities and assets reflects the tax consequences that would follow from the manner in which the Group expects, at the end of the reporting period, to recover or settle the carrying amount of its assets and liabilities.

For the purposes of measuring deferred tax for investment properties that are measured using the fair value model, the carrying amounts of such properties are presumed to be recovered entirely through sale, unless the presumption is rebutted. The presumption is rebutted when the investment property is depreciable and is held within a business model whose objective is to consume substantially all of the economic benefits embodied in the investment property over time, rather than through sale, which is always presumed to be recovered entirely through sale.

Deferred tax assets and liabilities are offset when there is a legally enforceable right to set off current tax assets against current tax liabilities and when they relate to income taxes levied to the same taxable entity by the same taxation authority.

Current and deferred tax are recognised in profit or loss, except when they relate to items that are recognised in other comprehensive income or directly in equity, in which case, the current and deferred tax are also recognised in other comprehensive income or directly in equity respectively.

In the application of the Group's accounting policies, which are described in note 3, the Directors are required to make judgments, estimates and assumptions about the carrying amounts of assets and liabilities that are not readily apparent from other sources. The estimates and underlying assumptions are based on historical experience and other factors that are considered to be relevant. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an on-going basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods.

#### **Critical judgments in applying accounting policies**

The following are the critical judgments, apart from those involving estimations (see below), that the Directors have made in the process of applying the Group's accounting policies and that have the most significant effect on the amounts recognised in the consolidated financial statements.

# Deferred taxation on investment properties

For the purposes of measuring deferred tax arising from certain investment properties that are measured using the fair value model, the Directors have reviewed the Group's investment property portfolios and concluded that the Group's investment properties are not held under a business model whose objective is to consume substantially all of the economic benefits embodied in the investment properties over time. Therefore, in determining the deferred taxation on investment properties, the Directors have determined that the presumption that the carrying amounts of investment properties measured using the fair value model are recovered entirely through sale is not rebutted. The Group has recognised deferred tax on changes in fair value of investment properties as the Group is subject to income taxes on the fair value changes of the investment properties on disposal.

As at 31st December, 2022, the carrying amount of deferred tax on investment properties is amounted to HK\$144,273,000 (2021: HK\$146,774,000).

# **Key sources of estimation uncertainty**

The following are the key assumptions concerning the future, and other key sources of estimation uncertainty at the end of the reporting period that may have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year.

# Fair values of investment properties

Investment properties are stated at fair value based on the valuation performed by independent professional valuers. The determination of the fair value involves certain assumptions of market conditions which are set out in note 16.

In relying on the valuation report, the management have exercised their judgment and are satisfied that the method of valuation is reflective of the current market conditions. Whilst the Group considers valuations of the Group's investment properties are the best estimates, the ongoing COVID-19 pandemic has resulted in greater market volatility depending on how the COVID-19 pandemic may progress and evolve which have led to higher degree of uncertainties in respect of the valuations in the current year. Changes to these assumptions, including the potential risk of any unexpected incidents as a result of change in macroeconomic environment, travel restrictions implemented by many countries, increased complexity in international trade tensions geopolitics, changes in policy direction and/or mortgage requirements, or other unexpected incidents would result in changes in the fair values of the Group's investment properties and the corresponding adjustments to the amount of gain or loss reported in the consolidated statement of profit or loss and other comprehensive income.

# Provision of ECL for loan receivables and related interest and other receivables

The Group determines the ECL for loan receivables and related interest and other receivables based on probability of default and loss given default for each individual loan as each of them have different loss patterns.

In determining the ECL, the Group engages the Valuer to perform the calculation of ECL taking into account on each of the borrowers and their guarantor's background, repayment history of their loans and forward-looking information that is reasonable and supportable available without undue costs or effort. The management of the Company works closely with the Valuer to determine the appropriate default rate and loss given default rate. At every reporting date, the probability of default and loss given default are reassessed and changes in the forward-looking information are considered.

The provision of ECL is sensitive to changes in estimates. Due to greater financial uncertainty triggered by the COVID-19 pandemic, the Group has increased the expected loss rates in the current year as there is higher risk that a prolonged pandemic could led to increased credit default rates. As at 31st December, 2022, the carrying amount of loan receivables and related interest and other receivables is HK\$155,359,000 (2021: HK\$178,519,000), net of ECL of HK\$103,138,000 (2021: HK\$79,843,000). Information about the ECL and the Group's loan receivables and other receivables is disclosed in note 30(b).

As permitted under HKFRS 15, the transaction price of estate management services allocated to the remaining performance obligations as at 31st December, 2022 and 2021 is not disclosed.

The executive directors of the Company have been identified as the chief operating decision maker. The executive directors regard the Group's business as a single operating segment, which is property leasing and estate management and reviews financial information as a whole accordingly. Therefore, no segment analysis of the Group's revenue, results, assets and liabilities are presented.

As at 31st December, 2022, other than financial assets at FVTPL, equity instrument at FVTOCI and loan receivables, the total of non-current assets located in Hong Kong and the People's Republic of China ("PRC") are HK\$1,244,637,000 and HK\$57,717,000 (2021: HK\$1,272,334,000 and HK\$62,566,000) respectively. During the current year, the total revenue derived from Hong Kong and the PRC are HK\$37,115,000 and HK\$1,264,000 (2021: HK\$36,951,000 and HK\$1,215,000) respectively.

The Bill was signed into law on 28th March, 2018 and was gazetted on the following day. Under the two-tiered profits tax rates regime, the first HK\$2 million of profits of the qualifying group entity will be taxed at 8.25%, and profits above HK\$2 million will be taxed at 16.5%. The profits of group entities not qualifying for the two-tiered profits tax rates regime will continue to be taxed at a flat rate of 16.5%.

Under the Law of the PRC on Enterprise Income Tax ("EIT Law") and Implementation Regulation of the EIT Law, the tax rate of the PRC subsidiaries is 25% for both years.

The Group's fair value interest rate risk related primarily to loan receivables.

The Group is exposed to cash flow interest rate risk as its cash equivalents and loan receivables which are subject to floating interest rate. However, the Group closely monitors interest rate movements and will enter into new banking facilities when favourable pricing opportunities arise. ### Credit risk and impairment assessment

The Group's exposure to credit risk arises from potential losses result from default on obligations by counterparties. The maximum exposure to the Group is represented by the carrying amount of its financial assets as stated in the consolidated statement of financial position.

Trade receivables consists of rental and estate management fees receivable from tenants. Credit checks are carried out before commencement of tenancies and on-going credit evaluation ensures any doubtful receivables are provided for as required. The exposure to credit risk is limited because the trade receivables are secured by tenant deposits. In this regard, the Directors consider that the Group's credit risk is significantly reduced and thus no loss allowance was recognised.

Regarding the credit risk management policy on note receivables, the Group assessments are based on the public subscription documents and the public information published by its listed guarantors. For the credit risk management policy on other loan receivables, the Group negotiates the credit limits and terms of new grants and renewals of loans receivable based on individual assessments of the background, financial strength and collateral provided on the loans of each of the borrowers. The credit limits and terms of the new grants or renewals of loans receivables are approved by the directors of the lender subsidiaries on case-by-case basis. As at 31st December, 2022, there are in total 2 (2021: 2) outstanding note receivables issued by listed entities in Hong Kong and 2 debtors (2021: 2 debtors) of outstanding other loan receivables, comprising private companies in Hong Kong and a related party in the PRC.

The Group performs a credit quality review to provide early identification of possible changes in the creditworthiness of counterparties regularly, including financial information analysis, collateral revisions and interviews with borrowers to update the credit risk of borrowers. The credit quality review enables the Group to assess the potential loss as a result of the risk to which it is exposed and take appropriate corrective actions.

The Group's note receivables are kept in the security broker account and the repayment of interests and principals of note receivables are directly debited in the security broker account when due. For the other loan receivables, the Group billed in advance by the debit notes to the borrowers. The Group performs ongoing monitoring on the note receivables and loan receivables repayment and the finance department of the Group is responsible for reporting to the Directors for any delay or default in repayment of the note receivables and loan receivables by the issuer or the borrower (as the case may be) upon maturity for further assessment of the loan recoverability and formulation of plans for loan collection.

The internal audit department within the Group periodically conducts internal control reviews and compliance checking over all aspects of credit processes to ensure that the credit procedures are complied with and sufficient controls are in place to mitigate credit risk.

The credit risk on liquid funds is limited because the counterparties are banks with high credit ratings assigned by international credit-rating agencies.

本集團以12個月的預期信貸虧損為基礎,評估了賬面總額為14,056,000港元(二零二一年:21,558,000港元)之其他應收款項之虧損撥備。其他應收款項之預期虧損為個別評估,並酌情考慮債務人過往之違約經驗及內部信用評級以及前瞻性資訊(如適用)。自首次確認以來,信用風險沒有顯著增加。

本集團沒有其他重大集中之信貸風險,風險亦分 散在眾多交易對手和客戶身上。

此外,本集團針對交易應收款項重新評估全期預期信貸虧損及其他金融資產於報告期末之12個月預期信貸虧損,確保對首次確認之風險有顯著增加趨勢提供足夠的減值虧損。就此而言,本集團之管理層認為本集團之信貸風險已大大降低。

為了減低信貸風險,本集團已制定按不同類別按 違約程度計算之信貸風險評級。本集團利用公 開的財務資訊及其過往之還款記錄,或在適當情 況下聘請外部評估師對主要客戶及債務人進行評 級。本集團於此方面及交易對手的信貸品質進行 持續監察及按所屬單位審批每個交易。

The Group had a concentration of credit risk as the loan receivables are advanced to a few independent third parties and related parties. As at 31st December, 2022, the loan receivables will be matured ranging from November 2023 to November 2024 (2021: November 2022 to November 2024). Management had assessed the credit rating of the borrowers for the secured and unsecured loan receivables of HK\$154,729,000 (2021: HK\$176,329,000). During the year ended 31st December, 2022, there is a default in repayment of note receivable with a principal amount of HK\$97,640,000 (2021: HK\$96,890,000) and the interest receivable of HK\$3,417,000 (2021: HK\$3,391,000), all other loans interest have been settled in accordance with agreement terms.

The Group assessed the loss allowances for other receivables with gross carrying amounts of HK\$14,056,000 (2021: HK\$21,558,000) on 12m ECL basis. The expected loss of other receivables are assessed individually, taking into account the historical default experience and internal credit rating of the debtors as well as forward-looking information, as appropriate. There had been no significant increase in credit risk since initial recognition.

The Group has no other significant concentrations of credit risk, with exposure spread over a number of counterparties and customers.

In addition, the Group reassesses the lifetime ECL for trade receivables and the 12m ECL for other financial assets at the end of the reporting period to ensure that adequate impairment losses are made for significant increases in the likelihood or risk of a default occurring since initial recognition. In this regard, management of the Group considers that the Group's credit risk is significantly reduced.

In order to minimise credit risk, the Group has developed credit risk grading to categorise exposures according to the degree of risk of default. The Group uses publicly available financial information and its own historical repayment records, or, where appropriate, engages the Valuer to rate its major customers and debtors. The Group's exposure and the credit quality of its counterparties are continuously monitored and the aggregate value of transactions concluded is spread amongst approved counterparties.

## 34. 報告期後事項

於二零二三年二月二十七日,本公司(「買方」)之間接全資附屬公司與第三方訂立一份買賣協議,以代價3港元,通過(i)收購一間投資控股公司(「目標公司」)之全部已發行股本及(ii)將目標公司所欠其股東的貸款轉讓以收購一個位於香港的物業,並進一步同意於完成交易時買方將訂立一份貸款協議向目標公司提供金額為1,000,000,000港元之貸款。收購之總支付金額為1,000,000,003港元。

於同日,本集團訂立兩份買賣協議以出售其非核心物業。一份為本公司之直接全資附屬公司與天安之直接全資附屬公司訂立之買賣協議,以代價80,000,000港元,通過出售一間投資控股公司的全部已發行股本及轉讓股東貸款的方式出售本集團位於中國之若干非核心物業。另一份為本公司之直接全資附屬公司與聯合集團之間接全資附屬公司訂立之買賣協議,以總代價250,000,000港元,通過出售兩間投資控股公司的全部已發行股本及轉讓各股東之貸款的方式出售本集團位於香港之若干非核心物業。

上述交易尚須經本公司之股東或獨立股東(視乎情況)於特別股東大會上批准,並須符合其他先決條件。截至報告日,該收購及出售尚未完成。上述交易之詳情已於日期為二零二三年二月二十七日之本公司、天安及聯合集團之聯合公佈中披露。

# 34. Events after the Reporting Period

On 27th February, 2023, an indirect wholly-owned subsidiary of the Company ("Purchaser") entered into a sale and purchase agreement with third parties to acquire a property in Hong Kong through (i) the acquisition of the entire issued share capital of an investment holding company ("Target Company") and (ii) the assignment of loan indebted by the Target Company to its shareholder, at the consideration of HK\$3. It was further agreed that at completion, the Purchaser shall enter into a loan agreement to provide to the Target Company a loan in the amount of HK\$1,000,000,000. The total payment for the acquisition shall be HK\$1,000,000,003.

On the even date, the Group entered into two sale and purchase agreements to dispose of its non-core properties. A sale and purchase agreement was entered into between a direct wholly-owned subsidiary of the Company and a direct wholly-owned subsidiary of TACI to dispose of certain PRC non-core properties of the Group through the disposal of the entire issued share capital of an investment holding company and the assignment of shareholder's loan at the consideration of HK\$80,000,000. Another sale and purchase agreement was entered into between a direct wholly-owned subsidiary of the Company and an indirect wholly-owned subsidiary of AGL to dispose of certain Hong Kong non-core properties of the Group through the disposal of the entire issued share capital of two investment holding companies and the assignment of the respective shareholder's loans at the aggregate consideration of HK\$250,000,000.

The above transactions are subject to the approval of the shareholders or independent shareholders (as the case may be) of the Company at an extraordinary general meeting and fulfilment of other conditions precedent. The acquisition and disposals have not been completed as at the reporting date. Details of the abovementioned transactions were disclosed in the joint announcement of the Company, TACI and AGL dated 27th February, 2023.
