CHAIRMAN'S STATEMENT

主席報告



On behalf of the board (the “**Board**”) of directors (the “**Directors**”) of Sprocomm Intelligence Limited (the “**Company**”), I present the audited consolidated results of the Company and its subsidiaries (collectively the “**Group**”) for the year ended 31 December 2022 to the shareholders of the Company.



Business Review

During the year ended 31 December 2022, the Group, as one of the leading ODM mobile phone suppliers based in China, continued to focus on the research and development, designing, manufacturing and sale of mobile phones, PCBAs for mobile phones and IoT related products, targeting emerging markets.



In March 2022, the People's Republic of China (“**PRC**”) experienced another outbreak of novel coronavirus (“**COVID-19**”) and the PRC Government swiftly responded by implementing various emergency public health measures. These public health measures caused disruptions to the business activities and economy of the PRC. Leveraging on the experience from previous COVID-19 outbreaks, the Group had implemented effective strategies to reduce the impact from the public health measures on its business operations and financial performance.

During the year ended 31 December 2022, the Group recorded revenue of approximately RMB1,450.4 million, representing a decrease of approximately 27.5% as compared to last year. On the other hand, the Group's gross profit margin significantly improved from approximately 8.6% for the year ended 31 December 2021 to approximately 14.0% for the year ended 31 December 2022, mainly resulted from the decrease in the costs of major raw materials. The significant improvement in the gross profit margin fully offset the adverse impact from the decrease in revenue and the Group recorded a profit after tax of approximately RMB6.4 million for the year ended 31 December 2022 as compared to a loss of approximately RMB18.1 million for the year ended 31 December 2021.

業務回顧

截至二零二二年十二月三十一日止年度，本集團作為中國領先的ODM手機供應商之一，一直致力於研發、設計、生產以及銷售手機、手機的印刷電路板組裝以及物聯網相關產品，著力開拓新興市場。

二零二二年三月，中華人民共和國(「**中國**」) 經歷另一波新冠病毒疫情(「**COVID-19**」)，中國政府迅速實施各種緊急公共衛生措施應對。該等公共衛生措施對中國的商業活動及經濟造成干擾。有了前幾波 COVID-19 疫情的經驗，本集團實施了有效的策略，減低公共衛生措施對其業務營運及財務表現的影響。

截至二零二二年十二月三十一日止年度，本集團錄得收益約人民幣1,450.4百萬元，較去年減少約27.5%。另一方面，本集團的毛利率由截至二零二一年十二月三十一日止年度的約8.6%大幅上升至截至二零二二年十二月三十一日止年度的約14.0%，主要由於主要原材料成本下降。毛利率大幅上升，完全抵銷收益跌幅的不利影響，本集團於截至二零二二年十二月三十一日止年度錄得除稅後溢利約人民幣6.4百萬元，而截至二零二一年十二月三十一日止年度則錄得虧損約人民幣18.1百萬元。

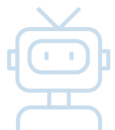

Business Overview

The Group is an ODM mobile phone supplier based in the People's Republic of China (the “PRC”), primarily engaged in research and development, designing, manufacturing and sale of mobile phones, PCBAs for mobile phones and IoT related products, targeting emerging markets.

The Group's products are sold worldwide with strategic focus on emerging markets which have high population and growing demands on mobile phones. Revenue generated from PRC and other emerging markets accounted for 95.8% of the Group's total revenue for the year ended 31 December 2022. The Group's customers include various top local branded mobile phone suppliers, telecommunication operators and trading companies in the PRC, India, other Asian countries and other parts of the world.

In March 2022, the PRC experienced another outbreak of novel coronavirus (“COVID-19”) and the PRC Government swiftly responded by implementing various emergency public health measures. These public health measures caused disruptions to the business activities and economy of the PRC. Leveraging on the experience from previous COVID-19 outbreaks, the Group had implemented effective strategies to reduce the impact from the public health measures on its business operations and financial performance.

During the year ended 31 December 2022, the Group recorded revenue of approximately RMB1,450.4 million, representing a decrease of approximately 27.5% as compared to last year. On the other hand, the Group's gross profit margin significantly improved from approximately 8.6% for the year ended 31 December 2021 to approximately 14.0% for the year ended 31 December 2022, mainly resulted from the decrease in the costs of major raw materials. 業務概覽

本集團向全世界銷售產品，並將人口眾多且手機需求不斷增長的新興市場作為策略重點。截至二零二二年十二月三十一日止年度，本集團來自中國及其他新興市場的收益佔總收益的95.8%。本集團的客戶包括中國、印度、其他亞洲國家及全球其他地方的多家頂尖的本土品牌手機供應商、電信運營商及貿易公司。

於二零二二年三月，中國再次爆發新型冠狀病毒（「COVID-19」）疫情，中國政府迅速作出反應，實施各種緊急公共衛生措施。該等公共衛生措施對中國的商業活動及經濟造成干擾。借鑒以往COVID-19疫情的經驗，本集團實施有效策略，以減少公共衛生措施對其業務營運及財務表現的影響。

截至二零二二年十二月三十一日止年度，本集團錄得收益為約人民幣1,450.4百萬元，較去年減少約27.5%。另一方面，本集團的毛利率從截至二零二一年十二月三十一日止年度的約8.6%大幅提高至截至二零二二年十二月三十一日止年度的約14.0%，主要由於主要原材料成本下降。毛利率的大幅提高完全抵銷收益減少帶來的不利影響，本集團於截至二零二二年十二月三十一日止年度錄得除稅後溢利約人民幣6.4百萬元，而截至二零二一年十二月三十一日止年度則為虧損約人民幣18.1百萬元。

Revenue

Revenue by product categories

The Group's product portfolio includes smartphones, feature phones, PCBAs for mobile phones and IoT related products. The Group mainly derives its revenue from the sales of smartphones and IoT products. Set out below is a breakdown of the Group's total revenue by product categories and the revenue generated from each product category as a percentage of total revenue for the year ended 31 December 2022 and 2021:

The Group's total revenue decreased by 27.5% to RMB1,450.4 million for the year ended 31 December 2022 from RMB2,000.1 million for the year ended 31 December 2021, primarily attributed to the decrease in sales of smartphones to India and sales of IoT related products to the PRC, but partially offset by increase in sales to customers from the Republic of Korea and the United States of America.

本集團的總收益由截至二零二一年十二月三十一日止年度的人民幣2,000.1百萬元減少27.5%至截至二零二二年十二月三十一日止年度的人民幣1,450.4百萬元，主要由於印度的智能電話銷售及中國的物聯網相關產品銷售減少，惟被大韓民國及美利堅合眾國客戶的銷售增加部分抵銷。

Revenue from mobile phones decreased by 16.2% to RMB1,029.8 million for the year ended 31 December 2022 from RMB1,229.1 million for the year ended 31 December 2021, primarily attributed to the decrease in sales of smartphones to India and the People's Republic of Bangladesh.

Revenue from PCBAs increased by 45.8% to RMB28.8 million for the year ended 31 December 2022 from RMB19.7 million for the year ended 31 December 2021, as customers placed more orders for PCBAs to suit their own needs.

Revenue from IoT related products decreased by 49.9% to RMB296.5 million for the year ended 31 December 2022 from RMB591.3 million for the year ended 31 December 2021, primarily attributed to the decrease in sales orders from a major customer in the PRC.

來自手機的收益由截至二零二一年十二月三十一日止年度的人民幣1,229.1百萬元減少16.2%至截至二零二二年十二月三十一日止年度的人民幣1,029.8百萬元，主要由於印度及孟加拉人民共和國的智能手機銷售減少。

來自印刷電路板組裝的收益由截至二零二一年十二月三十一日止年度的人民幣19.7百萬元增加45.8%至截至二零二二年十二月三十一日止年度的人民幣28.8百萬元，原因是更多客戶下訂單購買印刷電路板組裝以滿足其自身需求。

來自物聯網相關產品的收益由截至二零二一年十二月三十一日止年度的人民幣591.3百萬元減少49.9%至截至二零二二年十二月三十一日止年度的人民幣296.5百萬元，主要由於來自中國一名主要客戶的銷售訂單減少。

Revenue from India decreased by 21.2% to RMB757.8 million for the year ended 31 December 2022 from RMB962.2 million for the year ended 31 December 2021, primarily attributed to the decrease in demand for smartphones.

來自印度的收益由截至二零二一年十二月三十一日止年度的人民幣962.2百萬元減少21.2%至截至二零二二年十二月三十一日止年度的人民幣757.8百萬元，主要由於智能手機需求減少。

Revenue from the PRC decreased by 35.6% to RMB509.1 million for the year ended 31 December 2022 from RMB791.1 million for the year ended 31 December 2021, primarily attributed to decrease in sales orders for IoT related products from a major customer in the PRC.

來自中國的收益由截至二零二一年十二月三十一日止年度的人民幣791.1百萬元減少35.6%至截至二零二二年十二月三十一日止年度的人民幣509.1百萬元，主要由於來自一名中國主要客戶的物聯網相關產品銷售訂單減少。

Revenue from People's Republic of Bangladesh decreased by 52.1% to RMB95.4 million for the year ended 31 December 2022 from RMB199.2 million for the year ended 31 December 2021, primarily attributed to decrease in sales orders for smartphones from a major customer.

Revenue from the Republic of Korea increased to RMB26.8 million for the year ended 31 December 2022 from nil for the year ended 31 December 2021, primarily attributed to the increase in the Group's marketing effort to expand its sales geographical locations.

Revenue from the United States of America increased to RMB20.4 million for the year ended 31 December 2022 from nil for the year ended 31 December 2021, primarily attributed to the increase in the Group's marketing effort to expand its sales geographical locations.

Revenue from Algeria increased by 11.1% to RMB27.9 million for the year ended 31 December 2022 from RMB25.1 million for the year ended 31 December 2021, primarily attributed to the increase in demand for smartphones.

Gross profit and gross profit margin

Gross profit increased by 18.2% to RMB203.6 million for the year ended 31 December 2022 from RMB172.2 million for the year ended 31 December 2021. Gross profit margin increased to 14.0% for the year ended 31 December 2022 from 8.6% for the year ended 31 December 2021. The increase in gross profit and gross profit margin was primarily attributed to the decrease in the costs of major raw materials.

Other gains and income

Other gains and income mainly include comprises government subsidies and amortisation of government subsidies, bank interest income, exchange gain and sundry income. The Group's other gains and income increased by 17.4% to RMB52.2 million for the year ended 31 December 2022 from RMB44.4 million for the year ended 31 December 2021, primarily attributed to the increase in bank interest income by RMB6.4 million and exchange gain by RMB15.9 million.

來自孟加拉人民共和國的收益由截至二零二一年十二月三十一日止年度的人民幣199.2百萬元減少52.1%至截至二零二二年十二月三十一日止年度的人民幣95.4百萬元，主要由於來自一名主要客戶的智能手機銷售訂單減少。

來自大韓民國的收益由截至二零二一年十二月三十一日止年度的零增加至截至二零二二年十二月三十一日止年度的人民幣26.8百萬元，主要由於本集團加大營銷力度，擴大其銷售地區。

來自美利堅合眾國的收益由截至二零二一年十二月三十一日止年度的零增加至截至二零二二年十二月三十一日止年度的人民幣20.4百萬元，主要由於本集團加大營銷力度，擴大其銷售地區。

來自阿爾及利亞的收益由截至二零二一年十二月三十一日止年度的人民幣25.1百萬元增加11.1%至截至二零二二年十二月三十一日止年度的人民幣27.9百萬元，主要由於智能手機需求增加。

毛利及毛利率

毛利由截至二零二一年十二月三十一日止年度的人民幣172.2百萬元增加18.2%至截至二零二二年十二月三十一日止年度的人民幣203.6百萬元。毛利率由截至二零二一年十二月三十一日止年度的8.6%上升至截至二零二二年十二月三十一日止年度的14.0%。毛利及毛利率增加主要是由於主要原材料的成本下跌。

其他收益及收入

其他收益及收入主要包括政府補貼及政府補助攤銷、銀行利息收入、匯兌收益及雜項收入。本集團其他收益及收入由截至二零二一年十二月三十一日止年度的人民幣44.4百萬元增加17.4%至截至二零二二年十二月三十一日止年度的人民幣52.2百萬元，主要由於銀行利息收入增加人民幣6.4百萬元及匯兌收益增加人民幣15.9百萬元。

Selling and distribution expenses

Selling and distribution expenses mainly represent transportation and custom declaration expenses, salaries and employee benefits of our sales and marketing staff, business-related travelling and entertainment expenses. Selling and distribution expenses for the year ended 31 December 2022 decreased by 5.9% to RMB38.8 million from RMB41.2 million for the year ended 31 December 2021, primarily attributed to the decrease in transportation and custom declaration expenses resulting from the drop in sales.



Administrative expenses

Administrative expenses mainly represent salaries and benefits of our administrative and management staff, depreciation, amortisation of intangible assets, general office expenses, legal and professional fees, rental expenses, insurance expenses, bank charges, exchange losses and other miscellaneous administrative expenses. Administrative expenses for the year ended 31 December 2022 remained relatively stable at RMB64.9 million as compared with RMB65.9 million for the year ended 31 December 2021.



Research and development expenses

Research and development expenses for the year ended 31 December 2022 increased by 4.3% to RMB124.1 million from RMB119.0 million for the year ended 31 December 2021, primarily attributed to the salary increment of the Group's research and development staff.

Finance costs

Finance costs mainly represent interests on discounted bills, interest portion of lease liabilities, bank borrowings and factoring loans. The Group's finance costs for the year ended 31 December 2022 increased by 182.3% to RMB18.3 million from RMB6.5 million for the year ended 31 December 2021, primarily attributed to increase in interest on discounted bills financing and factoring loans.

Income tax expenses

For the year ended 31 December 2022, the Group's income tax expenses amounted to RMB3.5 million as compared with RMB2.2 million for the year ended 31 December 2021. The increase in income tax expenses was primarily attributed to the increase in assessable profits for the year ended 31 December 2022.

銷售及分銷開支

銷售及分銷開支主要為運輸及清關費用、我們銷售及市場營銷員工的薪金及僱員福利以及業務相關差旅及酬酢開支。銷售及分銷費用由截至二零二一年十二月三十一日止年度的人民幣41.2百萬元減少5.9%至截至二零二二年十二月三十一日止年度的人民幣38.8百萬元，主要由於銷售減少，導致運輸及清關費用減少。

行政開支

行政開支主要為我們行政及管理員工的薪金及福利、折舊、無形資產攤銷、一般辦公室開支、法律及專業費用、租金開支、保險開支、銀行費用、匯兌虧損及其他雜項行政開支。行政開支於截至二零二二年十二月三十一日止年度維持相對穩定，為人民幣64.9百萬元，而截至二零二一年十二月三十一日止年度則為人民幣65.9百萬元。

研發開支

研發開支由截至二零二一年十二月三十一日止年度的人民幣119.0百萬元增加4.3%至截至二零二二年十二月三十一日止年度的人民幣124.1百萬元，主要由於本集團研發員工加薪所致。

融資成本

融資成本主要為貼現票據、租賃負債的利息部分、銀行借貸及保理貸款利息。本集團的融資成本由截至二零二一年十二月三十一日止年度的人民幣6.5百萬元增加182.3%至截至二零二二年十二月三十一日止年度的人民幣18.3百萬元，主要由於貼現票據融資及保理貸款的利息增加。

所得稅開支

本集團截至二零二二年十二月三十一日止年度的所得稅開支為人民幣3.5百萬元，而截至二零二一年十二月三十一日止年度的所得稅開支則為人民幣2.2百萬元。所得稅開支增加主要是由於截至二零二二年十二月三十一日止年度的應課稅溢利增加。

Net profit/(loss) for the year

As a result of the above factors, the Group recorded a net profit of RMB6.4 million for the year ended 31 December 2022 (2021: a net loss of RMB18.1 million).

Dividend

The Board does not recommend the payment of dividend for the year ended 31 December 2022 (2021: nil).

Trade and bills receivables

As at 31 December 2022, the Group's trade and bills receivables amounted to RMB191.7 million (31 December 2021: RMB226.0 million). The Group generally grants credit period ranging from 30 to 90 days to its customers and allows its PRC customers to settle their purchases by way of bills with maturity period ranging from three to six months.

In order to minimise credit risk, the Group carefully assesses the background information and credit worthiness of its customers before it decides to grant them credit periods. Further, the Group also closely monitors the payment record of its customers and regularly reviews the credit terms granted to them. The Group's credit assessment is based on various factors, including but not limited to the financial strength, size of the business and payment history of customers and length of their business relationship with the Group.

The Group's average trade and bills receivables turnover days for the year ended 31 December 2022 were 52.6 days (2021: 51.6 days), which were within the range of credit periods normally offered by the Group to its customers. The shortened average trade and bills receivables turnover days were primarily attributed to the decrease in trade and bills receivables. Based on the dates of the relevant sales invoices, 95.6% of the Group's trade and bills receivables aged within 90 days and the Group did not notice any substantial long outstanding balances.

由於上述各項因素，本集團截至二零二二年十二月三十一日止年度錄得純利人民幣6.4百萬元（二零二一年：虧損淨額人民幣18.1百萬元）。

股息

董事會不建議派付截至二零二二年十二月三十一日止年度的股息（二零二一年：零）。

貿易應收款項及應收票據

於二零二二年十二月三十一日，本集團的貿易應收款項及應收票據為人民幣191.7百萬元（二零二一年十二月三十一日：人民幣226.0百萬元）。本集團通常向客戶授出介乎30至90天的信貸期，並容許中國客戶以到期期限介乎三至六個月的票據結付彼等之採購款。

為盡量降低我們的信貸風險，本集團於決定向客戶授出信貸期前謹慎評估其背景資料及信譽。此外，本集團亦密切監測客戶的支付紀錄，定期審閱我們向彼等授出的信貸期。本集團的信貸評估乃基於多項因素，包括但不限於客戶的財務實力、業務規模及支付紀錄以及彼等與本集團業務關係的年期。

截至二零二二年十二月三十一日止年度，本集團的貿易應收款項及應收票據平均週轉天數為52.6天（二零二一年：51.6天），處於本集團通常向客戶提供的信貸期範圍內。貿易應收款項及應收票據平均週轉天數按年縮短主要是由於貿易應收款項及應收票據減少。根據相關銷售發票日期，本集團95.6%的貿易應收款項及應收票據於90日內到期，本集團並未發現任何重大長期未付結餘。

Trade and bills payables

As at 31 December 2022, the Group's trade and bills payables amounted to RMB940.6 million (31 December 2021: RMB524.1 million). Suppliers generally grant the Group credit period ranging from 30 to 60 days, with certain suppliers require the Group to make advance payment before product delivery. The Group has financial risk management policies in place to ensure that all payables are settled within the credit timeframe. Certain suppliers allow the Group to settle its purchases by way of bank acceptance bills and the Group may also endorse certain bills receivables to its suppliers in order to settle the trade payable due to them.



The Group's average trade and bills payables turnover days for the year ended 31 December 2022 were 214.4 days (2021: 111.4 days). The lengthened average trade and bills payables turnover days were primarily attributed to the increase in trade and bills payables.

Capital structure, liquidity, financial resources and gearing

The Company's shares were successfully listed on the Main Board of the Stock Exchange on 13 November 2019. There has been no change in the capital structure of the Group since then. The Group mainly funds its business and working capital requirements by using a balanced mix of internal resources, borrowings and funds from the global offering.

The funding mix will be adjusted depending on the costs of funding and the actual needs of the Group. For the year ended 31 December 2022, the Group recorded a positive cash flow from operating activities of RMB555.9 million (Year ended 31 December 2021: positive cash flow of RMB21.4 million).

截至二零二二年十二月三十一日止年度，本集團貿易應付款項及應付票據的平均週轉天數分別為214.4天（二零二一年：111.4天）。貿易應付款項及應付票據平均週轉天數按年增加主要是由於貿易應付款項及應收票據增加。

資本架構、流動資金、財務資源及資本負債

本公司股份於二零一九年十一月十三日成功於聯交所主板上市。本集團的資本架構自此並無變動。本集團主要透過平衡地動用內部資源、借款及全球發售所得資金撥付業務及營運資金需求。

資金組合將根據資金成本及本集團實際需求進行調整。截至二零二二年十二月三十一日止年度，本集團錄得經營活動正現金流量人民幣555.9百萬元（截至二零二一年十二月三十一日止年度：正現金流量人民幣21.4百萬元）。

As at 31 December 2022, the Group had net current assets of RMB225.7 million (31 December 2021: RMB218.7 million), cash and cash equivalents amounted to RMB36.6 million (31 December 2021: RMB82.9 million), pledged bank deposits of RMB764.4 million (31 December 2021: RMB219.2 million) and borrowings amounted to RMB51.8 million (31 December 2021: RMB58.2 million). The Group's cash and cash equivalents and bank borrowings as at 31 December 2022 were mainly denominated in RMB.

As at 31 December 2022, the Group had borrowings of RMB10.0 million (31 December 2021: RMB19.8 million) subject to fixed interest rates and borrowings of RMB41.8 million (31 December 2021: RMB38.4 million) subject to variable interest rates. As at 31 December 2022, the Group had a current ratio of 1.2 times (31 December 2021: 1.3 times) and gearing ratio of 0.2 (calculated by dividing total debt by total equity) (31 December 2021: 0.2).

As at 31 December 2022, the Group's unutilised borrowing facilities amounted to RMB110.4 million (31 December 2021: RMB120.9 million).

Capital expenditure

For the year ended 31 December 2022, the Group incurred cash flows on capital expenditures for the purchase of properties, plant and equipment in the amount of RMB8.5 million (2021: RMB3.1 million); and intangible assets in the amount of RMB0.8 million (2021: RMB4.0 million), respectively.

Capital commitments

As at 31 December 2022, the Group had capital commitments of RMB1.7 million in relation to the purchase of property, plant and equipment (31 December 2021: nil).

Contingent liabilities

As at 31 December 2022, the Group did not have any material contingent liabilities or guarantees (31 December 2021: nil).

Significant investments held by the group

Saved as disclosed herein, the Group did not make any other significant investments during the year ended 31 December 2022.

Future plans for material investments and capital assets

On 26 November 2020, Sprocomm Intelligence Limited (“Sprocomm Intelligence”), an indirect wholly-owned subsidiary of the Company, entered into an investment agreement with the Management Committee of New Lingang Area of PRC (Shanghai) Pilot Free Trade Zone* (中國(上海)自由貿易試驗區臨港新片區管理委員會) (the “Lingang Committee”), pursuant to which, among others, (i) Sprocomm Intelligence agreed to set up a smart device R&D headquarters at New Lingang Area with an investment of fixed assets of not less than RMB120 million (equivalent to approximately HK\$142 million); and (ii) Lingang Committee agreed to provide various kinds of support and subsidy to Sprocomm Intelligence. As at 31 December 2021, the aforesaid investment was still in a preliminary planning stage. For the details of this investment agreement, please refer to the Company’s announcement dated 26 November 2020.

In the first quarter of 2022, the public bidding for the relevant land parcel took place. The Group and the Lingang Committee entered into a land use right transfer agreement, pursuant to which the Lingang Committee agreed to transfer the land use right for the land parcel situated at Nanhui New Town, Pudong New Area (a site area of 6,373.3 square metres) to the Group at a consideration of approximately RMB14.3 million. It is expected that the land use right permit for this land parcel will be received in 2023.

Saved as disclosed herein, the Group did not have any future plans for material investments and capital assets during the year ended 31 December 2022.

Foreign exchange risks

For the year ended 31 December 2022, the Group derived 64.9% (2021: 60.5%) of its total revenue from export sales and these export sales were principally denominated in USD. As at 31 December 2022, the Group had USD-denominated monetary assets with carrying amount of RMB128.7 million (31 December 2021: RMB141.2 million) and USD-denominated monetary liabilities of RMB33.9 million (31 December 2021: RMB49 million). The Group is exposed to foreign exchange risk arising from its export sales, monetary assets and liabilities denominated in foreign currencies. Any appreciation of RMB against USD will have a negative impact on the Group's profit margin. Management of the Group regularly reviews the impact of exchange risk exposure on the Group's financial performance and may use foreign exchange hedging instruments to reduce the Group's exchange risk exposure if appropriate.

Employees, remuneration policy and training

As at 31 December 2022, the Group had 890 employees (31 December 2021: 1,022 employees), whose remunerations and benefits are determined based on market rates, government policies and individual performance. For the year ended 31 December 2022, the Group's total staff costs (including directors' emoluments, salaries, allowances and other benefits and contributions to retirement benefits scheme) amounted to RMB141.5 million (2021: RMB137.7 million). To provide incentives or rewards to its employees, the Company adopted a share option scheme, particulars of which are set out in the section headed "Share option scheme" in this annual report. The Group provides comprehensive training and development opportunities to its employees on a regular basis. The trainings are arranged according to needs of employees, which are identified annually by individual departments.



Pension scheme

The employees of the Group's subsidiaries established in the PRC are required to participate in a state-managed retirement benefit scheme (the "Defined Contribution Scheme") operated by the PRC government. The Group is required to contribute a certain percentage of basic payroll costs to the Defined Contribution Scheme.

The Group's contributions to the Defined Contribution Scheme vest fully and immediately with the employees. Accordingly, (i) for the year ended 31 December 2022, there was no forfeiture of contributions under the Defined Contribution Scheme; and (ii) there were no forfeited contributions available for the Group to reduce its existing level of contributions to the Defined Contribution Scheme as at 31 December 2022. The contributions are charged to profit or loss as they become payable in accordance with the rules of the Defined Contribution Scheme.

Event after the reporting period

Saved as disclosed herein, the Group does not have any important events after the year ended 31 December 2022 and up to the date of this annual report.

Mr. Li established Shenzhen Sprocomm Telecommunication Technology Co., Ltd.* (深圳禾苗通信科技有限公司) (“**Shenzhen Sprocomm**”), the main operating subsidiary of the Group, with Mr. Xiong Bin on 16 September 2009. He is also currently the director of the Company’s subsidiaries, namely Shenzhen Sprocomm, Sprocomm Intelligence (HK) Holdings Limited (禾苗智能控股有限公司), Sprocomm Technologies Co., Ltd. (禾苗通信科技有限公司), Sprocomm Technologies Co., Ltd. The Board strives to adhere to the principles of corporate governance and has adopted sound corporate governance practices to meet the legal and commercial standards, focusing on areas such as internal control, fair disclosure and accountability to all shareholders of the Company to ensure the transparency and accountability of all operations of the Company. The Company believes that effective corporate governance is an essential factor to create more value for the shareholders of the Company. The Board will continue to review and improve the corporate governance practices of the Group from time to time to ensure that the Group is led by an effective Board in order to optimise return.

Corporate culture and strategy

The Company is an investment holding company and the principal activities of its subsidiaries include research and development, design, manufacture and sale of mobile phones, PCBAs for mobile phones and IoT related products. The Group is committed to provide high quality and reliable products and services, and to create values to the stakeholders through sustainable growth and continuous development.

The Board fosters a corporate culture by setting out the following values to guide the conduct and behaviours of employees and to ensure that the Company's vision, mission and business strategies are aligned to this corporate culture:

The Group will continue to review and adjust its business strategies and keep track of the changing market conditions to ensure prompt and proactive measures will be taken to respond to the changes and meet the market needs to support the continuous business development of the Group.

Adoption and compliance of corporate governance practices

The Company has adopted a set of corporate governance practices which aligns with the code provisions of the Corporate Governance Code (the “CG Code”) as set out in Appendix 14 of The Rules Governing the Listing of Securities on the Stock Exchange (the “Listing Rules”) since 13 November 2019. Except for code provision C.2.1, the Company has complied with the code provisions set out in the CG Code for the year ended 31 December 2022.

Code provision C.2.1 of the CG Code states that the roles of chairman and chief executive should be separate and should not be performed by the same individual. Under the current organisation structure of the Company, Mr. Li Chengjun is the Group’s chief executive officer, and he also performs as the chairman of the Board as he has considerable experience in the mobile communication industry. The Board believes that vesting the roles of both the chairman of our Board and the chief executive officer in the same person has the benefit of ensuring consistent leadership within the Group and enables more effective and efficient overall strategic planning of the Group.

企業管治守則條文第C.2.1條列明，主席與行政總裁的角色應予區分，不應由同一人兼任。根據本公司目前組織架構，李承軍先生為本集團行政總裁兼董事會主席，彼於移動通信行業擁有大量經驗。董事會相信，由同一人擔任董事會主席和行政總裁的角色，有利於確保本集團內部領導貫徹一致，並為本集團提供更有效及高效的整體戰略規劃。

Although Mr. Li Chengjun performs both the roles of chairman of the board and chief executive officer, the division of responsibilities between the chairman of the board and chief executive officer is clearly established. In general, the chairman of the board is responsible for supervising the functions and performance of the Board, while the chief executive officer is responsible for the management of the Group's businesses. The two roles are performed by Mr. Li Chengjun distinctly. Further, the current structure does not impair the balance of power and authority between the Board and management of the Company given the appropriate delegation of the power of the Board and the effective functions of the independent non-executive Directors.

The Stock Exchange published its conclusions on the consultation paper entitled "Review of the Corporate Governance Code and Related Listing Rules" in December 2021. The revised Listing Rules and new CG Code have come into effect on 1 January 2022, and the requirements under the new CG Code will be applied to corporate governance reports for financial years commencing on or after 1 January 2022. The Company has complied with these new requirements.

Model code for securities transactions by directors of listed issuers (the "Model Code")

The Company has adopted the Model Code set out in Appendix 10 to the Listing Rules as its code of conduct regarding Directors' securities transactions. All Directors have confirmed that, following specific enquiry by the Company, they have complied with the required standard set out in the Model Code for the year ended 31 December 2022 and up to the date of this annual report.

Chairman and chief executive officer

CG Code provisions C.2.1 stipulates that the roles of chairman and chief executive officer should be separate and should not be performed by the same individual. The Company does not segregate the roles of chairman and chief executive officer and Mr. Li Chengjun currently holds both of the chairman and chief executive officer positions, as explained in the paragraph headed "Adoption and compliance of corporate governance practices" above in this Corporate Governance Report.

During the year ended 31 December 2022, the Company received from each of the independent non-executive Directors a written confirmation of their independence pursuant to Rule 3.13 of the Listing Rules. The Company considers that all the independent non-executive Directors are independent from 1 January 2022 to the date of this report.

The Directors are of the opinion that the current Board structure can ensure the independence and objectivity of the Board and provide a system of checks and balances to safeguard the interests of the Company and its shareholders.

Board independence

The Group has established mechanisms to ensure independent views and input are available to the Board and such mechanisms will be reviewed annually by the Board. During the year ended 31 December 2022, the Board has reviewed the implementation and effectiveness of the following mechanisms at the Board meeting:

1. Four out of the eight Directors are independent non-executive directors, which exceeds the requirement of the Listing Rules that at least one-third of the Board are independent non-executive directors;
2. The Nomination Committee will assess the independence of a candidate who is nominated to be a new independent non-executive director before appointment and the continued independence of the current long-serving independent non-executive director (if any) on an annual basis;
3. All independent non-executive Directors are required to submit a written confirmation to the Company annually to confirm the independence of each of them and their immediate family members, and their compliance with the requirements as set out in the Rule 3.13 of the Listing Rules;
4. All Directors are entitled to retain independent professional advisors as and when it is required;
5. All Directors are encouraged to express freely their independent views and constructive challenges during the Board/Committee meetings;
6. No equity-based remuneration with performance-related elements will be granted to independent non-executive Directors;
7. A Director (including independent non-executive Director) who has a material interest in a contract, transaction or arrangement shall not vote or be counted in the quorum on any Board resolution approving the same; and
8. The chairman of the Board meets with independent non-executive Directors annually without the presence of the Executive Directors.

Appointment, re-election and removal of directors

Each of the executive Directors, except Mr. Wen Chuanchuan has entered into a service contract with the Company for a term of three years commencing on 13 November 2019, until terminated by either party giving not less than three months' notice in writing to the other. Mr. Wen Chuanchuan was appointed as an executive Director on 1 June 2021 and he has entered into a service contract with the Company for a term of three years commencing on 1 June 2021, until terminated by either party giving not less than three months' notice in writing to the other. Each of the independent non-executive Directors has entered into an appointment letter with the Company for a term of three years commencing on 13 November 2019. Each of the independent non-executive Directors has renewed the appointment letter with the Company on 13 November 2022 and such appointment will be terminated by either party giving not less than three months' notice in writing to the other; and in accordance with the articles of association of the Company (the "Articles") and the Listing Rules.

According to article 109(a) of the Articles, at each annual general meeting one third of the Directors for the time being, or, if their number is not three or a multiple of three, then the number nearest to but not less than one-third, shall retire from office by rotation, provided that every Director (including those appointed for a specific term) shall be subject to retirement by rotation at least once every three years. A retiring Director shall be eligible for re-election. The Company at the general meeting at which a Director retires may fill the vacated office.

According to article 113 of the Articles, the Board shall have power from time to time and at any time to appoint any person as a Director either to fill a casual vacancy or as an additional Director, provided that the number of Directors so appointed shall not exceed the maximum number determined from time to time by the shareholders in general meeting. Any Director appointed by the Board to fill a casual vacancy shall hold office only until the first general meeting of the Company after his appointment and be subject to re-election at such meeting. Any Director appointed by the Board as an addition to the existing Board shall hold office only until the next following annual general meeting of the Company and shall then be eligible for re-election. Any Director appointed under this article shall not be taken into account in determining the Directors or the number of Directors who are to retire by rotation at an annual general meeting.

Board diversity policy

The Company adopted a board diversity policy (the “**Board Diversity Policy**”) on 12 November 2019, which sets out the objective and approach to achieve and maintain diversity on the Board in order to enhance the effectiveness of the Board. The Board Diversity Policy provides that the Company should endeavor to ensure that the Board members have the appropriate balance of skills, experience, and diversity of perspectives that are required to support the execution of its business strategy.



All Board appointments will be based on meritocracy, and candidates will be considered against appropriate criteria and the attributes that they will bring to the Board to complement and enrich the competencies, experience and diversity of the Board. Pursuant to the Board Diversity Policy, a number of factors will be taken into account in determining the board composition to achieve board diversity, including but not limited to professional experience, skills, knowledge, age, gender, education, cultural background and length of service.

The Nomination Committee reviews the Board Diversity Policy from time to time to ensure its continued effectiveness, such as assessing annually on the board's diversity profile and gender balance. The Nomination Committee would discuss any revisions to the Board Diversity Policy that may be required and recommend any such revisions and the appointment of suitable candidates to the Board for consideration and approval.

During the year ended 31 December 2022, the Nomination Committee reviewed the structure, size and composition of the Board with reference to the Board Diversity Policy in order to comply with the CG Code. The Company considers that the current composition of the Board, one out of its eight members being women, has achieved Board diversity through the consideration of a number of factors, including gender, nationality, professional background and skills. The current Directors have extensive experience in mobile communications industry and professional knowledge of corporate advisory, business development and accounting.

Nomination policy

The Company has adopted a nomination policy (the “**Nomination Policy**”) which sets out the criteria, process and procedures for the Nomination Committee to recommend suitable candidates for directorship with a view to ensuring that the Board has a balance of skills, experience and diversity of perspectives appropriate to the requirements of the Company's business.

Selection criteria

The Nomination Committee will propose a candidate for nomination or a Director for re-election based on the followings:

- the Board Diversity Policy and the requirements under the Listing Rules;
- the expected contribution the candidate would add to the Board and to ensure the Board has a balance of skills, experience and diversity of perspectives appropriate to the requirements of the Company's business;
- the candidate or the re-elected Director is able to commit and devote sufficient time and attention to the Company's affairs;
- the level of independence from the Company, and potential or actual conflicts of interest of the candidate or the re-elected Director; and
- other relevant factors considered by Nomination Committee on a case-by-case basis.

The aforesaid factors are for reference only, and not meant to be exhaustive and decisive. The Nomination Committee has the discretion to nominate any person as it considers appropriate.

Nomination process

The Nomination Committee is responsible for ensuring that the selection criteria are being applied consistently and fairly in the nomination process and confirming the same to the Board when making its recommendation on appointment.



A. Procedures for appointment of new Director

Subject to the provisions in the Articles, if the Board recognises the need to appoint a new Director, the following procedures should be adopted:

- the Nomination Committee identifies candidates in accordance with the selection criteria set out in the Nomination Policy and with the assistance from the Group's human resources department and external agencies (if necessary);
- the Nomination Committee evaluates the candidates and recommends to the Board the appointment of the appropriate candidate for directorship; and
- the Board decides the appointment based upon the recommendation of the Nomination Committee.

B. Procedures for re-election of Director at general meeting

Procedures for re-election of Director at general meeting are set out as follows:

- the Nomination Committee reviews the overall contribution to the Company of the retiring Director;
- the Nomination Committee also reviews and determines whether the retiring Director continues to meet the selection criteria set out in the Nomination Policy; and
- the Nomination Committee shall recommend to the Board which shall then make recommendation to shareholders in respect of the proposed re-election of Director at the general meeting.

A. 任命新董事程序

C. Procedures for nomination by shareholders

Procedures for nomination by shareholders are set out as follows:

- the Company's website sets out the procedures for shareholders to propose a person for election as a Director; and
- for any person that is nominated by a shareholder for election as a Director at the general meeting of the Company, the Nomination Committee shall evaluate such candidate based on the selection criteria set out in the Nomination Policy and to determine whether such candidate is qualified for directorship and where appropriate, the Nomination Committee shall recommend to the Board which shall then make recommendation to shareholders in respect of the proposed election of Director at the general meeting.

Monitoring and reporting

The Nomination Committee will report annually, in the Corporate Governance section of the Company's Annual Report, how the Policy is being applied in recommending candidates for directorship and retiring Directors for re-election during the year.

Review of the Nomination Policy

The Nomination Committee will review the Nomination Policy periodically in line with the Company's strategy and recommend any proposed changes to the Board for approval.

C. 股東提名程序

An annual general meeting of the Company (the “AGM”) shall be called by at least 21 days’ (and not less than 20 clear business days’) notice in writing, and a general meeting of the Company, other than an AGM, shall be called by at least 14 days’ (and not less than 10 clear business days’) notice in writing. A meeting of the Board or any committee of the Board may be held by means of such telephone, electronic or other communication facilities as permit all persons participating in the meeting.

A Director shall not vote (nor shall he be counted in the quorum) on any resolution of the Board in respect of any contract or arrangement or proposal in which he or any of his close associate(s) has/have a material interest, and if he shall do so his vote shall not be counted (nor shall he be counted in the quorum for that resolution).

Audit committee

The Company has established the Audit Committee on 18 October 2019 with written terms of reference in compliance with Rule 3.21 of the Listing Rules and the CG Code. The terms of reference of the Audit Committee are available on the websites of the Stock Exchange and the Company.



The Audit Committee consists of three independent non-executive Directors, namely Mr. Wong Kwan Kit, Mr. Lu Brian Yong Chen and Mr. Hung Wan Man. Mr. Wong Kwan Kit is the chairman of the Audit Committee.



The primary duties of the Audit Committee include ensuring that an effective financial reporting, internal control and risk management systems are in place and compliance of the Listing Rules, reviewing the financial statements, making recommendations to the Board on the appointment and removal of external auditors and assessing their independence and qualifications, and ensuring the effective communication with external auditors.

During the year ended 31 December 2022, the Audit Committee held three meetings and the work performed by the Audit Committee was summarised as follows:

1. reviewed the Company's interim results for the six months ended 30 June 2022 and annual results for the year ended 31 December 2021;
2. reviewed the Company's interim report for the six months ended 30 June 2022 and annual report for the year ended 31 December 2021, which set out the Group's accounting policies, financial performance and position;
3. reviewed the findings and recommendations from external auditors and the independent internal control reviewer;

The primary duties of the Remuneration Committee include making recommendations to the Board in determining the remuneration policy for and remuneration packages of the Directors and senior management, reviewing incentive schemes and service contracts of the Directors and senior management, and evaluating the performance of the Directors and senior management.

During the year ended 31 December 2022, the Remuneration Committee held one meeting to review and the work performed by the Remuneration Committee was summarised as follows:

1. made recommendations to the Board on the remuneration packages of Directors, senior management and employees of the Group;
2. reviewed the appropriateness of the remuneration policy; and

Nomination committee

The Company has established a Nomination Committee on 18 October 2019 with written terms of reference in compliance with CG Code provision B.3.1. The terms of reference of the Nomination Committee are available on the websites of the Stock Exchange and the Company.



The Nomination Committee consists of four Directors, namely Mr. Li Chengjun, Mr. Wong Kwan Kit, Mr. Lu Brian Yong Chen and Ms. Tseng Chin I. Mr. Li Chengjun is the chairman of the Nomination Committee. In compliance with the Listing Rules, the Nomination Committee is chaired by the chairman of the Board and the other members are independent non-executive Directors.



The primary duties of the Nomination Committee include assisting the Board in identifying suitable candidates for the Directors and making recommendations to the Board, assessing the structure and composition of the Board, preparing, making recommendations to and supervising the execution of the board diversity policy and nomination policy of the Company.

During the year ended 31 December 2022, the Nomination Committee held one meeting and the work performed by the Nomination Committee was summarised in the paragraph headed “Nomination policy” of this corporate governance report.

Dividend policy

The Company has adopted a dividend policy (the “**Dividend Policy**”) which aims to ensure sustainable development of its business operations and to provide a favorable return to its shareholders.

Declaration of dividend will be made at the discretion of the Board and will be based upon the Group’s earnings, cash flows, financial conditions, capital requirements, statutory fund reserve requirements and any other conditions that our Directors consider relevant. The declaration, payment and amount of dividend will also be subject to the Company’s constitutional documents including, where necessary, the approval of the shareholders.

The Board will review the Dividend Policy from time to time and may exercise its sole and absolute discretion to update, amend and/or modify the Dividend Policy at any time as the Board thinks fit and necessary. There is no assurance that dividends will be paid in any particular amount for any given period. The Dividend Policy shall in no way constitute a legally binding commitment by the Company that any dividend will be paid in any particular amount and/or in no way obligate the Company to declare a dividend at any time or from time to time.

Whistleblowing policy

In compliance with the CG Code, the Group has implemented whistleblowing policy to provide a well-defined and accessible channel for reporting fraud, corruption, dishonest practices, or other similar matters and guidance on how an investigation would be initiated upon receiving a complaint. The policy also protects employees who report fraudulent activities in good faith and reasonable belief. A whistleblowing officer is elected to ensure that any reported case is dealt with in an expedited manner.

Upon receiving the complaint, the Board decides the method of investigation, which may involve appointing an external consultant for assessment. The Board will monitor and review the effectiveness of the whistleblowing policy from time to time.

Anti-fraud and anti-corruption policy

In compliance with the CG Code, the Group has implemented anti-fraud and anti-corruption policy. According to the Group's anti-corruption policy, all employees shall abide by the laws and regulations of the PRC and shall not engage in any illegal activities. Employees shall uphold the code of ethics, advocate fair competition and act against bribery. Any bribery, fraud, money laundering and embezzlement are prohibited.

Employees must not accept or request any improper benefits including banquets, gifts, securities, valuables and high-expenditure entertainment activities from business partners, suppliers and merchants, etc. When there is any alleged case in violation of laws, regulations, code of conduct or Group's policies, the Group will investigate and impose disciplinary actions upon offenders after verification. The Group also provides trainings to directors and employees from time to time to ensure that they comply and familiar with the anti-fraud and anti-corruption policy of the Group.

反欺詐及反貪腐政策

根據企業管治守則，本集團已實施反欺詐及反貪腐政策。根據本集團的反貪腐政策，全體僱員須遵守中國的法律及法規，不得從事任何違法活動。僱員須恪守道德準則、倡導公平競爭及防止賄賂。嚴禁任何賄賂、欺詐、洗黑錢及挪用公款行為。

僱員不得接受，亦不可要求商業夥伴、供應商及商人給予任何不當的利益，包括宴會、禮品、證券、貴重物品及高消費娛樂活動等。若發生任何涉嫌違反法律、法規、行為守則或本集團政策的事件，本集團會進行深入調查。若查明屬實，將會對違例者採取紀律處分。本集團亦不時向董事及僱員提供培訓以確保彼等遵守及熟悉本集團的反欺詐及反貪腐政策。



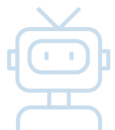

Internal control

Risk management and internal control

The Board emphasises on the importance of risk management and internal controls on the Group's business operations (including environmental, social and governance ("ESG")) and development and acknowledges its overall responsibility for the risk management and internal control systems and the review of their effectiveness.

The Board evaluates and determines the nature and extent of risks it is willing to accept, while achieving the Group's strategic business objectives. The Board also ensures implementation and maintenance of effective risk management and internal control systems; and oversees management in the design, implementation and monitoring of the risk management and internal control systems.

The Board has delegated the responsibility to physically implement and maintain the risk management and internal control systems to the management of the Company. The management, under the supervision of the Board, has implemented and maintained appropriate and effective risk management and internal control system, which aims to manage and reduce (i) risks associated with the Group's daily operations (including ESG); (ii) risks of failing to achieve business objectives; (iii) risks of asset misappropriation; and (iv) risks of making potential material misstatements or losses. However, the risk management and internal control system can only provide reasonable and not absolute assurance against material misstatements or losses.

The Group does not have an internal audit function. Taking into account the size, nature and complexity of the Group's business, the Board have sufficient capacity to oversee the design and implementation of the risk management and internal control system and to assess its effectiveness, and accordingly there is no immediate need to set up an internal audit function within the Group.

Response to findings of risk assessment

- Prioritise the risks by comparing the results of the risk assessment; and

Company secretary

Ms. Jian Xuegen (“**Ms. Jian**”) was appointed as the company secretary of the Company on 21 September 2019 and is responsible for overseeing all the company secretarial matters of the Group. In the opinion of the Board, Ms. Jian possesses the necessary qualification and experience, and is capable of performing the functions of a company secretary. During the year ended 31 December 2022, Ms. Jian confirmed that she has taken no less than 15 hours of relevant professional training as required under Rule 3.29 of the Listing Rules.

Shareholders' rights

The general meetings of the Company provide an opportunity for communication between the shareholders and the Board. An AGM of the Company shall be held in each year and at the place as may be determined by the Board. Each general meeting, other than an AGM, shall be called an extraordinary general meeting.

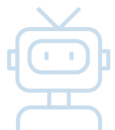

Shareholders to convene an extraordinary general meeting

Pursuant to article 64 of the Articles, extraordinary general meeting shall be convened on the requisition of one or more shareholders of the Company holding, at the date of deposit of the requisition, not less than one-tenth of the paid-up capital of the Company having the right of voting at general meetings. Such requisition shall be made in writing to the Board or the company secretary of the Company for the purpose of requiring an extraordinary general meeting to be called by the Board for the transaction of any business specified in such requisition. Such meeting shall be held within two months after the deposit of such requisition. If within 21 days of such deposit, the Board fails to proceed to convene such meeting, the requisitionist(s) himself (themselves) may do so in the same manner, and all reasonable expenses incurred by the requisitionist(s) as a result of the failure of the Board shall be reimbursed to the requisitionist(s) by the Company.



Putting enquiries by shareholders to the Board

Shareholders may send written enquiries to the Company for the attention of the company secretary at the Company's principal place of business in Hong Kong.

Procedures for putting forward proposals by shareholders at shareholders' meetings

Shareholders of the Company are requested to follow article 64 of the Articles for including a resolution at an extraordinary general meeting. The requirements and procedures are set out above in the paragraph headed "Shareholders to convene an extraordinary general meeting".

Pursuant to article 114 of the Articles, no person (other than a retiring Director) shall, unless recommended by the Board for election, be eligible for election to the office of Director at any general meeting, unless notice in writing of the intention to propose that person for election as a Director and notice in writing by that person of his willingness to be elected shall have been lodged at the head office of the Company or at the Hong Kong branch share registrar and transfer office of the Company. The period for lodgement of the notices required under this Article will commence no earlier than the day after the despatch of the notice of the general meeting appointed for such election and end no later than seven days prior to the date of such general meeting and the minimum length of the period during which such notices to the Company may be given will be at least seven days.

About the Report

Sprocomm Intelligence Limited (the “**Company**”) and its subsidiaries (collectively the “**Group**”) presents the Environmental, Social and Governance (“**ESG**”) report, which contains information on the Group’s business activities, ESG governance, strategies, performances and ongoing commitment towards sustainable development. This ESG report is intended to enhance the confidence and understanding of the stakeholders towards the Group.



About the Group

The Group is an ODM mobile phone supplier based in the PRC, primarily engaged in research and development, designing, manufacturing and sale of mobile phones, PCBAs for mobile phones and IoT related products, targeting emerging markets. The Group operates two production bases in the PRC, including one in Shenzhen that is responsible for the mobile phone assembly and the other one in Luzhou that is equipped with SMT lines for the production of PCBAs.



Reporting Period

This ESG report highlights the ESG performance of the Group from 1 January 2022 to 31 December 2022.

Reporting Standard

This ESG report was prepared with reference to the Environmental, Social and Governance Reporting Guide (the “**ESG Reporting Guide**”) as described in Appendix 27 of the Listing Rules and Guidance set out by the Stock Exchange. An assessment on the applicability and materiality of the relevant key performance indicators under the ESG Reporting Guide had been conducted.

Reporting Principles

報告準則

Reporting Scope

Based on the principle of materiality, the scope of this ESG report concentrates on the Group's business in the PRC, where the Group carries out its principal business operations and most of its employees and assets are located. All the PRC entities of the Group were included in the assessment of ESG performance for the purpose of this ESG report. The Group's operations outside the PRC were not included in the scope as they do not have significant environmental and social impacts.

ESG Governance

The Group views ESG commitments as part of its responsibilities and are committed to incorporating ESG considerations into its decision-making process. To achieve this goal, the Group has developed a framework to ensure ESG governance is aligned with its strategic growth, while advocating for the integration of ESG into its business operations. The structure of ESG governance mainly comprised of two components, namely the Board and the management team.

The Board holds the overall responsibility for the Group's ESG strategy and reporting by overseeing the overall governance and progress of the Group's ESG management system, policies, commitments, strategies and objectives.

A. Environment

The Group acknowledges its responsibility to protect the environment and it has implemented policies to reduce emissions and improve the efficiency in the use of resources.

The Group's business operations are subject to certain environmental requirements pursuant to the laws in the PRC such as Environmental Protection Law of the PRC (《中華人民共和國環境保護法》), Evaluation of Environmental Effects Law of the PRC (《中華人民共和國環境影響評價法》), Prevention and Control of Water Pollution Law of the PRC (《中華人民共和國水污染防治法》), Prevention and Control of Atmospheric Pollution Law of the PRC (《中華人民共和國大氣污染防治法》), Prevention and Control of Environmental Noise Pollution Law of the PRC (《中華人民共和國環境噪聲污染防治法》), Prevention and Control of Solid Waste Pollution Law of the PRC (《中華人民共和國固體廢物污染環境防治法》), and Regulations on the Administration of Construction Project Environmental Protection (《建設項目環境保護管理條例》), and Promotion of Cleaner Production Law of the PRC (《中華人民共和國清潔生產促進法》).

During the year ended 31 December 2022, the Group complied with all applicable PRC environmental laws and regulations in all material respects and had not been subject to any material penalty in relation to environmental protection.

A. 環境

A.1 Emissions

During the Group's production process, there are certain wastage generated (sources of emissions) including solid waste, water, noise and polluted air. The Group has in place standard procedures to manage, treat and reduce the pollution and wastage in accordance with national and local requirements. The Group also has in place facilities for air filtration to ensure that the level of wastage or pollutants generated during its production process is within statutory limits. In addition, the Group has engaged a professional waste disposal service company for the disposal of hazardous wastes. To ensure compliance with the latest environmental laws and regulations, the Group has internal compliance manuals setting out its goals and policies in relation to environmental matters. The Group has been accredited with the ISO 14001 certification of environmental management system.

(i) Air pollutant emissions

During the year ended 31 December 2022, air pollutant emissions were mainly related to petrol consumption for the use of the Group's self-owned vehicles, which contributed to the emission of 10.71 kg (2021: 9.92 kg) of nitrogen oxides (NOx), 0.19 kg (2021: 0.17 kg) of sulphur oxides (SOx) and 0.79 kg (2021: 0.73 kg) of respiratory suspended particles (PM).

Air pollutant emissions reduction target

To better manage the Group's ESG performance, the Group decides to set quantifiable targets for air pollutant emissions as follows:

A.1 排放

(i) 空氣污染物排放

截至二零二二年十二月三十一日止年度，空氣污染物排放主要與本集團使用自有汽車而消耗汽油有關，包括10.71千克氮氧化物(NOx)（二零二一年：9.92千克）、0.19千克硫氧化物(SOx)（二零二一年：0.17千克）及0.79千克可吸入懸浮粒子(PM)（二零二一年：0.73千克）。

During the year ended 31 December 2022, the Group's activities contributed to 6,182.38 tonnes (2021: 6,741.48 tonnes) or 0.1 tCO₂/m₂ (2021: 0.1 tCO₂/m₂) of carbon dioxide equivalent (carbon dioxide, methane, nitrous oxide and hydrofluorocarbons) emission. The decrease in carbon dioxide equivalent emission for the year ended 31 December 2022 was primarily attributed to the successful implementation of the Group's measures to reduce the consumption of resources, in particular electricity. Details of the Group's measures to reduce the consumption of resources and the related emissions are set out below. Same as the previous two years, the Group did not receive any complaints or warnings on greenhouse gas emissions during the year ended 31 December 2022.

Greenhouse gas emissions reduction target

To better manage the Group's ESG performance, the Group decides to set quantifiable targets for greenhouse gas emissions as follows:

Petrol consumption

During the year ended 31 December 2022, the Group's motor vehicles travelled 143,334 km (2021: 132,749 km), which consumed 12,936 litres (2021: 11,663 litres) of petrol (14.53 litres (2021: 11.73 litres) of petrol per employee) and contributed to 30.53 tonnes (2021: 27.52 tonnes) of carbon dioxide equivalent emissions. To reduce the emissions arising from petrol consumption, the Group encourages its employees to use public transport when they attend business activities. For business activities that take place within walking distance, the Group encourages its employees to walk or cycle to the destination.

Refrigerant consumption

During the year ended 31 December 2022, the Group consumed 45 kg (2021: 50 kg) of refrigerant (0.05 kg (2021: 0.05 kg) per employee) in connection with the use of air conditioning during its daily production and office operations, which contributed to 81.45 tonnes (2021: 90.50 tonnes) of carbon dioxide equivalent emissions. To reduce the emissions arising from refrigerant consumption, the Group encourages its employees to switch off the air conditioning when they leave the office and production premises.

Electricity consumption

During the year ended 31 December 2022, the Group consumed 6,516,763 kWh (2021: 7,130,284 kWh) of electricity (8,012 kWh (2021: 7,173 kWh) per employee) in connection with its daily production and office operations, which contributed to 5,865.09 tonnes (2021: 6,417.26 tonnes) of carbon dioxide equivalent emissions. To reduce the emissions arising from electricity consumption, the Group encourages its employees to switch off the lights and other electricity appliances when they leave the office and production premises.

汽油消耗

截至二零二二年十二月三十一日止年度，本集團汽車行駛143,334公里（二零二一年：132,749公里），消耗12,936升汽油（二零二一年：11,663升汽油）（每名僱員消耗14.53升汽油（二零二一年：11.73升汽油）及排放30.53噸（二零二一年：27.52噸）二氧化碳當量。為減少汽油消耗產生的排放，本集團鼓勵僱員使用公共交通工具前往業務活動。就步行距離之內的業務活動而言，本集團鼓勵員工步行或騎單車前往目的地。

製冷劑消耗

截至二零二二年十二月三十一日止年度，本集團在日常生產及辦公室運營過程中因使用空調消耗45千克（二零二一年：50千克）製冷劑（每名僱員0.05千克（二零二一年：0.05千克）），導致81.45噸（二零二一年：90.50噸）二氧化碳當量排放。為減少因消耗製冷劑而產生的排放，本集團鼓勵僱員離開辦公室及生產場所時關閉空調。

電力消耗

截至二零二二年十二月三十一日止年度，本集團在日常生產和辦公中消耗6,516,763千瓦時（二零二一年：7,130,284千瓦時）電力（每名僱員8,012千瓦時（二零二一年：7,173千瓦時）），排放5,865.09噸（二零二一年：6,417.26噸）二氧化碳當量。為減少用電產生的排放，本集團鼓勵僱員在離開辦公室和生產場所時關掉電燈和其他電器。

Paper consumption

During the year ended 31 December 2022, the Group consumed 1.3 tonnes (2021: 1.3 tonnes) of paper (0.001 tonnes (2021: 0.001 tonnes) per employee) in connection with its daily business operations, which contributed to 0.01 tonnes (2021: 0.01 tonnes) of carbon dioxide equivalent emissions. To reduce the emissions arising from paper usage, the Group encourages its employees to conserve paper, review documents on computers, send messages to customers via emails, use recycled paper and adopt double-sided printing.

Water consumption

During the year ended 31 December 2022, the Group consumed 28,101 cubic metres (2021: 32,820 cubic metres) of water (31.6 cubic metres (2021: 33.0 cubic metres) per employee) in connection with its daily business operations, which contributed to 28.10 tonnes (2021: 32.82 tonnes) of carbon dioxide equivalent emissions. To reduce the emissions arising from water usage, the Group encourages its employees to conserve water and remember to turn off the water tap after use. As a result, the employees have increased their awareness to reduce water consumption. During the year ended 31 December 2022, the Group did not encounter any problems in sourcing water that is fit for purpose. Further, the Group did not consume a significant amount of water that was and disproportional to the scale of its business operations.

Business air travel

The Group's business nature requires employees to travel by air to other countries for meetings with customers and suppliers. They would only travel by air when necessary and the Group keeps track of their business air travels. During the year ended 31 December 2022, business air travels of the Group's employees had contributed a total of 177.16 tonnes (2021: 173.37 tonnes) of carbon dioxide equivalent emission.

用紙

截至二零二二年十二月三十一日止年度，本集團因日常業務而使用1.3噸（二零二一年：1.3噸）紙張（每名僱員0.001噸（二零二一年：0.001噸）），產生0.01噸（二零二一年：0.01噸）二氧化碳當量排放。為減少紙張使用產生的排放，本集團鼓勵員工節約紙張，用電腦審閱文檔，通過電子郵件向客戶發送消息，使用再生紙並採用雙面打印。

用水

截至二零二二年十二月三十一日止年度，本集團日常業務消耗28,101立方米（二零二一年：32,820立方米）水（每名僱員31.6立方米（二零二一年：33.0立方米）），排放28.10噸（二零二一年：32.82噸）二氧化碳當量。為減少用水引起的排放，本集團鼓勵僱員節約用水和用後關水。因此，僱員的節水意識得以提高。截至二零二二年十二月三十一日止年度，本集團在獲取適用水源上並無遭遇任何困難。此外，本集團的用水量與其業務運營規模相符。

商務飛行

本集團的業務性質要求僱員乘飛機前往其他國家與客戶和供應商會面。彼等僅在必要時乘飛機旅行，旅程由本集團記錄。截至二零二二年十二月三十一日止年度，本集團僱員商務飛行合共排放177.16噸（二零二一年：173.37噸）二氧化碳當量。

(iii) Hazardous waste

During the year ended 31 December 2022, the Group generated minimal amount of hazardous waste. The major hazardous waste generated by the Group was waste light tube. To minimise the impact on environment, the Group has engaged a professional waste disposal service company for the disposal of hazardous wastes. The Group will strive to reduce generation of hazardous waste through upgrading technologies whenever possible. Same as the previous two years, the Group did not receive any complaints or warnings on disposal of its hazardous waste during the year ended 31 December 2022, and targets to achieve the same performance in 2023.

(iv) Non-hazardous waste

During the year ended 31 December 2022, the Group generated a total of 1,450 tonnes (2021: 1,550 tonnes) of non-hazardous waste (1.63 tonnes (2021: 1.56 tonnes) per employee). The non-hazardous waste generated by the Group were packaging materials generated from the Group's production process. The Group regularly reminds its employees to use resources efficiently and try to avoid the generation of waste. As a result, the employees' awareness of waste management has been increased. Same as the previous two years, the Group did not receive any complaints or warnings on disposal of its non-hazardous waste during the year ended 31 December 2022, and targets to achieve the same performance in 2023.

(iii) 有害廢物

截至二零二二年十二月三十一日止年度，本集團產生微量有害廢物。本集團產生的主要有害廢物為廢光管。為盡量減少對環境的影響，本集團已聘請專業廢物處理服務公司處理有害廢物。本集團將盡力通過升級技術減少產生有害廢物。與過去兩年一樣，本集團截至二零二二年十二月三十一日止年度並無接獲任何有害廢物的投訴或警告，並目標於二零二三年達致同樣表現。

(iv) 無害廢物

截至二零二二年十二月三十一日止年度，本集團合共產生1,450噸（二零二一年：1,550噸）無害廢物（每名僱員1.63噸（二零二一年：1.56噸））。本集團產生的主要無害廢物為本集團在生產過程中產生的包裝材料。本集團定期提醒僱員有效利用資源，盡量避免浪費，提高了僱員對廢物管理的認識。與過去兩年一樣，本集團截至二零二二年十二月三十一日止年度並無接獲任何處理無害廢物的投訴或警告，並目標於二零二三年達致同樣表現。

A.2 Use of resources

Reducing consumption of resources and enhancing utilisation efficiency are the Group's principles in minimising adverse impact on the environment and natural resources that may be caused by its business operations. The Group has adopted a set of guidelines to achieve efficient use of energy, water and other resources for long-term sustainability.

The Group's total consumption of resources during the year ended 31 December 2022 together with the relevant conservation measures adopted by the Group are detailed in the section headed "A.1 Emissions" above.

A.3 The environment and natural resources

During the year ended 31 December 2022, the Group's business activities did not cause significant adverse impact on the environment and natural resources.

To further improve the use of resources, the Group takes the following actions on an ongoing basis:

- keep track of its consumption level of resources;
- review the effectiveness of its conservation measures; and
- design improvement measures

As a result, the Group's employees are more aware of the importance of using resources efficiently.

A.2 資源使用

A.4 Climate change

The Group manages the climate change risk with reference to the Recommendations of the Task Force on Climate-related Financial Disclosures (TCFD), which contains four major components: Governance, Strategy, Risk Management and Metrics and Targets. The Board oversees the governance and reporting of the Group's climate change risk.

Management of the Group regularly monitors and identifies climate change risk that is relevant to the Group's business operations. Strategies will be implemented on a timely manner to mitigate such risk.

Climate change is mainly caused by the release of carbon dioxide into the atmosphere, resulting from the use of fossil fuels for electricity generation and for transportation. As mentioned above, the Group has implemented appropriate strategies to use resources more efficiently and reduce emissions to combat climate change and reduce potential costs in the future.

During the year ended 31 December 2022, the Group identified the following climate-related risks that may have material impacts on the Group's business operations:

Physical risks

The increased frequency and severity of extreme weather such as typhoons, storms and heavy rains can disrupt the Group's operations by damaging the power grid, and communication infrastructures, and injuring its employees during their work, leading to reduced capacity and decreased in productivity, or expose the Group to risks associated with non-performance and delayed performance. To minimise the potential risks and hazards, the Group has flexible working arrangements and precautionary measures during bad or extreme weather conditions.

A.4 氣候變化

本集團在管理氣候變化風險時參考氣候相關財務披露工作組(TCFD)的建議，其中包含四個主要部分：治理、策略、風險管理及指標和目標。董事會監控本集團的氣候變化風險治理及報告。

本集團管理層定期注視及識別與本集團業務經營有關的氣候變化風險。本公司將及時實施策略以降低有關風險。

氣候變化主要是由於使用化石燃料發電和運輸，而向大氣層釋放二氧化碳所致。如上文所述，本集團已實施適當的策略，以更有效地利用資源和減少排放，以應對氣候變化並降低未來的潛在成本。

截至二零二二年十二月三十一日止年度，本集團已識別以下可能對本集團的業務營運產生重大影響的氣候相關風險：

實體風險

極端天氣事件的頻率及嚴重程度的增加，如颱風、風暴、暴雨，可能會對電網及通信基礎設施造成破壞，從而擾亂本集團的營運，及傷害員工，導致產能減少和生產力下降，或使本集團面臨與不履約和延遲履約相關的風險。為將潛在風險和危害降至最低，本集團在惡劣或極端天氣條件下設有靈活的工作安排和預防措施。

Transition risks

The Group anticipates that there will be more stringent climate legislations and regulations to support the global vision of carbon neutrality. We acknowledge the requirements to enhance the climate-related information disclosures as a result of the recent update of the ESG Reporting Guide in respect to significant climate-related impact disclosures of an issuer. Stricter environmental laws and regulations may expose enterprises to higher risks of claims and lawsuits. Corporate reputation may also be adversely affected by the failure to meet the compliance requirements for climate change. The Group's related capital investment and compliance costs may increase. In response to the policy and legal risks as well as the reputation risks, the Group regularly monitors existing and emerging trends, policies and regulations relevant to climate and be prepared to alert the Board where necessary to avoid cost increments, penalties for non-compliance and/or reputational risks due to delayed response.

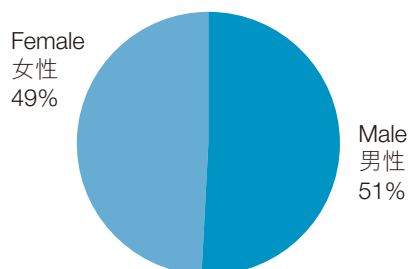

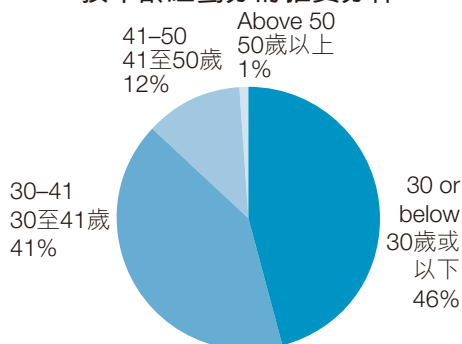

Employee benefits and welfare

The Group enters into employment contracts with its employees and the employment contract terms were stipulated under the principles of fairness, voluntarism, mutual consent, integrity and credibility. The remuneration package offered to employees includes salary, bonuses and other subsidies. In general, the remuneration package is based on each employee's qualifications, position, seniority and work performance. The Group carries out an annual review system to assess the performance of its employees, which forms the basis of decisions with respect to salary raises, bonuses and promotions.

During the year ended 31 December 2022, the Group maintains social insurance for its employees pursuant to the applicable PRC laws and regulations by making contributions to the mandatory social insurance and housing provident funds which provide basic retirement, medical, work-related injury, maternity and unemployment benefits.

During the year ended 31 December 2022, the Group complies with the Labour Law of the PRC and did not experience any significant disputes with its employees or any disruption to business operations due to labour disputes. In addition, the Group did not experience any difficulties in the recruitment and retention of experienced core staff or skilled personnel.

Labour standards

During the year ended 31 December 2022, there was no child labour nor forced labour working in the Group. The job application requirement specifies that job applicants must be at least 18 years old. To ensure that job applicants can meet the age requirement, identities of job applicants are verified against their valid identity documents, relevant permits and certificates.

The human resources department is required to carry out background checks to authenticate information provided by job applicants and is required to fill in forms that confirm hired employees have met the age requirement. If child labour or forced labour is discovered, such matter will be reported to the human resources department and the senior management and the Group will enhance the internal controls immediately. No material non-compliance in relation to laws and regulations regarding prevention of child and forced labour was recorded during the year ended 31 December 2022.

Equal opportunity

The Group provides equal opportunities for employees in respect of recruitment, job advancement, training and development, etc. Employees are not discriminated against or deprived of such opportunities on the basis of race, nationality, religion, physical condition, disability, gender, pregnancy, sexual orientation, political status, age and any other discrimination prohibited by applicable law. Employees shall not act in discriminatory manner or they can be subject to disciplinary actions.

(ii) Employee relations

The Directors consider that it is important to maintain good relationship with employees. The Group maintains regular communications with its employees by arranging gatherings, celebration activities and trainings. Through these activities, the Group would collect feedback from its employees on job satisfactions and their expectations on the Group and would implement appropriate strategies to improve the work environment and its relationship with the employees.

(iii) Employee health and safety

The Group places emphasis on occupational health and work safety. It provides a safe working environment and training sessions for its employees to ensure that they can work safely. It has also implemented a system of recording and handling accidents. Further, the Group also has dedicated personnel responsible for administering the internal worker safety policies, providing relevant training and education, and conducting regular inspections. During the year ended 31 December 2022, the Group had not experienced any material safety accidents or been penalised for any non-compliance relating to work safety laws and regulations.

B.2 Operating practices

(i) Supply chain management

The Group purchases raw materials and equipment based on its own needs, specifications, quality and safety performance of equipment, reputation, after-sales service and delivery time of the supplier. The Group compares different suppliers to select qualified suppliers (based on their product specifications, product compliances, production management, quality management and also ESG performances) before the Group enters into contract with the qualified suppliers.

When selecting equipment, the Group would also consider whether they are energy efficient and environmental friendly. During the year ended 31 December 2022, the Group principally sourced its major raw materials (including PCBAs, display modules, camera modules and mobile chips) and equipment from PRC suppliers.

B.2 經營常規

The Group expects its suppliers to uphold the environmental, social and governance principles that the Group has adopted into the management of its business operations. In order to ensure that the components and raw materials meet the requisite safety and quality standards, the Group adopts stringent criteria in supplier selection (including but not limited to whether they provide high quality raw materials, whether they maintain a high standard on environmental protection and comply with relevant laws on environmental issues, whether price is comparable to market rate and location of their factories) and continuously monitors existing suppliers on an annual basis, based on criteria such as product quality, product defect ratio, delivery punctuality ratio and responsiveness.

(ii) Product responsibility

Product assurance and recall

Product quality is crucial to the Group's continued success. The Group places strong emphasis on achieving a consistently high quality for its products. To achieve such purpose, stringent quality control measures throughout the production process were implemented to ensure the quality and safety of our products. The Group's quality control department performs regular inspections to evaluate the effectiveness of the quality control measures and further enhance these measures when necessary.

The Group's quality management system has complied with the standard of GB/T19001-2016/ISO9001:2015 Quality Management Systems Requirements and awarded a certificate for the design, development, production and services of communication products, including exportable mobile phone, on 18 January 2019, which remains valid until 16 January 2025. During the year ended 31 December 2022, the Group did not experience any claims, litigations and arbitrations or material adverse findings in inspection by government authorities with respect to product quality.

The Group only accepts product returns if there is manufacture or design defect or the product specification deviates from customers' specifications. During the year ended 31 December 2022, the Group did not experience any product recall, material non-compliance with laws and regulations in relation to product safety nor receive any material complaints from consumers.

(ii) 產品責任

產品質量對本集團取得持續成功至關重要。本集團極之注重維持產品的一貫優質表現。為達致此目的，本集團對全生產過程實施嚴格的質控措施，以確保我們產品的質量及安全。本集團的質控部門會定期檢查，以評估質控措施的成效和在必要時進一步強化該等措施。

Intellectual property rights and information security

As a mobile phone supplier with strong design capability, the Group registers patents to safeguard the technologies and mobile phone applications developed by the research and development department time to time. The Group relies on the relevant laws and regulations to protect its brand names, trademarks and other intellectual property rights.

During the year ended 31 December 2022, the Group was not aware of any material infringement (i) by the Group of any intellectual property rights owned by any third parties; or (ii) by any third party of any intellectual property rights owned by the Group. Further, there were no pending or threatened material claims made against the Group, nor had there been any material claims made by the Group against third parties, with respect to the infringement of intellectual property rights owned by the Group.

(iii) Anti-fraud and anti-corruption

According to the Group's anti-corruption policy, all employees shall abide by the laws and regulations of the PRC and shall not engage in any illegal activities. Employees shall uphold the code of ethics, advocate fair competition and act against bribery. Any bribery, fraud, money laundering and embezzlement are prohibited.

Employees must not accept or request any improper benefits including banquets, gifts, securities, valuables and high-expenditure entertainment activities from business partners, suppliers and merchants, etc. When there is any alleged case in violation of laws, regulations, code of conduct or Group's policies, the Group will investigate and impose disciplinary actions upon offenders after verification. The Group also provides trainings to directors and employees from time to time to ensure that they comply and familiar with the anti-fraud and anti-corruption policy of the Group.

知識產權及信息安全

The Board will monitor and review the effectiveness of the anti-fraud and anti-corruption policy from time to time.

During the year ended 31 December 2022, the Group complied with all applicable laws on prohibiting corruption and bribery of the PRC and there was no concluded legal case regarding corrupt practices brought against the Group or its employees.

Whistleblowing policy

The Group has implemented whistleblowing policy to provide a well-defined and accessible channel for reporting fraud, corruption, dishonest practices, or other similar matters and guidance on how an investigation would be initiated upon receiving a complaint. The policy also protects employees who report fraudulent activities in good faith and reasonable belief. A whistleblowing officer is elected to ensure that any reported case is dealt with in an expedited manner.

Upon receiving the complaint, the Board decides the method of investigation, which may involve appointing an external consultant for assessment. The Board will monitor and review the effectiveness of the whistleblowing policy from time to time.

DIRECTORS' REPORT

The directors present to the shareholders the annual report and the audited consolidated financial statements for the year ended 31 December 2022.

Principal activities

The Group is an ODM mobile phone supplier based in the PRC, primarily engaged in research and development, designing, manufacturing and sale of mobile phones, PCBAs for mobile phones and IoT related products, targeting emerging markets. Particulars of the Company's principal subsidiaries are set out in note 39 to the consolidated financial statements.

Business review

The business review of the Group for the year ended 31 December 2022 is set out in the sections headed "Chairman's Statement", "Management and Discussion and Analysis", "Corporate Governance Report", "Environmental, Social and Governance Report" and "Financial Summary" of this annual report.

Principal risk factors and uncertainties

The following sets out the principal risks and uncertainties encountered by the Group in its business operations:

Rapid technological changes

The Group operates in the mobile phone industry characterised by rapid technological changes with short product life cycle, and the Group may not be able to maintain its revenue growth and any delay by us in rolling out new and competitive mobile phones will adversely affect its financial performance.

Thin net profit margin

The Group has a relatively thin net profit margin and hence are highly sensitive to any unfavorable change in the cost of sales, selling price and sales volume.

Concentration of customers

The Group has a concentration of customers and any decrease or loss of business from these major customers could adversely and substantially affect its business operations and financial conditions.

本集團的純利率相對稀薄，因此對銷售成本、銷售價格及銷售量的任何不利變化都非常敏感。

客戶集中

本集團存在客戶集中的情況及來自該等主要客戶的業務減少或流失可能對我們的業務經營及財務狀況產生重大不利影響。



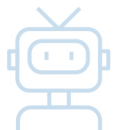

Fluctuations in the prices of raw materials

Fluctuations in the prices of raw materials may affect the Group's cost of sales and adversely affect its business operations and profitability.



Future prospect and development

The Group's business growth is expected to be driven by (i) the huge population and the increasing disposable income of the Group's target sales locations; (ii) increasing demand for IoT products; and (iii) the roll-out of 5G telecommunication network. In order to capture the potential market opportunities, the Group will continue to expand its production capacity, enhance its research and development capability, enrich its product portfolio and increase its sales and marketing effort to diversify its geographical locations.



Major suppliers and customers

During the year ended 31 December 2022, sales to the Group's largest customer and five largest customers accounted for 20.8% and 47.3% (2021: 23.6% and 54.3%) of the total revenue, respectively.

On the other hand, purchases from the Group's largest supplier and the five largest suppliers during the year ended 31 December 2022 accounted for approximately 11.9% and 38.0% (2021: 10.0% and 23.7%) of the total purchases, respectively.

None of the Directors of the Company or any of their close associates or any shareholders (which, to the best knowledge of the Directors, own more than 5% of the Company's issued share capital) had any beneficial interest in the Group's five largest customers or suppliers for the year ended 31 December 2022.

Key relationships with employees, customers and suppliers

Maintaining good relationships with employees, customers and suppliers is critical to the Group's business success. The Group creates a decent working environment for its employees, where they can work comfortably and achieve a work life balance. The Group rewards its employees based on their performance and also provides training to enhance their skills and knowledge. No strikes and cases of fatality due to workplace accidents are found in the reporting period under review.

原材料價格波動

另一方面，截至二零二二年十二月三十一日止年度，本集團最大供應商及五大供應商的採購額分別佔總採購額的約11.9%及38.0%（二零二一年：10.0%及23.7%）。

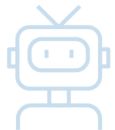

The purpose of which is to motivate the eligible participants to optimise their future contributions to the Group and/or to reward them for their past contributions, to attract and retain or otherwise maintain on-going relationships with such participants who are significant to and/or whose contributions are or will be beneficial to the performance, growth or success of the Group.

The eligible participants include any full-time or part-time employees, executives or officers, directors, advisers, consultants, suppliers, customers and agents of the Company or any of its subsidiaries; and such other persons who, in the sole opinion of the Board, will contribute or have contributed to the Group.

Subject to the terms and conditions of the Share Option Scheme, the maximum numbers of shares in respect of which options may be granted under the Share Option Scheme and any other schemes shall not, in aggregate, exceed 10% of the Company's shares in issue as at 13 November 2019 (i.e. 100,000,000 shares) unless approved by the shareholders of the Company. Such limit also represented 10% of the of the total issued shares of the Company as at the date of this annual report.

Unless approved by shareholders of the Company in general meeting in the manner stipulated in the Listing Rules, the maximum entitlement for each eligible participant (including both exercised and outstanding options) under the Share Option Scheme or any other share option schemes of the Company in any 12-month period up to the date of grant shall not exceed 1% of the total number of shares in issue.

The key audit matter 關鍵審計事項

As at 31 December 2022, the carrying amount of trade and bills receivables amounted to RMB191,704,000, representing 14% of the Group's total current assets.

ECL for trade and bills receivables is estimated based on lifetime ECL model, which is estimated based on historical credit loss experience and forward-looking information at the end of the reporting period.

We have identified impairment of trade and bills receivables as a key audit matter because the impairment assessment of trade and bills receivables involved a significant degree of management estimation and may be subject to management bias.

How the matter was addressed in our audit 吾等於審計中如何處理相關事項

Our procedures were designed to review the management's judgement and estimates used in assessment process and challenge the reasonableness of inputs and assumptions used in estimating the ECL of trade and bills receivables.

We obtained an understanding of how the ECL of trade and bills receivables were assessed by the management.

We have challenged management's assumption and judgement in determining ECL on trade and bills receivables as at 31 December 2022, the reasonableness of management's grouping of the trade debtors in the provision matrix, and the basis of ECL rates applied, adjusted for forward looking information including both current and forecast general economic conditions.

We have tested, on sample basis, payment history, past due status of the trade and bills receivables, and the settlements subsequent to the end of the reporting period.

We have tested the accuracy of the historical default data and tested trade receivables past due ageing analysis as at 31 December 2022, on a sample basis, by comparing individual items in the analysis with the relevant supporting documents.

We identified the valuation of inventories as a key audit matter due to the use of judgements in identifying obsolete and slow moving inventories and determining the net realisable value which are based on conditions and the marketability of the inventories.

We have assessed the net realisable value and subsequent sales of inventories on a sample basis and inspected the utilisation report and sales contracts entered into between the Group and its customers on a sample basis.

We have discussed with the management in respect of the adequacy of the allowance made by the management based on subsequent usage and sales, ageing analysis and current market conditions.

We have challenged the assumptions and judgements used by the management by assessing the reliability of the management's past estimates.

1. GENERAL

Sprocomm Intelligence Limited (the “**Company**”) was incorporated in the Cayman Islands under the Companies Law, Chapter 22 (Law 3 of 1961, as combined and revised) of the Cayman Islands as an exempted company with limited liability on 15 August 2018 and its shares have been listed on Main Board of The Stock Exchange of Hong Kong Limited (the “**Stock Exchange**”) since 13 November 2019 (the “**Listing**”). The ultimate controlling parties are Mr. Li Chengjun and Mr. Xiong Bin (the “**Controlling Shareholders**”), who are also executive directors of the Company.

The address of the registered office is located in P.O. BOX 31119, Grand Pavilion, Hibiscus Way, 802 West Bay Road, Grand Cayman, KY1-1205, Cayman Islands and the principal place of business of the Company is located in 5D-506, F1.6 Block, Tianfa Building, Tianan Chegongmiao Industrial Park, Futian District, Shenzhen, China.

The Company is an investment holding company. The principal activities of its subsidiaries are designing, manufacturing and sales of mobile phones and printed circuit board assembly (“**PCBA**”) and Internet of things (“**IoT**”) related products and investment holding. Particulars of the subsidiaries have been set out in Note 39, the company and its subsidiaries are collectively referred to as the “**Group**”.

The consolidated financial statements have been prepared in accordance with Hong Kong Financial Reporting Standards (“**HKFRSs**”) (which include all Hong Kong Financial Reporting Standards, Hong Kong Accounting Standards (“**HKASs**”) and interpretations) issued by the Hong Kong Institute of Certified Public Accountants (“**HKICPA**”), accounting principles generally accepted in Hong Kong and the disclosures required by the Rules Governing the Listing of Securities on the Main Board of the Stock Exchange and by the Hong Kong Companies Ordinance.

The consolidated financial statements have been prepared on the historical cost basis. Historical cost is generally based on the fair value of the consideration given in exchange for goods and services.

The consolidated financial statements are presented in RMB which is also the functional currency of the Company, and all values are rounded to the nearest thousands, except when otherwise indicated.

Basis of consolidation

The consolidated financial statements incorporate the financial statements of the Company and entities controlled by the Company and its subsidiaries.

Control is achieved where the Group has: (i) the power over the investee; (ii) exposure, or rights, to variable returns from its involvement with the investee; and (iii) the ability to use its power over the investee to affect the amount of the Group's returns.

The Group reassesses whether or not it controls an investee if facts and circumstances indicate that there are changes to one or more of the three elements of control listed above.

Consolidation of a subsidiary begins when the Group obtains control over the subsidiary and ceases when the Group loses control of the subsidiary.

All intra-group assets and liabilities, equity, income, expenses and cash flows relating to transactions between entities of the Group are eliminated in full on consolidation.

Where necessary, adjustments are made to the financial statements of subsidiaries in preparing the consolidated financial statements to bring their accounting policies in line with the Group's accounting policies.

Changes in the Group's ownership interests in existing subsidiaries

Changes in the Group's ownership interests in existing subsidiaries that do not result in the Group losing control over the subsidiaries are accounted for as equity transactions. The carrying amounts of the Group's interests and the non-controlling interests are adjusted to reflect the changes in their relative interests in the subsidiaries. Any difference between the amount by which the non-controlling interests are adjusted and the fair value of the consideration paid or received is recognised directly in equity and attributed to owners of the Company.

Revenue recognition

Revenue is recognised to depict the transfer of promised goods and services to customers at an amount that reflects the consideration to which an entity expects to be entitled in exchange for those goods or services to a customer. Specifically, the Group uses a five-step approach to recognise revenue:

- Step 1: Identify the contract(s) with a customer
- Step 2: Identify the performance obligations in the contract
- Step 3: Determine the transaction price
- Step 4: Allocate the transaction price to the performance obligations in the contract
- Step 5: Recognise revenue when (or as) the Group satisfies a performance obligation.

The Group recognises revenue when (or as) a performance obligation is satisfied, i.e. when "control" of the goods or services underlying the particular performance obligations is transferred to customer.

A performance obligation represents a good (or a bundle of goods) that is distinct or a series of distinct goods that are substantially the same.

Control is transferred over time and revenue is recognised over time by reference to the progress towards complete satisfaction of the relevant performance obligation if one of the following criteria is met:

- The customer simultaneously receives and consumes the benefits provided by the Group's performance as the Group performs;
- The Group's performance creates or enhances an asset that the customer controls as the asset is created or enhanced; or
- The Group's performance does not create an asset with an alternative use to the Group and the Group has an enforceable right to payment for performance completed to date.

Otherwise, revenue is recognised at a point in time when the customer obtains control of the distinct good or service. Revenue is measured based on the consideration specified in a contract with a customer, excludes amounts collected on behalf of third parties, discounts and sales related taxes.

Contract liabilities

A contract liability represents the Group's obligation to transfer goods or services to a customer for which the Group has received consideration from the customer.

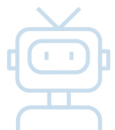
Sales of goods

The Group produces and sells mobile phones, PCBAs for mobile phones, IoT related products, and other products related to mobile phones. Revenue from the sale of goods is recognised when control of the product is transferred to the customer. Control of the product is considered transferred to the customer generally on delivery of goods to the customer's specified location and when customer acceptance has been obtained, which is the point of time the customer has the ability to direct the use of these products and obtain substantially all of the remaining benefits of these products.

A receivable is recognised when the products are delivered and accepted by customers as this is the point in time that the consideration is unconditional because only the passage of time is required before the payment is due. Payment of the transaction price is usually due within 30–90 days of the date when control of the products is transferred to the customer.

The Group normally received 5% to 30% of the contract value as deposit from customers when they signed the sale and purchase agreement for sales of products. For certain sale orders received from customer relating to IoT related products, the Group received 80% of the contract value as upfront deposit when they signed the sale agreement. These deposits are recognised as contract liabilities until the goods have been delivered to the customers.

The Group provides warranties for general repairs of defects to ensure that the products comply with agreed upon specification and they are therefore assurance-type warranties and the Group accounts for the warranty in accordance with HKAS 37 Provisions, Contingent Liabilities and Contingent Assets.

銷售貨品

本集團生產及銷售手機，手機用印刷電路板組裝，物聯網產品及其他與手機相關的產品。銷售貨品的收益於產品控制權已轉移予客戶時確認。產品控制權一般於產品交付至客戶指定地點及客戶確認收貨(即為客戶有能力直接使用該等產品並獲得該等產品之幾乎所有剩餘好處的時間點)時被視為轉移予客戶。

應收款項於產品交付及獲客戶接受時確認，因為付款需要時間的推移方會到期應付，故此為代價為無條件的時間點。支付交易價格通常於產品控制權轉移予客戶之日起30–90天內到期。

本集團在簽訂產品銷售買賣協議時，通常收取合約價值的5%至30%作為客戶押金。對於若干物聯網相關產品相關客戶的訂單，本集團在簽訂銷售協議時收到80%的合約價值作為預付款。有關按金在貨物交付客戶之前確認為合約負債。

本集團提供一般產品缺陷保修，以確保產品符合協定規格，因此，擔保屬保證型擔保，本集團根據香港會計準則第37號撥備、或然負債及或然資產對該等擔保進行會計處理。

Lease

Definition of a lease

A contract is, or contains, a lease if the contract conveys the right to control the use of an identified asset for a period of time in exchange for consideration.

The Group as lessee

The Group assesses whether a contract is or contains a lease, at inception of the contract. The Group recognises a right-of-use asset and a corresponding lease liability with respect to all lease arrangements in which it is the lessee, except for short-term leases (defined as leases with a lease term of 12 months or less from the commencement date and do not contain a purchase option). For these leases, the Group recognises the lease payments as an operating expense on a straight-line basis over the term of the lease unless another systematic basis is more representative of the time pattern in which economic benefits from the leased assets are consumed.

Lease liabilities

At the commencement date, the Group measures lease liability at the present value of the lease payments that are not paid at that date. The lease payments are discounted by using the interest rate implicit in the lease. If this rate cannot be readily determined, the Group uses its incremental borrowing rate.

Lease payments included in the measurement of the lease liability represents the fixed lease payments (including in-substance fixed payments).

本集團作為承租人

本集團於合約開始時評估合約是否為或包括租賃。本集團就其作為承租人的所有租賃安排（除短期租賃（界定為自開始日期起計租期為十二個月或更短且不包含購買選擇權的租賃）外）確認使用權資產及相關租賃負債。就該等租賃而言，本集團於租期內以直線法確認租賃付款為經營開支，惟倘有另一系統化基準更能代表耗用租賃資產經濟利益的時間模式則除外。

租賃負債

於開始日期，本集團以該日未支付租賃付款之現值計量租賃負債。租賃付款使用租賃中的內含利率進行貼現。倘上述利率不易確定，則本集團會使用增量借款利率。

The lease liability is presented as a separate line in the consolidated statement of financial position.

The lease liability is subsequently measured by increasing the carrying amount to reflect interest on the lease liability (using the effective interest method) and by reducing the carrying amount to reflect the lease payments made.

Right-of-use assets

The right-of-use assets are initially recognized at amounts which comprise the initial measurement amount of the corresponding lease liability, lease payments made at or before the commencement date and any initial direct costs, less lease incentives received.

Right-of-use assets are subsequently measured at cost less accumulated depreciation and impairment losses, and adjusted for any remeasurement of lease liabilities. They are depreciated over the shorter period of lease term and useful life of the underlying asset. The depreciation starts at the commencement date of the lease.

The Group applies HKAS 36 to determine whether a right-of-use asset is impaired and accounts for any identified impairment loss as described in the "Impairment losses on tangible assets and intangible assets" policy as stated below.

Allocation of consideration to components of a contract

For a contract that contains a lease component and one or more additional lease or non-lease components, the Group allocates the consideration in the contract to each lease component on the basis of the relative stand-alone price of the lease component and the aggregate stand-alone price of the non-lease components.

As a practical expedient, HKFRS 16 permits a lessee not to separate non-lease components, and instead account for any lease and associated non-lease components as a single arrangement. The Group has used this practical expedient for all leases.

Foreign currencies

In preparing the financial statements of each individual group entity, transactions in currencies other than the functional currency of that entity (foreign currencies) are recorded in the respective functional currency (i.e. the currency of the primary economic environment in which the entity operates) at the rates of exchanges prevailing at the dates of the transactions. At the end of the reporting period, monetary items denominated in foreign currencies are retranslated at the rates prevailing at that date. Non-monetary items that are measured in terms of historical cost in a foreign currency are not retranslated.

Exchange differences arising on the settlement of monetary items, and on the retranslation of monetary items, are recognised in profit or loss in the period in which they arise.

For the purposes of presenting the consolidated financial statements, the assets and liabilities of the Group's foreign operations are translated into the presentation currency of the Group (i.e. RMB) using exchange rates prevailing at the end of reporting period. Income and expenses items are translated at the average exchange rates for the year. Exchange differences arising, if any, are recognised in other comprehensive income and accumulated in equity under the heading of translation reserve.

Borrowing costs

Borrowing costs directly attributable to the acquisition, construction or production of qualifying assets, which are assets that necessarily take a substantial period of time to get ready for their intended use or sale, are added to the cost of those assets until such time as the assets are substantially ready for their intended use or sale.

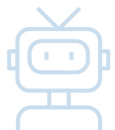
All other borrowing costs are recognised in profit or loss in the period in which they are incurred.

Government subsidies

Government subsidies are not recognised until there is reasonable assurance that the Group will comply with the conditions attaching to them and that the subsidies will be received.

Government subsidies are recognised in profit or loss on a systematic basis over the periods in which the Group recognises as expenses the related cost for which the subsidies are intended to compensate. Specifically, government subsidies whose primary condition is that the Group should purchase, construct or otherwise acquire non-current assets are recognised as deferred income in the consolidated statement of financial position and transferred to profit or loss on a systematic and rational basis over the useful lives of the related assets.

Government subsidies related to income that are receivable as compensation for expenses or losses already incurred or for the purpose of giving immediate financial support to the Group with no future related costs are recognised in profit or loss in the period in which they become receivable.

Retirement benefits cost

Payments to the People's Republic of China (the "PRC") state-managed retirement benefit schemes and the Mandatory Provident Fund Scheme (the "MPF Scheme") are recognised as an expense when employees have rendered service entitling them to the contributions.

Contributions are made based on a percentage of the employees' basic salaries and are charged to profit or loss as they become payable in accordance with the rules of the MPF Scheme. The assets of the MPF Scheme are held separately from those of the Group in an independently administered fund. The Group's employer contributions vest fully with the employees when contributed into the MPF Scheme.

Short-term employee benefits

A liability is recognised for benefits accruing to employees in respect of wages and salaries, annual leave and sick leave in the period the related service is rendered at the undiscounted amount of the benefits expected to be paid in exchange for that service.

Liabilities recognised in respect of short-term employee benefits are measured at the undiscounted amount of the benefits expected to be paid in exchange for the related service.

Taxation

Income tax expense represents the sum of the tax currently payable and deferred tax.

The tax currently payable is based on taxable profit for the year. Taxable profit differs from profit before tax as reported in the consolidated statement of profit or loss and other comprehensive income because it excludes items of income or expense that are taxable or deductible in other years and it further excludes items that are never taxable or deductible. The Group's liability for current tax is calculated using tax rates that have been enacted or substantively enacted by the end of the reporting period.

供款是根據僱員基本薪金的一個百分比作出的，並在根據強積金計劃的規則應付時計入損益。強積金計劃的資產與本集團的資產分開，存放於獨立管理的基金。本集團的雇主繳款在繳入強積金計劃時全部歸屬於僱員。

短期僱員福利

負債乃就僱員於該期間（按預期將就換取該服務而支付的未貼現福利金額所提供服務的期間）按工資及薪金、年假及病假應計的福利予以確認。

就短期僱員福利確認的負債乃按預期將就換取相關服務而支付的未貼現福利金額計量。

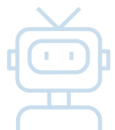

Deferred tax is recognised on temporary differences between the carrying amounts of assets and liabilities in the consolidated financial statements and the corresponding tax bases used in the computation of taxable profit. Deferred tax liabilities are generally recognised for all taxable temporary differences. Deferred tax assets are generally recognised for all deductible temporary difference to the extent that it is probable that taxable profits will be available against which those deductible temporary differences can be utilised. Such deferred tax assets and liabilities are not recognised if the temporary difference arises from the initial recognition of assets and liabilities in a transaction that affects neither the taxable profit nor the accounting profit.

Deferred tax liabilities are recognised for taxable temporary differences associated with investments in subsidiaries, except where the Group is able to control the reversal of the temporary difference and it is probable that the temporary difference will not reverse in the foreseeable future. Deferred tax assets arising from deductible temporary differences associated with such investments are only recognised to the extent that it is probable that there will be sufficient taxable profits against which to utilise the benefits of the temporary differences and they are expected to reverse in the foreseeable future.

The carrying amount of deferred tax assets is reviewed at the end of each reporting period and reduced to the extent that it is no longer probable that sufficient taxable profits will be available to allow all or part of the asset to be recovered.

Deferred tax assets and liabilities are measured at the tax rates that are expected to apply in the period in which the liability is settled or the asset is realised, based on tax rate (and tax laws) that have been enacted or substantively enacted by the end of the reporting period.

The measurement of deferred tax liabilities and assets reflects the tax consequences that would follow from the manner in which the Group expects, at the end of the reporting period, to recover or settle the carrying amount of its assets and liabilities.

Deferred tax assets and liabilities are offset when there is a legally enforceable right to set off current tax assets against current tax liabilities and when they relate to income taxes levied by the same taxation authority and the Group intends to settle current tax liabilities and assets on a net basis.

For the purposes of measuring deferred tax for leasing transactions in which the Group recognises the right-of-use assets and the related lease liabilities, the Group first determines whether the tax deductions are attributable to the right-of-use assets or the lease liabilities.

For leasing transactions in which the tax deductions are attributable to the lease liabilities, the Group applies HKAS 12 Income Taxes requirements to right-of-use assets and lease liabilities separately. Temporary differences relating to right-of-use assets and lease liabilities are not recognised at initial recognition due to application of the initial recognition exemption.

Current tax and deferred tax are recognised in profit or loss.

Property, plant and equipment are stated in the consolidated statement of financial position at cost less subsequent accumulated depreciation and subsequent accumulated impairment losses, if any.

The estimated useful lives, residual values and depreciation method are reviewed at the end of each reporting period, with the effect of any changes in estimate accounted for on a prospective basis.

An item of property, plant and equipment is derecognised upon disposal or when no future economic benefits are expected to arise from the continued use of the asset. Any gain or loss arising on the disposal or retirement of an item of property, plant and equipment is determined as the difference between the sales proceeds and the carrying amount of the asset and is recognised in profit or loss.

Ownership interests in leasehold land and buildings

When the Group makes payments for ownership interests of properties which includes both leasehold land and building elements, the entire consideration is allocated between the leasehold land and the building elements in proportion to the relative fair values at initial recognition. To the extent the allocation of the relevant payments can be made reliably, interest in leasehold land is presented as "right-of-use assets" in the consolidated statement of financial position. When the consideration cannot be allocated reliably between non-lease building element and undivided interest in the underlying leasehold land, the entire properties are classified as property, plant and equipment.

Intangible assets with finite useful lives that are acquired separately are carried at costs less accumulated amortisation and any accumulated impairment losses. Amortisation for intangible assets with finite useful lives is recognised on a straight-line basis over their estimated useful lives. The estimated useful life and amortisation method are reviewed at the end of each reporting period, with the effect of any changes in estimate being accounted for on a prospective basis.

Internally-generated intangible assets – research and development expenditure

An internally-generated intangible asset arising from development activities (or from the development phase of an internal project) is recognised if, and only if, all of the following have been demonstrated:

- the technical feasibility of completing the intangible asset so that it will be available for use or sale;
- the intention to complete the intangible asset and use or sell it;
- the ability to use or sell the intangible asset;
- how the intangible asset will generate probable future economic benefits;
- the availability of adequate technical, financial and other resources to complete the development and to use or sell the intangible asset; and
- the ability to measure reliably the expenditure attributable to the intangible asset during its development.

Development costs and patents are internally generated. Capitalised development cost represents the cost in relation to the self-developed feature for IT products. All of the Group's computer software were acquired from third parties. Such intangible assets are amortised on a straight-line basis over the following periods:

Interests in subsidiaries

Interests in subsidiaries are stated on the statement of financial position of the Company at cost less any identified impairment loss.

Inventories

Inventories are stated at the lower of cost and net realisable value. Costs of inventories are calculated using weighted average method. Net realisable value of inventories represents the estimated selling price in the ordinary course of business for inventories less all estimated costs of completion and costs necessary to make the sale.

Financial instruments

Financial assets and financial liabilities are recognised in the consolidated statement of financial position when a group entity becomes a party to the contractual provisions of the instrument.

Financial assets and financial liabilities are initially measured at fair value, except for trade receivables arising from contracts with customers which are initially measured in accordance with HKFRS 15. Transaction costs that are directly attributable to the acquisition or issue of financial assets and financial liabilities (other than financial assets or financial liabilities at fair value through profit or loss) are added to or deducted from the fair value of the financial assets or financial liabilities, as appropriate, on initial recognition. Transaction costs directly attributable to the acquisition of financial assets or financial liabilities at fair value through profit or loss are recognised immediately in profit or loss.

Financial assets at amortised cost (debt instruments)

The effective interest method is a method of calculating the amortised cost of a debt instrument and of allocating interest income over the relevant period.

For financial instruments, the effective interest rate is the rate that exactly discounts estimated future cash receipts (including all fees and points paid or received that form an integral part of the effective interest rate, transaction costs and other premiums or discounts) excluding ECL, through the expected life of the debt instrument, or, where appropriate, a shorter period, to the gross carrying amount of the debt instrument on initial recognition.

The amortised cost of a financial asset is the amount at which the financial asset is measured at initial recognition minus the principal repayments, plus the cumulative amortisation using the effective interest method of any difference between that initial amount and the maturity amount, adjusted for any loss allowance. On the other hand, the gross carrying amount of a financial asset is the amortised cost of a financial asset before adjusting for any loss allowance.

Interest income is recognised using the effective interest method for debt instruments measured subsequently at amortised cost. For financial instruments other than purchased or originated credit-impaired financial assets, interest income is calculated by applying the effective interest rate to the gross carrying amount of a financial asset, except for financial assets that have subsequently become credit-impaired.

Interest income is recognised in profit or loss and is included in the “other gains and income” line item.

Impairment of financial assets

The Group recognises a loss allowance for ECL on financial assets which are subject to impairment under HKFRS 9 (including trade and bills receivables, pledged bank deposits, restricted deposits, other receivables, amounts due from shareholders and bank balances and cash). The amount of ECL is updated at each reporting date to reflect changes in credit risk since initial recognition of the respective financial instruments.

The Group always recognises lifetime ECL for trade and bill receivables. The expected credit losses on these financial assets are estimated using a provision matrix based on the Group's historical credit loss experience, adjusted for factors that are specific to the debtors, general economic conditions and an assessment of both the current as well as the forecast direction of conditions at the reporting date, including time value of money where appropriate.

Assessment are done based on the Group's historical credit loss experience and forward looking information including both current and forecast general economic conditions at the reporting date.

The Group applies the simplified approach to provide for ECL prescribed by HKFRS 9 for trade and bills receivables.

For all other financial instruments, the Group measures the loss allowance equal to RMB5 millions ECL, unless when there has been a significant increase in credit risk since initial recognition, the Group recognises lifetime ECL. The assessment of whether lifetime ECL should be recognised is based on significant increases in the likelihood or risk of a default occurring since initial recognition.

(i) Significant increase in credit risk

In assessing whether the credit risk has increased significantly since initial recognition, the Company compares the risk of a default occurring on the financial instrument as at the reporting date with the risk of a default occurring on the financial instrument as at the date of initial recognition. In making this assessment, the Company considers both quantitative and qualitative information that is reasonable and supportable, including historical experience and forward-looking information that is available without undue cost or effort.

In particular, the following information is taken into account when assessing whether credit risk has increased significantly:

- an actual or expected significant deterioration in the financial instrument's external (if available) or internal credit rating;
- significant deterioration in external market indicators of credit risk, e.g. a significant increase in the credit spread, the credit default swap prices for the debtor;

- existing or forecast adverse changes in business, financial or economic conditions that are expected to cause a significant decrease in the debtor's ability to meet its debt obligations;
- an actual or expected significant deterioration in the operating results of the debtor; or
- an actual or expected significant adverse change in the regulatory, economic, or technological environment of the debtor that results in a significant decrease in the debtor's ability to meet its debt obligations.

Despite the foregoing, the Group assumes that the credit risk on a debt instrument has not increased significantly since initial recognition if the debt instrument is determined to have low credit risk at the reporting date. A financial instrument is determined to have low credit risk if i) the financial instrument has a low risk of default, ii) the borrower has a strong capacity to meet its contractual cash flow obligations in the near term and iii) adverse changes in economic and business conditions in the longer term may, but will not necessarily, reduce the ability of the borrower to fulfill its contractual cash flow obligations. The Group considers a debt instrument to have low credit risk when it has an internal or external credit rating of 'investment grade' as per globally understood definition or if an external rating is not available, the asset has an internal rating of 'performing'. Performing means that the counterparty has a strong financial position and there is no past due amounts.

The Group regularly monitors the effectiveness of the criteria used to identify whether there has been a significant increase in credit risk and revises them as appropriate to ensure that the criteria are capable of identifying significant increase in credit risk before the amount becomes past due.

(ii) Definition of default

The Group considers the following as constituting an event of default for internal credit risk management purposes as historical experience indicates that receivables that meet either of the following criteria are generally not recoverable.

- when there is a breach of financial covenants by the counterparty; or
- information developed internally or obtained from external sources indicates that the debtor is unlikely to pay its creditors, including the Group, in full (without taking into account any collaterals held by the Group).

(iii) Write-off policy

The Group writes off a financial asset when there is information indicating that the counterparty is in severe financial difficulty and there is no realistic prospect of recovery, e.g. when the counterparty has been placed under liquidation or has entered into bankruptcy proceedings, or in the case of trade and bills receivables, when the amounts are over 24 months past due, whichever occur sooner. Financial assets written off may still be subject to enforcement activities under the Group's recovery procedures, taking into account legal advice where appropriate. Any recoveries made are recognised in profit or loss.

(v) Measurement and recognition of ECL

The measurement of expected credit losses is a function of the probability of default, loss given default (i.e. the magnitude of the loss if there is a default) and the exposure at default. The assessment of the probability of default and loss given default is based on historical data adjusted by forward-looking information. As for the exposure at default, for financial assets, this is represented by the assets' gross carrying amount at the reporting date.

For the financial assets, the expected credit loss is estimated as the difference between all contractual cash flows that are due to the Group in accordance with the contract and all the cash flows that the Group expects to receive, discounted at the original effective interest rate.

If the Group has measured the loss allowance for a financial instrument at an amount equal to lifetime ECL in the previous reporting period, but determines at the current reporting date that the conditions for lifetime ECL are no longer met, the Group measures the loss allowance at an amount equal to 12-month ECL at the current reporting date, except for assets for which simplified approach was used.

The Group recognises an impairment gain or loss in profit or loss for all financial instruments with a corresponding adjustment to their carrying amount through a loss allowance account.

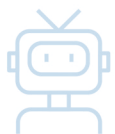

(vi) Derecognition of financial assets

A financial asset is derecognised only when the contractual rights to the cash flows from the asset expire, or when it transfers the financial asset and substantially all the risks and rewards of ownership of the asset to another entity. If the Group neither transfers nor retains substantially all the risks and rewards of ownership of the asset and continues to control the transferred asset, the Group recognises its retained interest in the asset and an associated liability for amounts it may have to pay. If the Group retains substantially all the risks and rewards of ownership of a transferred financial asset, the Group continues to recognise the financial asset and also recognises a collateralised borrowing for the proceeds received.

On derecognition of a financial asset measured at amortised cost, the difference between the asset's carrying amount and the sum of the consideration received and receivable is recognised in profit or loss.

Provisions

The fair value of services received determined by reference to the fair value of share options granted at the date of grant is expensed on a straight-line basis over the vesting period, with a corresponding increase in equity (share options reserve).

At the end of the reporting period, the Group revises its estimates of the number of options that are expected to ultimately vest. The impact of the revision of the original estimates during the vesting period, if any, is recognised in profit or loss such that the cumulative expense reflects the revised estimate, with a corresponding adjustment to share options reserve.

When share options are exercised, the amount previously recognised in share options reserve will be transferred to share premium. When the share options are forfeited after the vesting date or are still not exercised at the expiry date, the amount previously recognised in share options reserve will be transferred to retained earnings.

At the end of the reporting period, the Group reviews the carrying amounts of its property, plant and equipment, right-of-use assets and intangible assets with finite useful lives to determine whether there is any indication that those assets have suffered an impairment loss. When it is not possible to estimate the recoverable amount of an individual asset, the Group estimates the recoverable amount of the cash-generating unit to which the asset belongs. When a reasonable and consistent basis of allocation can be identified, corporate assets are also allocated to individual cash-generation units, or otherwise they are allocated to the smallest group of cash-generating units for which a reasonable and consistent allocation basis can be identified.

Recoverable amount is the higher of fair value less costs of disposal and value in use. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset for which the estimates of future cash flows have not been adjusted.

If the recoverable amount of an asset (or a cash-generating unit) is estimated to be less than its carrying amount, the carrying amount of the asset (or a cash-generating unit) is reduced to its recoverable amount. An impairment loss is recognised immediately in profit or loss.

Where an impairment loss subsequently reverses, the carrying amount of the asset (or a cash-generating unit) is increased to the revised estimate of its recoverable amount, but so that the increased carrying amount does not exceed the carrying amount that would have been determined had no impairment loss been recognised for the asset (or a cash-generating unit) in prior years. A reversal of an impairment loss is recognised as immediately in profit or loss as income.

4. KEY SOURCES OF ESTIMATION UNCERTAINTY

In the application of the Group's accounting policies, which are described in note 3, the directors of the Company are required to make judgements, estimates and assumptions about the amounts of assets, liabilities, revenue and expenses reported and disclosures made in the consolidated financial statements. The estimates and associated assumptions are based on historical experience and other factors that are considered to be relevant. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an on-going basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period or in the period of the revision and future periods if the revision affects both current and future periods.

The following are the key assumptions concerning the future, and other key sources of estimation uncertainty at the end of the reporting period, that have a significant risk of resulting in a material adjustment to the carrying amounts of assets and liabilities within the next financial year.

Estimated useful lives of property, plant and equipment (including right-of-use assets) and intangible assets

Property, plant and equipment (including right-of-use assets) and intangible assets are stated in the consolidated statement of financial position at cost less subsequent accumulated depreciation, amortisation and subsequent accumulated impairment losses, if any. The estimated useful lives reflect the Company's directors' estimate of the periods that the Group intends to derive future economic benefits from the use of the Group's property, plant and equipment (including right-of-use assets) and intangible assets, based on various factors. The estimation of useful lives impacts the level of annual depreciation or amortisation expenses recorded.

Impairment of property, plant and equipment, right-of-use assets and intangible assets with finite useful life

If circumstances indicate that the carrying value of a property, plant and equipment, right-of-use assets and intangible assets with finite useful life may not be recoverable, the asset may be considered impaired, and an impairment loss may be recognised in profit or loss. These assets are tested for impairment whenever events or changes in circumstances indicate that their recorded carrying amounts may not be recoverable. When a decline of the assets' recoverable amounts below the carrying amounts has occurred, the carrying amount is reduced to the recoverable amount. The recoverable amount is the greater of the fair value less costs of disposal and value in use. It is difficult to precisely estimate fair value less costs of disposal because quoted market prices for the Group's assets are not readily available. In determining value in use, expected cash flows generated by the asset are discounted to their present value, which requires significant judgement relating to level of sales volume and amount of operating costs. The Group uses all readily available information in determining an amount that is a reasonable approximation of the recoverable amount, including estimates based on reasonable and supportable assumptions and projections of sales volume and amount of operating costs. As at 31 December 2022, the carrying amounts of right-of-use assets, property, plant and equipment, and intangible assets were RMB5,649,000, RMB103,614,000 and RMB7,659,000 (2021: RMB21,132,000, RMB121,866,000 and RMB9,183,000) respectively.

Impairment losses recognised in respect of trade and bills receivables

The impairment for trade and bills receivables is based on assumptions about ECL. The Group used judgement in making these assumptions and selecting the inputs to the impairment calculation, based on the number of days that trade and bills receivables are outstanding as well as the Group's historical experience and forward-looking information at the end of the reporting period. Changes in these assumptions and estimates could materially affect the result of the assessment and it may be necessary to make additional impairment charge to the consolidated statement of profit or loss and other comprehensive income.

As at 31 December 2022, the carrying values of trade and bills receivables is approximately RMB 191,704,000 (31 December 2021: RMB226,014,000) net of allowance for doubtful debt of approximately RMB2,505,000 (31 December 2021: RMB2,581,000).

Allowances recognised in respect of inventories

The management of the Group reviews an ageing analysis at the end of each reporting period and makes allowance for obsolete and slow-moving items identified that are no longer suitable for sale or use. The Group makes allowance for inventories based on the assessment of the net realisable value. The management estimates the net realisable value for inventories based on subsequent usage and sales, ageing analysis and current market conditions. As at 31 December 2022, the carrying amounts of inventories were approximately RMB187,428,000 (2021: RMB280,485,000) and no impairment loss has been recognised for the years ended 31 December 2022 and 2021.

- (i) Pursuant to the rules and regulations of the British Virgin Islands and Cayman Islands, the Group is not subject to any income tax in these jurisdictions.
- (ii) The statutory tax rate of subsidiaries in Hong Kong is 16.5%. Under the two-tiered profits tax rates regime of Hong Kong Profits Tax, the first HK\$2 million of profits of qualifying group entity are taxed at 8.25%, and profits above HK\$2 million are taxed at 16.5%. The profits of group entities not qualifying for the two-tiered profits tax rate regime are to be taxed at a flat rate of 16.5%.
- (iii) Under the Law of the PRC on Enterprise Income Tax (the “EIT law”) and Implementation Regulation of the EIT Law, the tax rate of the subsidiaries established in the PRC is 25%.
- (iv) Two of the Group’s subsidiaries, Shenzhen Sprocomm Telecommunication Technology Co., Ltd. (“Shenzhen Sprocomm”) and Shanghai Sprocomm Telecommunication Technology Co., Ltd. (“Shanghai Sprocomm”), are recognised as a High and New-technology Enterprise, which have been granted tax concessions by the local tax bureau and are entitled to PRC EIT at concessionary rate of 15% from 2020 to 2022 and 2021 to 2023 respectively.
- (v) The India taxation was calculated based on the rates applicable in the relevant jurisdiction on the estimated assessable profits. The applicable tax rate is 30%. No provision of overseas profits tax in respect of India taxation has been made, as the Group did not have any assessable profits subject to such overseas profits tax for both years.
- (vi) In 2022, the Group is subjected to Federal Income taxes. The United States enterprise income tax rate has been provided at the applicable rate of 21% for the year ended 31 December 2022 (2021: nil).

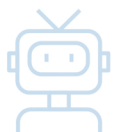

According to the PRC Company Law, companies in the PRC are required to transfer 10% of their respective after-tax profits, calculated in accordance with the relevant accounting principles and financial regulations applicable to entities established in the PRC, to the statutory surplus reserve until the reserve balance reaches 50% of the registered capital of the relevant subsidiaries. The statutory surplus reserve can be utilised, upon approval of the relevant authorities, to offset accumulated losses or to increase registered capital of these companies, provided that such fund is maintained at a minimum of 25% of the registered capital of the relevant subsidiaries. The statutory reserve is not distributable as cash dividends and must be made before distribution of dividend to equity owners.

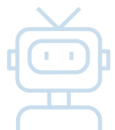

Any further grant of share options in excess of this limit is subject to shareholders' approval in a general meeting.

In addition, any grant of share options to substantial shareholders or independent non-executive directors or to any of their respective associates, in excess of 0.1% of the shares of the Company in issue on the date of offer with an aggregate value (based on the closing price of the Company's shares quoted on the Stock Exchange at the date of grant) in excess of HK\$5 million made within any 12-month period from the date of grant (inclusive) would be subject to shareholders' approval in a general meeting.

The offer of a grant of share options under the Share Option Scheme may be accepted within on or before the relevant acceptance date, upon payment of a nominal consideration of HK\$1 in total by the grantee.

The exercise price of share options is determinable by the board of directors, but may not be less than the highest of (i) the HKSE closing price of the Company's shares on the date of grant of the share options; (ii) the average closing price of the Company's shares for the five trading days immediately preceding the date of grant of the share options; and (iii) the nominal value of shares of the Company.

Pursuant to the Share Option Scheme of the Company adopted in 2019, the Company granted share options to subscribe for an aggregate of 69,100,000 shares (the “Share Options”) on 14 April 2020 to certain directors and employees. The options have a validity period of five years from the date of grant. The Group has no legal or constructive obligations to repurchase or settle the options in cash. These options vest in tranches over a period of up to 3 years.

The options are to be vested in three tranches, subject to the Group achieving its profit target and the directors and employees meeting their service conditions as well (the “Performance Conditions”). 32. RETIREMENT BENEFITS PLAN

The Group operates a MPF Scheme for all qualifying employees in Hong Kong. The assets of the scheme are held separately from those of the Group, in funds under the control of trustees. The Group contributes 5% of relevant payroll costs, capped at HK\$1,500 per month, to the MPF Scheme, in which the contribution is matched by the employees.



The subsidiaries established in the PRC contribute based on certain percentages of the salaries of the employees to defined contribution retirement benefit plans organised by the relevant government authorities in the PRC on a monthly basis. The government authorities undertake to assume the retirement benefit obligations payable to all existing and further retired employees under these plans and the Group has no further obligation for post-retirement benefits beyond the contributions made. Contributions to these plans are expensed as incurred. Assets of the plans are held and managed by government authorities and are separate from those of the Group.

The total cost charged to consolidated statement of profit or loss and other comprehensive income of approximately RMB17,097,000 (2021: RMB12,432,000) represents contributions paid and payable to these schemes by the Group during the year ended 31 December 2022.

During the year ended 31 December 2022, there was no forfeited contributions (2021: nil) under the defined contribution schemes and no utilisation of forfeited contributions. As at 31 December 2022, the Group had no forfeited contribution available to reduce its contribution to the retirement schemes in future years (2021: nil).

35. CAPITAL RISK MANAGEMENT

The Group manages its capital to ensure that entities within the Group will be able to continue as a going concern while maximising the return to shareholders through the optimisation of the debt and equity balances. The Group's overall strategy remains unchanged from period year.



The capital structure of the Group consists of borrowings, net of bank balances and cash and equity attributable to owners of the Company, comprising share capital and reserves.



The directors of the Company review the capital structure of the Group periodically. As part of this review, the directors of the Company consider the cost of capital and the risks associated with each class of capital. Based on recommendations of the directors of the Company, the Group will balance its overall capital structure through capital injection as well as raising of additional borrowings as additional capital or the redemption of existing debt.

(i) Currency risk

The Group's major operating subsidiaries have foreign currency sales, which expose the Group to foreign currency risk. The Group currently does not have a foreign currency hedging policy. However, the management monitors foreign exchange exposure and will consider hedging significant foreign currency exposure should the need arise.

As the Group had no material foreign currency denominated monetary assets and liabilities at 31 December 2022 and 31 December 2021, no significant impacts on the results of the Group would arise from the changes in foreign currency rates, accordingly sensitivity analysis in this respect is not presented.

(ii) Interest rate risk

The Group is exposed to fair value interest rate risk in relation to fixed rate borrowings (Note 26) and certain pledged bank deposits (Note 22). The Group currently does not have an interest rate hedging policy. However, the management monitors interest rate exposure and will consider other necessary actions when significant interest rate exposure is anticipated.

The Group is also exposed to cash flow interest rate risk in relation to certain variable-rate pledged bank deposits (Note 22) and bank balances (Note 23) and variable-rate bank borrowings (Note 26). The Group aims at keeping borrowings at variable rates. The Group manages its interest rate exposures by assessing the potential impact arising from any interest rate movements based on interest rate level and outlook. The management will review the proportion of borrowings in fixed and floating rates and ensure they are within reasonable range.

Sensitivity analysis

The sensitivity analysis below have been determined based on the exposure to interest rates for non-derivative financial instruments at the end of the reporting period. The analysis is prepared assuming the financial instruments outstanding at the end of the reporting period were outstanding for the whole year. A 100 basis point (2021: 100 basis point) increase or decrease is used when reporting interest rate risk internally to key management personnel and represents management's assessment of the reasonably possible change in interest rates. If the interest rate on variable bank borrowings had been 100 basis points (2021: 100 basis points) higher or lower and all other variables held constant, the Group's post-tax profit for the year ended 31 March 2022 would decrease or increase by approximately HK\$398,000 (2021: post-tax loss would increase or decrease by HK\$582,000). This is mainly attributable to the Group's exposure to interest rates on its variable-rate bank borrowings.

Credit risk

As at 31 December 2022, the Group's maximum exposure to credit risk which will cause a financial loss to the Group due to failure to discharge an obligation by the counterparties provided by the Group is arising from the carrying amount of the respective recognised financial assets as stated in the consolidated statement of financial position.

In order to minimise the credit risk, the management of the Group has delegated a team responsible for determination of credit limits, credit approvals and other monitoring procedures to ensure that follow-up action is taken to recover overdue debts.

In determining the ECL for trade and bills receivables, the management of the Group has taken into account the historical default experience and forward-looking information and concluded that credit risk inherent in the Group's outstanding trade and bills receivables are insignificant.

The Group applies the simplified approach to assess the expected credit losses prescribed by HKFRS 9, which permits the use of the lifetime expected credit loss for all trade and bills receivables. The Group determines the ECL on an individual basis and/or collectively by using a provision matrix, estimated based on historical credit loss experience, as well as the general economic conditions of the industry in which the debtors operate. In this regard, the directors of the Company consider that the Group's credit risk is significantly reduced.

於二零二二年十二月三十一日，本集團因對手方未能履行責任（本集團已就此作出撥備）而可能面臨財務虧損的最高信貸風險，來自綜合財務狀況表所述各已確認金融資產的賬面值。

為將信貸風險降至最低，本集團管理層已委派團隊負責釐定信貸額度、信貸審批及其他監察程序，以確保採取跟進措施收回逾期債務。

就貿易應收款項及應收票據釐定預期信貸虧損時，本集團管理層已計及過往違約經驗及前瞻性資料，認為本集團未償還貿易應收款項及應收票據的固有信貸風險不重大。

本集團按香港財務報告準則第9號規定應用簡化方法評估預期信貸虧損，該準則准許就所有貿易應收款項及應收票據採用全期預期信貸虧損。本集團運用撥備矩陣（基於過往信貸虧損經驗以及債務人經營行業的整體經濟狀況估計）按個別基準及／或組合基準釐定預期信貸虧損。就此而言，本公司董事認為本集團的信貸風險已大幅減少。

For other receivables, the Group has assessed whether there has been a significant increase in credit risk since initial recognition. If there has been a significant increase in credit risk, the Group will measure the loss allowance based on lifetime rather than 12-month ECL.

Management considered amount due from shareholders to be low credit risk and thus the impairment provision recognised during the year was limited to 12-month ECL.

The credit risk on liquid funds is considered minimal as such amounts are placed with banks with high credit ratings assigned by international credit-rating agencies.

The Group's concentration of credit risk by geographical location is mainly in China, which accounted for 67% (2021: China 52%) of the total trade and bill receivables respectively as at 31 December 2022.

The Group has concentration of credit risk as 37% (31 December 2021: 18%) of the total trade and bills receivables was due from the Group's largest trade debtor as at 31 December 2022 and 83% (31 December 2021: 65%) of the total trade and bills receivables was due from the Group's five largest trade debtors who are in telecom and technology industries as at 31 December 2022.

管理層認為應收股東款項的信貸風險偏低，因此在年內確認的減值撥備限於12個月預期信貸虧損。

流動資金的信貸風險被視為甚微，因為該等款項存放於國際信貸評級機構指派的高信貸評級銀行。

本集團按地理位置劃分的信貸風險主要集中在中國，於二零二二年十二月三十一日分別佔貿易應收款項及應收票據總額的67% (二零二一年：中國52%)。

Liquidity risk

In the management of the liquidity risk, the Group monitors and maintains a level of cash and cash equivalents deemed adequate by the management to finance the Group's operations and mitigate the effects of fluctuations in cash flows. In addition, the Group relies on borrowings as a significant source of liquidity. The management monitors the utilisation of borrowings and ensures compliance with loan covenants.

The following table details the Group's remaining contractual maturity for its non-derivative financial liabilities and lease liabilities. The table has been drawn up based on the undiscounted cash flows of financial liabilities and lease liabilities based on the earliest date on which the Group can be required to pay. The maturity dates for non-derivative financial liabilities and lease liabilities are prepared based on the agreed repayment dates. Specifically, borrowings with a repayment on demand clause are included in "Less than 1 year or on demand" band regardless of the probability of the financial institution choosing to exercise their rights.

The table includes both interest and principal cash flows. To the extent that interest flows are floating rate, the undiscounted amount is derived from interest rate curve at the end reporting period.

Borrowings with a repayment on demand clause is included in the “less than 1 year or on demand” time band in the above maturity analysis. As at 31 December 2022, the aggregate undiscounted principal amounts of these borrowings amounted to RMB37,006,000 (2021: RMB42,162,000). Taking into account the Group’s financial position, the directors of the Company do not believe that it is probable that the financial institutions will exercise their discretionary rights to demand immediate repayment. The directors of the Company believe that such borrowings will be repaid in accordance with the scheduled repayment dates set out in the loan agreements.

41. LITIGATIONS

During the year ended 31 December 2019, an independent factoring company (the “**Plaintiff**”) filed a lawsuit at Beijing Haidian District People’s Court (the “**District Court**”) against Shenzhen Sprocomm and a customer of Shenzhen Sprocomm owing the factored accounts receivable (the “**First Defendant**”) for the repayment of the outstanding accounts receivable under the factoring agreement. Provision for litigation loss of approximately RMB1,766,000 was made during the year ended 31 December 2019 with reference to legal opinion obtained and the then available information.

In December 2020, Shenzhen Sprocomm has received the judgement of the first trial from the District Court ruling it to repay the factored loan amount at approximately RMB26,805,000 and the relevant interest at approximately RMB3,303,000.

The directors of the Company, with reference to the updated legal opinion and the then available information, had made further provision for loss on litigation of approximately RMB327,000 during the year ended 31 December 2020. Accumulated provision for loss on litigation of RMB2,093,000 (being the sum of the provision for litigation loss in 2019 and 2020) was included in other payables in the consolidated statement of financial position as at 31 December 2020.

During the year ended 31 December 2021, Shenzhen Sprocomm filed an appeal (the “**Appeal**”) to the First Intermediate People’s Court of Beijing Municipality (the “**First Intermediate Court**”) and received the judgement of the second trial from the First Intermediate Court which dismissed the Appeal and ruled that the District Court’s decision remains effective. The judgement was executed by the District Court on 30 August 2021 and subsequently, Shenzhen Sprocomm paid an aggregate amounts of RMB31,138,000 (which comprised of the principal, interest and legal cost of approximately RMB26,805,000, RMB4,019,000 and RMB314,000 respectively) to settle the litigation claim.

41. 訴訟

截至二零一九年十二月三十一日止年度，一間獨立保理公司（「原告」）於北京市海澱區人民法院（「地區法院」）就償還保理協議項下未償還應收賬款針對深圳禾苗及一名結欠保利應收賬款的深圳禾苗客戶（「第一被告」）提起訴訟。參考已獲得的法律意見及當時可得的資料後，已於截至二零一九年十二月三十一日止年度計提訴訟虧損撥備約人民幣1,766,000元。

於二零二零年十二月，深圳禾苗已收到地區法院一審判決書，裁定其須償還保理貸款金額約人民幣26,805,000元及相關利息約人民幣3,303,000元。

本公司董事參考最新的法律意見及當時可得的資料，已於截至二零二零年十二月三十一日止年度就訴訟虧損進一步計提撥備約人民幣327,000元。累計訴訟虧損撥備為人民幣2,093,000元（即二零一九年及二零二零年訴訟虧損撥備之和），計入二零二零年十二月三十一日的綜合財務狀況表中的其他應付款項內。

於截至二零二一年十二月三十一日止年度，深圳禾苗向北京市第一中級人民法院（「第一中級法院」）提起上訴（「上訴」），並收到第一中級法院的二審判決書，判決駁回上訴，並裁定地區法院的判決維持有效。判決書於二零二一年八月三十日由地區法院執行，其後深圳禾苗支付合共人民幣31,138,000元（包括本金、利息及法律費用分別約為人民幣26,805,000元、人民幣4,019,000元及人民幣314,000元），以結付該訴訟索償。

The aforesaid litigation settlement of RMB31,138,000, net of the prior receipt in advance from the First Defendant of approximately RMB21,663,000 which Shenzhen Sprocomm was legally entitled to offset against the litigation claim. Accumulated provision for loss on litigation in prior years was approximately RMB2,093,000, additional amounted to RMB7,382,000 was recognised as loss on litigation included in administrative and other expenses in the consolidated statement of profit or loss and other comprehensive income during the year ended 31 December 2021 (Note 10).

In addition, pursuant to a deed of indemnity with the Controlling shareholders signed on 18 October 2019, which entitled the Group to all claims including legal costs and expenses incurred in relation to the relevant litigation, the Group recognised indemnification for litigation loss of approximately RMB9,475,000 by mutual consent from the controlling shareholders in other gains and income in the consolidated statements of profit or loss and other comprehensive income, upon the settlement of the aforesaid litigation during the year ended 31 December 2021.

41. 訴訟(續)

上述訴訟和解金人民幣31,138,000元，經扣除此前預先第一被告的款項約人民幣21,663,000元（深圳禾苗依法有權以其與訴訟索償抵銷）。過往年度累計訴訟損失撥備約人民幣2,093,000元，於截至二零二一年十二月三十一日止年度，額外的人民幣7,382,000元已確認為訴訟損失，計入綜合損益及其他全面收益表內的行政及其他開支（附註10）。

此外，根據於二零一九年十月十八日簽署的與控股股東的彌償契據，本集團有權獲得所有索償，包括就相關訴訟產生的法律費用及開支，於截至二零二一年十二月三十一日止年度，本集團在上述訴訟達成和解後，於綜合損益及其他全面收益表中的其他收益及收入確認經雙方同意後控股股東給予的訴訟損失彌償約人民幣9,475,000元。
