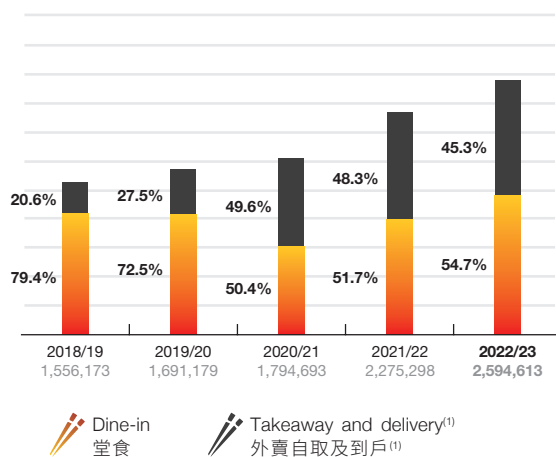

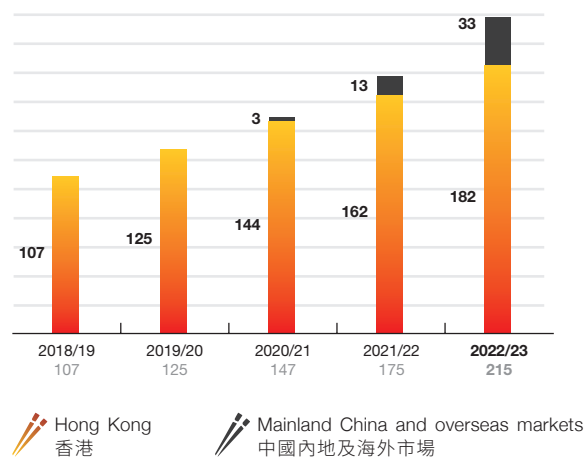

國際餐廳網絡

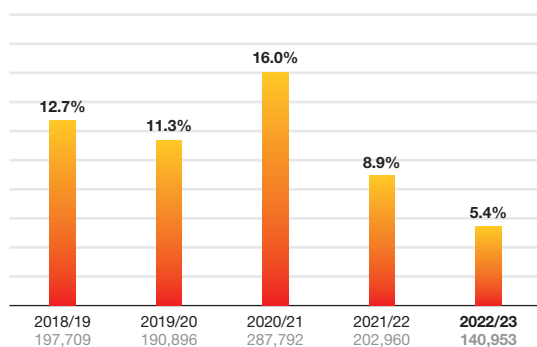
Number of restaurants 餐廳數目

年度溢利及利潤率

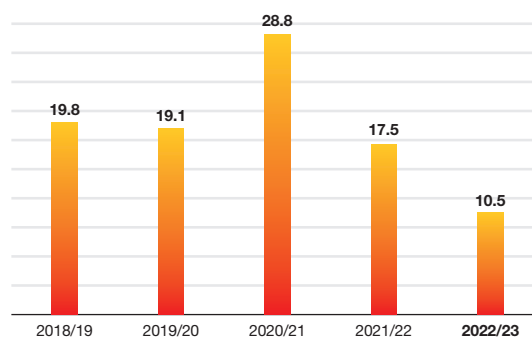

I would like to express my gratitude to all of you for placing your trust in us and remaining steadfast during challenging times.

The financial year ended 31 March 2023 (“FY2023”) marks the first full financial year since the successful listing of Tam Jai International Co. Limited (“TJI” or the “Company” and together with its subsidiaries, the “Group”, “we”, “us” or “our”) on the Main Board of The Stock Exchange of Hong Kong Limited (the “Stock Exchange”). This year has been particularly challenging, not only because the magnitude of the COVID-19 pandemic outbreak has been severe, but also due to the weaker economy under global inflation surge that has served as a backdrop for our international development. Thanks to our “Superior Will” to bring “Tam Jai” taste to the world, and the unwavering dedication of our team, TJI has demonstrated its strengths in adversity and surmounted these challenges.

“When the going gets tough, the tough get going”. Over the past three years of the pandemic, our team has capitalised on our experiences under unpredictable circumstances and built our capabilities in resilience, agility, innovation, and efficiency. I am confident TJI will become even stronger and united as we continue to move forward in a more welcoming business environment.

AGILE OPERATIONS

At TJI, we have demonstrated remarkable resilience throughout all twelve quarters from 2020 to 2022. Achieving this feat required us to remain agile and adaptable, constantly exercising innovation and discipline in all aspects of our business operations. We recognised the need to pivot rapidly and effectively to meet our customers’ and social needs, particularly in the face of severely impacted dine-in traffic. As a result, we swiftly transitioned to off-premises alternatives with creative and takeaway-friendly recipes, and our revenue from takeaway and delivery services contributed 45.3% of our total revenue in FY2023. This strategic shift was instrumental in our continued success, and we remain committed to adapting to the evolving needs of our customers in order to stay competitive and ahead in the industry.

RELENTLESS INNOVATION IN FOOD

Innovation is in our blood, and we are continuously striving to introduce new and creative offerings that go above and beyond our customers’ expectations. In FY2023, we have created more than 65 new products, ranging from spicy to non-spicy, traditional to revolutionary, and from red to green. This has brought excitement not only to our menu options but also to the taste buds of our customers.

截至二零二三年三月三十一日止財政年度（「二零二三財政年度」）乃自譚仔國際有限公司（「譚仔國際」或「本公司」，連同其附屬公司統稱「本集團」或「我們」）成功在香港聯合交易所有限公司（「聯交所」）主板上市後的第一個完整財政年度。今年市況尤其艱難，除了因為COVID-19疫情爆發的影響深遠外，全球通脹升溫導致經濟疲弱，我們的國際發展亦難免受到拖累。有賴我們「優越的意志」將「譚仔」味帶到世界各地，加上團隊堅定不移的竭誠付出，譚仔國際在逆境下自強不息，並得以克服此等挑戰。

「艱難之路，唯勇者行」。在過去三年的疫情中，我們的團隊利用自身經驗拆解種種始料未及的狀況，建立靈活變通、迅速應對、創新及高效的能力。本人深信，在迎來較佳的營商環境下，譚仔國際將會變得更加強大和團結。

靈活的業務營運

於二零二零年至二零二二年的整整十二個季度裡，譚仔國際展現非凡韌力。要達致此成績，我們須保持靈活變通，在業務營運各方面不斷推動創新並循規蹈矩。我們明白，為迎合顧客及社會需求，尤其當面對堂食顧客流量受嚴重衝擊時，需迅速有效進行調整。據此，我們旋即過渡到其他店外模式，配合具創意和適合外賣的餐牌選擇，於二零二三財政年度我們來自外賣自取及到戶訂單的收入為總銷售收益貢獻45.3%。此一戰略性變陣對我們持續取得成功有著關鍵作用，而我們會繼續致力適應顧客不斷變化的需求，以保持行業中的競爭優勢及領先地位。

食品不斷推陳出新

創新存在於我們的血液，因此，我們不斷努力推出讓人耳目一新、突破顧客想象的創意性食品款式。於二零二三財政年度，我們創出逾65種新產品，口味由辛辣到走辣，款式由傳統到嶄新，賣相由椒紅到素綠。這不但令餐單美食煥然一新，亦為顧客的味蕾帶來衝擊。

BRANDING AND MARKETING

Our tireless innovation is exhibited very well in our marketing and branding campaigns which continue to bring surprises and happiness to the public. We are the first food and beverage (“F&B”) company to get into non-fungible tokens (“NFT”). Our campaigns have consistently impressed our customers who are always looking forward to the next one, as well as industry professionals, who have highly recognised us with numerous awards. We will remain steadfast in our commitment to build strong customer loyalty and the stickiness of our brands. Underpinned by our creativity and out-of-the box thinking, we are confident that our marketing and branding strategies will continue to differentiate us from the competition, driving continued success and growth for our Group both in and outside of Hong Kong.

DIGITALISATION

In our ongoing pursuit of operational excellence, we have made significant investments in digital technology, with a focus on enhancing efficiency throughout our operations. In the third quarter of FY2023, we completed the full implementation of our Supply Chain Management (“SCM”) system and the first phase of our Customer Relationship Management (“CRM”) system for both TamJai Yunnan Mixian (“TamJai”) and TamJai SamGor Mixian (“SamGor”) brands, which proved to be a resounding success. Within a few short months, we successfully acquired approximately 450,000 unique members, a testament to the effectiveness of our digital transformation strategy. Moving forward, we will further enhance the features of our CRM and mobile apps to improve operational excellence and the overall customer experience, which will benefit our brand equity and revenue growth.

SUSTAINABLE DEVELOPMENT

The challenges we face have not distracted our focus and commitment to delivering our environmental, social and governance (“ESG”) commitments. We have set up the “Tam Jai Goodness Trust” to support various initiatives under our three ESG pillars: “Nourishing Communities”, “Uplifting People”, and “Preserving Nature”.

The TJI Education Support Scheme, “Go Green” menu, “TamJai Che Che” (譚仔車車) and the charitable NFT project were highlights of FY2023 and earned recognition from both the public and our staff. In addition, we held a Sustainability Week to enrich the ESG knowledge of our employees and encourage them to embed sustainability into daily business.

品牌及市場營銷

我們不遺餘力推動創新，證諸我們不少好評如潮的市場營銷及品牌推廣活動，其不斷為市民大眾帶來驚喜和快樂。我們是首間開展非同質化代幣（「NFT」）的餐飲公司。我們的推廣活動一直深受顧客欣賞，並熱切期待下次活動，而我們亦受業內專業人士高度認可並授予獎項等殊榮。我們將繼續致力建立強大的客戶忠誠度及品牌追隨度。我們深信，其著重發揮創意和破格思考的市場營銷和品牌建設策略，定可繼續助我們於競爭中脫穎而出，推動集團在香港和海外均持續成功和壯大。

數碼化

在持續追求卓越營運的過程中，我們對數碼科技作出重大投資，重點提高整體營運的效率。於二零二三財政年度第三季度，我們完成實行供應鏈管理（「SCM」）系統及同時為譚仔雲南米線（「譚仔」）和譚仔三哥米線（「三哥」）兩個品牌推出第一階段的客戶關係管理（「CRM」）系統，而且成績相當理想，短短數月內成功吸納約450,000名獨立會員，見證我們數碼轉型策略的成效。未來我們將進一步提升CRM及手機應用程式的功能以推進卓越營運，並提高整體顧客體驗，從而有利提升品牌價值及收入增長。

可持續發展

儘管面對種種挑戰亦無損我們專心一意實現環境、社會及管治（「ESG」）承諾。我們已成立「譚仔美善基金」，支持三大ESG主軸 — 「潤澤社區」、「提人為本」和「綠色倡議」下的各項企劃。

譚仔國際員工子女教育支援計劃、「Go Green」餐牌、「譚仔車車」及慈善NFT計劃均為二零二三財政年度的重點項目，贏得大眾及員工認可。此外，我們舉辦「可持續發展週」，以豐富員工的ESG知識，並鼓勵彼等將可持續發展融入日常業務。

LOOKING AHEAD

Our most immediate priority is to bring “Tam Jai” brands to our overseas markets and realise our international development plan.

Although the progress has been impacted by pandemic and our learning curve has deepened, we are optimistic that we can quickly adjust to adapt to local cultures and successfully connect with consumers in different markets. We will resume our pace of development as laid down in our prospectus dated 23 September 2021 (the “Prospectus”), and kick off the expansion plan into the western market in the financial year ending 31 March 2024 (“FY2024”) to further increase our penetration in potential markets.

While macroeconomic headwinds and numerous challenges remain, we are prepared to navigate the road to full recovery. Our primary focus is on achieving sustainable, long-term growth that benefits both our shareholders and stakeholders. Despite the potential for bumps in the road, we remain steadfast in our commitment to realising our international expansion goals and driving profitability for our business.

MANAGEMENT DISCUSSION AND ANALYSIS

管理層討論及分析



INDUSTRY OVERVIEW

FY2023 continued to be a challenging year for the global economy and the F&B industry.

Throughout FY2023, external factors have put notable price pressure on goods and services. As a combination of pandemic-induced supply chain disruptions and tension in Ukraine, the inflation among major items including energy, commodity, and food surged to very high levels.

The rising food cost subsequently led to a deteriorating margin for the F&B industry. Looking into the underlying Composite Consumer Price Index in Hong Kong, food prices increased relatively fast by 3.8% in the calendar year of 2022, while the prices of basic food, within the food prices category, rose by 4.5% as a result of the supply of certain food items from Mainland China being hit by a transportation disruption during the pandemic. Prices of meals out and takeaway food also rose by 3.4%.

In the first three quarters of FY2023, Hong Kong and Mainland China markets were still heavily impacted by the COVID-19 prevention measures, which broke the consumers' habits, and hence the overall sales volume. The consumer sentiment further worsened under the backdrop of substantial inflation in food and operating costs. In the case of Hong Kong, the market suffered from the lingering effect of the 5th wave of the COVID-19 pandemic that started in early 2022. Despite full dine-in services being resumed in May 2022, the prolonged suspension and the continual high number of infected cases have created notable damage to consumer confidence and changes to consumer behaviour.

Overall, as suggested by the Census & Statistics Department of the government of HKSAR, the value of total receipts of the restaurant sector in Hong Kong in the calendar year of 2022 was estimated to be HK\$86.8 billion, decreasing by 6.4% in value and 9.5% in volume compared with the calendar year of 2021. Total receipts of fast-food shops also decreased by 2.0% in value and 5.3% in volume.

行業概況

二零二三財政年度對全球經濟及飲食業而言仍然是荊棘滿途。

在整個二零二三財政年度，外部因素對商品及服務帶來顯著價格壓力。在疫情引發的供應鏈中斷及烏克蘭緊張局勢雙重影響下，主要項目包括能源、商品及食品等的通脹飆升至極高水平。

食品成本不斷上漲，飲食業的利潤率每況愈下。綜觀香港的相關綜合消費物價指數，食品價格於二零二二曆年增長較快，達到3.8%，而食品價格類別中，基本食品價格上升4.5%，原因是中國內地若干食品供應在疫情期間受到運輸中斷的影響。外用餐及外賣食品的價格亦上升3.4%。

於二零二三財政年度首三季度，香港及中國內地市場仍然受到COVID-19防疫措施的嚴重衝擊，消費者習慣，以至整體銷量均受影響。在食品及經營成本大幅上漲的背景之下，消費氣氛進一步轉淡。香港方面，市場受到二零二二年初開始的第五波COVID-19疫情所持續影響。儘管二零二二年五月已全面恢復堂食服務，但實施多時的暫停堂食措施以及持續高企的染疫宗數已重挫消費者信心，並改變了消費者的行為。

整體而言，根據香港特區政府統計處的數據顯示，二零二二曆年香港餐飲業的總收益價值估計為868億港元，與二零二一曆年相比，價值下跌6.4%，數量下跌9.5%。快餐店的總收益在價值及數量上分別下跌2.0%及5.3%。

MANAGEMENT DISCUSSION AND ANALYSIS

BUSINESS OVERVIEW

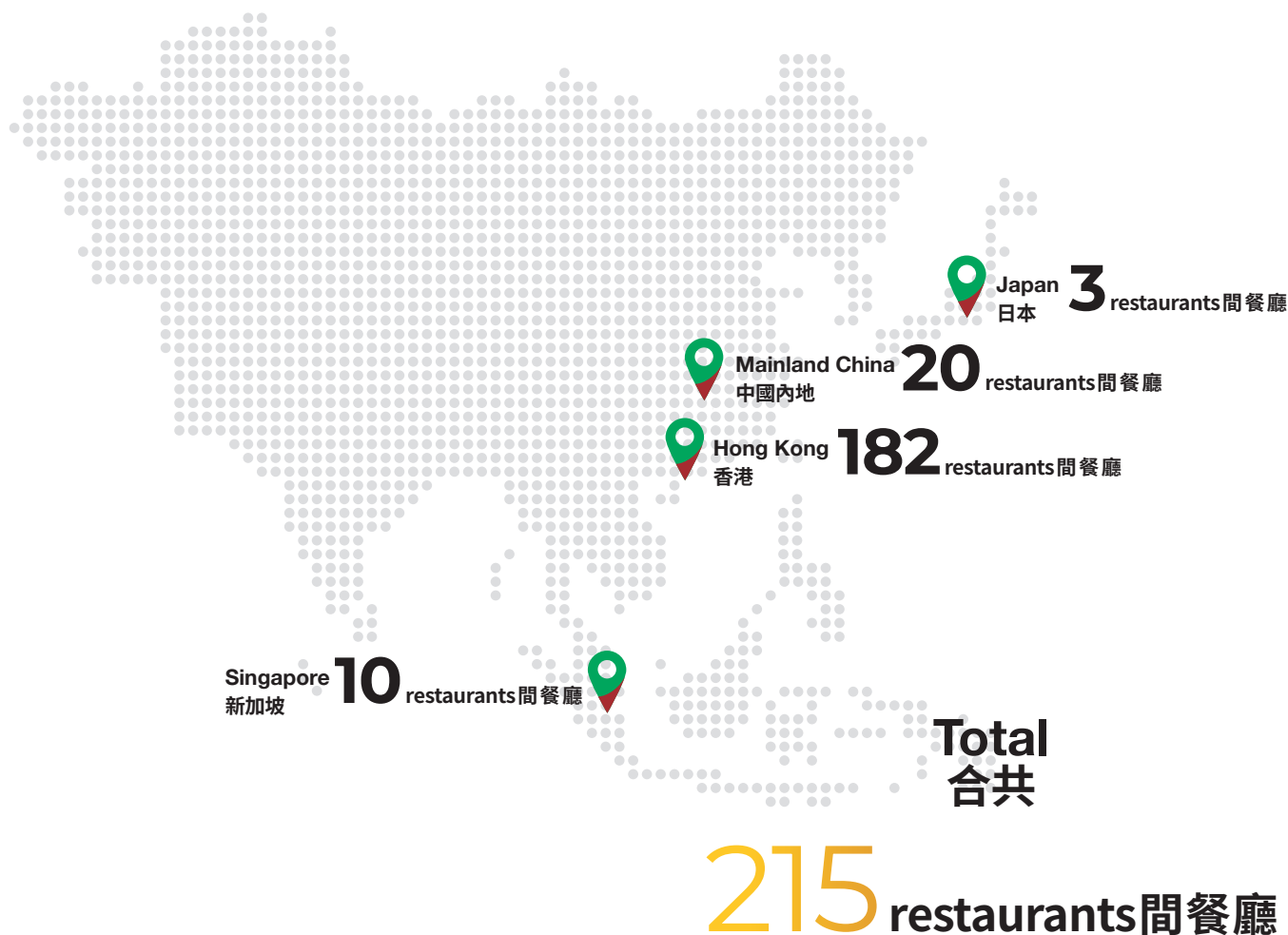
Throughout FY2023, global economy is experiencing a broad based slowdown even after the relaxation of COVID-19-related restrictions and the re-opening of borders across regions, hence, we slowed down our pace in the overseas expansion plan and eventually met our opening target in Hong Kong and cautiously opened 20 restaurants across Mainland China, Singapore and Japan in total in FY2023. As at 31 March 2023, we had a total of 215 restaurants across Hong Kong, Mainland China, Singapore and Japan. For FY2023, our revenue reached HK\$2,594.6 million, a 14.0% year-on-year increase as compared to the financial year ended 31 March 2022 (“FY2022”) (FY2022: HK\$2,275.3 million). The revenue increase was mainly driven by restaurant network expansion.

Profit of the year was HK\$141.0 million in FY2023 (FY2022: HK\$203.0 million). Basic earnings per share were HK10.5 cents in FY2023 (FY2022: HK17.5 cents).

業務概況

於整個二零二三財政年度，在COVID-19相關限制措施放寬及各地區邊境重開後，全球經濟仍在經歷廣泛性衰退，我們減慢了海外擴展計劃的步伐，但最終也達致香港的開店目標，於二零二三財政年度，我們謹慎地在中國內地、新加坡及日本合共開設了20間餐廳。於二零二三年三月三十一日，我們在香港、中國內地、新加坡及日本共有215間餐廳。於二零二三財政年度，我們的收益達2,594.6百萬港元，與截至二零二二年三月三十一日止財政年度（「二零二二財政年度」）比較，同比增加14.0%（二零二二財政年度：2,275.3百萬港元）。收益增加主要受餐廳網絡擴展帶動。

二零二三財政年度的年內溢利為141.0百萬港元（二零二二財政年度：203.0百萬港元）。二零二三財政年度的每股基本盈利為10.5港仙（二零二二財政年度：17.5港仙）。



Regional Analysis – Hong Kong

During the first three quarters of FY2023, our business performance in Hong Kong was inevitably impacted by the lingering effect of the 5th wave of COVID-19 pandemic and the related social distancing measures, in addition to the adverse consumer sentiment due to the economic downturn and the increasing operating costs caused by inflation. Nonetheless, as we entered the last quarter of FY2023 with the lifting of all social distancing measures and the reopening of border, our business in Hong Kong started picking up gradually, as evidenced by the improvement in our comparable restaurants' revenue performance. Our comparable restaurant revenue decreased by 9.0% in the first half of FY2023 as compared to the same period in FY2022, and decreased only by 2.2% in the full FY2023 as compared to FY2022 as our performance improved in the second half of FY2023.

As highlighted in our Prospectus, our business expansion strategy in Hong Kong was to tap into the potential locations through new restaurant openings, and continued to strengthen our restaurant network in order to grasp the opportunities from the post-COVID-19 era. During FY2023, we opened 20 new restaurants in Hong Kong across shopping malls, commercial and residential areas. These new restaurant openings should complement our existing network, laying a solid foundation for further recovery in FY2024.

區域分析 – 香港

於二零二三財政年度首三個季度，我們在香港的業務表現難免受到第五波COVID-19疫情及相關社交距離措施所持續影響，加上經濟低迷導致負面消費者情緒，以及經營成本因通脹而有所增加。然而，踏入二零二三財政年度最後一季，隨著所有社交距離措施取消及邊境重開，我們在香港的業務開始逐步回升，證諸於可比較餐廳的收入改善。二零二三財政年度上半年的可比較餐廳收入較二零二二財政年度同期減少9.0%，惟隨著二零二三財政年度下半年的業績改善，二零二三財政年度全年較二零二二財政年度僅減少2.2%。

誠如招股章程所述，我們在香港的業務擴張策略為透過開設新餐廳進軍潛在地區，並持續鞏固我們的餐廳網絡，以把握後COVID-19時代的機遇。於二零二三財政年度，我們在香港不同商場、商業及住宅區開設20間新餐廳。該等新開設的餐廳將補充我們現有的網絡，為二零二四財政年度的進一步復甦奠定堅實的基礎。

Although it is under adverse market conditions, we are still active and innovative in our marketing and promotional campaigns to drive sales and hence profits, such as the official launch of the mobile apps of SamGor and TamJai, which could help to drive customers' engagement and repeated consumption. Various tactical promotion campaigns and value combo offers were also carried out to enhance foot traffic and boost sales. To mitigate the impact of the rising cost of operations, our new mobile ordering function allowed us to enhance our staff efficiency. New upselling products launched all year round, such as Braised Pork Cartilage Flat Noodles and charred pepper & spices soup (Sha Sha Soup), together with the introduction of premium toppings, new snacks, and drinks, also helped us manage our food cost more effectively and hence achieve a better gross margin.

Regional Analysis — Mainland China

In Mainland China, our business was severely impacted by the strict COVID-19 measures and lockdowns in major cities. Our restaurants were inevitably affected and were closed for a total of 76 operation days under the restrictions of the COVID-19 measures, leading to a drop in our business performance in FY2023 unavoidably. We also suspended our expansion plan in the second half of FY2023 as a result of the uncertain market environment. Nonetheless, we remained confident in the prospect of the Mainland China market, given the gradual improvement in the financial performance in the last quarter of FY2023 since the lifting of social distancing measures and border restrictions.

Upon reflecting on the uncertain situation under COVID-19, we also carefully reviewed our pipeline and have since further refined our expansion strategy in Mainland China by accelerating the penetrations into the tier 2 cities in the Greater Bay Area ("GBA"), where operating costs are lower and competition is less severe. We will close down two under-performing restaurants, in which they are located in the newly developed zone and its traffic was badly disrupted by COVID-19, in the first quarter of FY2024 to centralise our resources and enhance efficiency. During FY2023, 12 new restaurants were opened across Shenzhen, Guangzhou, Dongguan, and Zhongshan.

雖然市況艱難，我們仍然積極推出創新的市場營銷及推廣活動以推高銷售及利潤，例如正式推出三哥及譚仔手機應用程式，有助推動顧客參與及重臨消費。我們亦進行多項策略性宣傳活動及推出超值套餐以帶動客流量及提高銷售。為紓緩營運成本上升所帶來的影響，手機訂餐的新功能讓我們提高員工效率。全年推出提高銷售的新產品，例如濃汁豬軟骨寬麵及焗辣湯(砂砂湯)，同時引入優質配料、新款小食及飲品，均有助我們有效管理食品成本，從而達致較佳的毛利率。

區域分析 — 中國內地

在中國內地，我們的業務受到主要城市嚴格的COVID-19措施及封控所嚴重影響。我們的餐廳亦難以倖免，在COVID-19措施的限制下，總共關閉了76個營業日，導致我們於二零二三財政年度的業務表現無可避免地下降。由於不確定的市場環境，我們亦於二零二三財政年度下半年暫停擴充計劃。儘管如此，鑑於二零二三財政年度最後一季的財務表現自社交距離措施及邊境限制取消起逐步改善，我們對中國內地市場的前景仍充滿信心。

經考慮COVID-19的不確定情況，我們亦已審慎檢視籌劃中的餐廳，並進一步完善中國內地的擴充策略，加快打入經營成本較低、競爭較少的大灣區二線城市(「大灣區」)。我們將在二零二四財政年度首季關閉兩間業績不佳的餐廳(該等餐廳均位於新開發區而當地人流已因COVID-19而遭受嚴重干擾)，以集中資源，提高效率。於二零二三財政年度，我們於深圳、廣州、東莞及中山開設12間新餐廳。

Apart from those value promotions and menu price adjustments to mitigate the impact caused by the COVID-19-related restrictions, we continued our brand building and customer engagement campaigns through social media promotion on several platforms, including TikTok (抖音) and Xiaohongshu (小紅書), to raise our brand awareness in the local market. Our online and offline marketing campaigns also showed promising engagement, with notable success from our “Cordyceps Flower & Chicken Roll Mixian” food-tasting promotion campaign (“蟲草花雞卷米線”霸王餐活動) in April 2022 and TamJai membership top-up card (譚仔米線會員充值有禮活動) in February 2023. Despite the tremendous operational challenges, we implemented cost control initiatives across staff management, overheads and capital expenditure, and restaurant-level operational efficiency enhancement. We also exerted our purchasing power to localise our products sourcing, which became local features dishes and being well received by customers, such as Chongqing Sour & Spicy soup with Pork cartilage and Enoki Mushroom (豬軟骨金針菇花椒重慶酸辣湯米線) .

Regional Analysis — Singapore

In Singapore, despite the notable recovery in our business performance in the first half of FY2023, our recovery was interrupted by the local labour shortage in the second half of FY2023, and that unavoidably hindered our pace of growth. Despite this, our average daily number of bowls served per seat for FY2023 increased by 32.1% to 3.7 compared with FY2022 (FY2022: 2.8). Together with our six new restaurants opening, our revenue in Singapore reached HK\$64.2 million in FY2023, representing a 149.8% year-on-year increase when compared with FY2022.

As the economic hub in Southeast Asia, we continued to see Singapore as an important market for building brand and enhancing brand awareness. During FY2023, we cooperated with a food delivery platform in Singapore as the additional food aggregator, enabling us to expand our customer base in new areas. In addition to the traditional restaurant model, we also explored alternative models such as the express model, intending to boost operational efficiency. By establishing these alternative models, we aim at striking a balance to maintain staff cost control, reasonable capital expenditure investment, and growth momentum.

除了以價值提升活動及調整菜單價格減輕COVID-19相關限制所帶來的影響外，我們通過在抖音及小紅書等多個平台上的社交媒體推廣，持續進行品牌建設及客戶參與活動，以提高我們在當地市場的品牌知名度。我們的線上和線下市場營銷活動亦反應熱烈，二零二二年四月舉辦的「蟲草花雞卷米線」霸王餐活動及二零二三年二月舉辦的「譚仔米線會員充值有禮活動」大獲好評。儘管面臨巨大經營挑戰，我們在員工管理、日常開支及資本支出方面實施成本控制措施，並提升餐廳層面營運效率。我們亦利用自身的採購力，在產品採購上貼近本土口味，成為本地特色小菜，深受顧客歡迎，例如「豬軟骨金針菇花椒重慶酸辣湯米線」。

區域分析 — 新加坡

在新加坡，儘管我們的業務表現於二零二三財政年度上半年顯著復甦，但於二零二三財政年度下半年，當地勞動力短缺令我們的復甦受到干擾，無可避免地阻礙了我們的增長步伐。儘管如此，與二零二二財政年度相比，日均每座位售出碗數於二零二三財政年度增加32.1%至3.7（二零二二財政年度：2.8）。加上我們開設六間新餐廳，我們在新加坡的收益於二零二三財政年度達到64.2百萬港元，與二零二二財政年度相比，同比增長149.8%。

作為東南亞的經濟中心，我們繼續將新加坡視為打造品牌及提高品牌知名度的重要市場。於二零二三財政年度，我們與新加坡外送平台合作，該平台作為額外的外賣到戶營銷商，使我們能夠在新的地區擴大客戶群。除了傳統的餐廳模式外，我們亦探索替代模式，如便捷模式，旨在提高營運效率。通過建立該等替代模式，我們旨在取得平衡，以保持員工成本控制、合理的資本支出投資及增長勢頭。

管理層討論及分析

On marketing, we replicated our success story of the campaign “KOL Bowl” from FY2022 by engaging 10 key opinion leaders (KOLs) in FY2023 to recommend their favourite mixian combinations in our restaurants to further expand our market presence and fanbases. We also introduced several promotion plans, including the limited edition SamGor Mahjong Set for online and offline giveaways. The campaign gained great popularity on Facebook and Instagram.

Regional Analysis – Japan

In Japan, our business performance during FY2023 was hindered by the spike in COVID-19 cases in Tokyo and was pulled down by the higher-than-expected capital expenditures and operating costs.

We opened two new restaurants in Japan during FY2023, to complete the first phase of the market entry. For the first year, we focused on establishing products and service quality, improving operational efficiencies and nurturing our brand culture internally, and building brand awareness and understanding to the market. We launched a series of branding and promotion campaigns in FY2023, including the “Spicy Challenges” campaign in August and September 2022, in an attempt to portray SamGor as an exotic alternative noodle option for Japanese consumers. We have also partnered with a food delivery platform in a bid to generate incremental revenue since the last quarter of FY2023 which received positive responses.

Looking ahead, we will continue our adaption to the local culture and preferences, while exploring new sales channels and enhancing operational efficiency, to boost our performance in the Japan market.

在市場營銷方面，我們複製了二零二二財政年度「KOL Bowl」活動的成功事例，於二零二三財政年度聘請10位關鍵意見領袖(KOL)推介其最喜愛的譚仔米線組合，以進一步擴大我們的市場佔有率及粉絲群。我們亦推出了多個推廣計劃，包括用作線上線下活動贈品的限量版三哥麻將套裝。該活動在Facebook及Instagram上大受歡迎。

區域分析 – 日本

在日本，我們於二零二三財政年度的業務表現受阻於東京COVID-19個案激增，並被高於預期的資本支出及經營成本所拉低。

我們於二零二三財政年度在日本開設兩間新餐廳，以完成打入市場的第一階段。於第一年，我們專注於建立產品及服務品質，提高營運效率，在內部培育品牌文化，並建立品牌知名度及對市場的了解。我們於二零二三財政年度推出一系列品牌建設及推廣活動，包括二零二二年八月及九月的「麻辣挑戰」活動，試圖將三哥描繪成日本消費者的異國替代麵條選擇。自二零二三財政年度最後一季以來，我們亦與外送平台合作，以期創造增量收益，反應理想。

展望未來，我們將繼續適應當地文化及偏好，同時探索新的銷售管道及提高營運效率，以提升我們在日本市場的表現。

OPERATION HIGHLIGHTS

Restaurant Network Expansion

In FY2023, we implemented a prudent yet well-managed expansion plan, by opening 20 new restaurants in Hong Kong, 12 in Mainland China, six in Singapore, and two in Japan, strengthening our foothold across different regions and countries. As a result, we have a total of 215 restaurants across the world as of 31 March 2023. In FY2024, we will continue to open new restaurants in strategic locations, allowing us to increase market penetration and enhance brand awareness in the local markets.

Supply Chain Management

According to the Census & Statistics Department of the government of HKSAR, food costs in Hong Kong inflated by 3.8% in the calendar year of 2022. The inflation inevitably affected our operating margin, with our food cost as a percentage of operation increased by 1.1 percentage points to 23.9% in FY2023 as compared with FY2022.

In response to the global price hike on food costs, we have expanded our supplier network, and increased the proportion of direct and localised food supply, which can effectively lower the transportation cost and lead time as well as minimise the risk of logistic disruption. In addition, we have also partnered with selected original equipment manufacturer suppliers in the regions we operated for bulk purchases, to strengthen our cost and supply chain control.

The development of new products and combo menus was also in full swing, which would give us up-selling opportunities to mitigate increasing costs. The SCM system was implemented to monitor the flow and cost of food and beverages consumed across the Group; menu enhancement and price adjustments were also carried out to mitigate cost inflation pressure. We are also looking to improve our SCM system flow further and invest in automation technologies, in order to enhance our operational efficiency and strengthen our grip on the supply chain to support our future expansion.

經營摘要

餐廳網絡拓展

於二零二三財政年度，我們實施審慎而完善的擴張計劃，在香港、中國內地、新加坡及日本分別開設20間、12間、六間及兩間新餐廳，加強我們在不同地區及國家的據點。因此，截至二零二三年三月三十一日，我們在全球共有215間餐廳。於二零二四財政年度，我們將繼續在策略性地點開設新餐廳，冀能在當地市場增加市場滲透率及提高品牌知名度。

供應鏈安排

根據香港特區政府統計處的數據，香港食品成本於二零二二曆年上漲了3.8%。該漲幅不可避免地影響我們的經營利潤，導致我們於二零二三財政年度的食品成本佔經營百分比比較二零二二財政年度增加1.1個百分點至23.9%。

為應對全球食品成本價格上升，我們擴大供應商網絡，增加直接及本地食品供應比例，從而有效降低運輸成本及交貨時間，並將物流中斷的風險降至最低。此外，我們亦與我們經營地區的選定代工生產供應商合作，進行集體採購，加強成本及供應鏈控制。

新產品及套餐菜單的開發工作亦正全力進行，有助我們提高銷售，減輕成本上漲。我們已推行SCM系統，以監察集團所使用食品及飲料的成本及流程，同時進行菜單改進及價格調整，以減輕成本通脹壓力。我們亦冀能進一步改善SCM系統流程，並投資自動化技術，以提高營運效率及加強對供應鏈的控制，從而支持未來擴張。

Staff Cost Management

During FY2023, despite the increasing number of COVID-19-related sick leaves taken by our employees and the general increase in staff pay and benefits, we still managed to maintain a stable staff cost level at 31.9% of revenue (FY2022: 31.8%), attributable to our smart rostering system and our agile recruitment strategy by hiring more part-time employees that could offer us greater flexibility. On the other hand, we also continued our investment in staff training by setting up a new training centre in Shenzhen, which will further enhance our manpower efficiency in the long term.

Corporate Social Responsibility Initiatives and Sustainability

During FY2023, we continued to show our commitment to corporate social responsibility. Apart from placing donation boxes at TamJai and SamGor stores for charitable organisations including UNICEF, Lok Sin Tong, and the St. James Settlement, we have also organised an ongoing charity event, “Mixian for the Good – one step further” (「線」有善報 – 行多一步), which delivers Mixian to a specific charity.

We also organised the first-ever charitable NFT, “Souper Hero”, by collaborating with local illustrators. All the net proceeds were donated to support the “Out of the Cube” project of the Hong Kong Art Centre, nurturing homegrown artists and supporting the development of the local art industry.

員工成本管理

於二零二三財政年度，儘管員工提取與COVID-19有關的病假數目增加，且員工工資及福利整體增加，我們仍能夠將員工成本佔收益的百分比維持在31.9%（二零二二財政年度：31.8%）的相若水平，這有賴我們的智能排班制度及靈活的招聘策略，通過聘請更多兼職員工，為我們提供更大的靈活性。另一方面，我們亦繼續對員工培訓投入資源，在深圳新開設了培訓中心，進一步提升我們長遠的人手效益。

企業社會責任舉措及可持續發展

於二零二三財政年度，我們繼續展現對企業社會責任的承諾。除了在譚仔及三哥店舖放置聯合國兒童基金會、樂善堂及聖雅各福群會等慈善機構的捐款箱外，我們亦舉辦一個持續的慈善活動「『線』有善報 – 行多一步」，將米線送到特定慈善機構。

我們亦與本地插畫師合作推出首創的慈善NFT「Souper Hero」。收益淨額已全數捐出支持香港藝術中心的「埋嚟學Out of the Cube」項目，以培養本土藝術家，支持本地藝術產業的發展。

Besides, we have extended the “TJI Education Support Scheme for Employees’ Children” to the Group level, with the support from TamJai Goodness Trust. We have increased the amount of scholarship from HK\$1.0 million to HK\$3.0 million with total recipients being increased to 60, which would finance the education needs of these recipients while contributing to business and society’s sustainability.

In order to promote and educate our team on the importance of sustainability, we have conducted a sustainability week enriching the understanding of and the efforts everyone could put to various sustainable campaigns and initiatives. We received excellent responses from our employees in this campaign.

Brand Building and Customer Loyalty

In Hong Kong, we have successfully developed a playful and approachable brand image with a twist of unique Hong Kong culture, especially focusing on youngster consumers who prefer diversified comfort-food choices with great value for money. To further reinforce our image and positioning, we developed the Lunar New Year Combo Set in collaboration with the movie that was aired during the Chinese New Year holiday, “Everything Under Control”, starring Hong Kong pop star Hins Cheung in January 2023. Besides, we have also organised the first-ever collaboration with Hins Cheung and girl groups from our brands, namely TamJai Girl Group (勿演女笙) of TamJai and “SamGirls” of SamGor, for introducing the launch of our mobile apps “TamJai Myxian Club” (“譚仔MY線會”) and “SamGor Spicy Club” (“三哥辛派”), as part of our enhanced CRM program that was aimed at further strengthening our customers engagement and brand stickiness. To be part of the recent development of NFT, our first-ever Charitable NFT, “Souper Hero”, was also launched during FY2023, receiving a 10-times over-subscription during the whitelisting stage.

此外，我們已將「譚仔國際員工子女教育支援計劃」擴展至本集團層面，並得到譚仔美善基金支持。我們將獎學金的金額由1.0百萬港元增加至3.0百萬港元，獲獎者總數增加至60人，將為該等獲獎者的教育需求提供資助，同時為企業及社會的可持續發展作出貢獻。

為了促進及教育我們的團隊理解可持續發展的重要性，我們開展可持續發展週，豐富了對各種可持續發展活動及企劃的認知及每個人能為其付出的努力。我們在該活動中得到員工的熱烈響應。

品牌建設及客戶忠誠度

在香港，我們已經成功建立創意出位及貼地的品牌形象，並揉合獨特的香港文化，尤其聚焦年輕消費者對選擇多樣及物有所值的舒心輕食的追捧。為了進一步加強我們的形象及定位，我們於二零二三年一月聯乘香港明星張敬軒主演的賀歲電影《超神機械劫案下》，推出農曆新年套餐。此外，我們亦首次覓得張敬軒與我們旗下品牌的女團，即譚仔「勿演女笙」及三哥「SamGirls」合作，介紹我們推出的手機應用程式「譚仔MY線會」及「三哥辛派」，作為我們加強CRM計劃的一部分，旨在進一步加強我們的顧客參與度及品牌粘性。因應近期NFT發展，我們首創的慈善NFT「Souper Hero」亦於二零二三財政年度推出，在白名單階段獲得了10倍的超額認購。

Riding on the trend of a healthy diet, we have also launched the “So Green” campaign in June 2022, introducing vegetarian menu at both SamGor and TamJai with a wide variety of plant-based options for our customers, including OmniPork & Celery Dumplings with Cordyceps, Impossible™ Minced Pork Sauce. The new additions allow us to cater to the needs of vegetarians, and enhance their loyalty to our brands.

Outside Hong Kong, we also completed a series of brand-building events to boost brand awareness, which were a great success. These events include Chinese New Year celebration with TamJai (譚仔陪你過大年) and “TamJai Mascot” Design Competition (“譚仔金碗獎”譚仔米線品牌IP設計大賽) in Mainland China, and 2nd Double Hell Fire Challenge Eating Competition in Singapore. In Japan, apart from the promotion events such as the introduction of Hong Kong Night menu to promote our brand’s culture, we also rode on some social media platforms such as Line to engage our customers in the local market.

PROSPECT

Our business in Hong Kong will continue to be our key revenue and profit driver for the Group and we expect our business will continue the recovery brought forward from the last quarter of FY2023 when all border restrictions and social distancing measures were lifted. As we are committed to sustaining our prominent brand value in Hong Kong, we will continue to input great amounts of resources to enhance our product quality and service quality, deliver exceptional dining experience through our digitalization journey and innovative products development, which will become business value in return, and will get closer to our customers.

For our Mainland China market, we believe that the revenue performance will be lifted up after the border re-opening and the relaxation of COVID-19-related restrictions, as demonstrated by the notable improvement in the last quarter of FY2023. We have also accelerated the process to resume the expansion plan in the GBA region and will implement various marketing campaigns to capture the opportunities from the stabilizing economy in FY2024.

乘著健康飲食的潮流，我們亦於二零二二年六月推出「So Green素tasty!」企劃，在三哥及譚仔引入素食餐單，為顧客提供多種植物性選擇，包括蟲草Omni新豬肉芹菜餃子、Impossible™植物豬肉乍醬。新增加的餐單能夠迎合素食者的需要，提高彼等對我們品牌的忠誠度。

在香港以外地區，我們亦已完成一系列提高品牌知名度的品牌建設活動，並取得圓滿成功。該等活動包括在中國內地舉辦的「譚仔陪你過大年」及「譚仔金碗獎」譚仔米線品牌IP設計大賽，以及在新加坡舉辦的第二屆雙倍地獄火挑戰吃貨大賽(2nd Double Hell Fire Challenge Eating Competition)。在日本，除了推出「香港之夜」餐單等宣傳活動以推廣品牌文化外，我們亦藉著部分社交媒體平台(例如Line)與當地市場的顧客互動。

前景

我們在香港的業務仍為本集團收益及利潤的主要推動力，我們預計我們的業務將繼續保持從二零二三財政年度最後一季所有邊境限制及社交距離措施取消後帶來的復甦。由於我們致力維持香港卓著的品牌價值，我們將繼續投放大量資源，以提高產品及服務品質，透過我們數碼化旅程及新穎的產品開發，提供獨特的餐飲體驗，從而成為業務價值，與顧客關係更為親密。

對於中國內地市場，我們相信在邊境重開及COVID-19相關限制措施放寬後，收益表現將得到提升，從二零二三財政年度最後一季的顯著改善可見一斑。我們亦加快步伐恢復在大灣區的擴張計劃，並將在二零二四財政年度實施各種市場營銷活動，以抓住經濟回穩帶來的機遇。

We also look to revamp our business operations in Singapore and Japan, as we are still in the process of enhancing the operational efficiency and service quality while adapting our brand into the local markets.

Outside of our existing presence, we will also look to expand into other potential markets, such as the western market, to expand our business footprint further and derive greater synergies and efficiency. We will explore the possibility of strategic collaborations with local partners, to help us to tap into those markets, by leveraging their local experience and resources. We are targeting to open approximately 50 new restaurants across regions in FY2024.

Despite the challenges caused by the worsening economic environment and the pandemic, we have shown a high sense of agility in our operations to cope with the uncertainties, and demonstrated our commitment of investing into brand building and systems enhancement to optimise our business processes. Now as we see light at the end of the tunnel, with the solid foundation we established, we are more than prepared for the business opportunities while we are on the road to market recovery.

PERFORMANCE OF RESTAURANT OPERATIONS

To supplement the consolidated statement of profit or loss presented in accordance with Hong Kong Financial Reporting Standards (“HKFRSs”), we also use operating profit and operating profit margin which are not required by, or presented in accordance with, HKFRSs. These supplemental measures will be helpful for the management, the investors and other interested parties to assess the profitability of our business operation. Although some of these financial measures are reconcilable to the line items in our consolidated statement of profit or loss as reported under HKFRSs, the use of the non-HKFRS financial measures has limitations as an analytical tool, and shareholders of the Company (the “Shareholder(s)”) and potential investors should not consider them in isolation from, or as a substitute for or superior to analysis of, our results of operations or financial conditions as reported under HKFRSs. Furthermore, these financial measures may not be comparable to other similarly titled measures used by other companies.

我們亦力求改進我們在新加坡及日本的業務運營，因為我們仍在提高營運效率及服務品質，同時將我們的品牌融入當地市場。

除了我們的現有業務外，我們亦冀擴展到其他潛在市場，如西方市場，以進一步擴大我們的業務足跡，並獲得更大的協同效應及效率。我們將探討與當地合作夥伴開展策略性合作的可能性，借助彼等的當地經驗及資源，助力我們開拓該等市場。我們目標於二零二四財政年度於不同地區開設約50間新餐廳。

儘管經濟環境惡化及疫情帶來挑戰，但我們在營運中表現出高度靈活性，以應對不確定性，並體現出我們投資於品牌建設及系統改進的承諾，以優化我們的業務流程。如今我們終於窺見一線曙光，在已建立的堅實基礎上，我們已經準備就緒把握市場復甦路上出現的商機。

餐廳經營業績

為了補充根據香港財務報告準則（「香港財務報告準則」）呈列的綜合損益表，我們亦使用經營利潤及經營利潤率，其並非香港財務報告準則所規定或根據香港財務報告準則所呈列。該等補充性計量將有助於管理層、投資者及其他利益相關方評估我們業務營運的盈利能力。雖然部分該等財務計量可與我們根據香港財務報告準則所呈報綜合損益表內的項目對賬，但使用非香港財務報告準則財務計量作為分析工具具有局限，故本公司股東（「股東」）及潛在投資者不應將其與根據香港財務報告準則呈報的經營業績或財務狀況的分析獨立考慮該等計量或作為該等分析的替代或視為優於該等分析。此外，該等財務計量未必能夠與其他公司使用的其他名稱類似的計量相比較。

The operating profit margin of our restaurant operations decreased from 20.9% in FY2022 to 17.2% in FY2023, mainly due to (i) increase in cost of food and beverages consumed as a percentage of revenue as a result of food cost inflation; (ii) increase in our handling charges as a percentage of revenue due to a less favorable rate offered by the delivery platforms in FY2023; (iii) increase in our depreciation of right-of-use assets, rental and related expenses as a percentage of revenue owing to the higher portions of new restaurants and the unfavorable sales performance in FY2023; and (iv) increase in advertising and promotion expenses as a percentage of revenue because of the market entry advertising cost in Japan as well as general increase in the marketing and branding expenditure in Mainland China, Singapore and Hong Kong.

FINANCIAL REVIEW

Revenue

Our revenue increased by 14.0% from HK\$2,275.3 million in FY2022 to HK\$2,594.6 million in FY2023. The increase was primarily due to the increase in the number of restaurants in operation.

Cost of food and beverages consumed

Our cost of food and beverages consumed increased by 19.7% from HK\$518.3 million in FY2022 to HK\$620.3 million in FY2023, which was mainly due to the expansion of our restaurant operation and food cost inflation. Our cost of food and beverages consumed as a percentage of revenue was 22.8% and 23.9% in FY2022 and FY2023, respectively.

Other net income

Our other net income increased significantly from HK\$57.7 million in FY2022 to HK\$74.0 million in FY2023, primarily attributable to the increase in interest income from bank deposits in FY2023. Included also in other net income was government subsidies mainly for easing the impact of COVID-19 of HK\$54.8 million and HK\$53.7 million in FY2022 and FY2023, respectively.

收益

其他淨收入

我們的其他淨收入由二零二二財政年度的57.7百萬港元大幅增加至二零二三財政年度的74.0百萬港元，主要由於二零二三財政年度的銀行存款利息收入增加。其他淨收入亦包括二零二二財政年度及二零二三財政年度主要用於紓緩COVID-19影響的政府補貼，分別為54.8百萬港元及53.7百萬港元。

Staff costs

Our overall staff costs (including restaurant, central kitchen and headquarters and offices staff) increased by 14.6% from HK\$722.8 million in FY2022 to HK\$828.6 million in FY2023, which was primarily due to (i) the effect from the increase in restaurant headcount due to the expansion of restaurant network; and (ii) the effect from the increase in headquarters and offices headcount coping with the expansion in Mainland China, Singapore and Japan markets. Our staff costs as a percentage of revenue was 31.8% and 31.9% in FY2022 and FY2023, respectively.

Our depreciation of owned property, plant and equipment increased by 33.4% from HK\$92.2 million in FY2022 to HK\$123.0 million in FY2023, mainly attributable to the increase in the number of our restaurants and also the enhancement in our central kitchen in FY2023.

Consumables and packaging

Our consumables and packaging increased by 19.8% from HK\$63.0 million in FY2022 to HK\$75.5 million in FY2023, primarily attributable to the increase in the volume of our takeaway and delivery orders. Our consumables and packaging as a percentage of revenue was 2.8% and 2.9% in FY2022 and FY2023, respectively.

Utilities expenses

Our utilities expenses increased by 37.9% from HK\$53.0 million in FY2022 to HK\$73.1 million in FY2023, mainly attributable to the increase in the number of our restaurants and the increase in charge rate in Hong Kong, Singapore and Japan during FY2023. Our utilities expenses as a percentage of revenue was 2.3% and 2.8% in FY2022 and FY2023, respectively.

水電開支

Advertising and promotion

Our advertising and promotion expenses increased by 30.9% from HK\$46.6 million in FY2022 to HK\$61.0 million in FY2023, primarily attributable to the new market entry brand awareness building and public relations campaigns and promotions in Japan, higher marketing cost in Singapore and Mainland China for the investments in brand building, as well as general increase in the marketing and branding expenditure in Hong Kong.

Other expenses

Our other expenses increased by 39.1% from HK\$51.1 million in FY2022 to HK\$71.1 million in FY2023, mainly attributable to the increase in the number of our restaurants and headquarters and office expansion.

Finance costs

Our finance costs mainly represented the interest on lease liabilities recognised in accordance with HKFRS 16 associated with our leases. The increase by 27.4% from HK\$14.9 million in FY2022 to HK\$18.9 million in FY2023 was due to the expansion of our restaurant network during FY2023.

Income tax expense

Our income tax expense decreased from HK\$42.1 million in FY2022 to HK\$35.1 million in FY2023, which was generally in line with the decrease in our profit before taxation adjusted for government subsidies, which is non-taxable in nature.

Right-of-use assets

Our right-of-use assets increased from HK\$700.8 million as at 31 March 2022 to HK\$768.6 million as at 31 March 2023 as we entered into more tenancy agreements for our restaurants and offices.

Inventories

Our inventories mainly consist of our food ingredients and beverages consumed in our restaurant operations, including meat, meat balls, offal, vegetables, and mixian. Our inventories increased from HK\$16.0 million as at 31 March 2022 to HK\$23.2 million as at 31 March 2023, mainly attributable to the expansion of our restaurant network. Our inventory turnover days increased from 10.4 days in FY2022 to 11.5 days in FY2023.

Trade and other receivables and deposits and prepayments

Our trade and other receivables and deposits and prepayments included (i) trading balances with our customers with smart card settlement; (ii) cash-in-transit pending to be deposited into our bank accounts held by a secured logistics service provider; (iii) government subsidy receivables; (iv) rental deposits to our landlords and utilities deposits; and (v) prepayments for purchases of fixed assets and prepaid insurance. Our trade and other receivables and deposits and prepayments decreased from HK\$256.1 million as at 31 March 2022 to HK\$215.1 million as at 31 March 2023, mainly due to the decrease in receivables of government subsidies.

融資成本

我們的融資成本主要指根據香港財務報告準則第16條確認的與租賃有關的租賃負債利息。融資成本由二零二二財政年度的14.9百萬港元增加27.4%至二零二三財政年度的18.9百萬港元，乃由於二零二三財政年度擴大餐廳網絡所致。

所得稅開支

我們的所得稅開支由二零二二財政年度的42.1百萬港元減少至二零二三財政年度的35.1百萬港元，整體上與我們就不須課稅的政府補貼而調整的除稅前溢利減幅一致。

使用權資產

我們的使用權資產由二零二二年三月三十一日的700.8百萬港元增加至二零二三年三月三十一日的768.6百萬港元，乃由於我們為餐廳及辦公室訂立了更多租賃協議。

存貨

我們的存貨主要包括我們餐廳營運所使用的食材及飲料，包括肉類、肉丸、內臟、蔬菜及米線。存貨由二零二二年三月三十一日的16.0百萬港元增加至二零二三年三月三十一日的23.2百萬港元，主要由於餐廳網絡擴充所致。存貨週轉天數由二零二二財政年度的10.4天增加至二零二三財政年度的11.5天。

貿易及其他應收款項以及按金及預付款項

我們的貿易及其他應收款項以及按金及預付款項包括(i)與以信用卡結算的客戶的貿易結餘；(ii)一家保安物流服務供應商持有的尚未存入我們銀行賬戶的在途資金；(iii)應收政府補貼；(iv)向業主支付租金按金及水電費按金；及(v)購買固定資產及預付保險的預付款項所致。貿易及其他應收款項以及按金及預付款項由二零二二年三月三十一日的256.1百萬港元減少至二零二三年三月三十一日的215.1百萬港元，主要由於應收政府補貼減少所致。

Trade and other payables and accruals and deposits received

Our trade and other payables and accruals and deposits received included (i) the purchase cost of food ingredients and beverages for restaurant operations; (ii) accrued operating costs of our restaurants, offices and central kitchens; (iii) contract liabilities generated from the loyalty programme and coupons distributed; and (iv) deposits received from the logistics service provider. Our trade and other payables and accruals and deposits received increased from HK\$199.4 million as at 31 March 2022 to HK\$238.4 million as at 31 March 2023, as a result of the expansion of our operations.

Lease liabilities

Our lease liabilities increased from HK\$708.1 million as at 31 March 2022 to HK\$787.8 million as at 31 March 2023, which was mainly due to new tenancy agreements for restaurants entered into by us during FY2023.

Liquidity and financial resources

We principally fund our working capital from internally generated cash flows. As at 31 March 2023, our cash and cash equivalents (representing the cash and bank balances) were HK\$1,375.7 million (31 March 2022 (representing the cash and bank balances and excluding any pledged deposits): HK\$1,365.2 million). The majority of the bank deposits and cash were denominated in Hong Kong dollars.

As at 31 March 2023, we did not have any interest-bearing bank and other borrowings (31 March 2022: Nil). Accordingly, the gearing ratio is not available.

Pledge of assets

As at 31 March 2023, we did not have any pledge of assets (31 March 2022: HK\$1.4 million of cash deposits were pledged to a bank in relation to the bank guarantees to landlords for our leases).

Foreign currency exposures

The Group's revenue and costs are mostly denominated in Hong Kong dollars, Renminbi, Singapore dollars and Japanese Yen. The fluctuations of Renminbi, Singapore dollars and Japanese Yen against Hong Kong dollars may affect the Group's results. The Group does not have any currency hedging policy and has not entered into any hedging or other instrument to reduce currency risks. The Group will continue to closely monitor the foreign currency exposure and take appropriate measures to minimise the risk when necessary.

貿易及其他應付款項以及應計費用及已收按金

我們的貿易及其他應付款項以及應計費用及已收按金包括(i)為餐廳營運購買食材及飲品的成本；(ii)餐廳、辦公室及中央廚房的應計經營成本；(iii)會員計劃及已派發優惠券產生的合約負債；及(iv)來自物流服務供應商的已收按金。貿易及其他應付款項以及應計費用及已收按金由二零二二年三月三十一日的199.4百萬港元增加至二零二三年三月三十一日的238.4百萬港元，乃由於業務擴張所致。

租賃負債

我們的租賃負債由二零二二年三月三十一日的708.1百萬港元增加至二零二三年三月三十一日的787.8百萬港元，主要是由於我們於二零二三財政年度為餐廳訂立了新的租賃協議。

流動資金及財務資源

我們主要以內部產生的現金流量為營運資金撥資。於二零二三年三月三十一日，我們的現金及現金等價物(指現金及銀行結餘)為1,375.7百萬港元(二零二二年三月三十一日(指現金及銀行結餘，並且不包括任何已抵押存款): 1,365.2百萬港元)。大部分銀行存款及現金以港元計值。

於二零二三年三月三十一日，我們並無擁有任何計息銀行及其他借款(二零二二年三月三十一日: 零)。因此，未有提供資本負債比率。

資產抵押

於二零二三年三月三十一日，我們並無任何資產抵押(二零二二年三月三十一日: 就租賃向業主提供銀行擔保而向銀行抵押的1.4百萬港元現金存款)。

外幣風險

本集團的收益及成本大多以港元、人民幣、新加坡幣及日圓計值。人民幣、新加坡幣及日圓兌港元的波動或會影響本集團的業績。本集團並無任何貨幣對沖政策，亦無設立任何對沖或其他工具以降低貨幣風險。本集團將繼續密切監控外幣風險及於必要時採取合適措施降低風險。

Capital commitments

As at 31 March 2023, we had capital commitments of HK\$2.3 million (31 March 2022: HK\$8.4 million).

Contingent liabilities

As at 31 March 2023, we did not have any significant contingent liabilities.

Significant investments held by the Group

There were no significant investments held by us as at 31 March 2023.

Material acquisitions and disposals by the Group

During FY2023, there were no material acquisitions and disposals of subsidiaries, associates and joint ventures.

Future plans for material investments or additions of capital assets

We will continue to focus on our business strategies as set out in the prospectus of the Company dated 23 September 2021 (the “Prospectus”). As at the date of this annual report, save as disclosed in the Prospectus, we have no plan for any other material investments or capital assets.

Employees, remuneration policy and pension scheme

As at 31 March 2023, we had 3,363 employees (31 March 2022: 2,990). The remuneration package of our employees (including full-time and part-time employees) generally includes basic salary, discretionary bonus and incentives, and equity settled share-based payments (eligible employees only). The basic salary is generally based on the particular employee’s work experience, academic and professional qualifications (if relevant) and the prevailing market salary levels. The discretionary bonus and incentives are generally based on, among other things, the financial performance of the Group. The equity settled share-based payments are to motivate and retain eligible employees to optimise their performance efficiency for the benefit of the long term growth of the Group.

We also provided frontline restaurant staff with training in various aspects, such as operational procedures, customer services, cleaning and sanitation, food safety and work safety. Our operations management teams will monitor and supervise our new staff in terms of quality of food and services, hygiene and manpower planning. We also provided our managerial staff with various types of on-the-job training in relation to, among other things, cost control, complaints handling, human resources, environmental, social and governance and legal issues.

Net proceeds from the listing and over-allotment option

The shares of the Company (the “Share(s)”) were listed on the Stock Exchange on 7 October 2021 (the “Listing Date”) following the completion of issue of 335,008,000 new Shares at an offer price of HK\$3.33 per Share. The net proceeds from the Global Offering (as defined in the Prospectus), after deducting the underwriting fees, commissions and other related expenses payable by the Company, amounted to approximately HK\$1,051.0 million (the “Net Proceeds”).

The Company intends to use the Net Proceeds for the purposes as set out in the Prospectus. As at 31 March 2023, an analysis of the utilisation of the Net Proceeds is as follows:

CORPORATE GOVERNANCE PRACTICES

The board of Directors (the “**Board**”) is committed to maintaining high corporate governance standards.

The Board believes that high corporate governance standards are essential in providing framework for the Company to safeguard the interests of Shareholders, enhance corporate value, formulate its business strategies and policies, and enhance its transparency and accountability.

During FY2023, the Company has applied the principles of good corporate governance as set out in Part 2 of the Corporate Governance Code (the “**CG Code**”) contained in Appendix 14 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”).

The Board is of the view that, for FY2023, the Company has complied with all applicable code provisions as set out in the CG Code, except for the deviation from code provision C.2.1 which states that the roles of chairman and chief executive should be separate and should not be performed by the same individual, and the reason for such deviation was further explained under the section headed “Chairman and Chief Executive” in this Corporate Governance Report.

The Board will continue to regularly review and monitor its corporate governance practices to ensure compliance with the CG Code as appropriate and maintain a high standard of corporate governance practice of the Company.

DIRECTORS’ SECURITIES TRANSACTIONS

The Company has adopted the Model Code for Securities Transactions by Directors of Listing Issuers (the “**Model Code**”) set out in Appendix 10 to the Listing Rules as the code of conduct regarding Directors’ dealings in the securities of the Company during FY2023.

Having made specific enquiry of all the Directors, all the Directors confirmed that they have complied with the required standards set out in the Model Code during FY2023.

The Board has also established written guidelines to regulate all dealings by informed persons who are likely to be in possession of inside information in relation to the Company’s securities and unpublished information as referred to code provision C.1.3 of the CG Code.

Responsibilities of the Directors and management

The Board should assume responsibility for leadership and control of the Company and is collectively responsible for directing and supervising the Company's affairs.

The Board directly, and indirectly through its committees, leads and provides direction to management by laying down strategies and overseeing their implementation, monitors the Group's operational and financial performance, and ensures that sound internal control and risk management systems are in place.

董事會直接及間接透過其委員會領導及指導管理層，其工作包括制定策略及監察其執行、監督本集團營運及財務表現，以及確保設有良好的內部監控及風險管理制度。

All Directors, including non-executive Directors and independent non-executive Directors, have brought a wide spectrum of valuable business experience, knowledge and expertise to the Board for its efficient and effective functioning. Through active participation in Board meetings, taking the lead in managing issues involving potential conflict of interest and serving on Board committees, all non-executive Directors (including the independent non-executive Directors) make various contributions to the effective direction of the Company.

The independent non-executive Directors are responsible for ensuring a high standard of regulatory reporting of the Company and providing a balance in the Board for bringing effective independent judgement on corporate actions and operations.

All Directors have full and timely access to all the information of the Company and may, upon request, seek independent professional advice in appropriate circumstances, at the Company's expenses, for discharging their duties to the Company.

The Directors shall disclose to the Company details of other offices held by them.

The Board is responsible for decision-making in all major matters relating to policy matters, strategies and budgets, internal control and risk management, material transactions (in particular those that may involve conflict of interests), financial information, appointment of Directors and other significant operational matters of the Company. The Board has delegated its powers relating to implementing decisions of the Board, directing and coordinating the daily operation and management of the Company to Mr. Lau Tat Man, the chief executive officer of the Company (the "**Chief Executive Officer**").

The Directors shall carry out duties in good faith, in compliance with applicable laws and regulations, and in the interests of the Company and the Shareholders at all times.

Each Director should also have a proper understanding of the Company's operations and business and is fully aware of his responsibilities under statute and common law, the Listing Rules, legal and other regulatory requirements and the Company's business and governance policies.

The Board has clearly set out the circumstances under which the management should report to and obtain prior approval from the Board before making decisions or entering into any commitments on behalf of the Company.

The Board regularly reviews the above said circumstances and ensures they remain appropriate.

The Board has also established mechanisms to ensure independent views and input are available to the Board.

The Board shall at all times comprise at least three independent non-executive Directors that represent at least one-third of the number of members of the Board, such that there is always a strong element of independence on the Board which can effectively exercise independent judgement.

All the Directors, including the independent non-executive Directors, are given equal opportunity and channels to communicate and express their views to the Board and have separate and independent access to the management of the Group in order to make informed decisions. If necessary, independent professional advice will be sought, at the Group's expense, to assist the relevant Directors to discharge their duties. The chairman of the Board will hold meetings with the independent non-executive Directors without the involvement of other Directors at least annually to discuss any issues and concerns.

Any Director or his/her associate who has a conflict of interest in a matter to be considered by the Board will be dealt with by a physical Board meeting rather than by written resolutions. Such Director will be required to declare his/her interests before the meeting and abstain from voting and he/she will not be counted towards the quorum and may not vote on the relevant resolutions. Independent non-executive Directors who, and whose associates, have no interest in the matter should attend the Board meeting.

The Board has reviewed and considered that the mechanisms are effective in ensuring that independent views and input are provided to the Board during FY2023.

The Company has arranged appropriate insurance coverage on Directors' and officers' liabilities in respect of any legal actions taken against Directors and senior management arising out of corporate activities. The insurance coverage would be reviewed on an annual basis. Details of the insurance is discussed in the paragraph headed "Permitted Indemnity" of the "Report of the Directors".

所有董事，包括獨立非執行董事，均有平等機會和渠道與董事會溝通及表達其意見，並且可以單獨和獨立接觸本集團管理層，以在掌握有關資料的情況下作出決定。如有必要，將尋求獨立的專業意見，以協助相關董事履行其職責，費用由本集團承擔。董事會主席將至少每年在其他董事避席的情況下與獨立非執行董事舉行一次會議，討論任何議題及關注事項。

若有任何董事或其聯繫人在董事會將予考慮的事項中存有利益衝突，有關事項應以舉行實體董事會會議（而非書面決議）方式處理。該董事將被要求在會議前申報其利益，並放棄投票，且不會計入法定人數及不可就相關決議案投票。在該事項中本身及其聯繫人均沒有利益的獨立非執行董事應出席董事會會議。

董事會已檢討並認為上述機制有效確保於二零二三財政年度董事會獲提供獨立意見。

本公司已就因公司活動而對董事及高級管理層所提出的任何法律訴訟為董事及高級人員責任安排適當的保險。保險範圍將每年進行檢討。有關保險的詳情於（「董事會報告」）「經許可彌償」一段討論。

Independent non-executive Directors

During FY2023, the Board had at all times met the requirements of rules 3.10 and 3.10A of the Listing Rules relating to the appointment of at least three independent non-executive Directors (representing one-third of the number of members of the Board) with one of whom possessing appropriate professional qualifications or accounting or related financial management expertise.

Confirmation of independence of independent non-executive Directors

The Company has received from each independent non-executive Director an annual confirmation of his independence for FY2023 pursuant to rule 3.13 of the Listing Rules and considers all of them to be independent.

There are no financial, business, family or other material or relevant relationships between Board members.

Continuous Professional Development of Directors

All the Directors in office during FY2023, namely Mr. Lau Tat Man, Ms. Chan Ping, Rita, Mr. Lee Yuk Hang, Ms. Lung Man Wai, Mr. Sugiyama Takashi, Mr. Tanaka Kimihiro, Mr. Tomitani Takeshi, Mr. Someya Norifumi, Mr. Shinkuma Satoshi, Mr. Lee Kwok Ming, Mr. Loo Kwok Wing and Mr. Yeung Yiu Keung, have complied with code provision C.1.4 of the CG Code and participated in continuous professional development to develop and refresh their knowledge and skills, which ensures that their contribution to the Board remains informed and relevant.

All Directors in office during FY2023 have been provided with necessary induction training and materials to ensure that they have proper understanding of the operation and business of the Company and their responsibilities under the relevant laws, regulations and rules. The Company will continue to provide updates to Directors on the latest developments regarding the Listing Rules and other applicable regulatory requirements, to ensure compliance and enhance their awareness of good corporate governance practices.

獨立非執行董事

於二零二三財政年度，董事會在任何時候均符合上市規則第3.10條及第3.10A條規定，即至少委任三名獨立非執行董事（佔董事會成員人數的三分之一），其中一人擁有適當的專業資格或會計或相關財務管理專長。

確認獨立非執行董事的獨立性

本公司已收到各獨立非執行董事根據上市規則第3.13條於二零二三財政年度就其獨立性而作出的年度確認函，並認為彼等均屬獨立人士。

董事會成員之間概無任何財務、商業、家庭或其他重大或相關關係。

董事持續專業發展

於二零二三財政年度在職的所有董事，即劉達民先生、陳萍女士、李育恒先生、龍文慧女士、杉山孝史先生、田中公博先生、富谷武史先生、染谷則史先生、新熊聡先生、李國明先生、盧國榮先生及楊耀強先生已遵守企業管治守則守則條文第C.1.4條，並參與持續專業發展，以發展及更新其知識和技能，從而確保其對董事會的貢獻保持知情及相關。

於二零二三財政年度在職的所有董事都獲得必要的入職培訓及材料，以確保彼等對本公司的營運及業務以及其於相關法律、法規及規則下的責任有妥當的認識。本公司將持續向董事提供有關上市規則及其他適用監管要求的最新發展資料，以確保彼等遵守並提高對良好企業管治常規的認識。

CHAIRMAN AND CHIEF EXECUTIVE

Pursuant to code provision C.2.1 of the CG Code, the role of chairman of the Board (the “**Chairman**”) and Chief Executive Officer should be separate and should not be performed by the same individual. The division of responsibilities between the Chairman and Chief Executive Officer should be clearly established and set out in writing.

Mr. Lau Tat Man is currently the Chairman and Chief Executive Officer. In view of the fact that Mr. Lau has been assuming the responsibilities in the overall management and supervision of the daily operations of the Group since October 2018, the Board believes that it is in the best interest of the Group to have Mr. Lau taking up both roles for effective management and operations. Therefore, the Directors consider that the deviation from such code provision is appropriate. Notwithstanding such deviation, the Directors are of the view that the Board is able to work efficiently and perform its responsibilities with all key and appropriate issues discussed in a timely manner.

RE-ELECTION OF DIRECTORS

Pursuant to code provision B.2.2 of the CG Code, all Directors should be subject to retirement by rotation at least once every three years.

Each of the non-executive Directors and independent non-executive Directors of the Company is appointed for a specific term and is subject to retirement by rotation at least once every three years pursuant to terms and conditions of their respective appointment letter, the articles of association of the Company (the “**Articles of Association**”) and the Listing Rules.

Under article 110 of the Articles of Association, all Directors appointed to fill a casual vacancy shall be subject to election by Shareholders at the next following annual general meeting after appointment. Pursuant to article 111 of the Articles of Association, at each annual general meeting, one-third of the Directors for the time being, or if their number is not three or a multiple of three, the number nearest to but less than one-third shall retire from office by rotation provided that every Director shall be subject to retirement by rotation at least once every three years. The retiring Directors shall be eligible for re-election.

主席及行政總裁

企業管治守則守則條文第C.2.1條，董事會主席（「**主席**」）及行政總裁的角色應分開，不應由同一人擔任。主席及行政總裁的職責分工應明確規定並以書面形式列出。

劉達民先生目前擔任主席兼行政總裁。鑒於劉先生自二零一八年十月一直承擔本集團整體管理和日常營運監督的責任，董事會認為，由劉先生同時擔任這兩個角色以實現有效的管理及營運符合本集團的最佳利益。因此，董事認為偏離該守則條款為恰當的做法。儘管存在該偏離，董事認為，董事會能夠有效地工作並履行其職責，並能及時討論所有關鍵及適當的問題。

重選董事

根據企業管治守則守則條文第B.2.2條，所有董事應至少每三年輪席退任一次。

本公司各非執行董事及獨立非執行董事按特定年期委任，並須根據其各自的委任函，本公司的組織章程細則（「**章程細則**」）及上市規則的條款和條件，每三年輪席退任一次。

根據章程細則第110條，所有被任命填補臨時空缺的董事須在委任後的下一個股東週年大會上由股東選舉。根據章程細則第111條，於各股東週年大會上，當時三分之一的董事（或如人數不是三或三的倍數，最接近但少於三分之一的董事）應輪值退任，但每位董事應至少每三年輪值退任一次。退任董事有資格膺選連任。

In light of the foregoing requirements, Ms. Chan Ping, Rita, Mr. Lee Kwok Ming and Mr. Loo Kwok Wing shall retire by rotation and, being eligible, have offered themselves for re-election at the forthcoming annual general meeting of the Company (the “AGM”). Mr. Someya Norifumi and Mr. Yeung Siu Cheong who were appointed as non-executive Director and executive Director on 1 November 2022 and 31 May 2023, respectively, shall hold office until the forthcoming AGM and shall then be eligible for re-election.

BOARD COMMITTEES

The Board has established three committees, namely, the Remuneration Committee, the Nomination Committee and the Audit Committee, for overseeing particular aspects of the Company’s affairs. All Board committees of the Company are established with specific written terms of reference explaining their roles, authorities and duties. The terms of references of the Board committees are available on the websites of the Stock Exchange and the Company.

Remuneration Committee

The Remuneration Committee comprises four members, namely Mr. Lau Tat Man, an executive Director, and Mr. Loo Kwok Wing, Mr. Lee Kwok Ming and Mr. Yeung Yiu Keung, all being independent non-executive Directors, with Mr. Loo Kwok Wing as the chairman.

The primary duties of the Remuneration Committee include but are not limited to:

(i) making recommendations to the Board regarding the policy and structure for the remuneration of all the Directors and senior management and on the establishment of a formal and transparent procedure for developing remuneration policies; (ii) making recommendations to the Board on the remuneration packages of the Directors and senior management; (iii) reviewing and approving the management’s remuneration proposals with reference to the Board’s corporate goals and objectives; and (iv) considering and approving the grant of share awards and/or share options to eligible participants pursuant to the share award scheme and/or share option schemes of the Company.

由於前述規定，陳萍女士、李國明先生及盧國榮先生應輪值退任，並已在本公司應屆股東週年大會（「股東週年大會」）上膺選連任。染谷則史先生及楊少昌先生分別於二零二二年十一月一日及二零二三年五月三十一日獲委任為非執行董事及執行董事，任期將直至應屆股東週年大會，而其時將符合資格重選連任。

董事委員會

董事會設立三個委員會，即薪酬委員會、提名委員會及審核委員會，負責監督公司事務的特定方面。本公司所有的董事會委員會均訂有具體的書面職權範圍，解釋其角色、許可權及職責。董事委員會的職權範圍可在聯交所及本公司網站查閱。

薪酬委員會

薪酬委員會由四名成員組成，即本公司執行董事劉達文先生及獨立非執行董事盧國榮先生、李國明先生及楊耀強先生，盧國榮先生是主席。

薪酬委員會的主要職責包括但不限於：

(i)就本公司所有董事及高級管理層的薪酬政策及架構，以及就制定薪酬政策的正式及透明程序向董事會提出建議；(ii)就本公司董事及高級管理層的薪酬待遇向本公司董事會提出建議；(iii)參照董事會的企業目標及宗旨，審閱及批准管理層的薪酬建議；及(iv)審閱及批准根據本公司股份獎勵計劃及／或購股權計劃向合格參與者授予股份獎勵及／或購股權。

Nomination Committee

The Nomination Committee comprises four members, namely Mr. Lau Tat Man, an executive Director, and Mr. Lee Kwok Ming, Mr. Loo Kwok Wing and Mr. Yeung Yiu Keung, all being independent non-executive Directors, with Mr. Lau Tat Man as the chairman.

The primary duties of the Nomination Committee include but are not limited to:

(i) review the structure, size and composition (including the skills, knowledge and experience) of the Board; (ii) make recommendations on any proposed changes to the Board to complement the Company’s corporate strategy; (iii) assess the independence of independent non-executive Directors; and (iv) make recommendations to the Board on the appointment or re-appointment of members of the Board.

During FY2023, the Nomination Committee held two meetings to discharge its duties including to review and discuss the nomination policy, procedures and criteria for nomination of the Directors, review and discuss the Board diversity policy and to discuss all measurable objectives set for implementation thereof and the progress made, reviewed the structure and composition of the Board and its committees, made recommendation to the Board on the appointment and re-appointment of Directors, and assessed the independence of independent non-executive Directors. The attendance record of the Nomination Committee members during FY2023 is set out in the paragraph “Attendance records of Directors – Board of Directors” of this report.

Nomination Policy

The Board has adopted a nomination policy which sets out the selection criteria and procedure of appointing and re-appointing a Director.

提名政策

董事會已經採納提名政策，列明委任及重新委任董事的甄選標準及程序。

Selection Criteria

In assessing the suitability of a proposed candidate, the Nomination Committee would consider a variety of factors including but not limited to:

- character and integrity;
- professional qualification, relevant skill, experience and knowledge;
- contribution to board diversity;
- commitment in available time and interest; and
- independence with reference to the requirements under Rule 3.13 of the Listing Rules in case of the appointment or re-appointment of independent non-executive Director.

The above factors are not exhaustive and conclusive. The Nomination Committee has the final discretion to the selection criteria.

Nomination Procedure

The procedure of nominating a proposed candidate is as follows:

- nomination and invitation of suitable candidates by Nomination Committee;
- evaluation on the candidate based on the relevant selection criteria;
- performing due diligence in respect of the candidate and making recommendation for the Board's consideration and approval;
- assessing independence of the candidate if applicable;
- in the context of re-appointment of retiring Directors, reviewing the candidate's overall contribution and performance and making recommendations to the Board and/or the Shareholders for consideration in connection with his/her re-election at general meetings; and
- convening a meeting of the Board to consider the appointment or re-appointment of the candidate as a Director.

The Nomination Committee shall review the nomination policy and assess its effectiveness on a regular basis or as required.

甄選標準

評估建議候選人的合適性時，提名委員會將考慮多種因素，包括但不限於：

- 性格和誠信；
- 專業資格、相關技能、經驗和知識；
- 對董事會多元化的貢獻；
- 可用時間和興趣的承諾；及

上文並無盡列所有因素，該等因素亦不具決定性作用。提名委員會對甄選標準有最終決定權。

提名程序

提名建議候選人的程序如下：

- 由提名委員會提名和邀請合適的候選人；
- 根據相關甄選標準對候選人進行評估；
- 對候選人進行盡職調查，並提出建議供董事會考慮和批准；
- 評估候選人的獨立性(如適用)；
- 在重新委任退任董事的情況下，檢討候選人的整體貢獻及表現，並向董事會及/或股東提出建議，供其在股東大會上重選時考慮；及
- 召開董事會會議，考慮委任或重新委任候選人為董事。

提名委員會應定期或根據需要檢討提名政策並評估其有效性。

Board Diversity Policy

The Board has adopted a board diversity policy which sets out the objective and approach to achieve Board diversity. The Group recognises the benefits of having a diversified Board and sees increasing diversity at the Board level as an essential element in supporting the attainment of the Group's strategic objectives and sustainable development. The Group seeks to achieve diversity of the Board through the consideration of a number of factors, including but not limited to professional experience, skills, knowledge, education background, gender, age and ethnicity.

The Nomination Committee will review the board diversity policy and its implementation from time to time and at least once annually to ensure its implementation and monitor its continued effectiveness. The Nomination Committee would discuss and agree on measurable objectives for achieving diversity on the Board, where necessary, and recommend them to the Board for adoption.

Our Directors have a balanced mix of experiences, including overall management, brand improvement, business development, legal, finance, auditing and accounting experiences. As at 31 March 2023, the ages of our Directors ranged from 40 years old to 65 years old. Taking into account the Group's business model and specific needs as well as the presence of two female Directors out of a total of nine Board members as at 31 March 2023, the Directors consider that the Board has achieved gender diversity at the Board level during FY2023. While our Group recognises that the gender diversity at the Board level can be improved given its composition of seven males and two females as at 31 March 2023, the Group will continue to apply the principle of appointments based on merits with reference to the Board diversity policy as a whole and the Group will continue to take steps to promote gender diversity at all levels of the Company.

董事會多元化政策

董事具備比例均衡的經驗，包括整體管理、品牌改進、業務發展、法律、金融、審核及會計經驗。於二零二三年三月三十一日，董事年齡介乎40歲至65歲。考慮到本集團的業務模式及特定需求，以及截至二零二三年三月三十一日在合共九名董事會成員中有兩名女性董事，董事認為，於二零二三財政年度，董事會已在董事會層面實現性別多元化。於二零二三年三月三十一日，鑒於董事會由七名男性及兩名女性組成，本集團明白董事會層面的性別多元化水平有待改善，但本集團將繼續整體上參考董事會多元化政策，採納唯才是用的原則，而本集團亦將繼續採取措施提高本公司各層面的性別多元化。

The Company actively seeks to ensure it has an appropriate mix of diversity and has a number of initiatives in place to meet its strategic imperative of ensuring it has a diverse Board. The Company will ensure that gender diversity is taken into account when recruiting staff members of mid to senior level, consider the possibility of nominating female management staff who has the necessary skills and experience to the Board, and ensure that sufficient resources are available for providing appropriate trainings and career development to develop a pipeline of potential female successors to the Board, with an aim to maintain or improve the current gender mix at the Board level, subject to there being suitable candidates and the Directors being satisfied with the qualification and experience of the relevant candidates after a reasonable review process based on selection criteria designed with the best interests of the Company's business in mind. The Board is of the view that it is not necessary to set numerical targets and timeline for board gender diversity for the time being.

Audit Committee

The Audit Committee comprises three members, namely Mr. Lee Kwok Ming, Mr. Loo Kwok Wing and Mr. Yeung Yiu Keung, all of them are independent non-executive Directors, with Mr. Lee Kwok Ming as the chairman.

The primary duties of the Audit Committee include but are not limited to:

(i) to review the financial statements and reports of the Company and consider any significant or unusual items raised by the external auditor before submission to the Board; (ii) to review and monitor the relationship with the external auditor of the Company by reference to the work performed by the external auditor, their fees and terms of engagement, and make recommendations to the Board on the appointment, re-appointment and removal of external auditor; (iii) to review the adequacy and effectiveness of the Company's financial controls, internal control system, risk management system and the associated procedures; (iv) to develop and review the Company's policies and practices on corporate governance and make recommendations to the Board; and (v) to perform other duties and responsibilities as may be assigned by the Board.

The Audit Committee has been provided with sufficient resources to discharge its duties. Corporate Governance Functions

The Board is responsible for performing the corporate governance functions set out in code provision A.2.1 of the CG Code.

The Board is responsible for reviewing the Company's corporate governance policies and practices, training and continuous professional development of Directors and senior management, the Company's policies and practices on compliance with legal and regulatory requirements, and the Company's compliance with the code of conducts, the CG Code, the compliance manual and disclosure in this Corporate Governance Report. The Board has performed the above duties for FY2023.

The Group encourages gender diversity across its workplace and is committed to maintaining an appropriate gender ratio of employees at all levels. SHAREHOLDERS' RIGHTS

Convening of Extraordinary General Meeting and Putting Forward Proposals at Shareholders' Meetings

Under Article 62 of the Articles of Association, the Directors may, whenever they think fit, and shall on requisition in accordance with the Companies Ordinance (Cap. 622 of the Laws of Hong Kong) (the "Companies Ordinance"), convene an extraordinary general meeting. Pursuant to Section 566 of the Companies Ordinance, an extraordinary general meeting can be convened on the requisition of any one or more Shareholders representing not less than 5% of the total voting rights of all Shareholders having a right to vote at general meetings of the Company. Such requisition shall be made in writing to the Company stating the general nature of the business to be dealt with at the meeting. Pursuant to Section 567 of the Companies Ordinance, the Directors must call a general meeting within 21 days after the date on which they become subject to the requirement and the meeting so called must be held on a date not more than 28 days after the date of the notice convening the meeting. If the Directors do not do so, the requisitioner(s) himself (themselves) may do so in the same manner, but the meeting must be called for a date not more than 3 months after the date on which the Directors become subject to the requirement to call a meeting. All reasonable expenses incurred by the requisitioner(s) as a result of the failure of the Directors duly to call the meeting shall be reimbursed by the Company.

For putting forward any enquiries to the Board of the Company, Shareholders may send their enquiries to the Company in writing to the principal place of business of the Company in Hong Kong, which is currently at the following address:

The Company considers that effective communication with Shareholders is essential for enhancing investor relations and investors' understanding of the Group's business performance and strategies. The Company endeavours to maintain an on-going dialogue with Shareholders and the Company has established various communication channels with Shareholders, including general meeting, annual results and interim results, annual and interim reports, announcements and circulars and performance conference. To facilitate the communication between the Company and investors, the Company holds meetings, briefings and roadshows with investors and analysts from time to time. Shareholders may also make enquires with the Company through other channels mentioned above, and provide comments and recommendations to the Directors or managements at any time. Upon receipt of written enquiries from a Shareholder, the Company will use reasonable endeavours to respond to the Shareholder as soon as possible. In addition, the Company updates its website from time to time to keep the Shareholders updated of the recent development of the Company. Having regard to the above, the Company considers the implementation of the Shareholders' communication policy during FY2023 was effective.

本公司認為，與股東的有效溝通對於加強投資者關係以及投資者對本集團業務表現及策略的了解至關重要。本公司盡力持續與股東保持對話，並已設立各種與股東溝通的渠道，包括股東大會、年度業績和中期業績、年度和中期報告、公告和通函以及業績發佈會。為促進本公司與投資者之間的溝通，本公司不時與舉行投資者及分析師會議、簡報會及路演。股東亦可透過上述的其他渠道向本公司作出查詢，並隨時向董事或管理層提供意見與建議。在收到股東的書面查詢後，本公司會盡合理努力，盡快向股東作出回應。此外，本公司會不時更新其網站，讓股東了解本公司的最新發展情況。綜上所述，本公司認為於二零二三財政年度實施的股東溝通政策屬有效。

Dividend policy

The Board has the discretion to declare dividend to the Shareholders from time to time, subject to the Articles of Association and all applicable laws and regulations. Pursuant to the Articles of Association, any declaration of final dividend for the year will be subject to the passing of an ordinary resolution by the Shareholders at a general meeting, while the Directors may from time to time resolve to pay to the Shareholders interim dividends as appear to the Directors to be justified.

On 14 September 2021, the Board resolved to adopt a dividend policy to set out the conditions of declaration and payment of dividend to the Company's shareholders by the Board.

We currently aim to pay a total dividend in respect of each financial year of not less than 30% of our profit attributable to our owners. When recommending the payment of any dividend, the Board would normally consider various factors, including but not limited to:

- i. results of operations;
- ii. financial performance;
- iii. profitability;
- iv. business development;
- v. prospects;
- vi. capital requirements; and
- vii. economic outlook.

The dividend policy may be reviewed from time to time and the payment of any future dividend will be subject to the Board's discretion taking into account the interests of the Group and the Shareholders as a whole and will be subject to compliance with all applicable laws and regulations.

股息政策

董事會可酌情不時向股東宣派股息，惟須遵守章程細則及所有適用法律及法規。根據章程細則，宣派任何年度末期股息須經股東在股東大會上通過普通決議案，而董事可不時決議向股東派付董事認為合理的中期股息。

於二零二一年九月十四日，董事會決定採納股息政策，規定董事會向本公司股東宣派及支付股息的條件。

我們現時的目標為就各財政年度支付不少於擁有人應佔溢利30%的總股息。推薦派付任何股息時，董事會通常會考慮多種因素，包括但不限於：

- i. 經營業績；
- ii. 財務表現；
- iii. 盈利能力；
- iv. 業務發展；
- v. 前景；
- vi. 資本要求；及
- vii. 經濟前景。

股息政策不時經審閱，而派付任何未來股息須由董事考慮本集團及股東整體利益酌情決定且須遵守所有適用法律及法規。

RISK MANAGEMENT AND INTERNAL CONTROL

The Group has formulated and adopted the risk management policy in providing direction in identifying, evaluating and managing significant risks. The main features of the risk management processes comprise 5 core stages: (a) risk identification, (b) risk assessment and prioritisation, (c) risk response, (d) risk monitoring and (e) risk reporting.

The appropriate risk mitigation plans are determined based on the following risk responses:

- Acceptance: Risks are considered immaterial and acceptable based on Group's risk appetite and therefore no action is considered necessary.
- Reduction: Risks cannot be considered immaterial and actions such as controls have to be taken to reduce the impact and vulnerability to an acceptable level.
- Avoidance: Risks are so significant that there is no measure both internally and externally to reduce the risk to an acceptable level, or involve unreasonably high cost to reduce the risk to an acceptable level. Therefore, activities giving rise to the risks should be avoided.

Internal audit function and review of risk management and internal control

The Group has an internal audit function, which consists of professional staff with relevant expertise. The internal audit function is independent from the Group's daily operation and carries out review of the risk management and internal control systems by conducting interviews, walkthroughs and tests of operating effectiveness. Review of risk management and internal control systems covering all material controls, including financial, operational and compliance controls are conducted half-annually, and the results are reported to the Board through the Audit Committee. During FY2023, the Board through its review and review made by the internal audit function, concluded that no material risk management and internal control aspects of any significant discrepancies were discovered during the review and was satisfied that the risk management and internal control systems were effective and adequate.

風險管理及內部監控

本集團已制定及採納風險管理政策以為識別、評估及管理主要風險提供指導。主要風險管理程序包括五個核心流程：(a)風險確定；(b)風險評估及其風險優先次序；(c)風險應對；(d)風險監控；及(e)風險匯報。

本集團根據以下風險應對措施釐定適當的風險減緩計劃：

- 接受：根據本集團之風險接受程度，風險被視為並不重大及可接受，故毋須採取任何行動。
- 降低：風險被視為不能忽視，並採取監控措施等行動以減少影響及風險承受程度至可接受水平。
- 防範：風險被視為相當重大，本集團沒有足夠及有效的內部監管系統及外界措施可將風險降至可接受水平或需不合理及高昂之成本將風險降至可接受水平。因此，須避開產生有關風險之活動。

內部審核職能及審閱風險管理及內部監控

本集團設有內部審核職能，由具有相關專業知識的專業人員組成。內部審核職能部門獨立於本集團的日常運作，並通過進行面談、走訪及測試營運有效性對風險管理及內部監控系統進行審閱。風險管理及內部監控系統涵蓋所有重大控制，包括財務、營運及合規控制，審閱每半年進行一次，並由審核委員會向董事會報告結果。於二零二三財政年度，董事會通過其審核及內部審計職能部門的審核，認為在審核期間沒有發現任何重大的風險管理及內部監控方面的重大差異，且確信風險管理及內部監控系統屬有效及足夠。

Compliance with risk management and internal control code provisions

The Company has established a dynamic risk management process, including risk identification, risk assessment, risk monitoring, risk response, risk supervision and improvement as well as risk reporting, to identify and evaluate the major risks of the Company.

The Company adopts a risk management system which manages the risk associated with its businesses and operations and has an internal control system which enables the Group to achieve objectives regarding effectiveness and efficiency of operations, reliability of financial reporting and compliance with applicable laws and regulations.

The Board acknowledges its responsibility for the risk management and internal control systems and reviewing their effectiveness. Such systems are designed to manage rather than eliminate the risk of failure to achieve business objectives and can only provide reasonable and not absolute assurance against material misstatement or loss.

Disclosure of inside information

The Company has put in place an internal policy for the handling and disclosure of inside information in compliance with the Securities and Futures Ordinance (Cap. 571 of the Laws of Hong Kong) (the “SFO”). The internal policy sets out the procedures and internal controls for handling and dissemination of inside information in a timely manner and provides the Directors, senior management and relevant employees a general guide in monitoring information disclosure and responding to enquiries. Control procedures have been implemented to ensure that unauthorized access and use of inside information are strictly prohibited.

遵守風險管理及內部監控守則條文

本公司已建立動態的風險管理流程，包括風險識別、風險評估、風險監測、風險應對、風險監督及改進以及風險報告，以識別及評估本公司的主要風險。

本公司採納風險管理系統，管理與其業務及營運相關的風險，並實行內部控制系統，使本集團能夠實現有關經營有效性及效率、財務報告可靠性以及遵守適用法律及法規的目標。

董事會瞭解其對風險管理及內部監控系統以及檢討其成效的責任。該等系統旨在管理而非消除未能達成業務目標的風險，且僅就不會存在重大錯誤陳述或損失作出合理而非絕對的保證。

披露內幕消息

本公司已制定處理及披露內幕消息的內部政策，以遵守證券及期貨條例（香港法例第571章）（「證券及期貨條例」）。該內部政策規定及時處理及傳播內幕消息的程序及內部監控，並為董事、高級管理層及相關員工提供監控資訊披露及回應查詢的一般指引。本公司已實行控制程序，以確保嚴格禁止未經授權獲取及使用內幕消息。

Anti-corruption and whistle-blowing policies

The Group has always adhered to high standards of business ethics, preventing corruption through corporate governance, internal controls and risk management, and is subject to ongoing oversight by the Board of Directors. We have zero tolerance for misconduct and unethical business behaviours. Therefore, the Anti-Bribery and Corruption Policy (the “**Policy**”) and Code of Ethics (the “**Code**”) have been formulated with reference to the requirements of the Prevention of Bribery Ordinance (POBO) and the Independent Commission Against Corruption (ICAC). The policies clearly state the requirements for accepting advantages and conflict of interests. The Human Resources Department is responsible for implementing and monitoring the Policy and the Code, and the Board reviews them on a regular basis. To communicate the details of the Policy and the Code to all staff members, the procedures outlined in the policies are incorporated into the induction program for new staff, while current staff will receive updates via email.

The Company also has a whistle-blowing policy where guidelines and processes for the reporting of misconduct or malpractice are clearly established. Any employees or business partners are able to report matters of concern in a confidential manner through the designated email address or the D-Quest hotline (a hotline for whistleblowing). Supervised by the Human Resources Department, any employee or agent who fails to comply with our policies or the regulatory requirements regarding anti-bribery and corruption will be subject to disciplinary actions, including the termination of employment or appointment, and will be reported to law enforcement authorities where appropriate.

本公司亦制定了舉報政策，規定舉報不當行為或瀆職行為的指引及程序。任何僱員或業務夥伴均可透過指定電郵地址或D-Quest熱線（舉報熱線）以保密方式呈報關注事項。在人力資源部的監督下，任何僱員或代理人如未有遵守我們的政策或有關反賄賂與貪污的監管規定，將會受到紀律處分，包括終止僱用或委任，並會在適當情況下向執法機構舉報。

(d) Exercise price

為實施股份獎勵計劃，譚仔國際僱員信託（「**僱員信託**」）於二零二一年三月二十五日成立，由恒泰信託（香港）有限公司擔任受託人（「**受託人**」）。受託人須代承授人持有獎勵股份，直至該等獎勵股份根據股份獎勵計劃規則歸屬予承授人為止。受託人須於有關歸屬日安排將獎勵股份轉讓予該等承授人，惟須經本公司確認。

於二零二一年三月二十五日及二零二一年八月九日，本公司就股份獎勵計劃向Blessing Keen Investing Limited（「**Blessing Keen**」）（受託人直接全資附屬公司）配發及發行2,024,000股及3,000,000股股份，相當於本年報日期的已發行股份總數分別約0.15%及0.22%。

Blessing Keen is a company wholly-owned by the Trustee and was incorporated in the British Virgin Islands as a special purpose vehicle solely to hold Shares on trust for the grantees for the purpose of the Share Award Scheme. As a wholly-owned subsidiary of the Trustee, Blessing Keen may only deal with the Shares it holds in accordance with the terms of the trust deed entered into between our Company as the settlor and the Trustee for the specific purposes of the Employee Trust (the “**Trust Deed**”). In accordance with the Trust Deed, an advisory committee (the “**Advisory Committee**”) established and authorised by our Company, currently comprising Mr. Lau Tat Man, an executive Director and the chief executive officer of the Company, shall provide instructions to the Trustee in relation to the Employee Trust and the Share Award Scheme. Such instructions shall only be given after the Board has passed resolutions with majority votes upon the recommendations of the Remuneration Committee.

The Trustee shall not exercise any voting rights and Blessing Keen does not have any voting rights in respect of any Shares held by Blessing Keen under the Employee Trust. After the actual vesting of the Shares awarded to our Group’s employees, the grantees will be entitled to exercise the voting rights attached to the vested Shares.

The Trustee shall, or shall procure Blessing Keen to, elect to receive dividends from our Company, unless receiving any written direction to the contrary from the Advisory Committee, and hold such dividends for the benefit of the Share Award Scheme. The dividends received by the Trustee shall form part of the trust fund of the Employee Trust, which will be utilised by the Trustee at the direction of the Advisory Committee for the benefit of the Share Award Scheme, including but not limited to acquisition of Shares on market for grant of the awarded Shares and settlement of the fees charged by the Trustee and the costs and expenses incurred by the Trustee in the course of performance of its duties in respect of the Employee Trust.

Blessing Keen為受託人全資擁有的公司，作為特殊目的實體於英屬維爾京群島註冊成立，目的僅為以信託形式為股份獎勵計劃的承授人持有股份。作為受託人的全資附屬公司，Blessing Keen僅可買賣其根據本公司（作為委託人）及受託人就僱員信託的特殊目的訂立的信託契據（「**信託契據**」）條款持有的股份。根據信託契據，本公司成立及授權顧問委員會（「**顧問委員會**」），其現由本公司執行董事兼行政總裁劉達民先生組成，將就僱員信託及股份獎勵計劃向受託人提供指示。有關指示僅可於董事會於薪酬委員會提出推薦建議後，以多數票通過決議案後作出。

受託人將不會行使任何投票權而Blessing Keen就其根據僱員信託持有的任何股份不享有任何投票權。本集團僱員獲授的股份實際歸屬後，承授人將有權行使已歸屬股份隨附的投票權。

受託人將會或將促使Blessing Keen選擇自本公司收取股息（除非顧問委員會作出相反的書面指示則作別論），並將以股份獎勵計劃持有該等股息。受託人收取的股息將構成僱員信託的信託基金一部分，其將由受託人按顧問委員會酌情決定用於股份獎勵計劃，包括但不限於在市場收購股份以授出獎勵股份及支付受託人收取的費用以及受託人在履行其有關僱員信託的職責期間產生的成本及開支。

(d) Maximum number of shares

The maximum number of awarded Shares which may be granted to the eligible participants under the Share Award Scheme is no more than 10% of the issued share capital of the Company immediately upon completion of the Global Offering i.e. 134,003,200 Shares, representing approximately 9.99% of the total issued Shares of the Company as at the date of this report, but excluding the awarded Shares which have been lapsed in accordance with the Share Award Scheme and all Shares which may be issued upon the exercise of options granted or to be granted under the Pre-IPO Share Option Scheme and the Post-IPO Share Option Scheme. The maximum number of Shares which may be allotted and issued by the Company under the Share Award Scheme in any financial year is no more than 3% of the issued share capital of the Company immediately upon completion of the Global Offering, i.e. 40,200,960, representing approximately 2.99% of the total issued Shares of the Company as at the date of this report.

(e) Maximum entitlement of each participant

The maximum entitlement of each participant under the Share Award Scheme shall be subject to the Listing Rules.

(f) Duration

The Share Award Scheme shall be valid and effective for a term of 10 years from the adoption date (i.e. 25 March 2021). As at the date of this report, the Share Award Scheme has a remaining life of approximately 7 years and 8 months.

(g) Shares awarded under the Share Award Scheme

A total of 5,024,000 Shares, representing approximately 0.37% of the total number of issued Shares as at the date of this report, were granted to certain selected employees on 25 March 2021 and 9 August 2021, respectively.

RETIREMENT BENEFIT SCHEMES

The Group operates a Mandatory Provident Fund Scheme (the “MPF Scheme”) under the Hong Kong Mandatory Provident Fund Schemes Ordinance for employees in Hong Kong under the jurisdiction of the Hong Kong Employment Ordinance. The MPF Scheme is a defined contribution retirement scheme administered by independent trustees. Under the MPF Scheme, the employer and its employees are each required to make contributions to the MPF Scheme at 5% of the employees’ relevant income, subject to a cap of monthly relevant income of HK\$30,000 (2022: HK\$30,000). Contributions to the plan vest immediately.

Employees engaged by the Group outside Hong Kong are covered by appropriate local defined contribution retirement schemes pursuant to the local labour rules and regulations. The only obligation of the Group with respect to the retirement benefits scheme is to make the specified contributions.

During FY2023, no forfeited contributions were available to reduce the existing or future level of contributions.

The Directors estimated that the maximum annual amount of service fees payable by the Group to Toridoll HK in relation to the Business Consulting Services FY2023 will not exceed HK\$6.5 million. The annual service fee paid/payable by the Group in relation to Business Consulting Services for FY2023 was HK\$2,942,000.

2. Operations Support Services

On 11 June 2021, the Company entered into an operations support service agreement (the “**Operations Support Service Agreement**”) with Toridoll Japan, pursuant to which Toridoll Japan has agreed to provide operations support services to the Company for the Group’s upcoming operations in Japan, which include (a) at the pre-opening phase, (i) assistance in establishing supply chain management system including sourcing of suppliers; (ii) assistance in obtaining licences and complying with applicable laws and regulations; (iii) assistance in site selection and tenancy matters of our restaurants; (iv) provision of advice on and assistance in the coordination of design development and construction work for our restaurants; (v) provision of advice on corporate social responsibility, marketing strategy and quality assurance; and (vi) provision of supporting functions such as human resources, administrative, accounting and finance services; and (b) at the post-opening phase, (i) provision of inventory control, quality inspection and store audit services; (ii) assistance in data collection and establishing and maintaining customer feedback system; (iii) assistance in on-going site selection and coordination of maintenance work for our restaurants; (iv) assistance in the marketing and promotional activities; and (v) provision of on-going supporting functions such as human resources, administrative, IT maintenance, accounting and finance services (the “**Operations Support Services**”). The Operations Support Service Agreement has a term commencing from 11 June 2021 to 31 March 2024, which may be renewed as the parties may mutually agree, subject to compliance with the requirements under Chapter 14A of the Listing Rules and all other applicable laws and regulations.

The Directors estimated that the maximum annual amount of service fees payable by the Group to Toridoll Japan in relation to the Operations Support Services for FY2023 will not exceed HK\$7.5 million. The annual service fee paid/payable by the Group in relation to Operations Support Services for FY2023 is HK\$1,141,000.

Each of Toridoll HK and Toridoll Japan is a controlling shareholder of the Company and therefore a connected person of the Company. Accordingly, the transactions contemplated under the Business Consulting Service Agreement and the Operations Support Service Agreement constitute continuing connected transactions of the Company since the Listing Date under Chapter 14A of the Listing Rules.

(“**TJ Japan**”), a wholly-owned subsidiary of the Company, entered into a procurement services framework agreement (the “**Procurement Services Framework Agreement**”) with Toridoll Japan, pursuant to which Toridoll Japan shall provide TJ Japan with procurement services for ingredients food, restaurant non-food products and restaurant consumables (the “**Procurement Services**”) for a term commencing from 1 April 2022 to 31 March 2023 (both days inclusive).

Under the Procurement Services Framework Agreement, TJ Japan shall reimburse Toridoll Japan for the actual costs incurred by Toridoll Japan for the provision of the Procurement Services. The annual cap for the fees to be paid by TJ Japan to Toridoll Japan pursuant to the Procurement Service Framework Agreement for FY2023 shall not exceed HK\$20 million. The total fees paid/payable by the Group to Toridoll Japan in relation to the Procurement Services for FY2023 was approximately HK\$8 million.

Toridoll Japan is a controlling shareholder of the Company and therefore a connected person of the Company. Accordingly, the transactions contemplated under the Procurement Services Framework Agreement constitute continuing connected transactions of the Company under Chapter 14A of the Listing Rules.

On 31 May 2022, the Company entered into a management services agreement (the “**Management Services Agreement**”) with Toridoll HK, pursuant to which the Group has agreed to provide Toridoll HK and its subsidiaries with management services including (i) assistance in stabilizing the Business operations; (ii) assistance in the procurement process of the Business; (iii) provision of expertise and knowledge sharing on improving frontline store operations; (iv) assistance in marketing activities and provision of marketing plans for the Business; (v) provision of general support services; and (vi) assistance in strengthening the enforcement of reporting system (collectively, the “**Management Services**”). The Management Services Agreement has a term commencing from 1 June 2022 to 31 May 2023, which may be renewed as the parties may mutually agree, subject to compliance with the requirements under Chapter 14A of the Listing Rules and all other applicable laws and regulations.

The Directors estimate that the maximum annual amount of service fees payable by Toridoll HK to the Group in relation to the Management Services shall not exceed HK\$4,000,000 and HK\$800,000 for the period from 1 June 2022 to 31 March 2023 and the period from 1 April 2023 to 31 April 2023 respectively. The annual service fee received/receivable to the Group in relation to Management Services for FY2023 was approximately HK\$2,026,000.

Toridoll HK is a controlling shareholder of the Company and therefore a connected person of the Company. Accordingly, the transactions contemplated under the Management Services Agreement constitute continuing connected transactions of the Company under Chapter 14A of the Listing Rules.

Each of Toridoll Japan, Toridoll HK, Mr. Awata Takaya, Mrs. Awata Toshimi and T&T Inc., being controlling shareholders of the Company, has confirmed to the Company of their compliance with the non-competition undertakings provided to the Company under a deed of non-competition dated 16 September 2021 (the "Deed of Non-competition") since the Listing Date and up to 31 March 2023. The Board and all the independent non-executive Directors had reviewed the status of compliance and the confirmations provided by each of the controlling shareholders and are not aware of any circumstance which would affect the compliance and enforcement of the terms under the Deed of Non-competition during FY2023. Accordingly, they are satisfied that the Deed of Non-competition has been fully complied with.

There is a risk that the value of right-of-use assets and property, plant and equipment in certain restaurants may not be recoverable in full through the future cash flows to be generated from operations of those restaurants or from disposal of the related right-of-use assets and property, plant and equipment.

At the end of each reporting period, right-of-use assets and property, plant and equipment are allocated to each individual restaurant which is considered as a cash-generating unit ("CGU"). Management reviews the performance of individual restaurants to identify if any restaurant displays negative performance indicators which could indicate impairment.

The value in use of the right-of-use assets and property, plant and equipment in those restaurants is determined by management on a restaurant-by-restaurant basis based on a discounted cash flow forecast.

1 SIGNIFICANT ACCOUNTING POLICIES

(a) Statement of compliance

These financial statements have been prepared in accordance with all applicable Hong Kong Financial Reporting Standards (“HKFRSs”), which collective term includes all applicable individual Hong Kong Financial Reporting Standards, Hong Kong Accounting Standards (“HKASs”) and Interpretations issued by the Hong Kong Institute of Certified Public Accountants (“HKICPA”), accounting principles generally accepted in Hong Kong and the requirements of the Hong Kong Companies Ordinance. These financial statements also comply with the applicable disclosure provisions of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited. Significant accounting policies adopted by the Group are disclosed below.

The HKICPA has issued certain amendments to HKFRSs that are first effective or available for early adoption for the current accounting period of the Group. Note 1(c) provides information on any changes in accounting policies resulting from initial application of these developments to the extent that they are relevant to the Group for the current accounting period reflected in these financial statements.

(b) Basic of preparation of the financial statements

The consolidated financial statements for the year ended 31 March 2023 comprise the Company and its subsidiaries (together referred to as the “Group”). The measurement basis used in the preparation of the financial statements is the historical cost basis.

The preparation of financial statements in conformity with HKFRSs requires management to make judgements, estimates and assumptions that affect the application of policies and reported amounts of assets, liabilities, income and expenses. The estimates and associated assumptions are based on historical experience and various other factors that are believed to be reasonable under the circumstances, the results of which form the basis of making the judgements about carrying values of assets and liabilities that are not readily apparent from other sources. Actual results may differ from these estimates.

1 主要會計政策

(a) 合規聲明

此等財務報表乃根據所有適用的香港財務報告準則（「香港財務報告準則」）編製，此統稱包括香港會計師公會（「香港會計師公會」）頒佈的所有適用的個別香港財務報告準則、香港會計準則（「香港會計準則」）及詮釋、香港一般公認會計原則以及香港《公司條例》之規定。此等財務報表亦符合香港聯合交易所有限公司證券上市規則的適用披露條文。本集團採納之主要會計政策披露如下。

香港會計師公會已頒佈若干於本集團當期會計期間首次生效或可提早採納之香港財務報告準則修訂。附註1(c)提供有關初步應用該等發展所引致的會計政策變動的資料，惟以該等變動與本集團在該等財務報表所反映的當期會計期間有關者為限。

(b) 財務報表的編製基準

截至二零二三年三月三十一日止年度之綜合財務報表包括本公司及其附屬公司（統稱為「本集團」）。編製財務報表時使用的計量基準為歷史成本基準。

編製符合香港財務報告準則的財務報表需要管理層作出判斷、估計及假設，該等判斷、估計及假設會影響政策應用以及所呈報資產、負債、收入及開支金額。該等估計及有關假設按過往經驗及被視為在有關情況下屬合理的多項其他因素作出，其結果構成無法依循其他來源得知資產及負債賬面值時作出判斷的基準。實際結果或會有別於該等估計。

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods.

Judgements made by management in the application of HKFRSs that have significant effect on the financial statements and major sources of estimation uncertainty are discussed in note 2.

(c) Changes in accounting policies

The Group has applied the following amendments to HKFRSs issued by the HKICPA to these financial statements for the current accounting period:

- Amendments to HKAS 16 *Property, plant and equipment: Proceeds before intended use*
- Amendments to HKAS 37, *Provisions, contingent liabilities and contingent assets: Onerous contracts – cost of fulfilling a contract*

None of these amendments have had a material effect on how the Group's results and financial position for the current or prior periods have been prepared or presented. The Group has not applied any new standard or interpretation that is not yet effective for the current accounting period.

(d) Subsidiaries

Subsidiaries are entities controlled by the Group. The Group controls an entity when it is exposed, or has rights, to variable returns from its involvement with the entity and has the ability to affect those returns through its power over the entity. When assessing whether the Group has power, only substantive rights (held by the Group and other parties) are considered.

管理層應用香港財務報告準則時所作出對財務報表有重大影響的判斷以及估計不確定因素的主要來源於附註2論述。

(c) 會計政策變動

本集團已於本會計期間，對該等財務報表應用由香港會計師公會頒佈的下列香港財務報告準則的修訂本：

- 香港會計準則第16號修訂本，物業、機器及設備：作擬定用途前之所得款項
- 香港會計準則第37號修訂本，撥備、或然負債及或然資產：虧損性合約 – 履行合約之成本

該等修訂概無對本集團於本期間或過往期間的業績及財務狀況的編製或呈列方法造成重大影響。本集團並無應用任何於本會計期間尚未生效的新訂準則或詮釋。

(d) 附屬公司

附屬公司指本集團控制的實體。倘本集團因參與實體的營運而就可變回報承受風險或享有權利，並有能力透過其對實體的權力影響該等回報，則本集團對該實體擁有控制權。當評估本集團是否擁有權力時，僅考慮由本集團及其他人士持有的實質權利。

An investment in a subsidiary is consolidated into the consolidated financial statements from the date that control commences until the date that control ceases. Intra-group balances, transactions and cash flows and any unrealised profits arising from intra-group transactions are eliminated in full in preparing the consolidated financial statements. Unrealised losses resulting from intra-group transactions are eliminated in the same way as unrealised gains but only to the extent that there is no evidence of impairment.

Changes in the Group's interests in a subsidiary that do not result in a loss of control are accounted for as equity transactions, whereby adjustments are made to the amounts of controlling and non-controlling interests within consolidated equity to reflect the change in relative interests, but no adjustments are made to goodwill and no gain or loss is recognised.

When the Group loses control of a subsidiary, it is accounted for as a disposal of the entire interest in that subsidiary, with a resulting gain or loss being recognised in profit or loss. Any interest retained in that former subsidiary at the date when control is lost is recognised at fair value and this amount is regarded as the fair value on initial recognition of a financial asset.

In the Company's statement of financial position, an investment in a subsidiary is stated at cost less impairment losses (see note 1(g)(ii)). A controlled structured entity that is directly held by the Company is considered as branch/agent of the Company and the assets and liabilities thereof are accounted for as assets and liabilities of the Company in the Company's statement of financial position.

自控制權開始之日至控制權停止之日，於附屬公司的投資綜合計入綜合財務報表。集團內公司間的結餘、交易以及集團內公司間交易所產生的現金流量及任何未變現溢利，在編製綜合財務報表時悉數對銷。集團內公司間交易所產生的未變現虧損則僅在並無減值證據的情況下，以相同的方式與未變現收益對銷。

倘本集團於附屬公司的權益變動不會導致喪失控制權，則作為股權交易入賬，據此會對綜合權益內的控股及非控股權益金額作出調整，以反映相對權益變動，惟不會對商譽作出調整，亦不會確認收益或虧損。

當本集團喪失對附屬公司的控制權，將作為出售於該附屬公司的全部權益入賬，而所產生的收益或虧損於損益中確認。任何在喪失控制權當日仍保留的於該前附屬公司權益按公允價值確認，而此金額被視為初步確認金融資產的公允價值。

Items of property, plant and equipment are stated at cost less accumulated depreciation and impairment losses (see note 1(g)(ii)).

Depreciation is calculated to write off the cost of items of property, plant and equipment, less their estimated residual value, if any, using the straight line method over their estimated useful lives as follows:

— Leasehold improvements	Remaining term of the tenancy lease
— Furniture and fixtures	20%
— Machinery and equipment	20%
— Computer equipment	20%
— Motor vehicles	25%

Both the useful life of an asset and its residual value, if any, are reviewed annually.

Gains or losses arising from the retirement or disposal of an item of property, plant and equipment are determined as the difference between the net disposal proceeds and the carrying amount of the item and are recognised in profit or loss on the date of retirement or disposal.

(f) Leased assets

At inception of a contract, the Group assesses whether the contract is, or contains, a lease. A contract is, or contains, a lease if the contract conveys the right to control the use of an identified asset for a period of time in exchange for consideration. Control is conveyed where the customer has both the right to direct the use of the identified asset and to obtain substantially all of the economic benefits from that use. To assess whether a contract conveys the right to control the use of an identified asset, the Group assesses whether:

- the contract involves the use of an identified asset — this may be specified explicitly or implicitly, and should be physically distinct or represent substantially all of the capacity of a physically distinct asset. If the supplier has a substantive substitution right, then the asset is not identified;
- the Group has the right to obtain substantially all of the economic benefits from use of the asset throughout the period of use; and
- the Group has the right to direct the use of the asset. The Group has this right when it has the decision-making rights that are most relevant to changing how and for what purpose the asset is used. In rare cases where the decision about how and for what purpose the asset is used is predetermined, the Group has the right to direct the use of the asset if either:
 - the Group has the right to operate the asset; or
 - the Group designed the asset in a way that predetermines how and for what purpose it will be used.

本集團在合約開始時評估該合約是否屬於或包含租賃。倘合約於一段時間內將控制某項已識別資產使用權以換取代價，則該合約為屬於或包含租賃。當客戶有權直接指示已識別資產的用途及取得來自該用途的絕大部分經濟利益時，即已轉移控制。為評估合約是否包含控制使用已識別資產的權利，本集團會評估該合約是否符合以下條件：

- 合約涉及使用已識別資產 — 已識別資產可為明確或隱含指定，且應為有形或代表有形資產的絕大部分能力。倘供應商擁有實質性的替代權，則該資產不予識別；
- 本集團有權於使用期間獲取使用該資產的絕大部分經濟利益；及

At inception or on reassessment of a contract that contains lease and non-lease components, the Group allocates the consideration in the contract to each lease component on the basis of their relative stand-alone prices. However, for the leases of land and buildings in which it is a lessee, the Group has elected to separate non-lease components and accounts for the lease and non-lease components separately.

At the lease commencement date, the Group recognises a right-of-use asset and a lease liability, except for short-term leases that have a lease term of 12 months or less and leases of low-value assets. When the Group enters into a lease in respect of a low-value asset, the Group decides whether to capitalise the lease on a lease-by-lease basis. The lease payments associated with those leases which are not capitalised are recognised as an expense on a systematic basis over the lease term.

Where the lease is capitalised, the lease liability is initially recognised at the present value of the lease payments payable over the lease term, discounted using the interest rate implicit in the lease or, if that rate cannot be readily determined, using a relevant incremental borrowing rate. Generally, the Group uses its incremental borrowing rate as the discount rate.

Lease payments included in the measurement of the lease liability comprise the following:

- fixed payments, including in-substance fixed payments;
- variable lease payments that depend on an index or a rate, initially measured using the index or the rate as at the commencement date;
- amounts expected to be payable under a residual value guarantee; and
- the exercise price under a purchase option that the Group is reasonably certain to exercise, lease payments in an optional renewal period if the Group is reasonably certain to exercise an extension option, and penalties for early termination of a lease unless the Group is reasonably certain not to terminate early.

於包含租賃及非租賃組成部分的合約開始或對其重新評估之時，本集團根據相關獨立價格，將合約的代價分配至各租賃組成部分。然而，對於本集團為承租人的土地及樓宇租賃，本集團選擇區分非租賃組成部分，以及將租賃及非租賃組成部分獨立列賬。

於租賃開始日期，本集團確認使用權資產及租賃負債，惟租期為12個月或以內的短期租賃及低價值資產除外。當本集團就低價值資產訂立租賃，本集團視乎個別租賃決定是否將租賃資本化。與該等不予資本化的租賃相關的租賃付款於租期內按有系統基準確認為開支。

資本化租賃時，租賃負債初始乃以租期內須支付之租賃付款之現值確認，使用租賃的隱含利率或（如無法確定該利率）使用相關增量借款利率折現得出。一般而言，本集團使用增量借款利率作為折現率。

計入租賃負債計量之租賃付款包括以下各項：

- 固定付款，包括實質固定付款；

After initial recognition, the lease liability is measured at amortised cost and interest expense is calculated using the effective interest method. Variable lease payments that do not depend on an index or rate are not included in the measurement of the lease liability and hence are charged to profit or loss in the accounting period in which they are incurred.

The right-of-use asset recognised when a lease is capitalised is initially measured at cost, which comprises the initial amount of the lease liability adjusted for any lease payments made at or before the commencement date, any initial direct costs incurred and an estimate of costs to dismantle and remove the underlying asset or to restore the underlying asset or the site on which it is located, discounted to their present value, less any lease incentives received. The right-of-use asset is subsequently depreciated using the straight line method from the commencement date to the earlier of the end of the useful life of the right-of-use asset or the end of the lease term. The estimated useful lives of right-of-use assets are determined on the same basis as those of property, plant and equipment. In addition, the right-of-use asset is periodically adjusted by impairment losses (see note 1(g)(ii)), if any, and certain remeasurements of the lease liability.

The initial fair value of refundable rental deposits is accounted for separately from the right-of-use assets and any difference between the initial fair value and the nominal value of the deposits is accounted for as additional lease payments made and is included in the cost of right-of-use assets.

The lease liability is remeasured when there is a change in future lease payments arising from a change in an index or a rate, or if there is a change in the Group's estimate of the amount expected to be payable under a residual value guarantee, or if there is a change arising from the reassessment of whether the Group will be reasonably certain to exercise a purchase, extension or termination option. When the lease liability is remeasured in this way, a corresponding adjustment is made to the carrying amount of the right-of-use asset, or is recorded in profit or loss if the carrying amount of the right-of-use asset has been reduced to zero.

可退回租賃按金的初始公平值與使用權資產分開入賬及按金的初始公平值與面值的任何差異入賬為已付額外租賃付款及計入使用權資產成本。

The lease liability is also remeasured when there is a change in the scope of a lease or the consideration for a lease that is not originally provided for in the lease contract (“lease modification”) that is not accounted for as a separate lease. In this case the lease liability is remeasured based on the revised lease payments and lease term using a revised discount rate at the effective date of the modification. The only exceptions are any rent concessions that occurred as a direct consequence of the COVID-19 pandemic and met the conditions set out in paragraph 46B of HKFRS 16, *Leases*. In such cases, the Group has taken advantage of the practical expedient not to assess whether the rent concessions are lease modifications, and recognised the change in consideration as negative variable lease payments in profit or loss in the period in which the event or condition that triggers the rent concessions occurred.

In the consolidated and company-level statements of financial position, the current portion of long-term lease liabilities is determined as the principal portion of contractual payments that are due to be settled within twelve months after the reporting period.

The Group recognises a loss allowance for expected credit losses (“ECLs”) on financial assets measured at amortised cost (including cash and bank balances, trade and other receivables and deposits).

Measurement of ECLs

ECLs are a probability-weighted estimate of credit losses. Credit losses are measured as the present value of all expected cash shortfalls (i.e. the difference between the cash flows due to the Group in accordance with the contract and the cash flows that the Group expects to receive).

The expected cash shortfalls for fixed-rate financial assets and trade and other receivables and deposits are discounted using the effective interest rate determined at initial recognition or an approximation thereof where the effect of discounting is material.

當租賃範圍發生變化，或租賃合約中原先沒有規定的租賃代價發生變化（「租賃修改」），且未作為單獨租賃入賬時，亦會重新計量租賃負債。在此情況下，租賃負債乃根據經修訂的租賃付款及租賃期，使用經修訂的折現率於修訂生效日重新計量。唯一的例外是任何因COVID-19疫情而直接產生的租金寬減，且其須符合香港財務報告準則第16號「租賃」第46B段所載的條件。在該等情況下，本集團利用不評估租金寬減是否為租賃修改的實際權宜法，並於觸發租金寬減的事件或狀況發生期間的損益確認代價變更為負可變租賃付款。

Measurement of ECLs (continued)

The maximum period considered when estimating ECLs is the maximum contractual period over which the Group is exposed to credit risk.

In measuring ECLs, the Group takes into account reasonable and supportable information that is available without undue cost or effort. This includes information about past events, current conditions and forecasts of future economic conditions.

ECLs are measured on either of the following bases:

- 12-month ECLs: these are losses that are expected to result from possible default events within the 12 months after the reporting date; and
- lifetime ECLs: these are losses that are expected to result from all possible default events over the expected lives of the items to which the ECL model applies.

Loss allowances for trade receivables are always measured at an amount equal to lifetime ECLs. ECLs on these financial assets are estimated based on the Group's historical credit loss experience, adjusted for factors that are specific to the debtors and an assessment of both the current and forecast general economic conditions at the reporting date.

For all other financial instruments, the Group recognises a loss allowance equal to 12-month ECLs unless there has been a significant increase in credit risk of the financial instrument since initial recognition, in which case the loss allowance is measured at an amount equal to lifetime ECLs.

預期信貸虧損乃按下列其中一個基準計量：

Significant increases in credit risk

In assessing whether the credit risk of a financial instrument has increased significantly since initial recognition, the Group compares the risk of default occurring on the financial instrument assessed at the reporting date with that assessed at the date of initial recognition. In making this reassessment, the Group considers that a default event occurs when the borrower is unlikely to pay its credit obligations to the Group in full, without recourse by the Group to actions such as realising security (if any is held). The Group considers both quantitative and qualitative information that is reasonable and supportable, including historical experience and forward-looking information that is available without undue cost or effort.

In particular, the following information is taken into account when assessing whether credit risk has increased significantly since initial recognition:

- failure to make payments of principal or interest on their contractually due dates;
- an actual or expected significant deterioration in a financial instrument's external or internal credit rating (if available);
- an actual or expected significant deterioration in the operating results of the debtor; and
- existing or forecast changes in the technological, market, economic or legal environment that have a significant adverse effect on the debtor's ability to meet its obligation to the Group.

於評估金融工具的信貸風險自初步確認以來是否大幅增加時，本集團會將於報告日期評估的金融工具發生的違約風險與於初步確認日期評估的違約風險進行比較。進行該重新評估時，本集團認為借款人不大可能在本集團並無採取行動(如變現抵押品，如持有)的情況下向本集團悉數支付其信貸責任時，即發生違約事件。本集團考慮毋須付出過多成本或精力即可獲得的合理及可靠的定量及定性資料，包括過往經驗及前瞻性資料。

具體而言，於評估信貸風險自初步確認以來是否大幅增加時，本集團會考慮以下資料：

Significant increases in credit risk (continued)

Depending on the nature of the financial instruments, the assessment of a significant increase in credit risk is performed on either an individual basis or a collective basis. When the assessment is performed on a collective basis, the financial instruments are grouped based on shared credit risk characteristics, such as past due status and credit risk ratings.

ECLs are remeasured at each reporting date to reflect changes in the financial instrument's credit risk since initial recognition. Any change in the ECL amount is recognised as an impairment gain or loss in profit or loss. The Group recognises an impairment gain or loss for all financial instruments with a corresponding adjustment to their carrying amount through a loss allowance account.

Basis of calculation of interest income

Interest income recognised in accordance with note 1(o)(ii) is calculated based on the gross carrying amount of the financial asset unless the financial asset is credit-impaired, in which case interest income is calculated based on the amortised cost (i.e. the gross carrying amount less loss allowance) of the financial asset.

At each reporting date, the Group assesses whether a financial asset is credit-impaired. A financial asset is credit-impaired when one or more events that have a detrimental impact on the estimated future cash flows of the financial asset have occurred.

Evidence that a financial asset is credit-impaired includes the following observable events:

- significant financial difficulties of the debtor;
- a breach of contract, such as a default or past due event;

- it becoming probable that the borrower will enter into bankruptcy or other financial reorganisation;
- significant changes in the technological, market, economic or legal environment that have an adverse effect on the debtor; or
- the disappearance of an active market for a security because of financial difficulties of the issuer.

Write-off policy

The gross carrying amount of a financial asset is written off (either partially or in full) to the extent that there is no realistic prospect of recovery. This is generally the case when the Group determines that the debtor does not have assets or sources of income that could generate sufficient cash flows to repay the amounts subject to the write-off.

Subsequent recoveries of an asset that was previously written off are recognised as a reversal of impairment in profit or loss in the period in which the recovery occurs.

(ii) Impairment of other non-current assets

Internal and external sources of information are reviewed at the end of each reporting period to identify indications that property, plant and equipment, right-of-use assets and investments in subsidiaries in the Company's statement of financial position may be impaired or an impairment loss previously recognised no longer exists or may have decreased.

If any such indication exists, the asset's recoverable amount is estimated.

— Calculation of recoverable amount

The recoverable amount of an asset is the greater of its fair value less costs of disposal and value in use. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset. Where an asset does not generate cash inflows largely independent of those from other assets, the recoverable amount is determined for the smallest group of assets that generates cash inflows independently (i.e. a cash-generating unit). A portion of the carrying amount of a corporate asset is allocated to an individual cash-generating unit if the allocation can be done on a reasonable and consistent basis, or to the smallest group of cash-generating units if otherwise.

— Recognition of impairment losses

An impairment loss is recognised in profit or loss if the carrying amount of an asset, or the cash-generating unit to which it belongs, exceeds its recoverable amount. Impairment losses recognised in respect of cash-generating units are allocated to reduce the carrying amount of the assets in the unit (or group of units) on a pro rata basis, except that the carrying value of an asset will not be reduced below its individual fair value less costs of disposal (if measurable) or value in use (if determinable).

— Reversals of impairment losses

An impairment loss is reversed if there has been a favourable change in the estimates used to determine the recoverable amount.

A reversal of an impairment loss is limited to the asset's carrying amount that would have been determined had no impairment loss been recognised in prior years. Reversals of impairment losses are credited to profit or loss in the year in which the reversals are recognised.

(iii) Interim financial reporting and impairment

Under the Rules Governing the Listing of Securities on the Stock Exchange of Hong Kong Limited, the Group is required to prepare an interim financial report in compliance with HKAS 34, *Interim financial reporting*, in respect of the first six months of the financial year. At the end of the interim period, the Group applies the same impairment testing, recognition, and reversal criteria as it would at the end of the financial year (see note 1(g)(ii)).

(h) Inventories

Inventories are assets which are held for sale in the ordinary course of business, in the process of production for such sale or in the form of materials or supplies to be consumed in the production process or in the rendering of services.

Inventories are carried at the lower of cost and net realisable value.

Cost is calculated using the first-in-first-out cost formula and comprises all costs of purchase, costs of conversion and other costs incurred in bringing the inventories to their present location and condition.

Net realisable value is the estimated selling price in the ordinary course of business less the estimated costs of completion and the estimated costs necessary to make the sale.

When inventories are sold, the carrying amount of those inventories is recognised as an expense in the period in which the related revenue is recognised.

The amount of any write-down of inventories to net realisable value and all losses of inventories are recognised as an expense in the period the write-down or loss occurs. The amount of any reversal of any write-down of inventories is recognised as a reduction in the amount of inventories recognised as an expense in the period in which the reversal occurs.

(i) Trade and other receivables

A receivable is recognised when the Group has an unconditional right to receive consideration. A right to receive consideration is unconditional if only the passage of time is required before payment of that consideration is due.

Trade receivables that do not contain a significant financing component are initially measured at their transaction price. Trade receivables that contain a significant financing component and other receivables are initially measured at fair value plus transaction costs. All receivables are subsequently stated at amortised cost, using the effective interest method including an allowance for credit losses (see note 1(g)(i)).

(j) Cash and cash equivalents

Cash and cash equivalents comprise cash at bank and on hand, demand deposits with banks and other financial institutions, and short-term, highly liquid investments that are readily convertible into known amounts of cash and which are subject to an insignificant risk of changes in value, having been within three months of maturity at acquisition. Cash and cash equivalents are assessed for ECLs in accordance with the policy set out in note 1(g)(i).

Trade and other payables are initially recognised at fair value. Subsequent to initial recognition, trade and other payables are stated at amortised cost unless the effect of discounting would be immaterial, in which case they are stated at invoice amounts.

A contract liability is recognised when the customer pays non-refundable consideration before the Group recognises the related revenue (see note 1(o)). A contract liability would also be recognised if the Group has an unconditional right to receive non-refundable consideration before the Group recognises the related revenue. In such cases, a corresponding receivable would also be recognised (see note 1(i)).

(l) Employee benefits

(i) Short term employee benefits and contributions to defined contribution retirement plans

Salaries, bonuses, paid annual leave, contributions to defined contribution retirement plans and the cost of non-monetary benefits are accrued in the year in which the associated services are rendered by employees. Where payment or settlement is deferred and the effect would be material, these amounts are stated at their present values.

(ii) Share-based payments

The fair value of share awards and share options granted to employees is recognised as an employee cost with a corresponding increase in a share-based compensation reserve within equity. The fair value is measured at grant date using the valuation model taking into account the terms and conditions upon which the share awards and share options were granted. Where the employees have to meet vesting conditions before becoming unconditionally entitled to the share awards and share options, the total estimated fair value of the share awards and share options is spread over the vesting period, taking into account the probability that the share awards and share options will vest.

Service cost on the net defined benefit liability is recognised in profit or loss as “staff costs”. Current service cost is measured as the increase in the present value of the defined benefit obligation resulting from employee services in the current period.

Remeasurement arising from long service payments, if material, is recognised in other comprehensive income and reflected immediately in retained profits.

(m) Income tax

Income tax for the year comprises current tax and movements in deferred tax assets and liabilities. Current tax and movements in deferred tax assets and liabilities are recognised in profit or loss except to the extent that they relate to items recognised in other comprehensive income or directly in equity, in which case the relevant amounts of tax are recognised in other comprehensive income or directly in equity, respectively.

Current tax is the expected tax payable on the taxable income for the year, using tax rates enacted or substantively enacted at the end of the reporting period, and any adjustment to tax payable in respect of previous years.

Deferred tax assets and liabilities arise from deductible and taxable temporary differences respectively, being the differences between the carrying amounts of assets and liabilities for financial reporting purposes and their tax bases. Future taxable profits that may support the recognition of deferred tax assets arising from deductible temporary differences include those that will arise from the reversal of existing taxable temporary differences, provided those differences relate to the same taxation authority and the same taxable entity, and are expected to reverse either in the same period as the expected reversal of the deductible temporary differences or in periods into which a tax loss arising from the deferred tax asset can be carried back or forward. The same criteria are adopted when determining whether existing taxable temporary differences support the recognition of deferred tax assets arising from unused tax losses and credits, that is, those differences are taken into account if they relate to the same taxation authority and the same taxable entity, and are expected to reverse in a period, or periods, in which the tax loss or credit can be utilised.

The amount of deferred tax recognised is measured based on the expected manner of realisation or settlement of the carrying amount of the assets and liabilities, using tax rates enacted or substantively enacted at the end of the reporting period. Deferred tax assets and liabilities are not discounted.

The carrying amount of a deferred tax asset is reviewed at the end of each reporting period and is reduced to the extent that it is no longer probable that sufficient taxable profits will be available to allow the related tax benefit to be utilised. Any such reduction is reversed to the extent that it becomes probable that sufficient taxable profits will be available.

Provisions are recognised when the Group has a legal or constructive obligation arising as a result of a past event, it is probable that an outflow of economic benefits will be required to settle the obligation and a reliable estimate can be made. Where the time value of money is material, provisions are stated at the present value of the expenditure expected to settle the obligation.

Where it is not probable that an outflow of economic benefits will be required, or the amount cannot be estimated reliably, the obligation is disclosed as a contingent liability, unless the probability of outflow of economic benefits is remote. Possible obligations, whose existence will only be confirmed by the occurrence or non-occurrence of one or more future events are also disclosed as contingent liabilities unless the probability of outflow of economic benefits is remote.

(o) Revenue and other income

Income is classified by the Group as revenue when it arises from the sale of goods or the provision of services in the ordinary course of the Group's business.

Revenue is recognised when control over a product or service is transferred to the customer at the amount of promised consideration to which the Group is expected to be entitled, excluding those amounts collected on behalf of third parties. Revenue excludes value-added tax or other sales taxes and is after deduction of any trade discounts.

Further details of the Group's revenue and other income recognition policies are as follows:

(i) Sale of food and beverages

The Group recognises revenue from the operation of restaurants which provide catering services. Revenue from the provision of catering services is recognised at a point in time when the services are rendered.

Loyalty programme

The Group operates a loyalty programme where customers accumulate reward points from qualified purchases. The reward points earned through qualified purchases entitle the customers to discount future purchases and are considered as a separate performance obligation arising from transactions with customers. The Group estimates the value of the future redemption obligation based on the estimated value of the products or services for which the reward points are expected to be redeemed based on the historical redemption pattern, including an estimate of the lapse of reward points that will not be redeemed. Subsequently, the contract liability is recognised as revenue at the point in time when the customers redeem the reward points in future purchases, or when the Group is legally released from its obligation when the reward points expire.

Coupons

The Group receives consideration when customers purchase coupons, estimates the value of the future redemption obligation based on the estimated value of the products or services for which the coupons are expected to be redeemed, and recognises the estimated fair value in the statement of financial position as a contract liability. Subsequently, the contract liability is recognised as revenue at the point in time when the customers redeem the coupons in future purchases, or when the Group is legally released from its obligation when the coupons expire.

(ii) Interest income

Interest income is recognised as it accrues under the effective interest method using the rate that exactly discounts estimated future cash receipts through the expected life of the financial asset to the gross carrying amount of the financial asset. For credit-impaired financial assets, the effective interest rate is applied to the amortised cost (i.e. gross carrying amount net of loss allowance) of the asset (see note 1(g)(i)).

會員計劃

本集團營運一項會員計劃，此顧客可通過合資格的購買賺取獎賞積分。通過合資格的購買賺取的獎賞積分讓顧客可於未來購買中享有折扣，並被視為與顧客進行交易所產生的一項個別履約責任。本集團根據預期基於過往兌換模式兌換獎賞積分所涉及的產品或服務的估計價值對未來兌換責任價值作出估計，包括估計將不會兌換的失效獎賞積分。其後，於客戶於未來購買中兌換獎賞積分時，或本集團於獎賞積分失效時合法解除其法律責任時，合約負債確認為收益。

優惠券

本集團於顧客購買優惠券時收到對價，根據預期將贖回的優惠券所涉及的產品或服務的估計價值對未來兌換責任的價值作出估計，並以估計公允價值於財務狀況表內確認為合約負債。其後，合約負債於顧客在未來的購買中兌換優惠券之時或當本集團於優惠券屆滿時可依法解除責任之時，確認為收益。

Government grants are recognised in the statement of financial position initially when there is reasonable assurance that they will be received and that the Group will comply with the conditions attaching to them. Grants that compensate the Group for expenses incurred are recognised as income in profit or loss on a systematic basis in the same periods in which the expenses are incurred.

(p) Translation of foreign currencies

Foreign currency transactions during the year are translated at the foreign exchange rates ruling at the transaction dates. Monetary assets and liabilities denominated in foreign currencies are translated at the foreign exchange rates ruling at the end of the reporting period. Exchange gains and losses are recognised in profit or loss.

Non-monetary assets and liabilities that are measured in terms of historical cost in a foreign currency are translated using the foreign exchange rates ruling at the transaction dates. The transaction date is the date on which the Group initially recognises such non-monetary assets or liabilities. Non-monetary assets and liabilities denominated in foreign currencies that are stated at fair value are translated using the foreign exchange rates ruling at the dates the fair value was measured.

The results of foreign operations are translated into Hong Kong dollars at the exchange rates approximating the foreign exchange rates ruling at the dates of the transactions. Statement of financial position items are translated into Hong Kong dollars at the closing foreign exchange rates at the end of the reporting period. The resulting exchange differences are recognised in other comprehensive income and accumulated separately in equity in the exchange reserve.

Impairment of right-of-use assets and property, plant and equipment

Internal and external sources of information are reviewed at the end of each reporting period to assess whether there is any indication that right-of-use assets and property, plant and equipment may be impaired. If any such indication exists, the recoverable amount of the right-of-use assets and property, plant and equipment is estimated. Changes in facts and circumstances may result in revisions to the conclusion of whether an indication of impairment exists and revised estimates of recoverable amounts, which would affect profit or loss in future periods.

3 REVENUE AND SEGMENT INFORMATION

The principal activities of the Group are the operation of restaurants. The restaurants trade in the name of “TamJai” and “SamGor”.

The Group manages its business as a single unit and, accordingly, the operation of restaurants is the only reporting segment and virtually all of the revenue and operating profits is derived from this business segment. The financial statements are already presented in a manner consistent with the way in which information is reported internally to the Group’s most senior executive management for the purposes of resource allocation and performance assessment. Accordingly, no separate business segment information is disclosed.

Revenue represents the sales value of food and beverages and excludes value-added tax or other sales taxes and is after deduction of any trade discounts.

Based on these estimates, impairment losses on the right-of-use assets and property, plant and equipment of \$718,000 (2022: \$ Nil) and \$254,000 (2022: \$ Nil) were reversed respectively.

The respective revenue is recognised when the reward points are redeemed or when the reward points expire. In addition, the Group receives consideration when customers purchase coupons from restaurants at the time of purchase. The respective revenue is recognised when the coupons are redeemed for future sales by customers from restaurants or when the coupons expire.

In particular, (i) employers may continue to use the accrued benefits derived from their MPF contributions (irrespective of the contributions made before, on or after the transition date, and irrespective of mandatory or voluntary contributions) to offset employees' pre-transition portion of long service payments; (ii) pre-transition portion of long service payments of employees will be calculated on the basis of the last month's salary immediately preceding the transition date and the years of service as at the transition date. Currently, the Group does not have any separate funding arrangement in place to meet its long service payment obligation.

The long service payment obligation is dependent on the employees' final salary and years of services, taking into account accrued benefits related to the Group's MPF Scheme contributions that can be used to offset pre-transition long service payments. All of the amount is expected to be utilised after more than one year.

19 RETIREMENT BENEFIT SCHEME

The Group operates a MPF Scheme under the Hong Kong Mandatory Provident Fund Scheme Ordinance for employees in Hong Kong under the jurisdiction of the Hong Kong Employment Ordinance. The MPF Scheme is a defined contribution retirement scheme administered by independent trustees. Under the MPF Scheme, the employer and its employees are each required to make contributions to the MPF Scheme at 5% of the employees' relevant income, subject to a cap of monthly relevant income of \$30,000 (2022: \$30,000). In accordance with section 135 of the Hong Kong Companies Ordinance, the ordinary shares of the Company do not have a par value.

The holders of ordinary shares are entitled to receive dividends as declared from time to time and are entitled to one vote per share at meetings of the Company. All ordinary shares rank equally with regard to the Company's residual assets.

(d) Capital management

The Group's primary objectives when managing capital are to safeguard the Group's ability to continue as a going concern so that it can continue to provide returns for shareholders.

The Group defines "capital" as including all components of equity. Trading balances that arise as a result of trading transactions with other group companies are not regarded by the Group as capital.

The Group actively and regularly reviews and manages its capital structure. Adjustments are made to the capital structure in light of changes in economic conditions affecting the Group, to the extent that these do not conflict with the directors' fiduciary duties towards the Group or the requirements of the Hong Kong Companies Ordinance. The results of the directors' review of the Group's capital structure are used as a basis for the determination of the level of dividends, if any, that are declared.

There has been no change in the Group's capital management practices as compared to prior years. Neither the Company nor any of its subsidiaries are subject to externally imposed capital requirements in the current or prior years.

Therefore, the Share Award Scheme Trust is considered as a controlled structured entity of the Group.

On 25 March 2021 and 9 August 2021, a total of 2,024,000 and 3,000,000 share awards (the “Awarded Shares”) were respectively granted to certain selected employees (including but not limited to directors, executives, officers and other employees, whether full-time or part-time, of any members of the Group) at no consideration under the Company’s Pre-IPO Share Award Scheme.

30% of the total number of the Awarded Shares granted to the grantee will vest from the date on which dealings in the shares first commence on the Hong Kong Stock Exchange (the “Listing Date”); 30% of the total number of the Awarded Shares granted to the grantee will vest from the date immediately after the 1st anniversary of the Listing Date; and 40% of the total number of the Awarded Shares granted to the grantee will vest from the date immediately after the 2nd anniversary of the Listing Date. The selected employees must also remain a director or an employee of the Company or its subsidiaries as at the vesting date.

Exposure to credit, liquidity and interest rate risks arises in the normal course of the Group's business. The Group's exposure to these risks and the financial risk management policies and practices used by the Group to manage these risks are described below.

(a) Credit risk

Credit risk refers to the risk that a counterparty will default on its contractual obligations resulting in a financial loss to the Group. The Group's credit risk is primarily attributable to trade receivables and rental deposits. The Group's exposure to credit risk arising from cash and bank balances is limited because the counterparties are banks and financial institutions which the Group considers to represent low credit risk.

As at 31 March 2023 and 2022, the Group does not have any significant concentration of credit risk and does not provide any guarantees which would expose the Group to credit risk. The maximum exposure to credit risk is represented by the carrying amount of each financial asset in the financial statements.

In respect of trade receivables, the Group has established a credit risk management policy under which individual credit evaluations are performed on all customers requiring credit over a certain amount. These evaluations take into account the customer's past history of making payments when due and current ability to pay, information specific to the customer as well as pertaining to the economic environment in which the customer operates. Trade receivables are due within 30 days from the billing date. Normally, the Group does not obtain collateral from customers.

No credit evaluations are performed for retail customers that transact in cash, stored value smart card or via major credit cards. The Group's trade receivables in connection with sales settled through delivery service platforms are with high credit rating and no past default history. Given that these assets are short-term in nature and the probability of default is negligible on the basis of high-credit rating issuers, the expected credit loss rates were insignificant and close to zero for the years ended 31 March 2023 and 2022, and accordingly, no loss allowance was recognised in respect of trade receivables.

就貿易應收款項而言，本集團制定信貸風險管理政策，據此，對所有需要超過一定金額信貸的客戶進行個別信貸評估。該等評估考慮到客戶過往支付到期款項的紀錄及現時的支付能力、客戶的具體資料及客戶經營所在經濟環境的相關資料。貿易應收款項須於發出賬單日期起計30天內到期。一般而言，本集團不會向客戶索取抵押品。

對於以現金、儲值智能卡或主要信用卡進行交易的零售客戶，本集團並無進行信貸評估。本集團透過外賣服務平台結算的銷售所涉及的貿易應收款項，具有高信貸評級且並無過往違約記錄。於截至二零二三年及二零二二年三月三十一日止年度，鑒於該等資產為短期資產，而按高信貸評級發行人計算，違約的可能性可忽略不計，預期信貸虧損率並不重大且接近零，因此並無就貿易應收款項確認虧損撥備。

Rental deposits are paid to landlords of restaurants. The credit quality of the landlords is assessed based on their financial position and/or past experience of the Group in dealing with the respective landlords. The Group's exposure to credit risk arising from refundable rental deposits is considered to be low, taking into account the landlords' credit rating and the remaining lease term and the period covered by the rental deposits. The directors are of the opinion that the expected credit loss rates for rental deposits were insignificant and close to zero for the years ended 31 March 2023 and 2022, and accordingly, no loss allowance was recognised thereon.

Further quantitative disclosures in respect of the Group's exposure to credit risk arising from trade receivables and deposits are set out in note 12.

(b) Liquidity risk

The Group's policy is to regularly monitor its liquidity requirements to ensure that it maintains sufficient reserves of cash to meet its liquidity requirements in the short and longer term.
