# 管理層討論及分析 MANAGEMENT DISCUSSION AND ANALYSIS

### **FINANCIAL RESULTS**

As the world emerged from the COVID-19 pandemic with optimism, a conflict in The Ukraine and political instability in the UK led to a sharp economic downturn affecting our operations in the UK & the EU. The rising cost of energy to our operation was considerable, and the knock-on impact to the cost and availability of electronic components required careful and considerable management.

Public sector budgets have been squeezed by the need to satisfy wage demands and private sector investment has weakened.

Despite this, the group has risen to the challenge and has broadened our supply chain to secure inventory for our critical messaging devices.

During the year under review, we continued to invest in the development of our next generation of products for the delivery of critical messaging which would embrace Cloud and Internet of Things ("**IOT**") solutions.

The business continued to focus on the delivery of critical messaging solutions. In this regard, our vision is to be the leading provider of integrated communications and automation solutions, helping people embrace the opportunities provided by apps and the Internet of Things whilst guaranteeing business continuity with intelligent systems and robust radio technologies.

### **Technology Business – System Products**

#### **Cloud messaging solutions**

The migration of our highly successful Multitone i-Message<sup>®</sup> critical messaging platform, to allow it to be provisioned from a Cloud computing instance has proven successful as reflected by sales to public sector healthcare in the UK, and interest from other International markets. As an AWS Partner, Multitone continues to utilise the AWS (Amazon Web Services) platform for Cloud computing.

During the year under review the Multitone Messenger smartphone application was released to the market as an additional offering in the field of clinical collaboration.

The Multitone i-Message<sup>®</sup> platform will continue to be maintained and supported whilst we have shifted our R&D focus and investment to our next generation Cloud microservices platform known as Multitone Aurora<sup>™</sup>.

# 財務業績

隨著世界樂觀地擺脱了COVID-19大流行的影響,烏克蘭的衝突和英國的政治不穩造成經 濟急劇下滑,影響了我們在英國和歐盟的業務。我們的能源運營成本不斷上升,這對電子 元件成本和可用性產生了連鎖負面反應,需 要管理層聚精會神地調控。

因滿足工資要求的需要,公共部門的預算受 到擠壓,而私營部門的投資也轉趨疲弱。

儘管如此,集團還是應對了挑戰,並擴大了我 們的供應鏈,以確保我們的緊急訊息傳遞設 備庫存充足。

於回顧年度內,我們持續投資於開發適用於 緊急訊息傳遞的下一代產品,這些產品將採 用雲計算和物聯網(「**物聯網**」)解決方案。

企業繼續專注於緊急訊息傳遞解決方案的提 供。在這方面,我們的願景是成為集成通信和 自動化解決方案的行業先鋒,幫助人們充分 利用應用程式和物聯網提供的機遇,同時通 過智能系統和可靠的無綫電技術確保業務的 連貫性。

### 科技業務一智慧通訊方案

#### 雲端平台的訊息傳遞解決方案

我們的Multitone i-Message<sup>®</sup>緊急訊息傳遞平台 遷移工作非常成功,使其能夠從雲計算實例 進行配置,這一舉措已經取得了廣泛認同,並 體現在我們向英國公共部門醫療行業的銷售 以及其他國際市場客戶的關注上。作為AWS 合作夥伴,Multitone繼續利用AWS(亞馬遜網 絡服務)平台進行雲計算。

於回顧年度內,Multitone Messenger智能手機 應用程式作為醫療配備領域的附加產品,亦 已經在市場上供應。

在我們繼續維護及支持Multitone i-Message<sup>®</sup>平 台的同時,我們亦已將研發重點和投資轉移 到名為Multitone Aurora™的下一代雲微服務平 台。

### Technology Business – System Products (Continued)

### EkoTek<sup>®</sup> & MaBLE

Continued development of Multitone's award winning EkoTek<sup>®</sup> personal security platform has led to an increase in sales in the UK within Mental Healthcare. Following the addition of a new vandal and ligature resistant call point device for the Mental Healthcare market, we are now in the process of developing an enhanced anti-vandal device with an increased impact ("**IK**") rating in order to satisfy further market demands.

In addition to this, Multitone successfully developed and integrated a wander alarm wristband solution for elderly and dementia patient care. MaBLE utilises Bluetooth Low Energy technology and is fully integrated with our EKOMS — EkoTek Management System reporting platform to alert EkoTek users when patient elopement occurs. This product was launched during the period under review and has become a key part of our German subsidiary's sales focus.

#### Revenue

The Group reported a total revenue for the twelve months ended 30 June 2023 of approximately HK\$129 million as compared with approximately HK\$128 million for the previous year, representing an increase of approximately 1.0 percent. This was mainly attributed by the performance in several of our business products, such as (i) sales of EkoTek across the group, which were largely driven by sales into UK Public Sector Mental Healthcare market, and the recovery of the Australian market during the year; (ii) sales of Fires solutions to UK Fire & Rescue services increased; (iii) UK Product Support service contract revenue increase; (iv) sales of Cordless/ DECT solutions in the Australian market as this market recovered following COVID-19; (v) Cloud messaging solutions sales were still modest in contribution to overall i-Message sales. However. Cloud is still a new proposition and as most of our contracts renew, we expect to convert to Cloud based solutions. Alder Hey Children's Hospital is an example of a Cloud sale to UK Healthcare for the year under review.

### Profit Attributable to Owners of the Company

Profit for the year ended 30 June 2023 was approximately HK\$9.7 million as compared with profit of approximately HK\$4.6 million for the previous year. The increase in profit for the year was mainly due to the fair value gain on financial asset. Earnings per share was HK3.72 cents as compared with earnings per share of HK2.06 cents for the previous year.

### 科技業務-智慧通訊方案(續)

### EkoTek<sup>®</sup> & MaBLE

Multitone公司持續開發備受讚譽的EkoTek<sup>®</sup> 個人安全平台,以促使在英國的精神健康醫 療領域銷售額增加。繼為精神健康醫療市場 增加了一種新的防破壞和防勒頸的呼叫設備 後,我們現正開發一種增強型的防破壞設備, 其防沖擊等級(「IK等級」)已被提高,以滿足市 場的進一步需求。

除此之外,Multitone還成功開發和整合了一種 適用於長者和失智症患者使用的智能防走失 手環解決方案。MaBLE採用低功耗藍牙技術, 並與我們的EKOMS - EkoTek管理系統報告平 台整合應用,可在患者走失時向EkoTek用戶發 出警報。該產品在回顧年度期間推出,並已成 為我們德國子公司銷售重點的關鍵組成部分。

### 收益

截至2023年6月30日的12個月內,集團的總 收入約為129.000.000港元,而上一年約為 128,000,000港元,略增長約為1.0%。這主要 歸因於我們在多個業務產品的表現,例如:(i) EkoTek在整個集團範圍內的銷售,其中主要推 動因素是在英國公共部門心理保健市場的銷 售增長以及澳大利亞市場在本年度的復甦;(ii) 向英國消防與救援服務銷售的消防解決方案 的增加;(iii)英國產品支持服務合同收入的增 加; (iv)澳大利亞市場的無線/DECT解決方案 銷售的增加,這是因為該市場在COVID-19後 復甦;(v)雲端平台的訊息傳遞解決方案的銷售 對整體i-Message銷售貢獻仍然較小。然而,雲 仍然是一個新的提議,隨著我們大部分合同 的續簽,我們預計將轉向基於雲的解決方案。 Alder Hey兒童醫院是本財政年度期間向英國醫 療保健部門銷售雲端平台的訊息傳遞解決方 案的一個例子。

### 本公司擁有人應佔溢利

截至2023年6月30日止年度溢利約為9,700,000 港元,而去年同期溢利約為4,600,000港元。溢 利的上升主要由於回顧年內金融資產公平值 收益所致上升。每股盈利為3.72港仙,而去年 同期則為每股盈利2.06港仙。

### FINANCIAL RESULTS (Continued)

### **Distribution Costs**

The Group's distribution costs for the twelve months ended 30 June 2023 were mainly attributed to our principal subsidiary in United Kingdom ("**UK**") — Multitone Electronics PLC ("**Multitone**"), which recorded distribution costs of approximately HK\$26.7 million compared with approximately HK\$24.4 million for the previous year, representing an increase of about 9.4 percent. The increase in distribution cost was mainly due to increase in salaries, pensions and employment costs due to increase in headcount in marketing and headcount in product management, and increase in sales commissions as a result of increase in sales. Furthermore, we implemented 5% salary review and staff retention bonus was provided in view of the UK's tight labour market during the year under review.

### **General and Administrative Expenses**

General and administrative expenses for the year ended 30 June 2023 were increased by approximately 5.0 percent to approximately HK\$48.3 million (2022: approximately HK\$46.0 million). The increase was due to increase in research and development costs for project development, and rising energy costs (especially Electricity), increase in legal & professional fees for UK Group's one-off and non- recurring legal cost on staff dismissal matters of about £75,000 and increase in amortisation & depreciation which was due to the heavy investment in R&D expenditure in recent years.

### **Finance Costs**

Finance costs for the year was increased to approximately HK\$1,290,000 from approximately HK\$629,000 as compared with the fiscal year 2022.

# **REVIEW OF OPERATIONS**

#### **Securities Investments**

As part of the Group's short term investment activities, the Group has invested in some Hong Kong listed securities, the details and information of which are as follows:

As at 30 June 2023, the fair value of the listed equity investments in Hong Kong classified as financial assets at fair value through profit or loss amounted to approximately HK\$14.0 million. This investment portfolio comprised 1 equity security listed in main board of The Stock Exchange of Hong Kong Limited (the "**Stock Exchange**").

# **財務業績**(續) 分銷成本

截至2023年6月30日的12個月,集團之分銷 成本主要產生自我們在英國主要附屬公司 Multitone Electronics PLC(「Multitone」),其分 銷成本錄得約26,700,000港元,較去年同期約 為24,400,000港元增加約9.4%。分銷成本上升 主要是增加營銷和產品管理人員數量導致薪 金、養老金及銷售的佣金上升。此外,鑑於英 國勞動力市場緊張,我們實施加薪5%,並提 供員工保留獎金。

### 一般及行政支出

截至2023年6月30日年度的總務及行政費用增加了約5%,達到約港幣48,300,000元(2022年約為港幣46,000,000)。費用增加是主要由於開發項目研發費用的上升,能源成本(特別是 電費)的上漲,英國集團涉及員工解僱事項的 一次過非經常性法律費用增加(金額約為英鎊 75,000),以及由於近年在研發支出上的大量 投資引致攤銷和折舊的增加。

### 財務成本

年內財務成本增加至約1,290,000港元,而 2022財政年度則約為629,000港元。

#### 1. 6698 STAR CM Holdings Limited

START CM Holdings Limited ("STAR CM") and its subsidiaries (collectively referred to as the "STAR CM Group") are principally engaged in creating, operating and holding the entertainment IPs.

From their initial public offer documents, STAR CM is the largest variety program IP creator and operator in China, they also launched "Sing! China" (中國好聲音). one of the most popular singing competition shows in China. On 14 July 2023, STAR CM announced that they entered into a memorandum of understanding (the "**MOU**") with Nfkings Productions Limited (the "**Nfkings**"), pursuant to which the parties to the MOU intend to enter into a joint venture arrangement to set up a Web3 entertainment company to capitalize on existing and new opportunities in the Web3 entertainment space. These are the positive sign of the development of STAR CM. However, the recent incidence caused the share price of STAR CM dropped by more than 50%. Our investment committee was noted and closely monitored the development of STAR CM. As of the date of this report, we are still considered this investment is worth to hold.

During the year under review, the Group disposed 50,000 shares of STAR CM with a realized gain of HK\$3,625,000 of such investment. As at 30 June 2023, the Group held 130,000 shares in STAR CM and the Group recorded an accumulated unrealized gain of HK\$10,582,000 in respect of such investment.

### **Technology Business – System Products**

#### Cloud i-Message — Amazon Web Services

A significant proportion of our investment in R&D has contributed to the migration of our Multitone i-Message<sup>®</sup> solution from on-premise to the cloud.

Our partnership with Amazon Web Services (AWS) on which our cloud platform is deployed has enabled us to offer a trusted cloud platform to our existing healthcare customers who are adopting a cloud first strategy.

#### 1. 6698星空華文控股有限公司

星空華文控股有限公司(「**星空華文**」)及其附屬公 司(統稱「**星空華文集團**」)主要從事創造、經營及 持有娛樂IP。

從他們的初始公開報價文件, 星空華文是中國 最大的綜藝IP創作者和運營商, 他們還推出了中 國最受歡迎的歌唱比賽節目《中國好聲音》。於 2023年7月14日他們與Nfkings Productions Limited (「Nfkings」)訂立一份諒解備忘錄(「諒解備忘 錄」), 據此, 諒解備忘錄的訂約方擬訂立一份合 營安排以成立一間Web3娛樂公司(「合營安排」), 藉此以把握Web3娛樂領域的現有機會和新機 會。這些都是星空華文發展的積極信號。然而, 近期事件導致星空華文股價下跌超過50%。我們 的投資委員會注意到並密切關注星空華文的發 展。截至本報告出具之日, 我們仍認為此項投資 值得持有。

於回顧年度內,本集團出售星空華文50,000股股份,該等投資已實現收益3,625,000港元。於 2023年6月30日,本集團持有130,000股星空華 文股份,本集團就該投資錄得累計未實現收益 10,582,000港元。

Multitone is a member of the AWS Partner Network as a Technology Partner and we will continue to work with AWS to deliver ultra-fast, highly reliable Multitone i-Message<sup>®</sup> services in the cloud.

AWS is highly secure and offers excellent resilience with over 99.9% availability. AWS is also global, delivering cloud services across every continent which will help Multitone to market our cloud solutions worldwide. (As referenced at https://www.multitone.com/partnerships/)

We now have a number of NHS customers in the UK utilising our AWS instance for the provision of Smartphone Messaging applications, to supplement their existing on-premise radio paging solutions.

This combination of being able to support Smartphone applications from our AWS cloud instance, and also support the radio based on-premise paging infrastructure from the cloud is a key differentiator between Multitone and its competitors in the UK.

#### The Award winning EkoTek Personal Security solution

Through continued innovation of our EkoTek and EkoCare family of products we have been successful in winning a number of high-profile contracts within the Mental Healthcare market.

Our next generation EkoTek Hub (aka Controller) was released to sales as expected in Q1 2022 and has resulted in the ability to deploy larger EkoTek solutions supporting a greater number of devices.

The development of a vandal and ligature resistant call point device for our EkoTek range of products, resulted in a successful bid to deploy our solution at the Camden & Islington Mental Healthcare NHS Trust, Highgate Hospital.

This was the largest ever EkoTek solution deployed in the UK which has led to EkoTek becoming an award-winning solution at the Health Tech Digital Awards 2022 for Best Mental Health Solution.

#### Paging

The demand for paging remained strong during the period under review. The period showed a modest growth in the volume of paging receivers sold, which supports our continued investment in paging as the best technology for critical messaging.

### **Cultural Products**

Cultural products, including precious stones and artifacts, valued at HK\$567,000 (as at 30 June 2022: HK\$4,303,000) have been held for trading and resale in the ordinary course of business. They were included in the inventories of the Group as at 30 June 2023. Unfortunately, due to the COVID-19 pandemic which led to the significant deterioration of economy had caused very substantial downturn in both prices and turnover of cultural products in China.

All such cultural products, totalling 143 pieces, have been kept in a secured warehouse run by a world-renowned security solution company, which is an independent third party to the Group.

### **Money Lending Transactions**

During the year under review, the Company's PRC subsidiary entered into four lending contracts ("**Loans**") with four PRC companies respectively, both of which are independent third parties. The amount of loan is RMB2.6 million, RMB2.4 million, RMB2.5 million and RMB2.7 million respectively. The terms of the three Loans are for a period of six months and the remaining one is for a period of twelve month started from the drawdown date, and interest rate is 8% and 6% per annum respectively. The Loans are properly backed by four guarantors whose financial strength are considered strong enough to act as guarantors of these loans. All these loans were settled in full on time.

Money lending services were only provided incidentally by the PRC subsidiary of the Company. Such PRC subsidiary has never held itself out to the public as money lenders and has never canvassed any borrower to borrow money from it. Therefore, the Directors do not consider or regard that money lending is part of the Company's principal or core business during this Period.

The money lendings were confined to term loan financing with fixed interest rates. All proposed lendings were considered case by case and no particular industry was specified for this purpose. However, the Company does have its own money lending checklist which the Directors would have to observe should the occasion arise.

Any loan will only be made with our idle funds, and it should only be granted to those who approach the directors of the subsidiary by their acquaintances. They would then carry out the credit assessment process and if the results were to their satisfaction, they would submit the requests to the Directors in Hong Kong for further assessment and approval.

於2023年6月30日,計入本集團存貨中包括文 化產品(即珍貴寶石及藝術品)價值為567,000 港元(於2022年6月30日:4,303,000港元),將 於日常貿易業務中持作買賣及轉售。很不幸 的是,由於COVID-19疫情導致經濟嚴重惡化, 中國文化產品的價格和銷售額都出現了非常 大幅度的下降。

上述文化產品合共143件,現存放在一間由世 界知名的保安公司營運之保險庫內,該保安 公司為本集團的獨立第三方。

### 放貸業務

於回顧年內,本公司之中國附屬公司分別 與四家中國公司(均為獨立第三方)訂立四 份貸款合同(「**貸款**」)。貸款額分別為人民幣 2,600,000元、人民幣2,400,000元、人民幣 2,500,000和人民幣2,700,000。三份貸款合同 的貸款期限為提款日起計六個月、第四份貸 款合同的貸款期限為提款日起計十二個月, 年利率分別為8%及6%。貸款得到四名擔保人 的擔保,其財務實力被認為足以擔任這些貸 款的擔保人。所有這些貸款均按時全額償還。

放貸服務僅由本公司之中國附屬公司偶然提 供。該中國子公司從來沒有向公眾展示自己 為放債人,也從來沒有兜攬任何人向他們貸 款。因此,董事並不考慮或認為放貸為本公司 於本期間內的主要或核心業務的一部份。

放貸僅限於固定利率的定期貸款。所有潛在 的貸款都是逐個個案考慮,亦沒有限於指定 的特定行業。然而,本公司有其本身的放貸程 序流程,倘有貸款情況發生,董事將遵守該流 程中的程序審批。

任何貸款都只能使用我們的閒置資金進行, 並且只可以貸款給附屬公司董事相熟的人。 然後,他們將對其進行信用評估程序,如果結 果令他們滿意,他們將向香港董事提交請求 以進行進一步評估和批准。

# Such assessment and know your client ("KYC") processes follow the procedures below:

- 1. Verify the identity of the directors of the borrowers and guarantors;
- 2. Verify the address proof of the borrowers and guarantors;
- 3. Obtain a copy of the business registration certificate and company number if applicable;
- Check the memorandum & articles of association of the borrower and 4. the guarantor if applicable;
- 5. Identify the tax position of the borrower by checking the tax clearance 5. certificate from the PRC competent authority;
- Obtain the due diligence report from National Enterprise Credit 6. Information Publicity System (國家企業信用信息公示系統), and if necessary, seek advice from external legal advisers; and
- 7. Obtain and study the financial statements, preferably audited financial statements if the potential borrower is an entity.

After the collection and verification of above background information of the intending borrowers, our PRC director and the company secretary department of the Group would conduct a loan assessment process through:

- 1. Obtaining the corporate bank account information;
- 2. Assessing the creditability and financial position of the borrowers by checking the latest audit report and management accounts and personal financial background of the guarantor, where appropriate; and
- 3. Obtaining board minutes of the borrowers for approving the lending.

After having due regard to the borrower's financial situation, the extent and quality of collaterals/guarantee and the loan tenure, the director of the PRC subsidiary would offer an interest rate which would tend to maximize profit and yet would comply with the PRC's rule in determining the maximum interest rates of the loans to ensure that we would not impose interest rates higher than the statutory ceiling. Normally, the PRC subsidiary would charge not less than double of the China Loan Prime Rate ("**CLPR**").

As of now, the maximum interest rate should not exceed 14.6% p.a., i.e. 4 times of the CLPR which is around 3.65% p.a..

The above due diligence report, KYC and credit assessment documents together with the amount, terms and repayment method of the loans would be submitted to the board of directors of the Group for approval. After the approval was granted, the final loan agreement would be signed by our PRC director of the subsidiary with the borrower and the guarantor.

The PRC directors of the subsidiary would maintain personal contact with the borrowers from time to time during the tenure of the loan and would start reminding them for repayment about one month before the respective due dates.

The following are our standard procedures for any delinquent loans:

- 1. Demand letter will be sent to the borrower for immediate repayment;
- 2. Instruct our PRC lawyer to issue demand letter to the borrower and guarantor to demand for immediate repayment; and
- 3. Formal legal action will be taken if:
  - (a) The borrower refuses to repay; or
  - (b) After 14 working days from the date of our legal demand letter if no settlement arrangement could be reached.

Ever since the current management permitted the granting of such term loans, there has been no sign that Loans would become delinquent.

Following two years of volatility due to the COVID-19 pandemic it was hoped that we would see a return to more predictable outcomes. However, the conflict in The Ukraine, and the resultant fiscal policies adopted to counter the impact of inflationary pressures has led to a continued impact on the supply chain, coupled with rising energy prices.

Component shortages, supply chain interruption, and cost increases continue to challenge the management team, but these are starting to ease, leading to a recovery in the second half of the fiscal year.

# 未來前景

零件短缺、供應鏈中斷和成本增加持續對管 理團隊帶來挑戰。但這些問題正在開始緩解, 從而導致財年下半年的復甦。

### Multitone Aurora™

Development effort continues on the Cloud optimised planned successor to the Multitone i-Message<sup>®</sup> platform. The first deliverable from the project is due in the forthcoming fiscal year, which will provide a device agnostic secure messaging and chat application supporting desktop, tablet and mobile devices. Additional phases of development have commenced to support features for Healthcare, Estate Management and Retail customers.

# Paging and the future — The Multitone Digital Alerter ("MDA")

Whilst traditional paging continues to support the majority of our hardware device sales in the UK and internationally, there is a continued drive towards newer transmission technologies such as Wi-Fi and Bluetooth.

Our new device being developed under the project name of the Multitone Digital Alerter ("**MDA**") includes an e-ink display, rapid charging, 2 way communication and message receipt acknowledgement using Wi-Fi and Bluetooth Low Energy ("**BLE**"). Whilst development of this device continues, early iterations of the design are promising with an expected sales release towards the end of 2023.

# Wander Alarm Wristband Solution for Elderly and Dementia Patient Care

MaBLE utilises Bluetooth Low Energy technology and is fully integrated with our EKOMS — EkoTek Management System reporting platform to alert EkoTek users when patient elopement occurs. This product was launched during the period under review and is a key part of our German subsidiary's sales focus.

Since MaBLE was released in the last quarter during the year under review and therefore, it does not have impact on the revenue for the year under review. The initial development was focused on features required for the German market. We expect a contribution to sales in Germany in the next financial year.

### Multitone Aurora™

我們仍在致力開發針對Multitone i-Message<sup>®</sup>平 台的雲優化計劃的後續產品。該項目的第一 個交付成果將在即將到來的財年中完成。該 產品將提供一款跨設備兼容的安全訊息和聊 天應用軟件,同時支持桌面、平板和移動設 備。額外的開發階段已經啟動了,用作支持醫 療保健、房地產管理和零售客戶的功能需求。

### 傳呼技術的未來一Multitone數字 警報器(「數字警報器」)

儘管傳統的傳呼技術仍然支持著我們在英國和國際市場上大部分的硬件設備銷售,但 我們現正持續推進採用更新的傳輸技術,如 Wi-Fi和藍牙。

我們正在開發的新設備,項目代號為Multitone 數字警報器(「MDA」),包括電子墨水顯示屏、 快速充電、雙向通信以及使用Wi-Fi和低功耗 藍牙(「BLE」)進行消息接收確認。儘管該設備 的開發仍在進行中,但初期設計的迭代版本 表現出了良好的前景,預計將於2023年年底 發佈銷售。

### 智能防走失手環解決方案用於長 者和失智症患者使用

MaBLE利用低功耗藍牙技術,並與我們的 EKOMS - EkoTek管理系統報告平台整合應 用,可在患者走失時向EkoTek用戶發出警報。 該產品在回顧年度期內推出,亦是德國子公 司重點銷售關鍵組成部分。

由於MaBLE是在回顧年度內的最後一個季度發佈的,因此對回顧年度內的收入沒有影響。 最初的開發工作主要針對德國市場所需的功能。我們預計在下一個財年中,MaBLE將對德國的銷售做出貢獻。

### The UK Market

The UK Sales operation has exceeded targets for the fiscal year despite significant challenges. Whilst it is largely expected that the challenges highlighted earlier in this report will remain until at least the end of 2023, there are significant projects within the sales pipeline. The UK team remains focused and confident that they can achieve an increased sales target in the new fiscal year.

There is also much to take from the success we have seen during the period under review and positivity regarding the Multitone Cloud offerings and performance of our EkoTek<sup>®</sup> sales in the UK Public sector Mental Healthcare market.

It is vital that we address market and customer feedback with the launch of both Multitone Aurora<sup>™</sup> and the MDA in the forthcoming fiscal year. These products will further enhance our available solutions and open new potential markets.

### The EU Market

Our subsidiary in Germany adjusted its financial year strategy in accordance with economic developments in the EU region. Focus was given to develop public projects which are well funded during a period of weaker private sector investment. Outside of Germany but within the EU the market is recovering after COVID-19 with key-distributors in France and Scandinavia increasing their sales.

### **Other markets**

#### Oceania - New Zealand & Australia

Despite the challenges, we have seen increased activity and sales, with the addition of a new distributor in New Zealand, opening up opportunities for increased sales of Multitone i-Message<sup>®</sup> and EkoTek<sup>®</sup> solutions. Sales during the period under review in this region have recovered and exceeded prepandemic levels.

### **US Market**

The US Market remains behind expectations. Strategic meetings and action plans are yet to be implemented by our in region partners, although revenue has been ahead of the previous period.

### 歐盟市場

我們在德國的子公司根據歐盟地區的經濟發展調整了財年策略。在私營企業投資疲弱時, 重點是要開發公共投資項目,這些項目資金 相對充裕。在德國以外的歐盟地區,市場氣氛 在COVID-19疫情後正在復甦,我們在法國和 斯堪的納維亞地區的主要經銷商銷售額亦受 惠上升。

### 其他市場

#### 大洋洲一新西蘭和澳大利亞

儘管面臨挑戰,但我們在新西蘭看到了活動和銷售的增長,新增了一家經銷商,為 Multitone i-Message<sup>®</sup>和EkoTek<sup>®</sup>解決方案提供了 銷售增長的機遇。在回顧年度期間,該地區的 銷售復甦,並超過了疫情前的水平。

### 美國市場

### **Iconic Projects**

Multitone has been successful in winning opportunities in the UK for iconic institutions such as the Camden & Islington NHS Foundation Trust (CANDI), and a number of UK Fire & Rescue services including the London Fire Brigade and the Dorset & Wiltshire Fire and Rescue Service.

Our subsidiary in Germany has been successful in winning its largest order ever for the supply of a messaging solution to the Klinikum der Universität München.

# LIQUIDITY AND FINANCIAL RESOURCES

### **Financial Position and Gearing**

The Group's financial position remained positive.

As at 30 June 2023, the Group had approximately HK\$101 million (2022: approximately HK\$108 million) liquid assets made up of deposits, bank balances and cash. Current assets were approximately HK\$176 million (2022: approximately HK\$159 million) and current liabilities amounted to approximately HK\$87 million (2022: approximately HK\$75 million). With net current assets of approximately HK\$89 million (2022: approximately HK\$84 million), the Group maintained a healthy level of financial liquidity. As at 30 June 2023, the Group had no borrowings (2022: no borrowings) and a zero-gearing ratio (2022: zero gearing ratio of the Group, defined as the Group's total borrowings to equity attributable to owners of the Company, was zero).

The Company has been maintaining sufficient cash levels to enable it to meet its liabilities as they fall due. Management reviews cashflow forecasts on a regular basis to determine sufficient cash reserves to meet future working capital requirements and to take advantage of business opportunities.

Finance costs for the year ended 30 June 2023 was approximately HK\$1,290,000 (2022: approximately HK\$629,000).

本集團維持正面良好的財務狀況。

### **Treasury Policy**

The Group is committed to manage its financial resources prudently and to maintain a positive liquid financial position with reasonable gearing. The Group finances its operation and business development by a combination of internally generated resources and from the capital market.

The group's sales to its customers in Europe are in Euros, and to its customers in other countries in US Dollars and Sterling, therefore the group is exposed to movements in the Euro and US Dollar to Sterling exchange rate. The group also sources products in Euros and US Dollars and therefore minimises the risk of exchange rate fluctuations by the operation of both Euro and US Dollar currency bank accounts. The group trades with companies and organisations in more than 30 countries around the world. This geographical spread facilitates a reduced exposure to any particular region of the world where exchange rate risks may occur.

As the level of borrowing was low during the year under review, there was no currency risk exposure associated with the Group's borrowings.

The Group does not engage in any speculative derivatives or structured product transactions, interest rate or foreign exchange speculative activities. It is the Group's policy to manage foreign exchange risk through matching foreign exchange income with expense and, where significant exposure to foreign exchange is anticipated, appropriate hedging instruments may be used.

Management deems the exposure on interest rate risk to be low since the Group's borrowing has been maintained at a low level.

### **Capital Commitments**

The Group did not have any capital commitments as at 30 June 2023 (2022: Nil).

#### Charges

Certain property, plant and equipment of the Group with the aggregate carrying amounts of approximately HK\$10.2 million (30 June 2022: approximately HK\$9.8 million) and the future income to be generated from those contracts of service and equipment rental with an aggregate amount of approximately HK\$37 million (30 June 2022: approximately HK\$32 million) have been pledged as collaterals for the defined benefit retirement scheme of certain subsidiaries operating in UK.

Save as disclosed above, the Group did not have any charges on assets as at 30 June 2023.

# **PRINCIPAL ACTIVITIES**

The Company is an investment holding company. The Group is principally engaged in sale of systems products, software licensing and customisation, leasing of systems products and trading of cultural products.

### **BUSINESS REVIEW**

A review of the Group's business, an indication of its likely future development and an analysis as well as particulars of important events affecting the Group that have occurred since the end of the year ended 30 June 2023 are discussed in the "Chairperson's Statement" and "Management Discuss and Analysis", sections from pages 5 to 20. On the other hand, a description of the principal risks and uncertainties faced by the Group is set out in the "Corporate Governance Report" on pages 38 to 62. The above discussions form part of this report.

In addition, the financial risk management objectives and policies of the Group are shown in note 5 to the consolidated financial statements.

# ENVIRONMENTAL POLICY AND PERFORMANCE

The Group puts great emphasis in environmental protection and energy conservation to enhance the capacity of sustainable development and undertake relative social responsibility. Through the establishment of an everimproving management system, energy conservation and environmental protection were strongly promoted, leading to the remarkable achievement of environmental management.

#### **INTRODUCTION**

The Board and the senior management of the Company are committed to establishing good corporate governance practices and procedures. The maintenance of high standard of business ethics and corporate governance practices has always been one of the Group's goals. The Company believes that good corporate governance provides a framework that is essential for effective management, successful business growth and a healthy corporate culture, thereby leading to the enhancement of shareholders' value.

Two of the independent non-executive Directors have appropriate accounting and financial management expertise. The number of independent nonexecutive Directors is more than one-third of the Board. Biographical details of the other Directors are set out in the paragraph headed "Directors and senior management profile" on pages 21 to 25 of this report.

The presence of three independent non-executive Directors is considered by the Board to be a reasonable balance between executive Directors and nonexecutive Directors. The Board is of the opinion that such balance can provide adequate checks and balances to safeguard the interests of shareholders and of the Group. The independent non-executive Directors provide to the Group with a wide range of expertise and experience so that independent judgement can be exercised effectively. They have also participated in Board meetings and general meetings, dealt with potential conflicts of interest, served on audit committee, human resources and remuneration committee and nomination committee of the Company and scrutinized the Group's performance and reporting. Through their active participation, the management process of the Company can be critically reviewed and controlled.

The Directors have distinguished themselves in their field of expertise, and have exhibited high standards of personal and professional ethics and integrity. All Directors have given sufficient time and attention to the Company's affairs. The Board believes that the ratio among executive Directors, non-executive Directors and independent non-executive Directors are reasonable and adequate to perform check and balance function over the Board in the decision-making process.

The Board is responsible for the appointment of new Director and nomination for re-election by shareholders at the annual general meeting of the Company. Under the Articles of Association, the Board may from time to time appoint a new Director either to fill a vacancy or as an addition to the Board. Any new Director appointed to fill a casual vacancy or as an addition to the existing Board shall hold office until the next annual general meeting after his/her appointment and shall then be eligible for re-election at such meeting.

#### **Chairperson and Chief Executive Officer**

Code provision C.2.1 of the CG Code stipulates that the roles of Chairman and Chief Executive Officer should be separate and should not be performed by the same individual. The division of responsibilities between the Chairman and the Chief Executive Officer should be clearly established and set out in writing.

The role of Chairman is being performed by Mr. Chan Koon Wa, who is also being an executive Director, and he is responsible for the overall strategic planning and development of the Group and the effective functioning and leadership of the Board.

The Company has no such title as the Chief Executive Officer and therefore the daily operation and management of the Company has been monitored by the executive Director and assisted by the non-executive Directors as well as the senior management.

The Board is of the view that although there is no Chief Executive Officer, the balance of power and authority is ensured by the operation of the Board, which comprises experienced individuals and who meet from time to time to look after the operations of the Company.

#### **INDEPENDENCE**

The Company has received an annual confirmation of independence from each of the independent non-executive Directors in accordance with Rule 3.13 of the Listing Rules and each of them has declared fulfilment of all the guidelines for assessing independence in accordance with Rule 3.13 of the Listing Rules. Accordingly, the Company considers that all the independent non-executive Directors are independent.

All independent non-executive Directors are identified as such in all corporate communications containing the names of the Directors. In addition, there is no material relationship between Board members.

Draft notice and agenda for regular meetings are provided to all Directors for comments and inclusion of any matters for deliberation at the meetings. Apart from holding regular meetings, senior management from time to time provides to the Directors information on activities and development of the business of the Group. The company secretary assists the Chairperson in preparing agenda for the meetings and ensures that all applicable rules and regulations in connection with the meetings are observed and complied with. Except for ad hoc Board meetings to deal with urgent issues, the agenda and Board papers are then sent to all Directors at least 3 days prior to the meeting. The company secretary also takes detailed minutes, keeps records of matters discussed and decision resolved at the meetings.

During regular meetings of the Board, the Directors discuss and formulate the overall strategies of the Group, monitor financial performances, review the annual and interim results, and make decisions on significant matters. The execution of daily operational matters is delegated to the senior executives of the Group.

The company secretary records the proceedings of each Board meeting in detail by keeping minutes, including the record of all decisions resolved by the Board together with concerns raised and dissenting views expressed (if any). Draft Board minutes are circulated to all Directors for comment and approval as soon as practicable after the meeting. All minutes are open for inspection at any reasonable time upon request by any Director.

All Directors have access to relevant and timely information at all times and they may make further enquiries if it is necessary to do so.

They also have unrestricted access to the advice and services of the company secretary, who is held responsible for providing Directors with Board papers and other related materials. The company secretary also ensures that proper Board procedures are followed and that all applicable laws and regulations are complied with. If the Directors consider necessary and appropriate, they may retain the service of independent professional advisers at the Group's expense.

In case where a conflict of interest arises involving a substantial shareholder or a Director, such matter will be resolved in a physical meeting instead of passing written resolutions. Independent non-executive Directors with no conflict of interest will be present at meetings to deal with such conflict issues.

The Board committees, including the audit committee, the human resources and remuneration committee, the nomination committee and the investment committee, have all adopted the applicable practices and procedures used in Board meetings.

The annual general meeting and other special general meetings of the Company are the primary forum for communication with its shareholders and for shareholders' participation. All shareholders are encouraged to attend the general meetings or to appoint proxies to attend and vote at meetings on their behalf if they are unable to attend.

During the year ended 30 June 2023, the Company held its annual general meeting on 29 December 2022. Details of major items discussed in that general meetings are set out in the circulars of the Company dated 30 November 2022.

During the year under review, the human resources and remuneration committee held one meeting to review and make recommendations to the Board on the remuneration packages of all Directors and senior management.

#### NOMINATION COMMITTEE

The nomination committee was established with specific written terms of reference which was revised and adopted on 23 September 2014. As at 30 June 2023, the nomination committee consists of three independent non-executive Directors, namely, Mr. Leung Man Fai (chairperson), Ms. Chung Sau Wai Ada and Mr. IP Wai Lun William.

### **AUDIT COMMITTEE**

The Company established an audit committee with specific written terms of reference which was revised and adopted on 1 January 2016. The main duties of the audit committee include, among other things, the following:

- (a) to review the financial statements and reports and consider any significant or unusual items raised by the Company's staff responsible for the accounting and financial reporting function or external auditor before submission to the Board.
- (b) to review the relationship with the external auditor by reference to the work performed by the auditor, their fees and terms of engagement, and make recommendation to the Board on the appointment, reappointment and removal of external auditor.
- (c) to review the adequacy and effectiveness of the Company's financial reporting system, internal control system and risk management system and associated procedures.

The audit committee is provided with sufficient resources to discharge and perform its duties.

Other duties of the audit committee are set out in its specific terms of reference which is posted on the websites of the Stock Exchange and the Company. The audit committee shall meet at least twice a year.

As at 30 June 2023, the audit committee consists of three independent nonexecutive Directors, namely Mr. Leung Man Fai (chairperson), Ms. Chung Sau Wai Ada and Mr. IP Wai Lun William. No member of the audit committee is a former partner of the existing audit firm of the Company within two years from the date of his ceasing to be a partner or had any financial interest in the auditing firm. The audit committee has reviewed the accounting principles and practices adopted by the Group and discussed internal controls and financial reporting matters with the management team of the Company.

During the year under review, the audit committee held two meetings to review, among other things, the Company's interim report for the six months ended 31 December 2022 and annual report for the year ended 30 June 2022. The audit committee has also reviewed the financial reporting and compliance procedures, report on the Company's internal control and risk management review and processes as well as the re-appointment of the external auditor. There is no material uncertainty relating to events and conditions that may cast significant doubt on the Company's ability to continue as a going concern. There is no disagreement between the Board and the audit committee regarding the selection, appointment, resignation or dismissal of external auditor.

The accounts for the year were audited by Cheng & Cheng Limited, whose term of office will expire upon the forthcoming annual general meeting. The audit committee has recommended to the Board that Cheng & Cheng Limited be nominated for re-appointment as the auditor of the Company at the forthcoming annual general meeting.

The company secretary keeps full minutes of all audit committee meetings. In line with practices consistent with Board meetings and other committee meetings, draft and final version of audit committee meeting minutes are circulated to all members of the audit committee for comments, approval and record as soon as practicable after each meeting.

#### **INVESTMENT COMMITTEE**

The investment committee was established with specific written terms of reference which was adopted on 15 August 2017. As at 30 June 2023, the investment committee consists of one non-executive Director, namely, Mr. Liu Ka Lim (chairperson), one independent non-executive Director, namely, Ms. Chung Sau Wai and two executive staffs of the Company. The investment committee is responsible for, among other things, to review investment performance and to advise the Company on their investment of cash, cash equivalents, financial assets, margin deposits, cash collateral taking account of the necessary constraints on the deployment of the various sources and purposes of the funds to enhance the Company's investment returns.

The specific terms of reference of the investment committee is posted on the websites of the Stock Exchange and the Company. The investment committee meets at least twice a year.

During the year under review, the investment committee held two meetings to consider and review the possible securities investments of the Group.

投資委員會的特定職權範圍刊登於聯交所及 本公司網站。投資委員會每年最少舉行兩次 會議。

於回顧年度內,投資委員會舉行二次會議以 商討及審閱本集團有可能之證券投資。

#### **DIRECTOR NOMINATION POLICY**

The Company has adopted the director nomination policy ("**Nomination Policy**") on 28 December 2018 which sets out the criteria and process in the nomination and appointment of directors of the Company. This Nomination Policy ensures that the Board has a balance of skills, experience and diversity of perspectives appropriate to the Company; and ensures Board continuity and appropriate leadership at Board level.

The Nomination Policy contains a number of factors in assessing the suitability of a proposed candidate, which include his or her ability to devote sufficient effort to the affairs of the Company and contribute to the diversity of the Board as well as the effective carrying out by the Board of the responsibilities.

If the candidate is proposed to be appointed as an independent nonexecutive Director, his or her independence shall be assessed in accordance with, among other things, the factors as set out in Rule 3.13 of the Listing Rules, subject to any amendments as may be made by the Stock Exchange from time to time. Where applicable, the totality of the candidate's education, qualifications and experience shall also be evaluated to consider whether he or she has the appropriate professional qualifications or related management expertise for filling the office of an independent non-executive Director with such qualifications or expertise as required under Rule 3.10(2) of the Listing Rules.

This Policy also lays down the nomination procedures on appointment or reappointment of directors. The Nomination Committee will conduct the relevant selection process (coupled with the relevant selection criteria) against the nominated candidate for new directorship or director offering for reelection and make recommendations to the Board for consideration. Where appropriate, the Nomination Committee and/or the Board should make recommendation to shareholders in respect of the proposed election and reelection of director at the general meeting.

#### **BOARD DIVERSITY POLICY**

The Board has adopted a board diversity policy setting out the approach to achieve diversity within the Board. The Company considered that diversity of board members can be achieved through consideration of a number of aspects, including but not limited to gender, age, cultural and educational background, professional experience, skills and knowledge. All Board appointments will be based on meritocracy, and candidates will be considered against objective criteria, having due regard to the benefits of diversity on the Board.

The ultimate decision will be made upon the merits of the selected candidates and their contribution to the Board.

#### **WORKFORCE DIVERSITY**

As at 30 June 2023, the ratio of male and female in the workforce by gender and age of the Group (including executive directors and senior management) is 30% and 70% respectively as set out above. In compliance with Code B.1.4 of the CG Code, on 29 December 2022, the Company has established and adopted the mechanisms that was to ensure a strong independent element, and independent views and input are available to the board of directors of the Company (the "**Mechanisms**"). The Mechanisms cover composition of the board and board committees; independence assessment; compensation, Board's decision making; and review of the policy implementation. The Board will review the implementation and effectiveness of the Mechanisms annually. At the meeting held on 27 September 2023, the Board has reviewed the implementation and effectiveness of the Mechanisms and considered that the Group was satisfied with the independence status of all the independent non-executive directors.

#### **ANTI-CORRUPTION POLICY**

On 29 December 2022, the Company adopted an anti-corruption policy ("Anti-Corruption Policy"), this policy is to outline the Company's expectations and requirements on prevention, detection, reporting and investigation of any suspected fraud, corruption and other similar irregularities; and to provide information and guidance on recognizing and dealing with bribery and corruption, the Company has established its group-wise anti-corruption policy that complies with Code D.2.7 of the CG Code.

Under the Anti-Corruption Policy, the Group has established the Code of Business Conducts, and has put in place internal control mechanism to prevent the occurrence of fraud, theft, bribery, corruption and other misconducts involving employees, customers and other third parties.

The Anti-Corruption Policy is reviewed and updated periodically to align with the applicable laws and regulations as well as the industry best practice.

#### WHISTLE-BLOWING POLICY

The Group is committed to achieving and maintaining the highest standards of openness, probity and accountability, the Company has established a whistle-blowing policy which forms an important part of its effective risk management and internal control systems.

Under the whistle-blowing policy, the Group allows stakeholders to report suspicious negligence, corruption, bribery and other misconduct to the Group anonymously. All reported cases are investigated confidentially to ensure the whistle-blower is protected.

The whistle-blowing policy is reviewed and updated periodically to align with the applicable laws and regulations as well as the industry best practice.

我們會定期檢討及更新反腐敗政策,以符合 適用的法律法規以及行業最佳慣例。

#### 舉報政策

本集團致力於追求及保持最高標準的開放、 誠信及問責,本公司已制定舉報政策,該政策 是其有效風險管理及內部控制系統的重要組 成部分。

根據舉報政策,本集團允許利益相關者匿名 向本集團舉報可疑的疏忽、貪污、賄賂及其他 不當行為。所有舉報的案件都會受到保密調 查,以確保舉報人受到保護。

本集團會定期檢討及更新舉報政策,以符合 適用的法律法規以及行業最佳慣例。



#### AUDITOR'S REMUNERATION

For the year ended 30 June 2023, the fee for the Company's external auditor for audit services was approximately HK\$900,000 (2022: approximately HK\$850,000) and that for non-audit services mainly relating to internal control review, risk management advisory and ESG report matters was approximately HK\$210,000 (2022: approximately HK\$332,000 (mainly internal control review, risk management advisory and ESG report)).

#### **COMPLIANCE WITH MODEL CODE**

The Company has adopted the Model Code for Securities Transactions by Directors of the Listed Issuers (the "**Model Code**") as set out in Appendix 10 to the Listing Rules as its own code of conduct regarding directors' securities transactions. Specific enquiries have been made with all Directors, who have confirmed that, during the year ended 30 June 2023, each of them has complied with the required standards as set out in the Model Code.

#### **RESPECTIVE RESPONSIBILITIES OF DIRECTORS AND AUDITOR**

The Directors are responsible for the preparation of financial statements, which give a true and fair view of the financial position of the Group. The auditor is responsible to form an independent opinion on the audited financial statements and report the same to the shareholders of the Company.

#### **CORPORATE GOVERNANCE FUNCTIONS**

No corporate governance committee has been established and the Board is responsible for performing the corporate governance functions including but not limited to developing and reviewing the Company's policies and practices on corporate governance, reviewing and monitoring training and continuous professional development of Directors and senior management, reviewing and monitoring the Company's policies and practices on compliance with legal and regulatory requirements, and reviewing the Company's compliance with the code and disclosure in this Corporate Governance Report.

本公司概無成立企業管治委員會,而董事會 須負責執行企業管治職能,包括但不限於制 定及檢討本公司之企業管治政策及常規、檢 討及監察董事及高級管理層之培訓及持續專 業發展、檢討及監察本公司有關遵守法律及 監管規定之政策及常規以及檢討本公司遵守 守則及本企業管治報告的披露。



#### **DELEGATION BY THE BOARD**

The Board is responsible for making decisions in relation to the overall strategic development of the Group's business. All Directors have formal letters of appointment setting out the key terms and conditions of their appointment. Due to the diversity and volume of the Group's business, responsibility in relation to the daily operations and execution of the strategic business plans are delegated to the management of the Group.

All committees, namely the audit committee, the human resources and remuneration committee, the nomination committee and the investment committee, have specific terms of reference setting out the authorities and responsibilities of the respective committees. All committees are required by their terms of reference to report to the Board in relation to their decisions, findings or recommendations, and in certain specific situations, to seek the Board's approval before taking any actions.

#### **CORPORATE GOVERNANCE REPORT**

The Board will review, on a yearly basis, all delegations by the Board to different committees to ensure that such delegations are appropriate and continue to be beneficial to the Company as a whole.

#### DIRECTORS' AND OFFICERS' LIABILITY INSURANCE

Insurance cover has been taken out for Directors' and Officers' Liability to provide adequate cover, as determined by the Board, in respect of the current Board members and senior management of the Company.

# COMMUNICATION WITH THE SHAREHOLDERS

The Company has adopted a Shareholders' Communication Policy on 29 December 2022 with the objective of providing the Shareholders with equal and timely access to information about the Company in order to enable the Shareholders to exercise their rights in an informed manner and allow them to engage actively with the Company.

The Company is committed to maintaining a high level of transparency and employs a policy of open and timely disclosure of relevant information to its shareholders. The commitment to fair disclosure and comprehensive and transparent reporting of the Company's activities can be reflected in various aspects.

To maintain an on-going dialogue with shareholders, the annual and special general meetings provide an opportunities for shareholders to exchange views with the Board.

Mr. Chan Koon Wa, the Chairman and executive Director, and Mr. Liu Ka Lim, the non-executive Director attended the annual general meeting in 2022 (the "2022 Annual General Meeting") so as to ensure that shareholders' views were communicated to the Board. A separate resolution was proposed by the Chairman in respect of each separate issue at the 2022 Annual General Meeting.

The proceedings of the annual general meeting are reviewed from time to time to ensure that the Company conforms to the best corporate governance practices. The circular in relation to the arrangement of annual general meeting will be circulated to all shareholders at least twenty one (21) clear days prior to the holding of the annual general meeting, in which it sets out the details of each resolution proposed and other relevant information. At the 2021 Annual General Meeting, all resolutions were put to vote by poll. Tricor Secretaries Limited, the Company's Hong Kong branch share registrar and transfer office was engaged as scrutineer to ensure votes were properly counted. The rights of shareholders and the procedures for demanding a poll on resolutions at general meeting are contained in the Articles of Association. An explanation of the detailed procedures for conducting a poll is provided to the shareholders at the commencement of the meeting. The Chairman and other directors would respond to queries raised by the shareholders regarding the voting procedures. The poll results are published in accordance with the relevant provisions of the Listing Rules.

Pursuant to the Articles of Association, two or more shareholders holding at the date of deposit of the requisition not less than onetenth (1/10) of the paid up capital of the Company carrying the right of voting at general meetings of the Company shall at all times have the right, by written requisition to the Board or the company secretary of the Company, to require an extraordinary general meeting to be called by the Board for the transaction of any business specified in such requisition and such meeting shall be held within two (2) months after the deposit of such requisition.

If within twenty one (21) days of such deposit the Board fails to proceed to convene such meeting, the requisitionists themselves may do so in the same manner.

主席兼執行董事陳冠華先生及非執行董事廖 嘉濂先生已出席2022年股東週年大會(「2022 年股東週年大會」),確保股東意見可傳達至董 事會。在2022年股東週年大會上,主席已就各 項個別事宜提呈獨立決議案。

根據組織章程細則,於遞呈要求日期持有不 少於附有本公司股東大會表決權之本公司繳 足股本十分之一(1/10)之兩名或以上股東,於 任何時候均有權透過向本公司之董事會或公 司秘書發出書面要求,要求董事會召開股東 特別大會,以處理有關要求中指明之任何事 項之交易,且該大會應於遞呈該要求後兩(2) 個月內舉行。

倘在進行有關遞呈後二十一日(21)內,董事會 未有召開該大會,則遞呈要求人士可自行以 同樣方式召開該大會。

To put forward proposals at a general meeting of the Company, a shareholder should lodge a written notice of his/her/its proposal (the "**Proposal**") with his/ her/its detailed contact information at Unit 4213, 42nd Floor, Hong Kong Plaza, 188 Connaught Road West, Hong Kong. The identity of the shareholder will be verified with the Company's Hong Kong branch share registrar and transfer office. Upon confirmation by the branch share registrar and transfer office that the request is made by a shareholder and that if the request is proper, the Board will include the Proposal in the agenda for the general meeting. The notice period to be given to all the shareholders for consideration of the Proposal raised by the shareholder concerned at the general meeting varies according to the nature of the Proposal as follows:

- Notice of not less than twenty one (21) clear days and not less than twenty (20) clear business days in writing if the Proposal requires approval in an annual general meeting;
- Notice of not less than twenty one (21) clear days and not less than ten
   (10) clear business days in writing if the Proposal requires approval by
   way of a special resolution in an extraordinary general meeting;
- (3) Notice of not less than fourteen (14) clear days and not less than ten (10) clear business days in writing if the Proposal requires approval in an extraordinary general meeting other than by way of a special resolution of the Company.

The Company also communicates to its shareholders through its annual and interim reports. The Directors, company secretary or other appropriate members of senior management also respond promptly to inquiries from shareholders and investors.

Shareholders may at any time serve their enquiries to the Board in writing for the attention of company secretary at Unit 4213, 42nd Floor, Hong Kong Plaza, 188 Connaught Road West, Hong Kong.

The Company is committed to a policy of open and timely disclosure of corporate information to shareholders and investors. The Company updates shareholders on its latest business developments and financial performance through its annual and interim reports and notices, announcements and circulars. On 29 December 2022, the resolution was duly passed for the adoption of the New Memorandum and Articles of Association (i) adopt a uniform set of 14 "Core Standards" for shareholder protections for issuers; and (ii) to modernize and provide flexibility to the Company in relation to the conduct of general meetings. As such, the Memorandum and Articles of Association was amended to, among others, (i) allow a general meeting to be held as an electronic meeting (also referred to as a virtual general meeting) or a hybrid meeting; (ii) bring the Memorandum and Articles of Association in line with amendments made to Listing Rules and applicable laws and procedures of Cayman Islands; and (iii) make certain minor housekeeping amendments to the Memorandum and Articles of Association for the purpose of clarifying existing practice and making consequential amendments in line with the amendments to the Memorandum and Articles of Association (collectively, the "Amendments"). Details of the Amendments was set out in the announcement and circular dated 14 November 2022 and 30 November 2022, respectively, save as disclosed, during the year under review, there had been no significant change made to the Company's constitutional documents.

The New Memorandum and Articles of Association is available on both the websites of the Company and the Stock Exchange.

# RISK MANAGEMENT AND INTERNAL CONTROL

The Board acknowledges that it is responsible for the risk management functions and internal control systems of the Group and ensuring review of the effectiveness of these systems has been conducted annually. Management is responsible for the design, implementation and monitoring such systems, while the Board oversees management in performing its duties on an ongoing basis.

During the year, the Board has complied with the risk management and internal control code provisions of the CG Code by establishing and maintaining appropriate and effective risk management and internal control systems and reviewing the effectiveness of the Group's risk management and internal control system. Such review covered all material controls, including financial, operational and compliance controls. Main features of the risk management and internal control systems are described in the sections below:

We adopt an integrated bottom-up and top-down risk review process to enable comprehensive identification and prioritization of all material risks throughout the Group, escalation of material risks at the right managerial level, effective risk dialogue among the management, and proper oversight of risk mitigation efforts.

#### **Risk Management Framework (Continued)**

The risk management framework adopted by the Group is embedded in our strategy development, business planning and day-to-day operations. The Group adopts a control and risk self-assessment methodology and continuously assess and manages its risk profile on a regular basis. Risks that are relevant to the Group's business are identified, assessed and ranked according to their likelihood and consequence on the Group. Risk owners are required to submit risk alerts with risk response promptly to the Board and Audit Committee for ongoing review and monitoring. Action plans were formulated and implemented during the year to address the areas of concern effectively.

## Internal Control System and Continuous Improvement

The Company has in place an internal control system which is based on the Committee of Sponsoring Organizations of the Treadway Commission ("**COSO**") framework for internal controls and has five components, namely Control Environment; Risk Assessment; Control Activities; Information and Communication; and Monitoring. In developing our internal control system, we have taken into consideration our organizational structure and the nature of our business activities.

We have put in place a phased improvement plan and progressed to future enhance our internal controls and risk management system. The phase of the plan focused on adopting a more risk-based (instead of process-based) approach to risk identification and assessment. This approach enriches our ability to analyze risks and respond to opportunities as we pursue our strategic objectives. Management reporting to the Audit Committee has also been enhanced, including the presentation of special reports on selected risk topics.

Due to the changing business environment and development including in annual budgeting and planning, we are still integrating internal controls and risk management into our business processes. Instead of treating the COSO framework as a framework-update exercise, a holistic approach has been adopted by us, taking into consideration the Company's circumstances, including its ongoing internal controls and risk management improvement plan as well as other strategic initiatives (e.g. corporate social responsibility strategy and reporting). All of these enhance our ultimate objective to make our risk management system a "live" one that is practiced on a day- to-day basis by operating units.

#### 風險管理框架(續)

本集團採用之風險管理框架植根於我們的策 略發展、業務計劃及日常營運中。本集團採 用控制及風險自我評估方法並定期持續評估 及管理風險預測。有關本集團業務之風險乃 根據其可能性及對本集團造成之後果進行識 別、評估及分級。風險所有人須立即向董事會 及審核委員會提交附帶風險反應之風險警告 以進行持續審核及監察。年內已制定及落實 行動計劃,以有效解決問題領域。

#### 內部監控制度及持續改進

本公司設有內部監控制度,乃依據反虛假 財務報告委員會發起人委員會(Committee of Sponsoring Organizations of the Treadway Commission)(「COSO」)就內部監控框架制定 者,包括監控環境、風險評估、監控活動、資 訊及溝通以及監察五個組成部分。在制定內 部監控制度時,我們已考慮到旗下組織架構 及業務活動性質。

我們已制定分階段改進計劃以供日後持續推 行,從而提升集團內部監控及風險管理制度。 計劃主力採納加強以風險管理為本(而非以程 序為本)之方式識別及評估風險,令我們在落 實策略目標之時更有能力分析風險及對商機 作出回應。管理層亦加強向審核委員會匯報, 包括就選定風險議題提呈特別報告。

因為相關業務環境及發展不斷改變,包括年 度預算編製及規劃,我們仍將內部監控及風 險管理融入業務程序。我們並非將COSO框架 視為框架更新活動,而是考慮到本公司情況 (包括其持續內部監控及風險管理改進計劃, 以及例如企業社會責任策略及報告等其他策 略措施)而採納全面方針。此等措施均有助落 實最終目標,務求風險管理制度成為各營運 單位日常採用之「靈活」制度。

#### Internal Control System and Continuous Improvement (Continued)

The Group also adopts and implements an inside information policy and procedures to ensure the truthfulness, accuracy, completeness and timeliness of its public disclosures. The following measures have been taken from time to time to ensure that proper safeguards exist to prevent a breach of a disclosure requirement in relation to the Group, which include:

- The access of information is restricted to a limited number of employees on a need-to-know basis. Employees who are in possession of inside information are fully conversant with their obligations to preserve confidentiality.
- Confidentiality agreements are in place when the Group enters into significant negotiations.
- The executive Directors are the designated persons who speak on behalf of the Company when communicating with external parties such as the media, analysts or investors.

#### **Internal Audit**

The Group has engaged an external professional consultant to take the primary role to perform the Internal Audit ("IA") function, and professional staff with relevant expertise of the Group are designated to provide assistance in the IA function. The IA function is independent of the Group's daily operation and carries out appraisal of the risk management and internal control systems by conducting interviews, walkthroughs and tests of operating effectiveness.

An IA plan has been approved by the Board. According to the established plan, review of the risk management and internal control systems is conducted annually and the results are reported to the Board via Audit Committee afterwards.

#### 內部監控制度及持續改進(續)

本集團亦採納及實施內幕消息政策及程序, 以提升本集團處理內幕消息之制度,並確保 真實、準確、完備及適時公開披露。本集團已 不時實施以下措施以確保存在適當之保障措 施,藉此防止違反與本集團有關之披露規定, 其包括:

- 資料僅限部分僱員按須知基準查閱。擁 有內幕消息之僱員完全熟知彼等之保密 義務。
- 本集團介入重大磋商時皆簽署保密協 議。
- 與外界(如媒體、分析師或投資者)溝通時,執行董事為代表本公司之指定發言人。

#### 內部審核

本集團已委聘外部專業顧問以擔當首要角色 履行內部審核(「內部審核」)職能,並指派具備 本集團相關專業知識之專業職員提供內部審 核職能方面之協助。內部審核職能獨立於本 集團日常營運並透過進行會談、走訪及測試 營運效能,對風險管理及內部監控制度進行 評估。

內部審核計劃已獲董事會批准。根據既定計 劃,每年對風險管理及內部監控制度進行審 核,且其後通過審核委員會向董事會報告結 果。

#### **PRINCIPAL RISKS AND UNCERTAINTIES**

The Group's financial condition, results of operations, businesses and prospects may be affected by a number of risks and uncertainties. The following are the key risks and uncertainties identified by the Group. There may be other risks and uncertainties in addition to those shown below which are not known to the Group or which may not be material now but could turn out to be material in the future.

#### **Business Risk**

#### **System Products**

Loss of market share and the uncertainties are the risks we are facing it, great change is taking place with each passing day on the stage of the internet and technology world. The Group needs to continue exploring opportunities in technology innovation to broaden the market share and keep investing in products research and development.

#### Foreign Exchange Risk

The Group operates its businesses in Hong Kong, USA, Euro and UK and transactions are denominated in HKD, USD and Pound. The value of Pound against HKD and other currencies may fluctuate and is affected by, among others, changes in the economic conditions and policies. However, fluctuations in the exchange rates of Pound would have limited impact on the Group's operations because the portion of revenue from UK will be used and refinanced in UK.

#### Legal Risk

Legal risk is the risk that unenforceable contracts, lawsuits or adverse judgments may disrupt or otherwise negatively affect the operations or financial conditions of the Group. The Group has complied with the relevant laws and regulations during the year.

## **Review of Risk Management & Internal Controls Effectiveness**

For the year ended 30 June 2023, the Board, through its review and the reviews made by IA function and Audit Committee, considered that the risk management and internal control system were effective and adequate. No significant areas of concern that may affect the financial, operational, compliance controls, and risk management functions of the Group has been identified. During the review, the Board also considered the resources, qualification and experience of staff of the Group's accounting, internal audit and financial reporting functions, and their training and budget were adequate. Such systems, however, are designed to manage rather than eliminate the risk of failure to achieve business objectives, and can only provide reasonable and not absolute assurance against material misstatement or loss.

### 主要風險及不確定因素

本集團之財務狀況、經營業績、業務及前景或 會受若干風險及不確定因素影響。下列各項 為本集團所識別的主要風險及不確定因素。 除下文所述者外,或會存在其他本集團未知 悉或現時並不重大惟可能於日後屬重大的風 險及不確定因素。

#### 業務風險

#### 智慧通訊方案

當今網路及科技世界上,每天都在發生著日 新月異的變化,流失市場佔有率的和不確定 因素是我們面臨的風險,本集團需要繼續探 索技術創新的機會,以擴大市場佔有率並繼 續投資於產品研究和開發。

#### 匯率波動

本集團在香港,美國、歐元和英國經營業務且 其交易以港元,美元和英鎊計值。英鎊兑港元 及其他貨幣之價值可能會波動,並受(其中包 括)經濟狀況和政策變動影響。但是,英磅匯 率的波動對本集團經營的影響十分有限,因 為來自英國的收入部份將在英國使用並進行 再融資。

#### 法律風險

法律風險指因不可執行合約、訴訟或不利判 決而可能使本集團運作或財務狀況出現混亂 或負面影響之風險。本集團於本年度相關內 已遵守法律及法規。

#### 審核風險管理及內部監控之成效

截至2023年6月30日止年度,董事會透過其審 核及由內部審核職能及審核委員會進行之審 核,認為風險管理及內部監控制度為有效及 完備。尚未識別出可影響本集團之財務、營 運、合規控制及風險管理職能之重大問題領 域。審核期間,董事會亦認為資源、本集團會 計、內部審核及財務申報職能之員工在資源、 資質及經驗以及培訓及預算方面屬足夠。然 而,該等制度乃制定以管理(而非完全杜絕)業 務目標未能達標之風險,且僅能提供合理(而 非絕對)之保證,以防出現嚴重誤報或損失之 情況。

### **CONCLUSION**

The Company believes that good corporate governance is significant in strengthening investor confidence and attracting investment. The management will devote considerable effort to strengthening and improving the standards of the corporate governance of the Group. Any views and suggestions from the shareholders to promote and improve our transparency are also welcome.

#### **OPINION**

We have audited the consolidated financial statements of Kantone Holdings Limited (the "**Company**") and its subsidiaries (the "**Group**") set out on pages 69 to 163, which comprise the consolidated statement of financial position as at 30 June 2023, and the consolidated statement of profit or loss and other comprehensive income, the consolidated statement of changes in equity and the consolidated statement of cash flows for the year then ended, and notes to the consolidated financial statements, including a summary of significant accounting policies.

In our opinion, the consolidated financial statements give a true and fair view of the consolidated financial position of the Group as at 30 June 2023, and of its consolidated financial performance and its consolidated cash flows for the year then ended in accordance with Hong Kong Financial Reporting Standards ("**HKFRSs**") issued by the Hong Kong Institute of Certified Public Accountants ("**HKICPA**") and have been properly prepared in compliance with the disclosure requirements of the Hong Kong Companies Ordinance.

#### **BASIS FOR OPINION**

We conducted our audit in accordance with Hong Kong Standards on Auditing ("**HKSAs**") issued by the HKICPA. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Consolidated Financial Statements section of our report. We are independent of the Group in accordance with the HKICPA's Code of Ethics for Professional Accountants (the "**Code**"), and we have fulfilled our other ethical responsibilities in accordance with these requirements and the Code. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

We identified the impairment of trade receivables as a key audit matter due to the significance of the balance to the consolidated financial statements as a whole and the estimation of impairment losses entails a significant degree of subjective estimation and assessment.

Management also considered forward looking information that may impact the customers' ability to repay the outstanding balances in order to estimate the expected credit losses for the impairment assessment.

## 1. GENERAL

Kantone Holdings Limited (the "**Company**") was incorporated in the Cayman Islands as an exempted company with limited liability under the Companies Law (Revised) Chapter 22 of the Cayman Islands and its shares are listed on the Main Board of The Stock Exchange of Hong Kong Limited (the "**Exchange**"). The ultimate holding company of the Company is Innovative City Investments Limited, which is incorporated in the British Virgin Islands ("**BVI**") and owned by Mr. Chan Koon Wa. The addresses of the registered office and principal place of business of the Company are disclosed in the Corporate Information section of the annual report.

The consolidated financial statements have been presented in Hong Kong dollar ("**HK\$**"), which is also the Company's functional currency. All values are rounded to the nearest thousand except when otherwise indicated.

The Company is an investment holding company. The principal activities of its subsidiaries are set out in note 35.

## 2. APPLICATION OF AMENDMENTS TO HONG KONG FINANCIAL REPORTING STANDARDS ("HKFRSs")

#### Statement of compliance

The consolidated financial statements have been prepared in accordance with HKFRSs (which includes all the HKFRSs, Hong Kong Accounting Standards ("**HKASs**") and Interpretations) issued by the HKICPA and accounting principles generally accepted in Hong Kong. In addition, the consolidated financial statements include applicable disclosures required by the Rules Governing the Listing of Securities on the Stock Exchange (the "Listing Rules") and by the Hong Kong Companies Ordinance.

The consolidated financial statements have been prepared on the historical cost basis except for defined benefit retirement plan and certain financial instruments that are measured at fair value. Historical cost is generally based on the fair value of the consideration given in exchange for goods and services.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date, regardless of whether that price is directly observable or estimated using another valuation technique. In estimating the fair value of an asset or a liability, the Group takes into account the characteristics of the asset or liability if market participants would take those characteristics into account when pricing the asset or liability at the measurement date. Fair value for measurement and/or disclosure purposes in these consolidated financial statements is determined on such a basis, except for share-based payment transactions that are within the scope of HKFRS 16 *Leases* ("HKFRS 16"), and measurements that have some similarities to fair value but are not fair value, such as net realisable value in HKAS 2 *Inventories* or value in use in HKAS 36 *Impairment of Assets*.

The principal accounting policies are set out below.

#### **Basis of consolidation**

The consolidated financial statements incorporate the financial statements of the Company, entities controlled by the Company and its subsidiaries. Control is achieved when the Company:

- has power over the investee;
- is exposed, or has rights, to variable returns from its involvement with the investee; and
- has the ability to use its power to affect its returns.

The Group reassesses whether or not it controls an investee if facts and circumstances indicate that there are changes to one or more of the three elements of control listed above.

Consolidation of a subsidiary begins when the Group obtains control over the subsidiary and ceases when the Group loses control of the subsidiary. Specifically, income and expenses of a subsidiary acquired or disposed of during the year are included in the consolidated statement of profit or loss and other comprehensive income from the date the Group gains control until the date when the Group ceases to control the subsidiary.

Profit or loss and each item of other comprehensive income are attributed to the owners of the Company and to the non-controlling interests. Total comprehensive income of subsidiaries is attributed to the owners of the Company and to the non-controlling interests even if this results in the non-controlling interests having a deficit balance.

Where necessary, adjustments are made to the financial statements of subsidiaries to bring their accounting policies in line with the Group's accounting policies.

All intragroup assets and liabilities, equity, income, expenses and cash flows relating to transactions between members of the Group are eliminated in full on consolidation.

#### **Revenue recognition**

Revenue is measured based on the consideration specified in a contract with a customer and excludes amounts collected on behalf of third parties. The Group recognises revenue when (or as) a performance obligation is satisfied, i.e. when "control" of the goods or services underlying the particular performance obligation is transferred to the customer.

A performance obligation represents a good or service (or a bundle of goods or services) that is distinct or a series of distinct goods or services that are substantially the same.

Control is transferred over time and revenue is recognised over time by reference to the progress towards complete satisfaction of the relevant performance obligation if one of the following criteria is met:

- (a) The customer simultaneously receives and consumes the benefits provided by the Group's performance as the Group performs.
- (b) The Group's performance creates or enhances an asset that the customer controls as the Group performs.
- (c) The Group's performance does not create an asset with an alternative use to the Group and the Group has an enforceable right to payment for performance completed to date.

Otherwise, revenue is recognised at a point in time when the customer obtains control of the distinct good or service.

A contract liability represents the Group's obligation to transfer goods or services to a customer for which the Group has received consideration (or an amount of consideration is due) from the customer. A contract liability would also be recognised if the Group has an unconditional right to receive consideration before the Group recognises the related revenue. In such cases, a corresponding receivable would also be recognised. When the contract includes a significant financing component, the contract balance includes interest accrued under the effective interest method.

#### **Revenue recognition (Continued)**

The Group recognises revenue from sales of goods (including cultural products and systems and related software licensing) based on the consideration specified in a contract with a customer and the Group excludes amounts collected on behalf of third parties. The Group satisfies a performance obligation when it transfers control of the cultural products and systems and related software licencing to a customer. Sales of systems and related software licensing is a single performance obligation. Revenue from sale of goods is recognised at the point in time.

The revenue from provision of installation service is recognised over time as the installation service creates or enhances an asset that the customer controls as the asset is created or enhanced.

The revenue from provision of maintenance services is recognised over time as the customers simultaneously receive and consume the benefits from the Group's performance. Input method is used to measure the progress towards complete satisfaction of a performance obligation which is to recognise revenue on the basis of the Group's efforts or inputs to the satisfaction of a performance obligation relative to the total expected inputs to the satisfaction of that performance obligation, that best depict the Group's performance in transferring control of goods or services.

Rental income, including rental invoiced in advance from assets under operating leases, is recognised on a straight-line basis over the relevant lease term.

Interest income is recognised as it accrues using the effective interest method. For financial assets measured at amortised cost that are not credit-impaired, the effective interest rate is applied to the gross carrying amount of the asset. For credit-impaired financial assets, the effective interest rate is applied to the amortised cost (i.e. gross carrying amount net of loss allowance) of the asset.

Property, plant and equipment including land and buildings held for use in the production or supply of goods or services, or for administrative purposes are stated in the consolidated statement of financial position at cost less subsequent accumulated depreciation and accumulated impairment losses.

Depreciation is recognised so as to write off the cost of assets less their residual values over their estimated useful lives, using the straightline method, at the following rates per annum:

An item of property, plant and equipment is derecognised upon disposal or when no future economic benefits are expected to arise from the continued use of the asset. Any gain or loss arising on the disposal or retirement of an item of property, plant and equipment is determined as the difference between the sales proceeds and the carrying amount of the asset and is recognised in profit or loss.

### Leasehold land and building

When the Group makes payments for ownership interests of properties which includes both leasehold land and building elements, the entire consideration is allocated between the leasehold land and the building elements in proportion to the relative fair values at initial recognition. To the extent the allocation of the relevant payments can be made reliably, interest in leasehold land is presented as "right-of-use assets" in the consolidated statement of financial position except for those that are classified and accounted for as investment properties under the fair value model. When the consideration cannot be allocated reliably between non-lease building element and undivided interest in the underlying leasehold land, the entire properties are classified as property, plant and equipment.

Investment property is property held to earn rentals and/or for capital appreciation.

Investment property also includes leased properties which are being recognised as right-of-use assets and subleased by the Group under operating leases.

Investment property is initially measured at cost, including any directly attributable expenditure. Subsequent to initial recognition, investment property is measured at their fair values. Gains or losses arising from changes in the fair value of investment property are included in profit or loss for the period in which they arise.

An investment property is derecognised upon disposal or when the investment property is permanently withdrawn from use and no future economic benefits are expected from its disposals. Any gain or loss arising on derecognition of the property (calculated as the difference between the net disposal proceeds and the carrying amount of the asset) is included in the profit or loss in the period in which the property is derecognised.

# Impairment on property, plant and equipment and right-of-use assets

At the end of the reporting period, the Group reviews the carrying amounts of its property, plant and equipment and right-of-use assets to determine whether there is any indication that those assets have suffered an impairment loss. If any such indication exists, the recoverable amount of the relevant asset is estimated in order to determine the extent of the impairment loss, if any. The recoverable amount of property, plant and equipment and right-of-use assets, and are estimated individually. When it is not possible to estimate the recoverable amount of an individual asset, the Group estimates the recoverable amount of the cash-generating unit to which the asset belongs. Recoverable amount is the higher of fair value less costs of disposal and value in use. If the recoverable amount of an asset (or a cash-generating unit) is estimated to be less than its carrying amount, the carrying amount of the asset (or a cash-generating unit) is reduced to its recoverable amount. An impairment loss is recognised immediately in profit or loss.

A contract is, or contains, a lease if the contract conveys the right to control the use of an identified asset for a period of time in exchange for consideration.

For contracts entered into or modified or arising from business combinations on or after the date of initial application of HKFRS 16, the Group assesses whether a contract is or contains a lease based on the definition under HKFRS 16 at inception, modification date or acquisition date, as appropriate. Such contract will not be reassessed unless the terms and conditions of the contact are subsequently changed. As a practical expedient, leases with similar characteristics are accounted on a portfolio basis when the Group reasonably expects that the effects on the consolidated financial statements would not differ materially from individual leases within the portfolio.

#### Allocation of consideration to components of a contract

Dividends from an investment in equity securities are recognised in profit or loss as other income.

# Impairment of financial assets subject to impairment assessment under HKFRS 9

The Group performs impairment assessment under expected credit loss ("ECL") model on financial assets (including trade and other receivables, loan receivables and cash and cash equivalents) which are subject to impairment assessment under HKFRS 9. The amount of ECL is updated at each reporting date to reflect changes in credit risk since initial recognition.

Lifetime ECL represents the ECL that will result from all possible default events over the expected life of the relevant instrument. In contrast, 12-month ECL ("**12m ECL**") represents the portion of lifetime ECL that is expected to result from default events that are possible within 12 months after the reporting date. Assessments are done based on the Group's historical credit loss experience, adjusted for factors that are specific to the debtors, general economic conditions and an assessment of both the current conditions at the reporting date as well as the forecast of future conditions.

The Group always recognises lifetime ECL for trade receivables.

For all other instruments, the Group measures the loss allowance equal to 12m ECL, unless there has been a significant increase in credit risk since initial recognition, in which case the Group recognises lifetime ECL. The assessment of whether lifetime ECL should be recognised is based on significant increases in the likelihood or risk of a default occurring since initial recognition.

In making this assessment, the Group considers both quantitative and qualitative information that is reasonable and supportable, including historical experience and forward-looking information that is available without undue cost or effort.

In particular, the following information is taken into account when assessing whether credit risk has increased significantly:

- an actual or expected significant deterioration in the financial • instrument's external (if available) or internal credit rating;
- significant deterioration in external market indicators of credit risk, e.g. a significant increase in the credit spread, the credit default swap prices for the debtor;
- existing or forecast adverse changes in business, financial or • economic conditions that are expected to cause a significant decrease in the debtor's ability to meet its debt obligations;
- an actual or expected significant deterioration in the operating results of the debtor;
- an actual or expected significant adverse change in the regulatory, economic, or technological environment of the debtor that results in a significant decrease in the debtor's ability to meet its debt obligations.

Irrespective of the outcome of the above assessment, the Group presumes that the credit risk has increased significantly since initial recognition when contractual payments are more than 30 days past due, unless the Group has reasonable and supportable information that demonstrates otherwise.

The Group regularly monitors the effectiveness of the criteria used to identify whether there has been a significant increase in credit risk and revises them as appropriate to ensure that the criteria are capable of identifying significant increase in credit risk before the amount becomes past due.

#### **Definition of default**

For internal credit risk management, the Group considers an event of default occurs when information developed internally or obtained from external sources indicates that the debtor is unlikely to pay its creditors, including the Group, in full (without taking into account any collaterals held by the Group).

Irrespective of the above, the Group considers that default has occurred when a financial asset is more than 90 days past due unless the Group has reasonable and supportable information to demonstrate that a more lagging default criterion is more appropriate.

#### **Credit-impaired financial assets**

A financial asset is credit-impaired when one or more events that have a detrimental impact on the estimated future cash flows of that financial asset have occurred. Evidence that a financial asset is credit-impaired includes observable data about the following events:

- significant financial difficulty of the issuer or the borrower;
- a breach of contract, such as a default or past due event;
- the lender(s) of the borrower, for economic or contractual reasons relating to the borrower's financial difficulty, having granted to the borrower a concession(s) that the lender(s) would not otherwise consider;
- it is becoming probable that the borrower will enter bankruptcy or other financial reorganisation ; or
- the disappearance of an active market for that financial asset because of financial difficulties.

#### Write-off policy

The Group writes off a financial asset when there is information indicating that the counterparty is in severe financial difficulty and there is no realistic prospect of recovery, for example, when the counterparty has been placed under liquidation or has entered into bankruptcy proceedings. Financial assets written off may still be subject to enforcement activities under the Group's recovery procedures, taking into account legal advice where appropriate. A write-off constitutes a derecognition event. Any subsequent recoveries are recognised in profit or loss.

#### Measurement and recognition of ECL

The measurement of ECL is a function of the probability of default, loss given default (i.e. the magnitude of the loss if there is a default) and the exposure at default. The assessment of the probability of default and loss given default is based on historical data and forward-looking information. Estimation of ECL reflects an unbiased and probabilityweighted amount that is determined with the respective risks of default occurring as the weights.

Generally, the ECL is the difference between all contractual cash flows that are due to the Group in accordance with the contract and the cash flows that the Group expects to receive, discounted at the effective interest rate determined at initial recognition.

Interest income is calculated based on the gross carrying amount of the financial asset unless the financial asset is credit-impaired, in which case interest income is calculated based on amortised cost of the financial asset.

The Group recognises an impairment gain or loss in profit or loss for all financial instruments by adjusting their carrying amount, with the exception of trade receivables where the corresponding adjustment is recognised through a loss allowance account.

#### Derecognition of financial assets

The Group derecognises a financial asset only when the contractual rights to the cash flows from the asset expire, or when it transfers the financial asset and substantially all the risks and rewards of ownership of the asset to another entity.

On derecognition of a financial asset measured at amortised cost, the difference between the asset's carrying amount and the sum of the consideration received and receivable is recognised in profit or loss.

#### Financial liabilities and equity

#### Classification as debt or equity

Debt and equity instruments are classified as either financial liabilities or as equity in accordance with the substance of the contractual arrangements and the definitions of a financial liability and an equity instrument.

#### Equity instruments

An equity instrument is any contract that evidences a residual interest in the assets of an entity after deducting all of its liabilities. Equity instruments issued by the Company are recognised at the proceeds received, net of direct issue costs.

#### Financial liabilities at amortised cost

Financial liabilities including trade and other payables, lease liabilities, amount due to a director and amount due to the former ultimate holding company are subsequently measured at amortised cost, using the effective interest method.

#### Derecognition of financial liabilities

The Group derecognises financial liabilities when, and only when, the Group's obligations are discharged, cancelled or have expired. The difference between the carrying amount of the financial liability derecognised and the consideration paid and payable is recognised in profit or loss.

#### **Provisions**

Provisions are recognised when the Group has a present obligation as a result of a past event, it is probable that the Group will be required to settle that obligation and a reliable estimate can be made of the amount of the obligation. Provisions are measured at the best estimate of the consideration required to settle the present obligation at the end of the reporting period, taking into account the risks and uncertainties surrounding the obligation. Where a provision is measured using the cash flows estimated to settle the present obligation, its carrying amount is the present value of those cash flows (where the effect of the time value of money is material).

#### Inventories

Inventories are stated at the lower of cost and net realisable value. Cost is calculated using the first-in, first-out method except for cost of cultural products, which are assigned by using specific identification cost method. Net realisable value represents the estimated selling price for inventories less all estimated costs of completion and costs necessary to make the sale.

#### **Trade and other receivables**

A receivable is recognised when the Group has an unconditional right to receive consideration. A right to receive consideration is unconditional if only the passage of time is required before payment of that consideration is due. If revenue has been recognised before the Group has an unconditional right to receive consideration, the amount is presented as a contract asset.

Receivables are stated at amortised cost using the effective interest method less allowance for credit losses.

#### Cash and cash equivalents

Cash and cash equivalents presented on the consolidated statement of financial position include:

- (a) cash, which comprises of cash on hand and demand deposits, excluding bank balances that are subject to regulatory restrictions that result in such balances no longer meeting the definition of cash; and
- (b) cash equivalents, which comprises of short-term (generally with original maturity of three months or less), highly liquid investments that are readily convertible to a known amount of cash and which are subject to an insignificant risk of changes in value. Cash equivalents are held for the purpose of meeting short-term cash commitments rather than for investment or other purposes.

For the purposes of the consolidated statement of cash flows, cash and cash equivalents consist of cash and cash equivalents as defined above, net of outstanding bank overdrafts which are repayable on demand and form an integral part of the Group's cash management. Such overdrafts are presented as short-term borrowings in the consolidated statement of financial position.

#### **Trade and other payables**

Trade and other payables are initially recognised at fair value. Trade and other payables are subsequently stated at amortised cost unless the effect of discounting would be immaterial, in which case they are stated at cost.

#### **Borrowing costs**

Borrowing costs directly attributable to the acquisition, construction or production of gualifying assets, which are assets that necessarily take a substantial period of time to get ready for their intended use or sale, are added to the cost of those assets until such time as the assets are substantially ready for their intended use or sale.

All other borrowing costs are recognised in profit or loss in the period in which they are incurred.

#### **Taxation**

Income tax expense represents the sum of the tax currently payable and deferred tax.

The tax currently payable is based on taxable profit for the year. Taxable profit differs from 'profit before taxation' as reported in the consolidated statement of profit or loss and other comprehensive income because it excludes items of income or expense that are taxable or deductible in other years and it further excludes items that are never taxable and deductible. The Group's liability for current tax is calculated using tax rates that have been enacted or substantively enacted by the end of the reporting period.

Deferred tax assets and liabilities are measured at the tax rates that are expected to apply in the period in which the liability is settled or the asset is realised, based on tax rate (and tax laws) that have been enacted or substantively enacted by the end of the reporting period. The measurement of deferred tax liabilities and assets reflects the tax consequences that would follow from the manner in which the Group expects, at the end of the reporting period, to recover or settle the carrying amount of its assets and liabilities.

Current and deferred tax is recognised in profit or loss, except when it relates to items that are recognised in other comprehensive income or directly in equity, in which case, the current and deferred tax are also recognised in other comprehensive income or directly in equity respectively.

#### Segment reporting

Operating segments are reported in a manner consistent with the internal reporting provided to the chief operating decision-maker. The chief operating decision-maker, who is responsible for allocating resources and assessing performance of the operating segments, has been identified as the directors of the Company that made strategic decisions during the year.

#### **Foreign currencies**

In preparing the financial statements of each individual group entity, transactions in currencies other than the functional currency of that entity (foreign currencies) are recognised at the rates of exchanges prevailing on the dates of the transactions. At the end of the reporting period, monetary items denominated in foreign currencies are retranslated at the rates prevailing at that date. When a fair value gain or loss on a non-monetary item is recognised in profit or loss, any exchange component of that gain or loss on a non-monetary item is recognised in profit or loss. When a fair value gain or loss on a non-monetary item is recognised in other comprehensive income, any exchange component of that gain or loss on a non-monetary item is recognised in other comprehensive income, any exchange component of that gain or loss is also recognised in other comprehensive income. Non-monetary items that are measured in terms of historical cost in a foreign currency are not retranslated.

Exchange differences arising on the settlement of monetary items, and on the retranslation of monetary items, are recognised in profit or loss in the period in which they arise.

For the purposes of presenting the consolidated financial statements, the assets and liabilities of the Group's operations are translated into the presentation currency of the Group (i.e. Hong Kong dollars) using exchange rates prevailing at the end of each reporting period. Income and expenses are translated at the average exchange rates for the period, unless exchange rates fluctuate significantly during that period, in which case, the exchange rates at the date of transactions are used. Exchange differences arising, if any, are recognised in other comprehensive income and accumulated in equity under the heading of translation reserve. Exchange differences are recognised in profit or loss in the period in which the foreign operation is disposed of.

#### **Retirement benefit scheme**

The Group operates a defined contribution Mandatory Provident Fund retirement benefit scheme (the "**MPF Scheme**") under the Mandatory Provident Fund Schemes Ordinance for all of its employees in Hong Kong. Contributions are made based on a percentage of the employees' basic salaries and are charged to profit or loss and other comprehensive income as they become payable in accordance with the rules of the MPF Scheme. The assets of the MPF Scheme are held separately from those of the Group in an independently administered fund.

Certain subsidiaries of the Company operate a self-administered and funded pension scheme in the United Kingdom. The scheme provides defined pension benefits with reference to the final salary of the members at retirement and their length of service. The scheme is closed to new members since 1 January 2003.

The Group's net obligation in respect of defined benefit retirement plans is calculated separately for each plan by estimating the amount of future benefit that employees have earned in return for their service in the current and prior periods; that benefit is discounted to determine the present value and the fair value of any plan assets is deducted. The calculation is performed by a qualified actuary using the projected unit credit method.

Service cost and net interest expense/(income) on the net defined benefit liability/(asset) are recognised in profit or loss and allocated by function as part of "administrative expenses". Current service cost is measured as the increase in the present value of the defined benefit obligation resulting from employee service in current period. When the benefits of a plan are changed, or when a plan is curtailed, the portion of the changed benefit related to past service by employees, or the gain or loss on curtailment, is recognised as an expense in profit or loss at the earlier of when the plan amendment or curtailment occurs and when related restructuring cost or termination benefit are recognised. Net interest expense/(income) for the period is determined by applying the discount rate used to measure the defined benefit liability/(asset). The discount rate is the yield at the end of the reporting period on high quality corporate bonds that have maturity dates approximating the terms of the Group's obligations.

Remeasurements arising from defined benefit retirement plans are recognised in other comprehensive income and reflected immediately in accumulated losses and will not be reclassified to profit or loss. Remeasurements comprise actuarial gains and losses, the return on plan assets (excluding amounts included in net interest on the net defined benefit liability/(asset)) and any change in the effect of the asset ceiling (excluding amounts included in net interest on the net defined benefit liability/(asset)).

In the application of the Group's accounting policies, which are described in note 3, the directors of the Company are required to make judgements, estimates and assumptions about the carrying amounts of assets and liabilities that are not readily apparent from other sources. The estimates and underlying assumptions are based on historical experience and other factors that are considered to be relevant. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods.

#### (a) Critical accounting judgements in applying the Group's accounting policies

In the process of applying the Group's accounting policies, management has made the following accounting judgements:

#### **Classification of inventories**

The Group holds certain cultural products for resale in the ordinary course of business. Although the value of cultural products may appreciate over time, it is the Group's intention to hold such assets for trading. Accordingly, those items of cultural products are classified as inventories under current assets.

#### **Revenue recognition**

Judgement is required in determining the timing of satisfaction of performance obligation. The Group derives revenue from sale of cultural products, systems and related software. The Group carefully evaluates the terms and conditions stipulated in contract and/or sale order with a customer and assesses when the control of the goods has been transferred to the customer. In addition, the Group also assessed whether the Group is acting as the principal (i.e. whether the Group has the primary responsibility for the sale of goods, bears the risks of loss and obsolescence, and also has full discretion over the goods). The directors of the Company have determined that the control is passed to customer upon the goods are delivered to the agreed destination. This also is the point in time at which the right to consideration becomes unconditional.

#### **Revenue recognition (Continued)**

The directors of the Company assessed and considered that the sales of systems and installation are one single performance obligation and to be recognised at a particular point in time (i.e. when control of the systems and software is transferred to the customer). The Group delivers products to customers after installation of customised softwares in the systems. The installation work is carried out in the Group's premises or on sites specified by customers. The Group grants customers the right to use the software and no update or upgrade of the software is required to be performed by the Group after sales. The sales of systems and software and related installation are assessed by the management to be not distinct in the context of the application of HKFRS 15 as what being delivered to the customer is a combined product with customer specifications.

The Group sells large telecommunication equipment and software that need to be installed at customers' premises. As management considered that the hardware installation service is a very simple procedure the equipment can operate and function as normal way and the customer can choose to install the equipment by themselves or by third party service provider, the installation service and sales of equipment are distinct in the content of the application of HKFRS 15. Revenue from provision of installation services is determined by management to be recognised over time as the customer simultaneously receives and consumes the benefits provided by the Group's performance as the Group performs the installation service. The Group recognises revenue in relation to the sales of telecommunication equipment of a particular point in time (i.e. when control is transferred to the customers).

The Group signed contracts with customers to provide maintenance over a period of time. The customer simultaneously receives and consumes the benefits provided by the Group's performance as the Group performs the maintenance service, therefore, revenue from provision of maintenance service is recognised over time.

The following are the key assumptions concerning the future, and other key sources of estimation uncertainty at the end of the reporting period, that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year.

#### Estimation of fair value of investment property

Investment property located outside Hong Kong as at 30 June 2023 is stated at fair value based on valuation reports, issued by SBT Commercial Property Consultants, by using direct comparison method.

In determining the fair value, the valuer has based on property valuation techniques which involve certain estimates including comparable sales in the relevant market.

In relying on the valuation reports, management has exercised their judgement and is satisfied that the method of valuation is reflective of the current market condition.

The carrying amounts of investment property as at 30 June 2023 were HK\$6,013,000. Further details, including the key assumptions used for fair value measurement, are stated in note 33.

Impairment allowances on financial assets (including trade and other receivables and loan receivables) Trade receivables with significant balances and credit-impaired are assessed for ECL individually.

The Group uses provision matrix to calculate ECL for trade receivables which are not assessed individually. The provision rates are based on internal credit ratings as groupings of various debtors that have similar loss patterns. The provision matrix is based on the Group's historical default rates taking into consideration forward-looking information that is reasonable and supportable available without undue costs or effort.

At every reporting date, the historical observed default rates are reassessed and changes in the forward-looking information are considered.

The Group determines the provision of impairment of other receivables and loan receivables based on ECL. The Group assesses the ECL for each of the other receivables and loan receivables individually based on the financial position and the economic environment in which the borrowers operate.

The provision of ECL is sensitive to changes in estimates. The information about the ECL of the Group's trade and other receivables, and loan receivables are disclosed in note 5.

#### Net realisable value of inventories

Net realisable value of inventories is the estimated selling price in the ordinary course of business, less estimated costs of completion and selling expenses. These estimates are based on the current market price of similar products and historical experience of distributing and selling products of similar nature. It could change significantly as a result of market condition. Management assesses the estimations at each reporting date.

At 30 June 2023, the carrying amount of the Group's inventories was HK\$23,150,000 (2022: HK\$20,934,000).

# Financial risk management objectives and policies

The Group's major financial instruments include trade and other receivables, loan receivables, financial assets at FVTPL, bank balances and cash, and trade and other payables. Details of these financial instruments are disclosed in respective notes. The risks associated with these financial instruments and the policies on how to mitigate these risks are set out below. The management manages and monitors these exposures to ensure appropriate measures are implemented on a timely and effective manner.

#### **Credit risk**

As at 30 June 2023, the Group's maximum exposure to credit risk which will cause a financial loss to the Group due to failure to discharge an obligation by the counterparties is arising from the carrying amount of the respective recognised financial assets as stated in the consolidated statement of financial position.

In order to minimise the credit risk in relation to trade receivables, the management of the Group will only allow customers with good credit history to pay on credit. In addition, the management reviews the recoverable amount of each individual trade debt at the end of the reporting period, taking into account future discounted cash flows, to ensure that adequate impairment losses are made for irrecoverable amounts. In this regard, the directors of the Company consider that the Group's credit risk is significantly reduced.

The directors of the Company are of the opinion that the credit risk of trade receivables is low based on the sound collection history of the receivables and the economic environment the debtors operate. Therefore, the ECL rate of the trade receivables is assessed to be closed to zero and no provision was made as at 30 June 2023.

The Group writes off a trade receivable when there is information indicating that the debtor is in severe financial difficulty and there is no realistic prospect of recovery, e.g. when the debtor has been placed under liquidation or has entered into bankruptcy proceedings. In the opinion of the directors of the Company, no trade receivables have been written off for both years.

As at 30 June 2023, the Group has exposed to credit risk on loan receivables. The management of the Group considers the probability of default based on the financial position of the borrowers and guarantors and the economic environment of the borrowers operate. As at 30 June 2023, the management of the Group considers for written off of the loan receivable with credit impaired in previous years. The directors of the Company are of the opinion that the credit risk of the remaining loan receivables is low. And, provision of expected credit loss on loan receivables of HK\$132,000 (2022: Nil) has been made.

As at 30 June 2023, the Group has exposed to credit risk on other receivables. As part of the Group's credit risk management, the management of the Group makes periodic individual assessment on the recoverability of other receivables based on historical settlement records, past experience, and also available reasonable and supportive forward-looking information. The management of the Group believes that there is no material credit risk inherent in the Group's other receivables.

Other than concentration of credit risk on liquid funds which are deposited with several banks with high credit ratings amounting to HK\$100,753,000 and other receivables with Champion, the former ultimate holding company, amounting to HK\$7,111,000, the Group does not have any other significant concentration of credit risk. Trade receivables consist of a large number of customers, spread across diverse industries and geographical areas. The credit risk on liquid funds is limited because the counterparties are banks with high credit ratings assigned by international credit-rating agencies.

#### Liquidity risk

In managing the liquidity risk, the Group monitors and maintains a level of cash and cash equivalents deemed adequate by the management to finance the Group's operations and mitigate the effects of fluctuations in cash flows. The management monitors the utilisation of borrowings and the compliance of loan covenants.

The following table details the Group's remaining contractual maturity for its financial liabilities based on the agreed repayment terms. The table has been drawn up based on the undiscounted cash flows of financial liabilities based on the earliest date on which the Group can be required to pay. The maturity dates for other non-derivative financial liabilities are based on the agreed repayment dates. The table includes both interest and principal cash flows.

To the extent that interest flows are floating rate, the undiscounted amount of interest payment is estimated based on the interest rate at the end of the reporting period.

#### Interest rate risk

The Group is exposed to cash flow interest rate risk in relation to variable-rate bank deposits. The Group is also exposed to fair value interest rate risk in relation to loan receivable and lease liabilities and amount due to the former ultimate holding company.

The Group does not enter into any arrangement to hedge cash flow interest rate risk. However, the management monitors interest rate exposure and will consider hedging significant interest rate risk should the need arises.

#### Sensitivity analysis

The sensitivity analysis below has been determined based on the exposure to interest rates for variable-rate deposits and bank balances at the end of the reporting period. The analysis is prepared assuming that the amount of balances outstanding at the end of the reporting period was outstanding for the whole year. A 25 basis points (2022: 10 basis points) increase or decrease represents management's assessment of the reasonably possible change in interest rates.

If interest rates had been 25 basis points (2022: 10 basis points) higher or lower and all other variables were held constant, the Group's profit after tax for the year ended 30 June 2023 would increase or decrease by approximately HK\$252,000 (2022: HK\$108,000).

In the management's opinion, the sensitivity analysis is unrepresentative of the inherent interest rate risk as the year end exposure does not reflect the exposure during the year.

For the purpose of preparing the consolidated financial statements for the year ended 30 June 2023, the Group engaged the valuer, 北京市國宏信 to assess the current market values of all 143 pieces of cultural products as at 30 June 2023 based on the finding of the Experts and the Appraisal Centre concerning the grading and classification of the cultural products and the current condition of the cultural products. Based on the valuation of the cultural products as at 30 June 2023 by 北京市國宏信, the management of the Group determined that their net realisable values were below their carrying amounts as of 30 June 2023 and the shortfalls resulted in further impairment loss of HK\$3,544,000 for the year ended 30 June 2023.

The directors of the Company were of the view that, with the detailed exercise performed by the Appraisal Center and the valuer, the carrying amount net of impairment recognised so far, reflected in the consolidated financial statements, was the best estimate of the recoverable amount of the cultural products.

#### (a) Defined contribution scheme

Certain subsidiaries of the Company participate in a retirement benefit scheme covering a portion of their employees. The assets of the scheme are held separately from those of the Group in funds under the control of independent trustees.

Commenced from December 2000, the Group enrolled all eligible employees in Hong Kong into a mandatory provident fund (the "**MPF**") scheme. The retirement benefit cost of the MPF scheme charged to the profit or loss represents contributions to the MPF scheme by the Group at rates specified in the rules of the MPF scheme.

The employees of the Group's subsidiaries in the PRC are members of government-managed retirement benefit scheme operated by the respective local government in the PRC. The Group is required to contribute a specified percentage of payroll costs to the retirement benefit scheme to fund the benefits. The only obligation of the Group with respect to the retirement benefit scheme is to make the specified contributions.

Certain subsidiaries of the Company in UK operate an administered and funded pension scheme in the UK. The scheme provides defined pension benefits with reference to the final salary of the members at retirement and their length of service. The scheme was closed to new members since 1 January 2003.

The contributions which are determined by a qualified actuary on the basis of triennial valuations using the projected unit credit method are charged to the profit or loss. Under the scheme, the employees are entitled to a pension between 1.67% and 2.50% of final salary for each year of pensionable service at an age of 65. No other post-retirement benefits are provided. The most recent actuarial valuations of scheme assets and the present value of the defined benefit obligations as at 30 June 2023 were prepared by Buck Consultants Limited, Mrs. Rachel Downs (FIA), Fellow of the Institute and Faculty of Actuaries ("**FIA**") (2022: Mrs. Rachel Downs (FIA)), for accounting reporting purpose. The assumptions which have the most significant effect on the results of the valuation are those relating to the rate of return on investments and the rates of increase in salaries, pensions and share dividends.

The funded pension scheme exposes the Group to actuarial risks such as investment risk, interest rate risk, longevity risk and salary risk.

The present value of the defined benefit plan liability is calculated using a discount rate determined by reference to high quality corporate bond yields; if the return on plan asset is below this rate, it will create a plan deficit. Currently the plan has relatively balanced investment in equity securities, debt instruments and real estates. Due to the long-term nature of the plan liabilities, the trustee of the pension fund considers it appropriate that a reasonable portion of the plan assets should be invested in equity securities and in real estate to leverage the return generated by the fund.

#### **Interest risk**

A decrease in the bond interest rate will increase the plan liability; however, this will be partially offset by an increase in the return on the plan's debt investments.

#### Longevity risk

The assets of the MPF Scheme are held separately from those of the Group in funds under the control of an independent trustee. Under the MPF Scheme, the employer and its employees are each required to make contributions to the MPF Scheme at rates specified in the rules. The only obligation of the Group with respect to the MPF Scheme is to make the required contributions. Except for voluntary contribution, no forfeited contribution under the MPF Scheme is available to reduce the contribution payable in future years.

For the retirement benefits of the Group's qualifying employees in the UK, the Group has participated in the retirement benefits scheme operated by the global HR benefits and human resource consulting firm authorised and regulated by the Financial Conduct Authority. The employees are entitled to post retirement cash commutation. Details of the scheme are set out in note 3 and note 25(b) to the consolidated financial statements. No forfeited contribution under UK retirement benefit Scheme is available to reduce the contribution payable in future years.

At 30 June 2023 and 2022, there were no significant forfeited contributions which arose upon employees leaving the schemes before they are fully vested in the contributions and which are available to reduce the contributions payable by the Group in the future.

The New Share Option Schemes were adopted for the purpose (i) to enable the Company to grant Options to the eligible participants as incentives or rewards for their contribution to the growth and development of the Group; (ii) to attract and retain personnel to promote the sustainable development of the Group; and (iii) to align the interest of the grantees with those of the Shareholders to promote the long-term financial and business performance of the Company. The basis of eligibility of any of the eligible persons to the grant of share options shall be determined by the Board from time to time on the basis of their contribution or potential contribution to the development and growth of the Group. The New Share Option Scheme, unless otherwise cancelled or amended, will remain in force for 10 years from 29 December 2022.

An option may be accepted by a participant within 21 days from the date of the offer of grant of the option. A nominal consideration of HK\$1 is payable on acceptance of the grant of an option. An option may be exercised in accordance with the terms of the New Share Option Scheme at any time during a period as determined by the Board, which must not be more than 10 years from the date of the grant. Unless otherwise determined by the Directors and stated in the offer for the grant of options to a grantee, there is no minimum period required under the New Share Option Schemes for the holding of an option before it can be exercised.

#### **30. CAPITAL RISK MANAGEMENT**

The Group manages its capital to ensure that entities in the Group will be able to continue as a going concern while maximising the return to stakeholders through the optimisation of the debt and equity balance. The Group's overall strategy remains unchanged from prior year.

The capital structure of the Group consists of equity attributable to owners of the Company, comprising issued share capital, reserves and accumulated losses.

The directors of the Company review the capital structure on a biannual basis. As part of this review, the directors of the Company consider the cost of capital and the risks associated with each class of capital. Based on recommendations of the directors of the Company, the Group will balance its overall capital structure through the new share issues and share buy-backs as well as the issue of new debt or the redemption of existing debt.
