Subject: Paratek Pharmaceuticals, Inc. – Anticipated Cash Settlement Option Symbol: PRTK Date: ???

On September 18, 2023, Shareholders of Paratek Pharmaceuticals, Inc. (PRTK) will vote concerning the proposed merger with a wholly owned subsidiary of Resistance Acquisition, Inc., both controlled by affiliates of Gurnet Point Capital, LLC and Novo Holdings A/S. If the merger is approved and consummated, each existing PRTK Common Share will be converted into the right to receive \$2.15 Cash plus one non-transferable Contingent Value Right ("CVR") per share.

Note: The CVR represents a non-transferable contractual right to receive an additional payment. The adjusted PRTK option deliverable will not include the non-transferable CVRs.

Exercise Consideration – PRTK options will not call for the delivery of the CVRs. Call option holders who wish to receive the CVRs should exercise their options in sufficient time in advance of the contract adjustment. In all cases, it is the sole responsibility of persons holding call options seeking to receive the underlying securities to determine when to exercise their options.

Contract Adjustment

Date:	Effective the opening of the business day after the merger is consummated. Contract adjustment is expected to occur in the third quarter of 2023.

Settlement in PRTK options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

Acceleration of Expirations
