Broadway Financial Corporation (BYFC) has announced a 1-for-8 reverse stock split. As a result of the reverse stock split, each BYFC Class A Common Share will be converted into the right to receive 0.125 (New) Broadway Financial Corporation Class A Common Shares. The reverse stock split will become effective before the market open on November 1, 2023. Cash will be paid in lieu of fractional shares.

BYFC1 = 0.125 (BYFC)

Delayed Settlement

The BYFC component of the BYFC1 deliverable will settle through National Securities Clearing Corporation (NSCC). OCC will delay settlement of the cash portion of the BYFC1 deliverable until the cash in lieu of fractional BYFC Shares is determined. Upon determination of the cash in lieu amount, OCC will require Put exercisers and Call assignees to deliver the appropriate cash amount.
