Subject: Hersha Hospitality Trust - Cash Settlement/Acceleration of Expirations

On November 8, 2023, Shareholders of Hersha Hospitality Trust (HT) voted concerning the proposed merger with 1776 Portfolio REIT Merger Sub, LLC, a wholly owned subsidiary of 1776 Portfolio Investment, LLC. The merger was approved and subsequently consummated before the open on November 28, 2023. As a result, each existing HT Common Share will be converted into the right to receive \$10.00 net cash per share.

Contract Adjustment

New Deliverable

Per Contract: \$1,000.00 Cash (\$10.00 x 100)

Settlement in HT options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

Acceleration of Expirations

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cashonly delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of Hersha Hospitality Trust options whose expiration dates are after 12-15-2023 will have their expiration dates advanced to 12-15-2023. Expiration dates occurring before 12-15-2023 (e.g., Flex options) will remain unchanged.

All Hersha Hospitality Trust options will utilize a \$.01 exercise threshold.

Existing Expiration: All months New expiration date: 12-15-2023

Existing American-style Hersha Hospitality Trust options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in two business days.
