On July 17, 2023, Shareholders of Embark Technology, Inc. (EMBK) voted concerning the proposed merger with Azara Merger Sub, Inc., a wholly owned subsidiary of Applied Intuition, Inc. The merger was approved and subsequently consummated before the open on August 2, 2023. As a result, each existing EMBK Class A Common Share will be converted into the right to receive \$2.88 net cash per share.

Settlement in EMBK options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

Acceleration of Expirations

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cashonly delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of Embark Technology, Inc. options whose expiration dates are after 08-18-2023 will have their expiration dates advanced to 08-18-2023. Expiration dates occurring before 08-18-2023 (e.g., Flex options) will remain unchanged.

All Embark Technology, Inc. options will utilize a \$.01 exercise threshold.

Existing American-style Embark Technology, Inc. options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in two business days. <u>Disclaimer</u>
