Subject: Adjusted Alzamend Neuro, Inc. - Cash In Lieu Settlement
Adjusted Option Symbol: ALZN1

Adjusted Alzamend Neuro, Inc. options were adjusted on October 31, 2023 (See OCC Information Memo #53455). The new deliverable became 1) 6 Alzamend Neuro, Inc. (ALZN) Common Shares, and 2) Cash in lieu of approximately 0.6667 fractional ALZN Shares. Only settlement of the cash portion of ALZN1 options exercise/assignment activity was subject to delayed settlement.

OCC has been informed that a price of \$1.61619 per whole ALZN share will be used to determine the cash in lieu amount at a rate of 0.6667. Accordingly, the cash in lieu amount is:

$$0.6667 \times \$1.61619 = \$1.08 \text{ per ALZN1 Contract}$$

Now that the exact cash in lieu amount has been determined, OCC will require Put exercisers and Call assignees, during the period of October 31, 2023 through November 14, 2023, to deliver the appropriate cash amount.

The cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.

Terms of the ALZN1 options are as follows:

New Deliverable

Per Contract: 1) 6 Alzamend Neuro, Inc. (ALZN) Common Shares
2) \$1.08 Cash

Strike Prices: Unchanged

CUSIP: ALZN: 02262M407

Multiplier: 100 (i.e., a premium of 1.50 yields \$150)

Settlement

The ALZN component of ALZN1 exercise/assignment activity from October 31, 2023 through November 13, 2023, has settled through National Security Clearing Corporation (NSCC). The \$1.08 cash amount will be settled by OCC.

Pricing

The underlying price for ALZN1 will be determined as follows:

$$\text{ALZN1} = 0.06 (\text{ALZN}) + 0.0108$$

For example, if ALZN closes at 1.36, the ALZN1 price would be calculated as follows:

$$\text{ALZN1} = 0.06 (1.36) + 0.0108 = 0.09$$
