VirnetX Holding Corporation (VHC) has announced a 1-for-20 reverse stock split. As a result of the reverse stock split, each VHC Common Share will be converted into the right to receive 0.05 (New) VirnetX Holding Corporation Common Shares. The reverse stock split will become effective before the market open on October 26, 2023.
