On December 6, 2022, the majority shareholders of Vivint Smart Home, Inc. (VVNT), which together on such date beneficially owned approximately 58.6% of the outstanding shares of VVNT, delivered a written consent approving and adopting a merger agreement with Jetson Merger Sub, Inc., a wholly-owned subsidiary of NRG Energy, Inc. The merger was subsequently consummated before the open on March 10, 2023. As a result, each existing VVNT Class A Common Share will be converted into the right to receive \$12.00 net cash per share.

#### **Contract Adjustment**

**Date:** March 10, 2023

**New Deliverable  
Per Contract:** \$1,200.00 Cash (\$12.00 x 100)

Settlement in VVNT options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

#### **Acceleration of Expirations**

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash-only delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of Vivint Smart Home, Inc. options whose expiration dates are after 03-17-2023 will have their expiration dates advanced to 03-17-2023. Expiration dates occurring before 03-17-2023 (e.g., Flex options) will remain unchanged.

All Vivint Smart Home, Inc. options will utilize a \$.01 exercise threshold.

New expiration date: 03-17-2023

Existing American-style Vivint Smart Home, Inc. options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in two business days.
