Imperial Petroleum Inc. (IMPP) has announced a 1-for-15 reverse stock split. As a result of the reverse stock split, each IMPP Common Share will be converted into the right to receive approximately 0.066667 (New) Imperial Petroleum Inc. Common Shares. The reverse stock split will become effective before the market open on April 28, 2023. Cash will be paid in lieu of fractional shares.

## **Delayed Settlement**

The IMPP component of the IMPP1 deliverable will settle through National Securities Clearing Corporation (NSCC). OCC will delay settlement of the cash portion of the IMPP1 deliverable until the cash in lieu of fractional IMPP Shares is determined. Upon determination of the cash in lieu amount, OCC will require Put exercisers and Call assignees to deliver the appropriate cash amount.
