On March 17, 2023, ABP Acquisition 2 LLC, a wholly owned subsidiary of ABP Acquisition LLC, completed its tender offer for AlerisLife Inc. (ALR). The subsequent merger was consummated before the open on March 20, 2023. As a result, each existing ALR Common Share will be converted into the right to receive \$1.31 net cash per share.

Per Contract:** \$131.00 Cash (\$1.31 x 100)

Settlement in ALR options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

Acceleration of Expirations

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash-only delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of AlerisLife Inc. options whose expiration dates are after 04-21-2023 will have their expiration dates advanced to 04-21-2023. Expiration dates occurring before 04-21-2023 (e.g., Flex options) will remain unchanged.

All AlerisLife Inc. options will utilize a \$.01 exercise threshold.

New expiration date: 04-21-2023

Existing American-style AlerisLife Inc. options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in two business days.
