On November 24, 2023, Listed Funds Trust announced it will liquidate the Roundhill MEME ETF (MEME). MEME shares were suspended from trading on the New York Stock Exchange before the open on December 13, 2023. Proceeds of the liquidation were distributed to shareholders in the amount of \$38.489173 per MEME share on December 15, 2023.

Contract Adjustment

The option symbol MEME will not change.

MEME options, which were subject to delayed settlement from December 13, 2023 through December 14, 2023, are no longer subject to delayed settlement, effective December 15, 2023.

Settlement in MEME options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

Acceleration of Expirations

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cashonly delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of Roundhill MEME ETF whose expiration dates are after 01-19-2024 will have their expiration dates advanced to 01-19-2024. Expiration dates occurring before 01-19-2024 (e.g., Flex options) will remain unchanged.

All Roundhill MEME ETF options will utilize a \$.01 exercise threshold.

Option Symbol: MEME Existing Expiration: All months New expiration date: 01-19-2024

Existing American-style Roundhill MEME ETF options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in two business days.
