Subject: Adjusted Biocept, Inc. - Cash In Lieu Settlement
Adjusted Option Symbol: BIOC1

Adjusted Biocept, Inc. options were adjusted on May 17, 2023 (See OCC Information Memo #52424).

The new deliverable became 1) 3 Biocept, Inc. (BIOC) Common Shares and 2) Cash in lieu of approximately 0.3333 fractional BIOC Shares. Only settlement of the cash portion of BIOC1 options exercise/assignment activity was subject to delayed settlement.

OCC has been informed that a price of \$3.89 per whole BIOC share will be used to determine the cash in lieu amount at a rate of 0.3333. Accordingly, the cash in lieu amount is:

$$0.3333 \times \$3.89 = \$1.30 \text{ per BIOC1 Contract}$$

Now that the exact cash in lieu amount has been determined, OCC will require Put exercisers and Call assignees, during the period of May 17, 2023 through June 9, 2023, to deliver the appropriate cash amount.

The cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.

Terms of the BIOC1 options are as follows:

New Deliverable Per Contract:	1) 3 Biocept, Inc. Common Shares 2) \$1.30 Cash
Strike Prices:	Unchanged
CUSIP:	09072V600
Multiplier:	100 (i.e., a premium of 1.50 yields \$150)

Settlement

The BIOC component of BIOC1 exercise/assignment activity from May 17, 2023 through June 8, 2023, has settled through National Security Clearing Corporation (NSCC). The \$1.30 cash amount will be settled by OCC.

Pricing

The underlying price for BIOC1 will be determined as follows:

$$\text{BIOC1} = 0.03 (\text{BIOC}) + 0.013$$

For example, if BIOC closes at 2.06, the BIOC1 price would be calculated as follows:

$$\text{BIOC1} = 0.03 (2.06) + 0.013 = 0.07$$
