**Subject:** Adjusted Sigilon Therapeutics, Inc. - Cash In Lieu Settlement  
Adjusted Option Symbol: SGTX1

Adjusted Sigilon Therapeutics, Inc. options were adjusted on May 23, 2023 (See OCC Information Memo #52475).

The new deliverable became 1) 7 Sigilon Therapeutics, Inc. (SGTX) Common Shares and 2) Cash in lieu of approximately 0.6923 fractional SGTX Shares. Only settlement of the cash portion of SGTX1 options exercise/assignment activity was subject to delayed settlement.

OCC has been informed that a price of \$5.70 per whole SGTX share will be used to determine the cash in lieu amount at a rate of 0.6923077. Accordingly, the cash in lieu amount is:

$$0.6923077 \times \$5.70 = \$3.95 \text{ per SGTX1 Contract}$$

Now that the exact cash in lieu amount has been determined, OCC will require Put exercisers and Call assignees, during the period of May 23, 2023 through June 9, 2023, to deliver the appropriate cash amount.

**The cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.**

Terms of the SGTX1 options are as follows:

**New Deliverable**

**Per Contract:** 1) 7 Sigilon Therapeutics, Inc. (SGTX) Common Shares  
2) \$3.95 Cash

**Strike Prices:** Unchanged

**CUSIP:** 82657L206

**Multiplier:** 100 (i.e., a premium of 1.50 yields \$150)

**Settlement**

The SGTX component of SGTX1 exercise/assignment activity from May 23, 2023 through June 8, 2023, has settled through National Security Clearing Corporation (NSCC). The \$3.95 cash amount will be settled by OCC.

### **Pricing**

The underlying price for SGTX1 will be determined as follows:

$$\text{SGTX1} = 0.07 (\text{SGTX}) + 0.0395$$

For example, if SGTX closes at 4.49, the SGTX1 price would be calculated as follows:

$$\text{SGTX1} = 0.07 (4.49) + 0.0395 = 0.35$$
