Subject: Blue Apron Holdings, Inc. – Cash In Lieu Settlement
Adjusted Option Symbol: APRN1

Blue Apron Holdings, Inc. options were adjusted on June 8, 2023 (See OCC Information Memo #52554). The new deliverable became 1) 8 Blue Apron Holdings, Inc. (APRN) Class A Common Shares and 2) Cash in lieu of approximately 0.3333 fractional APRN Shares. Only settlement of the cash portion of APRN1 options exercise/assignment activity was subject to delayed settlement.

OCC has been informed that a price of \$7.42 per whole APRN share will be used to determine the cash in lieu amount at a rate of 0.3333. Accordingly, the cash in lieu amount is:

$$0.3333 \times \$7.42 = \$2.47 \text{ per APRN1 Contract}$$

Now that the exact cash in lieu amount has been determined, OCC will require Put exercisers and Call assignees, during the period of June 8, 2023 through June 23, 2023, to deliver the appropriate cash amount.

The cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.

Terms of the APRN1 options are as follows:

New Deliverable

Per Contract: 1) 8 Blue Apron Holdings, Inc. (APRN) Class A Common Shares
2) \$2.47 Cash

Strike Prices: Unchanged

CUSIP: APRN: 09523Q309

Multiplier: 100 (i.e., a premium of 1.50 yields \$150)

Settlement

The APRN component of APRN1 exercise/assignment activity from June 8, 2023 through June 22, 2023, has settled through National Security Clearing Corporation (NSCC). The \$2.47 cash amount will be settled by OCC.

Pricing

The underlying price for APRN1 will be determined as follows:

$$\text{APRN1} = 0.08 (\text{APRN}) + 0.0247$$

For example, if APRN closes at 6.26, the APRN1 price would be calculated as follows:

$$\text{APRN1} = 0.08 (6.26) + 0.0247 = 0.53$$
