Subject: Adjusted Finch Therapeutics Group, Inc. – Cash In Lieu Settlement

Adjusted Option Symbol: FNCH1

Finch Therapeutics Group, Inc. options were adjusted on June 12, 2023 (See OCC Information Memo #52593). The new deliverable became 1) 3 Finch Therapeutics Group, Inc. (FNCH) Common Shares and 2) Cash in lieu of approximately 0.3333 fractional FNCH Shares. Only settlement of the cash portion of FNCH1 options exercise/assignment activity was subject to delayed settlement.

OCC has been informed that a price of \$8.13 per whole FNCH share will be used to determine the cash in lieu amount at a rate of 0.3333. Accordingly, the cash in lieu amount is:

 $0.3333 \times \$8.13 = \$2.71 \text{ per FNCH1 Contract}$ 

Now that the exact cash in lieu amount has been determined, OCC will require Put exercisers and Call assignees, during the period of June 12, 2023 through July 12, 2023, to deliver the appropriate cash amount.

The cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.

Terms of the FNCH1 options are as follows:

**New Deliverable** 

**Per Contract:** 1) 3 Finch Therapeutics Group, Inc. (FNCH) Common Shares

2) \$2.71 Cash

Strike Prices: Unchanged

**CUSIP:** FNCH: 31773D200

Multiplier: 100 (i.e., a premium of 1.50 yields \$150)

## Settlement

The FNCH component of FNCH1 exercise/assignment activity from June 12, 2023 through July 11, 2023, has settled through National Security Clearing Corporation (NSCC). The \$2.71 cash amount will be settled by OCC.

## **Pricing**

The underlying price for FNCH1 will be determined as follows:

$$FNCH1 = 0.03 (FNCH) + 0.0271$$

For example, if FNCH closes at 9.29, the FNCH1 price would be calculated as follows:

$$FNCH1 = 0.03 (9.29) + 0.0271 = 0.31$$
