Subject: Adjusted Imperial Petroleum Inc. – Cash In Lieu Settlement
Adjusted Option Symbol: IMPP1

Adjusted Imperial Petroleum Inc. options were adjusted on June 22, 2023 (See OCC Information Memo #52702). The new deliverable became 1) 6 Imperial Petroleum Inc. (IMPP) Common Shares, 2) Cash in lieu of 0.75 fractional CISS Common Shares, and 3) \$1.69 Cash. Only settlement of the cash portion of IMPP1 options exercise/assignment activity was subject to delayed settlement.

OCC has been informed that a price of \$2.6797 per whole CISS share will be used to determine the cash in lieu amount. Accordingly, the cash in lieu amount is:

$$0.75 \times \$2.6797 = \$2.01 \text{ per IMPP1 Contract}$$

Now that the exact cash in lieu amount has been determined, OCC will require Put exercisers and Call assignees, during the period of June 22, 2023 through July 12, 2023, to deliver the appropriate cash amount.

The cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.

Terms of the IMPP1 options are as follows:

New Deliverable

Per Contract: 1) 6 Imperial Petroleum Inc. (IMPP) Common Shares
2) \$3.70 Cash (\$1.69 + \$2.01)

Strike Prices: Unchanged

CUSIPs: IMPP: Y3894J187
CISS: Y18284102

Multiplier: 100 (i.e., a premium of 1.50 yields \$150)

Settlement

The IMPP component of IMPP1 exercise/assignment activity from June 22, 2023 through July 11, 2023, has settled through National Security Clearing Corporation (NSCC). The \$3.70 cash amount will be settled by OCC.

Pricing

The underlying price for IMPP1 will be determined as follows:

$$\text{IMPP1} = 0.06 (\text{IMPP}) + 0.0370$$

For example, if IMPP closes at 3.09, the IMPP1 price would be calculated as follows:

$$\text{IMPP1} = 0.06 (3.09) + 0.0370 = 0.22$$
