Subject: Adjusted ContraFect Corporation - Cash In Lieu Settlement
Adjusted Option Symbol: CFRX1

Adjusted ContraFect Corporation options were adjusted on February 15, 2023 (See OCC Information Memo #51948). The new deliverable became 1) 1 ContraFect Corporation (CFRX) Common Shares, and 2) Cash in lieu of 0.25 fractional CFRX Shares. Only settlement of the cash portion of CFRX1 options exercise/assignment activity was subject to delayed settlement.

OCC has been informed that a price of \$3.73 per whole CFRX share will be used to determine the cash in lieu amount. Accordingly, the cash in lieu amount is:

$$0.25 \times \$3.73 = \$0.93 \text{ per CFRX1 Contract}$$

Now that the exact cash in lieu amount has been determined, OCC will require Put exercisers and Call assignees, during the period of February 15, 2023 through February 23, 2023, to deliver the appropriate cash amount.

The cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.

Terms of the CFRX1 options are as follows:

New Deliverable
Per Contract: 1) 1 ContraFect Corporation (CFRX) Common Shares
2) \$0.93 Cash

Strike Prices: Unchanged

CUSIP: CFRX: 212326409

Multiplier: 100 (i.e., a premium of 1.50 yields \$150)

Settlement

The CFRX component of CFRX1 exercise/assignment activity from February 15, 2023 through February 22, 2023, has settled through National Security Clearing Corporation (NSCC). The \$0.93 cash amount will be settled by OCC.

Pricing

The underlying price for CFRX1 will be determined as follows:

$$\text{CFRX1} = 0.01 (\text{CFRX}) + 0.0093$$

For example, if CFRX closes at 3.20, the CFRX1 price would be calculated as follows:

$$\text{CFRX1} = 0.01 (3.20) + 0.0093 = 0.04$$
