On January 31, 2023, Shareholders of KnowBe4, Inc. (KNBE) will vote concerning the proposed merger with a wholly-owned subsidiary of Oranje Holdco, LLC, an affiliate of Vista Equity Partners Management, LLC. If the merger is approved and consummated, each existing KNBE Class A Common Share will be converted into the right to receive \$24.90 net cash per share.

Contract Adjustment

Date: Effective the opening of the business day after the merger is consummated.

Contract adjustment is expected to occur in 2023.

New Deliverable

Per Contract: \$2,490.00 Cash (\$24.90 x 100)

Settlement in KNBE options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

Acceleration of Expirations

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cashonly delivery will be subject to **an acceleration of the expiration dates for outstanding option series** (See OCC Information Memo 23988).
