Swvl Holdings Corporation (SWVL) has announced a 1-for-25 reverse stock split. As a result of the reverse stock split, each SWVL Class A Common Share will be converted into the right to receive 0.04 (New) Swvl Holdings Corporation Class A Common Shares. The reverse stock split will become effective before the market open on January 26, 2023.
