Delayed Settlement

The WAFD component of the WAFD1 deliverable will settle through National Securities Clearing Corporation (NSCC). OCC will delay settlement of the cash portion of the WAFD1 deliverable until the cash in lieu of fractional WAFD shares is determined. Upon determination of the cash in lieu amount, OCC will require Put exercisers and Call assignees to deliver the appropriate cash amount.

Background

On May 4, 2023, Shareholders of Luther Burbank Corporation (LBC) voted concerning the proposed merger with Washington Federal, Inc. (WAFD). The merger was approved and subsequently consummated on February 29, 2024. As a result, each existing LBC Common Share will be converted into the right to receive 0.3353 WAFD Common Shares. Cash will be paid in lieu of fractional WAFD shares.
