Subject: Adjusted Edgio, Inc. - Cash In Lieu Settlement
Adjusted Option Symbol: EGIO1

Adjusted Edgio, Inc. options were adjusted on March 1, 2024 (See OCC Information Memo #54214). The new deliverable became 1) 2 Edgio, Inc. (EGIO) Common Shares and 2) Cash in lieu of 0.5 fractional EGIO Shares. Only settlement of the cash portion of EGIO1 options exercise/assignment activity was subject to delayed settlement.

OCC has been informed that a price of \$8.97 per whole EGIO share will be used to determine the cash in lieu amount. Accordingly, the cash in lieu amount is:

$$0.5 \times \$8.97 = \$4.49 \text{ per EGIO1 Contract}$$

Now that the exact cash in lieu amount has been determined, OCC will require Put exercisers and Call assignees, during the period of March 1, 2024 through March 13, 2024, to deliver the appropriate cash amount.

The cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.

Terms of the EGIO1 options are as follows:

New Deliverable

Per Contract: 1) 2 Edgio, Inc. (EGIO) Common Shares
2) \$4.49 Cash

Strike Prices: Unchanged

CUSIP: EGIO: 53261M203

Multiplier: 100 (i.e., a premium of 1.50 yields \$150)

Settlement

The EGIO component of EGIO1 exercise/assignment activity from March 1, 2024 through March 12, 2024, has settled through National Security Clearing Corporation (NSCC). The \$4.49 cash amount will be settled by OCC.

Pricing

The underlying price for EGIO1 will be determined as follows:

$$\text{EGIO1} = 0.02 (\text{EGIO}) + 0.0449$$

For example, if EGIO closes at 8.16, the EGIO1 price would be calculated as follows:

$$\text{EGIO1} = 0.02 (8.16) + 0.0449 = 0.21$$
