Subject: BlackRock Capital Investment Corporation - Cash In Lieu Settlement
Adjusted Option Symbol: TCPC1

BlackRock Capital Investment Corporation options were adjusted on March 19, 2024 (See OCC Information Memo #54330). The new deliverable became 1) 38 BlackRock TCP Capital Corporation (TCPC) Common Shares, and 2) Cash in lieu of 0.34 TCPC shares. Only settlement of the cash portion of TCPC1 options exercise/assignment activity was subject to delayed settlement.

OCC has been informed that a price of \$10.95 per whole TCPC share will be used to determine the cash in lieu amount. Accordingly, the cash in lieu amount is:

$$0.34 \times \$10.95 = \$3.72 \text{ per TCPC1 Contract}$$

Now that the exact cash in lieu amount has been determined, OCC will require Put exercisers and Call assignees, during the period of March 19, 2024 through March 28, 2024, to deliver the appropriate cash amount.

The cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.

Terms of the TCPC1 options are as follows:

New Deliverable

Per Contract: 1) 38 BlackRock TCP Capital Corporation (TCPC) Common Shares
2) \$3.72 Cash

Strike Prices: Unchanged

CUSIP: TCPC: 09259E108

Multiplier: 100 (i.e., a premium of 1.50 yields \$150)

Settlement

The TCPC component of TCPC1 exercise/assignment activity from March 19, 2024 through March 27, 2024, has settled through National Security Clearing Corporation (NSCC). The \$3.72 cash amount will be settled by OCC.

Pricing

The underlying price for TCPC1 will be determined as follows:

$$\text{TCPC1} = 0.38 (\text{TCPC}) + 0.0372$$

For example, if TCPC closes at 10.38, the TCPC1 price would be calculated as follows:

$$\text{TCPC1} = 0.38 (10.38) + 0.0372 = 3.98$$
