CHAIRMAN'S STATEMENT 主席報告



Dear Shareholders,

For and on behalf of the board (the "**Board**") of directors (the "**Directors**") of Best Mart 360 Holdings Limited (the "**Company**", together with its subsidiaries, the "**Group**"), I am pleased to present the Group's results for the nine months ended 31 December 2023 (the "**Financial Period under Review**") to the shareholders of the Company (the "**Shareholders**").

CHAIRMAN'S STATEMENT 主席報告

During the Financial Period under Review, Hong Kong and the world are gradually recovering from the COVID-19 pandemic. However, the pace of economic recovery in various places has been hampered by negative factors, including tightening of monetary policy and the Russia-Ukraine conflicts. In the face of the unstable external business environment, the Group continued to adjust its product mix and sales strategies when appropriate, and through an effective pricing policy, we maintained sales and profit growth during the Financial Period under Review. In addition, we sourced a diverse range of products from all over the world and have been stringently selecting product suppliers to further enrich our product categories while controlling costs more effectively, so as to uphold the principle of providing products of "Best Quality" and "Best Price" to customers.

Looking ahead, the Group will continue to focus on its longterm development goals of maintaining a foothold in Hong Kong and expanding overseas to inject new impetus into the Group for its future growth. During the Financial Period under Review, we introduced China Merchants Hoi Tung Trading Company Limited (the "CMHT") as a substantial shareholder. We anticipated that, by virtue of its extensive cooperative network and resources, it would provide us with significant strategic support and promotes business synergies, thus promoting sustained business growth. The management is confident in our ability to uphold our competitiveness in the market with its solid business foundation.

As business activities resume, Hong Kong continued to launch various international events to attract tourists from all over the world. Looking forward, the management remains cautiously optimistic in promoting the development of the retail business in order to withstand economic or other uncertainties. The Group will continue to work with our colleagues, suppliers, customers, business partners and shareholders to lead the Group to scale new heights and strives for a better brand. Our management will also adhere to our business objectives and strive to provide customers with comfortable and superior shopping experience and meet the needs of different consumers and markets by continuously pursuing global sourcing. 回顧財政期間,本港以至全球逐步走出新型冠 狀病毒疫情的陰霾,惟受貨幣政策收緊及俄烏 戰事等負面因素影響,各地經濟復蘇步伐受 阻。面對外圍不穩定的營商環境,本集團繼 續因時制宜調整產品組合和銷售策略,透過有 效的價格政策,我們於回顧財政期間仍然維持 銷售及盈利增長。此外,我們於世界各地採購 多元化產品,並一直嚴格篩選產品供應商,務 求進一步豐富產品種類的同時,更有效控制成 本,以秉持為顧客提供「優質」、「優價」產品的宗 旨。

展望未來,本集團將繼續以扎根香港、拓展海 外為長遠發展目標,為本集團未來增長注入新 動力。於回顧財政期間,我們引入招商局海通 貿易有限公司(「**招商海通**」)為主要股東,期望藉 着其龐大的合作網絡和資源,為我們提供重要 戰略支持,尋求業務協同以促進業務的持續增 長。管理層深信,憑藉穩固的業務根基,本集 團能在市場上保持一定競爭力。

隨著商業活動復常,本港陸續復辦不同國際級 盛事,吸引各地遊客訪港。展望未來,管理層 仍以樂觀審慎的態度推動零售業務的發展,抵 禦經濟或其他不穩定的因素影響。本集團將繼 續與我們的同事、供應商、顧客、業務夥伴及 股東攜手合作,帶領本集團邁向更高峰,成為 更優質的品牌。管理層亦會堅守我們的經營宗 旨,通過不斷努力進行環球採購,致力為顧客 提供舒適及優越的購物體驗,滿足不同消費者 及市場的需求。

To further elevate the Group's profitability, the management will strive to refine our operational efficiency and further strengthen our cost control measures. In collaboration with CMHT, we endeavor to keep abreast of the times and make continuous improvement to maintain our leading position in the Hong Kong leisure food retail market, thereby ensuring stable and sustainable returns for our shareholders. The Board has recommended the payment of a dividend of HK6.0 cents per share for the nine months ended 31 December 2023.

On behalf of the Board, I would like to express my appreciation to the Group's management team and employees for their effort in contributing to the development of the Group. CHIEF EXECUTIVE OFFICER'S STATEMENT 行政總裁報告



Dear Shareholders,

During the Financial Period under Review, the haze of the COVID-19 outbreak gradually dissipated. Local economic activities returned to normal and the number of visitors to Hong Kong rebounded. However, the retail sector remains under pressure due to declining consumer sentiment driven by negative factors such as inflation and geopolitical situation, as well as the changes in consumption patterns of tourists coming to Hong Kong. Tourists are increasingly forgoing traditional shopping in favour of engaging in local culture, arts and other activities. During the Financial Period under Review, the Group responded quickly to the market changes and adjusted our business strategies. This involved optimizing our product mix and retail shop distribution to align with consumer needs. These adjustments resulted in a growth for both sales and profits of the Group, even against an overall retail market that has yet to fully recover.

尊敬的股東們:

於回顧財政期間,新型冠狀病毒疫情陰霾逐漸 消散,本地經濟活動重回正軌,訪港旅客人數 亦迎來反彈。然而,受通脹、地緣政治局勢等 負面因素影響,加上旅客來港消費模式轉變, 消費意欲下跌,讓零售業持續受壓。旅客逐漸 放棄傳統購物,轉而青睞本土文化、藝術及 其他活動。於回顧財政期間,本集團因應市場 變化迅速調整我們的業務策略,包括優化我們 的產品結構及零售店舖分佈,以滿足消費者需 求。該等調整令本集團於整體零售市場亦未全 面復蘇的情況下仍錄得銷售及盈利增長。 During the Financial Period under Review, the Group recorded a revenue of approximately HK\$1,930,831,000, representing a period-on-period increase of approximately 17.3% as compared with the unaudited revenue of the same nine-month period in 2022. During the Financial Period under Review, the profit attributable to owners of the Company was approximately HK\$168,335,000, representing a period-on-period increase of approximately 18.9% as compared with the unaudited profit attributable to owners of the Company of the same ninemonth period in 2022. Thanks to the hard work of the Group's management and all employees, the Group has remained vigilant in the face of different operating situations and has been able to respond appropriately to the unpredictable market environment.

GENERAL DESCRIPTION

As at 31 December 2023, the total number of the Group's retail stores increased from 154 stores as at 31 March 2023 to 167 stores. During the Financial Period under Review, the Group's global gourmet brand "FoodVille" added 2 new stores in Hong Kong, focusing on mid-to-high-end global quality food. Despite the uncertainties in the external economic environment, the Group maintained a steady pace in opening new retail stores. Our aim is to enhance the regional layout of local livelihood by actively seeking locations with reasonable rents, high customer traffic and geographical advantages for the expansion of our branches. During the Financial Period under Review, the Group continued to actively optimize our product mix, source more "Best Quality" and "Best Price" products around the world, which not only met the daily needs of local residents, but also introduced distinctive products to inbound visitors.

The Group is committed to building stable cooperative relationships with global suppliers and persistently seeks new suppliers to enrich its product categories and portfolio. The Group further developed its private label products during the Financial Period under Review, bringing advanced selection to customers. The private label products are conducive to improving the Group's overall profitability and exclusive brand image as well as strengthening customer loyalty. The related sales increased significantly by approximately 23.5% period-on-period, and the proportion of revenue further increased to approximately 15.8%.

於回顧財政期間,本集團錄得收入約1,930,831,000 港元,較二零二二年九個月同期未經審核收入增長約 17.3%;於回顧財政期間,本公司擁有人應佔溢利約 為168,335,000港元,較二零二二年九個月同期未經 審核本公司擁有人應佔溢利增長約18.9%。全賴本集 團管理層與全體員工的努力付出,面對不同經營情況 仍然謹守崗位,並能妥善地應對變幻莫測的市場環 境。

概況

於二零二三年十二月三十一日,本集團的零售 店舖總數由二零二三年三月三十一日的154間增 加至167間。於回顧財政期間,本集團旗下環球 美酒食品品牌[FoodVille]於本地新增2間分店, 主打中高端的環球優質食品。儘管外圍經濟環 境仍然存在不穩定因素,本集團繼續保持穩健 速度開設新的零售店舖。我們以加大本地民 麗家流量較大,以及地理環境優越的位置拓展 分店。本集團於回顧財政期間仍然積極優化我 份的產品結構,並積極地在世界各地搜羅更多 [優質]和[優價]的產品,既滿足本地居民日常 生活所需,同時為入境旅客帶來具有特色的商 品。

本集團一直致力與全球供應商建立穩定的合作 關係,並持續尋找新的供應商,以豐富其產品 種類及產品組合。於回顧財政期間,本集團進 一步開發自家品牌產品,為顧客帶來更高端的 選擇。自家品牌產品有利於本集團提升整體利 潤率以至品牌專屬形象,並加強顧客忠誠度, 相關的銷售額較同期顯著增加約23.5%,收入 佔比亦進一步提升至約15.8%。 During the Financial Period under Review, the Group actively expanded its business-to-business (B2B) operations by selling "Best Quality" products to retailers in Hong Kong and other markets so as to broaden the Group's revenue streams through diversified businesses. Concurrently, the Group capitalized on the strengths of its existing team to fully harness the synergies and attract more potential customers.

PROSPECTS

Looking ahead, the global economic environment is recovering sluggishly and the business environment for the retail sector remains uncertain. The management of the Group will pay close attention to the uncertain factors affecting the Group's operations and promptly implement appropriate business measures. We will uphold the principles of "Best Quality" and "Best Price", adhere to the concept of global procurement, and enable the procurement team to refine the product portfolio in line with market demand. This will consolidate the core competitiveness of the Group and achieve our goal of business diversification.

The Group will persist in offering a wide range of products at competitive prices by adopting global procurement strategy and continue to optimize its product mix to procure more food and essentials for local community customers and overseas tourists, fulfilling their demands and expectations. On the other hand, the Group will continue to develop its private label products, strive to provide customers with diversified choices, and will look for opportunities to promote its private label products to different markets to further optimize the overall sales of the Group's product portfolio. 於回顧財政期間,本集團積極拓展企業對企業 (Business-to-Business,B2B)之業務,出售「優質」 產品予本港及其他市場的零售商,透過多元化 業務拓展本集團收入來源。同時本集團利用既 有團隊的優勢,充分發揮協同效應,吸引更多 潛在客戶群。

前景

展望未來,環球經濟環境復蘇乏力,零售業的 營商環境仍然不明朗。本集團管理層將密切留 意各項影響本集團營運的不穩定因素,迅速實 行合適的業務措施。我們將秉持「優質」和「優價」 的宗旨,堅持環球採購的理念,讓採購團隊按 市場需求改善產品組合。此舉將鞏固本集團核 心競爭力,實現我們業務多元化發展的目標。

透過環球採購的策略,本集團將繼續以具競爭 力的價格提供廣泛種類的產品,並持續優化產 品結構,為本地社區顧客及海外旅客搜羅更多 食品及必需品,滿足顧客的需求及期望。另一 方面,本集團將繼續研發自家品牌產品,致力 為顧客提供多元化的選擇,並將會物色機會向 不同的市場推廣自家品牌產品,進一步優化本 集團的產品組合整體銷售額。

Retail Network 零售網絡

The Group continues to adopt a dual-brand strategy, consistently seeking suitable opportunities to expand the store network of its key retail brand, "Best Mart 360°" and global gourmet store, "FoodVille". As of 31 December 2023, the Group operated a total of 167 chain retail stores, strategically located in areas with heavy pedestrian flow in Hong Kong, Macau and Mainland China. These locations meet the demands of different customer segments for quality food products. The "Best Mart 360°" brand focuses on serving residential areas and expanding its store coverage, while "FoodVille" targets large network and medium-to-high-end shopping malls in Hong Kong as well as stores with larger area and locations with higher customer traffic and stronger consumer spending power. With the continuous expansion of store networks, the Group's turnover is growing steadily.

優品 360° 成立10週年舉行「一起童行」兒童慈善活動



In celebration of Best Mart 360°'s 10th anniversary, the Group has initiated a series of charitable activities focused on children. The initiative began in July with the "Walk with Kids. Best Buy, We Donate!" campaign – The Group pledged a donation of 1% of sales from "Famille", "Pando", or "Kalbarri" products purchased at Best Mart 360° branches in Hong Kong and Macau or FoodVille, amounting to HK\$150,000. This donation is aimed at funding various charitable activities in collaboration with the Society for Community Organization, aiming to give back to society and benefit over 1,000 families.

The activities include distributing shoe vouchers to 250 underprivileged children in August, enabling them to select new leather shoes or sneakers of their choice, and welcoming the new school year with a sense of comfort and confidence. Additionally, over 500 families living in subdivided flats or transitional housing were invited to exclusive cinema screenings of a family-friendly animated movie during the first weekend of the new school term.

In line with the Mid-Autumn Festival, the group gifted 500 goodie bags to underprivileged families, extending festive greetings and sharing joy. Volunteers made personal visits to several families in the Sham Shui Po district to hand out these goodie bags, engaging in direct conversations to better understand the living situations of the beneficiary families and their children's educational environments, thereby spreading care and warmth.

The Group is a leisure food retailer operating chain retail stores under the brands "Best Mart 360°" and "FoodVille" in Hong Kong, Macau and the PRC. The Group offers wide selection of imported pre-packaged leisure foods and other grocery products principally from overseas, which can be broadly categorised into (i) chocolates and confectioneries; (ii) nuts and dried fruits; (iii) packaged bakery products and snacks; (iv) biscuits and pastries; (v) cereals and milk; (vi) beverages and wine; (vii) rice, noodles and groceries; (viii) frozen and chilled food; and (ix) other products, such as personal care products, daily items and anti-epidemic products. It is the Group's business objective to offer "Best Quality" and "Best Price" products to customers through continuous efforts on global procurement, with a mission to provide comfortable shopping environment and pleasurable shopping experience to customers.

As disclosed in the announcement of the Company dated 5 September 2023, the Board resolved to change the financial year end date of the Company from 31 March to 31 December. Accordingly, the current audited consolidated financial statements of the Company covered a period of nine months from 1 April 2023 to 31 December 2023 and the audited comparative figures covered a period of twelve months from 1 April 2022 to 31 March 2023. Due to the difference in the length of the reporting period, the audited comparative figures may not be fully comparable.

BUSINESS REVIEW

During the Financial Period under Review, the COVID-19 outbreak has gradually stabilised, and since the resumption of travel in February last year, the Hong Kong Government has been actively preparing and organising a number of large-scale events for the purpose of attracting overseas visitors' revisit and stimulating the retail consumption market. However, under the haze of the global monetary policy tightening cycle and the Russia-Ukraine war, with the slowdown of economic growths in various places, which dragged down the recovery of tourism, retail and other industries and weakened personal consumption expenditure, the business environment continued to be full of uncertainties. 本集團為一間連鎖休閒食品零售商,於香港、 澳門及中國經營「優品360°」及「FoodVille」品牌零 售店舖。本集團提供廣泛種類,主要來自海外 的進口預先包裝休閒食品及其他雜貨產品,其 可大致分為:(i)朱古力及糖果;(ii)果仁及乾果; (iii)包裝烘焙產品及零食;(iv)餅乾及糕點;(v)穀 類食品及牛奶:(vi)飲品及酒類:(vii)米、麵食及 糧油雜貨;(viii)冷凍及急凍食物;及(ix)其他產 品,例如個人護理、生活用品及防疫產品等。 本集團的經營宗旨是通過環球採購不斷努力, 為顧客提供「優質」和「優價」的產品,以向顧客提 供舒適的購物環境和愉快的購物體驗為使命。

誠如本公司日期為二零二三年九月五日的公告 所披露,董事會決議將本公司的財政年度結算 日由三月三十一日變更為十二月三十一日。因 此,本公司當前經審核綜合財務報表涵蓋二零 二三年四月一日起至二零二三年十二月三十一 日止九個月期間,以及經審核比較數字涵蓋二 零二二年四月一日起至二零二三年三月三十一 日止十二個月期間。因報告期間長度不同,該 經審核比較數字未必完全具有可比性。

業務回顧

於回顧財政期間,新型冠狀病毒疫情逐漸回 穩,加上自去年二月通關以來,港府一直積極 籌辦多項大型活動盛事,冀吸引海外旅客重 臨,刺激零售消費市道。然而,在全球貨幣政 策緊縮週期、俄烏戰事等陰霾籠罩下,各地經 濟增長放緩,拖累旅遊、零售等行業復蘇步伐 減慢,削弱個人消費支出,營商環境繼續充斥 不確定因素。 According to statistics from the Census and Statistics Department, the provisional estimate of the value of retail sales for the whole year of 2023 increased by 16.2% year-on-year, of which the provisional estimates of the value and volume of seasonally adjusted total retail sales decreased by 3.3% and 3.6% respectively in the third quarter of 2023 and the fourth quarter of 2023. In addition, according to a spokesperson for the Hong Kong Tourism Board, the number of visits of tourists to Hong Kong in 2023 recorded approximately 34 million, just returning to approximately half of the pre-COVID-19 level.

Despite the challenging business environment in Hong Kong, the Group continues to rise to the challenge. The Group is committed to enrich its product range and product portfolio to meet the daily needs of consumers in the local community, as well as to introduce global and "made in Hong Kong" specialty foods to attract overseas tourists to purchase in response to the recovery of tourism, which led to the Group's sales growth despite the weak overall retail market during the Financial Period under Review.

For the nine months ended 31 December 2023, the Group recorded revenue of approximately HK\$1,930,831,000, representing a period-on-period increase of approximately 17.3% as compared with the unaudited revenue of same nine-month period in 2022. Of which, revenue from retail stores in Hong Kong, Macau and the PRC accounted for approximately 97.9% of the Group's revenue during the Financial Period under Review. The Group's gross profit margin for the nine months ended 31 December 2023 was approximately 36.0%, representing an increase of approximately 0.6 percentage points compared with approximately 35.4% for the year ended 31 March 2023. During the Financial Period under Review, the Group recorded an approximately 3.4% growth in same store sales performance (for the year ended 31 March 2023: approximately 2.5% growth).

Profit attributable to owners of the Company for the nine months ended 31 December 2023 was approximately HK\$168,335,000 (for the year ended 31 March 2023: approximately HK\$200,997,000). The Group's net profit margin was approximately 8.7% for both the nine months ended 31 December 2023 and the year ended 31 March 2023. 根據政府統計處報告,二零二三年全年的零售 業銷貨價值臨時估計,按年顯著上升16.2%, 其中二零二三年第三季與二零二三年第四季比 較,經季節性調整的零售業總銷貨價值及數量 的臨時估計分別下跌3.3%及3.6%。另外,根據 香港旅遊發展局發言人指,二零二三年全年訪 港旅客人數錄約3,400萬人次,僅回復至新型冠 狀病毒疫情前約一半。

儘管本港營商環境充滿挑戰,本集團仍然積極 迎難而上,本集團致力於豐富其產品範圍及產 品組合,以滿足本地社區消費者的日常需要, 亦引入環球及「香港製造」特色食品,吸引海外 旅客採購以迎接旅遊業復甦,帶動本集團於回 顧財政期間在整體零售市場疲弱情況下,仍錄 得銷售增長。

截至二零二三年十二月三十一日止九個月,本 集團錄得收入約1,930,831,000港元,較二零 二二年同期九個月期間的未經審核收入同比增 加約17.3%。當中來自香港、澳門及中國零售 店舖的收入佔本集團於回顧財政期間的收入約 97.9%。本集團截至二零二三年十二月三十一 日止九個月的毛利率約為36.0%,較二零二三 年三月三十一日止年度約35.4%增長約0.6個百 分點。於回顧財政期間,本集團同店銷售表現 錄得約3.4%增長(截至二零二三年三月三十一日 止年度:約2.5%增長)。

截至二零二三年十二月三十一日止九個月的 本公司擁有人應佔溢利約為168,335,000港 元(截至二零二三年三月三十一日止年度:約 200,997,000港元)。截至二零二三年十二月三十 一日止九個月及截至二零二三年三月三十一日 止年度,本集團的純利率均為約8.7%。

Chain Retail Stores

As at 31 December 2023, the Group operated a total of 167 chain retail stores (31 March 2023: 154 stores), including 159 chain retail stores (31 March 2023: 145 stores) in Hong Kong, 7 chain retail stores (31 March 2023: 7 stores) in Macau and 1 chain retail store (31 March 2023: 2 stores) in Mainland China, respectively. During the Financial Period under Review, the Group opened 19 new retail stores, and closed 6 stores upon expiration of their respective lease terms in alignment with the optimisation of the Group's store opening strategy.

As at 31 December 2023, the 159 retail stores of the Group in Hong Kong consist of 28 retail stores located on Hong Kong Island, 54 retail stores located in Kowloon and 77 retail stores located in the New Territories; while 53 retail stores are street-level stores, 104 retail stores are situated in shopping arcades within community or residential districts and 2 retail stores are situated at traffic hubs that are easily accessible by tourists, spanning over all of the 18 districts in Hong Kong. Rental expense (cash basis) for retail stores was approximately HK\$183,154,000 for the nine months ended 31 December 2023 (for the year ended 31 March 2023: approximately HK\$220,230,000). The typical saleable area of the Group's retail stores ranges from approximately 515 square feet to 2,684 square feet.

The ratio of rental expense (cash basis) to sales revenue of retail stores for the nine months ended 31 December 2023 was approximately 9.5%, which was lower than that of approximately 9.6% for the year ended 31 March 2023.

連鎖零售店舖

於二零二三年十二月三十一日,本集團合共經 營167間連鎖零售店舖(於二零二三年三月三十 一日:154間),包括於香港經營159間連鎖零售 店舖(於二零二三年三月三十一日:145間)、於 澳門經營7間連鎖零售店舖(於二零二三年三月 三十一日:7間)及於內地經營1間連鎖零售店舖 (於二零二三年三月三十一日:2間)。於回顧財 政期間,本集團新開設了19間零售店舖,並因 本集團的開舖策略進行優化,故此在相關店舖 租期屆滿時關閉了6間店舖。

於二零二三年十二月三十一日,本集團香港159 間零售店舖中,28間位於香港島、54間位於九 龍及77間位於新界:當中有53間為街舖、104 間位於社區或住宅區購物商場及2間位於旅客 可輕易到達的多個交通樞紐,遍佈全港18區。 截至二零二三年十二月三十一日止九個月零售 店舖的租金開支(現金基準)約為183,154,000港 元(截至二零二三年三月三十一日止年度:約 220,230,000港元)。本集團零售店舖的一般實 用樓面面積介乎約515平方呎至2,684平方呎不 等。

截至二零二三年十二月三十一日止九個月的零 售店舗租金開支(現金基準)對銷售收入比率約為 9.5%,低於截至二零二三年三月三十一日止年 度的約9.6%。

Employees

Employees are crucial to the sustainable development of the Group's business, and in particular, front-line staffs constitute the majority of the labour force of the Group's retail business. Although the business environment remained challenging during the Financial Period under Review, the Group maintained a steady pace of expansion. As at 31 December 2023, the total number of employees of the Group was 1,322, which, excluding Directors, comprised of 863 full-time employees and 459 part-time employees, while the total number of employees of the Group as at 31 March 2023 was 1,121, which, excluding Directors, comprised of 813 full-time employees and 308 part-time employees. In order to retain talented and skilled labour force and to incentivise the Group's employees so as to increase cohesion and loyalty amongst them, the Group regularly reviews and refreshes the employee benefit scheme and remuneration packages with reference to the supply of the labour market, the trend of labour costs and the individual performance of the employees. The staff costs (excluding the Directors' emoluments) for the nine months ended 31 December 2023 amounted to approximately HK\$181,349,000, representing approximately 9.4% of the revenue of the Group for the Financial Period under Review, while the staff costs (excluding the Directors' emoluments) amounted to approximately HK\$203,338,000 for the year ended 31 March 2023, representing approximately 8.8% of the revenue of the Group for the year. Amongst which, the staff costs of frontline and warehouse staff (including basic salary, commission and other benefits) represented approximately 7.2% and 6.9% of the revenue for each of the nine months ended 31 December 2023 and the year ended 31 March 2023, respectively.

Products

During the Financial Period under Review, the Group continued its global procurement policy and mission by sourcing broad spectrum of products worldwide that meet and satisfy market trend and demand. To better cater to the needs of the local community and the international travellers, the Group further strengthened the supply of basic foodstuffs such as cereals, noodles, canned food, milk, chilled and frozen food, daily necessities and basic grocery products. In addition, the Group continued to strengthen its private label sales in retail stores, including nuts and dried fruits, organic grains, wet tissues, canned food, biscuits and snacks, etc., providing consumers with more diversified choices.

僱員

僱員是本集團業務可持續發展的重要一環,尤 其前線員工是本集團零售業務勞動力的重要組 成部分。雖然於回顧財政期間營商環境仍然充 滿挑戰,本集團維持穩健的拓張步伐。於二零 二三年十二月三十一日,本集團僱員數目合共 1,322名(不計董事,包括863名全職及459名兼 職僱員),於二零二三年三月三十一日的本集團 僱員數目合共1.121名(不計董事,包括813名全 職及308名兼職僱員)。為了挽留才藝兼備的勞 動力,以及給予本集團僱員獎勵以加強僱員凝 聚力及忠誠度,本集團參考勞工市場供應、勞 工成本趨勢及僱員個人表現,定期檢討並更新 僱員福利計劃及薪酬待遇。截至二零二三年十 二月三十一日止九個月的員工成本(不包括董事 酬金)約為181,349,000港元,佔本集團於回顧財 政期間的收入約9.4%。而截至二零二三年三月 三十一日止年度的員工成本(不包括董事酬金)約 為203,338,000港元,佔本集團該年度的收入約 8.8%。當中,前線及倉庫員工的員工成本(包括 基本薪金、佣金及其他福利)佔截至二零二三年 十二月三十一日止九個月及截至二零二三年三 月三十一日止年度各期內的收入分別約7.2%及 6.9% °

產品

於回顧財政期間,本集團繼續奉行其環球採購 政策及使命,從全世界採購廣泛種類的產品, 以迎合及滿足市場趨勢及需求。為了更迎合本 地社群及國際旅客的需要,本集團進一步強化 穀物食品、麵食、罐頭食品、牛奶、冰鮮及急 凍食物等基本食品、生活必需品和基本雜貨產 品的供應。此外,本集團在零售店持續加強自 家品牌銷售,包括果仁及乾果、有機穀物、濕 紙巾、罐頭食品、餅乾零食及其他產品,為消 費者提供更多元化的選擇。

For the nine months ended 31 December 2023, the Group offers a total of 3,724 stock keeping units ("**SKUs**") of products (for the year ended 31 March 2023: 3,770 SKUs) from suppliers principally from overseas markets, and brand owners or importers in Hong Kong, with product mainly originating from, among others, Japan, Korea, the United States, Europe, Australia, Vietnam and Thailand, as well as other Asia-Pacific countries. The Group sourced the most popular and trendy food products from these countries or regions to offer a globally-diversified, multi-brand and multi-category selection for every customer.

As at 31 December 2023, the total amount of inventories of the Group amounted to approximately HK\$276,691,000 (31 March 2023: approximately HK\$244,219,000), representing an increase of approximately 13.3%. The increase in the Group's total amount of inventories was mainly due to an increase in the number of retail stores and preparation for increased demand during the peak sales season in the coming quarter.

During the Financial Period under Review, the Group continued to actively develop private label products that on one hand allow the Group to capture advantages of pricing and exercise higher level of guality control on its products and on the other hand further uplift its brand awareness and strengthen customers' loyalty. For the nine months ended 31 December 2023, sales derived from private label products was approximately HK\$305,520,000 which accounted for approximately 15.8% of the revenue of the Group for the nine months ended 31 December 2023, as compared to approximately HK\$346,352,000 for the year ended 31 March 2023, which accounted for approximately 15.0% of the revenue of the Group for the year ended 31 March 2023, representing an increase of approximately 0.8%. During the Financial Period under Review. the Group has launched an aggregate of 11 private labels, and the products for sale included nuts and dried fruits, organic grains, wet tissues, canned food, biscuits and snacks, etc.

截至二零二三年十二月三十一日止九個月,本 集團向主要自海外市場的供應商以及香港的品 牌擁有人或進口商進行採購,並銷售合共3,724 個庫存單位(「SKU」)的產品(截至二零二三年三 月三十一日止年度:3,770個SKU)。產品主要 來自其中包括日本、韓國、美國、歐洲、澳大 利亞、越南及泰國,以及其他亞太國家。本集 團從該等國家或地區採購最流行和最時尚的食 品,為每一位客戶提供全球多元化、多品牌和 多類別的選擇。

於二零二三年十二月三十一日,本集團總存貨 量約值276,691,000港元(二零二三年三月三十一 日:約244,219,000港元),增加約13.3%。本集 團總存貨量增加主要為零售店舖數量增加及為 下一個季度的銷售旺季的需求增加做準備。

於回顧財政期間,本集團繼續積極開發自家 品牌產品,此舉一方面可有助本集團捕捉價 格優勢,以及對產品可行使較高程度的品質 監控,另一方面可進一步提升本集團的品牌知 名度及加深顧客忠誠度。截至二零二三年十二 月三十一日止九個月,自家品牌產品的銷售額 約305,520,000港元,佔本集團截至二零二三 年十二月三十一日止九個月的收入約15.8%, 而截至二零二三年三月三十一日止年度約 346,352,000港元,佔本集團截至二零二三年三 月三十一日止年度的收入約15.0%,佔比增加 約0.8%。於回顧財政期間,本集團已累計推出 11個自家品牌,售賣產品包括果仁及乾果、有 機穀物、濕紙巾、罐頭食品、餅乾零食及其他 產品。

Membership Scheme

Given that the retail business of the Group is a consumer-driven business, the Group placed substantial efforts in developing and reinforcing its customer base. As such, the Group has established a membership scheme since April 2015 in order to promote consumer loyalty, stimulate sales and expand customer base. In order to further deepen customer stickiness and expand customers' coverage, the Group used big data analysis and reformulated its marketing strategy to launch a new three-tier membership scheme and a second generation mobile app in mid-June 2020. The new membership scheme helps to elevate brand positioning and market recognition, and the membership rewards have been fully optimised and enhanced, with more member benefits such as multiple items purchase stamp reward, special offers for selected products and access to latest market information. Through diversified marketing strategies, the Group aims to internally strengthen the membership core from within and attract new customers through external expansion, so as to effectively and purposefully foster the ties between members and the Group, thereby driving recurring business from members and promoting sustainable growth of the Group's business.

During the Financial Period under Review, the number of the Group's members increased from approximately 2,059,688 as at 31 March 2023 to approximately 2,123,365 as at 31 December 2023, representing an increase of approximately 3%.

The year 2023 marked the 10th anniversary of the Group's establishment. The Group conducted various marketing and promotional activities during the Financial Period under Review, including the "Super Best Price (超級至優價)" promotional campaign, which provided customers with a series of special offers for selected quality products to express our gratitude for our customers' support over the years and to enhance customer loyalty. Meanwhile, the Group continued to advertise through television, newspapers, social media platforms and other media, which successfully obtained repeat customers, attracted new customers and greatly promoted the discussions about the Group in the market.

會員計劃

鑒於本集團零售業務以顧客為導向,故投放了 巨大努力於發展及鞏固其顧客基礎。有見及 此,本集團自二零一五年四月起設立會員計 劃,藉以提升顧客忠誠度、刺激銷售及擴展顧 客基礎。為進一步深化顧客的黏貼度及擴大其 覆蓋面,本集團運用大數據分析及重新制定營 銷策略,並於二零二零年六月中旬推出全新的 三級制會員計劃及第二代手機應用程式。新計 劃有助提升本品牌定位及市場知名度,而會員 獎賞亦全面優化及提升,享有更多會員福利如 印花複購、精選產品優惠及接收最新市場資訊 等。本集團期望透過提供多元化的推廣策略, 向內鞏固會員核心及向外延展吸納新顧客,有 效及具目標性地促進會員與本集團之間的聯 繫,從而促使會員重複惠顧並帶動本集團業務 的可持續增長。

於回顧財政期間,本集團會員數目由二零二三 年三月三十一日約2,059,688名增加至二零二三 年十二月三十一日2,123,365名,增幅約3%。

二零二三年為本集團成立10週年的重要里程 碑,並在回顧財政期間進行不同市場推廣活 動,包括以「超級至優價」優惠活動,為顧客提 供一系列精選優質產品價格優惠,以感謝顧客 多年來的支持,提升顧客忠誠度。另一方面, 集團繼續透過電視、報紙、社交平台等媒介進 行廣告宣傳,成功促使顧客重複惠顧,並吸引 新顧客光臨,大大增加本集團於市場上之討論 熱度。

PROSPECTS

Looking ahead, the Board expects that the economy of Hong Kong and the globe will remain weak in the near future, and the tourism and consumption-related sectors will continue to be under pressure. In the face of uncertainties in Hong Kong's economic and retail business environment, the Group will be cautiously optimistic in expanding its business, closely monitor the development of various adverse factors affecting the Group's operations, and promptly implement necessary and appropriate business measures in response to market changes to minimise the impact on the Group's business operations. With the successive hosting of various world-class mega events in Hong Kong, it is expected to accelerate the pace of recovery of local business activities and drive the gradual recovery of market consumption sentiment. Therefore, the Group will continue to focus on the Hong Kong market as the core of its development, by optimizing its product structure to cover more basic foodstuffs and necessities and enhancing the development of its private label products to cater to the needs of the local market, thus consolidating and strengthening the Group's competitiveness in the retail market.

In order to enhance business operational profits, the Group will continue to review the regional distribution of its brand stores, adjust its store mix through appropriate expansion policies and appropriate leasing strategies, and look for suitable opportunities to expand the store network of its major retail brands "Best Mart 360° (優品360°)" and global gourmet store "FoodVille" in Hong Kong and Macau, with a target of achieving a net increase of 15 retail stores each year to satisfy the demand of different customer segments for quality food products with the pattern of dual-brand. The "Best Mart 360°" brand will focus on serving residential areas, and the Group will continue to optimize the geographical distribution of its stores, review the spatial layout and store expansion opportunities of its existing retail stores, enhance store sales efficiency and provide customers with a more comfortable shopping experience; while "FoodVille" targets large and mediumto-high-end shopping malls in Hong Kong as well as stores with larger area and high customer traffic and density so as to further differentiate the two brands.

展望

為保持營運效益,本集團持續審視旗下品牌店 舖的區域分佈,透過適度的擴張政策及適宜的 租店策略,調整店舖組合,並尋找適當機會拓 展旗下主要零售品牌[優品360°]以及環球美酒 食品店[FoodVille],分別在港、澳等地之店舖 網絡,目標每年淨增加15間零售店舖,以[雙品 牌]模式迎合不同顧客群對優質食品的需求。其 中[優品360°]零售品牌將主力於民生住宅區開 展業務,本集團繼續優化店舖區域分佈,審視 現有零售店舖之空間佈局和店面擴張機會,提 升店舖銷售效率,並為顧客提供更舒適的購物 體驗。至於[FoodVille]則以香港大型中高端購物 商場、面積較大、人口流量及密度高的店舖為 目標,以進一步加強兩個品牌的差異性。 The Group introduced China Merchants Hoi Tung Trading Company Limited ("**CMHT**") as a substantial shareholder during the Financial Period under Review, providing substantial strategic support to the Group and synergy maximisation for the sustainable growth of the Group. The Group will continue to uphold its business mission in offering products with the "Best Quality" and "Best Price" to its customers, adhere to the concept of global sourcing. Through leveraging the extensive cooperation network and resources of CMHT, the Group is committed to explore more upstream suppliers, and optimise its sales categories and maintain its price competitiveness. Furthermore, the Group will proactively source a diversified range of food products worldwide as well as step up the development of its private label products, aiming not only to satisfy market demand for daily necessities but also to provide customers with a broader range of choices.

On the other hand, the Group has entered into a sales and procurement framework agreement with CMHT and will sell products to and purchase products from CMHT and its subsidiaries in the financial year of 2024. The Board believes that through CMHT's robust network of food importers and distributors, the Group will strengthen its procurement and business-to-business (B2B) operations, and provide a more diversified range of imported products and private label products of the Group to customers and other retailers in Hong Kong, online stores and even merchants or enterprises in overseas markets, enriching the Group's streams of revenue and expanding its potential customer base.

In the face of the rapidly changing business environment, the Group is confident, by working closely with its employees, customers and other stakeholders, in creating better results for the Group and the best returns for its shareholders.

本集團於回顧財政期間引入招商局海通貿易有限公司(「**招商海通**」為大股東,為本集團提供重要戰略支持,並為本集團持續增長發揮最大協同效應。本集團將繼續秉持「優質」及「優價」的經營使命,堅持環球採購的理念。透過招商海通龐大的合作網絡和資源,本集團致力於探索更上游之供應商,致力優化銷售產品之種類和維持價格競爭優勢。同時,本集團積極於世界各地搜羅各式各樣食品,以及加大發展本集團的自家品牌產品,既滿足市場對日常生活必需品的需求,亦為顧客提供多元化選擇。

另一方面,本集團已與招商海通訂立銷售及採 購框架協議,並於二零二四財政年度向招商海 通及其附屬公司相互銷售、生產及採購產品。 董事會相信,透過招商海通強大的食品進品商 和分銷商網絡,有助本集團加強發展採購及企 業對企業(Business-to-Business,B2B)業務,為 本港客戶及其他零售商、網上商店,甚或其他 海外市場的商家或企業,提供更多元化進口產 品和本集團的自家品牌產品,更有效拓展本集 團收入來源,以及擴大潛在顧客群。

面對急速變化的營商環境,本集團有信心與員 工、顧客及其他持份者緊密合作,與全體員工 一起攜手為本集團創造更好的成績,為股東創 造最佳的回報。

FINANCIAL REVIEW

Revenue

During the nine months ended 31 December 2023, the revenue of the Group mainly represented the retail sales to walkin customers through its retail stores which accounted for approximately 97.9% of the revenue of the Group. For the nine months ended 31 December 2023, the revenue of the Group was approximately HK\$1,930,831,000, as compared to approximately HK\$2,305,907,000 for the year ended 31 March 2023.

Profit for the Period

Profit of the Group for the nine months ended 31 December 2023 amounted to approximately HK\$168,335,000, as compared to approximately HK\$200,997,000 for the year ended 31 March 2023. Net profit margin before interest and tax for the nine months ended 31 December 2023 was approximately 11.1%, while the net profit margin before interest and tax for the financial year ended 31 March 2023 was approximately 10.8%. The increase was attributable to our improvement in gross profit margin as well as enhancement in operational efficiency. Net profit margin was approximately 8.7% for both the nine months ended 31 December 2023 and the year ended 31 March 2023.

Gross Profit and Gross Profit Margin

For the nine months ended 31 December 2023, the gross profit of the Group was approximately HK\$694,258,000 (year ended 31 March 2023: approximately HK\$817,263,000). The gross profit margin was approximately 36.0% (year ended 31 March 2023: approximately 35.4%). The increase was attributable to timely adjustment of sales and marketing strategy and continuous optimisation of product mix.

Other Income and Other Gains, Net

For the nine months ended 31 December 2023, the Group recorded net other income and other gains of approximately HK\$4,676,000, while for the financial year ended 31 March 2023 it recorded net other income and other gains of approximately HK\$19,920,000. The decrease in net other income and other gains was mainly due to HK\$17,996,000 received from the Employment Support Scheme provided by the Government of Hong Kong during the preceding financial year.

財務回顧

收入

截至二零二三年十二月三十一日止九個月,本 集團的收入主要來自其零售店舖的街客所帶來 的零售銷售額,其佔本集團收入約97.9%。截 至二零二三年十二月三十一日止九個月,本集 團的收入約為1,930,831,000港元,而截至二零 二三年三月三十一日止年度約2,305,907,000港 元。

期間溢利

本集團截至二零二三年十二月三十一日止九個 月的溢利約為168,335,000港元,而截至二零二 三年三月三十一日止年度約200,997,000港元。 截至二零二三年十二月三十一日止九個月的除 息税前純利率約為11.1%,截至二零二三年三 月三十一日止財政年度的除息税前純利率則約 為10.8%。該增加乃由於毛利率提高及營運效 率提升。截至二零二三年十二月三十一日止九 個月及截至二零二三年三月三十一日止年度的 純利率均為約8.7%。

毛利及毛利率

截至二零二三年十二月三十一日止九個月,本 集團的毛利約為694,258,000港元(截至二零二三 年三月三十一日止年度:約817,263,000港元), 而毛利率則約為36.0%(截至二零二三年三月三 十一日止年度:約35.4%)。毛利率上升主要原 因為實時調整銷售及營銷策略以及持續優化產 品結構。

其他收入及其他收益淨額

截至二零二三年十二月三十一日止九個月,本 集團錄得其他收入及其他收益淨額約4,676,000 港元,而截至二零二三年三月三十一日止 財政年度則錄得其他收入淨額及其他收益約 19,920,000港元。其他收入及其他收益淨額減 少主要由於上一財政年度收到香港政府提供的 「保就業」計劃收入約17,996,000港元。

Selling and Distribution Expenses

For the nine months ended 31 December 2023, selling and distribution expenses of the Group amounted to approximately HK\$422,722,000, as compared to approximately HK\$515,266,000 for the financial year ended 31 March 2023. Selling and distribution expenses represented approximately 21.9% of total revenue for the nine months ended 31 December 2023 (financial year ended 31 March 2023: approximately 22.3%). The decrease was mainly the result of our dedication to stringent cost control measures as well as enhancement in operational efficiency.

Administrative and Other Expenses

For the nine months ended 31 December 2023, administrative and other expenses of the Group amounted to approximately HK\$62,568,000, as compared to approximately HK\$72,996,000 for the financial year ended 31 March 2023. Administrative and other expenses represented approximately 3.2% of total revenue for the nine months ended 31 December 2023 (financial year ended 31 March 2023: approximately 3.2%).

Finance Costs

Finance costs of the Group for the nine months ended 31 December 2023 amounted to approximately HK\$10,930,000, as compared to approximately HK\$8,708,000 for the financial year ended 31 March 2023. Effective interest rate for bank borrowings of the Group was approximately 3.13% for the nine months ended 31 December 2023, representing an increase of 0.25 percentage point from the financial year ended 31 March 2023 of approximately 2.88% as a result of increase in HIBOR for the Financial Period under Review.

銷售及分銷開支

截至二零二三年十二月三十一日止九個月,本 集團的銷售及分銷開支約為422,722,000港元, 而截至二零二三年三月三十一日止財政年度約 為515,266,000港元。截至二零二三年十二月三 十一日止九個月,銷售及分銷開支佔總收入約 21.9%(截至二零二三年三月三十一日止財政年 度:約22.3%)。該減少主要是由於我們致力於 嚴格的成本控制措施及營運效率提升。

行政及其他開支

截至二零二三年十二月三十一日止九個月,本 集團的行政及其他開支約為62,568,000港元, 而截至二零二三年三月三十一日止財政年度約 為72,996,000港元。截至二零二三年十二月三 十一日止九個月,行政及其他開支佔總收入約 3.2%(截至二零二三年三月三十一日止財政年 度:約3.2%)。

融資成本

本集團截至二零二三年十二月三十一日止九 個月的融資成本約為10,930,000港元,而截 至二零二三年三月三十一日止財政年度約為 8,708,000港元。截至二零二三年十二月三十 一日止九個月的本集團銀行借款實際利率約為 3.13%,較截至二零二三年三月三十一日止財 政年度的約2.88% 增長0.25 個百分點,乃由於 回顧財政期間香港銀行同業拆息攀升。

Financial Position, Liquidity and Financial Resources

As at 31 December 2023, the Group's total cash and bank balances (including cash and cash equivalents) were approximately HK\$130,712,000 (31 March 2023: approximately HK\$146,047,000), representing a decrease of approximately HK\$15,335,000 which was mainly used in financing activities. The overview of the Group's cash flow for the nine months ended 31 December 2023 and the financial year ended 31 March 2023 respectively are set out as follows:

As at 31 December 2023, the Group has total bank borrowings of approximately HK\$76,756,000, representing a decrease of approximately 3.3% as compared to approximately HK\$79,349,000 as at 31 March 2023. The total unutilised banking facility extended by commercial banks as at 31 December 2023 amounted to approximately HK\$240,630,000 (31 March 2023: approximately HK\$244,411,000). The carrying amounts of the Group's borrowings are denominated in Hong Kong dollars, secured and approximate to their fair value. 於二零二三年十二月三十一日,本集團的銀 行借款總額約為76,756,000港元,較於二零二 三年三月三十一日約79,349,000港元減少約 3.3%。本集團於二零二三年十二月三十一日 獲商業銀行提供的未使用銀行融資額合共約為 240,630,000港元(二零二三年三月三十一日:約 244,411,000港元)。本集團的借款為有抵押,其 賬面值以港元計值,並與其公平值相若。

As at 31 December 2023, the Group had a gross gearing ratio (i.e., gross debt divided by total equity) of approximately 16.8% (31 March 2023: approximately 16.6%). For this purpose, gross debt is defined as total interest-bearing borrowings excluding lease liabilities.

The Group financed its liquidity and working capital requirements through a combination of various sources, including but not limited to cash generated from the Group's operations, bank borrowings, and other external equity and debt financings as and when appropriate.

The Group continued to maintain a strong financial position with cash and bank balances of approximately HK\$130,712,000 and the Group's working capital amounted to approximately HK\$79,212,000 as at 31 December 2023. Based on the Group's steady cash inflow from operations, coupled with sufficient cash and bank balances and readily available banking facilities, the Group has adequate liquidity and financial resources to meet its working capital requirements in the next twelve months from the balance sheet date. During the Financial Period under Review, the majority of the Group's cash and bank balances were in Hong Kong dollar, Macau Pataca, Renminbi and were deposited in reputable financial institutions.

Capital Structure

The shares of the Company (the "**Shares**") were successfully listed on the main board of The Stock Exchange of Hong Kong Limited (the "**Stock Exchange**") on 11 January 2019 by way of share offer. Since then, there has been no change in the capital structure of the Company. The capital structure of the Company comprises issued share capital and reserves. As at 31 December 2023, the Company had 1,000,000,000 Shares in issue.

The capital structure of the Group as at 31 December 2023 in terms of debt profile is mainly bank borrowings and as at 31 December 2023, the Group has outstanding bank borrowings repayable within one year or contain a repayment on demand clause of approximately HK\$76,756,000 (31 March 2023: approximately HK\$79,349,000). Bank borrowings bear interest at floating interest rates. The effective interest rates of the Group's bank borrowings is HIBOR plus 1.3% (31 March 2023: HIBOR plus 1.3%) per annum for the nine months ended 31 December 2023.

Capital Commitments

Details of capital commitments are set out in note 26 to the financial statements.

資本架構

本公司股份(「股份」)已於二零一九年一月十一日 成功以股份發售方式在香港聯合交易所有限公 司(「聯交所」)主板上市。自此之後,本公司的 資本架構並無任何變動。本公司的資本架構由 已發行股本及儲備組成。於二零二三年十二月 三十一日,本公司有1,000,000,000股已發行股 份。

本集團於二零二三年十二月三十一日的資本架 構在債務方面主要為銀行借款,而於二零二三 年十二月三十一日,本集團有未償還銀行借款 約76,756,000港元(二零二三年三月三十一日: 約79,349,000港元)為須於一年內償還或具有 按要求即時償還條款。銀行借款按浮動利率計 息。截至二零二三年十二月三十一日止九個 月,本集團銀行借款的實際利率為香港銀行同 業拆息加年利率1.3%(二零二三年三月三十一 日:香港銀行同業拆息加年利率1.3%)。

Charge on Group Assets

As at 31 December 2023, the bank borrowings and other banking facilities of the Group are secured by:

- (i) a corporate guarantee provided by the Company and a subsidiary; and
- property, plant and equipment of office premises of the Group with carrying amount of approximately HK\$162,615,000 (31 March 2023: HK\$166,358,000).

Foreign Currency Risk

The Group mainly operates in Hong Kong and is exposed to foreign exchange risk from (i) the purchase of products from various overseas suppliers, which are primarily settled in foreign currencies, mainly USD, JPY, EUR, GBP, AUD, SGD and RMB; and (ii) the revenue generated from the operation in Macau and PRC. Nevertheless, taking into account the retail industry practice, the Group's current operation, the stable exchange rate of Macau Pataca historically and that the Group's cash balance in Renminbi is considered to be not material, the Directors do not consider that the Group is subject to material foreign exchange risk. The Group will take proactive measures and monitor closely its exposure to such currencies movement.

Treasury Policies

The Group adopts prudent treasury management policies and does not engage in any highly leveraged or speculative derivative products. Cash balances are mostly placed in Hong Kong dollars bank deposit with appropriate maturity period for meeting future funding requirements.

EMPLOYEES REMUNERATION POLICY

The remuneration policy of the Group is to reward the employees based on their performance, qualifications, experience and competence. Remuneration package typically comprises salary, contribution to pension schemes, discretionary annual bonus, performance-related bonus, sales target bonus and miscellaneous duties-related allowances. The Group conducts annual review on the performance of the employees and make reference to such performance review for assessing discretionary annual bonus, salary adjustments and promotion appraisals. The remuneration packages of the executive Directors and the senior management are determined with reference to those paid by comparable companies, the time commitment and performance of the executive Directors and the senior management, as well as the performance of the Group. A remuneration committee is set up to review the Group's emolument policy and structure of all remuneration of the Directors and senior management of the Group with reference to their experience, responsibilities, workload and time devoted to the Group and performance of the Group.

本集團主要於香港經營業務,並因(i)向不同海 外供應商採購產品,且有關採購主要以外幣(主 要為美元、日圓、歐元、英鎊、澳元、坡元及 人民幣)結算:及(ii)澳門及中國營運所得收入, 而面對外幣風險。儘管如此,考慮到零售業慣 例、本集團目前營運狀況、澳門元滙率一直穩 定及本集團以人民幣計值的現金結餘被視為 並不重大,董事認為本集團面對的外幣風險並 不重大。本集團將就有關貨幣變化所帶來的風 險,而採取主動措施以及作出嚴密監察。

庫務政策

本集團採取審慎的庫務管理政策,不投購任何 高槓桿或投機性衍生產品。現金結餘一般存於 設定適當到期日的港元銀行存款賬戶,以滿足 未來資金需要。

僱員薪酬政策

The Group has joined the Mandatory Provident Fund Scheme under the Mandatory Provident Fund Scheme Ordinance (Cap. 485 of the Laws of Hong Kong) (the "**MPF Scheme**") for all employees in Hong Kong. The contributions to the MPF Scheme are based on minimum statutory contribution requirement of the lower of 5% of eligible employees' relevant aggregate income and HK\$1,500 per month. The funds of the MPF Scheme are held separately from those of the Group.

The Group makes contributions to the social security fund for our eligible employees in Macau based on, inter alia, whether they are long term employees or fixed term employees. As stipulated by the labour regulations of PRC, the Group participates in various defined contribution retirement plans organised by municipal and provincial governments for its PRC employees. The Group is required to make contributions to the retirement plans at rates ranging from 14% to 15% of the eligible employees' salaries for the nine months ended 31 December 2023 (financial year ended 31 March 2023: 14% to 15%).

The Company's employer contribution for each of the abovementioned scheme/fund/plan vests fully with the employees when contributed into each respective scheme/fund/plan. Accordingly, for the nine months ended 31 December 2023 and the financial year ended 31 March 2023, there were no forfeited contributions (by employers on behalf of employees who leave the scheme prior to vesting fully in such contributions) that may be used by the employer to reduce the existing level of contributions.

The Company has adopted a share option scheme (the "**Share Option Scheme**") on 18 December 2018 for the purpose of providing incentives and rewards to the participants for their contributions to the Group. As at the date of this report, no option has been granted under the Share Option Scheme.

SIGNIFICANT INVESTMENTS

The Group did not have any significant investments during the nine months ended 31 December 2023.

MATERIAL ACQUISITIONS AND DISPOSALS

The Group did not have any material acquisitions and disposals during the nine months ended 31 December 2023.

FUTURE PLANS FOR MATERIAL INVESTMENTS AND CAPITAL ASSETS

The Group did not have any plans for material investments and capital assets as at 31 December 2023.

CONTINGENT LIABILITIES

The Group did not have any significant contingent liabilities as at 31 December 2023.

Entering into the CMHT Sales and Procurement Framework Agreement is beneficial for both procurement and business-tobusiness sales of the Group. This arrangement not only increases the Group's revenue streams but also ensures a stable supply chain. In addition, the arrangement aligns with the business development needs of the Group, achieving a synergic effect in fair and reasonable manner, and realising resources complementarity and a win-win situation for all parties.

Connected transaction and continuing connected transactions in relation to tenancy agreement

Reference is made to the announcement of the Company dated 12 April 2024, CIAO International (as tenant) and Mr. Lin Hiu San Burton (as landlord) entered into a tenancy agreement (the "**Stanley New Street Tenancy Agreement**") for a term of three years from 22 April 2024 to 21 April 2027 (both days inclusive) for the lease of the Stanley New Street Property (as defined in the announcement of the Company dated 12 April 2024). Pursuant to the Stanley New Street Tenancy Agreement, CIAO International shall pay Mr. Lin Hiu San Burton (i) a monthly base rent of HK\$110,000 ("**Fixed Base Rents**") and (ii) a turnover rent of 8% monthly gross receipts exceeding the Fixed Base Rents ("**Variable Turnover Rents**"), exclusive of government rates, management charges and other outgoings and inclusive of government rent. MANAGEMENT DISCUSSION AND ANALYSIS 管理層討論及分析

Mr. Lin Hiu San Burton is the son of Mr. Lin Tsz Fung, a substantial Shareholder and an executive Director. Accordingly, Mr. Lin Hiu San Burton is a connected person of the Company under the Listing Rules. Hence, the payment of the Fixed Base Rents under the Stanley New Street Tenancy Agreement will be regarded as a one-off connected transaction, whereas the payment of the Variable Turnover Rents under the Stanley New Street Tenancy Agreement will be regarded as continuing connected transactions under Rule 14A.31 of the Listing Rules.

As detailed in the announcement of the Company dated 12 April 2024, based on the then present value of the aggregated Fixed Base Rents for the entire terms of the Stanley New Street Tenancy Agreement as discounted using a discount rate which is equivalent to the Company's incremental borrowing rate, the Value of Right-of-Use Assets of the Stanley New Street Tenancy Agreement recognized by the Company in accordance with HKFRS 16 amounted to approximately HK\$3,587,737 (unaudited).

The Variable Turnover Rents under the Stanley New Street Tenancy Agreement will be recognized as expenses of the Group over the term of the Stanley New Street Tenancy Agreement. CORPORATE GOVERNANCE PRACTICES

The Company is committed to maintaining a high standard of corporate governance in accordance with the principles of good corporate governance, to formulate good corporate governance practice for improvement of accountability and transparency in operations, and to strengthen the internal control system from time to time so as to ensure we meet the expectations of the Shareholders.

During the Financial Period under Review, the Company has adopted and complied with all applicable code provisions in the Corporate Governance Code (the "**CG Code**") as set out in Appendix C1 to the Rules Governing the Listing of Securities on the Stock Exchange (the "**Listing Rules**").

CHAIRMAN AND CHIEF EXECUTIVE OFFICER

The roles of the Chairman and the Chief Executive Officer are separate and performed by different individuals to ensure a balance of power and authority, so that power is not concentrated in any one individual. Mr. Li Guanpeng, the chairman of the Company and an executive Director, is responsible for formulating the Group's strategic planning and the overall business development and overseeing overall management and operation of the Group, while Mr. Hui Chi Kwan, the chief executive officer of the Group and an executive Director, is responsible for overseeing day-today management of the Group and reporting to and executing decisions from the Board. There is a clear division of responsibilities between the chairman and the chief executive officer.

SECURITIES TRANSACTIONS BY DIRECTORS

The Company has adopted the Model Code for Securities Transactions by Directors of Listed Issuers (the "**Model Code**") as set out in Appendix C3 to the Listing Rules as its own code of conduct governing the securities transactions by the Directors. Following a specific enquiry made by the Company on the Directors, all Directors have confirmed that they had complied with the required standard set out in the Model Code during the Financial Period under Review.

董事進行證券交易

本公司已採納上市規則附錄C3所列載的上市 發行人董事進行證券交易的標準守則(「標準守 則」)作為其自身規管董事進行證券交易的行為守 則。經本公司向董事作出具體查詢後,全體董 事均已確認,彼等於回顧財政期間內已遵守標 準守則所規定的準則。

BOARD OF DIRECTORS

Responsibilities of the Board

The Board is primarily responsible for overseeing and supervising the overall management of the Group's business. The Board is collectively responsible for promoting the success of the Company by providing effective leadership and direction to its business, formulating group policies and business directions, monitoring internal controls and performances, and ensuring transparency and accountability of its operations. The powers and duties of the Board include convening general meetings and reporting the Board's work at the Shareholders' meetings, determining the business and investment plans, preparing the periodic financial budgets and reports, preparing the financial accounts, overseeing the financial reporting process, formulating proposals for profit distributions and exercising other powers, functions and duties as conferred by the memorandum and articles of association ("Articles of Association") of the Company. The Board has established Board committees and has delegated to these Board committees various responsibilities as set out in their respective terms of reference which are published on the respective websites of the Stock Exchange and the Company.

The Company has established relevant mechanisms to ensure independent views and input are available to the Board and conducted review of such mechanisms on an annual basis. Members of our audit committee are independent non-executive Directors who are able to bring independent and objective views to the Board.

The mechanism is disclosed below:

1. The Board ensures the appointment of at least three independent non-executive Directors and at least one-third of its members being independent non-executive Directors (or such higher threshold as may be required by the Listing Rules from time to time), with at least one independent non-executive Director possessing appropriate professional qualifications, or accounting or related financial management expertise. Further, independent non-executive Directors will be appointed to board committees as required under the Listing Rules and as far as practicable to ensure independent views are available.

董事會

董事會職責

董事會主要負責監督及督導本集團業務的整體 管理。董事會整體負責為本公司業務提供高效 的領導力及指引,制定集團政策及業務方向, 監察內部監控及表現,以及確保營運的透明,以推動本公司邁向成功。董事會的 權力及職務包括召開股東大會並於股東大會上 匯報董朝財務預算及報告、編製財務賬目、監督 以前務報告過程、制定利潤分配方案以及行使本 公司組織章程大綱及細則(「組織章程細則」)」賦予 的其他權力、職能及職務。董事會已成立多 職 權範圍的內容已於聯交所及本公司網 站刊載)賦予其不同職責。

本公司已制定相關機制,確保董事會可獲得獨 立觀點及見解,並每年對有關機制進行檢討。 審核委員會的成員為獨立非執行董事,彼等能 夠為董事會帶來獨立及客觀的觀點。

該機制披露如下:

 董事會應確保委任至少三名獨立非執行董 事,且其成員中至少有三分之一為獨立非 執行董事(或上市規則可能不時規定的更高 門檻),而至少一名獨立非執行董事須具有 合適專業資格或會計或相關財務管理專業 知識。本公司亦會按上市規則所規定及在 可行情況下委任獨立非執行董事加入董事 會委員會,以確保獲取獨立觀點。

- 2. The Nomination Committee strictly adheres to the Nomination Policy with regard to the nomination and appointment of independent non-executive Directors, and is mandated to assess annually the independence of independent nonexecutive Directors to ensure that they can continually exercise independent judgement.
- 3. No equity-based remuneration with performance-related elements will be granted to independent non-executive Directors as this may lead to bias in their decision-making and compromise their objectivity and independence.
- 4. The Board assesses and reviews the time contributed by each independent non-executive Director and their attendance to meetings of the Board and the board committees so as to ensure that every independent non-executive Director has devoted sufficient time to the Board to discharge his/her responsibilities as a Director of the Company.
- 5. The Directors, upon reasonable request, may seek external independent professional advice at the Company's expense, to assist the performance of their duties.
- 6. The chairman meets with the independent non-executive Directors regularly without the presence of the other Directors to discuss matters relating to the Group.

The Directors have full access to information of the Group and are entitled to seek independent professional advice in appropriate circumstances at the Company's expense.

The management of the Company is accountable to the Board and performs the following major duties: reporting to the Board, executing the resolutions of the Board, and completing all the tasks assigned by the Board.

Save as disclosed above, there was no financial, business, family or other material relationship among the Directors.

The independent non-executive Directors have extensive experience in different areas or professions and will give independent advice to the Board from time to time. By their active participation in Board meeting and by their service on various Board committees, the independent non-executive Directors contribute in important ways to the making of the Group. The terms of appointment of the independent non- executive Directors are set out on page 103 to 104 of this report.

During the Financial Period under Review, the Board had at all times met the requirements of Rules 3.10(1) and (2) and 3.10A of the Listing Rules relating to the appointment of at least three independent non-executive Directors representing at least one-third of the Board.

Each of the independent non-executive Directors has signed a confirmation of independence in writing pursuant to Rule 3.13 of the Listing Rules. Based on such confirmation, the Company considers that all the independent non-executive Directors are independent and have met the independence guidelines set out in Rule 3.13 of the Listing Rules during the Financial Period under Review.

The audit committee comprises three independent non-executive Directors, namely, Mr. Sze Irons, Ms. Choy So Yuk and Ms. Chan Yuen Sau Kelly. The chairman of the audit committee is Ms. Chan Yuen Sau Kelly.

Nomination Committee

The primary function of the nomination committee is to make recommendations to the Board on the appointment of members of the Board. The nomination committee comprises two independent non-executive Directors and one executive Director, namely, Mr. Gao Wei, Ms. Chan Yuen Sau Kelly and Mr. Li Guanpeng. The chairman of the nomination committee is Mr. Li Guanpeng.

The Company recognises and embraces the importance and benefit to achieve diversity on the Board to corporate governance and board effectiveness. The Company sees increasing diversity at the Board level as an essential element in supporting the attainment of its strategic objectives and its sustainable development. In deciding the composition of the Board, the Company will consider the Board diversity from various perspectives with reference to the Company's business model and specific needs, including but not limited to gender, age, race, language, cultural background, educational background, industry experience and professional experience.

All appointments of the Board are based on meritocracy, and candidates will be considered against appropriate criteria, having due regard for the benefits of a balance of skills, experience and diversity on the Board. The nomination committee has primary responsibility for identifying suitably gualified candidates to become members of the Board and shall give adequate consideration to this policy in selection of board candidates. To ensure changes to the Board composition can be managed without undue disruption, a formal, considered and transparent procedure is in place for the selection, appointment and re-appointment of directors. The nomination committee will consider candidates on merit and objective criteria, including his/her ability to dedicate sufficient time and attention to the Company's affairs, contribute to the diversity of the Board as set out in the Board Diversity Policy as well as effectively support the Board of their responsibilities, in order to determine whether a candidate is gualified before making recommendations to the Board.

The Board has achieved the measurable objectives (including gender diversity) as set out in the Board diversity policy. During the Financial Period under Review, our Board comprised twelve members, including three female executive Directors and two female independent non-executive Directors. Going forward, the Company will continue to maintain gender diversity on the Board through certain measures to be implemented by our Nomination Committee in accordance with our board diversity policy and nomination policy. Through the Board Diversity Policy of the Company and the annual assessment by Nomination Committee on the Board structure, the Company could develop a pipeline of potential successors to the Board to achieve gender diversity.

- The risk management and internal control systems adopted by the Company are designed to manage rather than to eliminate the risk of failure to achieve business objectives and can only provide reasonable and not absolute assurance against material misstatement or loss.
- The audit committee is responsible for reviewing the internal control systems and procedures for compliance with the requirements prescribed by the applicable laws, rules and regulations. The Board is responsible for the risk management and internal control systems of the Company, and through the audit committee, conducts an annual review on the effectiveness of the Group's risk management and internal control systems in its financial, operational and compliance controls and risk management functions. If defects are discovered during the review, the Board and the chief executive officer will review such defects and make corresponding plans to resolve them, taking into consideration the available resources.

The amount of any dividends to be declared will be subject to the decision of the Board and will depend on, among others, the Group's results of operations, available cashflows, financial condition, operating and capital requirements, the Articles of Association, the Companies Laws, applicable laws and regulations and any other factors that the Directors deem relevant. Dividends may only be paid out of the distributable profits of the Company as permitted under the applicable laws and shall not exceed the amount determined by the Board.

SHAREHOLDERS' RIGHTS

Procedures for Putting Forward Proposals at Shareholders' Meetings

There are no provisions allowing Shareholders to make proposals or make a motion at the annual general meetings of the Company ("**AGMs**") under the Articles of Association or the laws of the Cayman Islands. Shareholders who wish to make proposals or motions may, however, convene an extraordinary general meeting of the Company (the "**EGM**") in accordance with the "Procedures for Shareholders to Convene an EGM" set out below.

Procedures for Shareholders to Convene an EGM

In accordance with article 57 of the Articles of Association, an EGM shall be convened on the requisition of one or more Shareholders holding, at the date of deposit of the requisition, not less than one-tenth of the paid up capital of the Company carrying the right of voting at the general meetings of the Company. Such requisition shall be made in writing to the Board or the company secretary for the purpose of requiring an EGM to be called by the Board for the transaction of any business specified in such requisition. Such meeting should be held within two months after the deposit of such requisition.

Upon receipt, the Company will verify the requisitionists' particulars and shareholding and if the requisition is in order, the Company will convene the EGM in accordance with the Articles of Association. On the contrary, if the requisition has been verified as not in order, the requisitionists concerned will be advised of the outcome and accordingly, the Board will not convene the EGM and/or include the proposal(s) made or the resolution(s) proposed by the requisitionists at the EGM.

Communications with Shareholders

The Company has adopted a Shareholders' communication policy to ensure effective communication with Shareholders. Under the policy, the Company's information shall be communicated to the Shareholders through general meetings, including AGMs, the Company's corporate communications (including, but not limited to, the annual report, the interim report, notices of meeting, circulars and proxy forms), information and materials on the Company's website and the Stock Exchange's website.

Overview

匯報依據

本乃按照香港聯合交易所有限公司(「聯交所」)證 券上市規則(「上市規則」)附錄C2所載《環境、社 會及管治報告指引》(「環境、社會及管治報告指 引」)編製。在編製本報告的過程中,本集團嚴 格遵循「重要性」、「量化」、「平衡」及「一致性」原 則,披露與環境、社會及管治有關的措施及表 現。

A. ENVIRONMENTAL

The Group is committed to offering quality products in a manner that ensures a safe and healthy workplace for the Group's employees and minimises the Group's potential impact on the environment. The Group will operate in compliance with all relevant environmental legislation and it strives to use pollution prevention and environmental best practices throughout its operations.

The Group's environmental policy therefore is to:

- Consider environmental concerns and impacts in our decision making and activities;
- Minimise the production of waste and then reuse or recycle as much of it as possible;
- Minimise energy use within our operations and processes in order to conserve supplies and minimize the consumption of natural resources;
- Where possible, purchase products and services that do the least damage to the environment;
- Educate and inform the Group's employees about the environmental issues that may affect their work;
- Promote environmental awareness among the Group's employees and encourage them to work in an environmentally responsible manner; and
- Communicate our environmental commitment to customers and the public and encourage them to support the Group's environmental commitments.

The group is principally engaged in retail business in Hong Kong, Macau and Mainland China and its business operations do not directly generate industrial pollutants that are generally regarded as having a high environmental impact such as hazardous emissions, wastes or pollutants. The Group understands and respects its responsibility to the environment, and endeavours to achieve eco-friendly operations and conservation of resources in pursuit of sustainable development.

A. 環境

本集團致力在確保本集團僱員的工作場所 安全健康,以及盡量減少本集團對環境的 潛在影響下,提供優質產品。本集團將遵 守所有相關環境法例,並努力在其整個營 運過程中,跟從最佳的預防污染及環保常 規。

因此,本集團的環境政策是:

- 在集團決策及活動中顧及環境因素及 影響;
- 盡量減少產生廢物,並盡可能重用或
 回收廢物;
- 在營運過程及程序中盡量減少使用能 源,以節省供應及最大限度地減低天 然資源消耗;
- 盡可能選購對環境損害最小的產品及 服務;
- 教育並告知本集團僱員有哪些環境問題可能影響其工作;
- 提高本集團僱員的環保意識,鼓勵僱 員在工作中實踐環保;及
- 向顧客及公眾傳達本集團的環保承諾,並鼓勵彼等支持本集團履行其環保承諾。

本集團主要在香港、澳門及中國內地從事 零售業務,其業務營運不會直接產生一般 被視為對環境造成高危影響的工業污染 物,例如有害排放物、廢料或污染物。本 集團明白並尊重其對環境的責任,致力實 現對環境友善的經營模式及資源節約,力 求達致可持續發展。
During the Financial Period under Review, the Group had not been involved in any material non-compliance issues in respect of any applicable laws and regulations on environmental protection.

A.1 Emissions

Air emission

The Group does not directly produce air emissions. The major source of air emissions is the transportation of products in Hong Kong, Macau and Mainland China. The Group has engaged several external logistic service companies including a Hong Kong logistic company, and Macau and Mainland China shipping and logistic service companies to collect, distribute and/or deliver goods from the products' arrival shipping terminal, airport and warehouse of the forwarders appointed by the Group's overseas suppliers, to the warehouses and retail stores of the Group. As the logistic services are operated by independent third parties that are not owned by or controlled by the Group, therefore the retrieval of relevant data of such emissions in Hong Kong, Macau and Mainland China are not feasible. Instead, as a major client of our logistic partners, we engage in close collaboration with them to minimize the environmental impact of the transportation fleet through the following methods:

- streamline the logistic routing and maximise the loading capacity of each transportation vehicle;
- arrange delivery services to the retail stores in during non-peak hours;
- encourage our logistics partners to upgrade their fleet to meet the latest emission standards. For example, our Hong Kong logistic partner had upgraded all of its heavy-duty vehicles to the Euro VI emission standard in 2019; and
- ensure our logistics partners are operating in accordance with all prevailing environmental laws and regulations.

於回顧財政期間內,本集團並無牽涉於任 何有關環保的任何適用法律及法規的重大 違規情況。

A.1 排放物

廢氣排放

本集團不直接產生廢氣。廢氣排放主 要來自香港、澳門及中國內地的產品 運輸過程。本集團委託多間外部物流 服務公司,包括一間香港物流公司、 及澳門及中國內地航運公司及物流服 務公司,負責從產品到貨的航運碼 頭、機場及本集團海外供應商指定的 貨運代理倉庫,收集、配送及/或運 送貨品至本集團的倉庫及零售店舖。 由於物流服務由並非本集團擁有或 控制的獨立第三方處理,故此無法取 得有關方面的香港、澳門及中國內地 排放數據。取而代之,作為上述物流 夥伴的主要客戶,本集團與其共同努 力,透過以下方法減少運輸車隊所造 成的環境影響:

- 精簡物流路線,最大限度地提高 每輛運輸車輛的裝載能力;
- 將送貨至零售店舖的服務編排於 非繁忙時間進行;
- 鼓勵物流夥伴升級其車隊,以符 合最新排放標準。舉例而言,集 團的香港物流夥伴已於二零一九 年全面升級其重型車輛,以符合 歐盟六期排放標準;及
- 確保物流夥伴依照所有現行環境 法律及法規經營其業務。

Greenhouse gases (GHG) emission

The only source of GHG emission is Scope 2 GHG emissions, which were contributed by electricity consumption (for the exact usage, please refer to **A.2 Use of resources**). Scope 1 GHG emissions typically include fuel usage from company-owned/controlled vehicles or equipment, which is not applicable to our operations. The data below includes the head office and warehouse in Hong Kong and retail stores in Hong Kong, Macau and Mainland China. The Group aims to reduce its GHG emissions in the coming year to levels below those of this year.

The GHG emission data is set out in the table below:

Non-recyclable Waste

Our waste is categorized as non-hazardous municipal waste. Depending on the local regulations and capabilities, we separate the non-recyclable from the recyclable waste. Waste volume is managed and tracked internally. We have a number of programs to raise staff's awareness and introduce best practices on waste management, including that of the office, warehouse and frontline.

The details of the non-recyclable wastes are listed as follows:

We explore various methods for waste treatment, considering community needs and viable solutions tailored to different waste types. Moving forward, we will enhance our waste data collection processes, assess and transparently disclose relevant information, and gradually set appropriate targets on waste reduction.

A.2 Use of resources

The Group is committed to complying with all laws and regulations on managing the use of resources and strives to become a resource-saving and environmentally responsible enterprise through the implementation of various policies and procedures which aims to achieve higher efficiency in resource use and also reduction in the overall use of resources throughout the Group's operations, where possible.

Use of energy

The major source of energy used by the Group is electricity, which is mainly used in the general lighting, air-conditioning and powering of computers, office equipment and other equipment in the retail stores, warehouse and office of the Group. The total energy consumption of the nine months ended 31 December 2023 was 7,317,185 kWh (financial year ended 31 March 2023: 7,115,778 kWh) which is 2.8% higher than that of the last reporting year and was due to expansion of the Group's operations. The Group has also strived to enhance efficiency through various ways such as cleaning the air conditioners, and will continue to explore ways to improve energy efficiency in its daily operation. 基於社區需求及針對不同廢物類型量 身定製的可行解決方案,我們探索各 種廢物處理方法。展望未來,我們將 優化廢物數據收集流程,評估並透明 地披露相關資料,並逐步制定適當的 減廢目標。

A.2 資源使用

本集團致力遵守有關管理資源使用的 所有法律及法規,並通過落實不同政 策及程序,以盡可能提高資源使用效 率及減少本集團整體營運中使用的資 源為目標,從而成為一間節約資源、 對環境負責的企業。

能源使用

本集團使用的主要能源為電力,其主 要用於本集團辦公室、零售店舖及倉 庫的一般照明、空調以及電腦、辦公 室設備及其他設備的供電。截至二零 二三年十二月三十一日止九個月的 能源消耗總量為7,317,185千瓦時(截 至二零二三年三月三十一日止財政年度: 7,115,778千瓦時),較上個報告年度 高2.8%,此乃由於本集團營運擴張所 致。本集團亦致力透過不同方法提高 效益,例如清潔空調系統;並將繼續 探討於日常營運中改善能源效益的方 法。

- Note 1: The increase in consumption of electricity and the generation of carbon dioxide emissions for the Financial Period under Review as compared to that of last reporting year was mainly due to the increase in the number of retail stores of the Group in the Financial Period under Review. In addition, the Group increased the product categories to selling frozen foods, therefore more refrigerators are needed for storage which increased the energy consumption.
- Note 2: The revenues of the Financial Period under Review and the last reporting year are approximately HKD1,930,831,000 and HKD2,305,907,000, respectively.

Water consumption

Water usage in the Group's business operation is minimal as the Group's operation does not consume water. Water is mainly used by employees for drinking and personal hygiene purpose in the office, retail stores and warehouses of the Group and the usage was relatively insignificant. There was no issue in sourcing water that is fit for purpose.

A.3 Impacts on natural resources and management actions

The Group believes that corporate development should not come at the expense of the environment. The Group's material impact on the environment and natural resources are in the form of electricity and material consumption, as well as waste generation. Other environmental impact such as noise pollution or impact to biodiversity is not material given the nature of our business activities. The following summarises our efforts in reducing our negative environmental impacts.

The Group has adopted the following measures for energy and resources saving during the Financial Period under Review:

- switch-off lighting, air-conditioning and computer monitors when leaving the office areas and workplaces to reduce electricity consumption;
- automatically switch off non-essential lighting in office areas and workspaces after office hours;
- install block-out curtains to keep out sunlight and heat during daytime and maintain a relatively lower room temperature;
- switch off all non-essential air-conditioning in retail stores when the retail stores are closed after operation hours;
- maintain air-conditioning temperature to avoid power wastage (in office generally at 24–26°C, in retail stores generally at around 24–25°C in autumn and winter seasons and at not lower than 19°C in summer season); and
- login with staff card when photocopying to encourage paper saving;

A.3 對天然資源的影響及管理行動

本集團相信,企業發展不應以犧牲環 境為代價。本集團對環境及天然資源 所帶來的重大影響體現在電力及材料 消耗以及廢物產生兩方面。鑑於集團 的業務活動的性質,噪音污染或生物 多樣性影響等其他環境影響並不顯 著。下文總結了集團在減少不利及負 面的環境影響方面所作的努力。

本集團已於本回顧財政期間採取以下 節約能源及資源措施:

- 離開辦公區域及工作場所時,關 掉照明、空調及電腦屏幕,以減 低電力消耗;
- 辦公時間後自動關上於辦公室範 圍及工作空間的非必要照明;
- 安裝遮擋窗簾,在白天遮擋陽光
 及熱力,保持相對較低的室溫;
- 零售店舖在營業時間後關門時, 關掉店內所有非必要的空調;
- 保持空調溫度以避免浪費電力(辦公室一般為攝氏24至26度,零售店舖於秋冬季節一般為攝氏24至25度左右、於夏季為不低於攝氏19度);及
- 複印文件時必須使用職員證登入,以鼓勵節約用紙;

For resources used in daily operation, the following measures have been adopted:

- paperless office is encouraged by using electronic POS, WMS and M18 and electronic note-taking. If that is not possible, paper used by the Group is sourced from suppliers which are certified to be in compliance with Forest Stewardship Council (FSC) Chain-of-Custody certification and promote double sided printing, where possible;
- collection boxes for one-sided paper are placed next to printers in office to encourage paper recycling;
- very thin thermal paper rolls used by cash registers of retail stores have been tested to be free from bisphenol A;
- tissue paper and towel paper used by the Group have been tested to be in compliance with GB standard 20810–2006 Bathroom Tissue (including bathroom tissue base paper);
- electronic salary statements have been adopted to exempt paper usage;
- time attendance system and leave application system of employees have been computerized to minimize paper usage;
- ink boxes and toner cartridges used by the Group are sourced from manufacturers which are certified to be in compliance with ISO 9001:2016;
- choosing vendors using water-based latex ink instead of traditional latex ink to print advertising materials;
- garbage classification has been implemented in the office and warehouse of the Group for the ease of waste recycling;

對於日常營運中使用的資源,已採取 以下措施:

- 通過使用電子POS銷售系統、倉庫管理系統、M18企業資源規劃 系統及電子筆記裝置,鼓勵無紙 化的辦公室運作。在必須使用紙 張的情況下,本集團使用的紙張 均採購自符合森林管理委員會 (FSC)產銷監管鏈認證的供應商, 除此之外亦盡量鼓勵雙面列印;
- 在辦公室的打印機旁邊放置單面 紙的收集箱,以鼓勵紙張回收;
- 零售店舖的收銀機使用的特薄熱 敏紙卷經測試為不含雙酚A;

- all circulars and notices to retail stores are sent in electronic format to exempt paper usage;
- the polybags used by the Group are made of oxobiodegradable plastic which have satisfied relevant product environmental criteria set by Green Council and have been certified and licensed under the Hong Kong Green Label Scheme;
- reduced the use of the undegradable plastic wrap by increasing the use of reusable ropes and nylon ties in replacement of the one-time packaging plastic wrap for bounding products and the use of pallet cage carts to secure products on the transition from warehouses to retail stores;
- reduced the use of disposable cutlery by increasing the use of washable cutlery and lunch boxes;
- reduced the use of single-use batteries by increasing the use of rechargeable electronic products; and
- encouraged effective internal lighting by daylighting if possible.

In addition, the Group promotes the quantitative reduction of wastage at source by:

- reducing food wastage by offering slow-moving and expiring products at clearance prices to customers;
- no festival gift wrapping in order to reduce the usage of wrapping paper; and
- strictly complying with the Product Eco-responsibility (Amendment) Ordinance 2014 and the plastic shopping bag levy in Hong Kong.

Looking ahead, aiming at growing the business without depleting the environment and natural resources, the Group will continue to review its operation and explore other possibilities to further diminish pollutants and waste, optimize energy consumption and improve energy efficiency.

展望將來,在尋求業務成長,但不竭 盡環境及天然資源的宗旨下,本集團 將繼續檢討其營運,不斷探索其他機 遇,以進一步減少污染及廢物、優化 能源消耗及改善能源效益。

A.4 Climate Change

Climate change is an issue that the Group is fully aware of and understands as being one that will inevitably affect all of the Group's business operations and its stakeholders. The Board is responsible for ensuring the Group is prepared to tackle both physical and transition climate risks, and the Group's vulnerability to these risks. The Group identifies the physical and transitional risks and related financial and operational impact. It has implemented a number of mitigation plans and measures in order to protect its assets against extreme weather and reduce the carbon footprint from its managed properties. Climate-related risks have been classified by the Group into physical and transition risks, which are as follows:

Physical Risk

Physical climate risks come in the form of extreme weather conditions in greater frequency and intensity, as well as rise in sea level. The operations of the Group are located in Hong Kong and Macau. Extreme weather conditions such as typhoons and heavy rains are expected to become more frequent with climate change. The Group has prepared contingency plans to cope with these threats. For example, the Group maintains comprehensive insurance to cover damage to the Group's assets arising from flooding and typhoons.

Transition Risk

Transition climate risks are the evolution of the regulatory, technological and market landscape due to climate change action. It is believed that environmental-related policies and regulations, such as waste reduction requirements, will be tightened in the future. The Group will promote and encourage employees to reduce waste in their daily business activities, and will also provide relevant information and resources to enhance responsiveness. The Group will monitor updates on climate change-related regulations on a periodic basis.

A.4 氣候變化

實體風險

實體氣候風險肇因於極端天氣情況發 生的頻率及強度加劇,以及海平面上 升。本集團的營運業務位於香港及澳 門。隨著氣候變化,預計颱風及暴雨 等極端天氣情況將變得更加頻繁。本 集團已擬備應變計劃,以應對此等威 脅。舉例而言,本集團投購承保範圍 較全面的保險,以保障本集團資產因 洪水及颱風而造成的損失。

過渡風險

過渡氣候風險為基於氣候變化行動而 帶來的監管、技術及市場格局的變革 所造成的風險。未來,相信將會收緊 各項環保相關政策及法規,如減廢要 求等。本集團將推動及鼓勵僱員於日 常業務活動中減少浪費,並將提供相 關資料及資源,以提高應對能力。本 集團將定期監察氣候變化相關法規的 最新動態。

B. SOCIAL

As a responsible business and employer, the Group seeks to maximize positive impacts on its staff and community, as well as its business partners. The Group is committed to consistently looking for ways to meet corporate social responsibilities.

B.1 Employment and labour practices

Human resources is a critical foundation of the Group's operations and is fundamental to achieving the continued development of the Group. The Group treats its employees as one of its valuable assets. The Group generally recruits employees from the open market. The recruitment process is conducted thoroughly and monitored by the human resources department to ensure fairness, factors such as their experience in the retail industry would be reviewed. The Group is an equal opportunities employer and is committed to providing equal opportunities in recruitment and promotion, regardless of age, gender, race, color, religion, nationality, marital status or disability.

The Group conducts performance reviews for its employees periodically and would assess salary adjustments and promotion appraisals based on their performance. The Group offers discretionary annual bonus to all of the employees and, for the front-line staff, performance-related bonus, sales target bonus and miscellaneous duties-related allowances. The Group also offers various benefit plans to the employees, including staff shopping discounts, top-up leave entitlement and medical insurance. The Group would regularly review its remuneration policy to ensure packages offered by the Group are appealing to employees, which could persistently increase the loyalty and incentives of employees.

B. 社會

作為負責任的企業及僱主,本集團尋求為 其員工、社區及業務夥伴發揮最大化積極 影響。本集團致力不斷尋找方法,以履行 企業社會責任。

B.1 僱傭及勞工常規

人力資源是本集團營運的重要基礎, 也是本集團持續發展的根本因素。本 集團視其僱員為其寶貴資產之一。本 集團一般於公開市場招聘僱員。招聘 過程由人力資源部全面進行及監督, 以確保公平,並將檢視多項因素,例 如僱員於零售業的經驗等。本集團為 平等機會僱主,並致力在招聘及晉升 上,不論年齡、性別、種族、膚色、 宗教、國籍、婚姻狀況或殘疾,均提 供平等機會。

本集團定期對其僱員進行表現評估, 並會根據彼等的表現評估薪酬調整及 晉升考核。本集團向僱員發放酌情年 終花紅,另外亦向前線員工發放表情 獎金、銷售獎金及其他職務相關非 點。本集團亦向僱員提供多項福利, 包括員工購物折扣、額外假期及醫療 保險。本集團將定期檢討其薪酬政 策,以確保本集團提供的待遇對僱員 具有吸引力,從而持續提升僱員的忠 誠度及動力。

B.2 Employee health and safety

The Group strives to promote safety awareness, improve occupational environment and reduce occupational risks and commits to providing a healthy and safe working environment for its employees. The Group complies with the Occupational Safety and Health Ordinance in all relevant requirements. The business operations do not involve high-risk or safety-sensitive types of work. To ensure that the business is operated in a safe environment and staff has the necessary knowledge on work safety, the Group has adopted and implemented work place safety guidelines for all our staff in the retail stores which set out the Group's work safety policies and promote safety in work sites. The Group has also conducted training sessions for employees to increase their knowledge of correct practices for health and safety in work place.

Accidents that occur in the work place will be reported to and handled by the human resources department to ensure injuries that occurred in the work place will be properly recorded, and that insurance claims and treatments are effectively pursued to protect the employees and the Group. The Group has not reported any fatalities in relation to its work during the reporting period of the past three years. During the Financial Period under Review, the number of working days lost due to work-related injury was 245 days.

B.2 僱員健康與安全

於工作場所發生的意外事故將由人力 資源部負責收報及處理,以確保於工 作場所內發生的受傷事故均得到妥善 記錄,以及有關的保險理賠及治療均 能有效進行,為僱員及本集團提供保 障。本集團於過去三年的報告期內未 曾錄得任何與工作有關的死亡事故。 於回顧財政期間,因工傷損失的工作 日數為245天。 Apart from raising the health and safety standards in the Group's working environment, the management of the Group also swiftly responded to emergencies to safeguard the health and safety of employees at the work place.

During the Financial Period under Review, the Group had no non-compliance case regarding violation of relevant laws and regulations on occupational health and safety.

B.3 Development and training

Enabling the Group's employees achieve to their full potential will ultimately benefit the Group in its future development plans. The Group provides various types of training to enhance the competency of our staff. For the newly recruited employees, orientation trainings for understanding the company background, code of conduct, workplace health and safety, customer service and grooming standard were provided. The Group also provided operations technical trainings, supervisory skills trainings and anti-corruption trainings to all staff to educate the them on the duties to comply with statutory obligations. A series of supervisory skills training were conducted to store-in-charge to enhance their competency. 除了提升本集團工作環境的健康及安 全標準外,本集團管理層亦迅速應對 突發事件,以保障僱員於工作場所的 工作健康及安全。

The Group also supports employees' personal development through attending external trainings. The Group would provide sponsorship for the employees' personal development. Various types of relevant seminars or training courses are recommended to employees via email and they can choose to register either in person or through the Company.

B.4 Labour standards

The Group ensures equal opportunities for all employees and job applicants, particularly in recruitment, internal transfer, and promotion. Discrimination based on gender, age, religious belief, race, or any physical disability is strictly prohibited. Applicants' identities would be verified during the recruitment process. The Group strictly prohibits the use of child labour and forced or compulsory labour at all of its business units, and highly values and strictly abides by all applicable labour laws and regulations on employment in Hong Kong. If child or forced labour is discovered, the Group will terminate the employment contract immediately and assist the child to resume education and contact social workers to follow up. During the Financial Period under Review, the Group did not identify any non-compliance cases regarding violation of relevant child labour and forced labour laws.

B.5 Supply Chain Management

To maintain a quality, trendy and broadly appealing product mix in the retail stores with competitive prices, the selection of suppliers is crucial in decision-making. The Group generally maintains stable collaborative business relationships with the existing suppliers to regularly review new brands and products available in the markets around the world to keep abreast of information on new products available in the international market. During the Financial Period under Review, the Group stopped attending international trade shows and business delegations due to the epidemic. 本集團亦支持僱員為自身個人發展參 加外部培訓。本集團會為僱員的個人 發展提供資助。各類相關研討會或培 訓課程乃透過電子郵件推薦予僱員, 彼等可選擇親自或透過本公司報名。

為了維持零售店舖以具競爭力的價格 保持優質、流行及廣具吸引力的產品 組合,在決策過程中選擇供應商是至 關重要的。本集團與現有供應商普遍 維持穩定的業務合作關係,定期檢 視世界各國市場推出的新品牌及新 產品,以掌握國際市場的最新產品資 訊。於回顧財政期間,本集團因疫情 關係而暫停參加國際貿易展覽會及商 貿考察團。 The Group has maintained a list of suppliers and typically works with trustworthy suppliers possessing a reliable corporate background, trading history and reputation. All of the potential suppliers would be screened by standardised criteria for evaluating the qualifications. Documents such as manufacturing and analysis certificates, health certificates, certificates of origin and/ or attestations, and certificates in relation to food or products safety and/or quality manufacturing process of the products, may need to be provided by the potential supplier for the screening process.

During the Financial Period under Review, the Group has engaged a total of 429 suppliers, of which 100% have undergone the supplier screening process. Choose the Right Partners Referencing to International Standards

We encourage our suppliers to adopt responsible and sustainable practices with respect to a range of environmental and social issues when engaging with new suppliers. This process gives preference to suppliers which integrate considerations for environmental conservation, protection of endangered species, protection of labour rights and welfare, equal opportunities, non-participation in animal testing, and responsible sourcing into their own operations. When selecting logistics partners for the distribution of goods from our central warehouse to our stores, environmental protection is one of our selection criteria.

During the Financial Period under Review, the Group implemented an ESG supplier assessment policy (the "**ESG Supplier Assessment**") that makes it mandatory to assess its major suppliers regarding its ESG practices during the tender process. In this way, the Group endeavours to achieve a balance of sourcing from suppliers that offer competitive pricing and quality goods and to excluding suppliers that have not complied with the Group's requirements on environmental protection, employee health and rights, information security requirements and ethics. The ESG Supplier Assessment also gives preference to those that offer products that have positive environmental and/or social characteristics, such as products with recycled packaging or manufactured by small local businesses.

The Group would review approved suppliers periodically in terms of product quality, services standard and reputation to ensure product quality and services are maintained at a satisfactory level. The Group would assess the appropriateness of packaging of products provided by individual approved suppliers on their arrival, the consistency of quality between sample products and products ordered and delivered, any quality issue(s) on products provided by individual approved suppliers and its/their nature and materiality of such issue(s) and the overall satisfactory level on the quality of products provided by individual approved suppliers based on customers' feedback. Recommendations would be provided to suppliers which are unable to meet the guiding standards for periodical review, and the suppliers will be removed from the list of suppliers until appropriate remedial measures are taken to the Group's satisfaction.

B.6 Product responsibility

The Group puts great efforts into maintaining product quality and safety, which includes establishing procedures to ensure that the products procured are in full compliance with the food safety, food labelling and consumer goods safety-related laws and regulations in Hong Kong. The Group has set up a guality control team and they are responsible for monitoring and assessing the compliance of products to be procured with the relevant Hong Kong laws and regulations before placing purchase orders. Relevant documents or certificates that could warrant the accuracy and completeness of products should be provided by the suppliers. The Group's logistic team performs designated quality check procedures and checks the inclusion of printed label information on product packages or the status of affixation of applicable product labels on such products at the warehouse. The products are checked regularly in store by the front-line sales to maintain the safety and quality of the in-store inventory and to ensure relevant product labels are duly affixed.

本集團會定期審查其認可供應商的產 品品質、服務標準及信譽,以確保產 品品質及服務維持在滿意水平。本集 團會於產品到貨時評估個別認可供應 商所提供的產品的包裝是否合適、產 品樣品與正式訂購及交付的產品之間 在品質上是否一致,以及個別認可供 應商所提供的產品有否任何品質問題 及該/該等問題的性質及嚴重程度, 並基於客戶的反饋,評估個別認可供 應商所提供的產品的品質的整體滿意 度。倘有供應商未能達到就定期審查 所訂的指引標準,本集團將向該供應 商提出建議,並會將供應商從供應商 名單中除名,直至其採取適當的補救 措施令本集團滿意。

B.6 產品責任

本集團在維持產品品質及安全上作出 了極大努力,包括建立多項程序以確 保所採購的產品完全符合香港的食品 安全、食品標籤及消費品安全的相關 法律及法規。本集團已成立品質控制 **團隊,負責在下達採購訂單前監控及** 評估擬採購的產品是否符合相關香港 法律及法規。供應商應提供文件或證 明,以保證相關產品的準確性及完整 性。本集團的物流團隊會於倉庫內執 行指定的品質檢查程序,檢查產品包 裝上是否已印有標籤資料或是否已貼 上適用的產品標籤。前線銷售人員定 期於店舖內檢查產品,以維持店內存 貨的安全及品質,並確保產品已妥為 貼上相關標籤。

During the Financial Period under Review, an independent food testing laboratory had been engaged to conduct laboratory tests that are necessary for private label products to safeguard and ensure the compliance of relevant laws and regulations for such original equipment manufacturer products, such as product labels requirements and to uplift food safety standard.

The Group is committed to complying with relevant laws and regulations on customer data protection and privacy. The personal information of customers collected by the Group through the membership scheme are kept in strict confidence and is only used for specific intended purposes. The Group has established internal guidelines to ensure compliance with the Personal Data (Privacy) Ordinance of Hong Kong.

The Group implements a complaint handling procedure. When the Group receives customer complaints, the information of the customers and corresponding stores is recorded. The record is kept for three years in the customer service department. Each complaint is investigated and recommendations of solutions, responses and/or decisions is provided post-investigation. Exchange or refund is offered if the complaint is valid and is about unsatisfactory product quality. During the Financial Period under Review, the Group has received 208 complaints about products and services and no products were required to be recalled. In the event of any recall, whether announced by the government, notified by media, requested by suppliers or identified during product monitoring process, we will arrange the goods to be removed from shelves and notify the staff on the suspension of sales of these products. All relevant departments will be informed for following up the incident. Media and PR agencies will be notified after our investigation when appropriate. The Group will also share the information with the government departments upon request.

本集團訂有一套投訴處理程序。本集 團於收到客戶投訴時,會記錄客戶及 相應店舖的資料。有關紀錄於客戶服 務部保存三年。每項投訴均會展開調 查,並於調查後提供建議,包括解決 方案、回應及/或決定。倘發現投訴 屬實,而有關投訴涉及產品品質,本 集團將會提供換貨或退款。於回顧財 政期間,本集團共收到208宗關於產 品及服務的投訴,並無產品需要被召 回。倘基於政府宣佈、媒體報導、供 應商要求或在產品檢測過程中發現而 須召回任何產品,本集團會安排有關 貨品下架,通知員工暫停出售有關貨 品, 並通知各相關部門對事件進行跟 進。本集團於調查結束後,將適時通 知媒體及公關機構。本集團亦會應要 求向政府部門分享有關資料。

The Group is committed to complying with relevant laws and regulations such as Colouring Matter in Food Regulations (Cap.132H), Sweeteners in Food Regulations (Cap.132U), Food Adulteration (Metallic Contamination) Regulations (Cap.132V), Consumer Goods Safety Ordinance (Cap. 456), Trade Descriptions Ordinance (Cap. 362), Food Safety Ordinance (Cap. 612), etc. that constitute a significant impact on the Group in relation to health and safety, labelling and privacy matters. The Group's OA department would perform the random checking of the goods including packaging and food labels regularly, the goods department would need to reprint the correct label and the packaging department would re-packed the goods if the label is wrong or the packaging quality is not up to standard. The Group would accept the punishment for any violations of laws and regulations. The Group did not have any material product non-compliance during the Financial Period under Review.

Intellectual Property Rights

The Group respects intellectual property rights and is committed to observe and comply with the relevant laws including the Copyright Ordinance (Cap. 528 of the Laws of Hong Kong) and the Trade Marks Ordinance (Cap. 559 of the Laws of Hong Kong). The Group regularly consults its legal advisor on any potential issues relating to infringement of intellectual property rights of third parties. In addition, in an effort to protect the Group's intellectual property rights and interests, the Group's trademarks have been duly registered and the Group will take prompt action to respond to any violation of its intellectual property rights upon detection, including but not limited to obtaining legal advice from its legal advisor on any course of legal action available. During the Financial Period under Review, the Group was not aware of any material non-compliance with the relevant laws and regulations concerning the intellectual property and privacy of its products and services that may have a significant impact on the Group.

All employees must fully comply with the relevant laws and regulations as well as the Group's corruption prevention policies.

During the Financial Period under Review, anticorruption trainings were conducted for executive Directors and staffs to enhance their understanding of the anti-corruption laws as well as to enhance ethical management and staff integrity. The breakdown of training participation is shown as follows:

B.8 Community investment

To maintain a high standard of corporate governance, the Group acknowledges the importance of enhancing its transparency to the community. The Group actively participates in various community involvement programs or charity events to support the development of healthy life, to cater the needs of local community, to enhance fraternal cooperation in the community and to create a better community.

The Group has actively participated in environmental protection activities and has been accredited the Certificate of Merit of "Hong Kong Awards for Environmental Excellence" by Hong Kong Productivity Council.

To celebrate the Hong Kong SAR Establishment and the National Day, the Group donated a total of 2,400 gift bags to grassroots families and the elderly in subdivided units in July and October 2023, with a total value exceeding HKD460,000. In various districts of Hong Kong, Kowloon, and the New Territories, BEST MART 360° volunteers went to distribute gift bags and extend their concerns to the beneficiaries.

To celebrate the 10th anniversary of BEST MART 360°, the Group launched a series of charity activities for children. First of all, from 26 July to 17 August 2023, we held a Purchase for Donation event for children. When a customer purchased any product under "Famillie", "Pando" or "Kalbarri" at the FoodVille stores in Hong Kong and Macau, the Group donated 1% of the sales, which totaling HK\$150,000, to give back to the community in a series of charity activities in collaboration with the Hong Kong Society for Community Organization, benefiting more than 1,000 families. The charity activities include:

On 28 August 2023, the Group donated 250 shoe coupons to underprivileged students to meet their needs in the new school year, so that they could welcome the new school year with comfort and confidence.

The Company is an investment holding company and the Group is principally engaged in the retail sale of prepackaged leisure foods and other grocery products, which can be broadly categorised into (i) confectioneries; (ii) packaged bakery products and snacks; (iii) nuts and dried fruits; (iv) grain and other miscellaneous food products; (v) beverages and wine; (vi) personal care products; and (vii) other products. The principal activities of the subsidiaries are set out in note 28 to the consolidated financial statements.

Risks related to the global and local economic environment

The global economy faces a complex mix of risks as it navigates the post-pandemic recovery. In January 2024, the International Monetary Fund's "World Economic Outlook Report" forecasted a steady global growth rate of 3.1% for the year, with a slight uptick to 3.2% anticipated in 2025. These figures remain below the historical average, indicating a sluggish recovery. Contributing to this tempered growth are restrictive monetary policies implemented by central banks to combat inflation, the withdrawal of fiscal support as governments aim to manage high debt levels, and persistently low productivity growth.

Fiscal policies are diverging globally, with some advanced economies providing more fiscal stimulus than the others, while emerging markets maintain a neutral stance, with notable exceptions. This divergence could amplify economic disparities and slow growth as many countries begin fiscal tightening in 2024.

Uncertainties in the global economy and business environment may lead to fluctuating exchange rates. As the Group adheres to its global procurement policy by sourcing products worldwide, part of the Group's purchase cost, which are settled in foreign currencies, may increase, negatively impacting profitability.

The challenging external environment will continue to pose pressures on Hong Kong's economy in 2024. While the region experienced a strong uptick at the outset of 2023 following the pandemic's downturn, the pace of Hong Kong's economic rebound has been more gradual than initially expected due to prevailing global headwinds. Diminished worldwide demand coupled with elevated interest rates are likely to dampen business investment and consumer confidence over the short term. - (vii) any adviser (professional or otherwise) or consultant to any area of business or business development of any member of the Group or any Invested Entity; and
- (viii) any other group or classes of participants who have contributed or may contribute by way of joint venture, business alliance or other business arrangement to the development and growth of the Group,

and, for the purposes of the Share Option Scheme, the options may be granted to any company wholly owned by one or more Eligible Participants.

In such event, our Company must send a circular to its Shareholders containing a generic description of the specified participants, the number and terms of options to be granted, the purpose of granting options to the specified participants with an explanation as to how the terms of the options serve such purpose and such other information required under Rule 17.02(2)(d) of the Listing Rules and the disclaimer required under Rule 17.02(4) of the Listing Rules.

(d) Maximum entitlement of each Eligible Participant

The total number of Shares issued and to be issued upon exercise of the options granted under the Share Option Scheme and any other share option scheme of the Group (including both exercised or outstanding options) to each Eligible Participant in any 12-month period shall not exceed 1% of the Shares in issue for the time being. Where any further grant of options to a grantee under the Share Option Scheme would result in the Shares issued and to be issued upon exercise of all options granted and to be granted to such person (including exercised, cancelled and outstanding options) under the Share Option Scheme and any other share option schemes of the Group in the 12-month period up to and including the date of such further grant representing in aggregate over 1% of the Shares in issue, such further grant must be separately approved by the Shareholders in general meeting with such grantee and his close associates (or his associates if the grantee is a connected person) abstaining from voting. The Company must send a circular to the Shareholders and the circular must disclose the identity of the grantee, the number and terms of the options to be granted (and options previously granted to such grantee), the information required under Rule 17.02(2)(d) of the Listing Rules and the disclaimer required under Rule 17.02(4) of the Listing Rules. The number and terms (including the exercise price) of options to be granted to such participant must be fixed before Shareholders' approval and the date of board meeting for proposing such further grant should be taken as the date of grant for the purpose of calculating the exercise price under the Listing Rules.

(f) Time of acceptance and exercise of option

An option may be accepted by a participant within 21 days from the date of the offer of grant of the option.

An option may be exercised in accordance with the terms of the Share Option Scheme at any time during a period to be determined and notified by the Directors to each grantee, which period may commence on the date on which the offer for the grant of option is made but shall end in any event not later than 10 years from the date on which the offer for the grant of option is made subject to the provisions for early termination thereof. Unless otherwise determined by the Directors and stated in the offer of the grant of options to a grantee, there is no minimum period required under the Share Option Scheme for the holding of an option before it can be exercised.

(g) Subscription price for Shares and consideration for the option

The subscription price per Share under the Share Option Scheme shall be determined at the absolute discretion of the Directors, provided that it shall not be less than the highest of (i) the closing price of the Shares as stated in the Stock Exchange's daily quotations sheet on the date on which the offer for the grant of option is made, which must be a business day; (ii) the average closing price of the Shares as stated in the Stock Exchange's daily quotations for the five business days immediately preceding the date on which the offer for the grant of option is made; and (iii) the nominal value of the Shares.

A nominal consideration of HK\$1.00 is payable on acceptance of the grant of an option.

DIRECTORS' AND SUBSTANTIAL SHAREHOLDERS' INTEREST IN COMPETING BUSINESS

As at 31 December 2023, save for Mr. Lin Tsz Fung who is also the chairman and chief executive officer of other retail stores in Hong Kong principally engaged in the sales of footwear and lifestyle products as disclosed in the prospectus of the Company dated 28 December 2018, none of the Directors and substantial shareholders of the Company and its subsidiaries, or their respective close associate, had interests in businesses which compete or are likely to compete, either directly or indirectly, with the businesses of the Company and its subsidiaries as required to be disclosed pursuant to the Listing Rules. Given the overall nature of such retail products of Mr. Lin's other business is substantially different from the principal products of the Company i.e. prepackaged leisure food, the Directors are of the view that the competition between such retail businesses of Mr. Lin and the Group is relatively minimal and remote.

PERMITTED INDEMNITY PROVISIONS

During the Financial Period under Review and up to date of this report, the Company has in force indemnity provisions for the benefit of the Directors. The permitted indemnity provisions are provided according to the Articles of Associations and the Company has maintained the directors and officers liability insurance in respect of potential liability and costs associated with any legal proceedings which may be brought against the Directors of the Company.

(a) Connected and continuing connected transactions in relation to tenancy agreements

Reference is made to the announcement of the Company dated 14 September 2023 (the "**14 September Announcement**"). On 14 September 2023, CIAO International (a wholly-owned subsidiary of the Company) entered into (i) a tenancy agreement with Glorious Supreme Limited (as landlord) for a term of three years for the lease of the On Yam Estate Property (as defined in the 14 September Announcement) (the "**On Yam Estate Tenancy Agreement**"); and (ii) a tenancy agreement with King Worldwide Holdings Limited (as landlord) for a term of three years for the lease of the Shek Wai Kok Estate Property (as defined in the 14 September Announcement) (the "**Shek Wai Kok Estate Tenancy Agreement**"), respectively.

The monthly rental of the On Yam Estate Property comprises of (i) monthly base rent of HK\$50,000 ("**On Yam Property Fixed Base Rent**"); and (ii) a turnover rent of 5% monthly gross receipts exceeding the On Yan Property Fixed Base Rent, exclusive of government rates, management charge air-conditioning charge and other outgoings and inclusive of government rent. CIAO International shall also pay a deposit of HK\$178,047 in respect of the On Yam Estate Property.

The monthly rental of the Shek Wai Kok Estate Property comprises of (i) monthly base rent of HK\$50,000 ("**Shek Wai Kok Property Fixed Base Rent**"); and (ii) a turnover rent of 5% monthly gross receipts exceeding the Shek Wai Kok Property Fixed Base Rent, exclusive of government rates, management charge air-conditioning charge and other outgoings and inclusive of government rent. CIAO International shall also pay a deposit of HK\$189,099 in respect of the Shek Wai Kok Estate Property.

The Group's lease of the On Yam Estate Property and the Shek Wai Kok Estate Property to operate the "Best Mart 360°" brand retail stores shall optimize the Group's retail store-location strategy and enhance the Group's overall performance.

(a) 有關租約的關連及持續關連交易

石圍角邨物業的月租包括:(i)每月基本租 金50,000港元(「石圍角邨物業固定基本租 金」):及(ii)按每月總收入5%計算超出石圍 角邨物業固定基本租金的營業額租金,不 包括政府差餉、管理費、空調費及其他支 出,但包括政府地租。彩鷗國際亦須就石 圍角邨物業繳付按金189,099港元。

本集團租賃安蔭邨物業及石圍角邨物業以 經營「優品360°」品牌零售店鋪將有助完善 本集團零售店鋪的佈局戰略,提升本集團 整體業績。 As detailed in the 14 September Announcement, based on the then present value of the aggregated fixed rental payments for the entire terms of the On Yam Estate Tenancy Agreement and the Shek Wai Kok Estate Tenancy Agreement as discounted using a discount rate which is equivalent to the Company's incremental borrowing rate, the aggregated value of right-of-use assets of the On Yam Estate Tenancy Agreement and the Shek Wai Kok Estate Tenancy Agreement recognised by the Company in accordance with HKFRS 16 amounted to approximately HK\$3,078,000.

The variable turnover rents under the On Yam Estate Tenancy Agreement and the Shek Wai Kok Estate Tenancy Agreement will be recognized as expenses of the Group over the term of the respective tenancy agreement. The payment of variable turnover rents for the nine months ended 31 December 2023 under the On Yam Estate Tenancy Agreement and the Shek Wai Kok Estate Tenancy Agreement are nil and nil, respectively.

As detailed in the 14 September Announcement, as all the applicable percentage ratios in respect of the aggregated annual caps for the payment of variable turnover rents under the On Yam Estate Tenancy Agreement and the Shek Wai Kok Estate Tenancy Agreement are less than 5% and less than HK\$3,000,000, such continuing connected transactions are exempted from the reporting, annual review, announcement and the independent shareholders' approval requirements under Chapter 14A of the Listing Rules.

Continuing connected transactions in relation to sales and purchase framework agreement

Reference is made to the announcement of the Company dated 26 January 2024. On 26 January 2024, the Company (for itself and on behalf of its subsidiaries) and CMHT (for itself and on behalf of its subsidiaries other than the Group) entered into a sales and procurement framework agreement (the "**CMHT Sales and Procurement Framework Agreement**") for the term of one year from 1 January 2024 to 31 December 2024. As CMHT is a substantial Shareholder, the entering into the CMHT Sales and Procurement Framework Agreement between the Company and CMHT and the transactions contemplated thereunder will become continuing connected transactions of the Company under the Listing Rules.

Pursuant to the CMHT Sales and Procurement Framework Agreement, the Company and CMHT agree that (i) the Group shall sell to CMHT and its subsidiaries (other than the Group) liquor, food and beverages, personal care and health products, household and basic groceries, maternal and infant food and supplies, pet food and supplies and other ancillary services arising from the above sales (the "**CMHT Sales Transactions**"); and (ii) the Group shall procure from CMHT and its subsidiaries (other than the Group) liquor, food and beverages, personal care and health products, household and basic groceries, maternal and infant food and supplies, pet food and supplies and other ancillary services arising from the above procurement (the "**CMHT Procurement Transactions**").

Entering into the CMHT Sales and Procurement Framework Agreement is beneficial for both procurement and business-tobusiness sales of the Group. This arrangement not only increases the Group's revenue streams but also ensures a stable supply chain. In addition, the arrangement aligns with the business development needs of the Group, achieving a synergic effect in fair and reasonable manner, and realising resources complementarity and a win-win situation for all parties.

Continuing connected transactions in relation to the CMBL Logistics Services Framework Agreement and the CMQHW Transportation Framework Agreement

Reference is made to the announcement of the Company dated 12 April 2024, (i) CIAO International (a wholly-owned subsidiary of the Company) and CMBL, a company held by CMPH as to 60% and China Merchants Port Group Co., Ltd as to 40%, which is a substantial shareholder of CMPH, entered into a logistics services framework agreement (the "**CMBL Logistics Services Framework Agreement**") for a term from 12 April 2024 to 31 December 2026; and (ii) CIAO International and CMQHW, a company indirectly held by CMPH as to 60% and China Merchants Port Group Co., Ltd. as to 40%, entered into a transportation framework agreement (the "**CMQHW Transportation Framework Agreement**") for a term from 12 April 2024 to 31 December 2026. 訂立招商海通銷售及採購框架協議對本集團的 採購和B2B銷售均有所裨益。此安排不僅增加 本集團的收入來源,還確保穩定的供應鏈。此 外,該安排符合本集團的業務發展需求,以公 平合理的方式實現協同效應,並實現資源互補 和各方共贏的局面。

有關招商保税物流服務框架協議及招商前海灣 運輸框架協議的持續關連交易

茲提述本公司日期為二零二四年四月十二日的 公告,(i)彩鷗國際(本公司全資附屬公司)與招 商保税(一間由招商港口持有60%權益及由招商 港口主要股東招商局港口集團股份有限公司持 有40%權益的公司)訂立物流服務框架協議(「招 商保税物流服務框架協議」),期限為自二零二四 年四月十二日起至二零二六年十二月三十一日 止;及(ii)彩鷗國際與招商前海灣(一間由招商港 口間接持有60%權益及由招商局港口集團股份 有限公司持有40%權益的公司)訂立運輸框架協 議(「招商前海灣運輸框架協議」),期限為自二零 二四年四月十二日起至二零二六年十二月三十 一日止。

As CMHT, a substantial shareholder of the Company, and both CMBL and CMQHW are indirect subsidiaries of China Merchants Group Limited, each of CMBL and CMQHW is considered as an associate of CMHT, and therefore a connected person of the Company as defined under the Listing Rules. As such, the entering into of (i) the CMBL Logistics Services Framework Agreement between CIAO International and CMBL and (ii) the CMQHW Transportation Framework Agreement between CIAO International and CMBL and CMQHW, and the respective transactions contemplated thereunder will become continuing connected transactions of the Company under the Listing Rules.

Pursuant to the CMBL Logistics Services Framework Agreement, CIAO International Limited and CMBL agree that (i) CMBL shall provide customs clearance, warehousing and related logistics services to CIAO International for its goods, and (ii) CIAO International shall appoint CMBL as its sole customs clearance service provider in Shenzhen Qianhai Comprehensive Bonded Zone (深圳前海綜合保税區) (the "CMBL Transactions"). Pursuant to the CMQHW Transportation Framework Agreement, CIAO International and CMQHW agree that CMQHW shall provide land transportation services of goods between Shenzhen and Hong Kong and other supporting services to CIAO International (the "CMQHW Transactions").

Given that CMPH is a leading provider of bonded logistics in the PRC in particular in Shenzhen, the Group can leverage on the cooperation with CMPH and CMPH's bonded logistics services to manage the logistics and transportation of the Group's products more efficiently. This collaboration grants the Group access to reliable and cost-effective supply chain solutions in Mainland China, especially when the Group is tackling the current labor shortage while simultaneously expanding its retail operations in Hong Kong.

Connected transaction and continuing connected transactions in relation to tenancy agreement

Reference is made to the announcement of the Company dated 12 April 2024, CIAO International (as tenant) and Mr. Lin Hiu San Burton (as landlord) entered into a tenancy agreement (the "**Stanley New Street Tenancy Agreement**") for a term of three years from 22 April 2024 to 21 April 2027 (both days inclusive) for the lease of the Stanley New Street Property (as defined in the announcement of the Company dated 12 April 2024). Pursuant to the Stanley New Street Tenancy Agreement, CIAO International shall pay Mr. Lin Hiu San Burton (i) a monthly base rent of HK\$110,000 ("**Fixed Base Rents**") and (ii) a turnover rent of 8% monthly gross receipts exceeding the Fixed Base Rents ("**Variable Turnover Rents**"), exclusive of government rates, management charges and other outgoings and inclusive of government rent. CIAO International shall also pay a deposit of HK\$344,100 in respect of the Stanley New Street Property.

Mr. Lin Hiu San Burton is the son of Mr. Lin Tsz Fung, a substantial Shareholder and an executive Director. Accordingly, Mr. Lin Hiu San Burton is a connected person of the Company under the Listing Rules. Hence, the payment of the Fixed Base Rents under the Stanley New Street Tenancy Agreement will be regarded as a oneoff connected transaction, whereas the payment of the Variable Turnover Rents under the Stanley New Street Tenancy Agreement will be regarded as continuing connected transactions under Rule 14A.31 of the Listing Rules.

As detailed in the announcement of the Company dated 12 April 2024, based on the then present value of the aggregated Fixed Base Rents for the entire terms of the Stanley New Street Tenancy Agreement as discounted using a discount rate which is equivalent to the Company's incremental borrowing rate, the Value of Right-of-Use Assets of the Stanley New Street Tenancy Agreement recognized by the Company in accordance with HKFRS 16 amounted to approximately HK\$3,587,737 (unaudited). 鑒於招商港口為於中國領先的保税物流供應 商,尤其是於深圳,本集團可藉着與招商港口 的合作,利用招商港口的保税物流服務更有效 管理本集團產品的物流及運輸。是次合作給予 本集團得以獲取中國內地可靠及具成本效益供 應鏈解決方案的機會,特別是當本集團於香港 擴展其零售經營時,正應對目前勞工短缺。

Save as disclosed above, there were no other changes in auditor of the Group during the past three years.

The consolidated financial statements for the Financial Period under Review have been audited by SHINEWING (HK) CPA Limited. A resolution will be submitted to the Forthcoming AGM to re-appoint SHINEWING (HK) CPA Limited as the auditor of the Company.

CHANGE OF FINANCIAL YEAR END DATE

As disclosed in the announcement of the Company dated 5 September 2023, the Board resolved to change the financial year end date of the Company from 31 March to 31 December. Accordingly, the reporting financial period in this annual report covers a nine-month period from 1 April 2023 to 31 December 2023. The corresponding comparative amounts shown in this annual report covered the 12-month period from 1 April 2022 to 31 March 2023 and therefore may not be entirely comparable with the amounts shown for the current period.

Valuation of inventories

The key audit matters

The Group held significant inventories as at 31 December 2023, which comprised finished goods in respect of food and beverage, household and personal care products. Inventories are stated at the lower of cost and net realisable value.

Management assessed the level of write-downs of inventories required at the reporting date after considering inventory ageing and other relevant factors. Such assessment involves significant management judgement and estimation in determining the value of inventories which will not be recoverable at the reporting date.

We identified the valuation of inventories as a key audit matter because inventories are significant to the consolidated financial statements and because of the significant degree of management judgement involved in determining the write-down of inventories.

How the matter was addressed in our audit

- obtaining an understanding of and assessing the application of the Group's key internal controls over the inventory writedown assessment process;
- comparing the cost of goods with third party supplier invoices, on a sample basis;
- selecting inventory items, on a sample basis, at the reporting date and comparing their carrying value with their subsequent selling prices as indicated in sales invoices subsequent to the reporting date; and
- assessing the historical accuracy of management's calculation of write-downs of inventories at the end of the previous financial year during the current financial year.

1. GENERAL

Best Mart 360 Holdings Limited (the "**Company**") was incorporated in the Cayman Islands as an exempted company with limited liability under the Companies Law, Cap. 22 (Law 3 of 1961, as consolidated and revised) of the Cayman Islands on 24 January 2018. The address of the Company's registered office is Cricket Square, Hutchins Drive, PO Box 2681, Grand Cayman, KY1–1111, Cayman Islands and its principal place of business in Hong Kong is 11th Floor., C-Bons International Centre, No. 108 Wai Yip Street, Kowloon, Hong Kong.

The Company is an investment holding company and its subsidiaries (collectively referred to as the "**Group**") are principally engaged in retailing of food and beverage, household and personal care products under the "Best Mart 360° (優品360°)" and "FoodVille" brand stores in the Hong Kong Special Administrative Region ("**Hong Kong**"), the Macau Special Administrative Region ("**Macau**") and the Mainland of the People's Republic of China ("**PRC**") and wholesaling in Hong Kong.

The directors consider the immediate holding company of the Group to be China Merchants Hoi Tung Trading Company Limited, which was established in Hong Kong.

The directors consider the ultimate controlling party of the Group to be China Merchants Group Limited, which was established in the PRC.

The consolidated financial statements are presented in Hong Kong Dollars ("**HK\$**"), which is also the functional currency of the Company and all values are rounded to the nearest thousand except when otherwise indicated.

Accordingly, the accompanying consolidated financial statements of the current financial period cover a period of nine months from 1 April 2023 to 31 December 2023. The comparative figures for the consolidated statement of profit or loss and other comprehensive income, consolidated statement of changes in equity, consolidated statement of cash flows and related notes, however, cover a period of twelve months from 1 April 2022 to 31 March 2023, and hence are not directly comparable.

4. MATERIAL ACCOUNTING POLICY INFORMATION

The consolidated financial statements have been prepared in accordance with HKFRSs issued by the HKICPA. In addition, the consolidated financial statements include applicable disclosures required by the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited and by the Hong Kong Companies Ordinance.

The consolidated financial statements have been prepared on the historical cost basis at the end of each reporting period.

Historical cost is generally based on the fair value of the consideration given in exchange for goods.

The material accounting policies are set out as below.

Basis of consolidation

The consolidated financial statements incorporate the financial statements of the Company and entities controlled by the Group.

Control is achieved where the Group has: (i) the power over the investee; (ii) exposure, or rights, to variable returns from its involvement with the investee; and (iii) the ability to use its power over the investee to affect the amount of the Group's returns.

The Company reassesses whether it controls an investee if facts and circumstances indicate that there are changes to one or more of these elements of control stated above.

Consolidation of a subsidiary begins when the Group obtains control over the subsidiary and ceases when the Group loses control of the subsidiary.

Income and expenses of subsidiaries are included in the consolidated statement of profit or loss from the date the Group gains control until the date when the Group ceases to control the subsidiary.

Profit or loss and each component of other comprehensive income of subsidiaries are attributed to owners of the Company and to the non-controlling interest. Total comprehensive income of subsidiaries is attributed to the owners of the Company and to the non-controlling interests even if this results in the non-controlling interests having a deficit balance.

All intra-group assets and liabilities, equity, income, expenses and cash flows relating to transactions between entities of the Group are eliminated in full on consolidation.

Revenue from contracts with customers

Revenue is recognised to depict the transfer of promised goods to customers in an amount that reflects the consideration to which the entity expects to be entitled in exchange for those goods. Specifically, the Group uses a 5-step approach to revenue recognition:

- Step 1: Identify the contract(s) with a customer
- Step 2: Identify the performance obligations in the contract
- Step 3: Determine the transaction price
- Step 4: Allocate the transaction price to the performance obligations in the contract
- Step 5: Recognise revenue when (or as) the entity satisfies a performance obligation.

The Group recognised revenue when (or as) a performance obligation is satisfied, i.e. when "control" of the goods underlying the particular performance obligation is transferred to customers.

A performance obligation represents a good or service (or a bundle of goods) that is distinct or a series of distinct goods that are substantially the same.

Control is transferred over time and revenue is recognised over time by reference to the progress towards complete satisfaction of the relevant performance obligation if one of the following criteria is met:

- The customer simultaneously receives and consumes the benefits provided by the Group's performance as the Group performs;
- The Group's performance creates and enhances an asset that the customer controls as the asset is created and enhanced; or
- The Group's performance does not create an asset with an alternative use to the Group and the Group has an enforceable right to payment for performance completed to date.

Otherwise, revenue is recognised at a point in time when the customer obtains control of the distinct goods or service.

Revenue is measured based on the consideration to which the Group expects to be entitled in a contract with a customer, excludes amounts collected on behalf of third parties, discounts and sales related taxes.

Contract liabilities

A contract liability represents the Group's obligation to transfer goods to a customer for which the Group has received consideration from the customer.

Revenue recognition

For a single contract with the customer, either a net contract asset or a net contract liability is presented. For multiple contracts, contract assets and contract liabilities of unrelated contracts are not presented on a net basis.

The Group recognised revenue from the following major sources:

- Sale of goods retail
- Sale of goods wholesale
- Customer loyalty programme

Sale of goods - retail

The Group sells goods directly to retail customers within retail stores. Revenue recognised from sale of goods to retail customers is recognised at a point in time when the product is transferred to the customers upon sale. Payment of the transaction price is due immediately when the customers purchase the good. The payment is usually settled in cash or using credit cards, octopus card, Alipay, WeChat pay and other electronic payment platform.

Sale of goods - wholesale

Sales are recognised at a point in time when control of the products has been transferred, being when the products are delivered to the wholesaler, the wholesaler has full discretion over the channel and price to sell the products, and there is no unfulfilled obligation that affects the wholesaler's acceptance of the products.

Discounts, coupons and other cash incentive to retail customers and discounts to wholesale customers are accounted for as reduction of the transactions prices.

Customer loyalty programme

The Group operates a loyalty programme where retail customers accumulate points for purchases made which entitle them to redeem award points for discounts in future purchases. The transaction price is allocated to the product and the award points on a relative stand-alone selling price basis. Revenue from the award points is recognised when the award points are redeemed. Contract liabilities are recognised until the award points are redeemed. Contract liabilities in relation to customer loyalty programme were included in "Accruals and other payables".

Leasing

Definition of a lease

A contract is, or contains, a lease if the contract conveys a right to control the use of an identified asset for a period of time in exchange for consideration.

The Group as lessee

The Group assesses whether a contract is or contains a lease, at inception of the contract or modification date or acquisition date, as appropriate. The Group recognises a rightof-use asset and a corresponding lease liability with respect to all lease arrangements in which it is the lessee, except for short-term leases (defined as leases with a lease term of 12 months or less from the commencement date and do not contain a purchase option) and leases of low value assets. For these leases, the Group recognises the lease payments as an operating expense on a straight-line basis over the term of the lease unless another systematic basis is more representative of the time pattern in which economic benefits from the leased assets are consumed.

Lease liabilities

At the commencement date, the Group measures lease liability at the present value of the lease payments that are not paid at that date. The lease payments are discounted by using the interest rate implicit in the lease. If this rate cannot be readily determined, the Group uses its incremental borrowing rate.

Lease payments included in the measurement of the lease liability comprise fixed lease payments (including in-substance fixed payments).

The lease liability is presented as a separate line in the consolidated statement of financial position.

The lease liability is subsequently measured by increasing the carrying amount to reflect interest on the lease liability (using the effective interest method) and by reducing the carrying amount to reflect the lease payments made.

Lease liability is remeasured (and with a corresponding adjustment to the related right-of-use asset) whenever:

- the lease term has changed or there is a significant event • or change in circumstances resulting in a change in the assessment of exercise of a purchase option, in which case the lease liability is remeasured by discounting the revised lease payments using revised discount rate.
- the lease payments change due to changes in an • index or rate or a change in expected payment under a guaranteed residual value, in which cases the lease liability is remeasured by discounting the revised lease payments using the initial discount rate (unless the lease payments change is due to a change in a floating interest rate, in which case a revised discount rate is used).
- A lease contract is modified and the lease modification is not accounted for as a separate lease, in which case the lease liability is remeasured based on the lease term of the modified lease by discounting the revised lease payments using a revised discount rate at the effective date of the modification.

Right-of-use assets

The right-of-use assets comprise the initial measurement of the corresponding lease liability, lease payments made at or before the commencement date and any initial direct costs, less lease incentives received. Whenever the Group incurs an obligation for costs to dismantle and remove a leased asset, restore the site on which it is located or restore the underlying asset to the condition required by the terms and conditions of the lease, a provision is recognised and measured under HKAS 37 "Provision, Contingent Liabilities and Contingent Assets". The costs are included in the related right-of-use asset.

Right-of-use assets are subsequently measured at cost less accumulated depreciation and impairment losses, and adjusted for any remeasurement of lease liabilities, if any. They are depreciated over the shorter period of lease term and useful life of the underlying asset. The depreciation starts at the commencement date of the lease.

Right-of-use assets are presented as "properties" under property, plant and equipment.

The Group applies HKAS 36 Impairment of Assets to determine whether a right-of-use assets is impaired and accounts for any identified impairment loss.

Variable rents that do not depend on an index or rate are not included in the measurement of the lease liability and the right-of-use asset. The related payments are recognised as an expense in the period in which the event or condition that triggers those payments occurs and are included in selling and distribution expenses in the consolidated statement of profit or loss and other comprehensive income consolidated statement of profit or loss.

Lease modification

The Group accounts for a lease modification as a separate lease if:

- the modification increases the scope of the lease by adding the right to use one or more underlying assets: and
- the consideration for the lease increases by an amount commensurate with the stand-alone price for the increase in scope and any appropriate adjustments to that stand-alone price to reflect the circumstances of the particular contract.

For a lease modification that is not accounted for a separate lease, the Group remeasures the lease liability based on the lease term of the modified lease by discounting the revised lease payments using a revised discount rate at the effective date of the modification.

Foreign currencies

In preparing the financial statements of each individual group entity, transactions in currencies other than the functional currency of that entity (foreign currencies) are recorded in the respective functional currency (i.e. the currency of the primary economic environment in which the entity operates) at the rates of exchanges prevailing at the dates of the transactions. At the end of the reporting period, monetary items denominated in foreign currencies are retranslated at the rates prevailing at that date. Non-monetary items carried at fair value that are denominated in foreign currencies are retranslated at the rates prevailing at the date when the fair value was determined. Non-monetary items that are measured in terms of historical cost in a foreign currency are not retranslated.

Exchange differences arising on the settlement of monetary items, and on the retranslation of monetary items, are recognised in profit or loss in the period in which they arise.

Exchange differences arising on the retranslation of nonmonetary items carried at fair value are included in profit or loss for the period.

For the purposes of presenting the consolidated financial statements, the assets and liabilities of the Group's foreign operations are translated into the presentation currency of the Group (i.e. HK\$) using exchange rates prevailing at the end of each reporting period. Income and expenses items are translated at the average exchange rates for the period/year. Exchange differences arising, if any, are recognised in other comprehensive income and accumulated in equity under the heading of translation reserve (attributed to non-controlling interest as appropriate).

Borrowing costs

Borrowing costs directly attributable to the acquisition, construction or production of qualifying assets, which are assets that necessarily take a substantial period of time to get ready for their intended use or sale, are added to the cost of those assets, until such time as the assets are substantially ready for their intended use or sale.

All other borrowing costs are recognised in profit or loss in the period in which they are incurred.

Government grants

Government grants are not recognised until there is reasonable assurance that the Group will comply with the conditions attaching to them and that the grants will be received.

Government grants related to income that are receivable as compensation for expenses or losses already incurred or for the purpose of giving immediate financial support to the Group with no future related costs are recognised in profit or loss in the period in which they become receivable.

Retirement benefits costs

A defined contribution plan is a pension plan under which the Group pays fixed contributions into a separate entity. The Group has no legal or constructive obligations to pay further contributions if the fund does not hold sufficient assets to pay all employees the benefits relating to employee service in the current and prior periods.

The Group contributes to defined contribution provident funds, including the scheme set up under the Hong Kong Mandatory Provident Fund Schemes Ordinance ("MPF **Scheme**"), which are available to all gualifying employees in Hong Kong. Contributions to the MPF Scheme are in accordance with the statutory limits prescribed by the Mandatory Provident Fund Schemes Ordinance. The Group contributes 5% of the relevant payroll to the MPF Scheme, which contribution is matched by employees. The employees are entitled to 100% of the employer's mandatory contributions upon their retirement age of 65 years old. death or total incapacity. Payments to the MPF Scheme are recognised as an expense when employees have rendered service entitling them to the contributions. The Group's employer contribution vest fully with the employees when contributed into the MPF Scheme. Accordingly, for the Financial Period under Review and year ended 31 March 2023, there were no forfeited contributions (by employers on behalf of employees who leave the Scheme prior to vesting fully in such contributions) that may be used by the employer to reduce the existing level of contributions.

The Group also participates in the employee retirement benefits plan of the respective governments in various jurisdiction where the Group operates. The Group is required to make monthly contributions calculated as a percentage of the monthly payroll costs and the respective municipal government undertakes to assume the retirement benefit obligations of all existing and future retired employees of the Group. The Group's contributions to the schemes are expensed as incurred.

Short-term employee benefits

A liability is recognised for benefits accruing to employees in respect of wages and salaries and annual leave in the period the related service is rendered at the undiscounted amount of the benefits expected to be paid in exchange for that service.

Liabilities recognised in respect of short-term employee benefits are measured at the undiscounted amount of the benefits expected to be paid in exchange for the related service.

Taxation

Income tax expense represents the sum of the tax currently payable and deferred tax.

The tax currently payable is based on taxable profit for the year. Taxable profit differs from "loss before tax" as reported in the consolidated statement of profit or loss because it excludes items of income or expense that are taxable or deductible in other years and it further excludes items that are never taxable or deductible. The Group's liability for current tax is calculated using tax rates that have been enacted or substantively enacted by the end of the reporting period.

Deferred tax is recognised on temporary differences between the carrying amounts of assets and liabilities in the consolidated financial statements and the corresponding tax base used in the computation of taxable profit. Deferred tax liabilities are generally recognised for all taxable temporary differences. Deferred tax assets are generally recognised for all deductible temporary difference to the extent that it is probable that taxable profits will be available against which those deductible temporary differences can be utilised. Such deferred tax assets and liabilities are not recognised if the temporary difference arises from the initial recognition of assets and liabilities in a transaction that affects neither the taxable profit nor the accounting profit and at the time of the transaction does not give rise to equal taxable and deductible temporary differences.

Deferred tax liabilities are recognised for taxable temporary differences associated with investments in subsidiaries, except where the Group is able to control the reversal of the temporary difference and it is probable that the temporary difference will not reverse in the foreseeable future. Deferred tax assets arising from deductible temporary differences associated with such investments are only recognised to the extent that it is probable that there will be sufficient taxable profits against which to utilise the benefits of the temporary differences and they are expected to reverse in the foreseeable future.

The carrying amount of deferred tax assets is reviewed at the end of each reporting period and reduced to the extent that it is no longer probable that sufficient taxable profits will be available to allow all or part of the asset to be recovered.

Deferred tax assets and liabilities are measured at the tax rates that are expected to apply in the period in which the liability is settled or the asset is realised, based on tax rate (and tax laws) that have been enacted or substantively enacted by the end of the reporting period.

The measurement of deferred tax liabilities and assets reflects the tax consequences that would follow from the manner in which the Group expects, at the end of the reporting period, to recover or settle the carrying amount of their assets and liabilities.

For leasing transactions in which the tax deductions are attributable to the lease liabilities, the Group applies HKAS 12 requirements to the lease liabilities, and the related assets separately. The Group recognises a deferred tax asset relate to lease liabilities to the extend that it is probable that taxable profit will be available against which the deductible temporary difference can be utilised and a deferred tax liability for all taxable temporary differences.

Deferred tax assets and liabilities are offset when there is a legally enforceable right to set off current tax assets against current tax liabilities and when they related to income taxes levied by the same taxation authority and the Group intends to settle current tax liabilities and assets on a net basis.

Current and deferred tax are recognised in profit or loss.

Property, plant and equipment, including right-of-use assets, are stated in the consolidated statement of financial position at cost less subsequent accumulated depreciation and subsequent accumulated impairment losses, if any.

Ownership interests in leasehold land and buildings

When the Group makes payments for ownership interests of properties which includes both leasehold land and building elements, the entire consideration is allocated between the leasehold land and the building elements in proportion to the relative fair values at initial recognition. To the extent the allocation of the relevant payments can be made reliably, interest in leasehold land is presented as "right-of-use assets" in the consolidated statement of financial position. When the consideration cannot be allocated reliably between non-lease building element and undivided interest in the underlying leasehold land, the entire properties are classified as property, plant and equipment.

Depreciation is recognised so as to write off the cost of items of property, plant and equipment, less their residual values over their estimated useful lives, using the straightline method. The estimated useful lives, residual values and depreciation method are reviewed at the end of each reporting period, with the effect of any changes in estimate accounted for on a prospective basis.

Inventories

Inventories are stated at the lower of cost and net realisable value. Cost is calculated using the first-in, first-out method. Net realisable value represents the estimated selling price in the ordinary course of business less all estimated costs of completion and costs necessary to make the sale.

Cash and cash equivalents

In the consolidated statement of financial position, cash and bank balances comprise cash (i.e. cash on hand and shortterm bank deposits) and cash equivalents. Cash equivalents are short-term (generally with original maturity of three months or less), highly liquid investments that are readily convertible to a known amount of cash and which are subject to an insignificant risk of changes in value. Cash equivalents are held for the purpose of meeting short-term cash commitments rather for investment or other purposes.

Investments in subsidiaries

Investments in subsidiaries are stated on the statement of financial position of the Company at cost less accumulated impairment loss, if any.

Financial assets and financial liabilities are recognised in the consolidated statement of financial position when a group entity becomes a party to the contractual provisions of the instrument.

Financial assets and financial liabilities are initially measured at fair value, except for trade receivables arising from contracts with customers which are initially measured in accordance with HKFRS 15 Revenue from Contracts with Customers. Transaction costs that are directly attributable to the acquisition or issue of financial assets and financial liabilities (other than financial asset at fair value through profit or loss "**FVTPL**") are added to or deducted from the fair values of the financial assets or financial liabilities, as appropriate, on initial recognition. Transaction costs directly attributable to the acquisition of financial asset at FVTPL are recognised immediately in profit or loss.

Financial assets

All regular way purchases or sales of financial assets are recognised and derecognised on a trade date basis. Regular way purchases or sales are purchases or sales of financial assets that require delivery of assets within the time frame established by regulation or convention in the marketplace.

All recognised financial assets are subsequently measured in their entirety at either amortised cost or fair value, depending on the classification of the financial assets. Financial assets are classified, at initial recognition, as subsequently measured at amortised cost and FVTPL.

The classification of financial assets at initial recognition depends on the financial asset's contractual cash flow characteristics and the Group's business model for managing them.

Financial assets at amortised cost are subsequently measured using the effective interest method and are subject to impairment.

The effective interest method is a method of calculating the amortised cost of a debt instrument and of allocating interest income over the relevant period.

For financial assets other than purchased or originated credit-impaired financial assets (i.e. assets that are creditimpaired on initial recognition), the effective interest rate is the rate that exactly discounts estimated future cash receipts (including all fees and points paid or received that form an integral part of the effective interest rate, transaction costs and other premiums or discounts) excluding the expected credit losses ("ECL"), through the expected life of the debt instrument, or, where appropriate, a shorter period, to the gross carrying amount of the debt instrument on initial recognition. For purchased or originated credit impaired financial assets, a credit adjusted effective interest rate is calculated by discounting the estimated future cash flows, including expected credit losses, to the amortised cost of the debt instrument on initial recognition.

The amortised cost of a financial asset is the amount at which the financial asset is measured at initial recognition minus the principal repayments, plus the cumulative amortisation using the effective interest method of any difference between that initial amount and the maturity amount, adjusted for any loss allowance. The gross carrying amount of a financial asset is the amortised cost of a financial asset before adjusting for any loss allowance.

Interest income is recognised using the effective interest method for debt instruments measured subsequently at amortised cost. For financial assets other than purchased or originated credit-impaired financial assets, interest income is calculated by applying the effective interest rate to the gross carrying amount of a financial asset, except for financial assets that have subsequently become credit impaired (see below). For purchased or originated credit impaired financial assets, the Group recognises interest income by applying the creditadjusted effective interest rate to the amortised cost of the financial asset from initial recognition. Irrespective of the outcome of the above assessment, the Group presumes that the credit risk on a financial asset has increased significantly since initial recognition when contractual payments are more than 30 days past due, unless the Group has reasonable and supportable information that demonstrates otherwise.

Despite the foregoing, the Group assumes that the credit risk on a debt instrument has not increased significantly since initial recognition if the debt instrument is determined to have low credit risk at the reporting date. A financial instrument is determined to have low credit risk if (i) the financial instrument has a low risk of default; (ii) the debtor has a strong capacity to meet its contractual cash flow obligations in the near term; and (iii) adverse changes in economic and business conditions in the longer term may, but will not necessarily, reduce the ability of the borrower to fulfill its contractual cash flow obligations. The Group considers a debt instrument to have low credit risk when the asset has external credit rating of 'investment grade' in accordance with the globally understood definition or if an external rating is not available, the asset has an internal rating of 'performing'. Performing means that the counterparty has a strong financial position and there is no past due amounts.

The Group regularly monitors the effectiveness of the criteria used to identify whether there has been a significant increase in credit risk and revises them as appropriate to ensure that the criteria are capable of identifying significant increase in credit risk before the amount becomes past due.

Write-off policy

The Group writes off a financial asset when there is information indicating that the debtor is in severe financial difficulty and there is no realistic prospect of recovery, e.g. when the counterparty has been placed under liquidation or has entered into bankruptcy proceedings. Financial assets written off may still be subject to enforcement activities under the Group's recovery procedures, taking into account legal advice where appropriate. Any recoveries made are recognised in profit or loss.

Measurement and recognition of ECL

The measurement of ECL is a function of the probability of default, loss given default (i.e. the magnitude of the loss if there is a default) and the exposure at default. The assessment of the probability of default and loss given default is based on historical data adjusted by forward-looking information as described above. The carrying amount of an asset is not reduced below the highest of its fair value less costs of disposal (if measurable), its value in use (if determinable) and zero. The amount of the impairment loss that would otherwise have been allocated to the asset is allocated pro rata to the other assets of the unit or the group of cash-generating units. An impairment loss is recognised immediately in profit or loss.

Where an impairment loss subsequently reverses, the carrying amount of the asset (or the cash-generating unit) is increased to the revised estimate of its recoverable amount, but so that the increased carrying amount does not exceed the carrying amount that would have been determined had no impairment loss been recognised for the asset (or the cash-generating unit) in prior years. A reversal of an impairment loss is recognised as income immediately.

In the application of the Group's accounting policies, which are described in Note 4, the directors of the Company are required to make judgements, estimates and assumptions about the amounts of assets, liabilities, revenue and expenses reported and disclosures made in the consolidated financial statements. The estimates and associated assumptions are based on historical experience and other factors that are considered to be relevant. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an on-going basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods.

Key sources of estimation uncertainty

The followings are the key assumptions concerning the future, and other key sources of estimation uncertainty at the end of the reporting period, that have a significant risk of resulting in a material adjustment to the carrying amounts of assets and liabilities within the next financial year.

Useful lives and residual values of property, plant and equipment

In determining the useful life and residual value of an item of property, plant and equipment, the Group has to consider various factors, such as technical or commercial obsolescence arising from changes or improvement in production, or from a change in the market demand for the products or service output of the asset, expected usage of the asset, expected physical wear and tear, the care and maintenance of the asset, and legal or similar limits on the use of the asset. The carrying amount of property, plant and equipment excluding properties as at 31 December 2023 is HK\$209,987,000 (31 March 2023: HK\$211,005,000). The estimation of the useful life of the asset is based on the experience of the Group with similar assets that are used in similar way. The Group will revise the depreciation charge where useful lives are different to those previously estimated, or it will write-off or writedown technically obsolete or non-strategic assets that have been abandoned or sold.

Allowance for slow-moving inventories

Allowance for slow-moving inventories is made based on the ageing and estimated net realisable value of inventories. The assessment of the allowance amount involves judgement and estimates. Where the actual outcome in future is different from the original estimate, such difference will impact the carrying value of inventories and allowance charge/write-back in the period in which such estimate has been changed. The carrying amount of inventories as at 31 December 2023 is HK\$276,691,000 (31 March 2023: HK\$244,219,000).

Impairment loss for non-financial assets

The Group assesses at the end of each reporting period whether non-financial assets suffered any impairment in accordance with accounting policy stated in Note 4. The nonfinancial assets are reviewed for the impairment whenever events or changes in circumstances indicate that the carrying amount of the assets exceeds their recoverable amounts. The determination of recoverable amount requires an estimation of future cash flows and the selection of appropriate discount rates. Changes in these estimates could have a significant impact on the carrying value of the assets and could result in additional impairment charge or reversal of impairment in future periods, where applicable. No impairment loss on nonfinancial assets was recognised by the Group in both periods.

Income taxes

The Group is subject to income taxes in Hong Kong and Macau. Significant judgement is required in determining the provision for income taxes. There are many transactions and calculations for which ultimate tax determination is uncertain during the ordinary course of business. The Group recognised liabilities for anticipated tax issues based on estimates of whether additional taxes will be due. Where the final tax outcome of these matters is different from the amounts that were initially recorded, such differences will affect the income tax and deferred tax provision in the period in which such determination is made.

Provision of reinstatement costs of retail stores and offices

Most of the Group's retail stores are leased under operating lease and are subject to reinstatement obligation as stipulated in the lease agreements. Management assesses the amount of provision made for each store and offices based on various factors, including the size of the store and offices, the complexity of refurbishment and specific requirements from landlords. The Group's management assesses the adequacy of such provision at the end of each reporting period. As at 31 December 2023, the carrying amount of such provision was approximately HK\$4,916,000 (31 March 2023: HK\$4,125,000).

Leases - Estimating the incremental borrowing rate

The Group cannot readily determine the interest rate implicit in a lease, and therefore, it uses an incremental borrowing rate ("IBR") to measure lease liabilities. The IBR is the rate of interest that the Group would have to pay to borrow over a similar term, and with a similar security, the funds necessary to obtain an asset of a similar value to the right-of-use asset in a similar economic environment. The IBR therefore reflects what the Group "would have to pay", which requires estimation when no observable rates are available (such as for subsidiaries that do not enter into financing transactions) or when it needs to be adjusted to reflect the terms and conditions of the lease (for example, when leases are not in the subsidiary's functional currency). The Group estimates the IBR using observable inputs (such as market interest rates) when available and is required to make certain entity-specific estimates (such as the subsidiary's stand-alone credit rating).

31. FINANCIAL RISK MANAGEMENT

The main risks arising from the Group's financial instruments in the normal course of the Group's business are credit risk, liquidity risk, foreign currency risk, and interest rate risk.

These risks are limited by the Group's financial management policies and practices described below.

(a) Credit risk

The Group's maximum exposure to credit risk is the carrying amounts of cash and bank balances, and trade and other receivables. The Group has no concentration of credit risk from third party debtors.

All of the Group's trade receivables and other receivables have no collateral. The Group assessed the credit quality of the counterparties by taking into account their financial position, credit history and other factors. Management also regularly reviews the recoverability of these receivables and follow up the disputes or amounts overdue, if any. The Directors are of the opinion that the risk of default by counterparties is low.

The Group considers the probability of default upon initial recognition of asset and whether there has been a significant increase in credit risk on an ongoing basis throughout each reporting period. To assess whether there is a significant increase in credit risk, the Group compares the risk of a default occurring on the asset as at the reporting date with the risk of default as at the date of initial recognition. It considers available reasonable and supportable forwarding-looking information.

(i) Trade receivables

The Group applies the simplified approach to providing for ECL prescribed by HKFRS 9, which permits the use of the lifetime expected loss provision for all trade receivables. The Group always measures the loss allowance for trade receivables. at an amount equal to lifetime ECL. The ECL on trade receivables is estimated by reference to past default experience of the debtor and current market condition in relation to each debtor's exposure. The ECL also incorporates forward-looking information with reference to general macroeconomic conditions that may affect the ability of the debtors to settle receivables. To measure the ECL, the trade receivables have been grouped based on share credit risk characteristics and the days past due according to the ageing as disclosed in Note 18. Expected loss rate of current trade receivables are assessed to be 0.1% as the trade receivables mainly represent amounts due from Octopus Cards Limited and credit card companies with high credit rating and no history of default. For the past due trade receivables, since the balances were immaterial, the management of the Group considered the loss allowance provision for these balances were immaterial. There is no change in the ECL rate for trade receivables during the period/year mainly due to no significant change in the historical default rates of trade receivables based on which the ECL rate is determined. The management of the Group considered the loss allowance provision for trade receivables was immaterial during the period ended 31 December 2023 (for the year ended 31 March 2023: immaterial).

As at 31 December 2023, the management of the Group takes into account the historical default experience and forward-looking information, as appropriate, for example the Group considers the consistently low historical default rates of counterparties, and concludes that credit risk inherent in the Group's outstanding other receivables is insignificant. The management of the Group has assessed that other receivables do not have a significant increase in credit risk since initial recognition and risk of default is insignificant, therefore the ECL for these receivables were immaterial under the 12 months expected loss method and no loss allowance was recognised during the nine months ended 31 December 2023 (31 March 2023: Nil).

(b) Liquidity risk

The Group's policy is to regularly monitor its liquidity requirements to ensure that it maintains sufficient reserves of cash to meet its liquidity requirements in the short and long term. The management of the Company is satisfied that the Group will be able to meet in full its financial obligations as and when they fall due in the foreseeable future in the normal course of business. The following table details the remaining contractual maturities at the end of each reporting period of the Group's financial liabilities, which are based on contractual undiscounted cash flows (including interest payment computed using contractual rates or, if floating, based on the current rates at the reporting date) and the earliest date the Group may be required to pay.

The Group mainly operated in Hong Kong with most of the transactions settled in HK\$ and did not have significant exposure to risk resulting from changes in foreign currency exchange rates.

(d) Interest rate risk

The Group's exposure to interest rate risk relates principally to its bank deposits and interest-bearing bank borrowing. Borrowing issued at variable rates expose the Group to cash flow interest-rate risk. The Group has not entered into any financial derivative instruments to hedge its exposure to interest rate risk. The Group's policy is to manage its interest rate risk, working within an agreed framework, to ensure that there are no unduly exposures to significant interest rate movements.

Sensitivity analysis

At the respective end of each reporting period, it is estimated that a general increase/decrease of 100 basis points in interest rates, with all other variables held constant, would increase/decrease the Group's profit for the period ended 31 December 2023 by approximately HK\$56,000 (31 March 2023: decrease/increase by approximately HK\$622,000).

The sensitivity analysis above has been determined to assume that the change in interest rates had occurred at the end of each reporting period and had been applied to the exposure to interest rate risk for the bank deposits and borrowing in existence at that date. The 100 basis point increase or decrease represents management's assessment of a reasonably possible change in interest rates over the next twelve months period.

The interest rate risk policies have been followed by the Group consistently throughout the period.

32. CAPITAL MANAGEMENT

The Group's primary objective when managing capital is to safeguard the Group's ability to continue as a going concern and maximising the return to stakeholders. The Group's capital structure is regularly reviewed and managed by the directors of the Company. The Group is not subject to externally imposed capital requirements. To maintain or adjust capital structure, the Group may adjust dividend payment to shareholders or issue new shares. Adjustments will be made to the capital structure in light of changes in economic conditions affecting the Company or its subsidiaries, and the risk characteristics of the Group's underlying assets.

34. ACCOUNTING IMPLICATIONS OF THE ABOLITION OF THE MPF-LSP OFFSETTING MECHANISM IN HONG KONG

In June 2022, Hong Kong Government gazetted the Hong Kong Employment and Retirement Schemes Legislation (Offsetting Arrangement) (Amendment) Ordinance 2022 (the "Amendment Ordinance"), which will eventually abolish the statutory right of an employer to reduce its long service payment ("LSP") and severance payment payable to a Hong Kong employee by drawing on its mandatory contributions to the mandatory provident fund ("MPF") scheme (also known as the offsetting mechanism). Hong Kong Government has subsequently announced that the Amendment Ordinance will come into effect from 1 May 2025 (the "Transition Date"). Separately, the HKSAR Government is also expected to introduce a subsidy scheme to assist employers after the abolition.

Among other things, once the abolition of the offsetting mechanism takes effect, an employer can no longer use any of the accrued benefits derived from its MPF contributions (irrespective of the contributions made before, on or after the Transition Date) to reduce the LSP in respect of an employee's service from the Transition Date. However, where an employee's employment commenced before the Transition Date, the employer can continue to use the above accrued benefits to reduce the LSP in respect of the employee's service up to that date; in addition, the LSP in respect of the service before the Transition Date will be calculated based on the employee's monthly salary immediately before the Transition Date and the years of service up to that date.

34. 香港取消強積金與長期服務金對沖 機制的會計影響

二零二二年六月,香港政府就《二零二二年 僱傭及退休計劃法例(抵銷安排)(修訂)條 例》(「修訂條例」)刊憲,落實取消僱主使用 其向強制性公積金(「強積金」)計劃作出的強 制性供款來扣減應付予其香港僱員的長期 服務金(「長期服務金」)及遣散費的法定權利 (又稱「對沖機制」)。香港政府其後宣佈修訂 條例將於二零二五年五月一日(「過渡日」)起 生效。另外,預計香港特別行政區政府還 將推出一項補貼計劃,在取消對沖機制後 為僱主提供協助。

一旦取消對沖機制生效,僱主不可再使用 其強積金強制性供款(不論在過渡日之前、 當日或之後作出的供款)所產生的累算權 益,來扣減僱主就員工於過渡日後的服務 所應付的長期服務金。然而,如僱員在過 渡日前開始受僱,僱主可繼續以上述累算 權益扣減就該僱員截至該日止的服務所應 付的長期服務金;此外,就過渡日之前的 服務所應付的長期服務金,將根據過渡日 之前僱員的最後月薪及截至該日的服務年 期計算。

34. ACCOUNTING IMPLICATIONS OF THE ABOLITION OF THE MPF-LSP OFFSETTING MECHANISM IN HONG KONG (Cont'd)

In July 2023, the HKICPA published accounting implications of the abolition of the MPF-LSP offsetting mechanism in Hong Kong that provides guidance on the accounting considerations relating to the offsetting mechanism and the abolition of the mechanism. In particular, the guidance indicates that entities may account for the accrued benefits derived from its mandatory MPF contributions that are expected to be used to reduce the LSP payable to an employee as deemed contributions by that employee towards the LSP: however. upon the enactment of the Amendment Ordinance in June 2022, entities can no longer apply the practical expedient in paragraph 93(b) of HKAS 19, Employee Benefits, to recognise such deemed contributions as reduction of current service cost in the period the related service is rendered, and any impact from ceasing to apply the practical expedient is recognised as a catch-up adjustment in profit or loss with a corresponding adjustment to the LSP liability in the financial statements.

In this financial report and in prior periods, consistent with the HKICPA guidance the Group has been accounting for the accrued benefits derived from its mandatory MPF contributions that are expected to be used to reduce the LSP payable to an employee as deemed employee contributions towards the LSP. The Group has been applying the abovementioned practical expedient.

The Group has assessed the implications of this new guidance on the above accounting policies and has decided to change those accounting policies to conform with the HKICPA guidance. The management has commenced the processes on implementing the change including additional data collection and impact assessment. However, the impact of the change is not reasonably estimable at the time of these consolidated financial statements are authorised for issuance, as the Group has yet to fully complete its assessment of the impact of the HKICPA guidance.

34. 香港取消強積金與長期服務金對沖 機制的會計影響(續)

二零二三年七月,香港會計師公會發出《香 港取消強積金與長期服務金對沖機制的會 計影響》,為對沖機制及取消對沖機制的 相關會計考慮提供指引。具體而言,該指 引指出,實體可以將其預計用以扣減應付 僱員的長期服務金的強積金強制供款累約 權益,以視作僱員對長期服務金的供款累入 賬;然而,自二零應用《香港會計準則》第 19號僱員福利第93(b)段中的可行權宜之 法,將此類視作供款確認為提供相關服務 均當期服務成本扣減,而停止應用可 行權宜之法的任何影響均確認為損益中的 追加調整,在財務報表中對長期服務金負 債進行相應調整。

於本財務報告及過往會計期中,本集團均 依照香港會計師公會的指引,將其預計用 以扣減應付予僱員的長期服務金的強積金 強制供款累算權益,視作僱員對公司的供 款入賬。本集團一直應用上述可行權宜之 法。

本集團已評估此項新指引對上述會計政策 的影響,並決定為符合香港會計師公會指 引而改變該等會計政策。管理層已經開始 實施變動的程序,包括收集額外資料及進 行影響評估。然而,在該等綜合財務報表 獲授權發佈時,由於本集團尚未完全完 成對香港會計師公會指引的影響作出的評 估,因此未能對該變動的影響作出合理的 估計。
