### **DEAR SHAREHOLDERS,**

On behalf of the board (the "**Board**") of directors (the "**Directors**") of Renze Harvest International Limited (the "**Company**"), I am pleased to present the results of the Company and its subsidiaries (collectively, the "**Group**") for the year ended 31 December 2023 (the "**Year**").

The Group recorded a revenue of approximately HK\$740.3 million, representing an decrease of approximately 8.8% in revenue from approximately HK\$811.4 million as recorded in the previous financial year. The decrease in revenue was mainly due to the decrease of trading volume of automation business in the Year as compared with those in the previous year.

The Company recorded a profit for the Year of approximately HK\$55.3 million (2022: loss for the Year of approximately HK\$537.4 million). The increase in the profit for the Year as compared to the previous financial year was primarily attributable to the recognition of gain on bargain purchase arising from the business combination of approximately HK\$550.5 million in the Year (2022: nil) and recovery of impairment losses on financial assets arising from acquisition of a subsidiary of approximately HK\$259.1 million for the Year (2022: nil).

### 尊敬的各位股東:

本人謹代表中澤豐國際有限公司(「本公 司」)董事(「董事」)會(「董事會」),欣然呈 列本公司及其附屬公司(統稱「本集團」)截 至二零二三年十二月三十一日止年度(「本 年度」)之業績。

本集團錄得收益約740.3百萬港元,較上一 財年錄得的收益約811.4百萬港元減少約 8.8%。收益減少主要由於本年度自動化業 務的交易量相較於過往年度有所減少。

本公司於本年度錄得溢利約55.3百萬港元 (二零二二年:年度虧損約537.4百萬港 元)。本年度溢利較上一財政年度增加主要 是由於於本年度由業務合併產生的議價購 買確認收益約550.5百萬港元(二零二二年: 無)及於本年度收購一間附屬公司產生的金 融資產減值虧損收回約259.1百萬港元(二 零二二年:無)。

### **MARKET OVERVIEW**

The global market was an ever-changing landscape in 2023. Although the COVID-19 pandemic has come to an end, the global economy remained under its aftermath and unforeseen effects. Hong Kong has experienced volatility in 2023. During the economic downturn, the property market returned to the level of 2018 and the stock market returned to the level of 1997. The decline in the share prices of majority of the shares listed in Hong Kong has shrunk investors' assets and diminish their desire to invest, leading to a continuous slump of turnover. The overall market sentiment has been affected and Hong Kong stocks have continuously slumped in 2023.

#### **Automation Business**

In 2023, the consumer electronic market was weak, and global smartphone shipments declined compared to 2022. This has led manufacturers to be more prudent in their investments in automation equipment. As the economy further recovered, inventory conditions of manufacturers improved and new products were launched, the consumer electronics market has gradually reversed its downturn at a slow and steady pace since the third guarter of 2023. With the gradual perfection of the intelligent manufacturing system, the era of Industrial 4.0 represented by artificial intelligence, big data, 5G and other technologies has arrived. The AI wave will usher in industry innovation and various electronic product manufacturers are actively exploring new opportunities for integration and development of AI large models. The rapidly growing computational power requirements will drive demand for related equipment, and it is expected that the market demand for electronic manufacturing equipment will continue to rise in the future. With the continuous upgrading of industrial structure and the increasing cost of labor, major manufacturing companies are increasingly demanding automation equipment. More manufacturing companies place emphasis on intelligent manufacturing, which has driven the growth in demand for SMT equipment.

### 市場概覽

二零二三年,環球市場形勢風雲變色,儘 管新冠疫情已經結束,全球經濟仍受到疫 情餘波及未能預計的影響。香港於二零 二三年經歷陰晴不定,在經濟不景下,樓 市重返二零一八年的水平,而股市更曾重 返一九九七年的水平。大部分在香港上市 的股票股價下滑,令投資者資產萎縮,投 資意欲減弱,導致成交呈現不斷萎縮的現 象。整體大市氣氛受累,港股於二零二三 年持續下挫。

### 自動化業務

二零二三年,消費電子市場疲弱,全球智 能手機市場出貨量較二零二二年下跌,令 製造廠商對自動化設備投資審慎。由於經 · 濟進一步復甦, 廠商庫存狀況改善及推出 新的產品,消費電子市場自二零二三年第 三季度開始正以緩慢而穩定的速度逐步扭 轉低迷狀態。隨著智能製造體系建設的逐 漸完善,以人工智能、大數據、5G等技術 為代表的工業4.0時代已經到來,AI浪潮 將開啟行業革新,各類電子產品製造廠商 正在積極探索與AI大模型融合發展的新契 機,算力快速增長的需求將帶動對相關設 備的需求,預計未來市場對電子製造設備 的需求仍將持續增長。隨著產業結構不斷 升級以及人工成本越來越高,各大製造企 業對於自動化設備的需求也將越來越高, 越來越多製造企業重視智能製造,推動了 對SMT機器需求的增長。

#### **Property Investment and Development Business**

In 2023, the real estate market in the PRC continued to adjust at the bottom. The Central Government adopted a stable policy before relaxing, with the Politburo's meeting in July serving as a turning point by stating that "there has been a significant shift in the supply and demand in the industry". The policy focus has been gradually shifting towards a combination of support and utilization. In particular, on the demand side, policies such as reducing down payment, lowering interest rates, grant of loans based on buyers' houses and tax refund for deferred housing replacement have successively been implemented to support purchases of properties by mortgage loans. On the supply side, relief measures such as the extension of "16 financial policies", "three no lowers" and the "white list of real estate enterprises" have been introduced to alleviate the liquidity pressure on property enterprises. The relaxation of local policies has accelerated, by loosening policies 622 times in 273 provinces and cities from third- and fourth-tier cities to core first- and second-tier cities, and almost all restrictive administrative measures have been lifted.

The Central Government mentioned the "Three Major Projects" for the first time in 2023, namely planning and construction of affordable housing, renovation of urban villages and public infrastructure for ordinary and urgent uses. The "Three Major Projects" were highlighted at the Politburo's meetings both in April and July 2023. In July 2023, the State Council issued a document to promote the renovation of urban villages, which mainly targeted 22 superand mega-cities with urban population of more than 5 million. In August 2023, the Standing Committee of the State Council considered and approved the "Guiding Opinions on Planning and Construction of Affordable Housing", striving to build a new housing supply pattern of "Ensure rigid demand being satisfied and sufficient supply for housing improvement being available". It specifies that the affordable housing targets at wage earners, and shall be sold based on the pricing principle of capital preservation with moderate profits.

### 物業投資及發展業務

中國房地產市場在二零二三年繼續底部調整。中央政策力度前穩後鬆,以七月的政治局會議定調「行業供需關係發生重大轉變」為分水嶺,政策力度逐漸轉向「托舉並用」。在需求端方面,降首付、降利率、認房不認貸、延期置換退税等政策接連落地,支持居民按揭購房。在供給端方面,續期「金融16條」、「三個不低於」、「房企白名單」等紓困措施相繼提出,緩解房企資金壓力。地方政策鬆綁加力提速,273省市622次政策鬆綁,從三四線到核心一二線反向傳導,限制性行政措施幾乎都已退出。

中央在二零二三年首提「三大工程」,即作 出規劃建設保障性住房、城中村改造及平 急兩用基礎設施三方面重要部署。於二零 二三年四月及七月的兩次政治局會議中均 重點提及「三大工程」。在二零二三年七 月,國務院發文推進城中村改造,主要面 向22個城區人口超500萬的超大特大城市。 在二零二三年八月,國常會審議通過《關於 規劃建設保障性住房的指導意見》,致力於 構建「剛需有保障、改善有商品」的住房供 給新格局,明確保障對象為工薪階層,採 取保本微利定價原則配售。

### **Financial Services Business**

In 2023, the asset management sector is experiencing significant growth in the global financial industry, from actively managed products aiming to achieve market alpha and passive funds like exchange-traded funds (ETFs). The Hong Kong Government took proactive measures to enhance this sector by implementing various measures and revitalizing investment schemes. These initiatives were designed to attract more family offices and high-networth individuals to Hong Kong. It is expected that long-term macro factors, such as the expansion of the capital market, increasing investor awareness and recognition of professional asset management services, and enhanced distribution efforts, will contribute to the continuous growth of the industry.

Looking ahead, the Company wishes that the Hong Kong's economy will get back on track for stable growth. Building a diversified, sustainable and dynamic financing platform has always been the direction of Hong Kong's efforts to enhance its competitiveness. In addition to consolidating and leveraging Hong Kong's advantages as an international financial hub, China's move to expand domestic demand will provide new growth impetus for Hong Kong's economic development.

### **BUSINESS REVIEW**

Established in 2009 and listed on the main board of The Stock Exchange of Hong Kong Limited in December 2010, the Group is principally engaged in the business of automation, property investment and development, financial services and securities investment. Over the past years, the Group has been adhering to its philosophy of "sustainable development and giving back to the community" with its commitment to provide all-rounded quality products and services to maximise return for its shareholders and contribute to the wellbeing of the society. In the face of a challenging business environment, the Group will strive to improve its business planning and operating performance in 2024 to promote its long-term growth.

#### 金融服務業務

於二零二三年,資產管理行業在全球金融 業中經歷顯著成長,從旨在實現阿爾法策 略的主動型管理基金,乃至交易所買賣基 金(ETF)等被動型基金。香港政府積極採取 各種措施,透過實施各種措施及振興投資 計劃以推動行業增長。該等措施旨在吸引 更多家族辦公室及高淨值人士落戶香港。 預計資本市場擴張、投資者對專業資產管 理服務的認識及認知提高、分銷力度加大 等長期宏觀因素將有助行業持續增長。

展望未來,本公司希望香港經濟將重上穩 定增長的軌道。努力建設多元化、可持續 化、活力化的融資平台,一直是香港提升 其競爭力的努力方向。除了繼續鞏固和發 揮國際金融中心的優勢,國家拓展內需市 場還將為香港經濟發展提供新的增長動力。

### 業務回顧

本集團成立於二零零九年,二零一零年 十二月於香港聯合交易所有限公司主板上 市,主要從事自動化、物業投資及發展、 金融服務及證券投資。過去多年來,本集 團秉承「持續發展,回饋社會」的理念,致 力提供全方位的優質產品和服務,既為其 股東爭取最大回報,也致力為社會的福祉 做出貢獻。面對嚴峻的營商環境,本集團 將迎難而上,完善二零二四年的業務規劃 及竭力提升經營業績,以促進本集團之長 遠發展。

### **AUTOMATION BUSINESS**

For the year ended 31 December 2023, the revenue of the automation segment recorded approximately HK\$431.8 million (2022: approximately HK\$574.6 million), representing a decrease of 24.9% over the last year and accounting for approximately 58.3% (2022: approximately 70.8%) of the Group's total revenue. The operating profit decreased by 51.0% to approximately HK\$12.6 million (2022: approximately HK\$25.7 million). The decrease in revenue and operating profit were primarily due to decline in orders of machineries as the China's manufacturing sector is experiencing the impact of post-pandemic and economic uncertainties, thus have a longer delivery cycle of suppliers and a sluggish consumer electronics market.

Gallant Tech Limited ("**Gallant Tech**"), a wholly-owned subsidiary of the Group, focuses on the sales of high-end intelligent manufacturing equipment, such as SMT and semiconductor production equipment, and provides ancillary services for the equipment sold, including technical support and equipment rental. Currently, Gallant Tech is one of the top three major suppliers of SMT production equipment and semiconductor packaging and testing equipment in the PRC market. Gallant Tech's vision is to become a leading supplier of high-end smart manufacturing equipment and solution provider in the electronics manufacturing industry in China, as well as the most trusted partner in smart manufacturing, making smart manufacturing simpler with more added values.

In order to provide customers with world-class intelligent manufacturing equipment and technical services, Gallant Tech's business model will be based on the objective of timely response to the rapidly changing technological environment and customer needs, and adopting the strategy of maintaining product competitiveness and upgrading core technologies, while setting the standards of comprehensively improving product quality, service level and personnel quality. The customers of Gallant Tech are mainly well-known manufacturers in the telecommunications, computer, automotive battery, smart charging station, new energy, integrated circuit and other electronics and information technology industries. The company is the brand agent of ITW MPM printing machines, Koh Young inspection systems and Fuji SMT pick-and-place machines, all of which are top sellers among similar brands in China. Starting from the early days of computers and displays industries, developing into mobile phones and smart home appliances, and now the booming new energy vehicles, 5G, photovoltaic and others, Gallant Tech has accompanied every industrial development and industrial upgrading of China's electronics manufacturing industry. As artificial intelligence continues to expand into peoples' horizons, intelligent and automated production modes will further proliferate deeply into a more extended scope of the electronics manufacturing industry, and the demand for advanced intelligent manufacturing equipment by Chinese enterprises will further increase.

### 自動化業務

截至二零二三年十二月三十一日止年度, 自動化分部錄得收益約431.8百萬港元(二 零二二年:約574.6百萬港元),較上一年 度減少24.9%,佔本集團總收益約58.3% (二零二二年:約70.8%)。經營溢利減少 51.0%至約12.6百萬港元(二零二二年:約 25.7百萬港元)。收益及經營溢利下降乃主 要由於中國製造業正經歷疫情後及經濟不 明朗因素的影響,導致供應商交付周期延 長而消費者電子市場不景氣,使機器訂單 減少。

本集團的全資附屬公司佳力科技有限公司 (「佳力科技」)專注於高端智慧製造設備(如 SMT及半導體生產設備)的銷售,且對於已 銷售設備提供技術支持與設備租賃等配套 服務。目前,佳力科技是中國市場主要的 SMT生產設備及半導體封裝檢測設備的三 大供應商之一。佳力科技的願景是成為中 國電子製造行業領先的高端智慧製造裝備 供應商、解決方案服務商及最值得信賴的 智慧製造合作夥伴,讓智慧製造更簡單、 更具價值。

為了給客戶提供世界級標準的智慧製造設 備和技術服務,佳力科技的業務模式將以 及時應對高速變化的技術環境和客戶需求 為宗旨、以採取保持產品競爭力和提升核 心技術為策略、以綜合提升產品質素、服 務水平、人員素養為標準。佳力科技的客 戶主要為通訊、電腦、汽車電池、智慧充 電站、新能源、積體電路等電子資訊產業 知名製造企業。公司代理的品牌ITW MPM 印刷機、Koh Young檢測設備、Fuji貼片 機均為同類品牌中國銷量第一。從早期的 電腦、顯示器行業起步,發展至手機、智 慧家電行業,再到現在蓬勃發展的新能源 汽車、5G、光伏等行業,佳力科技伴隨著 中國電子製造行業的每一次產業發展與產 業升級。隨著人工智能不斷深入人們的視 野,智慧化、自動化的生產模式將會在更 深層級,更廣領域的電子製造行業內傳播 開來,中國企業對高維度的智慧製造設備 的需求會進一步提升。

Gallant Tech has been closely following every generation in the development of China's electronics manufacturing industry, and has accompanied its suppliers and customers to achieve leapfrog development. With the advent of the Industrial Internet era, the demand and requirements of enterprises for highend intelligent manufacturing equipment are constantly rising. Together with top international partners, Gallant Tech is committed to assist customers in building intelligent factories and help them move towards the era of Industry 4.0 by providing advanced intelligent and automated production equipment as well as digital solutions and customised service solutions.

Looking back to 2023. Gallant Tech has strengthened and improved the development of MES (Manufacturing Execution System) service modules. In the market environment with rapid product update and iteration today, it is increasingly common to see the corporate production mode of multi product varieties, small quantities and short cycles. Against this backdrop, the advantages of MES in manufacturing to improve production efficiency and standardise production process will make the enterprises' production more transparent and production management more efficient. It has become a trend to develop a tailor-made MES according to the industrial form and specific needs of enterprises. To actively respond to this trend, Gallant Tech has set up an MES execution department, and developed the GT LINK MES system at the end of 2023. GT LINK system is a one-stop, integrated system that collects, records and aggregates real-time production data from the customers' workshops by linking up the intelligent equipment that Gallant Tech carries. By consistently improving and developing the GT LINK system, Gallant Tech will provide customers with better customised services and more intelligent solutions for production lines management.

佳力科技緊貼中國電子製造業發展的每一 個時代,伴隨供應商及客戶實現跨越式發 展。隨著工業互聯網時代的到來,企業對 高端智慧製造裝備的需求和要求在不斷提 升,佳力科技將攜手國際頂級合作夥伴, 通過提供先進的智慧化、自動化生產設備 及數位化解決方案、個性化服務方案,致 力協助客戶打造智慧工廠,助力客戶邁向 工業4.0時代。

回顧二零二三年,佳力科技加強與完善了 對於MES(生產執行系統)服務模塊的開 發。在如今產品更新疊代速度飛快的市場 環境中,多品種、小批量、短週期的企業 生產模式越來越常見。在此背景下,MES 在生產製造中所起到的提高生產效率、規 範生產流程等優勢,將使企業的生產製造 更加透明化,生產管理更加高效,針對企 業的產業形態和特殊需求定製開發MES 已成為了一種趨勢。為了積極響應這個趨 勢,佳力科技於二零二三年年底已成立 MES執行部門,且研發出GT LINK MES系 統。GT LINK系統可以將佳力科技所代理 的智慧設備串聯起來,一站式、一體化的 收集、記錄、匯總客戶車間的實時生產數 據。通過對於GT LINK系統的不斷完善與開 發,佳力科技將為客戶提供更卓越的定製 化服務與更具智慧的產線管理方案。

### PROPERTY INVESTMENT AND DEVELOPMENT BUSINESS

For the year ended 31 December 2023, the revenue of the property investment and development segment was approximately HK\$354.7 million (2022: approximately HK\$259.3 million), accounting for approximately 47.9% (2022: approximately 31.9%) of the Group's total revenue. The increase in revenue was mainly due to the increase in scale of property sales made handover to the customers during the Year as compared with those in 2022.

For the year ended 31 December 2023, the operating loss of the property investment and development segment was approximately HK\$249.5 million, compared to the operating loss of approximately HK\$82.4 million recorded in the previous year. The increase of the operating loss was primarily due to the recognition of the write down of inventory properties amounting to approximately HK\$170 million provided during the Year 2023.

### Shenzhen Bangkai Science and Technology Industrial Park Project

Bangkai Science and Technology Industrial Park (formerly known as "Baoxin Science and Technology Industrial Park"), located at Fenghuang Town Industrial Zone in the hinterland of Guangming Science City in Guangming District, Shenzhen, is one of the 18 key development zones in Shenzhen. It is adjacent to Fenghuang Town Station of Metro Line 6 and Guangmingcheng Railway Station, and 1 km away from Guangming Exit of Longda Expressway. Occupying an area of 114,502 square meters and with a total construction area of 547,850 square meters, this project plans to build an industry-city complex integrating science and technology research and development, pilot plant, headquarters base, business office, smart apartment and leisure and business. The project consists of three phases, of which Phases I and II, consisting a total of seven buildings, have been completed, with a total area of 187,199 square meters in property ownership certificates and a rentable area of 187,379 square meters, including office, R&D plant, apartments, hotel and ancillary business. The Phase III of the project is currently under construction, and has been included in the list of major industrial projects in Shenzhen.

### 物業投資及發展業務

截至二零二三年十二月三十一日止年度, 物業投資及發展分部帶來收益約354.7百萬 港元(二零二二年:約259.3百萬港元), 佔本集團總收益約47.9%(二零二二年:約 31.9%)。收益增加主要由於本年度向客戶 移交的物業銷售規模較二零二二年有所增 加。

截至二零二三年十二月三十一日止年度, 物業投資及發展分部產生經營虧損約249.5 百萬港元,而去年錄得經營虧損約82.4百 萬港元。經營虧損增加主要由於二零二三 年確認撇減庫存物業約170百萬港元。

#### 深圳邦凱科技園項目

邦凱科技園(前稱「寶新科技園」)位於深 圳市光明區光明科學城腹地鳳凰城產業片 區,是深圳18個重點發展片區之一,鄰近 地鐵6號線鳳凰城站及光明城高鐵站,距 龍大高速光明出口1公里。項目佔地面積 114,502平方米,總建築面積547,850平 方米,規劃建成集科技研發、中試廠房、 總部基地、商務辦公、智慧公寓、休閒商 業等為一體的產城綜合體。項目分三期 建設,已建成第一及二期共7棟,共計房 產證面積187,199平方米,可出租面積達 187,379平方米。業態包括辦公、研發廠 房、公寓、酒店、配套商業。三期項目正 在建設中,該項目被列入深圳市重大工業 項目名錄。

In 2023, closely focusing on the government's policy orientation, the park, based on the spatial characteristics, actively introduced relevant institutions and enterprises to move in with intelligent manufacturing as the leading industry, and science & technology finance and information service industry as the auxiliary industries. Thanks to superior geographical location and comprehensive industrial supporting services, the park has attracted more than 100 enterprises to move in so far. As of 31 December 2023, the occupancy rate of the project was 94.92%, and there were more than 1,000 customers with various project sizes in various business forms that have moved into the park, including approximately 900 apartments and more than 100 corporate customers, which included 1 company listed on the STAR Market, 14 national high-tech enterprises, 7 small and medium-sized science and technology enterprises and 11 supporting service businesses in Shenzhen.

In 2023, with the efforts of the team, the park achieved satisfactory business performance while also facing some challenges: (1) due to the sluggish property industry and the continuously severe economic situation throughout the year, many customers in the park were affected to different extents; (2) due to the post-epidemic effect and the national policy, the economic development slowed down, and the market demand for properties decreased sharply, thus there were many difficulties in selling out inventories and reserving customers; and (3) the rental prices of properties have decreased due to fierce market competition as a large number of similar properties in the surrounding areas have been introduced to the market.

In response to these difficulties, Bangkai team has taken the following steps, including (1) adopting a flexible rental portfolio policy to strengthen customer stickiness and drive investment promotion by key customers, and the investment promotion personnel took the initiative to preach from door to door, thus speeding up the progress of investment promotion and inventory sold-out; (2) organizing a variety of activities, both online and offline, to promote the project brand image; (3) advancing the education of service awareness of team members to improve the quality of property services in the park, establishing comprehensive information files for enterprises in the park to provide policy interpretation and declaration assistance for them, and assisting many companies to declare rent subsidies of the science and technology innovation industrial park; and (4) through self-built declaration channels and investment introduction, building a multi-dimensional industrial space to meet the needs at different stages from start-up teams, small and micro science and technology enterprises, national high-tech enterprises to intelligent manufacturers.

在二零二三年, 園區緊密圍繞政府政策導向, 依託空間特性, 以智能製造為主導產 業, 以科技金融業、信息服務業為輔助產 業, 積極引入相關機構及企業進駐。憑藉 優越的地理位置及全面的產業配套服務, 目前園區已吸引百餘家企業入駐。截至二 零二三年十二月三十一日, 在出租率方 面, 入住項目的大小及各業態客戶1000餘 家, 其中公寓約900戶、企業客戶1000餘 戶、有科創板上市企業1家、國家高新技術 企業14家、科技型中小企業7家、專精特 新小巨人企業1家、深圳市專精特新中小企 業6家及深圳市創新型中小企業8家及配套 服務業11家。

在二零二三年,在團隊的努力下,園區取 得了理想的經營業績,同時也面臨一些挑 戰,包括(1)由於地產行業萎靡不振,全年 經濟形勢持續嚴峻的影響,園區內諸多客 戶受到不同程度的影響;(2)由於疫情後遺 症及國家政策原因,經濟發展放緩,市場 對物業需求急劇減少,去存化與儲客均有 較大難度;及(3)周邊同類物業大量集中上 市,導致市場競爭激烈,各類物業租賃價 格不漲反降。

面對這些困難,邦凱團隊作出了以下應 對,包括(1)採取靈活的租賃組合政策,加 強客戶粘性,以重點客戶帶動招商,招商 員主動出擊,上門宣講,從而加快招商去 化進度;(2)組織多樣化的線上線下活動以 推廣項目品牌形象:(3)加強團隊員工的 推廣項目品牌形象:(3)加強團隊員工的 服務意識教育,提升園區物業服務品質, 之完善的園區企業信息檔案,為園區企業 提行科技創新產業園;及(4)通過自建申報 與招商引入,構建多維度產業空間,滿巽 智能製造企業的不同階段需求。

### **Ganzhou Real Estate Project**

The Company develops two large-scale comprehensive real estate projects in Ganzhou, Jiangxi, namely Century Plaza and Taigu Plaza. The residential buildings and apartments of the two projects were all sold out. Currently, office buildings and parking lots are available for sale while hotels and office buildings are available for rent. The shopping malls of the two projects, namely Universal Square\* (環球匯) and Joyous Square\* (歡樂匯), are operated by the company in Ganzhou.

In 2023, the main tenants of Ganzhou Century Plaza are in the business forms of hotels, real estate industry, financial industry, department store industry and e-commerce industry. The main operating business forms of Ganzhou Taigu Plaza are commercial buildings and hotels. In terms of investment promotion, Ganzhou team positioned the operation of two business projects in March 2023, and decided to recommence investment promotion and marketing on the premise of cost reduction and efficiency improvement. In 2023, the Universal Square\* (環球匯) and Joyous Square\* (歡樂匯) projects successfully attracted several well-known brands to settle in, recording good business performance and becoming popular comprehensive shopping centres in the local area of Ganzhou.

### **The Shantou Property Project**

In March 2023, the Group completed the acquisition of 51% equity interest in Shantou Taisheng Technology Limited ("**Shantou Taisheng**"). Shantou Taisheng is engaged in the development of a real estate construction project - Shantou Times Bay\* (汕頭時代灣) located at Longhu District, Shantou City, Guangdong Province, the PRC, with a total land area of approximately 167,000 sq.m. and a gross floor area of approximately 951,000 sq.m., which is divided into three zones, and involve office and commercial buildings, residential units and loft apartments.

In 2023, although the Shantou Taisheng team encountered a number of challenges in terms of sales, the team focused on the sales of the existing office buildings in the Southern District of the project. The team also made full efforts to expand to potential customer groups to increase customer sources and develop targeted sales policies to promote sales transactions.

As for business solicitation, the team timely adjusted its policies on new leases, lease renewals and team incentives in accordance with the market situation and customers' circumstances to reduce customers' resistance and facilitate leasing transactions. In addition, the team actively approached the government for assistance to attract enterprises, and explored the upstream and downstream entities to facilitate office leasing transactions through various activities such as segmented marketing activities, revitalizing the business, further broadening the park's business base and attracting more customers flow.

### 贛州房地產項目

本公司於江西省贛州市發展兩個名為世紀 城及太古城的大型綜合性地產項目。兩個 項目的住宅、公寓物業已經全部銷罄,目 前寫字樓、車位在售,酒店、寫字樓出 租,兩個項目的商場(環球匯及歡樂匯)由 贛州公司自營。

在二零二三年,贛州世紀城出租主要客戶 群體業態為酒店、房地產行業、金融行 業、百貨行業及電商行業。贛州太古城現 經營主要業態為商業、酒店。在招商方 面,贛州團隊在二零二三年三月確定兩個 商業項目的經營方向,在降本增效的前 提下,確定重啟招商及推廣。於二零二三 年,環球匯及歡樂匯重點引進多個知名品 牌入駐,業績表現良好,成為贛州當地熱 門綜合購物中心。

### 汕頭房地產項目

本集團於二零二三年三月完成收購汕頭市 泰盛科技有限公司(「汕頭市泰盛」)的51% 股權。汕頭市泰盛於中國廣東省汕頭市龍 湖區從事開發房地產建設項目 - 汕頭時代 灣。該項目總土地面積約16.7萬平方米, 總建築面積約95.1萬平方米,分為三個區 域,涉及辦公及商業建築、住宅單位及閣 樓公寓。

在二零二三年,在銷售方面,汕頭市泰盛 儘管遇到不少挑戰,但團隊聚焦項目南區 寫字樓現樓銷售,發力拓展潛在客戶群 體,增加客戶來源,制定針對性銷售政 策,促進成交。

在招商方面,團隊根據市場態勢及客戶情況,適時調整相應的新租賃、續租、團隊激勵等政策,降低客戶抗性,促成租賃交易。此外,團隊積極接洽政府引進企業,並拓展上下游單位,以圈層活動等多維度 促成寫字樓租賃成交,煥發商務新活力, 進一步豐富園區業態及吸引人流。

The Company also has certain investment properties in Hong Kong for the purpose of leasing. Currently, these properties have no vacancies.

### FINANCIAL SERVICES BUSINESS

The Group provides comprehensive financial services in Hong Kong through its subsidiaries, and has been striving to connect the capital markets onshore and offshore over the years. The Group makes contribution to the economy through financial services and offers all-aspect financial services to its customers based on its operational concept of being stable and innovative.

For the year ended 31 December 2023, the financial services segment netted approximately HK\$38.2 million in revenue (2022: approximately HK\$47.5 million), representing a year-on- year decrease of approximately 19.6% and approximately 5.2% of the Group's total revenue (2022: 5.9%). The operating loss amounted to approximately HK\$70.5 million (2022: approximately HK\$118.4 million).

### **Securities Brokerage Services**

Over the past years, the securities brokerage team is committed to providing more comprehensive professional and convenient services to its clients, including: agency securities trading, margin financing services, placing and underwriting services for listed issuers, financial products business and one-stop integrated investment and financing services for high net-worth clients, etc. The securities brokerage team is committed to providing more comprehensive professional and convenient services to its clients.

During the period under review, the Hong Kong Hang Seng Index (HSI) fell from 19,781 points at the close of 2022 to 17,047 points at the close of 2023, a decline of 13.8%, as the investment market continued to face multiple impacts of rising global interest rates, high inflation and slowing economic growth. The continued downturn in the market has dampened investors' desire to enter the market, resulting in a decrease in the industry's overall commission income. The high cost of capital has also led to a decline in spread income, resulting in a decrease in revenue from the securities brokerage business during the period under review as compared to the same period last year.

#### **Asset Management Services**

Atlantic Asset Management Limited, a wholly owned subsidiary of the Group, manages its own funds and provides investment advisory services to high-net-worth individuals, corporations, and institutional clients in global markets. As at the date of this report, it acts as the investment manager for 2 segregated portfolio company funds which encompass 3 segregated portfolios with total assets under management at around HK\$165 million.

本公司也於香港持有若干投資物業用於出 租,該等物業目前處於空置狀態。

### 金融服務業務

本集團透過附屬公司在香港提供綜合金融 服務,多年來致力於成為連接境內與海外 資本市場的橋樑,以金融服務實體經濟, 秉持穩建創新經營理念為客戶提供全方位 金融服務。

截至二零二三年十二月三十一日止年度, 金融服務分部賺取約38.2百萬港元收益(二 零二二年:約47.5百萬港元),按年減少約 19.6%,相當於本集團總收益約5.2%(二零 二二年:5.9%)。經營虧損約70.5百萬港 元(二零二二年:約118.4百萬港元)。

### 證券經紀服務

過去多年,證券經紀團隊致力為其客戶提 供更為全面專業便捷的服務,包括:代理 買賣證券、提供孖展融資服務、為上市發 行人提供配售與包銷服務、金融產品業務 及為高淨值客戶提供一站式綜合投融資服 務等。

回顧期內,投資市場持續面臨環球利率攀 升、通脹高企及經濟增長放緩等多重打 擊,香港恒指從二零二二年收市的19,781 點跌至二零二三年收市17,047點,跌幅 13.8%。市況持續低迷令投資者入市意欲下 降,行業整體佣金收入減少;資金成本高 漲亦導致息差收入下跌,令回顧期內證券 經紀業務收益較去年同期下跌。

### 資產管理服務

本集團全資附屬公司大西洋資產管理有限 公司管理自有基金,並向全球市場的高淨 值人士、公司及機構客戶提供投資諮詢服 務。於本報告日期,其擔任2個獨立投資組 合公司基金(涵蓋3個獨立投資組合)的投 資經理,資產管理規模約為165百萬港元。

### **Wealth Management Services**

For Year 2023, following the disposal of the subsidiaries operating wealth management business in May 2023, the Group ceased to provide wealth management services (2022: In 2022, the Company provided diversified wealth management service to its client so as to fulfill their different wealth management needs).

### **Money-lending Business**

The Group, through its wholly owned subsidiary, namely Glory Sun Credit Limited ("**Glory Sun Credit**"), engaged in the money lending business primarily on the provision of short-term and long-term share mortgage loans and property mortgage loans to customers in Hong Kong under the Money Lenders Ordinance (Cap. 163) (the "**MLO**").

In light of the challenging economic and property environment, Glory Sun Credit has adopted stringent credit control to conduct its share mortgage loan and property mortgage loan business to reduce associated credit risks. As at 31 December 2023, the overall weighted average loan-to- value ratio of its loan portfolio was at 68.0% (2022: 95.4%).

### **Compliance with Ordinances and Regulations**

Glory Sun Credit has strictly complied with all relevant laws and regulations. The MLO and the Anti-Money Laundering and Counter-Terrorist Financing Ordinance (Cap. 615) (the "**AMLO**") have a significant influence on the money lending business during the current year.

The MLO acts as the principal ordinance governing the money lending business in Hong Kong while the AMLO governs the matters in relation to the money laundering and terrorist financing. During the current year, Glory Sun Credit did not receive any objection from the Registrar of Money Lenders (the "**Registrar**") nor the Commissioner of Police regarding the renewal of the money lenders licence. Glory Sun Credit has also established policies and procedures to strictly follow the Guideline on Compliance of Anti-Money Laundering and Counter-Terrorist Financing Requirements for Licensed Money Lenders (the "**AML-CTF Guideline**") issued by the Registrar for the money lending business operations to mitigate the risks of money laundering and terrorist financing.

To the best of its knowledge, Glory Sun Credit has complied with the MLO and AMLO in all material aspects, and that it is not aware of any matter that might come to its attention that the money lenders licence would be suspended, terminated or would not be renewed in foreseeable future.

### 財富管理服務

於二零二三年,隨著於二零二三年五月出 售經營財務管理服務之附屬公司,本集團 不再提供財富管理服務(二零二二年:於 二零二二年,本公司為客戶提供多元化的 財富管理服務,以滿足不同客戶之理財要 求)。

### 放貸業務

本集團透過其全資附屬公司寶新信貸有限 公司(「**寶新信貸**」)從事放貸業務,主要為 根據香港法例第163章《放債人條例》(「**放債** 人條例」)向香港客戶提供短期及長期股份 按揭貸款及物業按揭貸款。

鑑於經濟及樓市環境充滿挑戰,寶新信貸 採取嚴格的信貸控制進行其股份按揭貸款 及物業按揭貸款業務,以減低相關信貸風 險。於二零二三年十二月三十一日,其貸 款組合的整體加權平均貸款價值比率為 68.0%(二零二二年:95.4%)。

### 遵守條例及規例

寶新信貸嚴格遵守所有相關法例及規例。 放債人條例及香港法例第615章《打擊洗錢 及恐怖分子資金籌集條例》(「打擊洗錢條 例」)對本年度的放貸業務有重大影響。

放債人條例是規管香港放貸業務的主要條 例,而打擊洗錢條例則規管洗錢及恐怖分 子資金籌集的相關事宜。於本年度,寶新 信貸並無就續領放債人牌照遭放債人註冊 處處長(「處長」)或警務處處長反對。寶新 信貸亦已制定政策及程序,嚴格遵守處長 就經營放債業務發佈的《持牌放債人遵從打 擊洗錢及恐怖分子資金籌集規定的指引》, (「打擊洗錢及恐怖分子資金籌集的風險。

就其所深知,寶新信貸已在所有重大方面 遵守放債人條例及打擊洗錢條例,且其並 不知悉放債人牌照將於可見將來遭吊銷、 終止或不予重續而可能需提請其注意的任 何事宜。

### **Business Model and Loan Portfolios**

Glory Sun Credit mainly offers share mortgage loans and property mortgage loans.

For share mortgage loans, Glory Sun Credit granted secured loans to customers and held collaterals against loan receivables in the form of mortgages over listed shares owned by these customers. All of these collaterals were listed in Hong Kong. The gross share mortgage loans receivable was accounted for approximately 64.1% of the entire gross loan receivable of Glory Sun Credit as at 31 December 2023 (2022: 15.4%). The interest rates of the share mortgage loans, mainly determined with reference to factors such as the quality and liquidity of the collaterals provided by the customers, loan-to-value ratios, loan amounts, tenors, and customers' net worth, ranged from 8.0% to 18.0% (2022: 8.0% to 18.0%).

For property mortgage loans, Glory Sun Credit granted secured loans to customers and held collaterals against loan receivables in the form of mortgages over properties owned by these customers. All of these collaterals were located in Hong Kong, of which more than 34.0% of them were residential properties. The gross property mortgage loans receivable was accounted for approximately 32.6% of the entire gross loan receivable of Glory Sun Credit as at 31 December 2023 (2022: 5.3%). The interest rates of the property mortgage loans, mainly determined with reference to factors such as the quality, type and location of the collaterals provided by the customers, type of mortgages, loan-to-value ratios, loan amounts, tenors, and customers' net worth, ranged from 6.0% to 9.5% (2022: 9.5% to 9.5%).

During the current year, the customers comprised individuals and corporations in Hong Kong and were all independent third parties (within the meaning of Chapter 14A of the Listing Rules).

As at 31 December 2023, Glory Sun Credit had 7 (2022: 6) active accounts, of which 3 (2022: 1) of them were individual customers and the remaining of 4 (2022: 5) were corporate customers; and of which 3 (2022: 2) of them were share mortgage loan customers and 3 (2022: 1) of them were property mortgage loan customers.

During the current year, the top five customers (as determined by interest income generated) accounted for approximately 99.8% (2022: 97.8%) of the total revenue of the Group, and the single largest customer accounted for approximately 79.1% (2022: 85.5%) of the total revenue.

### 業務模式及貸款組合

寶新信貸主要提供股份按揭貸款及物業按 揭貸款。

就股份按揭貸款而言, 寶新信貸向客戶授 出有抵押貸款,並以就該等客戶所擁有的 上市股份設置按揭抵押的形式持有應收貸 款的抵押品。所有該等抵押品均於香港上 市。於二零二三年十二月三十一日,應收 股份按揭貸款總額佔寶新信貸全部應收貸 款總額約64.1%(二零二二年:15.4%)。 股份按揭貸款的利率主要參考客戶提供抵 押品的質素及流通性、貸款價值比率、貸 款金額、期限及客戶淨值等因素釐定,介 乎8.0%至18.0%(二零二二年:8.0%至 18.0%)。

就物業按揭貸款而言,寶新信貸向客戶授 出有抵押貸款,並以就該等客戶所擁有的 物業設置按揭抵押的形式持有應收貸款的 抵押品。所有該等抵押品均位於香港,其 中34.0%以上為住宅物業。於二零二三 年十二月三十一日,應收物業按揭貸款總 額佔寶新信貸全部應收貸款總額約32.6% (二零二二年:5.3%)。物業按揭貸款的利 率主要參考客戶提供抵押品的質素、類型 及位置、按揭類別、貸款價值比率、貸款 金額、期限及客戶淨值等因素釐定,介乎 6.0%至9.5%(二零二二年:9.5%至9.5%)。

於本年度,客戶包括香港的個人及公司, 且均為獨立第三方(定義見上市規則第14A 章)。

於二零二三年十二月三十一日,寶新信貸 擁有7個(二零二二年:6個)活躍賬戶,其 中個人客戶3名(二零二二年:1名),其餘 4名(二零二二年:5名)為公司客戶;股份 按揭貸款客戶3名(二零二二年:2名),物 業按揭貸款客戶3名(二零二二年:1名)。

於本年度,五大客戶(按所產生的利息收入 釐定)佔本集團總收入約99.8%(二零二二 年:97.8%),單一最大客戶佔總收入約 79.1%(二零二二年:85.5%)。

As at 31 December 2023, the largest and top five customers (as determined by loan receivable balance) of the total gross loan receivables balance accounted for 50.8% (2022: 77.3%) and 95.6% (2022: 99.8%) respectively.

### **Credit Approval Processes and Credit Risk Assessment Policies**

All information and data provided by customers for loan applications will have to go through credit assessment and approval procedures in accordance with credit risk policies.

Prior to the acceptance of any loan application submitted by customers, Glory Sun Credit will carry out know-your-customer procedures ("**KYC procedures**") to verify the identities of customers and assess the credit risk associated with these customers by referring to documents, data and information available from reliable and independent sources, such as government and public authorities. It will also assess the risk of money laundering and terrorist financing associated with the customers in accordance with its established policy and the AML-CTF Guideline.

Glory Sun Credit will verify the ownership of the collaterals provided by the customers and confirm if there is any incumbency on them.

With reference to the application information and the results of the KYC procedures, the credit team would make recommendations to the management on the proposed terms of the loan. Here are the main factors being taken into consideration during the loan approval stage:

- (i) For property mortgage loan applications
  - the quality, type and location of the properties provided by customers as collaterals;
  - type of mortgages (i.e. first mortgage or second mortgage);
  - loan-to-value ratios;
  - loan amounts;
  - tenors; and
  - customers' net worth.
- (ii) For share mortgage loan applications
  - the quality and liquidity of the collaterals provided by customers;
  - loan-to-value ratios;
  - loan amounts;
  - tenors; and
  - customers' net worth.

#### 信貸審批程序及信貸風險評估政策

客戶所提供有關貸款申請的所有資料及數 據均須根據信貸風險政策進行信貸評估及 審批程序。

在受理客戶提交的任何貸款申請之前,寶 新信貸將執行了解客戶程序(「**了解客戶程 序**」),參考從可靠、獨立的來源(如政府及 公眾主管機關)所獲得的文件、數據及資 料,核實客戶身份並評估該等客戶的相關 信貸風險。寶新信貸亦將根據其既定政策 及打擊洗錢及恐怖分子資金籌集指引評估 與客戶相關的洗錢及恐怖分子資金籌集風 險。

寶新信貸將核實客戶所提供抵押品的所有 權,並確認其是否有任何產權負擔。

信貸團隊將參考申請資料及了解客戶程序 的結果,就貸款的擬議條款向管理層提出 推薦建議。於貸款審批階段將考慮的主要 因素如下:

- (i) 物業按揭貸款申請
  - 客戶所提供作為抵押品的物業 的質素、類型及位置;
  - 按揭類別(即首次按揭或二次按 揭);
  - 貸款價值比率;
  - 貸款金額;
  - 期限;及
  - 客戶淨值。
- (ii) 股份按揭貸款申請
  - 客戶所提供抵押品的質素及流 通性;
  - 貸款價值比率;
  - 貸款金額;
  - 期限;及
  - 客戶淨值。

#### **Loan Impairment Assessment**

The Group has developed policies and procedures to appropriately assess and measure the expected credit loss ("**ECL**") in accordance with impairment requirements of HKFRS 9. Details of the movement of provision for impairment and written-off of loan and interest receivables are disclosed in Note 23.

### **SECURITIES INVESTMENT**

The Group has been investing in listed shares in Hong Kong, the PRC and foreign countries and adjusting its investment strategy to ensure that it is sufficiently prudent to cope with the uncertainties in the financial market. For the year ended 31 December 2023, the securities investment business generated a loss of approximately HK\$84.4 million (2022: approximately HK\$70.0 million). The operating loss of the segment amounted to approximately HK\$86.1 million (2022: approximately HK\$71.2 million).

### **OTHER INVESTMENTS**

As at 31 December 2023 and 31 December 2022, the Company held 32% equity interest in Yunnan International Holding Group Limited, an associate principally engaged in the business of clean energy, health, investment management, new energy and financial services. Through the cooperation with the shareholders of the associate, the Company vigorously participated in the strategic construction brought by The Belt and Road Initiative.

### PROSPECT

Looking ahead to 2024, following the pace of global economic recovery in the post-epidemic era, the Company will shift the focus of industrial development from quantitative to qualitative growth, seeking innovation while maintaining stability, and supporting the country's development direction of new productive forces. The Company will actively and steadily promote the development of its various business segments to maintain Hong Kong's unique status as an international financial center.

### 貸款減值評估

本集團已制定政策及程序,以根據香港財 務報告準則第9號的減值規定適當評估及計 量預期信貸虧損(「預期信貸虧損」)。應收 貸款及利息減值撥備及撇銷之變動於附 註23披露。

### 證券投資

本集團一直以來投資在香港、中國及外國 上市的股份,且一直調整投資策略,確保 以十分謹慎的態度應對金融市場不明朗因 素。於截至二零二三年十二月三十一日止 年度,證券投資業務產生虧損約84.4百萬 港元(二零二二年:約70.0百萬港元)。該 分部的經營虧損約為86.1百萬港元(二零 二二年:約71.2百萬港元)。

### 其他投資

於二零二三年十二月三十一日及二零二二 年十二月三十一日,本公司持有雲能國際 控股集團有限公司32%的股權,雲能國際 為一家主要從事有關潔淨能源、健康、投 資管理、新能源及金融服務業務的聯營公 司。透過與聯營公司股東的合作,本公司 積極參與[一帶一路]戰略建設。

### 展望

展望二零二四年,跟隨著后疫情時代全球 經濟復蘇的步伐,公司產業發展重心將由 量變轉為質變,在穩健中尋求創新,擁護 國家提出的新質生產力發展方向。積極穩 步推進公司各類業務板塊的發展,維護香 港國際金融中心的獨特地位。

### **Prospects of Automation Business**

The automation segment has been providing automation manufacturing devices and services for the industries of smartphones, Internet of Things, semi-conductors, automobile electronics in the PRC. The application of automation manufacturing equipment, including SMT production equipment, in key industries in the PRC is still in the rising stage of development. Following the gradual sophistication of 5G application business regimes together with the accelerating progress proposed by China in terms of the new infrastructure facilities construction as representative of 5G, Artificial Intelligence, Industrial Internet and Internet of Things, there will be a new source of vitality to benefit the development of the automation segment.

To enhance sales revenue and market competitiveness, the Company will further enrich its product portfolio by continuing to develop new products in terms of semiconductor equipment, other automation equipment and related materials. It will also seek to obtain more authorisations to act as suppliers' agent. Considering the increasing number of manufacturing clients establishing production bases overseas, the Company will conduct business with a global mindset and implement overseas market strategies in a timely manner. In terms of overseas market expansion, the Company will follow the footsteps of its clients to align with their overseas market layouts and provide long-term service planning.

The Company will focus on leveraging its core strengths, combining market demand with technological development trends, and strategically positioning itself in business areas with growth potential. It aims to create competitive new products and services to meet the diverse needs of customers. By enhancing its R&D capabilities and strengthening collaborations with intelligent manufacturing industry partners, the Company will gradually transform from a distribution-based enterprise to a technology manufacturing enterprise.

### Prospects of Property Investment and Development Business

In 2024, the Bangkai Science and Technology Industrial Park will focus on investment promotion and payment collection, striving to improve the overall occupancy rate and collection rate of receivables of the properties and speed up the construction of Phase III. In terms of industries, by closely following the government policy guidance, the park will continue to focus on dominant industries, introduce national high-tech enterprises with better quality and specialised new enterprises, and improve the total output value of the park, as well as strengthen the service quality of the park, so as to further enhance the property brand value of the park.

### 自動化業務的展望

自動化分部一直為中國智慧手機、物聯 網、半導體、汽車電子等行業提供自動化 製造裝備及服務。包括SMT生產設備在內 的自動化製造設備在中國的主要應用產業 仍處於發展的上升期,隨著5G應用商業模 式日漸成熟,加上中國提出加快以5G、人 工智慧、工業互聯網、物聯網為代表的新 型基礎設施建設進度,將為自動化分部發 展帶來新動力。

為提升銷售收入和市場競爭力,本公司將 進一步豐富產品結構,在半導體設備、其 它自動化設備及相關材料方面繼續開發新 的產品,增加供應商代理授權資格。鑒於 越來越多的製造業客戶於海外設立生產基 地,本公司將以全球化的思維開展業務, 適時實施海外市場策略。在海外市場的拓 展,本公司採取跟隨客戶出海步伐的策 略,配合客戶在海外市場進行佈局,提供 服務的長期規劃。

本公司將注重發揮自身的核心優勢,結合 市場需求和技術發展趨勢,選擇具有發展 潛力的業務領域進行佈局,打造具有競爭 力的新產品和服務,滿足客戶的多元化需 求。通過提升自身研發能力及與智能製造 業合作夥伴加強合作,逐步從分銷型企業 向科技製造企業轉型。

### 房地產投資及開發業務的展望

邦凱科技園在二零二四年將重點抓招商及 回款,力爭提升物業整體出租率及應收回 款率,同時加快三期項目建設。園區產業 方面將緊跟政府政策導向,繼續聚焦主導 產業,引入更加優質的國高企業及專精特 新企業,提升園區總產業產值,加強園區 服務品質,進一步提升園區的物業品牌價 值。

In 2024, the Ganzhou project will adjust the policy on office sales in a timely manner in accordance with market conditions, increase efforts to expand office customers and seek the overall underwriting of office buildings and the sales of hotels in Ze Feng Biz Hub\* (澤豐中心). In terms of parking space sales, the policies in relation to sales of parking space will be adjusted, and preferential sales policies will be released in due course, to promote some wait-and-see buyers to make deals. In the commercial sector, Ganzhou team will focus on building the characteristics of the ancient tree plaza of the Universal Square\* (環球匯) to differentiate the competing projects, making the project form a customer gathering effect and extend to the surrounding shops, so as to drive the mobility of customers all over the project. It will also adjust investment promotion direction and business planning in line with the market, and introduce large-scale children play and catering companies to move in, enhancing the business atmosphere of the project.

In 2024, the Shantou project will focus on the two major objectives of sales and timely delivery of completed buildings, concentrating in the sales of existing buildings, and making every effort to optimise sales and deliver buildings. The team will expand new sales in the Southern District through multiple channels, with the whole team focusing on exploring partners from occupied units whose upstream and downstream connections may provide opportunities for transactions, as well as expedite the progress of large transactions and new transactions related to existing customers. As for the business solicitation team, they will focus on broadening the customer pipeline, taking measures including (1) actively participating in renewing the tenders with existing major customers and government customers and secure contract renewal; (2) releasing project product information and policy advantage to tap potential customers; (3) improving market tracking and policy updates to timely adjust the investment promotion direction and strategy; and (4) increasing the number of events in the park to enhance the sense of belonging of the resident enterprises and to facilitate the increase in the ratio of bringing in new customers from existing occupants.

#### **Prospects of Financial Services Business**

Notwithstanding the uncertainties plaguing the global economic outlook, the Group's securities brokerage team will continue to capitalise on the opportunities brought about by the economic recovery in the financial markets in 2024 proactively, and continue to optimise the trading experience of its clients in order to enhance the competitiveness of its market segments. At the same time, the securities brokerage team will adhere to its prudent approach in reviewing its financing services and adopting appropriate strategies to minimise downside risks, with a view to maintaining stable business development.

汕頭項目在二零二四年將圍繞加大銷售和 保交樓兩大目標,重點消化現樓銷售,全 力以赴做好銷售及交樓工作。團隊將多管 道拓展南區新增銷售,團隊全員上陣, 對挖掘合作夥伴、已入駐單位上下游關 單位成交可能,加快大宗交易進程以及 帶新成交。招商團隊則重點拓寬客大型。 帶新成交。招商團隊則重點拓寬客戶續 簽;(2)釋放項目產品資訊及政策利好, 挖掘潛在客戶;(3)完善市場跟蹤及政策利 類區運營活動,提升入駐企業歸屬感,提 升老帶新比例。

### 金融服務業務的展望

儘管有多個不明朗因素困擾環球經濟前 景,本集團的證券經紀團隊在二零二四年 將繼續積極把握經濟復蘇為金融市場帶來 的機遇,持續優化客戶交易體驗,以提升 其市場板塊競爭力。同時證券經紀團隊將 堅守其審慎的方針,審視其融資服務並採 取適當策略減低下行風險,致力維持穩定 的業務發展。

In 2024, under the macro-environment of accelerating global market integration and constant geopolitical events, the asset management team of the Company will continue to adopt scientific and rational investment analysis strategies to screen investment targets in the global market and evaluate their investment value, and implement rebalancing strategies for major assets based on regional market characteristics. The Company will continue to rely on the advantages of Hong Kong as an international financial center to focus on investment opportunities in the Greater China region.

In 2024, the Group will continue to capture the development opportunities and strive to create better returns to its shareholders.

### **FINANCIAL REVIEW**

The total liabilities of the Group as at 31 December 2023 increased by 60.6% to approximately HK\$4,543.9 million due to the acquisition of a subsidiary during the Year (2022: approximately HK\$2,829.1 million). The gearing ratio, which is calculated at borrowings divided by net assets value was decreased to 24.3% (2022: 27.6%).

#### Revenue

The Group's revenue for the year ended 31 December 2023 decreased by approximately 8.8% (2022: 69.0%) to approximately HK\$740.3 million (2022: approximately HK\$811.4 million). The revenue analysis by segment is presented as follows:

During the year, automation and property investment and development segments were the major source of revenue for the Group, accounting for approximately 58.3% (2022: 70.8%) and approximately 47.9% (2022: 31.9%) of total revenue, respectively.

#### Gross Profit and Margin

The gross profit for the year has decreased by approximately 23.9% to approximately HK\$138.6 million (2022: approximately HK\$182.2 million), while the gross profit margin decreased to 18.7% (2022: 22.5%). The change was mainly due to the increase in competition of automation segment and property investment and development segment in the Year which narrows the gross margin achievable as compared with those in 2022.

#### Other Loss/Gains - Net

The net other loss during the year was approximately HK\$7.4 million (2022: the net other gains during the year was approximately HK\$53.8 million), which was mainly due to decrease of recovery of bad debt written off in prior years amounting to approximately HK\$53.3 million during the Year 2022.

#### **Other Income**

The other income decreased by approximately 71.2% to approximately HK\$15.2 million (2022: approximately HK\$52.8 million) due to the decrease in sundry income from approximately HK\$49.5 million in 2022 to approximately HK\$12.1 million in 2023.

#### **Distribution Costs**

The distribution costs decreased by approximately 2.9% to approximately HK\$20.1 million (2022: approximately HK\$19.6 million), accounting for 2.7% (2022: 2.4%) of the total revenue. There was no significant fluctuation comparing with last year.

#### Administrative Expenses

The administrative expenses decreased by approximately 25.3% to approximately HK\$244.6 million (2022: approximately HK\$327.4 million), mainly due to the written off of loans and advance has dropped by HK\$53 million and foreign exchange loss has dropped by HK\$38 million comparing between two years.

#### Finance Costs – Net

The net finance costs during the Year 2023 was approximately HK\$31.1 million (2022: net finance income of approximately HK\$41.5 million). The increase in net finance costs was because of the decrease in interest income on financial assets at amortised cost of approximately HK\$112.2 million in the Year 2022

#### 毛利及毛利率

其他收入減少約71.2%至約15.2百萬港元 (二零二二年:約52.8百萬港元),乃由於 雜項收入由二零二二年約49.5百萬港元減 少至二零二三年約12.1百萬港元。

#### 分銷成本

分銷成本減少約2.9%至約20.1百萬港元(二 零二二年:約19.6百萬港元),佔總收益的 2.7%(二零二二年:2.4%)。與去年相比並 無大幅波動。

#### 行政費用

行政費用減少約25.3%至約244.6百萬港元 (二零二二年:約327.4百萬港元),乃主要 由於兩年間撇銷貸款及墊款減少53百萬港 元以及匯兑虧損減少38百萬港元所致。

#### 財務成本一淨額

於二零二三年,財務成本淨額約31.1百萬 港元(二零二二年:財務收入淨額約41.5百 萬港元)。財務成本淨額增加的原因是按攤 銷成本計量的金融資產的利息收入於二零 二二年減少約112.2百萬港元。

#### Income Tax Expense

During the year ended 31 December 2023, the Group recorded an income tax expense of approximately HK\$12.8 million (2022: approximately HK\$29.4 million) which was mainly due to the decrease in taxable profits for the Year.

#### Profit/Loss Attributable to Owners of the Company

For the year ended 31 December 2023, the Company recorded a profit attributable to the owners of the Company of approximately HK\$102.5 million (2022: loss of approximately HK\$551.5 million).

### FINANCIAL RESOURCES REVIEW

#### **Liquidity and Financial Resources**

By adopting a prudent financial management approach, the Group continued to maintain a healthy financial position. As at 31 December 2023, the Group's cash and cash equivalents of approximately HK\$562.3 million (2022: approximately HK\$486.3 million). The working capital represented by net current assets amounted to approximately HK\$1,985.7 million (2022: approximately HK\$1,051.1 million). The current ratio was approximately 1.6 (2022: approximately 1.4). The gearing ratio, which is calculated at borrowings divided by net asset value, was 24.3% (2022: 27.6%).

The borrowings of the Group as at 31 December 2023 included corporate bonds of approximately HK\$313.0 million (2022: approximately HK\$341.0 million), trust receipt loans of approximately HK\$nil (2022: approximately HK\$8.8 million) and bank loans of approximately HK\$422.8 million (2022: approximately HK\$966.2 million), and other loans of approximately HK\$987.6 million (2022: approximately HK\$92.5 million).

The borrowings as at 31 December 2023 were secured by (i) guarantees provided by the Company, shareholder of the Company, certain of its subsidiaries and related parties; (ii) property, plant and equipment of approximately HK\$198.3 million (2022: approximately HK\$199.6 million); (iii) investment properties of approximately HK\$1,832.5 million (2022: approximately HK\$1,749.3 million); and (iv) pledged bank deposit of approximately HK\$237.8 million (2022: HK\$nil).

藉採取審慎的財務管理方針,本集團繼續 維持健康的財政狀況。於二零二三年十二 月三十一日,本集團的現金及現金等價 物約為562.3百萬港元(二零二二年:約 486.3百萬港元)。流動資產淨額所反映的 營運資金約1,985.7百萬港元(二零二二年:約1,051.1百萬港元)。流動比率約1.6(二 零二二年:約1.4)。根據借貸除以資產淨 值計算的資產負債比率是24.3%(二零二二 年:27.6%)。

本集團於二零二三年十二月三十一日的借 貸包括公司債券約313.0百萬港元(二零 二二年:約341.0百萬港元)、信託收據 貸款約零港元(二零二二年:約8.8百萬港 元)、銀行貸款約422.8百萬港元(二零二二 年:約966.2百萬港元)及其他貸款約987.6 百萬港元(二零二二年:約92.5百萬港元)。

### **Capital and Other Commitments**

As at 31 December 2023, the Group had contracted but not provided for capital commitments of approximately HK\$215.2 million, HK\$3,585.1 million and HK\$1,255.0 million relating to the investment in an associate and investment properties and property development expenditures and the second tranche acquisition payment of the equity interest of Shantou Taisheng, respectively (2022: approximately HK\$215.2 million and HK\$424.1 million relating to the investment in an associate and investment properties and property development expenditures, respectively).

#### **Currency Exposure and Management**

During the year, the Group's receipts were mainly denominated in Hong Kong dollars, Renminbi ("**RMB**"), and US dollars. The Group's payments were mainly made in Hong Kong dollars, RMB and US dollars.

As the business activities of the Group's automation and property investment and development segments were mainly conducted in the mainland China, most of the Group's labour costs and manufacturing overheads were settled with the RMB. As such, fluctuation of the RMB exchange rate will have an impact on the Group's profitability. The Group will closely monitor movements of the RMB and, if necessary, consider entering into foreign exchange forward contracts with reputable financial institutions to reduce potential exposure to currency fluctuations. During the year, the Group did not enter into any foreign exchange forward contract.

## Future Plans for Capital Investment and Expected Source of Funding

The Group finances its operating and capital expenditures mainly by internal resources such as operating cash flow and shareholders equity and bank facilities. The Group expects to have sufficient resources and banking facilities to meet its capital expenditure and working capital requirement.

由於本集團自動化及物業投資及發展分部 的業務活動主要在中國內地進行,故本集 團大部分勞工成本及製造費用均以人民幣 結算。因此,人民幣匯率波動將影響本集 團的盈利能力。本集團將密切監察人民幣 走勢,並在有需要時考慮與信譽良好的金 融機構訂立外匯遠期合約,以減低貨幣波 動的潛在風險。於年內,本集團並無訂立 任何外匯遠期合約。

### 未來資本投資計劃及預期資金來源

本集團的經營及資本開支主要透過營運現 金流及股東權益等內部資源及銀行融資提 供資金。本集團預期會有充裕資源及銀行 融資來應付其資本開支及營運資金需要。

#### Fund raising for future business development

When the Group considers that there are funding needs for the expansion of its businesses and development of new businesses, it will explore possible fund raising methods, such as debt financing, placing of new shares or issuance of corporate bonds.

#### **Employees and Remuneration Policy**

As at 31 December 2023, the Group had 406 (2022: 292) full-time employees in Hong Kong and the PRC. Employees' remuneration is determined in accordance with individual's responsibility, competence and skills, experience and performance as well as market pay level. Staff benefits include medical insurance, provident funds and other competitive fringe benefits.

To provide incentives or rewards to the staff, the Company adopted a share option scheme on 2 June 2020 and share options will be granted to eligible employees in accordance with the share option scheme.

# USE OF PROCEEDS FROM SHARE SUBSCRIPTION IN JULY 2019

On 10 July 2019, the Company entered into a subscription agreement with Bao Xin Development Limited (the "**BXD**"), in relation to the subscription of 4,000,000,000 new shares of the Company (the "**Share(s)**") at a subscription price of HK\$0.25 per Share (the "**BXD Share Subscription**"). Please refer to the announcement of the Company dated 10 July 2019 and the circular of the Company dated 10 October 2019 (the "**2019 Circular**") for more details regarding the BXD Share Subscription.

The placing shares will be allotted and issued pursuant to the general mandate approved in the annual general meeting in June 2022. On 22 March 2023, the Company issued and allotted 310,624,390 new Shares to the Placees and received proceeds of approximately HK\$105.6 million. The net proceeds of the Placing were approximately HK\$104.4 million, approximately 90% of which will be applied for the repayment of maturing indebtedness and the rest will be applied as general working capital of the Group.

As at the date of this report, the net proceeds of approximately HK\$104,412,293 have been fully utilised as intended.

## USE OF PROCEEDS FROM SHARE SUBSCRIPTION IN APRIL 2023

On 20 April 2023, the Company entered into a subscription agreement with China Grand Developments Limited ("**China Grand**") in relation to the subscription of 800,000,000 new shares of the Company at a subscription price of HK\$0.281 per Share (the "**China Grand Share Subscription**"). Please refer to the announcement of the Company dated 20 April 2023 and the circular of the Company dated 2 June 2023 for more details regarding the China Grand Share Subscription.

On 26 July 2023, the Company issued and allotted 800,000,000 new Shares to China Grand and received proceeds of HK\$224.8 million. The net proceeds of the China Grand Share Subscription were approximately HK\$224.7 million, approximately 90% of which will be applied for the repayment of maturing indebtedness and the rest will be applied as general working capital of the Group. The net proceeds designated for general working capital will be utilised for the (i) distribution costs of the Group including but not limited to staff costs, advertising, promotion and exhibition expenses and (ii) administrative expenses of the Group including but not limited to utilities expenses.

As at the date of this announcement, out of the net proceeds of HK\$224.7 million from the China Grand Share Subscription, the amount of approximately HK\$134.0 million and HK\$8.6 million, dedicated to the repayment of maturing indebtedness and general working capital of the Group, respectively, remained unutilised. As at the date of this announcement, no option had been granted by the Company under the Share Option Scheme.

### **KEY RISKS AND UNCERTAINTIES**

The Group's financial conditions, results of operations, businesses and prospects may be affected by a number of risks and uncertainties. The key risks and uncertainties identified by the Group are discussed in this section. There may be other risks and uncertainties in addition to those illustrated below, which are not known to the Group or which may not be material now but could become material in the future. Furthermore, risks can never be eliminated completely due to the inherent limitations in measures taken to address them. Nevertheless, risks may be accepted for strategic reasons or if they are deemed not cost-effective to mitigate.

### **Operational Risk**

Operational risk is the risk of financial loss or reputational damage resulting from inadequate or failed internal processes, people and systems. Responsibility for managing the Group's operational risks rests with every function at both divisional and departmental levels.

Key functions in the Group are guided by standard operating procedures, limits of authority and a reporting framework. The Group will identify and assess key operational exposures and report such risk issues to the senior management as early as possible so that appropriate risk responses can be taken.

### 主要風險及不確定因素

本集團的財務狀況、經營業績、業務和前 景可能受到一些風險和不確定因素的影 響。本集團將討論已識別的主要風險和不 確定因素。除下文所列明者外,可能還存 在其他風險和不確定因素,本集團尚未悉 知該等風險和不確定因素,或者彼等現在 可能並非重大的,但日後可能為重大。此 外,由於解決這些問題所採取的措施的 固有局限性,永遠不能完全消除風險。然 而,倘認為減輕風險不具成本效益,風險 可能由於戰略原因而被接受。

### 操作風險

操作風險是由於內部流程、人員和系統不 適當或失效而導致的財務損失或聲譽損失 的風險。本集團管理操作風險的責任在於 分支及部門層面的每項職能。

本集團的主要職能由標準操作程序、權限 限制和報告框架指導。本集團將識別及評 估關鍵業務風險,並儘早向高級管理層報 告此類風險問題,以便採取適當的風險應 對措施。
### MANAGEMENT DISCUSSION AND ANALYSIS 管理層討論及分析

### **Industry Risk**

The financial services business of the Group is subject to extensive regulations. Among others, operating subsidiaries such as Glory Sun Securities Limited and Atlantic Asset Management Limited are obliged to operate in accordance with the Securities and Futures Ordinance (Cap. 571) (the "**SFO**"). The Group is required to ensure consistent compliance with all applicable laws, regulations and guidelines and satisfy the relevant regulatory authorities that it remains fit and proper to be licensed. If there is any change or tightening of relevant laws, regulations and guidelines, the Group will face a higher compliance requirement for its business activities. In addition, if the Group fails to comply with the applicable rules and regulations from time to time, it may face fines or restrictions on its business activities or even suspension or revocation of some or all of its licenses for operating the financial services business. Furthermore, the financial services business, like all other businesses of the Group, is not immune from market changes. Any downturn in the financial market may also adversely affect the financial services business of the Group.

The automation business of the Group operates in a highly competitive environment. The Group faces fierce competition from global technology companies and rapid technological changes which may render technologies developed and employed by the Group obsolete. As such, the Group's products may lose its competitiveness, adversely affecting the Group's ability to maintain its market share. Failure to maintain the Group's competitive position may lead to a material adverse effect on the results and profit margins of these business segments. Furthermore, the current trade war between the PRC and the US may have an impact on the business environment in the PRC. The Group is prepared to pay close attention to market conditions and will establish a contingency plan if the trade war persists over a period of time.

The securities investment business of the Group is sensitive to market conditions and fluctuations in the prices of the securities held by the Group. Any significant downturn in the securities market may affect the mark to market value of the Group's securities investments and may adversely affect the results of the Group.

### 行業風險

本集團的金融服務業務須遵守多項規定。 其中包括營運附屬公司(如寶新證券有限公 司及大西洋資產管理有限公司)需根據證券 及期貨條例(「**證券及期貨條例**」)(香港法 例第571章)開展業務。本集團需要確保持 續遵守所有適用法例、規例及指引,以及 讓相關監管當局信納我們繼續為持牌人的 適當人選。倘相關法例、規例及指引有任 何變動或收緊,本集團的業務活動將面對 更高的合規要求。此外,倘本集團未能符 合不時的適用規則及規例,我們將可能面 臨罰款或限制我們進行業務活動,甚或暫 停或收回我們經營金融服務業務的全部或 部分牌照。此外,一如本集團所有其他業 務,金融服務業務亦不能避開市場變動。 金融市場不景亦可能會對本集團的金融服 務業務造成不利影響。

本集團的自動化業務在競爭激烈的環境中 經營。本集團面臨來自全球技術公司的激 烈競爭和快速的技術變革,這可能使本集 團開發和使用的技術過時。因此,本集團 的產品可能失去其競爭性,對本集團維持 市場份額的能力造成不利影響。未能維持 本集團的競爭地位,可能對此等業務分部 的業績和利潤造成重大不利影響。此外, 中國及美國近期的貿易戰對中國內地的營 商環境將有影響。若中美貿易戰將維持一 段時間,本集團需密切注意市場環境及將 制定另一套計劃應對。

本集團的證券投資業務對市場情況及本集 團持有的證券價格波動頗為敏感。證券市 場的任何重大衰退都可能影響本集團證券 投資的市值,並可能對本集團的業績造成 不利影響。

### MANAGEMENT DISCUSSION AND ANALYSIS 管理層討論及分析

### **Financial Risk**

In the course of its business activities, the Group is exposed to various financial risks, including market, liquidity and credit risks. The changes in the currency environment and interest rate cycles may significantly affect the Group's financial position and results of its operations in the PRC.

The Group's earnings and capital or its ability to meet its business objectives may be adversely affected by movements in foreign exchange rates, interest rates and equity prices. In particular, any depreciation in the Group's functional currency may affect its gross profit margin. The Group closely monitors the relative foreign exchange positions of its assets and liabilities and allocates its holdings of different currencies accordingly in order to minimise foreign currency risk.

The Group may be subject to liquidity risk if it is unable to obtain adequate funding to finance its operations. In managing liquidity risk, the Group monitors its cash flows and maintains an adequate level of cash and credit facilities to enable it to finance its operations and reduce the effects of fluctuations in cash flows.

The Group is subject to credit risk from its clients. To minimise risk, new clients will undergo stricter credit evaluation, while the Group continuously monitors its existing clients to further improve its risk control measures.

#### **Manpower and Retention Risk**

The competition for human resources in the countries that the Group operates in may result in the Group not being able to attract and retain key personnel with the desired skills, experience and levels of competence. The Group will continue to provide remuneration packages and incentive plans to attract, retain and motivate suitable candidates and personnel.

#### **Business Risk**

The Group constantly faces the challenge of gauging and responding promptly to market changes within the sectors that it operates in. Any failure to interpret market trends properly and adapt its strategy to such changes accordingly may have a material adverse effect on the Group's business, financial position, results of operations and prospects.

#### 財務風險

在經營活動中,本集團面臨各種金融風險,包括市場、流動性和信貸風險。貨幣 環境改變和利率週期,可能對本集團於中 國的財務狀況和經營業績產生重大影響。

本集團的盈利及資本或其達致業務目標的 能力可能會因匯率、利率及股票價格變動 而受到不利影響。特別是,本集團功能貨 幣的任何貶值可能影響其毛利率。本集團 密切監控其資產和負債的相關外匯狀況, 並相應地分配其持有的不同貨幣,以盡量 減少外匯風險。

如果本集團無法獲得足夠的資金為其業務 融資,則可能面臨流動性風險。在管理流 動性風險時,本集團監控其現金流量,並 維持足夠水平的現金和信用額度,以便為 其業務融資並減少現金流量波動的影響。

Pursuant to the Share Option Scheme, the Company may at its absolute discretion grant options to any employee of the Company or its subsidiaries (including any director, whether executive or non-executive and whether independent or not, of the Company or its subsidiaries) who is in full-time or part-time employment with the Company or its subsidiaries at the time when an option is granted to such employee, or any person who, in the sole discretion of the Board, have contributed or may contribute to the Group.

## (c) Total number of shares available for issue under the Share Option Scheme

As at the date of this report, the total number of shares of the Company available for issue under the Share Option Scheme is 156,937,561, representing approximately 5.86% of the entire issued share capital of the Company as of the date of this report.

The maximum number of shares which may be issued upon exercise of all outstanding options granted and yet to be exercised under the Share Option Scheme and any other schemes of the Company shall not exceed 30% of the total number of shares in issue from time to time.

### (e) Time of exercise of options

An option may be exercised in accordance with the terms of the Share Option Scheme at any time during a period to be determined and notified by the Directors to each grantee, which may commence on the date on which the offer for the grant of options is made but shall end in any event not later than 10 years from the date of the grant of the option subject to the provisions for early termination thereof. No minimum period for which the option must be held before it can be exercised is specified in the Share Option Scheme.

### (f) The subscription price per Share

The subscription price per share in respect of an option granted under the Share Option Scheme is such price as determined by the Board at the time of the grant of the options, but in any case the subscription price shall not be lower than the higher of:

- the closing price of the share as stated in the daily quotation sheets issued by the Stock Exchange on the date on which the options are offered, which must be a business day;
- the price being the average closing price of the shares as stated in the daily quotation sheets issued by the Stock Exchange for the five business days immediately preceding the date on which the options are offered; and
- the nominal value of a share on the date on which the options are offered.

#### (g) Payment on acceptance of option

A non-refundable sum of HK\$1 or other amount as determined by the Board by way of consideration for the grant of an option is required to be paid by each of the grantee upon acceptance of the granted option.

The Share Option Scheme will remain in force for a period of 10 years from its adoption date (i.e. 2 June 2020). The Share Option Scheme will terminate or expire (as the case may be) on the earlier of (i) the approval of the shareholders in a general meeting, and (ii) at the close of business on the day immediately preceding the tenth anniversary of the adoption date (the "**Share Option Scheme Period**").

After the Share Option Scheme Period, the Company cannot grant new options but for so long as there are options granted but not yet exercised, outstanding vested or unvested options, the Share Option Scheme will remain in full force and effect of such outstanding vested or unvested options or otherwise as may be required in accordance with the Share Option Scheme. As at the date of this report, no option had been granted by the Company under the Share Option Scheme.

### **CONTINUING CONNECTED TRANSACTIONS**

On 14 April 2021, Shenzhen Baokai Investment Holding Company Limited\* ("**Baokai Investment**"), an indirect wholly-owned subsidiary of the Company, entered into a property management services framework agreement (the "**Framework Agreement**") with Shenzhen Jixiang Property Services Group Limited\* ("**Shenzhen Jixiang**"), pursuant to which, Shenzhen Jixiang agrees to provide property management services to Baokai Investment and its subsidiaries in accordance with the Framework Agreement for the period between 14 April 2021 and 31 December 2023. The transaction contemplated under the Framework Agreement constituted a continuing connected transaction for the Group.

As Shenzhen Jixiang ceased to be a connected person of the Group in or about October 2022, the transaction contemplated under the Framework Agreement would no longer be subject to the annual review and reporting requirements from the financial year ended 31 December 2023 onwards.

At present, the Audit Committee comprises one Non-Executive Director, namely Mr. Zhang Chi and two Independent Non-Executive Directors, namely Ms. Zhang Juan and Mr. Chan Manwell, of which Ms. Zhang Juan is the Chairman.

The Audit Committee has reviewed with the management the accounting principles and practices adopted by the Group and discussed auditing, internal controls and financial reporting matters, including the review of the audited financial statements of the Group for the year ended 31 December 2023. The consolidated financial statements for the year ended 31 December 2023 have been audited by the Company's independent auditor, Moore CPA Limited.

Meanwhile, it cares for its employees by providing safe and healthy working environment and regularly hosting events and activities for the employees to benefit from work-life balance.

The Group encourages its employees to minimise the use of paper by using e-files. While ensuring the observance of high level of confidentiality, employees are prompted to use reusable papers. The Group has largely replaced its lighting systems from metal halide lamps to light-emitting diode (LED) energysaving lighting to reduce carbon emissions. 本公司一直致力推行高水平的企業管治。 董事會已採納內部企業管治政策,以提高 透明度及披露質素,以及進行更有效的風 險管理及內部監控。董事會按照其於二零 一五年十一月二日正式採納的職權範圍監 控本公司企業管治制度的執行及實施,包 括但不限於制定及檢討本公司的企業管治 政策及常規並確保彼等遵守法例及監管規 定,審查及監控董事及本公司高級管理層 的培訓及持續專業發展。

為貫徹最佳企業管治常規,本公司已成立 審核委員會、薪酬委員會、提名委員會、 戰略委員會及投資委員會。董事會及轄下 所有委員會根據其職權範圍定期評估及審 查其工作的有效性。

本公司相信,其對高水平常規的堅持,將 帶來長遠價值,繼而為股東創造回報。本 公司管理層致力藉著履行社會責任及以專 業的方式經營業務等,從而為股東爭取長 遠利益。

董事會程序符合本公司的組織章程細則 (「**細則**」)以及相關規則及法規。截至二零 二三年十二月三十一日止年度,細則並無 重大變動。

### 企業社會責任及環保事宜

為造就更好的社區,本集團致力於透過達 成其企業社會責任成為良好企業公民並回 饋社會。於二零二三年,本集團向有需要 人士提供捐款幫助。同時,本集團關懷其 僱員,提供安全健康的工作環境,並為僱 員定期舉辦項目及活動,達至工作與生活 的平衡。

本集團鼓勵其僱員使用電子檔案以減少用 紙。於確保高度保密同時,亦提示僱員使 用可重複使用的紙。本集團已大範圍以發 光二極管(LED)節能照明系統取代金屬鹵化 物燈照明系統,減少碳排放。

Details of the environmental policies and performance of the Group are disclosed in the 2023 Environmental, Social and Governance Report to be published in compliance with the requirements under the Listing Rules.

### **CORPORATE GOVERNANCE**

The Company maintains a high standard of corporate governance with a view to enhancing the management of the Company as well as preserving the interests of the shareholders as a whole. During the year under review, the Board is of the view that the Company has complied with the code provisions set out in the Corporate Governance Code (the "**CG Code**") in Appendix 14 to the Listing Rules, except the deviations disclosed herein.

According to the code provision C.2.1 of the CG code, the roles of chairman and chief executive should be separate and should not be performed by the same individual. Mr. Huang Wansheng assumed the roles of both the Chairman and the Chief Executive Officer of the Company. The Company deviates from this provision as it believes that by holding both roles, Mr. Huang will be able to provide the Group with strong and consistent leadership. It allows for more effective and efficient business planning and decisions as well as execution of long-term business strategies of the Group. As such, the structure is beneficial to the business prospects of the Group. Furthermore, the Company's present management structure comprises sufficient number of independent nonexecutive directors and all major decisions are made after consultation with the Board, appropriate Board Committees and key personnel. The Board, therefore, believes that a balance of power and authority have been and will continue to be maintained.

Pursuant to Rule 3.10 of the Listing Rules, the board of a listed issuer must include at least three independent non-executive directors ("**INED(s)**"). Pursuant to Rule 3.21 of the Listing Rules, the audit committee of a listed issuer must comprise a minimum of three members and the majority of the audit committee members must be INEDs. Pursuant to Rule 3.25 of the Listing Rules, the remuneration committee of a listed issuer must be chaired by an INED and comprise a majority of INEDs. Following the resignation of Professor Lee Kwok On, Matthew with effect from 31 July 2023, the number of INEDs and the composition of the Audit Committee and the Remuneration Committee have failed to meet the relevant requirements under the Listing Rules.

Following the appointment of Mr. Chan Manwell, the number of INEDs and the composition of the Audit Committee and the Remuneration Committee have complied with the relevant requirements under the Listing Rules.

### 企業管治

根據企業管治守則之守則條文第C.2.1條, 主席及行政總裁之職能應有區分,不應由 一人同時兼任。黃萬勝先生出任本公司主 席執首席執行官。本公司對此條文有所 離,因為本公司相信由黃先生兼任兩個 位,將對本集團發揮強大且貫徹一致的領 ,並能更高效地進行業務規劃及決策 以 及執行本集團的長期業務前景。此外,本 公司目前的管理架構包括充足的獨立非執 行董事人數及所有重大決定都與董事會 委員會及主要人員協商後作 出。因此,董事會相信此舉可維持並將繼 續維持權力與授權的平衡。

根據上市規則第3.10條,上市發行人董事 會必須包括最少三名獨立非執行董事(「獨 **立非執行董事**」)。根據上市規則第3.21 條,上市發行人審核委員會必須最少由三 名成員組成,而審核委員會的大多數成 員必須是獨立非執行董事。根據上市規則 第3.25條,上市發行人薪酬委員會必須由 獨立非執行董事擔任主席,並由過半數獨 立非執行董事組成。自李國安教授於二零 二三年七月三十一日起辭任後,獨立非執 行董事的人數及審核委員會及薪酬委員會 的組成均未能符合上市規則的相關規定。

於陳文偉先生獲委任後,獨立非執行董事 人數以及審核委員會及薪酬委員會的組成 均符合上市規則的相關規定。

Following the resignation of Mr. Ho Lik Kwan, Luke as the company secretary (the "**Company Secretary**") and authorised representative (the "**Authorised Representative**") of the Company, the Company had no Company Secretary, and was not be able to meet the requirements under Rule 3.28 of the Listing Rules and the requirement that an issuer should appoint two authorised representatives under Rule 3.05 of the Listing Rules.

### **THE BOARD**

The Board provides leadership and guidance to the Group's activities, overseeing the Group's businesses, strategic decisions and financial performances. The Board has delegated its powers to the management for the Group's daily management and operations.

### **BOARD COMMITTEES**

The Board has established an audit committee, a remuneration committee, a nomination committee, a strategic committee and an investment committee with clearly defined written terms of reference. Each committee reports to the Board on its decisions or recommendations, unless there are legal or regulatory restrictions on its ability to do so.

### **Audit Committee**

The Company has established the Audit Committee on 28 November 2009, with written terms of reference in compliance with the Listing Rules. The principal duties of the Audit Committee include the review and supervision of the Group's financial reporting matters, risk management and internal control procedures. The Audit Committee comprises one non-executive director, namely Mr. Zhang Chi and two independent non-executive directors, namely Ms. Zhang Juan and Mr. Chan Manwell, of which Ms. Zhang Juan is the Chairman. The Audit Committee has reviewed and approved the preliminary announcement of the Group's results for the year ended 31 December 2023.

The Nomination Committee comprises three members, namely Mr. Huang Wansheng, Ms. Zhang Juan and Ms. Zhao Yizi, of which Mr. Huang Wansheng is the Chairman. During the year, the Nomination Committee has duly discharged the above duties.

#### **Remuneration Committee**

The Company has established the Remuneration Committee on 28 November 2009, with written terms of reference consistent with those set out in the CG Code. The principal duties of the Remuneration Committee include determining and reviewing the remuneration packages of all the Directors and senior management of the Company. The senior management of the Company comprises only the Executive Directors of the Company. The Remuneration Committee comprises three members, namely Mr. Chan Manwell, Mr. Huang Wansheng and Ms. Zhang Juan, of which Mr. Chan Manwell is the Chairman. During the year, the Remuneration Committee has duly discharged the above duties.

#### **Strategic Committee**

The Company has established the Strategic Committee on 28 March 2012. The principal duties of the Strategic Committee include considering and recommending to the Board on the Group's business strategies and investment opportunities. The Strategic Committee comprises four members, namely Mr. Huang Wansheng, Mr. Li Minbin and Mr. Chan Manwell, of which Mr. Huang Wansheng is the Chairman. During the year, the Strategic Committee has duly discharged the above duties.

#### **Investment Committee**

The Company has established Investment Committee on 26 August 2016. The principal duties of the Investment Committee include the consideration of the proposals regarding investment, fundraising, acquisition and disposal made by the Company and its subsidiaries. The Investment Committee comprises two members, namely Mr. Huang Wansheng and Mr. Li Minbin, of which Mr. Huang Wansheng is the Chairman. During the year, the Investment Committee has duly discharged the above duties.

### **MODEL CODE FOR SECURITIES TRANSACTIONS**

### TERM OF APPOINTMENT OF INDEPENDENT NON-EXECUTIVE DIRECTORS

Each of the Independent Non-executive Directors has signed a letter of appointment with the Company, with a term of directorship for 3 years with effect from the date of appointment, reappointment or reelection. Upon the expiry of the aforesaid term of 3 years, the appointments shall be subject to the approval by the Board of the Company. The term of appointment shall be terminable by either the Independent Non-executive Director or the Company by giving the other party not less than 3 months' prior notice in writing.

### **INTERNAL CONTROL**

### **Risk management and internal control report**

The Group has established and adopted the "Renze Harvest Group Risk Management System" as a simple and effective management procedure for all business units. Pursuant to which, risks were identified, reviewed and prioritised to facilitate resources allocation for the appropriate risk management. The Group has also engaged independent consultants to conduct review of the internal control system of our business segments. The management, through the framework, also developed clear understanding on the material risks faced by the Group, which formed the basis for its decision and project implementation, thereby enabling the Group to deliver better operating results.

It is the sole responsibility of the Board to build and maintain a comprehensive and effective risk management and internal control system for the Group for the purpose of safeguarding shareholders' investment and the Group's assets. Such system is designed to identify and manage the risk of failure to achieve business objectives. This risk management and internal control report describes the structure and major features of the risk management and internal control system.

### **Risk Management Methodology**

The Group adopts the enterprise risk management framework of the Committee of Sponsoring Organizations of the Treadway Commission in establishing the risk management system, which illustrates the key elements necessary for managing risks and their integration at all levels.

The top-down approach is adopted in the Group's risk management system. This is facilitated by strong oversight exercised by the Board of Directors, the Audit Committee and the Risk Management Taskforce in the establishment and maintenance of the risk management policy and risk management system. These oversight components provide leadership and guidance that the business needs to focus, balance risk and reward and steer the Group to the planned direction. This approach ensures clarity of the top extreme/high risks involved in shaping the Group's objectives and performance, supports risk related decisions at the Board/senior management level and ensures communication amongst the management teams. It is based on risk appetite and broad understanding of themes.

The risk assessment comprises of five stages:

#### 1. Risk Identification:

Business departments that directly oversee their respective processes should identify potential risks of their processes through daily operations, operating and financial data analysis, changes in operations, etc. All of the risks identified during the risk identification process should be input into a risk inventory which summarises the risks that the Group is facing. The risk identification process should be performed at least once a year to take into account changes in the business environment and determine whether adjustment to the risk inventory is required.

#### 2. Risk Assessment and Prioritization

Risks in the risk inventory shall be evaluated by business departments using a predetermined assessment criteria. Both qualitative and quantitative criteria shall be used to measure different aspects of the risks. Ratings of 1, 2 and 3 will be assigned to the risks in the risk inventory after completion of the assessment. Prioritization will be performed according to the total score of the risks which indicate their level of significance. This facilitates the determination of action plan and timeline for mitigating the risks.

### 風險管理方法

本集團採用美國反舞弊性財務報告委員會 的企業風險管理框架,建立風險管理系 統,該系統闡述了管理風險及其於各層面 之整合所必需的關鍵要素。

本集團於風險管理系統中採用自上而下的 方法。此乃得益於董事會、審核委員會及 風險管理專責小組於建立及維護風險管理 政策及風險管理系統時的強力監督。這些 監督組成部分提供了方向及指引,即開展 業務須專注、平衡風險並取得回報,從而 引領本集團朝預定的方向發展。該方法確 保形成本集團目標及表現時,區分所涉風 險為極高/高,於董事會/高級管理團隊之 間的有效溝通。該方法基於風險偏好及對 主題的廣泛理解。

風險評估包括五個階段:

#### 1. 風險識別:

直接監督其各自流程的業務部門應透 過日常經營、經營及財務數據分析、 經營變動等識別流程中的潛在風險。 於風險識別過程中識別的所有風險應 輸入概述本集團目前所面臨風險的風 險清單中。風險識別過程應至少每年 執行一次,以考慮業務環境的變化並 確定是否需要對風險清單進行調整。

### 2. 風險評估及優先排序

風險清單中的風險應由業務部門採用 預先確定的評估標準進行評估。應同 時採用定量及定性標準評估風險的不 同方面。評估完成後按1、2及3評級 順序對風險清單中的風險進行評級。 根據風險的總得分(顯示其重要程度) 進行優先排序。這將有助於確定緩解 風險的行動計劃及時間表。

#### 3. Risk Response

The risk inventory is submitted to the Risk Management Taskforce for review. The Risk Management Taskforce is responsible for assigning risk owners from business departments to top risk events. The number of risk events identified as top risks is determined by the Board, Audit Committee and Risk Management Taskforce depending on the Group's overall risk appetite.

Risk owners involved in the operations of their respective processes are responsible for formulating risk mitigation plans for the top risks assigned to them. They should consider the risks' impact and vulnerability when determining the appropriate risk mitigation plan.

In generally, four types of risk responses can be adopted:

(i) Acceptance:

Risks are considered immaterial and acceptable based on Group's risk appetite and therefore no action is considered necessary.

(ii) Reduction:

Risks cannot be considered immaterial. Actions have to be taken to reduce the impact and vulnerability to an acceptable level.

(iii) Sharing:

Risks cannot be considered immaterial and the Group cannot effectively reduce the risks to an acceptable level by itself, therefore a portion of the risks has to be transferred to or shared with other parties. Common ways of risks sharing are purchasing of insurance, and outsourcing.

(iv) Avoidance:

Risks are so significant that there is no internal nor external measures available to reduce the risk to an acceptable level, or the mitigation actions are associated with unreasonably high costs. Activities giving rise to the risks should be avoided.

Risk response should at least include the risk owners and risk mitigation plans, reviewed and approved by the Risk Management Taskforce before implementation.

### 3. 風險應對

風險清單將遞交風險管理專責小組審 閱。風險管理專責小組負責從業務部 門中指派最高風險事件的風險負責 人。已識別為最高風險的風險事件數 目由董事會、審核委員會及風險管理 專責小組視乎本集團整體風險偏好而 釐定。

參與其各自經營流程的風險負責人負 責為指派彼等的最高風險制定風險緩 解計劃。彼等於確定適當的風險緩解 計劃時須考慮風險的影響及漏洞。

總之,可採取四類風險回應:

(i) 接受:

風險根據本集團風險偏好被認 為屬不重大且尚可接受,因此 被認為毋須採取行動。

(ii) 减少:

風險不可視為不重大。必須採 取行動以減輕影響及漏洞至可 接受範圍。

(iii) 分擔:

風險不可視為不重大且本集團 未能自身有效降低風險至可接 受範圍,因此部分風險必須轉 移至其他方或與其共同分擔。 風險分擔的普遍方式為投購保 險及外包。

(iv) 防範:

風險相當重大,以致並無可用 的內外措施可降低風險至可接 受範圍,或緩解措施會產生極 高成本。應避免參與產生此類 風險的活動。

風險應對措施至少應包括風險負責人 及風險緩解計劃,並在實施前由風險 管理專責小組進行審核和批准。

### 4. Risk Monitoring

Monitoring is a key component of the Group's risk management system. It enables the Board, Audit Committee, Risk Management Taskforce and business departments to determine whether the system is functioning effectively as they should and to ensure that risks are identified and communicated in a timely manner to those responsible for taking corrective action and to the Board as appropriate.

Risk owners assigned to oversee and manage a particular risk are responsible for implementing or ensuring the implementation of risk mitigation plan for the assigned risks.

Annual review on the risk management system should be performed. The Risk Management Taskforce shall examine whether all of the required information (i.e. risk event, risk mitigation plan, reporting frequency and period, responsible department) have been filled in by the risk owners, and have been properly supported by supporting documents or other data if applicable.

### 5. Risk Reporting

The Risk Management Taskforce shall report top risks of the year and the corresponding risk mitigation plans to the Audit Committee and the Board for endorsement annually. It should perform the independent review on the risk management system and report the result to the Audit Committee.

The above risk management system aims at managing but not eliminating the risk of failure to achieve business objectives. Furthermore, the Board will only give reasonable but not absolute assurance that there will be no material misrepresentation or loss.

### 4. 風險監測

監測乃本集團風險管理系統的關鍵部 分。監測可令董事會、審核委員會、 風險管理專責小組及業務部門確定系 統是否有效如常運作,確保可識別風 險並及時告知負責採取訂正措施的人 員以及適時向董事會報告。

獲指派監督及管理特定風險的風險負 責人負責落實或確保實施該指派風險 的風險緩解計劃。

應對風險管理系統進行年度審閲。風 險管理專責小組應檢查風險負責人是 否已提交所有的必要資料(即風險事 件、風險緩解計劃、匯報頻率及期 間、負責部門),且有關資料是否有 支持文件或其他數據(如適用)的合理 支持。

### 5. 風險報告

風險管理專責小組應每年向審核委員 會及董事會匯報年度最高風險及相應 的風險管理計劃供其確認。該小組應 對風險管理系統進行獨立檢討並向審 核委員會報告結果。

上述風險管理系統旨在管理而非消除未能 達成業務目標的風險,而且董事會只能就 不會有重大的失實陳述或損失作出合理而 非絕對的保證。

#### **Review on system effectiveness**

The review on effectiveness of the risk management and internal control system for 2022 covers the year ended 31 December 2023, in which the Board has performed annual review on the effectiveness of the risk management and internal control system of the Group through the Audit Committee, and was of the opinion that the existing risk management and internal control system was sufficient and effective. During the review, the Board has reviewed the adequacy of resources, staff qualification and experience of the audit and financial reporting function of the Group through the Audit Committee, and has not identified any material deficiencies. The Board was not aware of any material issues that may affect the shareholders and require their attention, and was of the view that the internal control of the Group was in full compliance with all of the code provisions relating to internal control under the Corporate Governance Code.

In conclusion, the Board strives to enhance the risk management and internal control system of the Group on an on-going basis.

## Procedures and internal controls for the handling and dissemination of inside information

In accordance with the requirements of the Securities and Futures Ordinance and the Listing Rules, the Group shall disclose to the public any insider information as soon as possible after such information comes to the attention of the Group, unless such information is within the scope under any safe harbours provision in the Securities and Futures Ordinance. The Group will ensure such information will be kept confidential before it is fully announced to the public. If the Group considers that the confidentiality required cannot be kept, or such information may have leaked already, such information will be disclosed to the public immediately. We also endeavour to ensure that the information contained in the annual report shall not be deceptive or misleading in all material aspects, and there are no other material matters the omission of which would make the information contained therein to be deceptive or misleading, such that the insider information disclosed can be made available to the public in an equal, timely and effective manner.

### 系統成效的檢討

二零二二年的風險管理及內部監控系統成 效檢討涵蓋截至二零二三年十二月三十一 日止年度,其中董事會已透過審核委員會 就本集團的風險管理及內部監控系統是否 有效進行年度檢討,並認為現有的風險管 理及內部監控系統足夠而有效。於檢討 程中,董事會已透過審核委員會審閲 之財務匯報職能方面的資源、員 置歷及經驗是否充足,且並無發現重大缺 漏。董事會並不察覺任何可能影響股更的 調注的重要事項,並相信本集團的內 部監控完全符合企業管治守則中各項有關 內部監控的守則條文。

最後,董事會矢志持續改善本集團的風險 管理及內部監控系統。

### 處理及發佈內幕消息的程序和內部 監控措施

In addition, if there occurs any significant risk events, the related information will be disclosed to appropriate authorities and personnel in a complete, accurate and timely manner, so that appropriate decisions and measures can be made and implemented by the Group to deal with such risk events. Meanwhile, in order to further develop the risks management culture of the enterprise, as well as to enhance the risk awareness of our staff, the Group has already rolled out training programs, so that we can assure to maintain the balance between business expansion and risk management in our operation.

### **ACCOUNTABILITY AND AUDIT**

The Directors are responsible for overseeing the preparation of financial statements of each financial year, which give a true and fair view of the state of affairs of the Group and of the results and cash flows for that year. In preparing the financial statements for the year ended 31 December 2023, the Directors have selected suitable accounting policies and applied them consistently, approved adoption of all Hong Kong Financial Reporting Standards, made appropriate judgement and estimates, prepared the financial statements on a going-concern basis.

### AUDITOR'S REMUNERATION

On 6 December 2023, Crowe (HK) CPA Limited has resigned as the auditors of the Company and Moore CPA Limited was appointed as auditors of the Company.

The remuneration in respect of services provided by the external auditors of the Company for the year ended 31 December 2023 is summarised as follows:

### **COMMUNICATION WITH SHAREHOLDERS**

The Board established a shareholders communication policy in 2014 and made it available on the Company's website. The policy is subject to review on a regular basis to ensure its effectiveness.

The Group has established and maintains different communication channels with its shareholders. Annual reports and other corporate communications are published on the websites of the Company and the Stock Exchange. General meetings and investor meetings were held either face-to-face or via telephone conference. The Group reports to the shareholders twice a year and maintains a regular dialogue with investors.

Shareholders are provided with contact details of the Company, including email address and postal address, in order for them to make queries that they may have with respect to the Company. They can also send their enquiries to the Board by these means. In addition, shareholders can contact Tricor Investor Services Limited, the share registrar of the Company, if they have any enquiries about their shareholdings and entitlements to dividend. The website of the Company has also set out details on how shareholders can convene an extraordinary meeting, and the procedures for shareholders to put forward proposals at shareholders' meeting.

The annual general meeting provides an useful forum for shareholders to exchange their views with the Board.

### SHAREHOLDER'S RIGHTS

### (i) Procedures for Shareholders to convene an Extraordinary General Meeting ("EGM")

The Board shall, on the requisition in writing by the shareholder(s) to the Secretary of the Company of not less than one-tenth of the paid up capital of the Company carrying the right of voting at general meetings of the Company, forthwith proceed to convene an EGM in accordance with the Memorandum and Articles of Association of the Company.

If within twenty-one days of such deposit the Board fails to proceed to convene the EGM, the requisitionist(s), or any of them representing more than one half of the total voting rights of all of them, may themselves do so but any meeting so convened shall not be held after the expiration of three months from the said date.

### (ii) Procedures for putting forward proposals at General ( Meeting ("GM")

Shareholders can submit a written requisition to move a resolution at GM. The number of shareholders shall represent at least 5% of the total voting rights of all the shareholders having at the date of the requisition a right to vote at the GM.

The written requisition must state the resolution, accompanied by a statement of not more than one thousand words with respect to the matter referred to in any proposed resolution or the business to be dealt with at the GM. It must also be signed by all of the shareholders concerned and be deposited at Unit 1908, 19/F., Tower 2, Lippo Centre, No. 89 Queensway, Admiralty, Hong Kong for the attention of the "Company Secretary" no less than six weeks before the GM in case of a requisition requiring notice of a resolution and no less than one week before the GM in case of any other requisitions.

### 股東權利

### (i) 股東召開股東特別大會(「股東 特別大會」)的程序

The shareholders concerned must deposit a sum of money reasonably sufficient to meet the Company's expenses giving the notice of the resolution and circulating the statement submitted by the shareholders concerned under applicable laws and rules.

If the requisition is verified to be not in order or the requisitionists have failed to deposit sufficient money to meet the Company's expenses for the said purpose, the requisitionists will be advised of the result and accordingly, no action will be taken by the Company in that regard.

### **OPINION**

We have audited the consolidated financial statements of Renze Harvest International Limited (formerly known as Glory Sun Financial Group Limited) and its subsidiaries (collectively referred to as the "**Group**") set out on pages 80 to 262, which comprise the consolidated statement of financial position as at 31 December 2023, and the consolidated statement of comprehensive income, the consolidated statement of changes in equity and the consolidated statement of cash flows for the year then ended, and notes to the consolidated financial statements, including material accounting policy information.

In our opinion, the consolidated financial statements give a true and fair view of the consolidated financial position of the Group as at 31 December 2023, and of its consolidated financial performance and its consolidated cash flows for the year then ended in accordance with Hong Kong Financial Reporting Standards ("**HKFRSs**") issued by the Hong Kong Institute of Certified Public Accountants (the "**HKICPA**") and have been properly prepared in compliance with the disclosure requirements of the Hong Kong Companies Ordinance.

### **BASIS FOR OPINION**

We conducted our audit in accordance with Hong Kong Standards on Auditing ("**HKSAs**") issued by the HKICPA. Our responsibilities under those standards are further described in the *Auditors responsibilities for the audit of the consolidated financial statements* section of our report. We are independent of the Group in accordance with the HKICPAs Code of Ethics for Professional Accountants (the "**Code**"), and we have fulfilled our other ethical responsibilities in accordance with the Code. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

### 意見

我們已審計中澤豐國際有限公司(前稱寶新 金融集團有限公司)及其附屬公司(統稱「貴 集團」)列載於第80至262頁的綜合財務報 表,包括於二零二三年十二月三十一日的 綜合財務狀況表,及截至該日止年度的綜 合全面收益表、綜合權益變動表及綜合現 金流量表,以及綜合財務報表附註,包括 重大會計政策資料。

我們認為,該等綜合財務報表已根據香港 會計師公會(「**香港會計師公會**」)頒佈的《香 港財務報告準則》(「**香港財務報告準則**」) 真實而中肯地反映了貴集團於二零二三年 十二月三十一日的綜合財務狀況及其截至 該日止年度的綜合財務表現及綜合現金流 量,並已遵照香港《公司條例》的披露規定 妥為擬備。

### 意見的基礎

#### **KEY AUDIT MATTERS**

Key audit matters are those matters that, in our professional judgement, were of most significance in our audit of the consolidated financial statements of the current period. These matters were addressed in the context of our audit of the consolidated financial statements as a whole, and in forming our opinion thereon, and we do not provide a separate opinion on these matters.

#### Purchase price allocation for business combinations

Refer to notes 4.1 and 41 to the consolidated financial statements.

During the year ended 31 December 2023, the Group completed the acquisition of 51% of the total equity of interest and actual paid-up registered capital of Shantou Taisheng Technology Limited ("**Shantou Taisheng**") for an aggregate consideration of approximately RMB1,175,550,000 and performed purchase price allocation for the acquisition.

Gain on bargain purchase of approximately HK\$550,515,000 arising from the business combination is recognised.

In performing purchase price allocation, the management of the Company has:

- (a) Assessed the identification of the assets acquired and the liabilities assumed, as well as recognised any additional assets and liabilities that are identified on the date of acquisition;
- (b) Engaged an independent valuer to estimate the fair value of the net identifiable assets acquired and liabilities assumed; and
- (c) Performed the purchase price allocation of the total cost against the Group's share of the fair value of the net identifiable acquired assets and liabilities assumed.

We identified the purchase price allocation as key audit matter due to the assessment of fair value of net identifiable assets acquired and liabilities assumed of the acquired subsidiary involved significant management judgement and high level of estimation uncertainty.

#### 關鍵審計事項

於二零二三年十二月三十一日止年度,貴 集團完成收購汕頭市泰盛科技有限公司 (「汕頭市泰盛」)總股權及實際繳足註冊資 本的51%,總代價約人民幣1,175,550,000 元,並為收購進行購買價格分配。

已確認業務合併所產生的議價購買收益約 550,515,000港元。

在進行購買價格分配時,貴集團管理層曾:

- (a) 評估所收購資產及所承擔負債的識別 情況,以及確認在收購日期識別的任 何額外資產及負債;
- (b) 委聘獨立估值師對已收購可識別資產 及已承擔負債淨值進行公平值估計; 及

The Group's investment properties amounted to approximately HK\$5,465,774,000 as at 31 December 2023 and a fair value loss of approximately HK\$20,704,000 was recognised in the fair value loss on investment properties in the consolidated statement of comprehensive income for the year.

Management has engaged independent professional valuers (the "**IP Management Expert**") to assist the management in performing the valuation of the Group's investment properties at the end of the reporting period. Valuations of the Group's investment properties are dependent on certain key inputs and assumptions that require significant management judgement. The valuation was inherently subjective due to the significant estimates used and significant changes in these estimates could result in material changes to the fair value of the investment properties.

#### Our response:

Our procedures in relation to assessing the appropriateness of the valuation of the investment properties included:

- Understanding the managements process for reviewing and evaluating the work of the IP Management Expert;
- Evaluating the independence, competence, capabilities and objectivity of the IP Management Expert;
- Obtaining an understanding from the IP Management Expert about the valuation techniques, the performance of the property markets, significant assumptions adopted in the valuations; and
- Engaging our internal valuation specialists to assist in evaluating the valuation performed by the IP Management Expert, including the reasonableness of significant unobservable inputs and the accuracy of the source data adopted by the management of the Group and the IP Management Expert by comparing them, on a sample basis, to existing tenancy profiles, market data for a selection of investment properties, publicly available information of similar comparable properties and our knowledge of the real estate industry.

# Assessment of net realisable value of inventories of properties

Refer to notes 4.11, 5(b)(vi), 21, 22 to the consolidated financial statements.

We identified the assessment of net realisable value (the "**NRV**") of the Group's inventories of properties as a key audit matter due to the significant estimates involved in the determination of the NRV of these properties. As disclosed in the consolidated financial statements, the Group had properties under development for sale of HK\$1,600,065,000 and completed properties for sale of HK\$1,284,471,000 respectively (collectively the inventories of properties) as at 31 December 2023, which are situated in the PRC.

The management of the Group determined the NRV of the inventories of properties by reference to the estimated selling prices of the inventories of properties, which takes into account a number of factors including prevailing real estate market conditions in the PRC, estimated costs to completion, and costs necessary to make the sales. Based on management's estimation of the NRV of the inventories of properties, a write-down of inventories of properties amounting to approximately HK\$170,009,000 was recognised in the profit or loss for the year ended 31 December 2023.

#### Our response:

Our procedures in relation to the appropriateness of assessing NRV of the inventories of properties included:

- Obtaining an understanding on the managements process of determining of the NRV of the inventories of properties;
- Evaluating the reasonableness of the estimated future costs to completion of the properties, on a sample basis, by comparing it to the actual development cost of similar completed properties of the Group;
- Comparing the estimated selling expenses to be incurred which is estimated based on a certain percentage of selling price with the actual average selling expenses to revenue ratio of the Group in recent years; and
- Assessing the reasonableness of the estimated selling prices used by management with reference to market prices achieved in the same projects or by comparable properties, including an evaluation of the appropriateness of the comparable properties used by management of the Group based on our knowledge of the Group's business and real estate industry in the PRC.

As at 31 December 2023, the Group had loans and advances, trade receivables and other receivables of approximately HK\$132,339,000, HK\$80,432,000 and HK\$838,110,000, respectively after loss allowance for expected credit losses ("**ECL**") of approximately HK\$721,612,000, HK\$13,159,000 and HK\$21,581,000 respectively.

Management performed the assessment on the recoverability of the loans and advances, trade receivables, other receivables and the sufficiency of loss allowance for ECL. Assessment on the recoverability of certain loans and advances, trade receivables, other receivables and the sufficiency of the related loss allowance for ECL are performed with the assistance of an independent professional valuer (the "**ECL Management Expert**").

In carrying out impairment assessment on loans and advances, trade receivables and other receivables under the ECL model, significant management judgement was used to determine the underlying estimations.

#### Our response:

Our key procedures in relation to the managements impairment assessment of loans and advances, trade receivables and other receivables included:

- Assessing whether the loans and advances, trade receivables and other receivables had been appropriately grouped by management based on their shared credit risk characteristics;
- Assessing the appropriateness of the key input data used by management and the ECL Management Expert to develop the historical loss rates and assessing the sufficiency, reliability and relevance of that data;
- Involving an auditor's expert to assist our assessment on the appropriateness of methodology in determining the historical loss rates on certain loans and advances, trade receivables and other receivables;

#### **1. GENERAL INFORMATION**

Renze Harvest International Limited (formerly known as Glory Sun Financial Group Limited) (the "**Company**"), together with its subsidiaries (the "**Group**"), was incorporated in the Cayman Islands as an exempted company with limited liability under the Companies Law, Cap. 22 (Law 3 of 1961, as consolidated and revised) of the Cayman Islands. The address of its registered office is Cricket Square, Hutchins Drive, P.O. Box 2681, Grand Cayman KY1-1111, Cayman Islands. The principal place of business is Unit 1909, 19/F, Tower Two, Lippo Centre, No. 89 Queensway, Admiralty, Hong Kong.

The Company is an investment holding company. The principal activities of its subsidiaries are set out in note 38 to the consolidated financial statements.

The Company's shares are listed on the Main Board of The Stock Exchange of Hong Kong Limited (the "**Stock Exchange**").

#### 2. BASIS OF PREPARATION

#### (a) Statement of compliance

These consolidated financial statements have been prepared in accordance with all applicable Hong Kong Financial Reporting Standards ("**HKFRSs**"), which collective term includes all applicable individual Hong Kong Financial Reporting Standards, Hong Kong Accounting Standards and Interpretations issued by the Hong Kong Institute of Certified Public Accountants ("**HKICPA**"), and the disclosure requirements of the Hong Kong Companies Ordinance. These consolidated financial statements also comply with the applicable disclosure provisions of the Rules Governing the Listing of Securities on the Stock Exchange. Significant accounting policies adopted by the Group are disclosed below.

The HKICPA has issued certain new and amendments to HKFRSs which are first effective or available for early adoption for the current accounting period of the Group. Note 3 provides information on any changes in accounting policies resulting from initial application of these developments to the extent that they are relevant to the Group for the current accounting period reflected in these consolidated financial statements.

#### 1. 一般資料

#### 2. 編製基準

#### (a) 合規聲明

此等綜合財務報表乃按照所有 適用的香港財務報告準則(「**香 港財務報告準則**」)(該統稱包括 香港會計師公會(「**香港會計師** 公會」)頒佈的所有適用的香港 財務報告準則、香港會計準則 及詮釋)以及香港公司條例的務 報表亦遵守聯交所證券上市規 則的適用披露條文。本集團所 採納的主要會計政策披露如下。

香港會計師公會已頒佈若干於 本集團本會計期間首次生效或 可供提早採納的新訂及經修訂 香港財務報告準則。附註3就此 等綜合財務報表內所反映初次 應用該等於本會計期間與本集 團有關的準則所導致的任何會 計政策變動提供資料。

#### (a) Statement of compliance (Continued)

The comparative figures of loss per share are restated to adjust for the effect of share consolidation completed during the year ended 31 December 2022. Details of the restatement is set out in note 14 to the consolidated financial statements.

#### (b) Basis of preparation of the financial statements

The consolidated financial statements for the year ended 31 December 2023 comprise the Company and its subsidiaries (together referred to as the "**Group**") and the Group's interests in associates.

Items included in the financial statements of each entity in the Group are measured using the currency of the primary economic environment in which the entity operates (the "**functional currency**"). The consolidated financial statements are presented in Hong Kong dollar ("**HKD**"), which is the Company's functional and presentation currency.

The preparation of financial statements in accordance with HKFRSs requires management to make judgements, estimates and assumptions that affect the application of policies and reported amounts of assets, liabilities, income and expenses. The estimates and associated assumptions are based on historical experience and various other factors believed to be reasonable under the circumstances, the results of which form the basis of making the judgements about carrying amounts of assets and liabilities not readily apparent from other sources. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods.

Judgements made by management in the application of HKFRSs that have significant effect on the financial statements and major sources of estimation uncertainty are discussed in note 5.

2. 編製基準(續)

#### Impacts on application of Amendments to HKAS 1 and HKFRS Practice Statement 2 Disclosure of Accounting Policies

The Group has applied the amendments for the first time in the current year. HKAS 1 Presentation of Financial Statements is amended to replace all instances of the term "significant accounting policies" with "material accounting policy information". Accounting policy information is material if, when considered together with other information included in an entity's financial statements, it can reasonably be expected to influence decisions that the primary users of general purpose financial statements make on the basis of those financial statements.

The amendments also clarify that accounting policy information may be material because of the nature of the related transactions, other events or conditions, even if the amounts are immaterial. However, not all accounting policy information relating to material transactions, other events or conditions is itself material. If an entity chooses to disclose immaterial accounting policy information, such information must not obscure material accounting policy information.

HKFRS Practice Statement 2 Making Materiality Judgements (the "**Practice Statement**") is also amended to illustrate how an entity applies the "four-step materiality process" to accounting policy disclosures and to judge whether information about an accounting policy is material to its financial statements. #### 4.1 Business combination and basis of consolidation

The consolidated financial statements comprise the financial statements of the Group. Inter-company transactions and balances between group companies together with unrealised profits are eliminated in full in preparing the consolidated financial statements. Unrealised losses are also eliminated unless the transaction provides evidence of impairment on the asset transferred, in which case the loss is recognised in profit or loss.

The results of subsidiaries acquired or disposed of during the year are included in the consolidated statement of comprehensive income from the dates of acquisition or up to the dates of disposal, as appropriate. Where necessary, adjustments are made to the financial statements of subsidiaries to bring their accounting policies in line with those used by other members of the Group.

The Group accounts for business combinations using the acquisition method when the acquired set of activities and assets meets the definition of a business and control is transferred to the Group. In determining whether a particular set of activities and assets is a business, the Group assesses whether the set of assets and activities acquired includes, at a minimum, an input and substantive processes and whether the acquired set has the ability to produce outputs.

The cost of an acquisition is measured at the aggregate of the acquisition-date fair value of assets transferred, liabilities incurred and equity interests issued by the Group, as the acquirer. The identifiable assets acquired and liabilities assumed are principally measured at acquisition-date fair value. The Group's previously held equity interest in the acquiree is re-measured at acquisitiondate fair value and the resulting gains or losses are recognised in profit or loss. The Group may elect, on a transaction-bytransaction basis, to measure the non-controlling interests that represent present ownership interests in the subsidiary either at fair value or at the proportionate share of the acquiree's identifiable net assets. All other non-controlling interests are measured at fair value unless another measurement basis is required by HKFRSs. Acquisition-related costs incurred are expensed unless they are incurred in issuing equity instruments in which case the costs are deducted from equity.

Subsequent to acquisition, the carrying amount of non-controlling interests that represent present ownership interests in the subsidiary is the amount of those interests at initial recognition plus such non-controlling interests share of subsequent changes in equity. Non-controlling interests are presented in the consolidated statement of financial position within equity, separately from equity attributable to owners of the Company. Profit or loss and each component of other comprehensive income are attributed to the owners of the Company and to the non-controlling interests. Total comprehensive income is attributed to such non-controlling interests even if this results in those non-controlling interests having a deficit balance.

When the Group loses control of a subsidiary (except for disposal of subsidiaries by way of distribution in specie by the Company, where the disposed subsidiaries are ultimately under control of the same parties before and after the distribution), the gain or loss on disposal is calculated as the difference between (i) the aggregate of the fair value of the consideration received and the fair value of any retained interest and (ii) the previous carrying amount of the assets (including goodwill), and liabilities of the subsidiary and any non-controlling interests. Amounts previously recognised in other comprehensive income in relation to that subsidiary are accounted for on the same basis as would be required if the relevant assets or liabilities were disposed of.

#### 4.2 Subsidiaries

A subsidiary is an investee over which the Company is able to exercise control. The Company controls an investee if all three of the following elements are present: (i) power over the investee, (ii) exposure, or rights, to variable returns from the investee, and (iii) the ability to use its power to affect those variable returns. Control is reassessed whenever facts and circumstances indicate that there may be a change in any of these elements of control.

In the Company's statement of financial position, investments in subsidiaries are stated at cost less impairment loss, if any. The results of subsidiaries are accounted for by the Company on the basis of dividend received and receivable.

#### 4.3 Associates

An associate is an entity over which the Group has significant influence and that is neither a subsidiary nor a joint arrangement. Significant influence is the power to participate in the financial and operating policy decisions of the investee but not control or joint control over those policies.

Associates are accounted for using the equity method whereby they are initially recognised at cost and thereafter, their carrying amount are adjusted for the Group's share of the post-acquisition change in the associates net assets except that losses in excess of the Group's interest in the associate are not recognised unless there is an obligation to make good those losses.

Profits and losses arising on transactions between the Group and its associates are recognised only to the extent of unrelated investors interests in the associate. The investors share in the associates profits and losses resulting from these transactions is eliminated against the carrying value of the associate. Where unrealised losses provide evidence of impairment of the asset transferred they are recognised immediately in profit or loss.

Any premium paid for an associate above the fair value of the Group's share of the identifiable assets, liabilities and contingent liabilities acquired is capitalised and included in the carrying amount of the associate. Any excess of the Group's share of the net fair value of the identifiable assets and liabilities over the cost of investment, after reassessment, is recognised immediately in profit or loss. Where there is objective evidence that the investment in an associate has been impaired, the carrying amount of the investment is tested for impairment in the same way as other non-financial assets.

#### 4.4 Goodwill

Where the fair value of net identifiable assets acquired and liabilities assumed exceed the aggregate of the fair value of consideration paid, the amount of any non-controlling interest in the acquiree and the acquisition date fair value of the acquirers previously held equity interest in the acquiree, the excess is recognised in profit or loss on the acquisition date, after re-assessment.

Goodwill is measured at cost less impairment losses. For the purpose of impairment testing, goodwill arising from an acquisition is allocated to each of the relevant cash- generating units ("**CGU(s)**") that are expected to benefit from the synergies of the combination. A CGU is the smallest identifiable group of assets that generates cash inflows that are largely independent of the cash inflows from other assets or groups of assets. A CGU to which goodwill has been allocated is tested for impairment annually, by comparing its carrying amount with its recoverable amount (see note 4.16), and whenever there is an indication that the unit may be impaired.

For goodwill arising on an acquisition in a financial year, the CGU to which goodwill has been allocated is tested for impairment before the end of that financial year.

#### 4.5 Property, plant and equipment

Property, plant and equipment other than construction- inprogress are stated at cost less accumulated depreciation and any accumulated impairment losses. The cost of property, plant and equipment includes its purchase price and the costs directly attributable to the acquisition of the items.

Subsequent costs are included in the assets carrying amount or recognised as a separate asset, as appropriate, only when it is probable that future economic benefits associated with the item will flow to the Group and the cost of the item can be measured reliably. The carrying amount of the replaced part is derecognised. All other repairs and maintenance are recognised as an expense in profit or loss during the financial period in which they are incurred.

Property, plant and equipment are depreciated so as to write off their cost net of expected residual value over their estimated useful lives on a straight-line basis. The useful lives, residual value and depreciation method are reviewed, and adjusted if appropriate, at the end of each reporting period. The useful lives are as follows:

#### 4.6 Investment properties

Investment properties are properties held to earn rentals and/or for capital appreciation (including properties under construction for such purposes). Investment properties include land held for undetermined future use, which is regarded as held for capital appreciation purpose.

Investment properties are initially measured at cost, including any directly attributable expenditure. Subsequent to initial recognition, investment properties are measured at their fair values. Gains or losses arising from changes in the fair value of investment properties are included in profit or loss for the period in which they arise.

Construction costs incurred for investment properties under construction are capitalised as part of the carrying amount of the investment properties under construction.

An investment property is derecognised upon disposal or when the investment property is permanently withdrawn from use and no future economic benefits are expected from its disposals. Any gain or loss arising on derecognition of the property (calculated as the difference between the net disposal proceeds and the carrying amount of the asset) is included in the profit or loss in the period in which the item is derecognised.

Transfers are made to (or from) investment property only when there is a change in use. If an investment property becomes owner-occupied, it is reclassified as property, plant and equipment and its fair value at the date of reclassification becomes its cost for accounting purposes.

ECLs are a probability-weighted estimate of credit losses. Credit losses are measured as the difference between all contractual cash flows that are due to the Group in accordance with the contract and all the cash flows that the Group expects to receive. The shortfall is then discounted at an approximation to the assets original effective interest rate.

The Group measured loss allowances for trade receivables and contract assets using HKFRS 9 simplified approach and has calculated ECLs based on lifetime ECLs. Some of the Group's contracts with customers from the sale of automated production related products provides customers a right of return (a right to exchange another product). These rights of return do not allow the returned goods to be refund in cash. The right of return gives rise to variable consideration. The variable consideration is estimated at contract inception and constrained until the associated uncertainty is subsequently resolved. The application of the constraint on variable consideration increases the amount of revenue that will be deferred.

Any amount previously recognised as a contract asset is reclassified to trade receivables at the point at which it is invoiced to the customer. The amount of current tax payable or receivable is the best estimate of the tax amount expected to be paid or received that reflects any uncertainty related to income tax.

Deferred tax is recognised in respect of temporary differences between the carrying amounts of assets and liabilities for financial reporting purposes and the corresponding amounts used for tax purposes. Except for goodwill not deductible for tax purposes and initial recognition of assets and liabilities that are not part of the business combination which affect neither accounting nor taxable profits and at the time of transaction does not give rise to equal taxable and deductible temporary differences, taxable temporary differences arising on investments in subsidiaries and associates where the Group is able to control the reversal of the temporary difference and it is probable that the temporary difference will not reverse in the foreseeable future, deferred tax liabilities are recognised for all taxable temporary differences. Deferred tax assets are recognised to the extent that it is probable that taxable profits will be available against which deductible temporary differences can be utilised, provided that the deductible temporary differences are not arises from initial recognition of assets and liabilities in a transaction other than in a business combination that affects neither taxable profit nor the accounting profit and at the time of transaction does not give rise to equal taxable and deductible temporary differences. Deferred tax is measured at the tax rates appropriate to the expected manner in which the carrying amount of the asset or liability is realised or settled and that have been enacted or substantively enacted at the end of reporting period, and reflects any uncertainty related to income taxes.

Nonmonetary items carried at fair value that are denominated in foreign currencies are retranslated at the rates prevailing on the date when the fair value was determined. Non-monetary items that are measured in terms of historical cost in a foreign currency are not retranslated.

Exchange differences arising on the settlement of monetary items, and on the translation of monetary items, are recognised in profit or loss in the period in which they arise. Exchange differences arising on the retranslation of non-monetary items carried at fair value are included in profit or loss for the period except for differences arising on the retranslation of non-monetary items in respect of which gains and losses are recognised in other comprehensive income, in which case, the exchange differences are also recognised in other comprehensive income.

On consolidation, income and expense items of foreign operations are translated into the presentation currency of the Group (i.e. Hong Kong dollars) at the average exchange rates for the year, unless exchange rates fluctuate significantly during the period, in which case, the rates approximating to those ruling when the transactions took place are used. All assets and liabilities of foreign operations are translated at the rate ruling at the end of reporting period. In the consolidated statement of cash flows, cash and cash equivalents include cash in hand, deposits held at call with banks and other short-term highly liquid investments with original maturities of three months or less.

#### 4.19 Client trust bank balances

The Group maintains trust and segregated accounts with authorised financial institutions to hold clients' deposits arising from normal business transactions. The Group has classified the clients' monies as client trust bank balances under the current assets in the consolidated statement of financial position as the Group is allowed to retain some or all of the interest income on the clients' monies and recognised corresponding accounts payable to the respective customers in the current liabilities clients on grounds that it is liable for any loss or misappropriation of clients' monies. Under the Hong Kong Securities and Futures Ordinance (Cap. 571), the Group is not allowed to use the clients' monies to settle its own obligation.

Revenue from Securities Investment segment is derived from realised and unrealised gains/(losses) of financial assets at FVTPL and commission income on dealing in securities. Revenue from Financial Services segment includes commission and brokerage income on dealings in securities and future contracts, interest income from money lending, management fee and performance fee income from financial services. Revenue from Property Investment and Development segment is derived from the sale of properties, rental income and property management income.

The CEO assesses the performance of the operating segments based on a measure of operations, which is in a manner consistent with that of the consolidated financial statements. The measurement of segment results excludes the effect of unallocated corporate income and expenses, as these type of activities are managed by central finance and accounting function, which manages the working capital of the Group. In addition, share of results of associates, impairment losses on financial assets and contract assets, gain on bargain purchase from acquisition of a subsidiary, recovery of impairment losses on financial assets arising from acquisition of a subsidiary are not allocated to segments.

LAT is levied at progressive rates ranging from 30% to 60% on the appreciation of land value, being the proceeds of sales of properties less deductible expenditures including leasehold land payments and all property development expenditures. Deferred tax assets are recognised for tax loss carry-forwards to the extent that the realisation of the related tax benefit through future taxable profits is probable. The Group did not recognise deferred tax assets in respect of losses amounting to approximately HK\$781,714,000 (2022: HK\$396,739,000) that can be carried forward against future taxable income due to uncertainty of availability of future taxable income. Except for tax losses of approximately HK\$269,284,000 (2022: HK\$59,658,000) that will be expired in 5 years, the remaining tax losses do not have expiry date.

As at 31 December 2023, the Group has deductible temporary difference of approximately HK\$608,873,000 (2022: HK\$551,876,000) relating to ECLs provision of loans and advances, trade receivables, contract assets, other receivables and the fair value loss on FVOCI. No deferred tax asset has been recognised in relation to such deductible temporary difference as it is not probable that taxable profit will be available against which the deductible temporary differences can be utilised.

Pursuant to relevant laws and regulations in the PRC, withholding tax is imposed at 10% on dividends declared to foreign investors in respect of profit earned by PRC subsidiaries from 1 January 2008 onward. At the end of the reporting period, the aggregate amount of temporary differences associated with undistributed earnings of PRC subsidiaries for which deferred tax have not been recognised is approximately HK\$1,358,195,000 (2022: HK\$534,061,000). No liability has been recognised in respect of these differences because the Group is in a position to control the timing of reversal of the temporary differences and it is probable that such differences will not reverse in the foreseeable future.

#### **35. RESERVES**

- (a) Merger reserve represents (i) the difference between the share capital of the Company and the combined share capital of the subsidiaries (after eliminating intra-group investments and share capital) acquired by the Company pursuant to the Group reorganisation in 2009 and (ii) impact on business combination under common control.
- (b) Capital reserve of the Group represents the net assets attributable to non-controlling shareholders which were acquired pursuant to the Group reorganisation in 2009, and is treated as a deemed contribution from equity holders and the release of share-based compensation reserve upon the incentive shares under share incentive scheme approved and adopted by the Group in 2008.
- The PRC laws and regulations require companies registered in (C) the PRC to provide for certain statutory reserves, which are to be appropriated from the net profit (after offsetting accumulated losses from prior years) as reported in their respective statutory financial statements, before profit distributions to equity holder. All statutory reserves are created for specific purposes. The PRC company is required to appropriate 10% of statutory net profits to statutory reserve, upon distribution of its post- tax profits of the current year. A company may discontinue the contribution when the aggregate sum of the statutory reserve is more than 50% of its registered capital. The statutory reserves shall only be used to make up losses of the companies, to expand the companies' production operations, or to increase the capital of the companies. In addition, a company may make further contribution to the discretional surplus reserve using its post-tax profits in accordance with resolutions of the board of directors.
- (d) Other reserves represented (i) share of other comprehensive income of associates; (ii) gains/losses arising from changes in Group's interests in subsidiaries that do not result in a loss of control; and (iii) revaluation surplus upon transfer of owneroccupied properties to investment properties and the tax arising from revaluation thereof.

#### Share option scheme adopted by the Company

The Company adopted a share option scheme on 2 June 2020 (the "**2020 Share Option Scheme**").

The 2020 Share Option Scheme remain in force for ten years commencing on the adoption date. The number of shares in respect of which options may be granted under the 2020 Share Option Scheme and any other share option schemes is not permitted to exceed 30% of the shares of the Company in issue from time to time. The maximum number of shares issued and to be issued upon exercise of options granted and to be granted pursuant to the 2020 Share Option Scheme and any other share options schemes of the Company to any person (including both exercised and outstanding options) in any 12-month period up to the date of grant of options shall not exceed 1% of the shares of the Company in issue.

The exercise price is determined by the directors of the Company at the time of the grant of the options and will not be less than the higher of (i) the official closing price of the Company's share as stated in the daily quotation sheets issued by the Stock Exchange on the date of grant; (ii) the average closing price of the Company's share as stated in the daily quotation sheets issued by the Stock Exchange for the five trading days immediately preceding the date of grant; and (iii) the nominal value of the Company's share. The options are exercisable in ten years starting from the date of grant. The Group has no legal or constructive obligation to repurchase or settle options in cash.

During the years ended 31 December 2023 and 2022, no share option was granted, exercised, cancelled or lapsed under the 2020 Share Option Scheme and no outstanding option as at 31 December 2023 and 2022.

### Acquisition of Shantou Taisheng Technology Limited\* (汕頭市泰盛科技有限公司) (the "Shantou Taisheng")

On 19 October 2022, the Company procured Shenzhen Baokai Investment Holding Company Limited\*, an indirectly wholly-owned subsidiary of the Company (深圳寶開投資控股有限公司) (the "**Purchaser**") and Glory Sun Land Group Limited ("**GSLG**") procured Shenzhen Hong Jia Xin Technology Limited\*, an indirectly wholly-owned subsidiary of Glory Sun Land Group (深圳宏佳新科技有限公司) (the "**Vendor**") to enter into an agreement, pursuant to which the Purchaser conditionally agrees to acquire, and the Vendor conditionally agrees to sell, 100% of the total equity interest and actual paid-up registered capital of Shantou Taisheng in two tranches. The 1st tranche acquisition (representing 51% of the total equity interest and actual paid-up registered capital of the Shantou Taisheng) was completed on 22 March 2023.

2nd tranche acquisition is subject to the satisfaction (or waiver, as the case may be) of the conditions precedent set forth in the aforementioned agreement, the Vendor shall dispose the 2nd tranche sale equity interest (representing the remaining 49% of the total equity interest and actual paid-up registered capital of the Shantou Taisheng held by the Vendor) to the Purchaser within twelve months from 1st tranche completion.

The 1st and 2nd tranche considerations are amounting to RMB1,175,550,000 and RMB1,129,450,000 respectively.

The 1st tranche consideration should be paid by cash and set-off loans principal together with the corresponding interest due from GSLG (Note 23(b)) of RMB12,100,000 (equivalent to HK\$16,285,000) and RMB1,163,400,000 (equivalent to HK\$1,326,544,000) respectively.

Shantou Taisheng has certain balances due from subsidiaries of GSLG ("**GSLG Group**"). As at the date of agreement, the balance outstanding was RMB415,000,000. In addition, Shantou Taisheng has granted a land charge ("**Land Charge**") to Xiamen International Trust Co., Ltd. for securing the loan of RMB360,000,000 ("**Secured Loan**") granted to GSLG Group which shall be mature on 19 October 2026. Pursuant to the agreement, the 2nd tranche consideration should be offset with the amount due from GSLG Group and the Group shall direct the payment of consideration to repay the Secured Loan and the corresponding interest.

Shangtou Taisheng is a company established in the PRC with limited liability and is solely engaged in a development and construction project located at Longhu District, Shantou City, Guangdong Province, the PRC, with total land area of approximately 167,000 sq.m. which involve office and commercial buildings, residential units and loft apartments.

For details, please refer to the announcements of the Company dated 3 October 2022 and 22 March 2023 and the circular of the Company dated 28 February 2023. The shareholders of the Company have approved the acquisition 100% equity interest in Shantou Taisheng in March 2023.

- (a) Shantou Taisheng has an amount due from GSLG Group of RMB415,000,000 on the date of entering into the acquisition. The counterparties have agreed to have this balance being considered as part of the settlement for the 2nd tranche acquisition. The management of the Group considered the fair value of the amount due is approximate to the amount agreed to offset.
- (b) Balance represents financial guarantees issued by Shangtou Taisheng for the Secured Loan. Fair value of the financial guarantees on acquisition date was determined by the AP Appraisal Limited, a firm of professional valuer. The counterparties have agreed to have the consideration payable by the Group for the 2nd tranche acquisition to be directed to the relevant lenders.
- (c) The Group has engaged a professional valuer to evaluate the fair values of the target company at the date of acquisition and the difference represents the fair value over their net book values at the acquisition date.

The asset approach is applied in the valuation of the 100% equity interests of the target company. The asset approach determines a fair value indication of a business, business ownership interest, security, or intangible asset by using one or more methods based on the value of the assets net of liabilities. Value is established based on the cost of reproducing or replacing the property, less depreciation from physical deterioration and functional and economic obsolescence, if present and measurable.

The gain on bargain purchase of approximately HK\$550,515,000 is attributable to the Group's bargaining power and ability in negotiating the agreed terms of the transaction with its counter party, especially, the Vendor disposing Shangtou Taisheng at a discount due to lack of funding to repay the loan and corresponding interest payable upon expiry (Note 23(b)), and is immediately recognised in the consolidated statement of comprehensive income.

The acquisition enables the Group to participate in the project adheres to the Group's business strategies in further expanding its property investment and development portfolio. The project forms part of a large scale urban development in Shantou City, comprising intelligent complex integrating high-end residence, cultural centre, five-star hotel, topnotch business, office buildings, offices and aesthetic mansions. The urban development is designed to promote regional development and innovation, encourage industrial upgrading of the city and to stimulate economic growth.

### 44.1 Financial risk factors

The Group's activities expose it to a variety of financial risks: market risk (including foreign exchange risk, price risk and interest rate risk), credit risk and liquidity risk. The Group's overall risk management program focuses on the unpredictability of financial markets and seeks to minimise potential adverse effects on the Group's financial performance. Risk management is carried out by the senior management of the Group under policies approved by the directors of the Company.

#### (a) Market risk

#### Foreign exchange risk

The Group operates principally in Hong Kong and in the PRC. It is exposed to foreign exchange risk primarily with respect to Hong Kong dollar and RMB denominated transactions. Foreign exchange risk arises where future commercial transactions, recognised assets and liabilities are denominated in currency that is not the respective Company's functional currency.

As at 31 December 2023 and 2022, the Group's cash and bank balances, deposits and other receivables and loans and advances are mainly denominated in Hong Kong dollar, RMB and US dollar other than the functional currency of the relevant group companies. Since Hong Kong dollar is pegged to US dollar, the Group believes the exposure of transactions denominated in Hong Kong dollar which are entered into the Group to be insignificant.

As at 31 December 2023 and 2022, if RMB had strengthened/weakened by 5% with all other variables held constant, profit after income tax would have been approximately HK\$2,708,000 higher/lower (2022: HK\$36,492,000 lower/higher).

#### Price risk

Management has delegated a team responsible for determination of credit limits, credit approvals and other monitoring procedures to ensure that follow-up action is taken overdue debts. The overdue balances for margin clients are reviewed daily, and force-sell action may be taken against clients with overdue balances on case by case basis.

For other loans and advances, prior to the lending of loan, the financial strength, purpose of the borrowing and repayment ability of the borrower is reviewed to ensure the default probability is acceptably low.

Except for the financial guarantee given by the Group as set out in note 45, the Group does not provide any other guarantees which would expose the Group to credit risk. The maximum exposure to credit risk in respect of these financial guarantees at the end of the reporting period is disclosed in note 45.

Credit risk is deemed to have increased significantly if the credit rating has significantly deteriorated at the reporting date relative to the credit rating at the date of initial recognition.

Prudent liquidity risk management includes maintaining sufficient cash and marketable securities, the availability of funding through an adequate amount of committed credit facilities and the ability to settle the payables of the Group. Due to the dynamic nature of the underlying businesses, senior management of the Group aims to maintain flexibility in funding by keeping committed credit lines available. In addition, due to the conversion of RMB into foreign currencies is subject to the rules and regulations of foreign exchange control promulgated by the PRC government management aims to monitor and manage its operating cashflows and transactions denominated in RMB regularly to minimise the respective liquidity risk.

Management monitors rolling forecasts of the Group's liquidity reserve which comprise undrawn borrowing facilities and cash and cash equivalents on the basis of expected cash flows. The Group aims to maintain flexibility in funding while minimising its overall costs by keeping a mix of committed and uncommitted credit lines available.

#### 44.2 Capital risk management

The Group's objectives when managing capital are to safeguard the Group's ability to continue as going concern in order to provide returns for shareholders and benefits for stakeholders and to maintain an optimal capital structure to reduce the cost of capital. The Group's overall strategy remains unchanged from prior year.

In order to maintain or adjust the capital structure, the Group may adjust the amount of dividends paid to shareholders, issue new shares or dispose of assets to reduce debt.

The capital structure of the Group consists of borrowings and shareholders equity. Capital is managed so as to maximise the return to shareholders while maintaining a capital base to allow the Group to operate effectively in the marketplace and sustain future development of the business. Consistent with others in the industry, the Group monitors capital on the basis of gross gearing ratio. This ratio is calculated as total borrowings divided by total equity.

For the years ended 31 December 2023 and 2022, the Group has engaged independent professionally qualified valuer, Kroll (formerly known as Duff & Phelps), to assist the Group in determining the fair value of financial instruments in level 3 for financial reporting purposes. The responsibility for determining the fair value rests with the Group.

At each financial year end, the finance department reviews all significant unobservable inputs and valuation adjustments used to measure the fair values of financial instruments in level 3. Changes in level 2 and 3 fair values are analysed at each reporting date. As part of that discussion, the finance department presents a report that explains the reasons for the fair value movements.

## **45. FINANCIAL GUARANTEES**

The Group provided guarantees in respect of mortgage facilities granted by certain banks relating to mortgage loans arranged for certain purchasers of the Group's properties in the PRC of approximately HK\$440,379,000 (2023: HK\$3,223,000). Pursuant to the terms of the guarantees, upon default in mortgage payments by these purchasers, the Group will be responsible for repaying the outstanding mortgage principals together with accrued interest and penalty owed by the defaulted purchasers to the banks whilst the Group will then be entitled to take over the legal title and possession of the related properties. Such guarantees will terminate upon issuance of the relevant property ownership certificates. The directors of the Company consider that the likelihood of default in payments by purchasers is minimal.

In addition, Shantou Taisheng has granted a land charge to Xiamen International Trust Co., Ltd. for securing the loan of RMB360,000,000 granted to GSLG Group which shall be mature on 19 October 2026.
