Subject: Adjusted Fomento Económico Mexicano, S.A.B. de C.V. - Cash

Distribution Settlement

Adjusted Option Symbols: FMX1/1FMX1

Adjusted Fomento Económico Mexicano, S.A.B. de C.V. options were adjusted on April 16, 2024 (See OCC Information Memo #54450). The new deliverable became 1) 100 Fomento Económico Mexicano, S.A.B. de C.V. (FMX) American Depositary Shares and 2) Approximately \$46.57 Cash (approximately \$0.465703 x 100). Only settlement of the cash component of FMX1/1FMX1 options exercise/assignment activity was subject to delayed settlement.

OCC has been informed that the final distribution rate is \$0.446802 per FMX share held.

Now that the distribution rate has been determined, OCC will require Put exercisers and Call assignees, during the period of April 16, 2024 through May 2, 2024, to deliver the appropriate cash amount.

Terms of the FMX1/1FMX1 options are as follows:

New Deliverable

Per Contract: 1) 100 Fomento Económico Mexicano, S.A.B. de C.V. (FMX)

American Depositary Shares 2) \$44.68 Cash (\$0.446802 x 100)

Strike Prices: Unchanged

CUSIP: 344419106

Multiplier: 100 (i.e., a premium of 1.50 yields \$150)

Settlement

The FMX component of FMX1/1FMX1 exercise/assignment activity from April 16, 2024 through May 1, 2024, has settled through National Security Clearing Corporation (NSCC). The \$44.68 amount will be settled by OCC.

Pricing

The underlying price for FMX1/1FMX1 options will be determined as follows:

FMX1 = FMX + 0.4468

For example, if FMX closes at 118.09, the FMX1/1FMX1 prices would be calculated as follows:

FMX1 = 118.09 + 0.4468 = 118.54
